(57) **CLAIM**

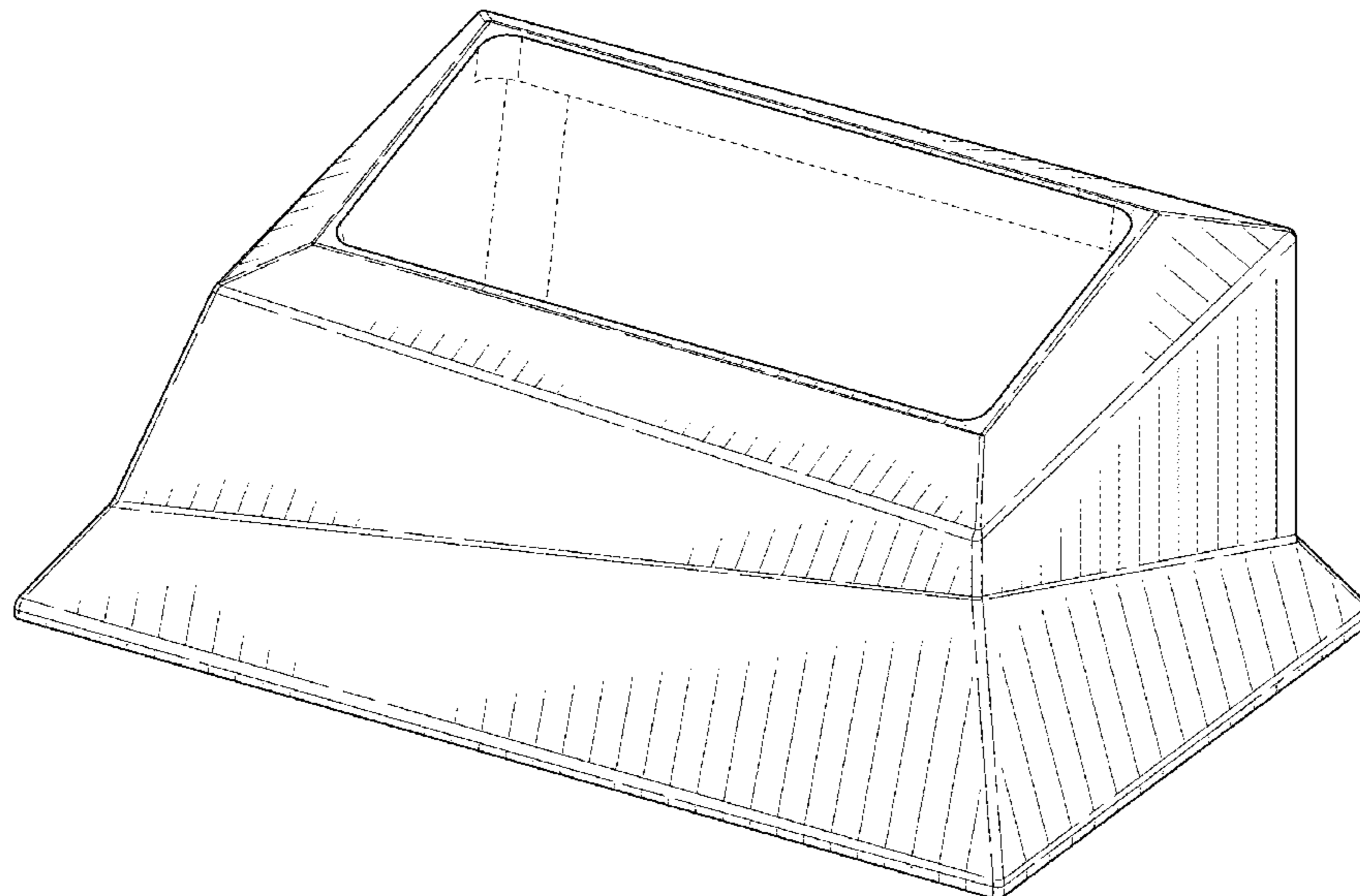
The ornamental design for a razor stand, as shown and described.

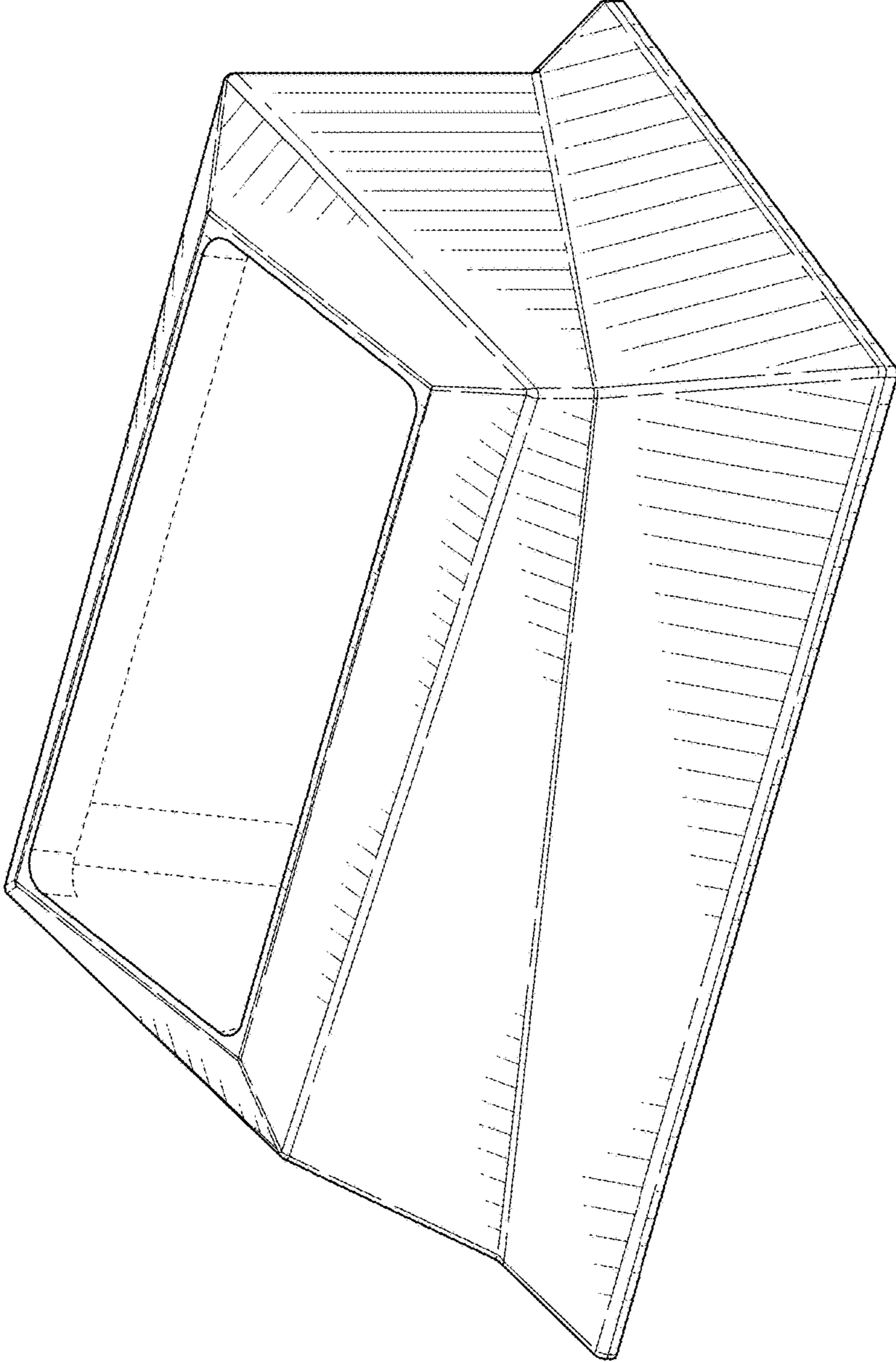

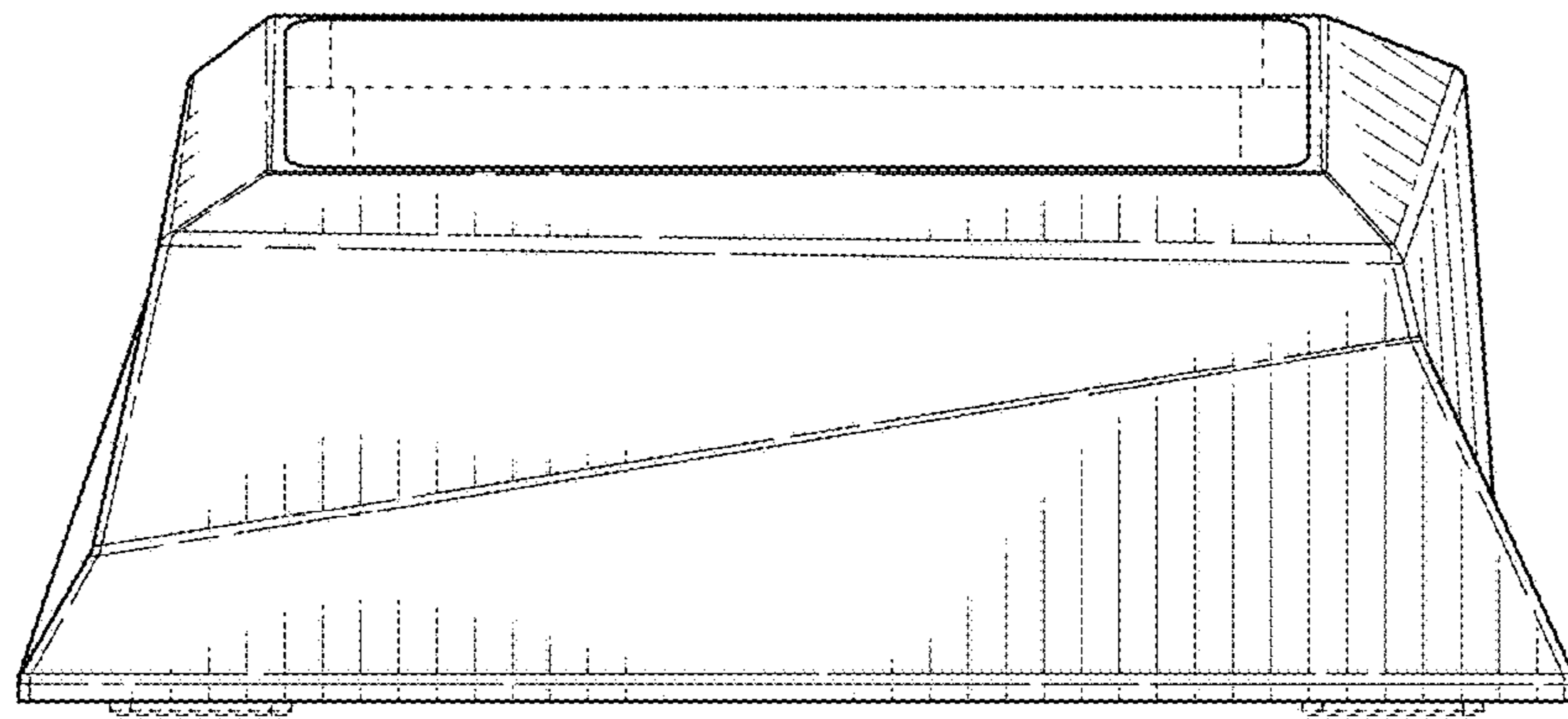

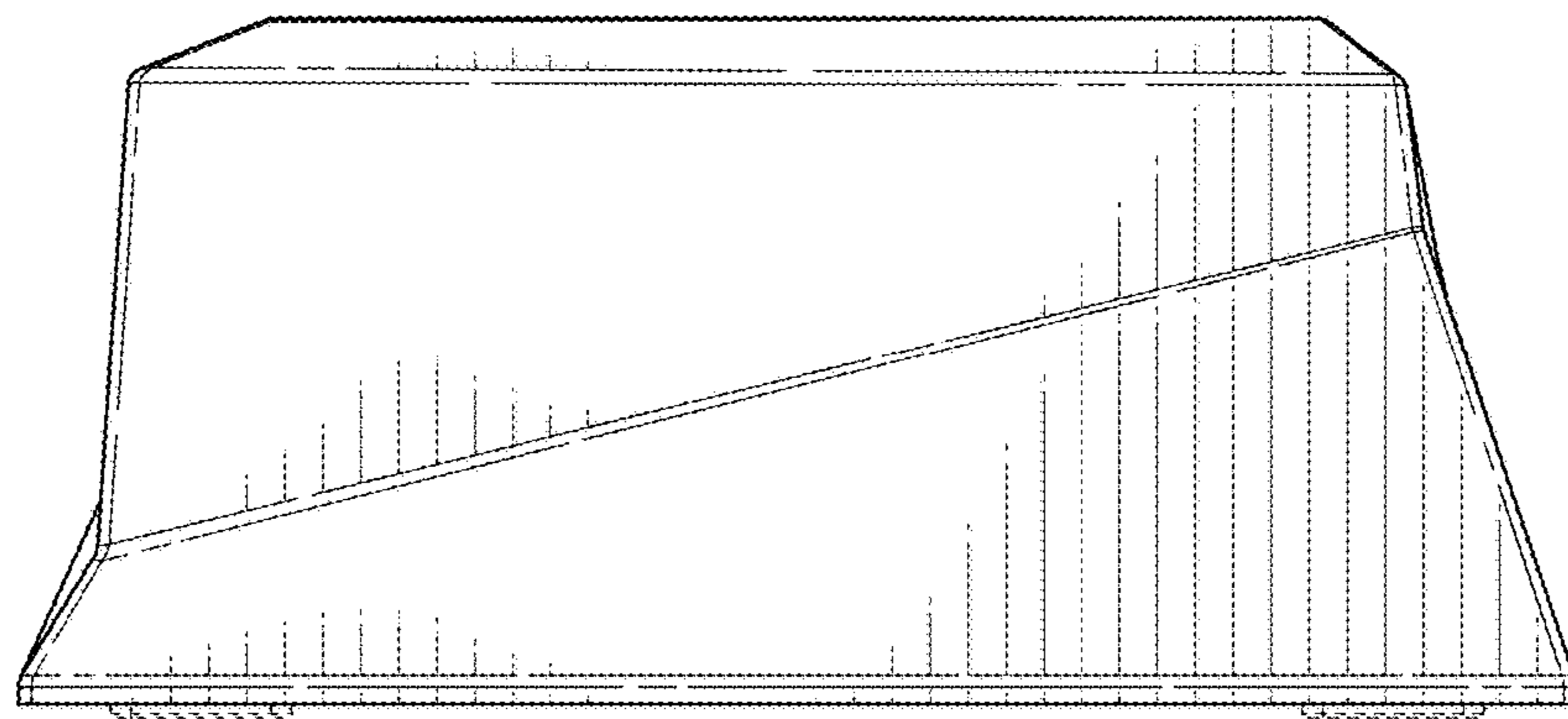

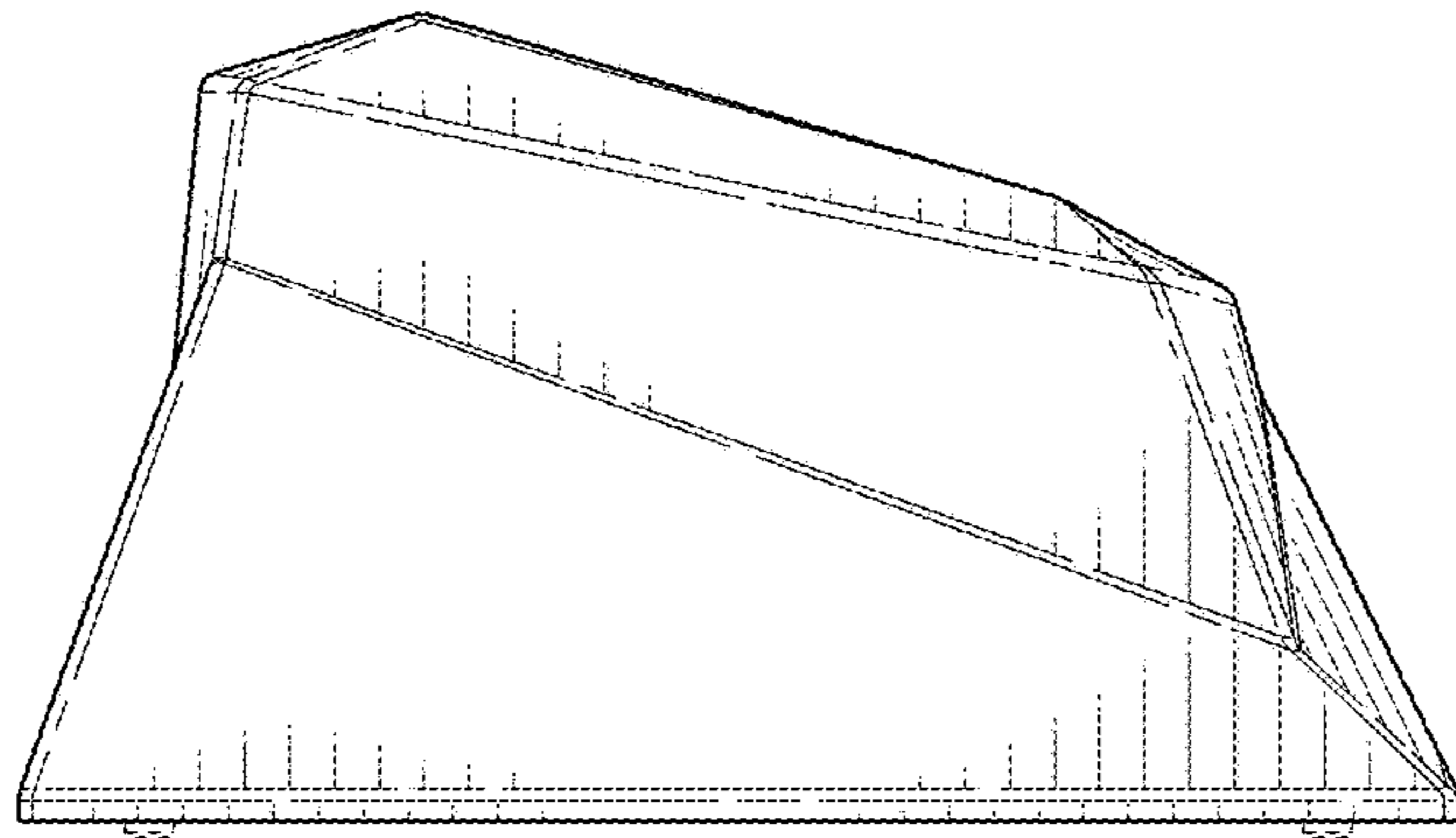

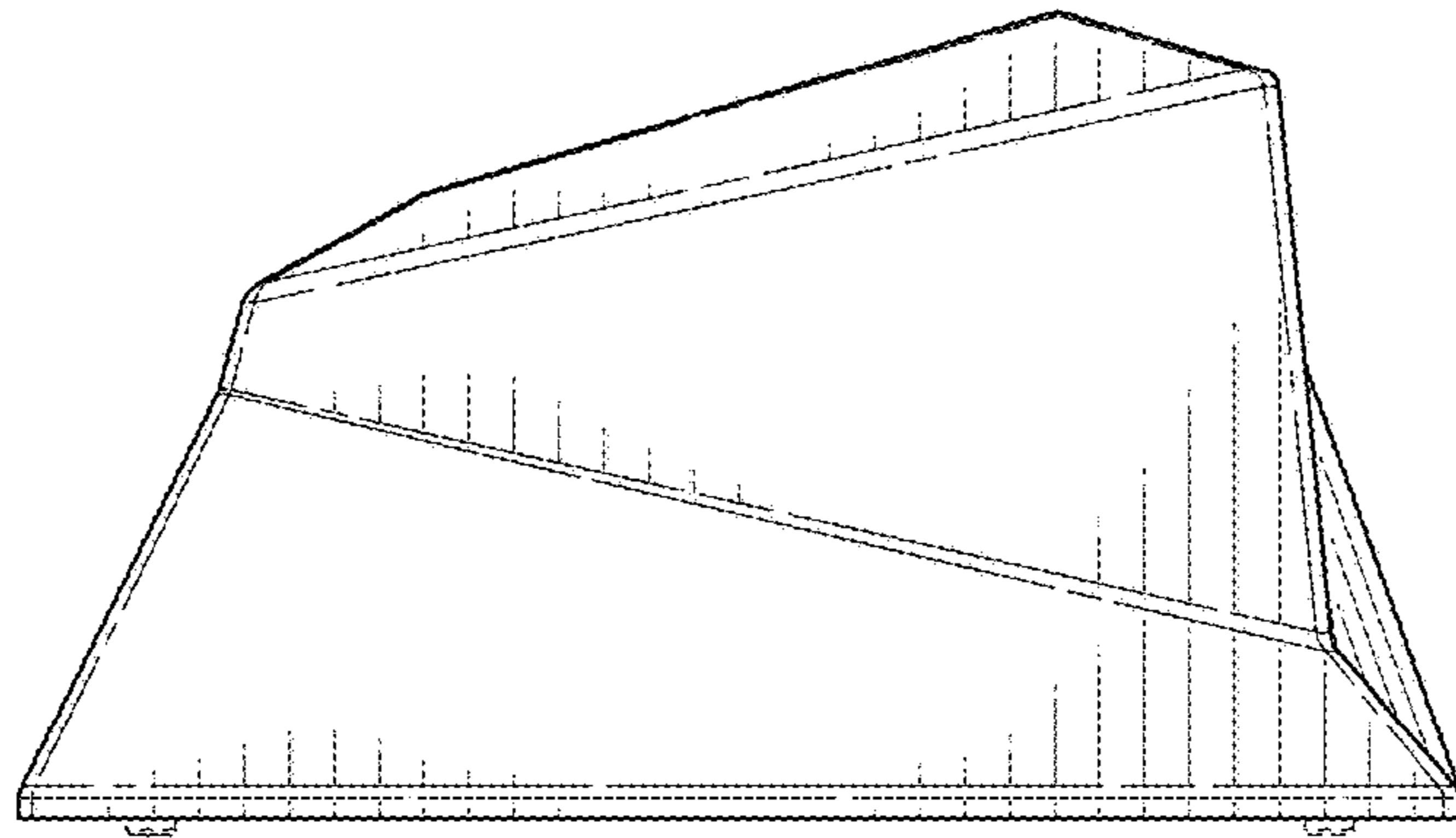

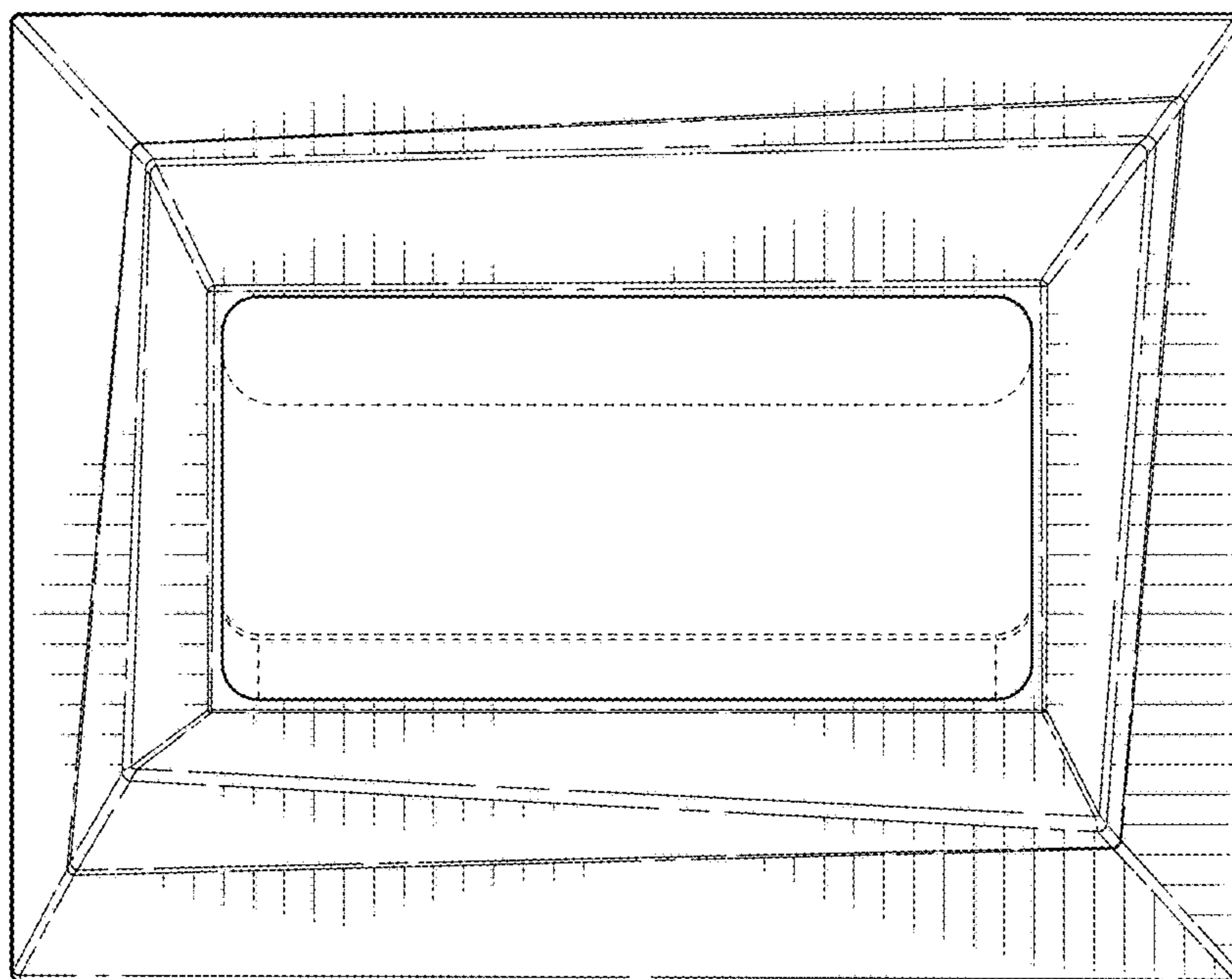

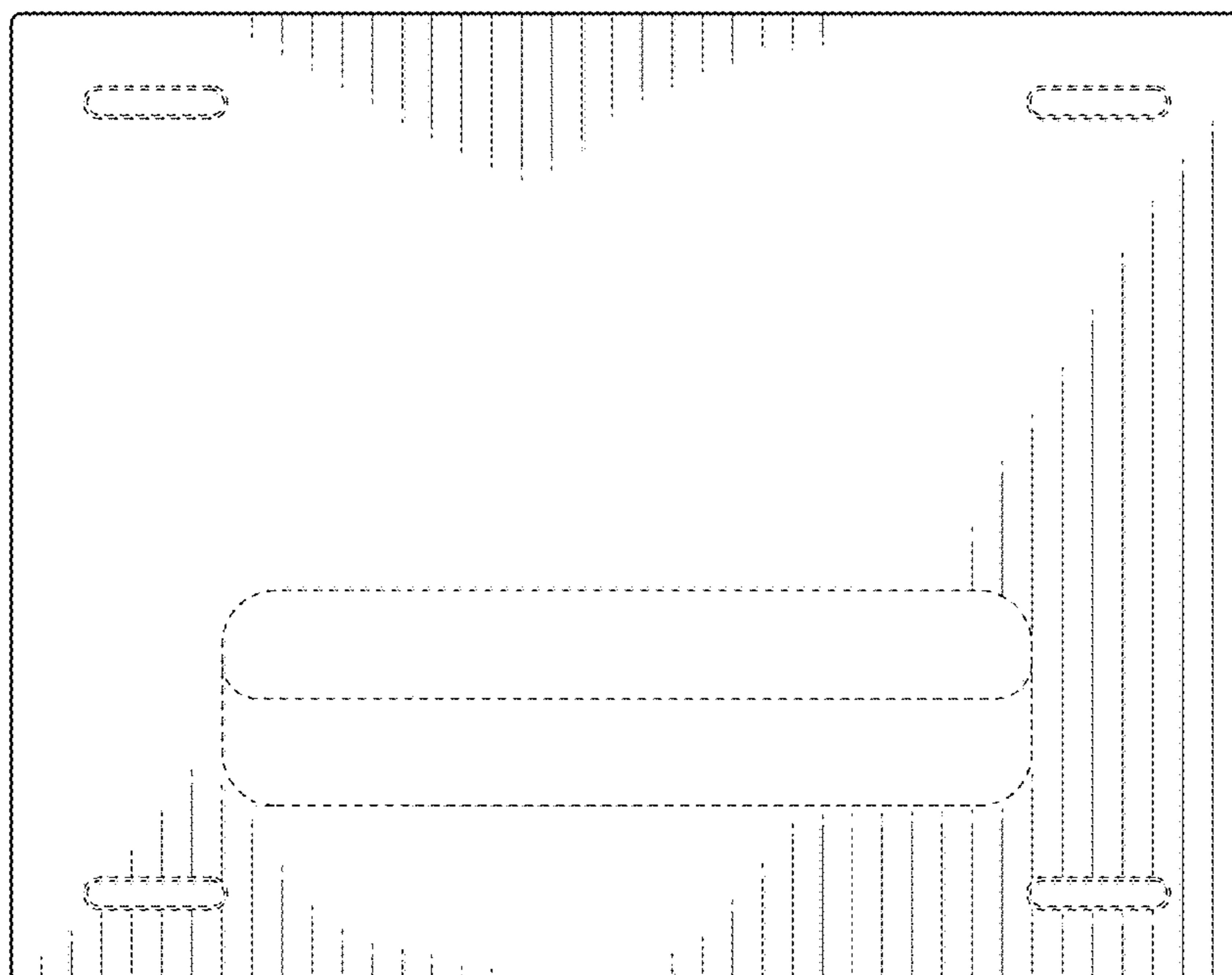
