(57) **CLAIM**

We claim the ornamental design for a wine cooler, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wine cooler showing my new design.

FIG. 2 is a front view thereof;

FIG. 5 is a second side view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof.

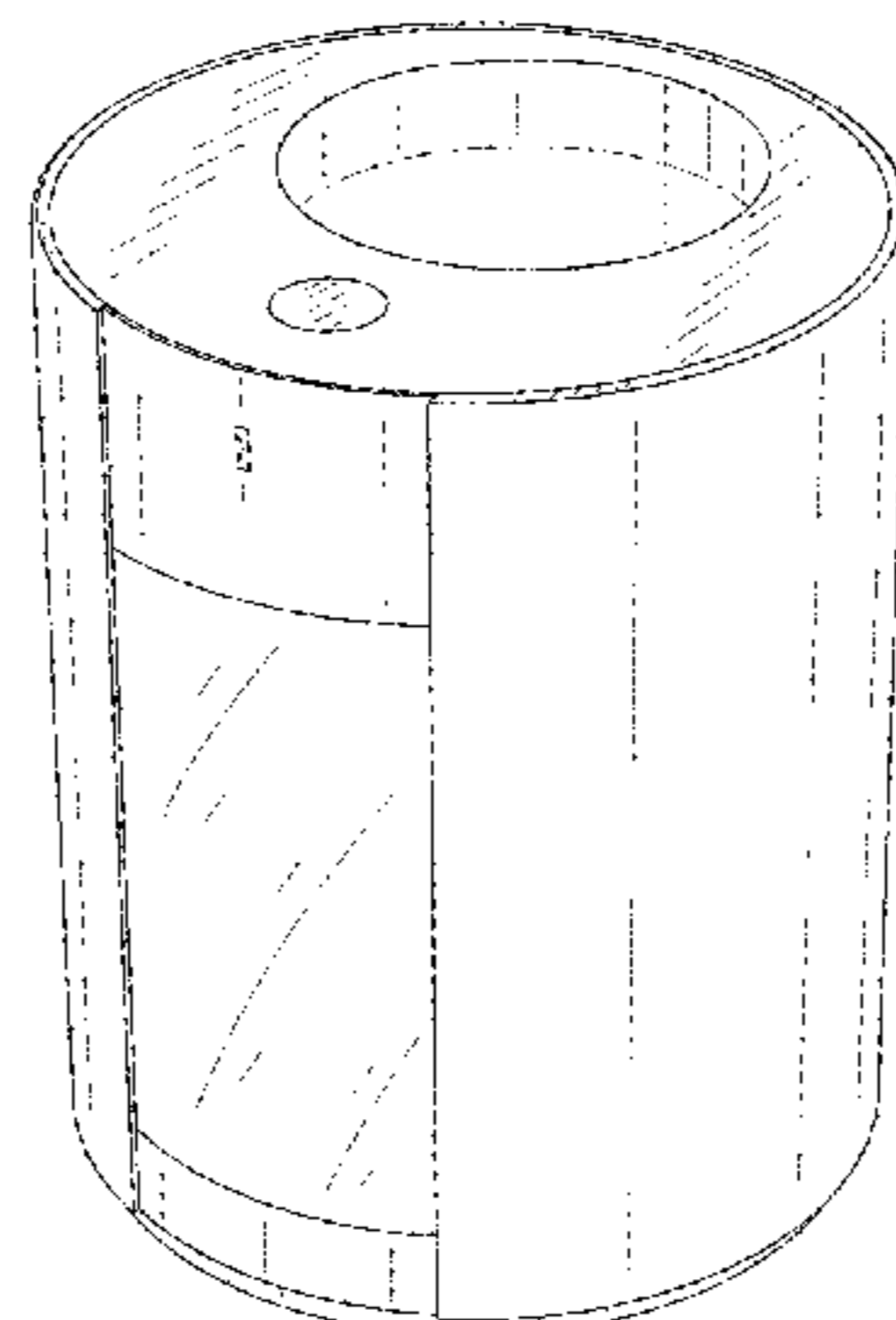

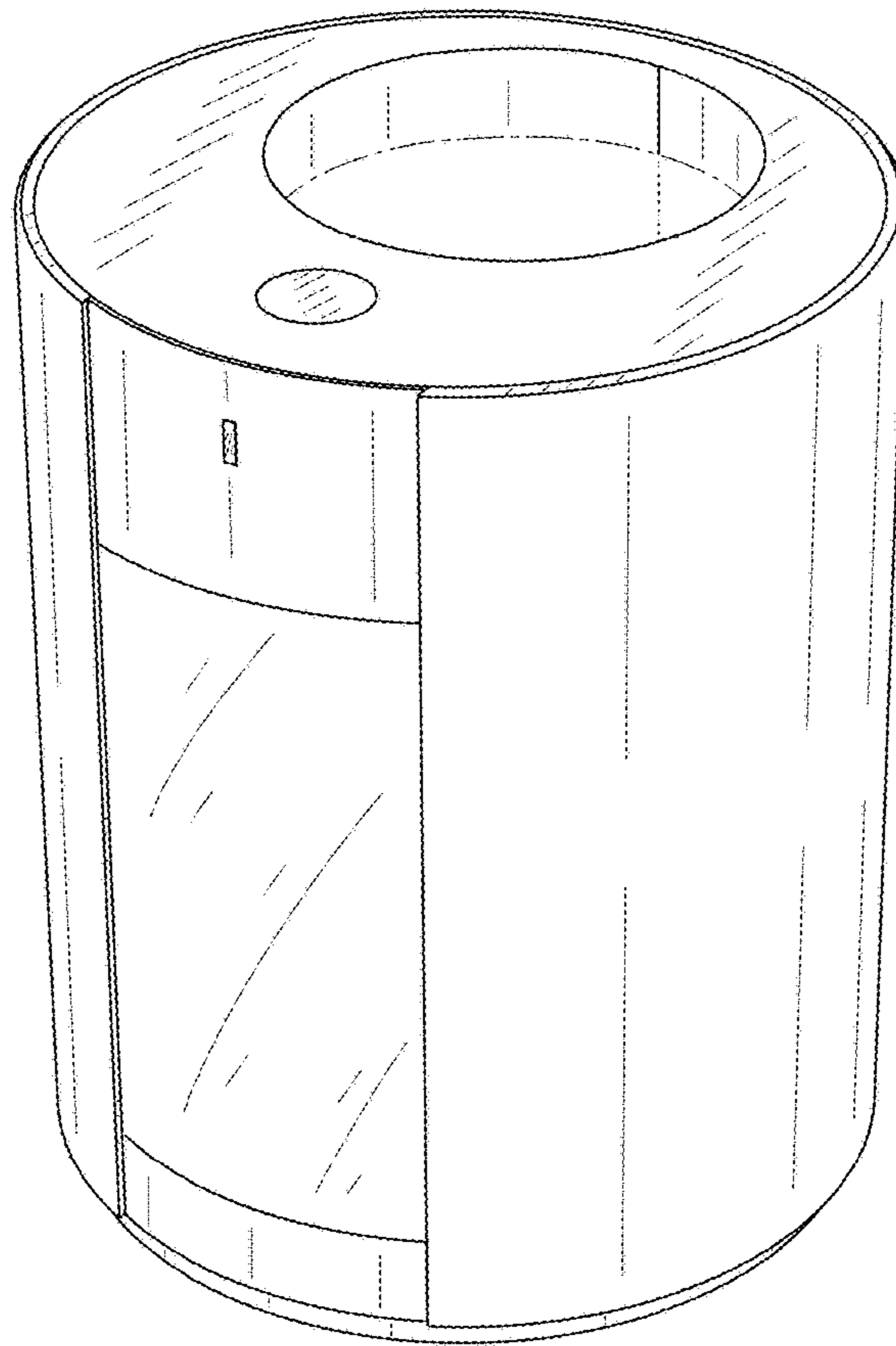

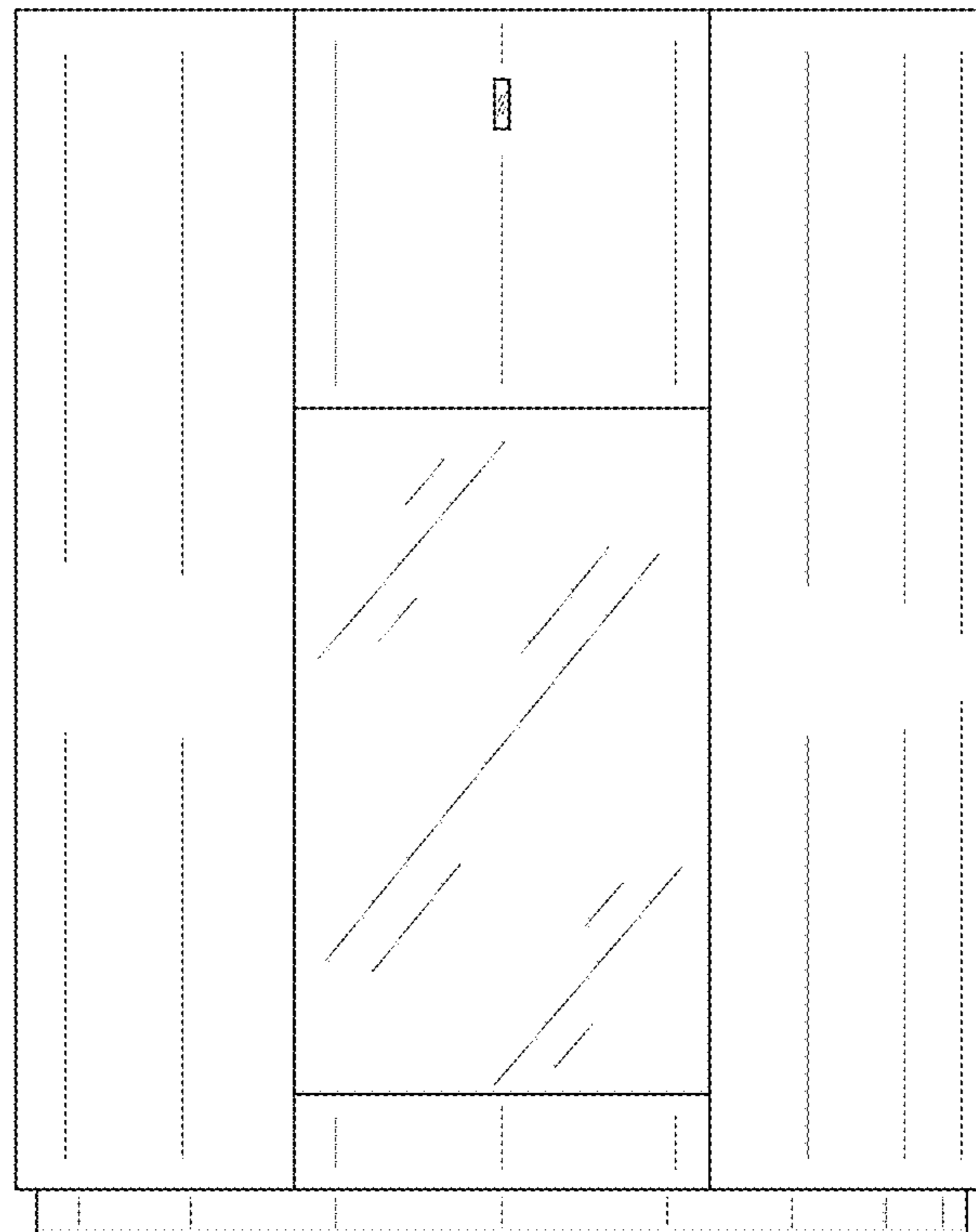

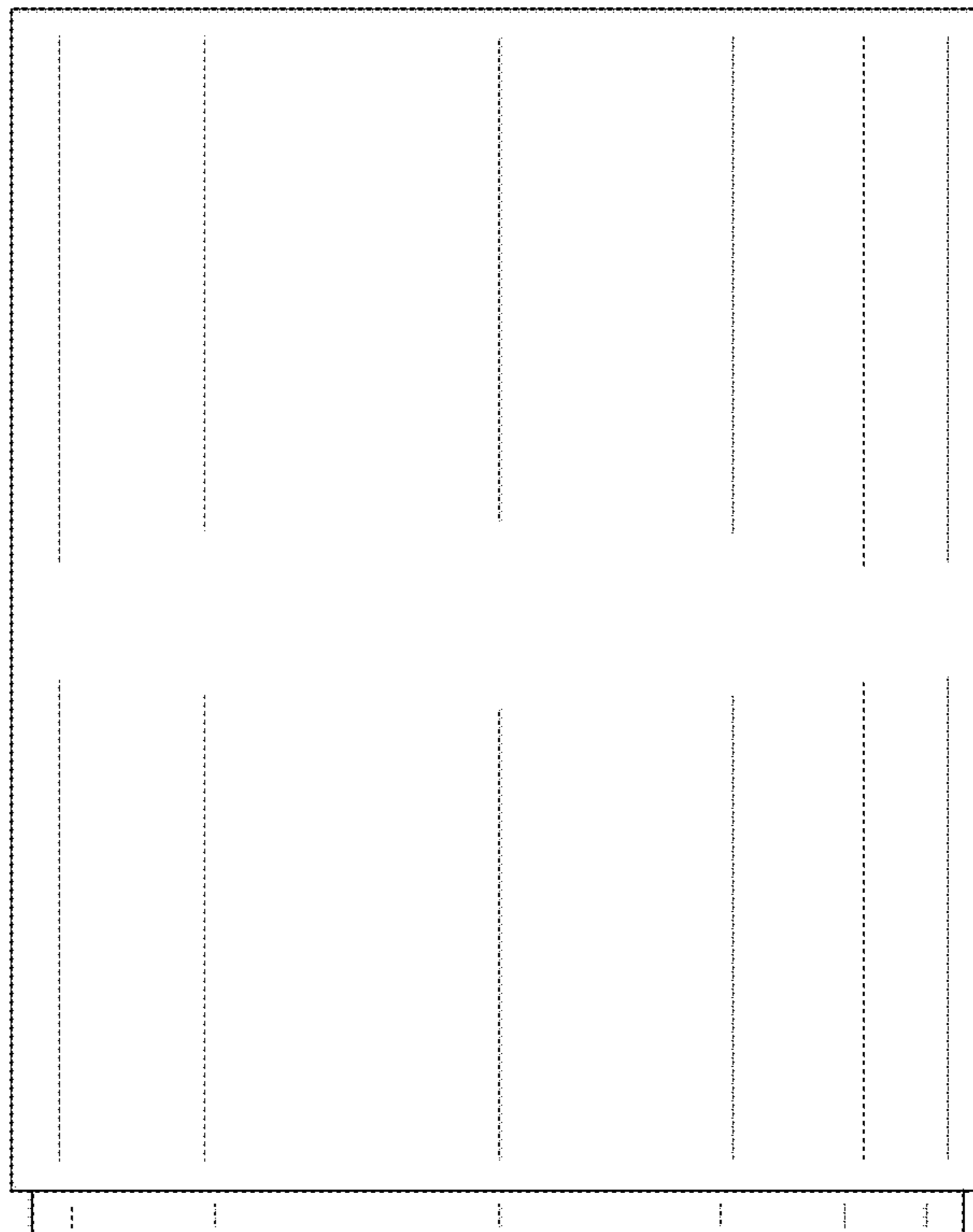

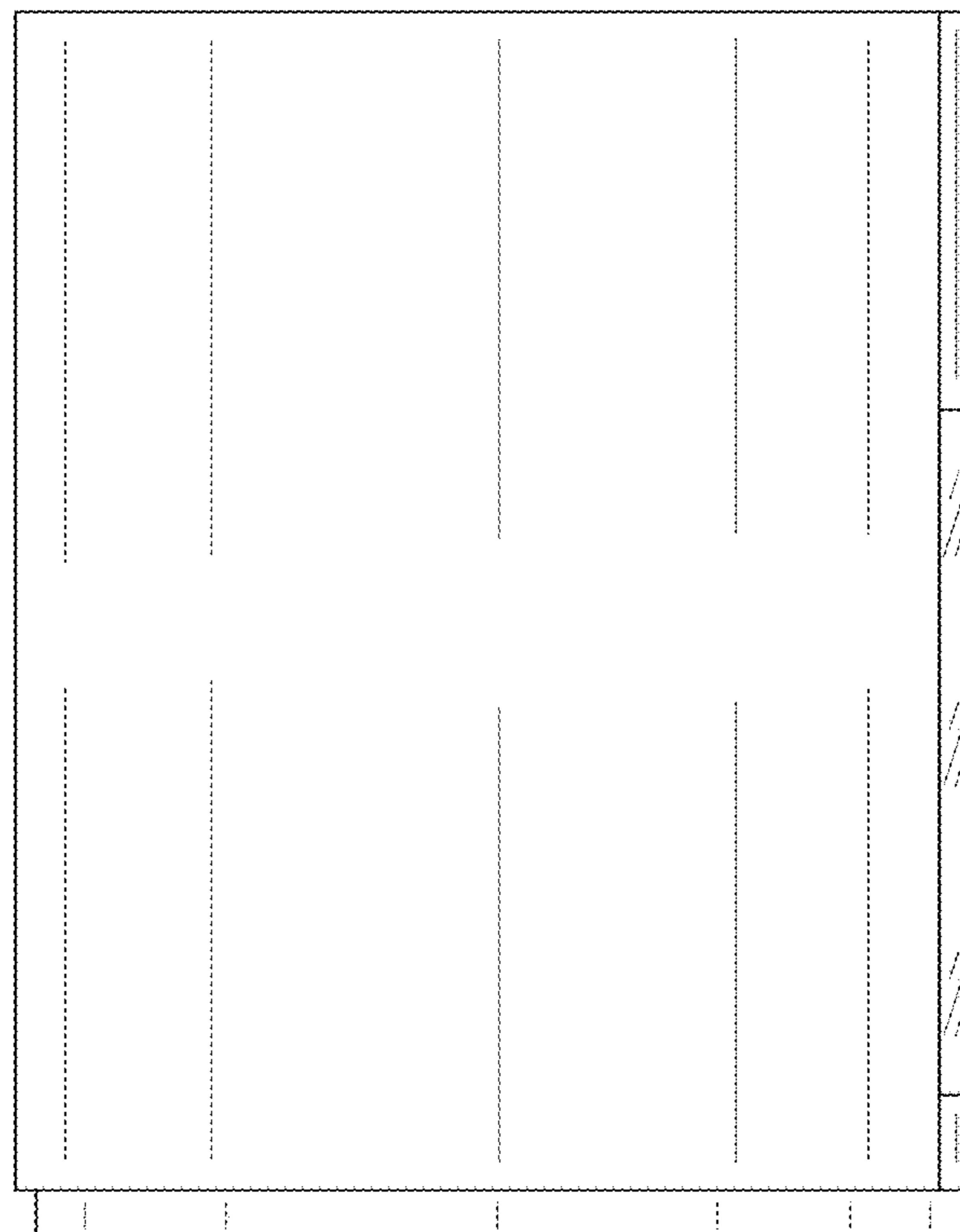

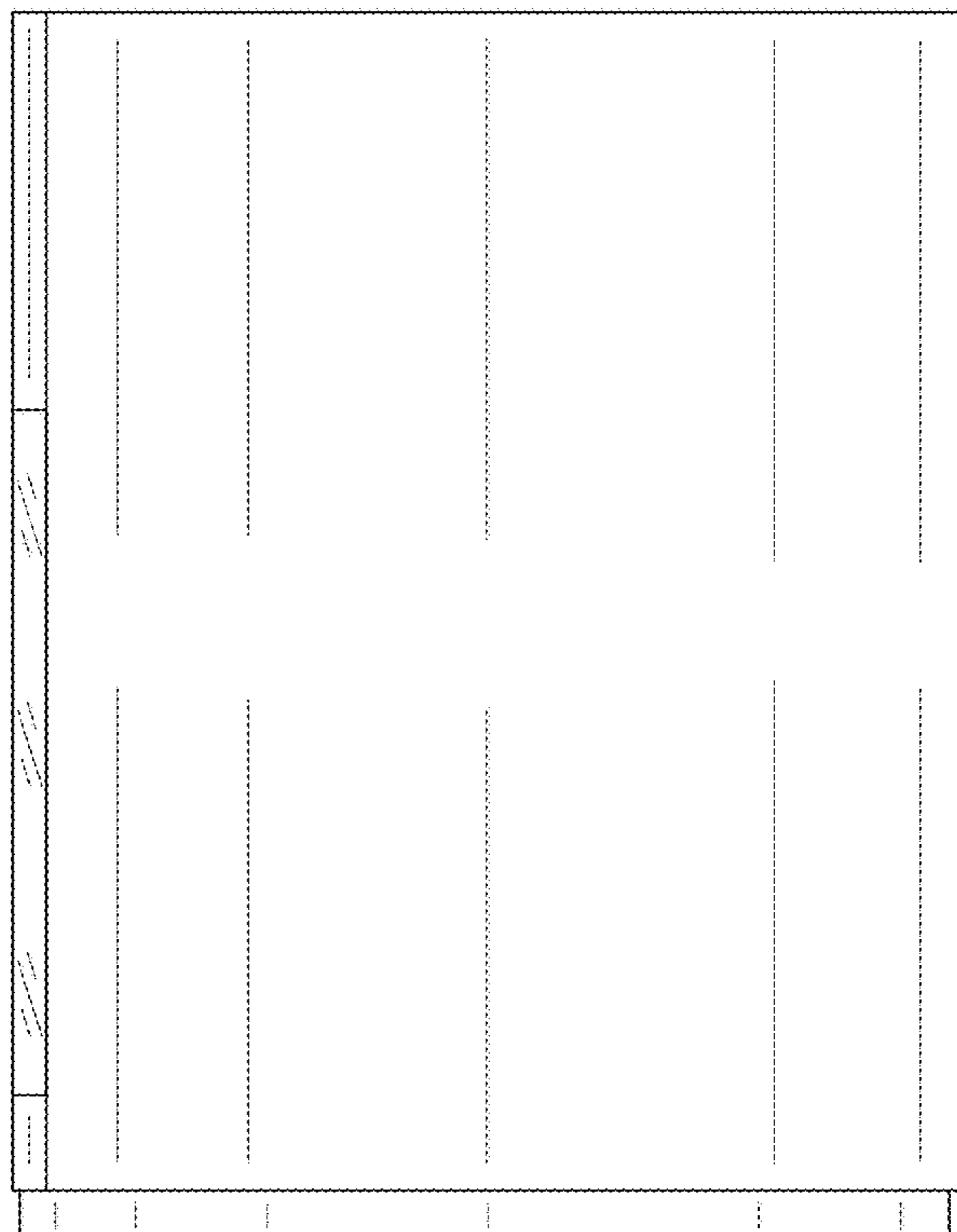

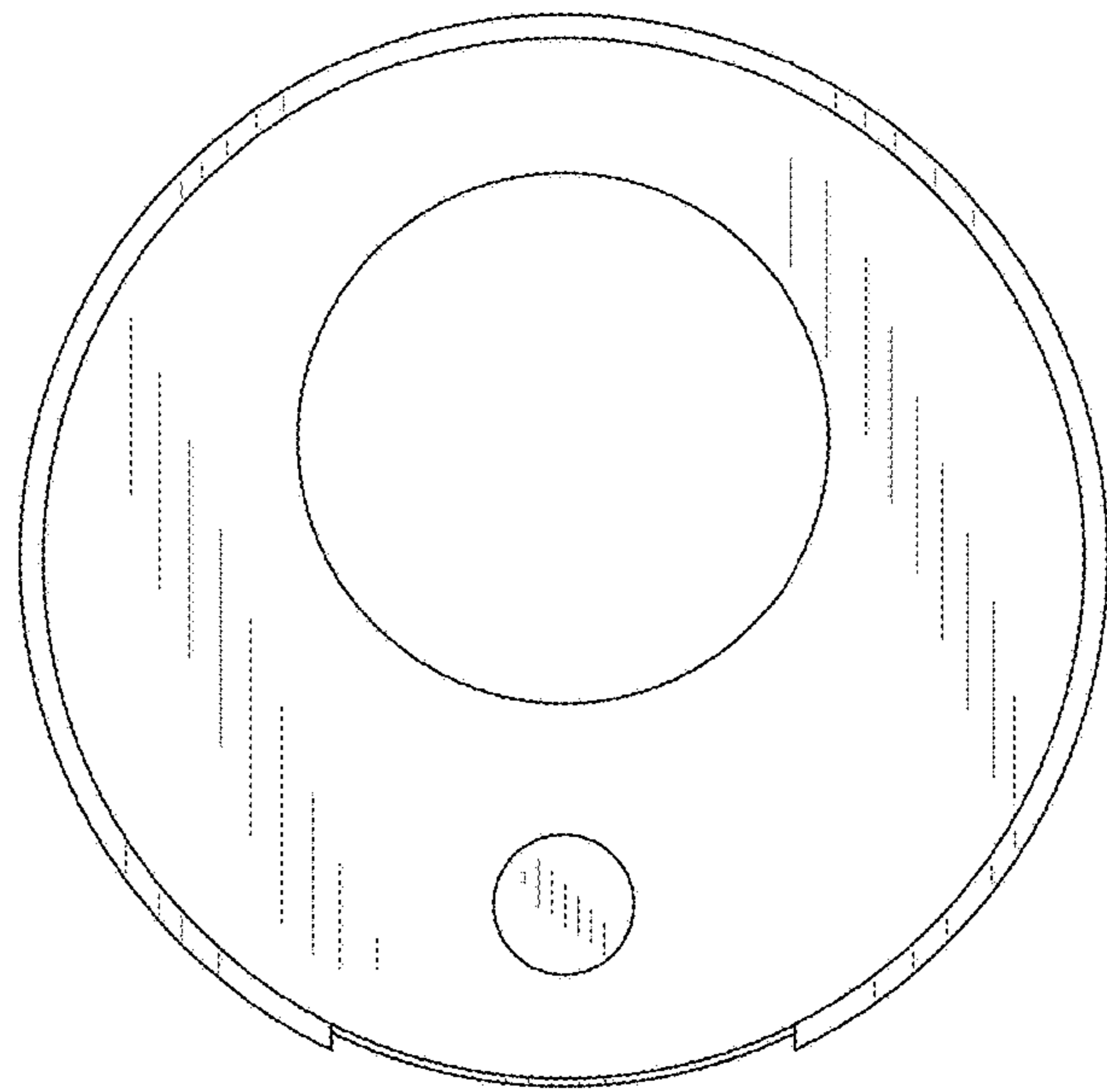
