The ornamental design for a power tool accessory, as shown  
and described.

**DESCRIPTION**

Cross reference is made to copending U.S. design patent  
application Ser. No. 29/611,818 entitled “Power Tool Cou-  
pling Portion” by Luescher et al., filed on Jul. 26, 2017.

FIG. 1 is a perspective view of a power tool accessory  
showing our new design;

FIG. 2 is a top plan view of the power tool accessory of FIG.  
1;

FIG. 3 is a bottom plan view of the power tool accessory of  
FIG. 1;

FIG. 4 is a right side elevational view of the power tool  
accessory of FIG. 1;

FIG. 5 is a left side elevational view of the power tool  
accessory of FIG. 1;

FIG. 6 is a front elevational view of the power tool accessory  
of FIG. 1; and,

FIG. 7 is a rear elevational view of the power tool accessory  
of FIG. 1.

claimed design. The dot-dash broken lines shown in the

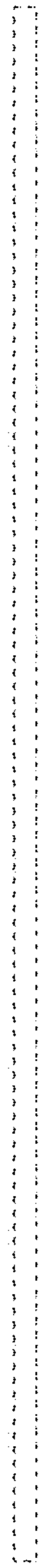

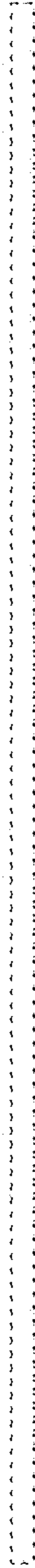

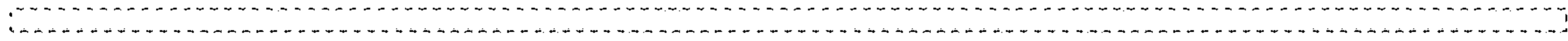

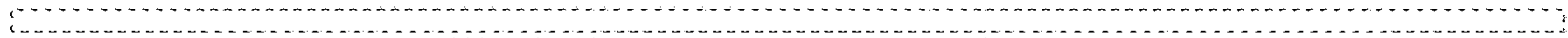
