DESCRIPTION

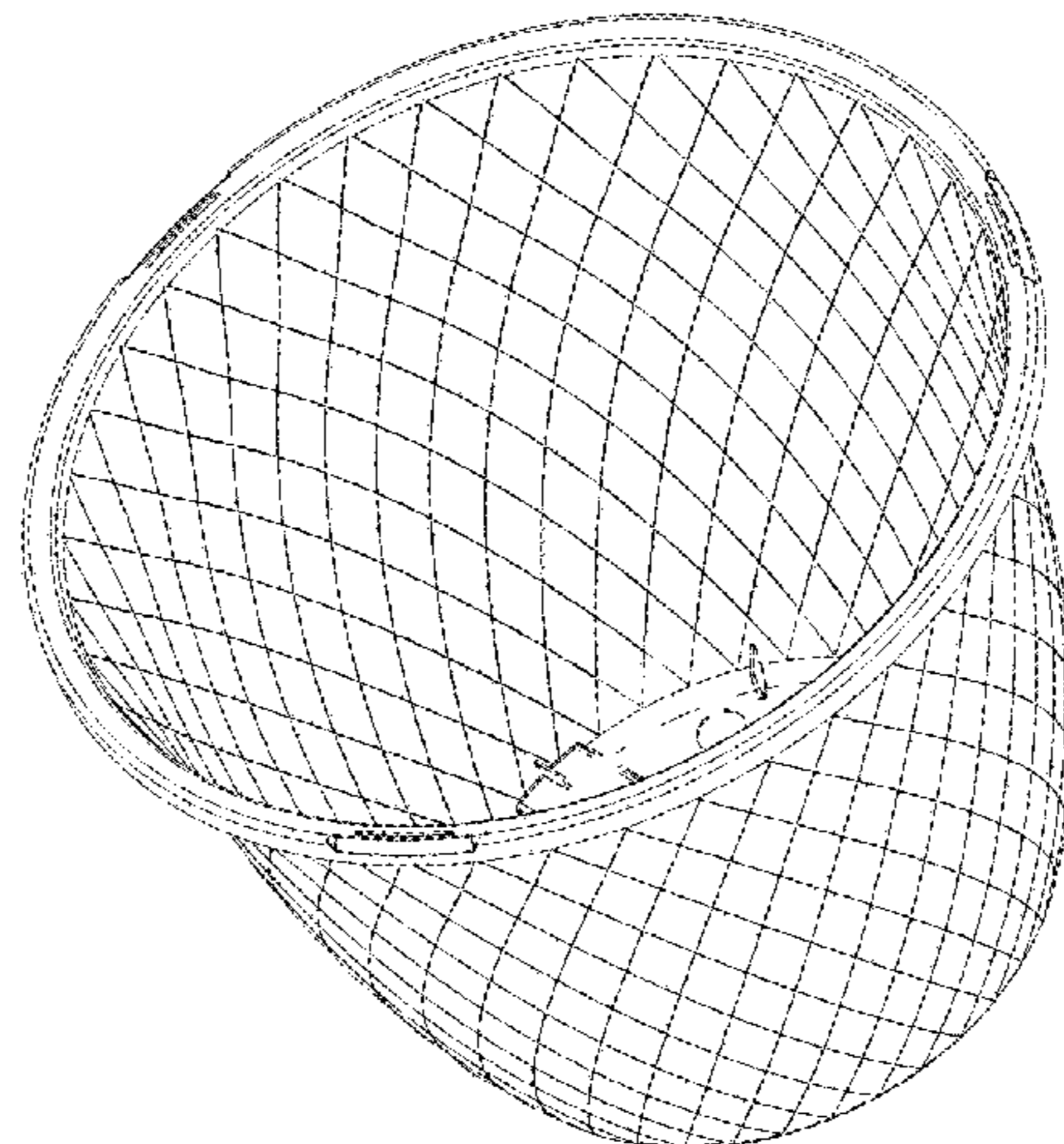
FIG. 1 is a perspective view of a planter showing our new design.

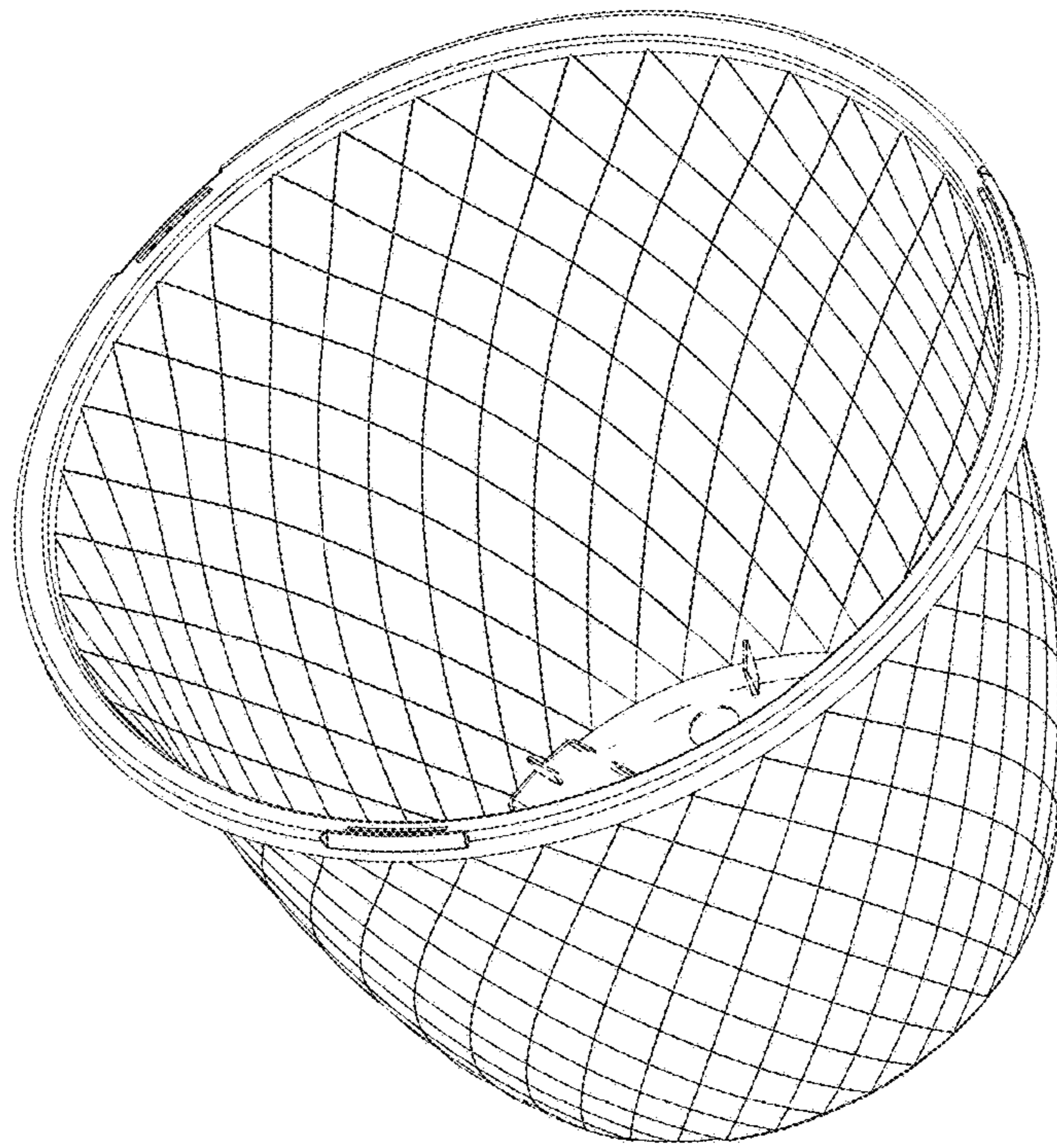

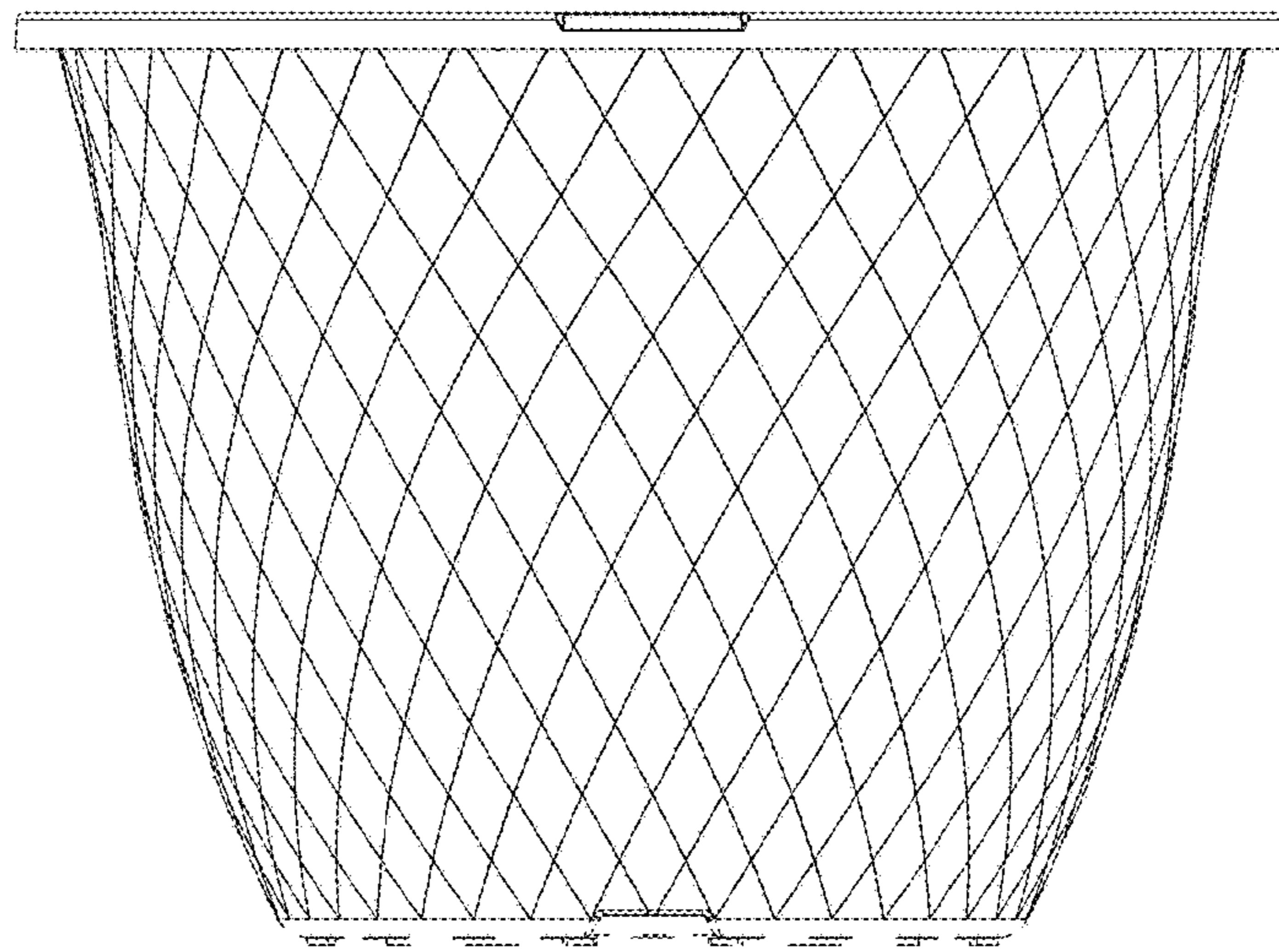

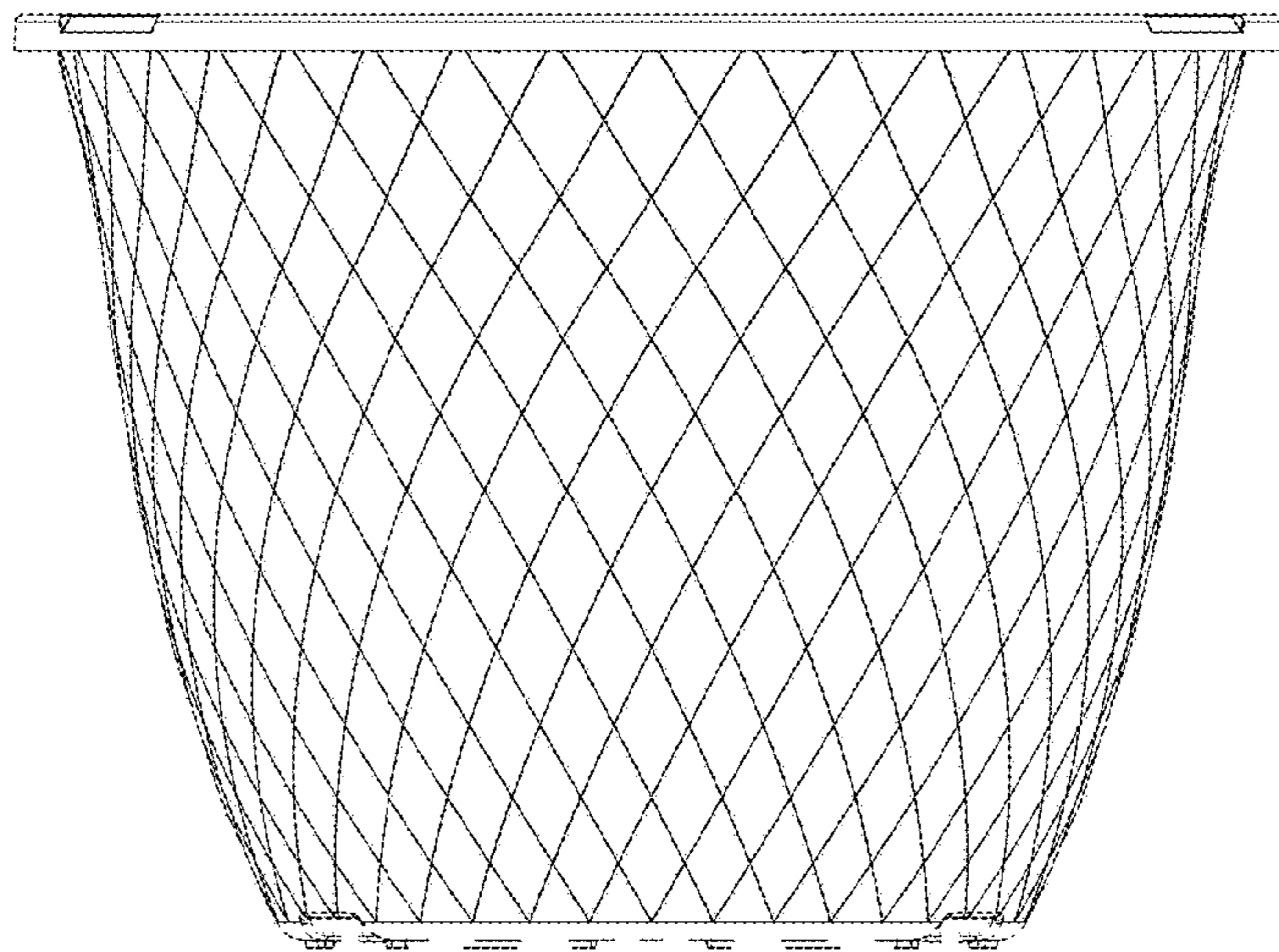

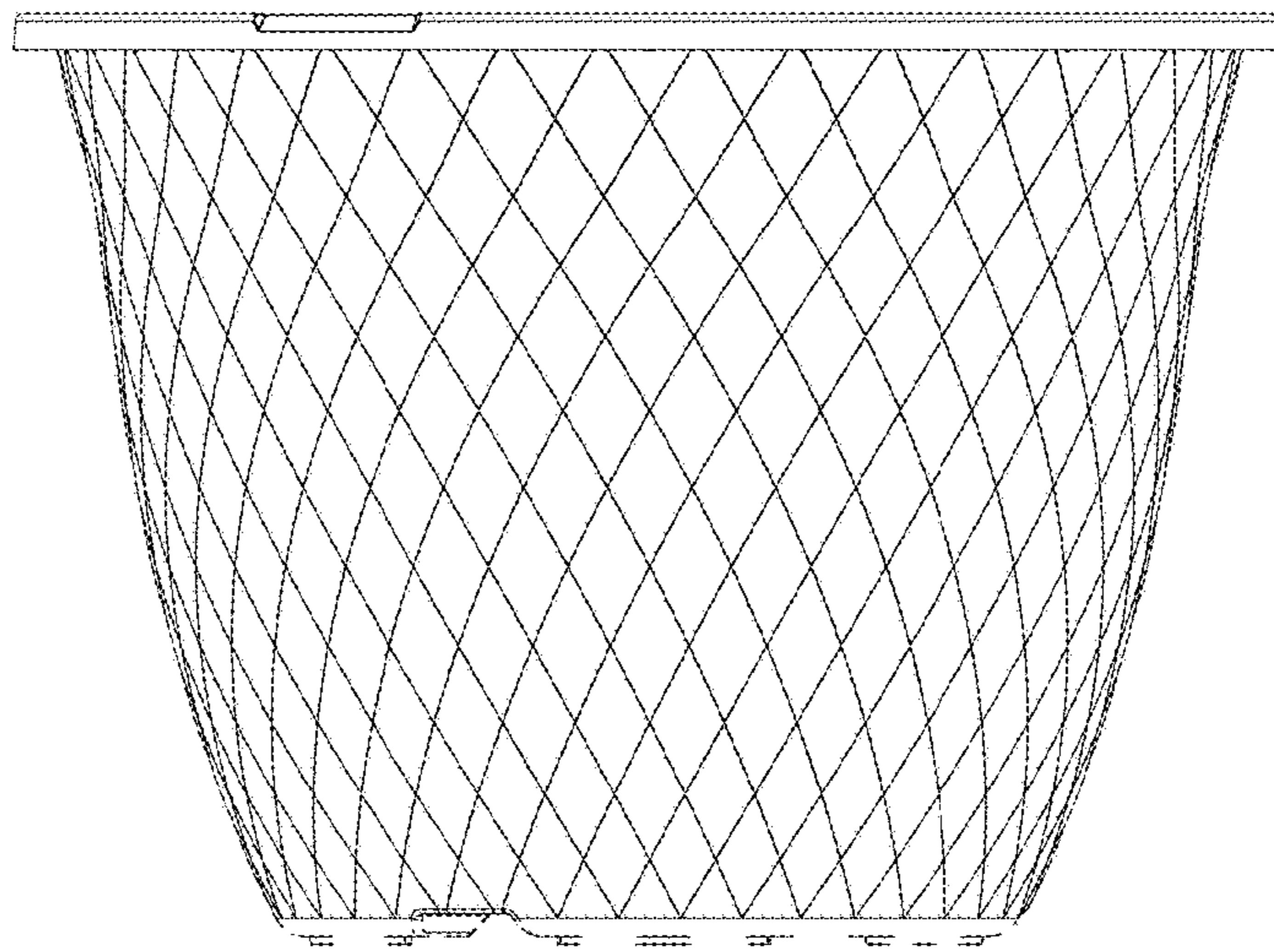

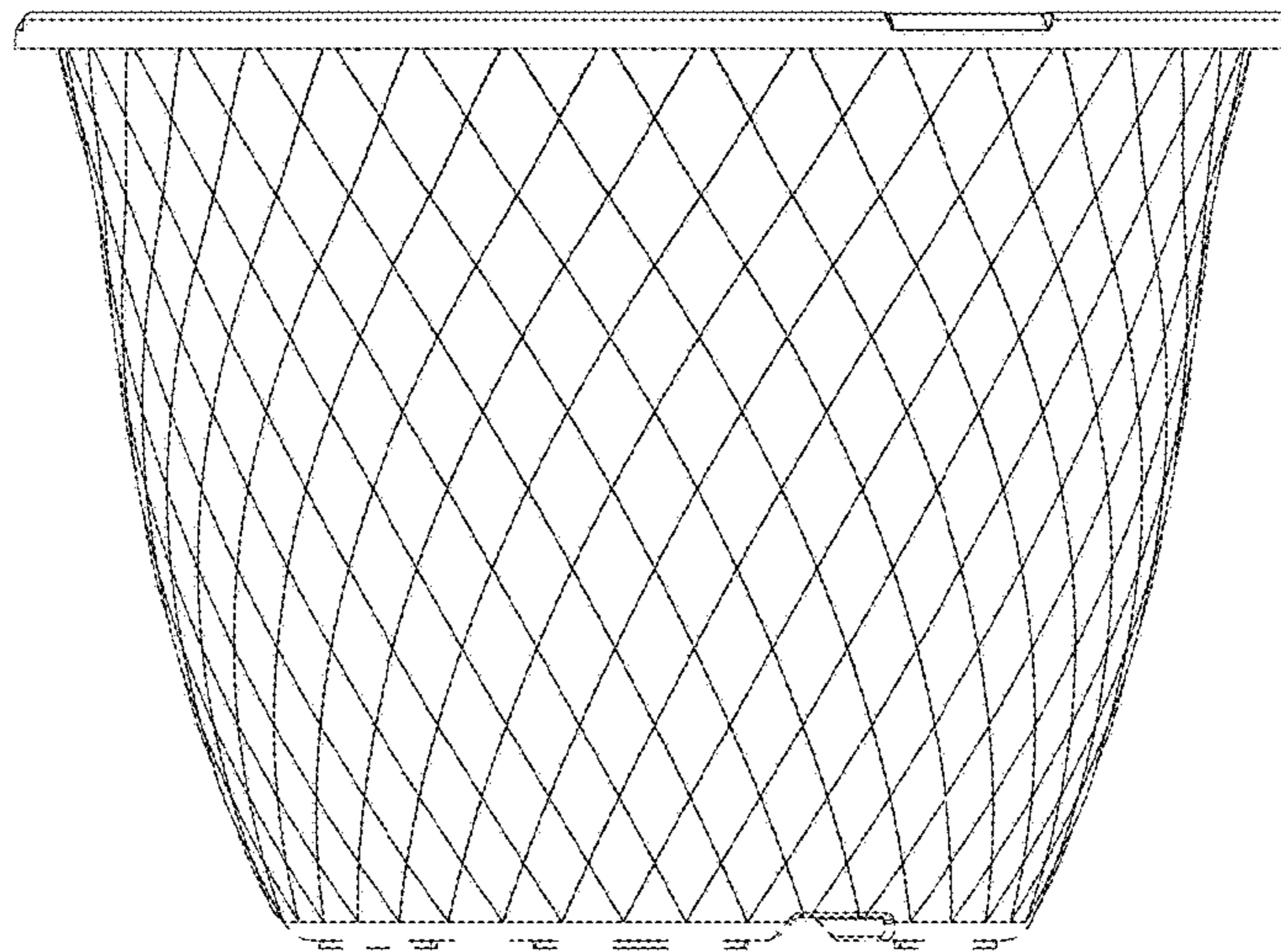

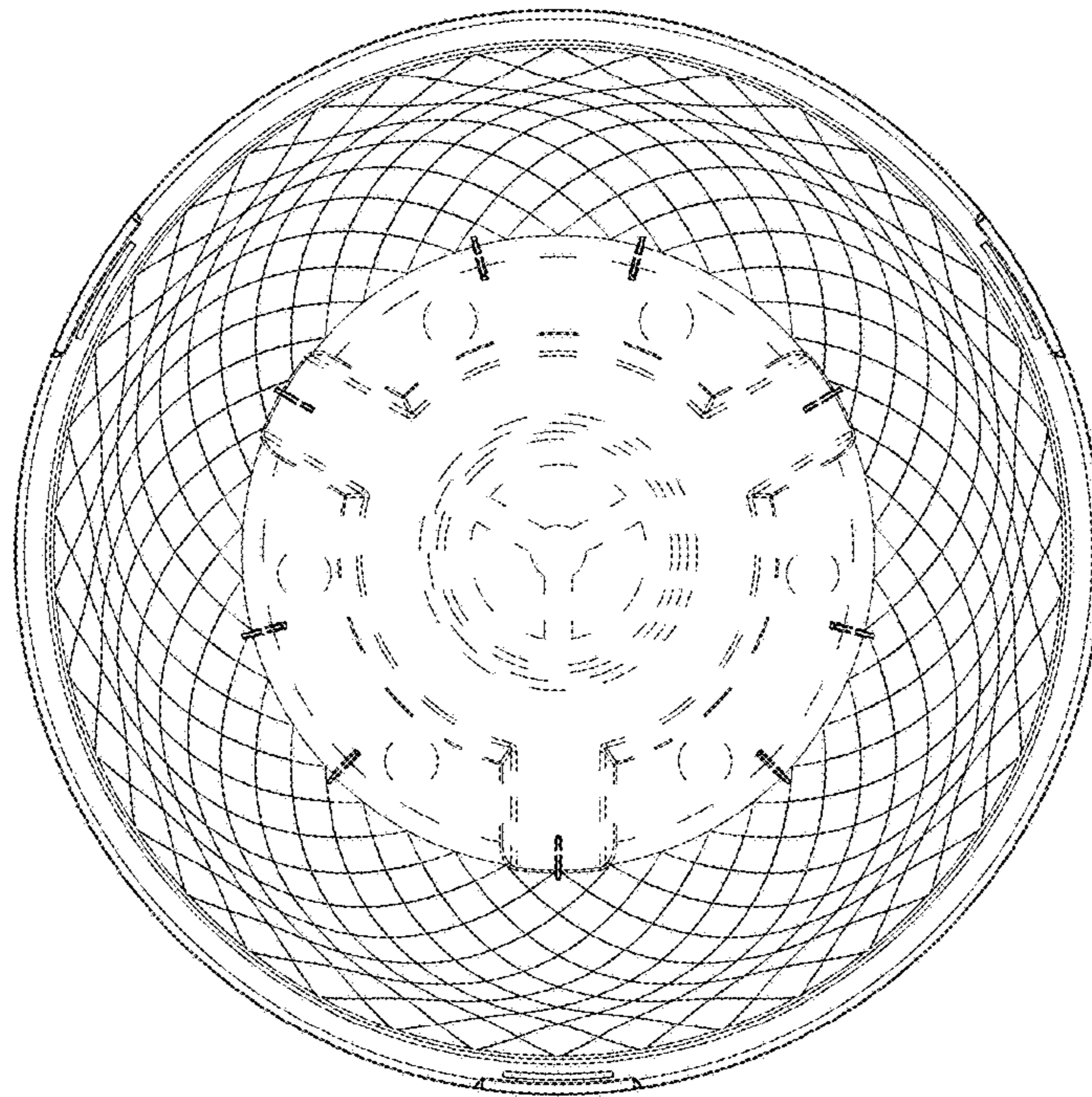

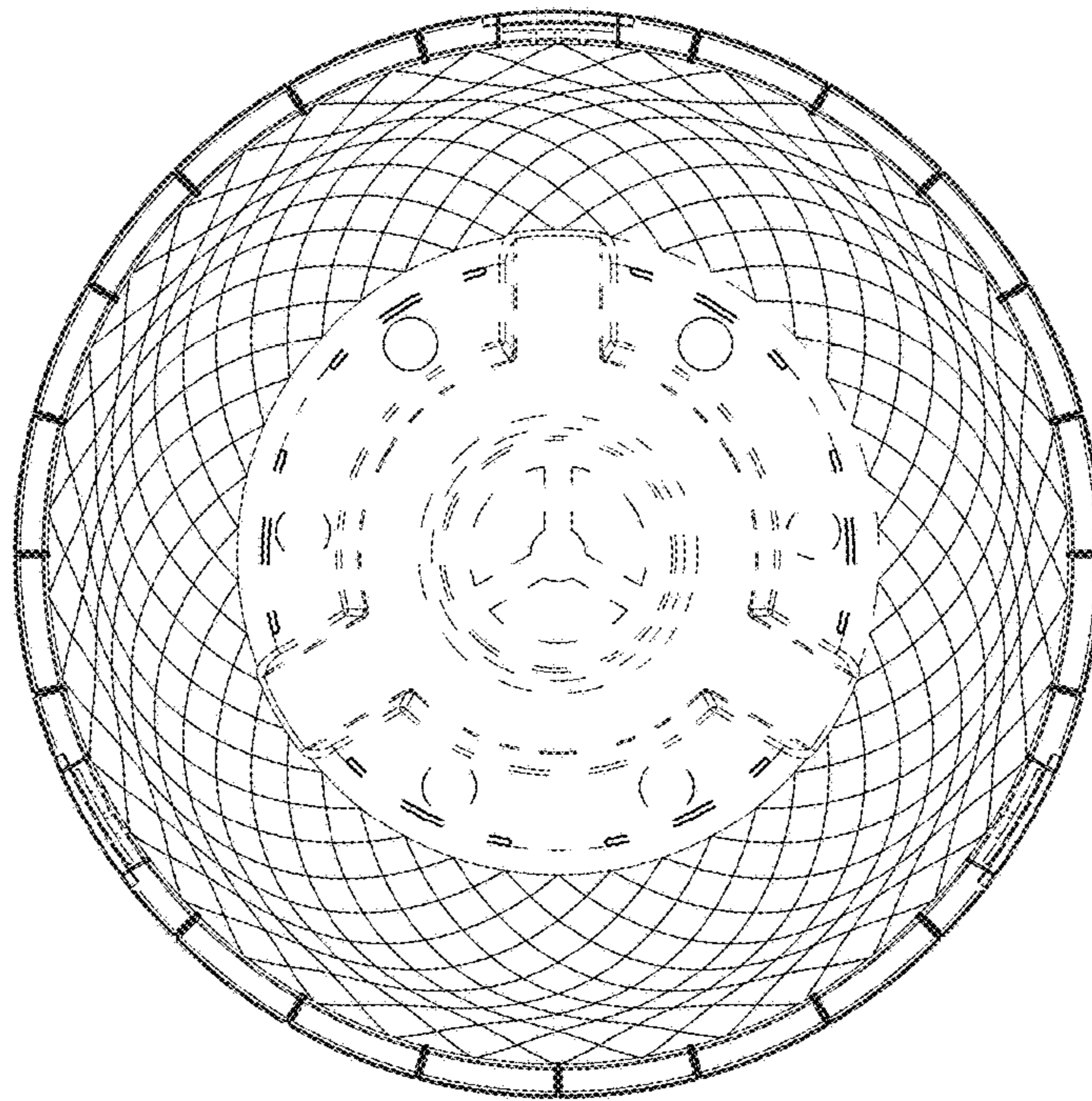
