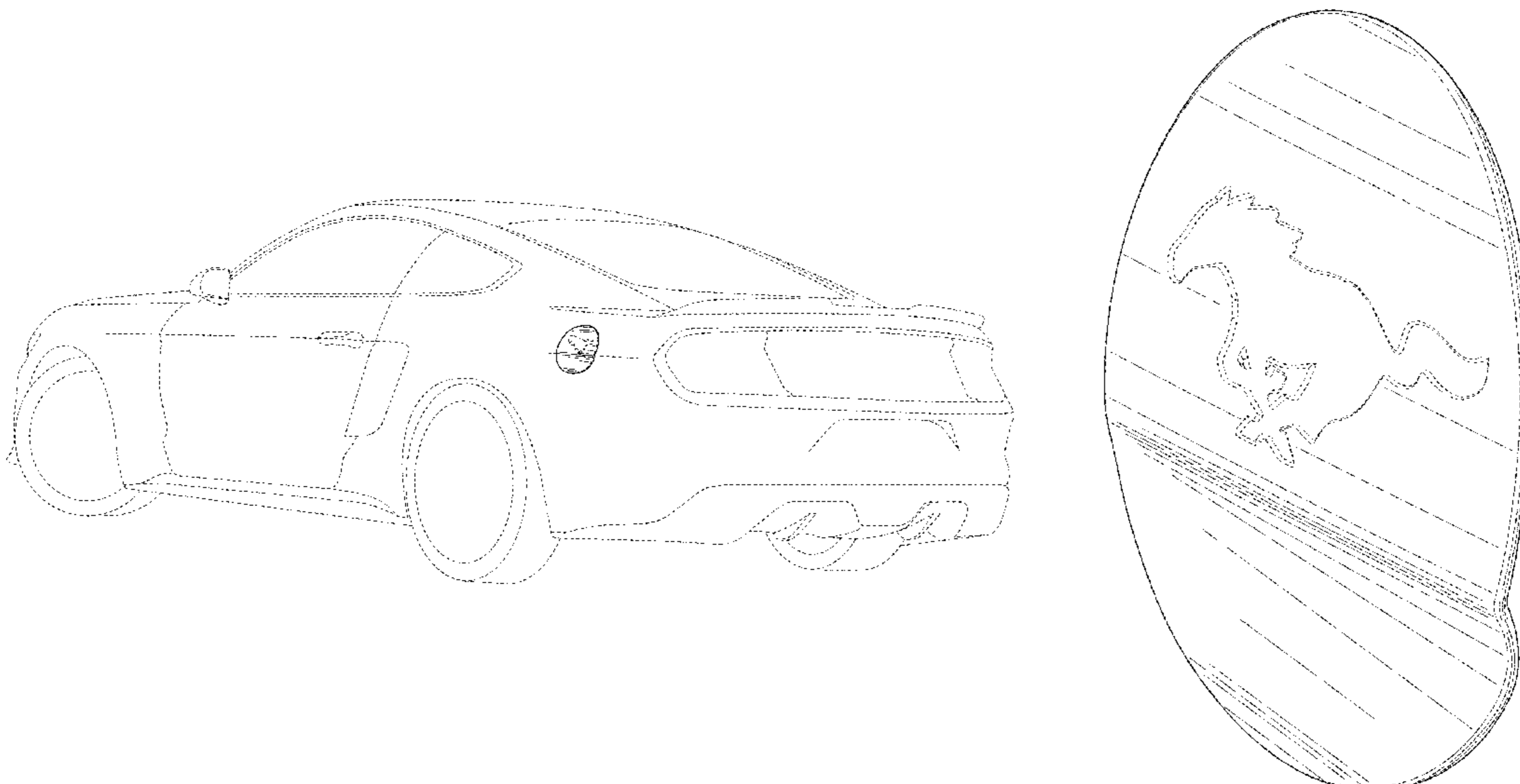
(57) **CLAIM**

The ornamental design for the fuel door, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the fuel door of the present invention in a potential environment; FIG. 2 is a perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof. The broken lines illustrate the design's environment and form no part of the claimed design. The FIG. 4 innermost circular broken line defines the bounds of the claimed design and forms no part thereof.

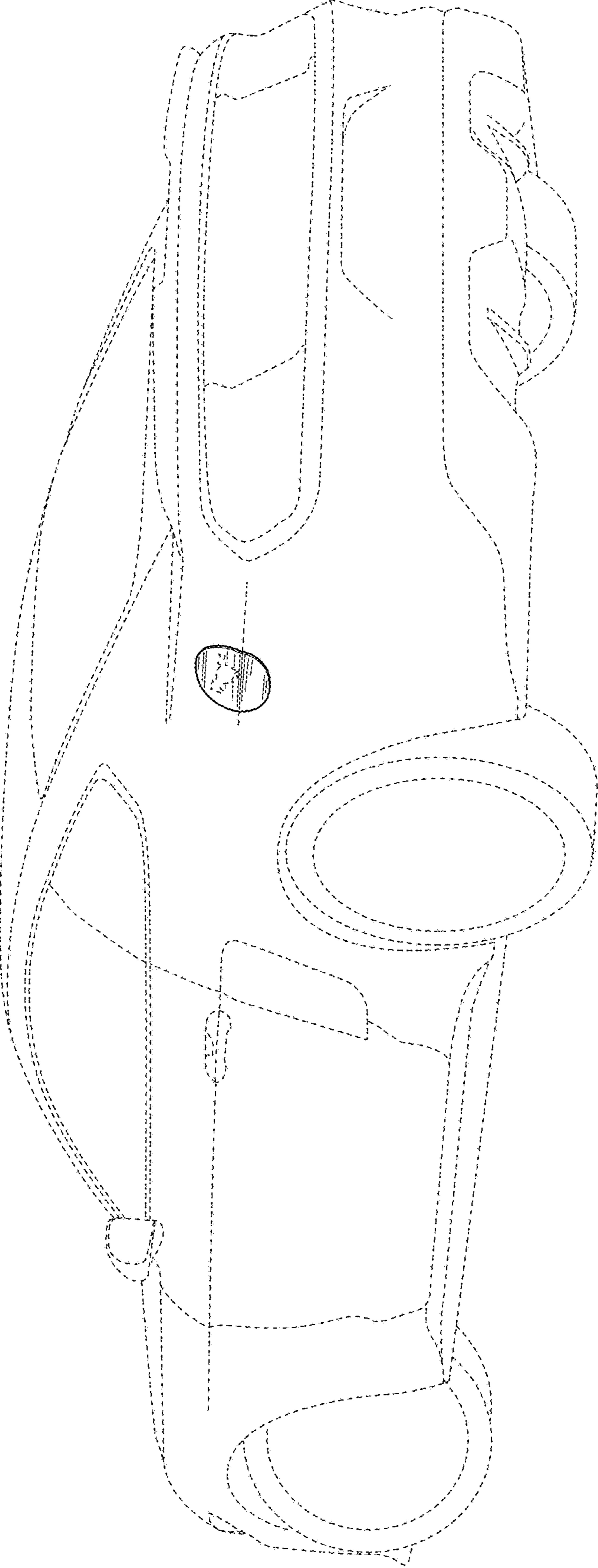
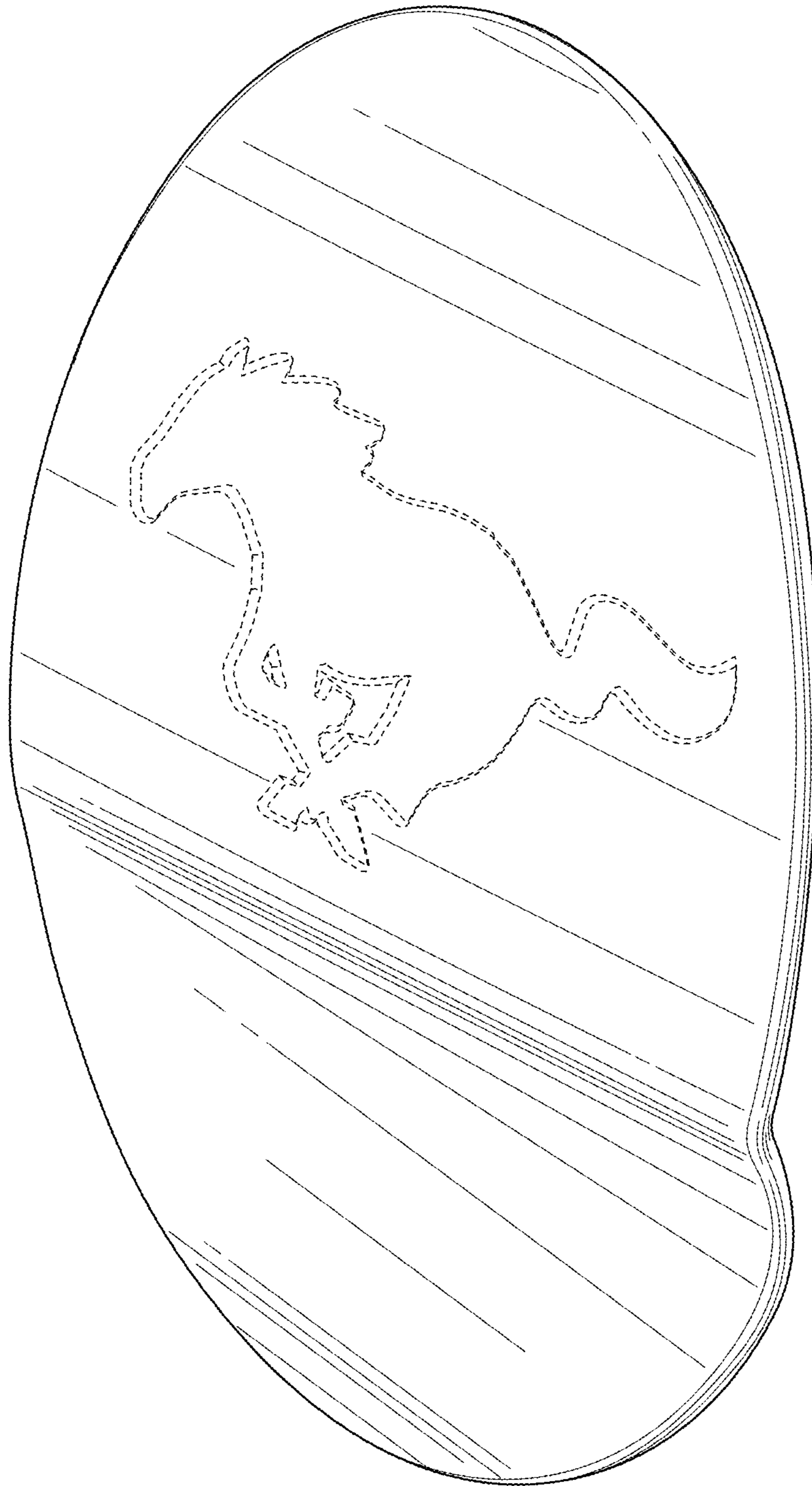

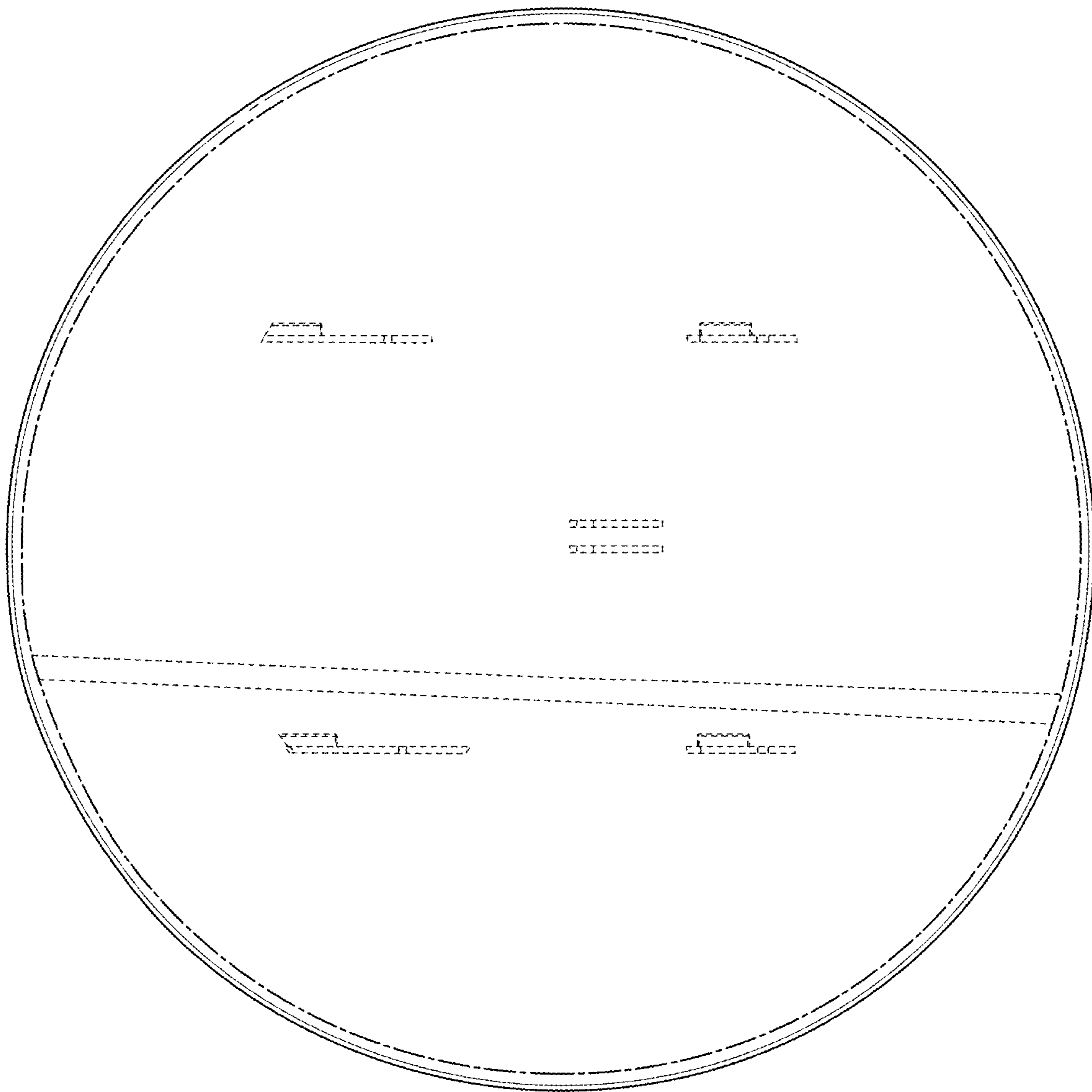

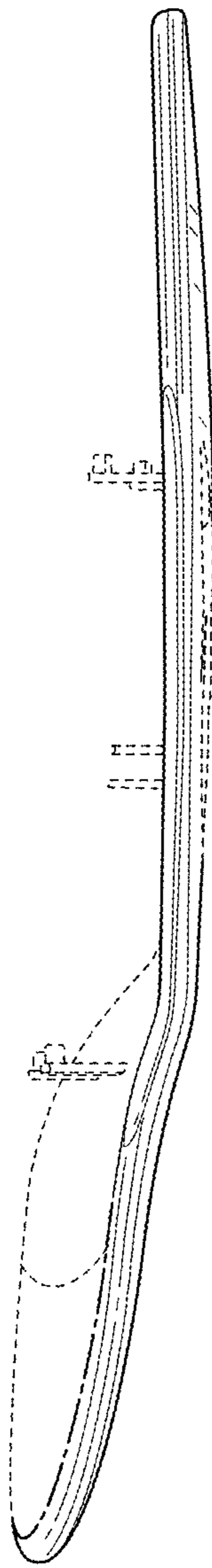

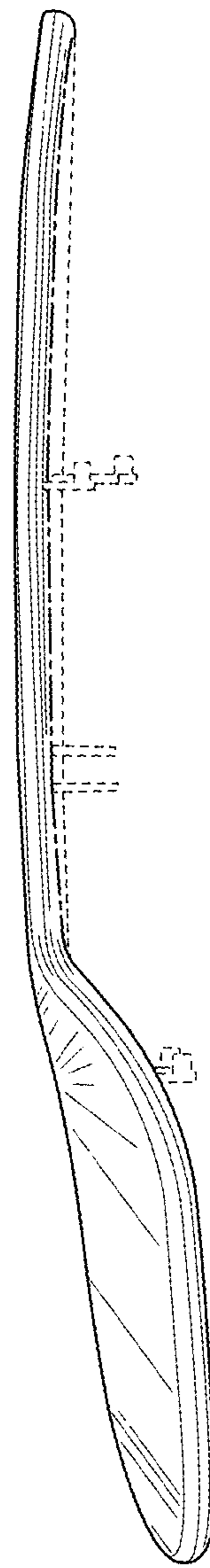

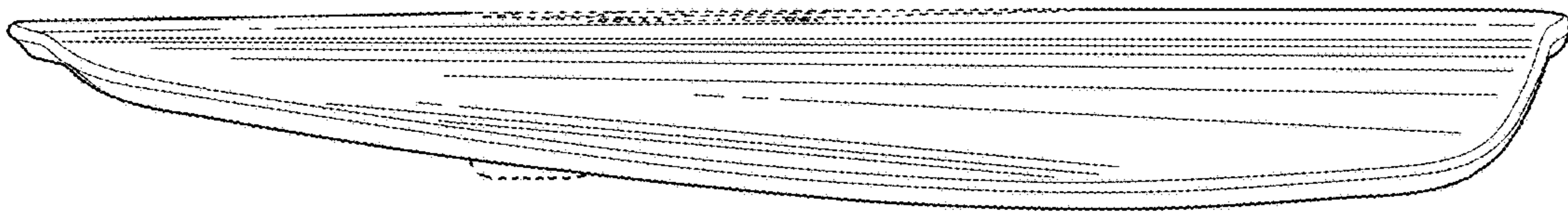

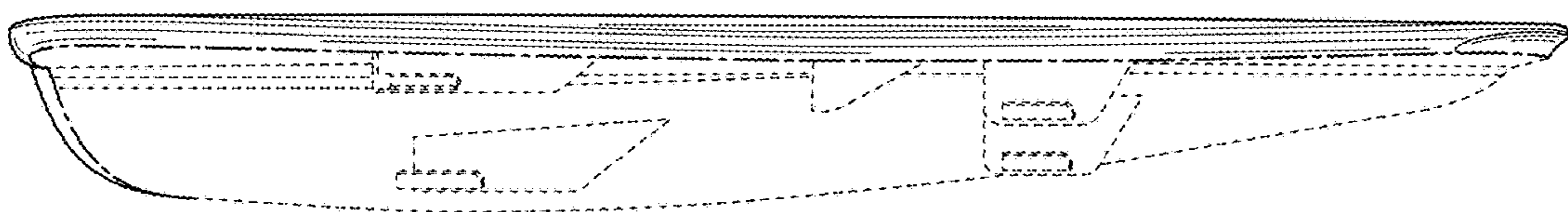
