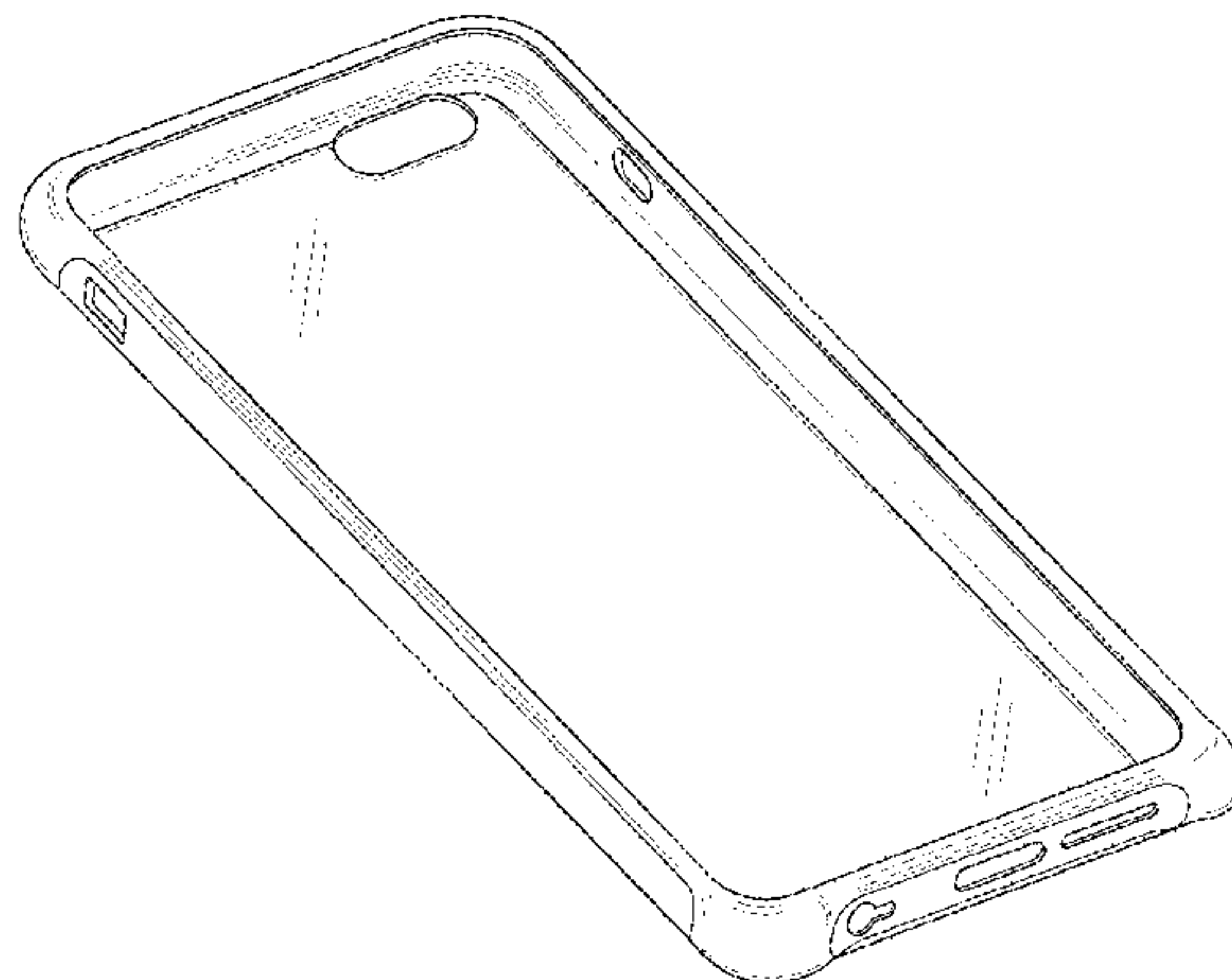
(57) **CLAIM**

The ornamental design for a bumper phone case, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of the bumper phone case, which embodies my design;
FIG. 2 is a back view of the bumper phone case;
FIG. 3 is a front view of the bumper phone case;
FIG. 4 is a right side view of the bumper phone case;
FIG. 5 is left side view of the bumper phone case;
FIG. 6 is a top view of the bumper phone case; and,
FIG. 7 is a bottom view of the bumper phone case.
The oblique shade lines in FIGS. 1-3 indicate a transparent surface.

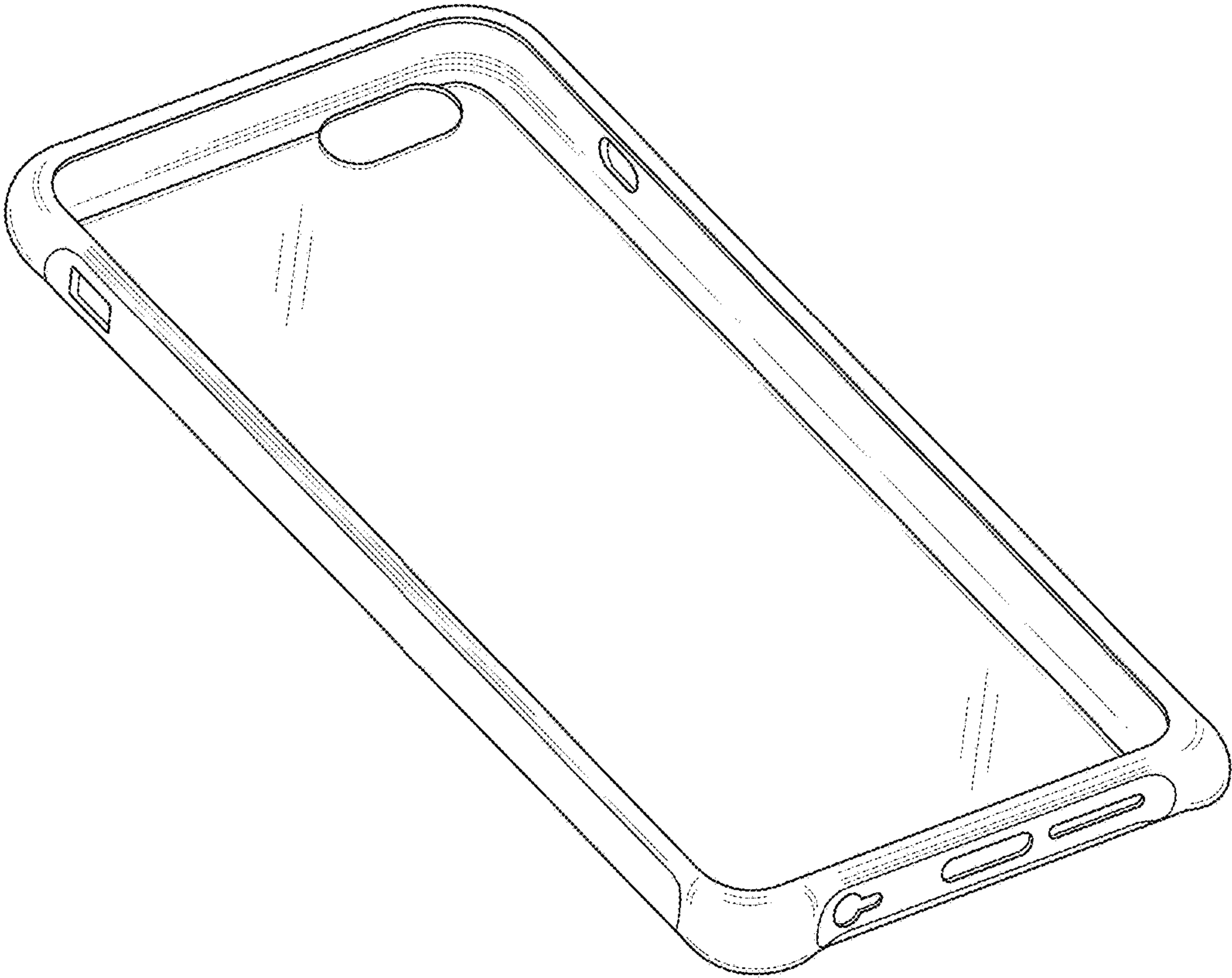

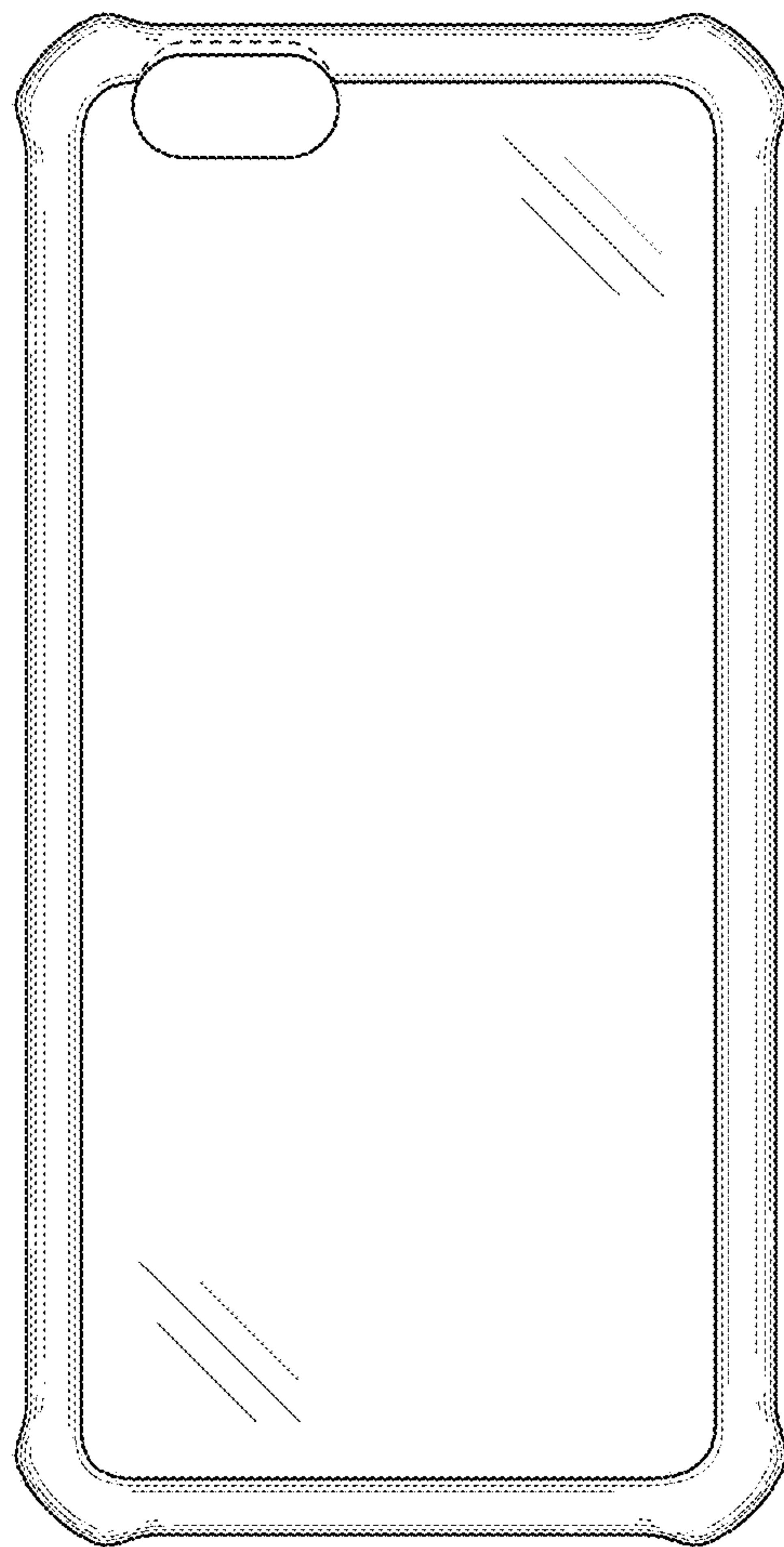

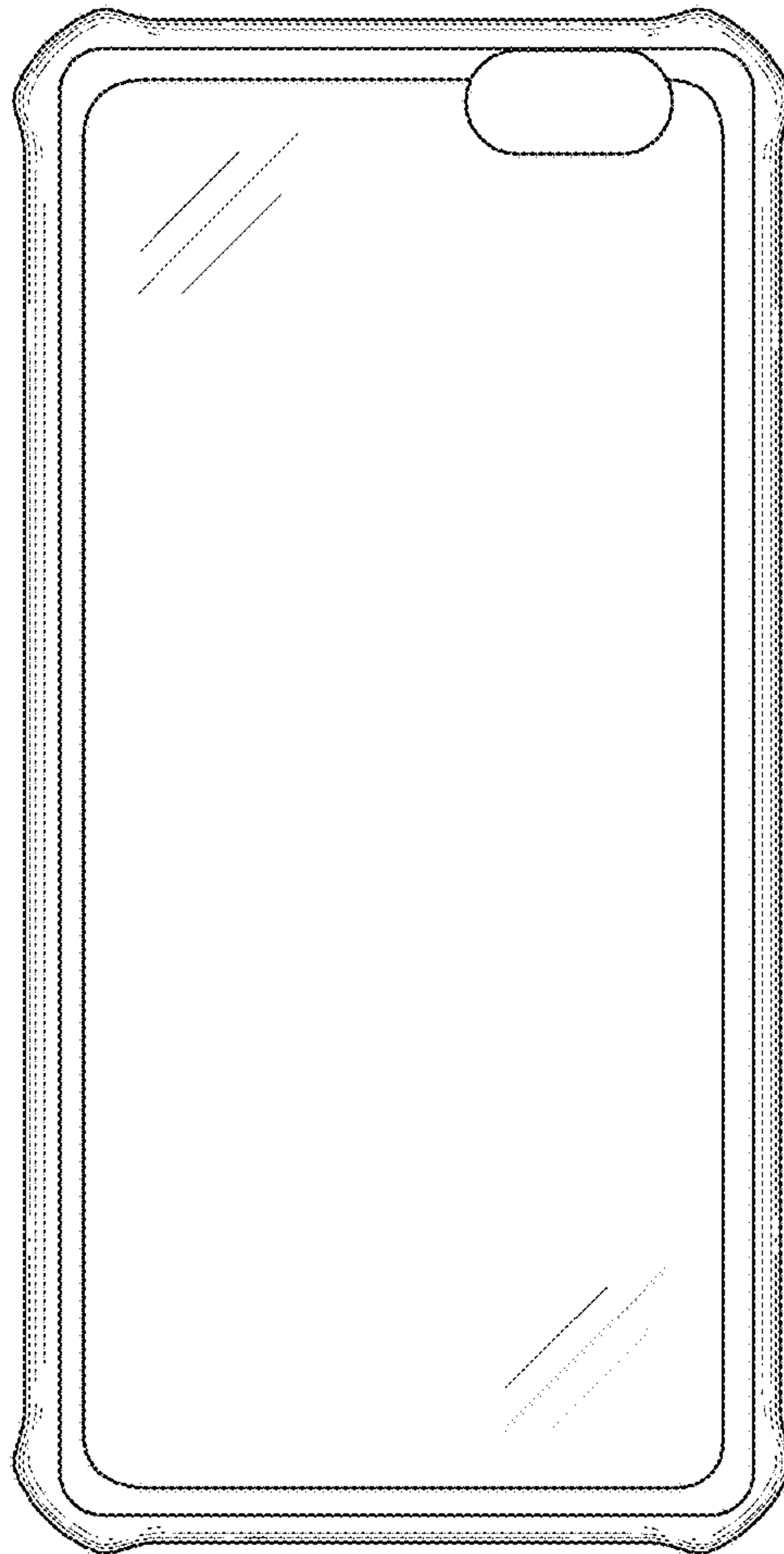

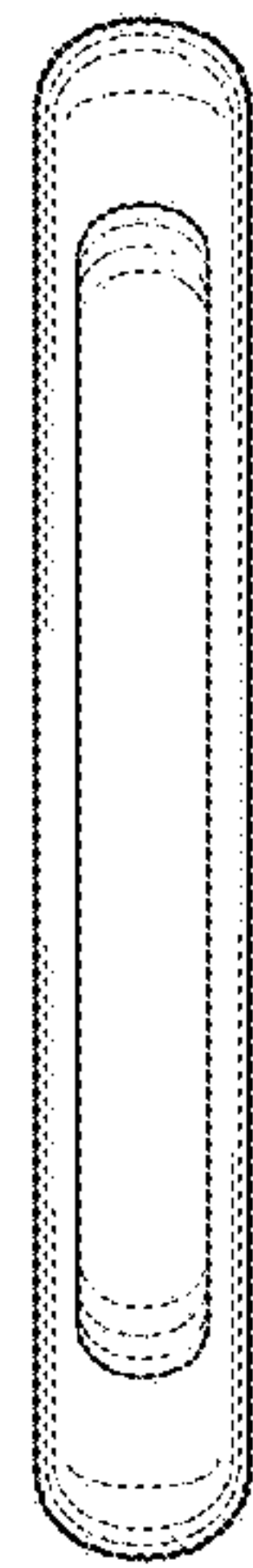

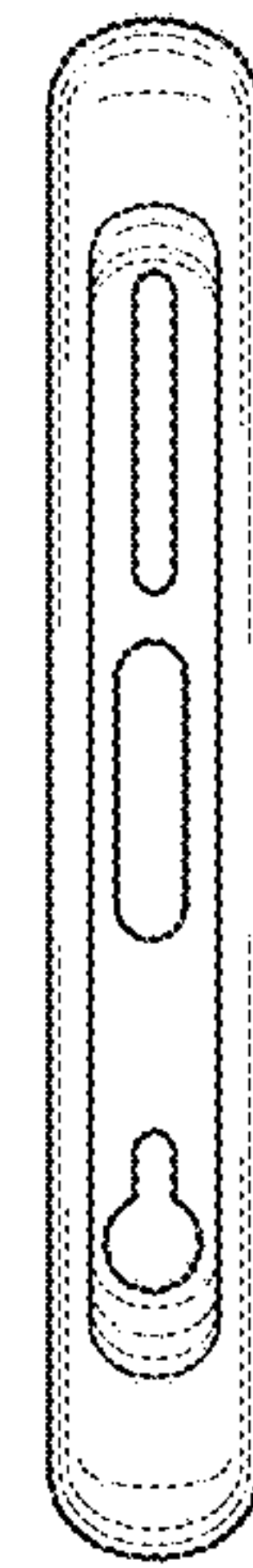
