(57) **CLAIM**

The ornamental design for a display screen or portion thereof with an animated graphical user interface for product display, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence of a display screen or portion thereof with an animated graphical user interface for product display, showing our new design; and,

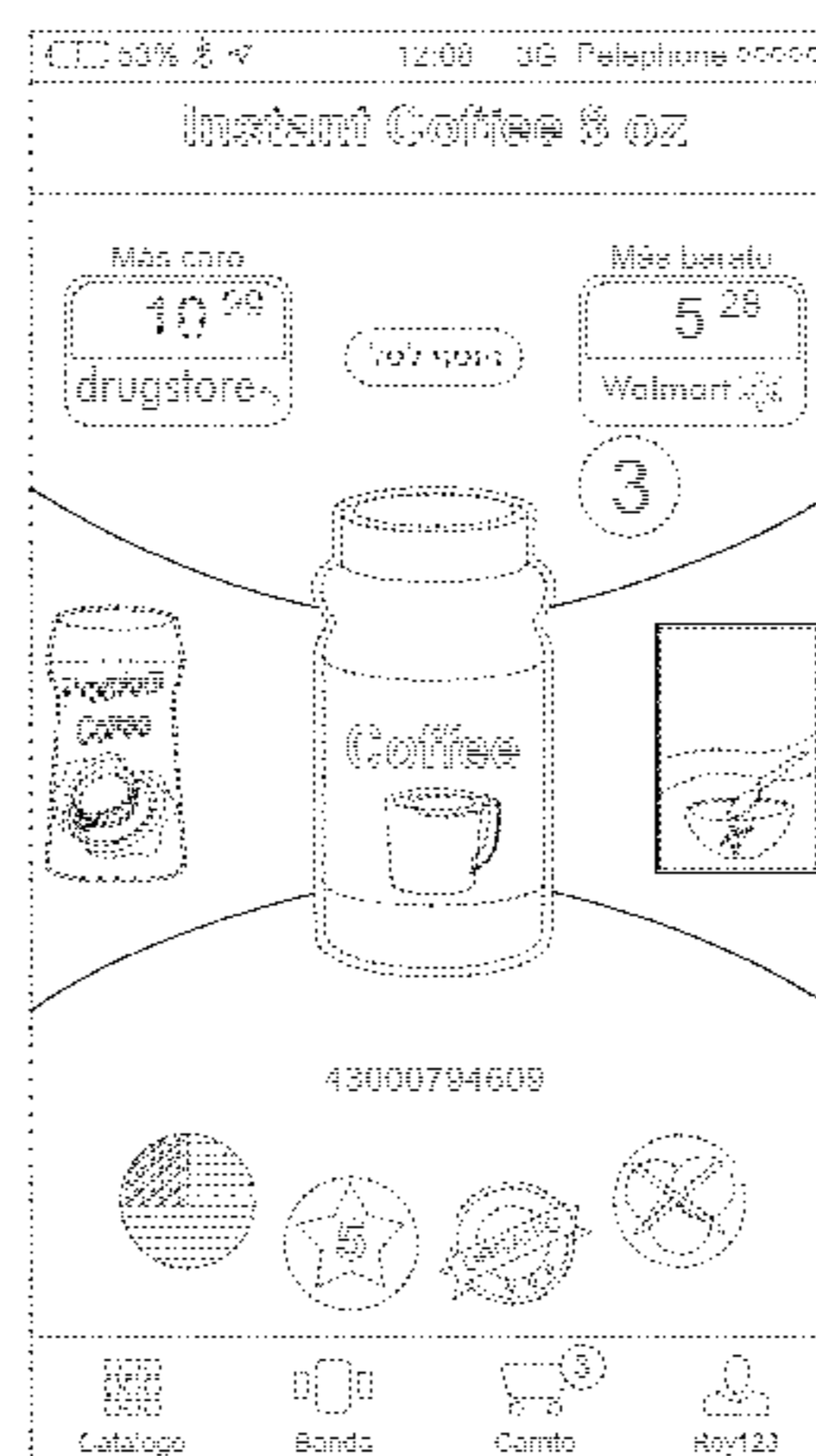
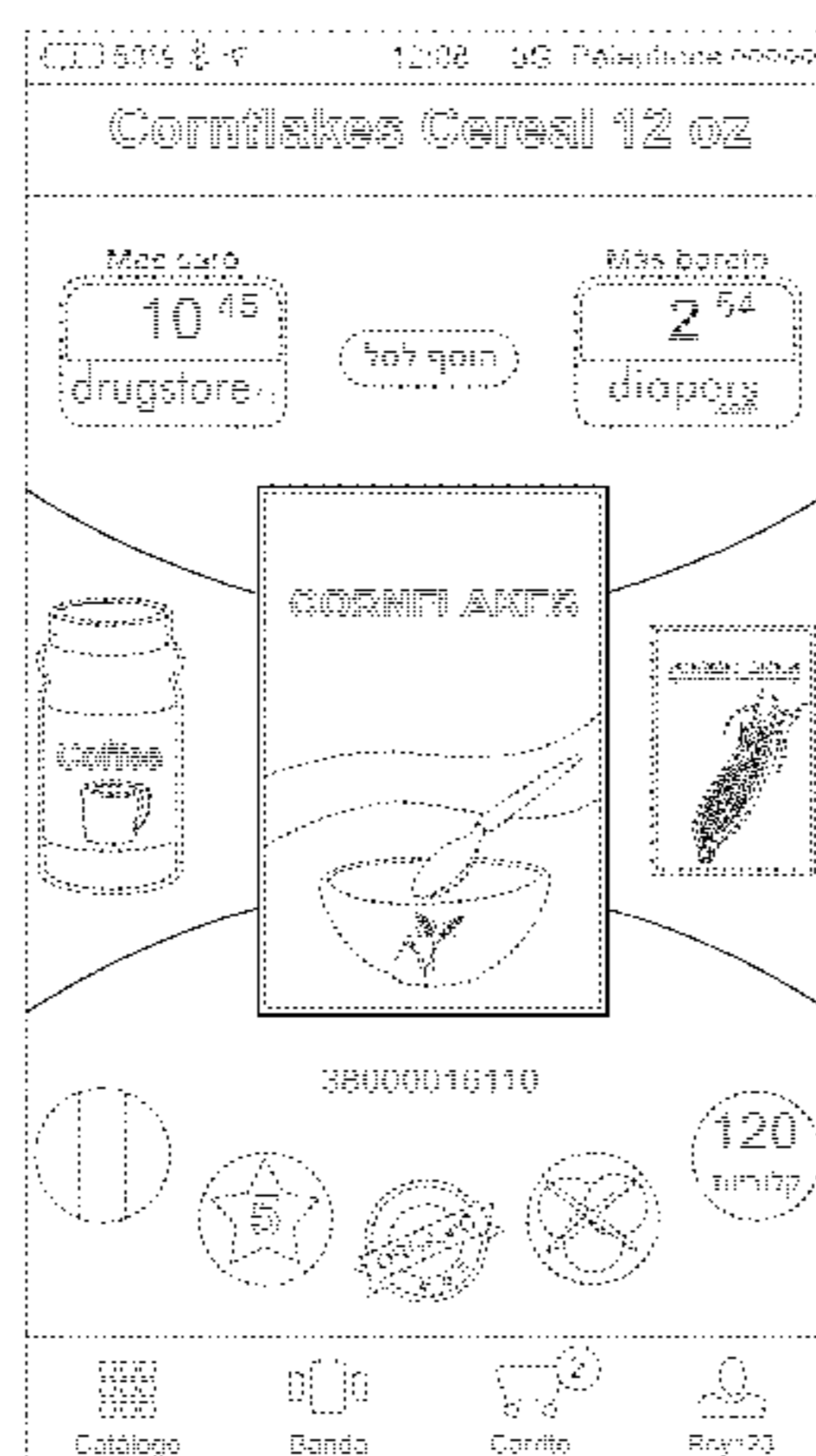
FIG. 2 is a second image thereof.

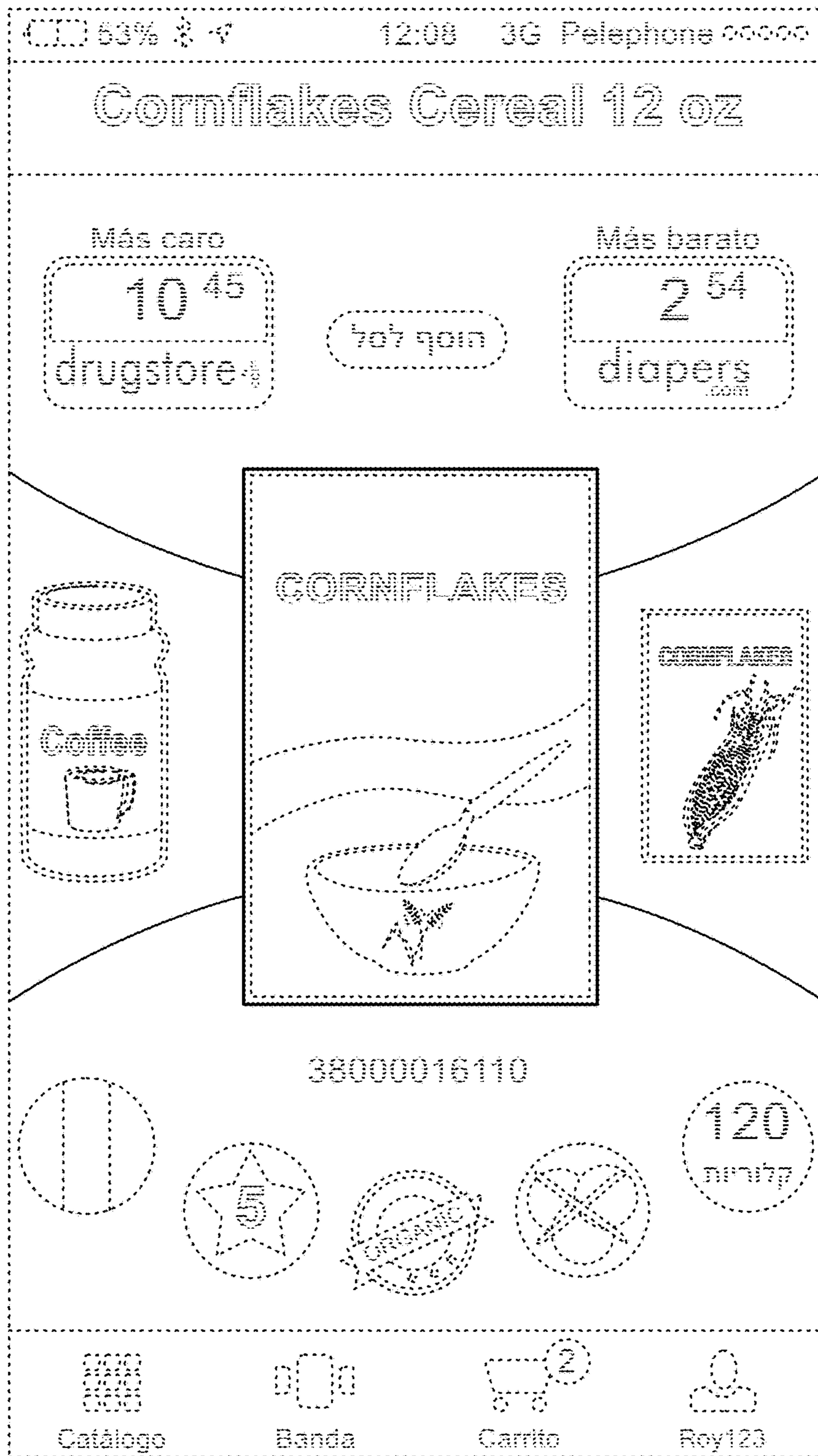
