(57) **CLAIM**

The ornamental design for a display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence of images of an animated display screen with animated graphical user interface;

FIG. 2 is a front view of a second image of the sequence of images of the animated graphical user interface illustrated in FIG. 1;

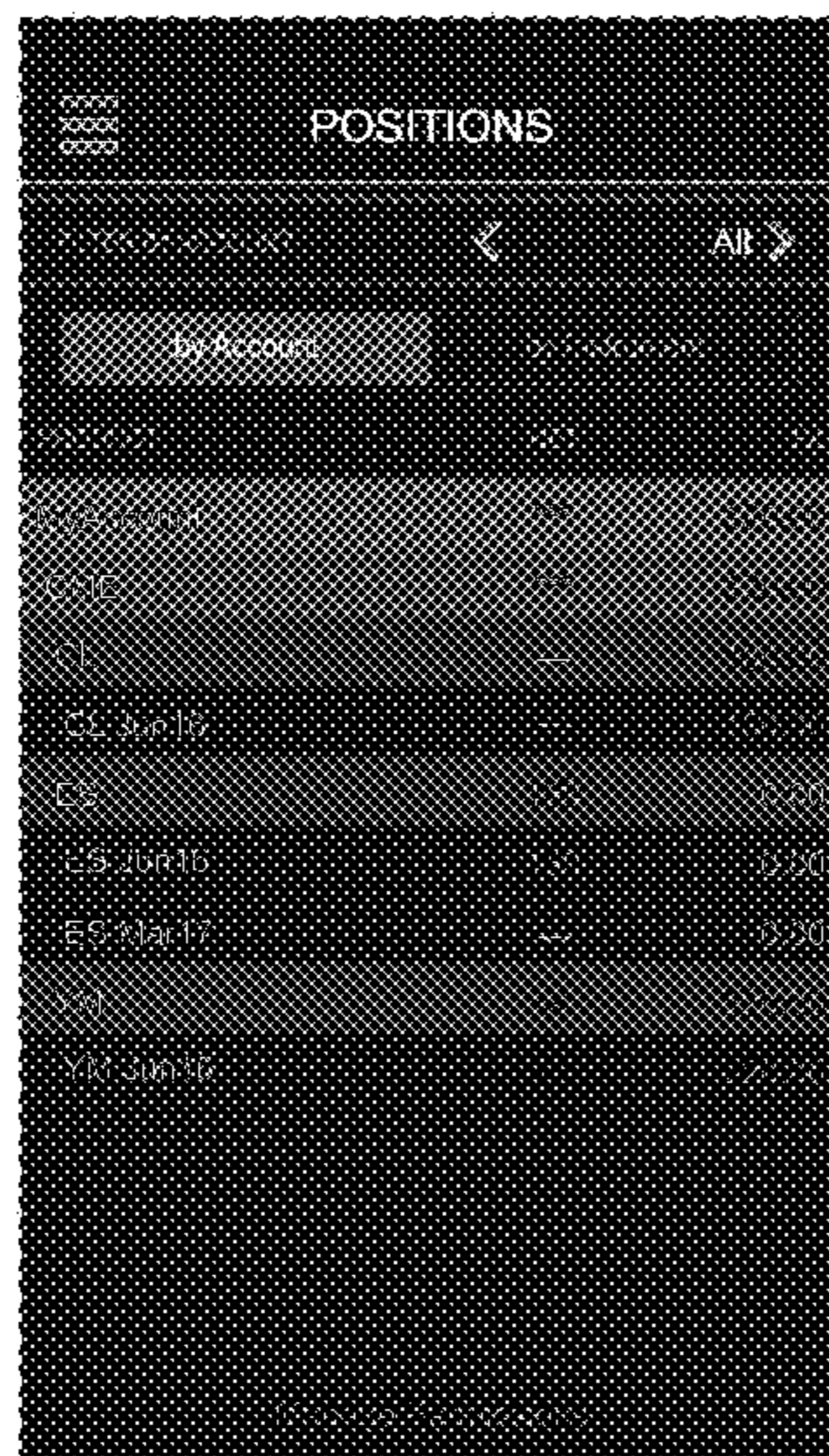
FIG. 3 is a front view of a first image in a sequence of images of a second embodiment of an animated display screen with animated graphical user interface; and,

FIG. 4 is a front view of a second image of the sequence of images of the animated graphical user interface illustrated in FIG. 3.

The outermost broken line showing of a display screen and the other broken line showing of elements of the graphical user interface illustrate portions of the article and do not form part of the claimed design.

The appearance of the animated graphical user interface transitions sequentially between the images shown in FIGS. 1 and 2 in embodiment 1 and FIGS. 3 and 4 in embodiment 2. The process or period in which one image transitions to another forms no part of the claimed design.

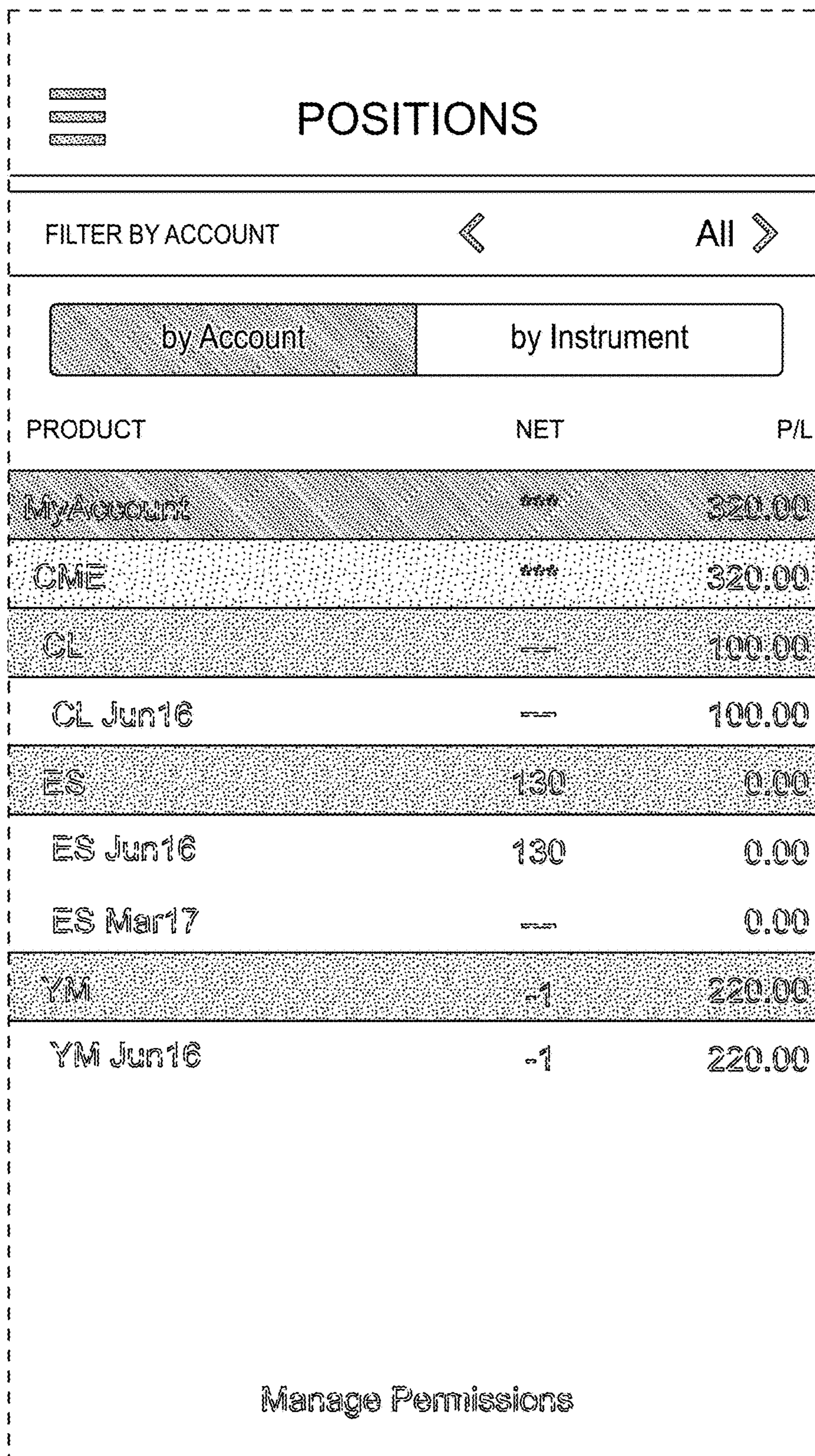
