(57) **CLAIM**
 The ornamental design for a drawer for refrigerator, as shown and described.

DESCRIPTION

1. Drawer for refrigerator

1.24 is a perspective view thereof, in a use condition;

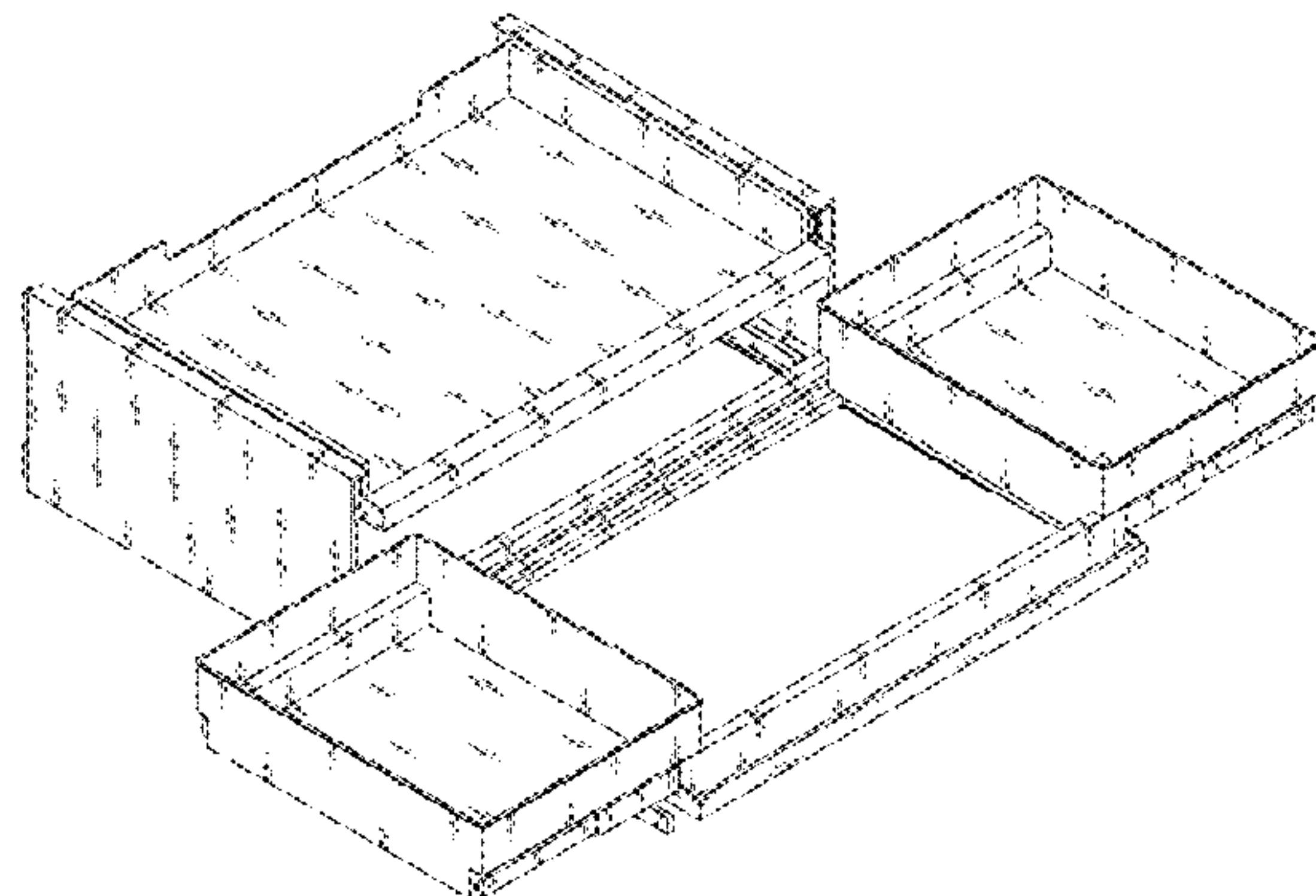
1.25 is a perspective view of the drawer for refrigerator, when each of the upper and lower drawers is slid out and each of the baskets therein slides to each side;
