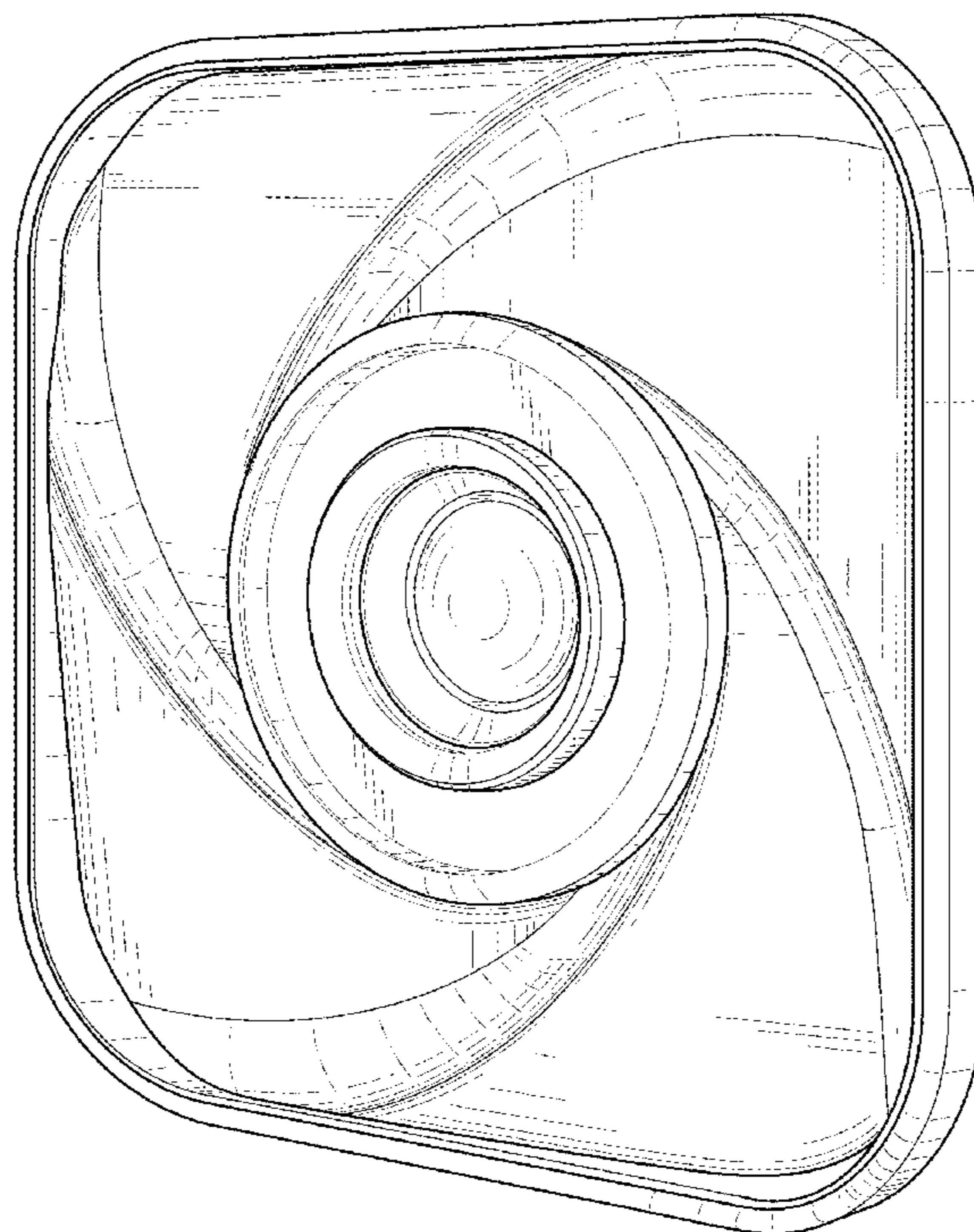
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first perspective view of the work light, showing my new design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a front elevational view thereof;

FIG. 5 is a left side elevational view thereof;

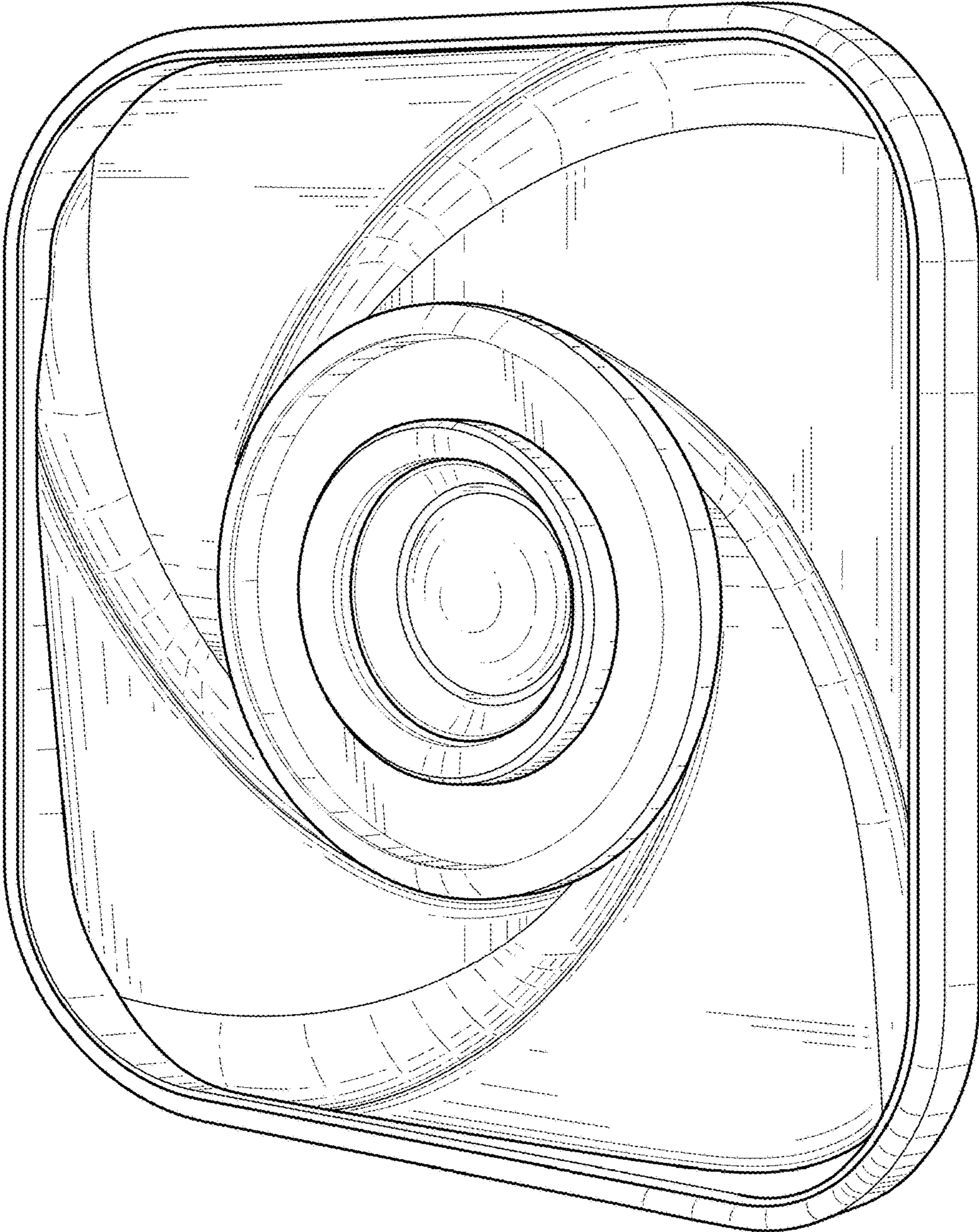

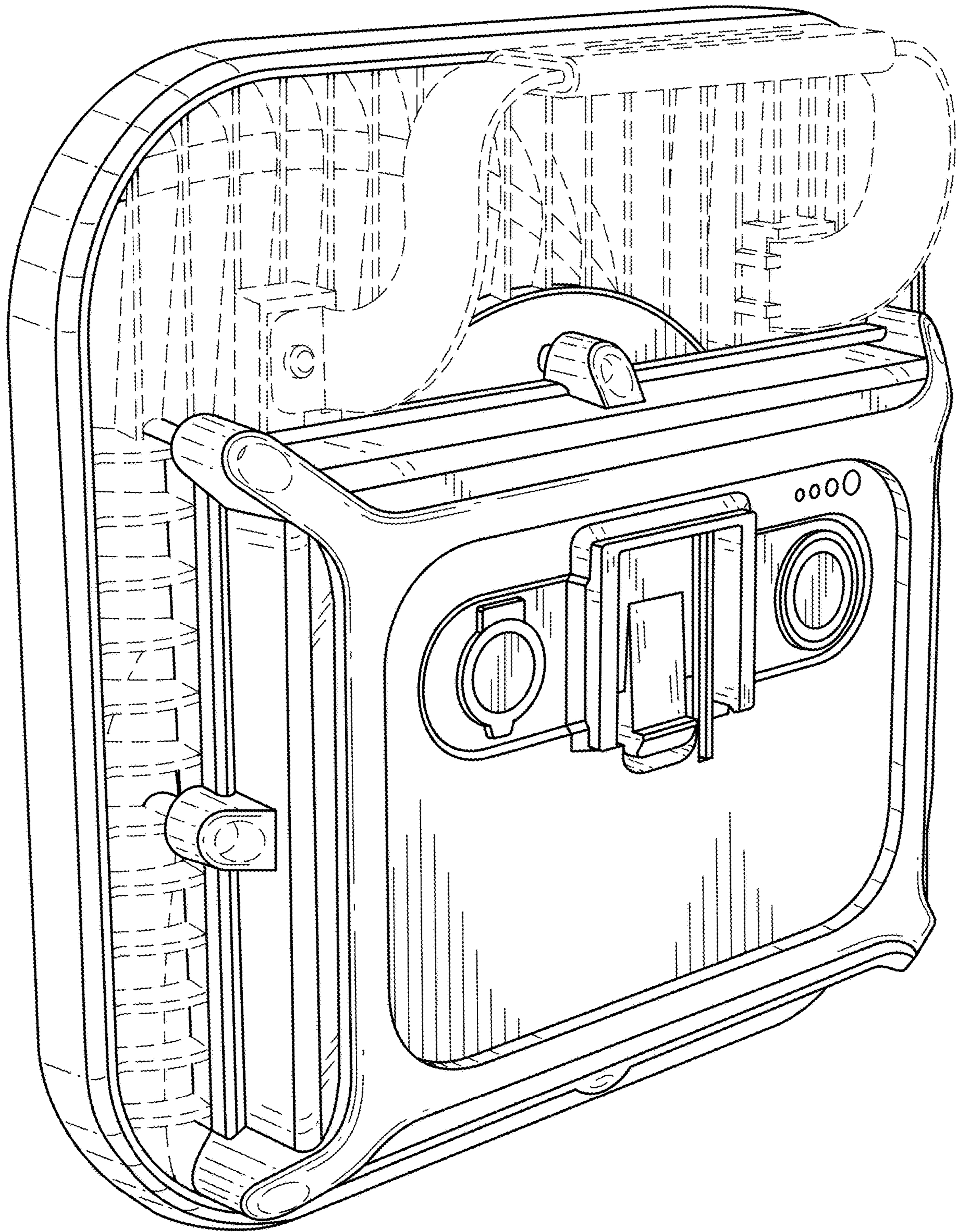

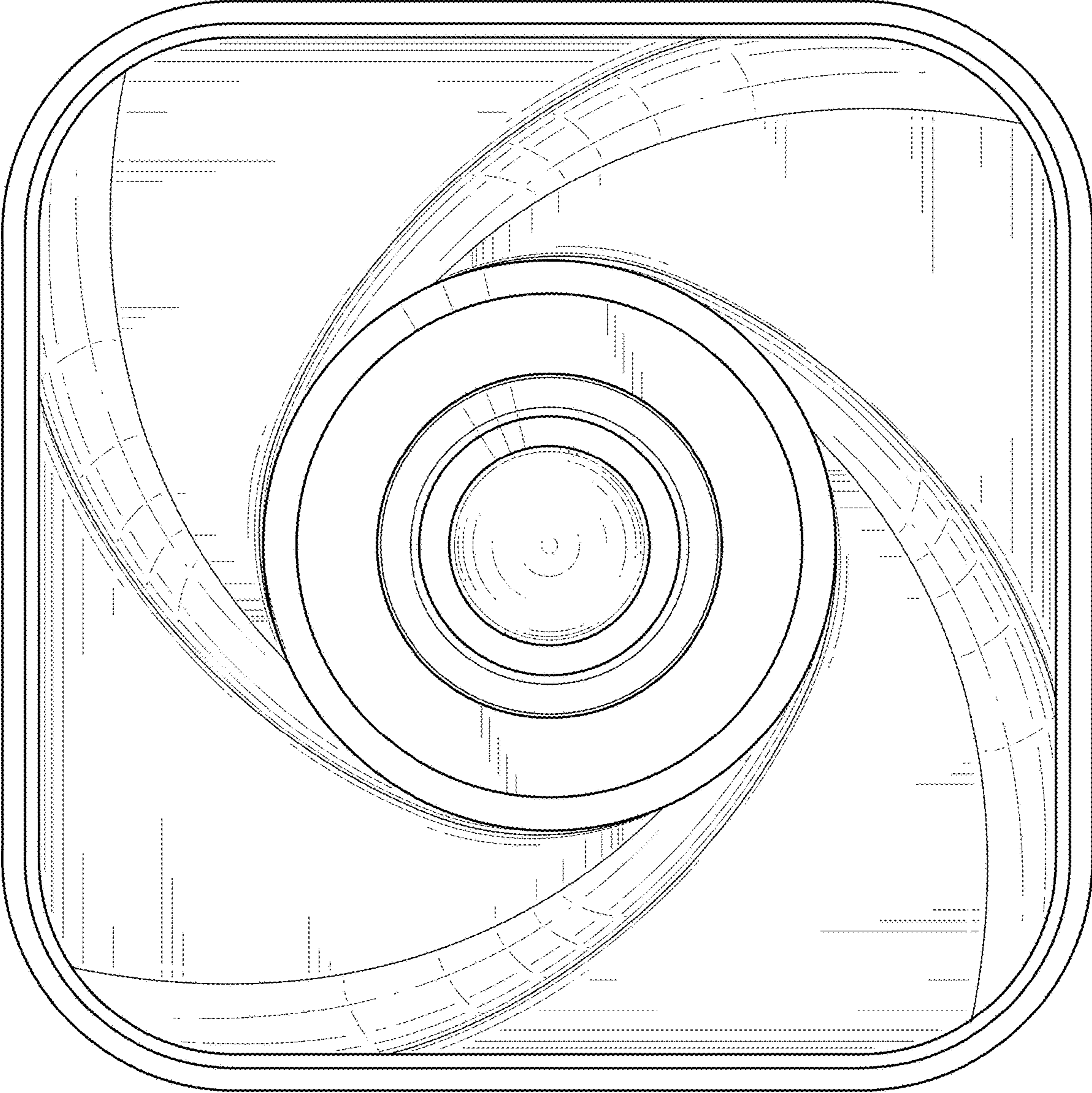

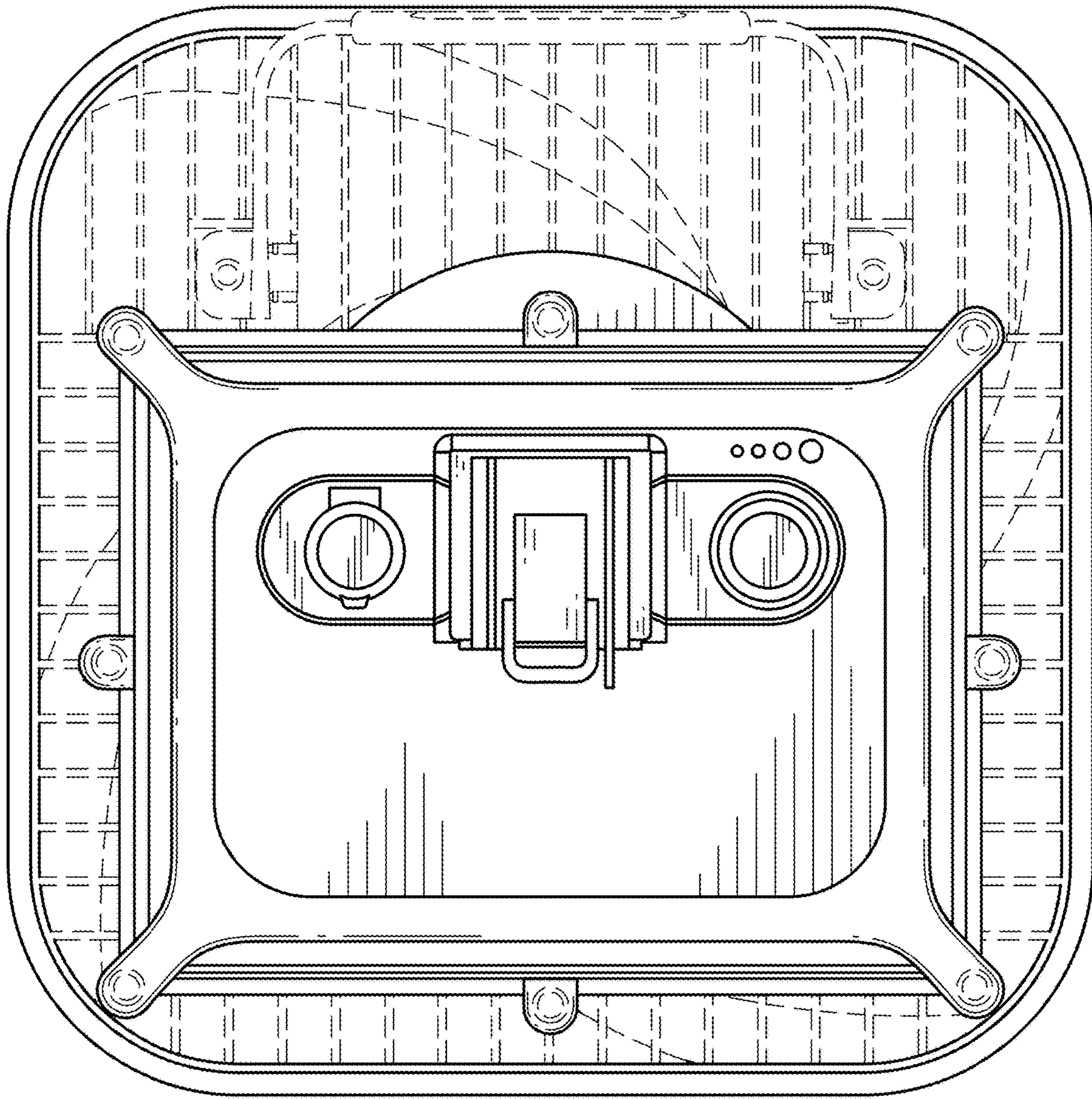

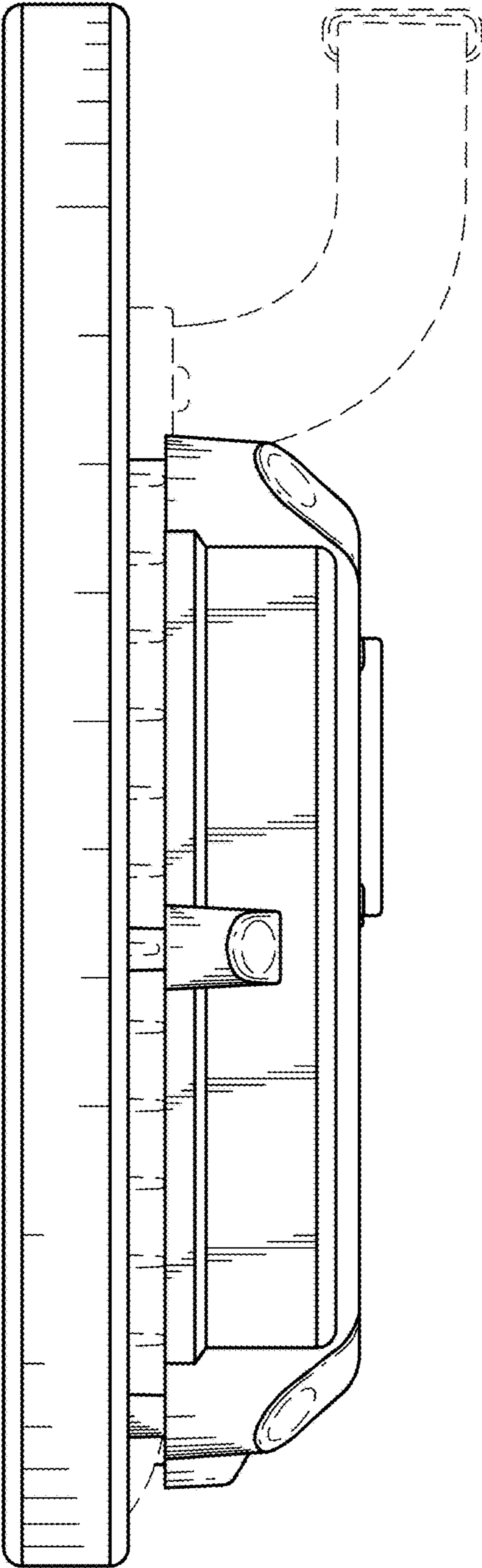

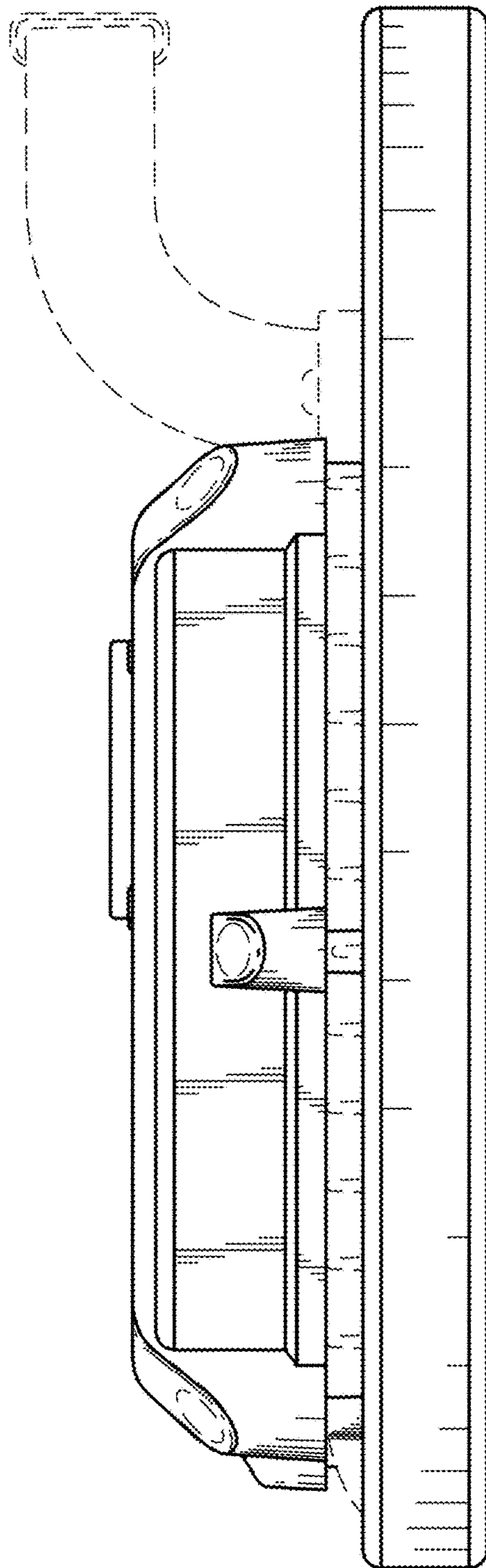

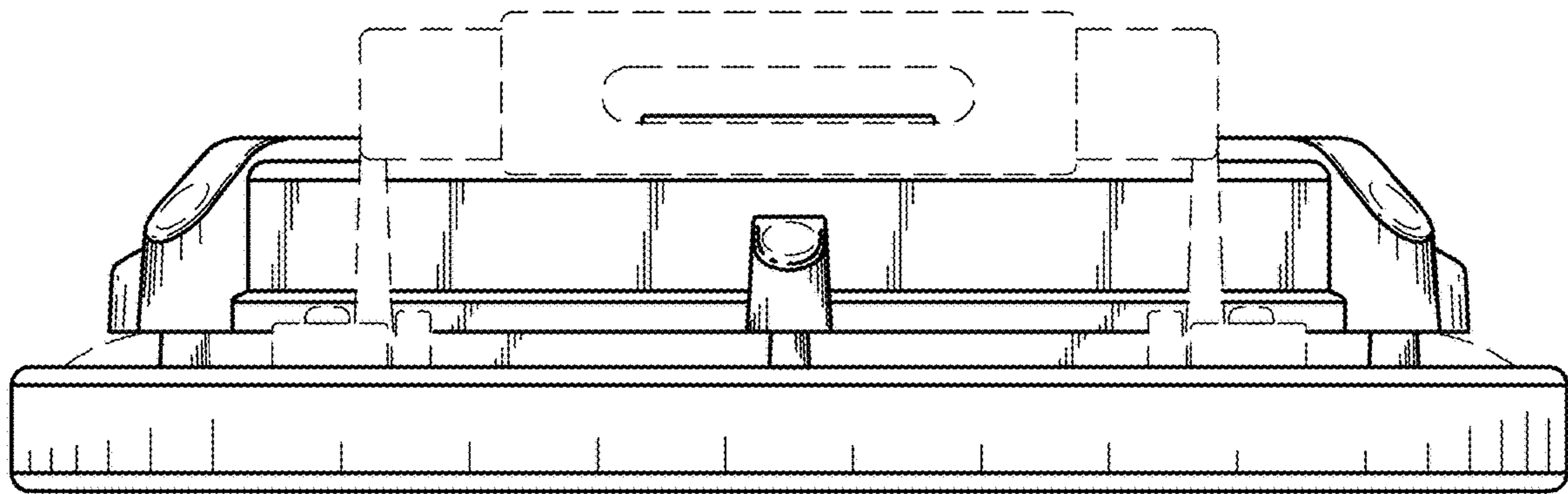

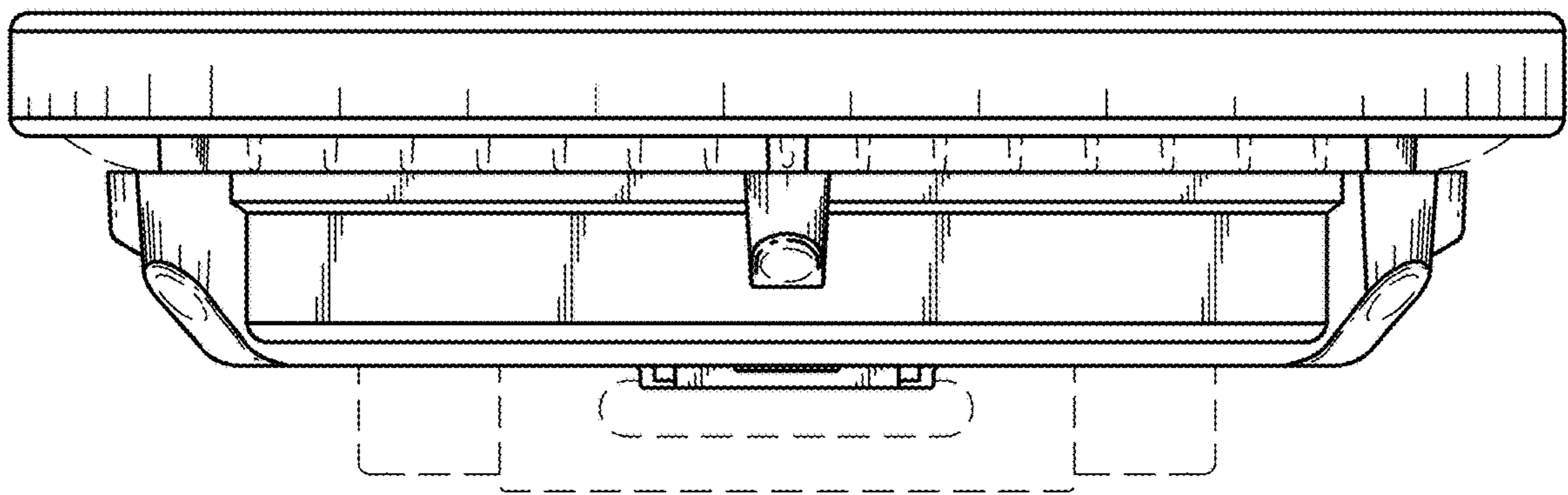
