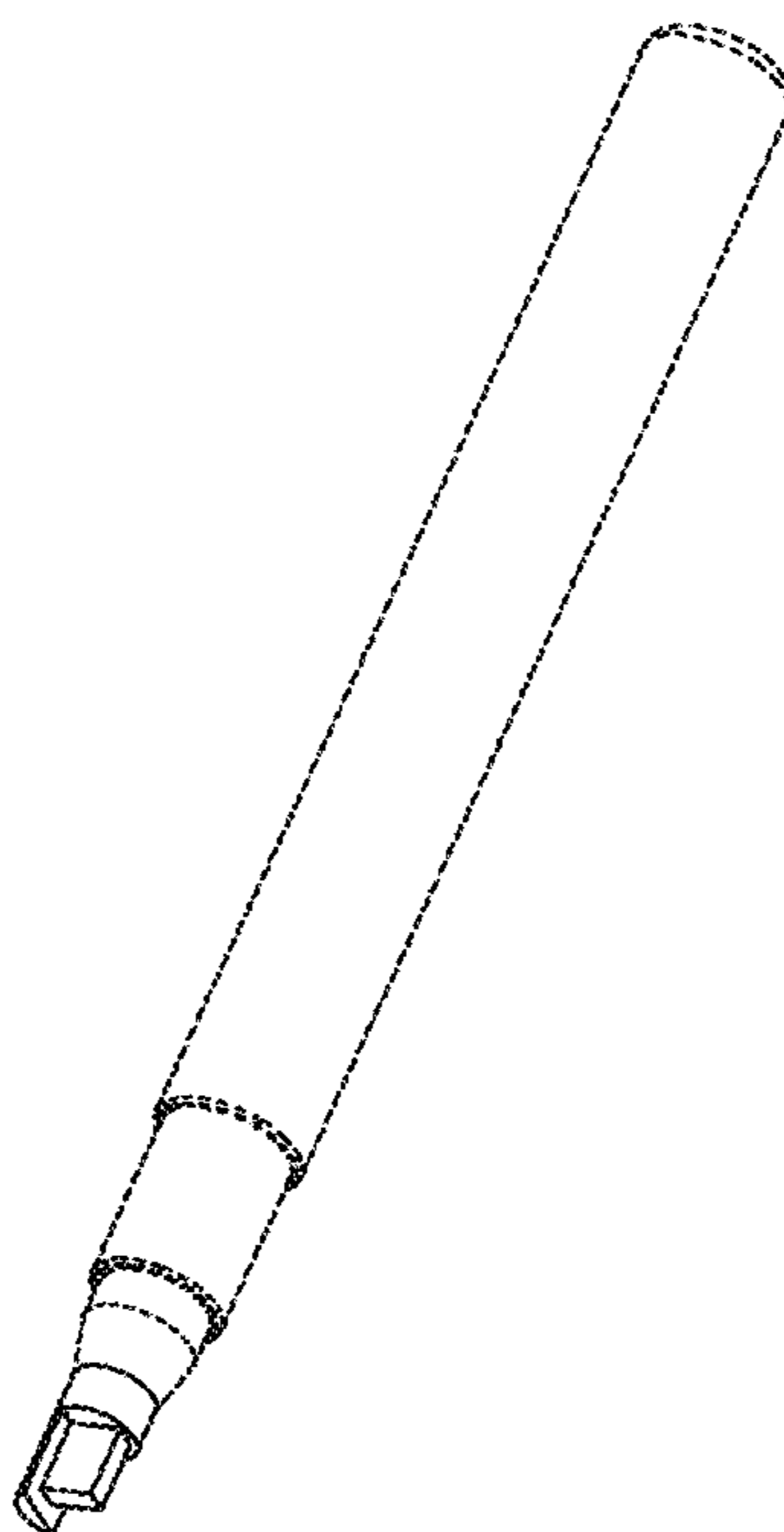
(57) **CLAIM**

I claim the ornamental design for a French manicure applicator, as shown and described.

DESCRIPTION

FIG. 1 is a front, side perspective view of a French manicure applicator straight side guided felt tip;
 FIG. 2 is a rear, side perspective view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a front view thereof;
 FIG. 5 is a rear view thereof;
 FIG. 6 is a right side elevational view thereof;
 FIG. 7 is a top view thereof; and,
 FIG. 8 is a bottom view thereof.

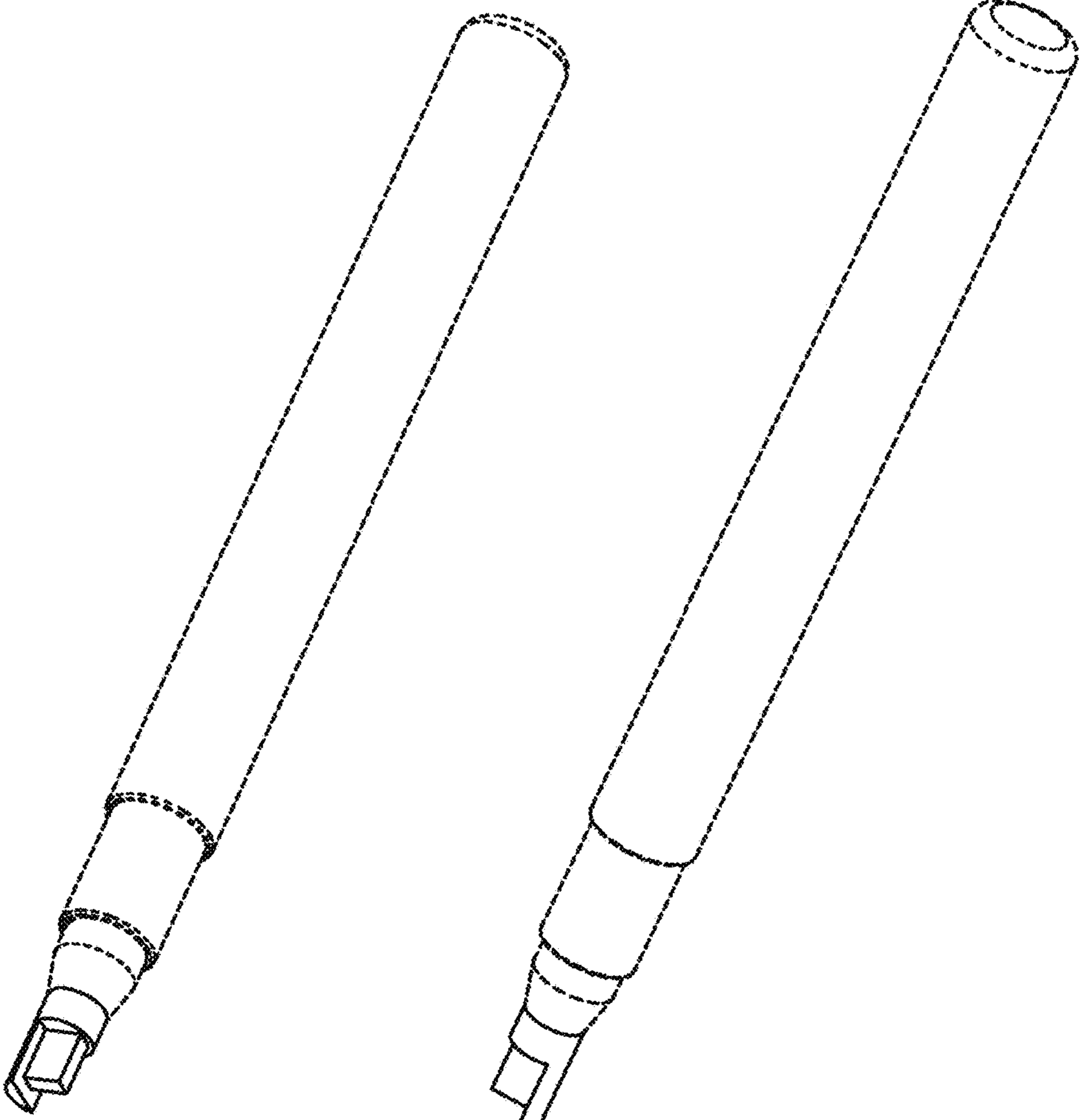

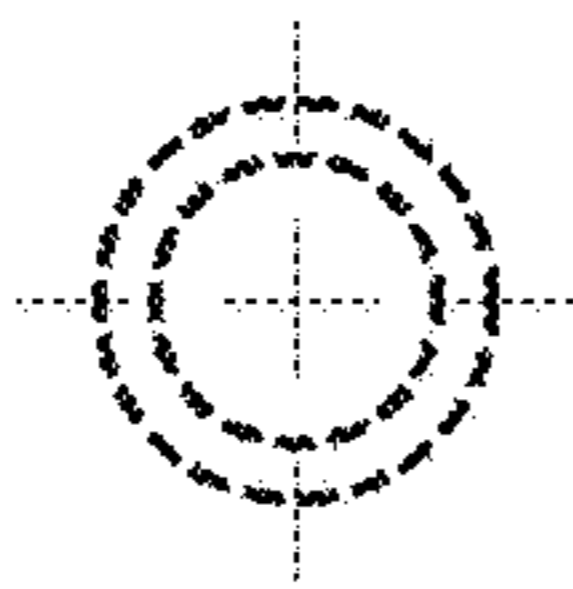

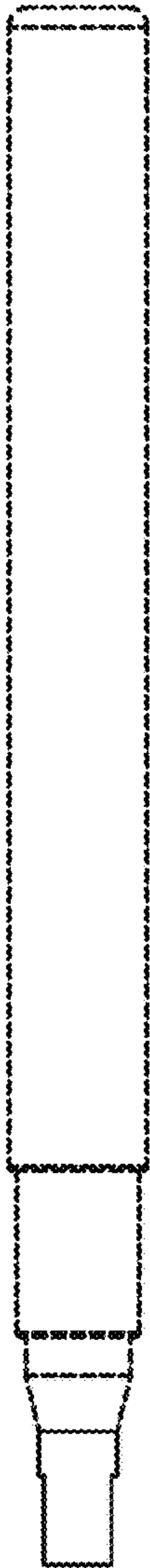

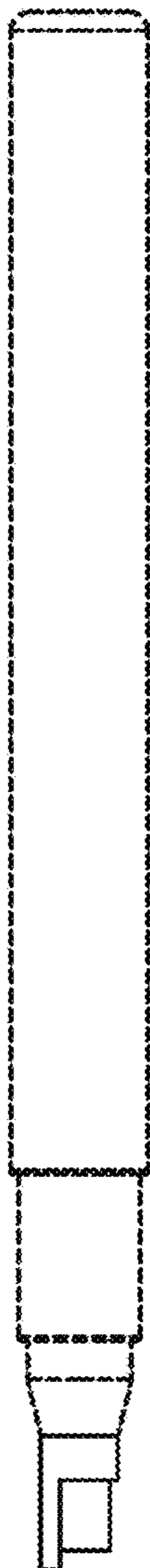

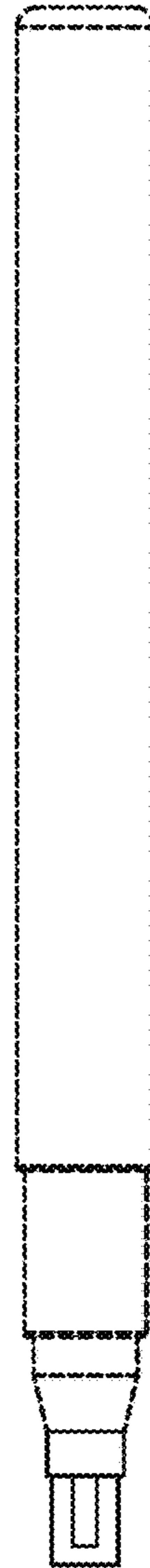

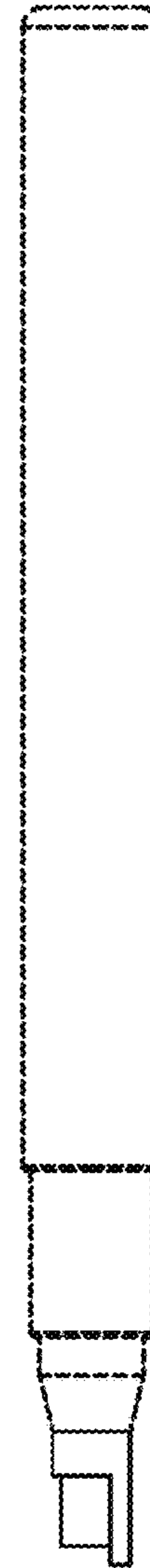

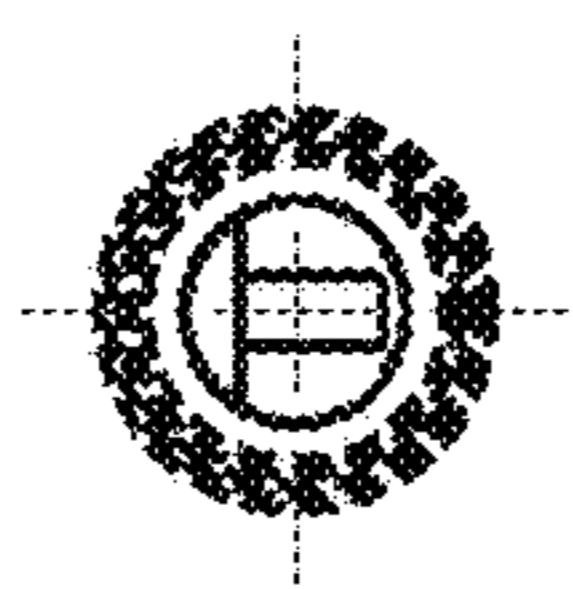
