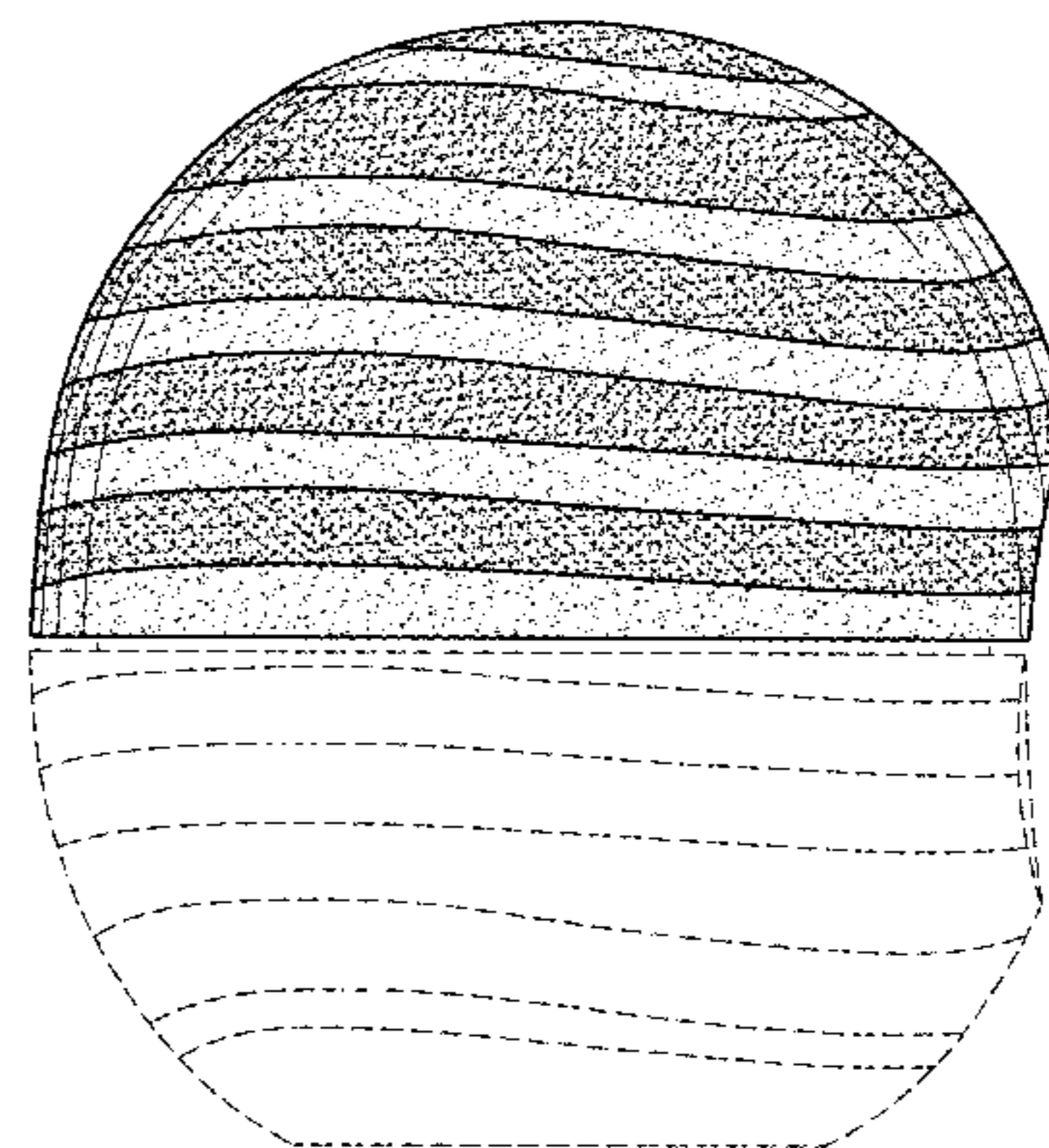
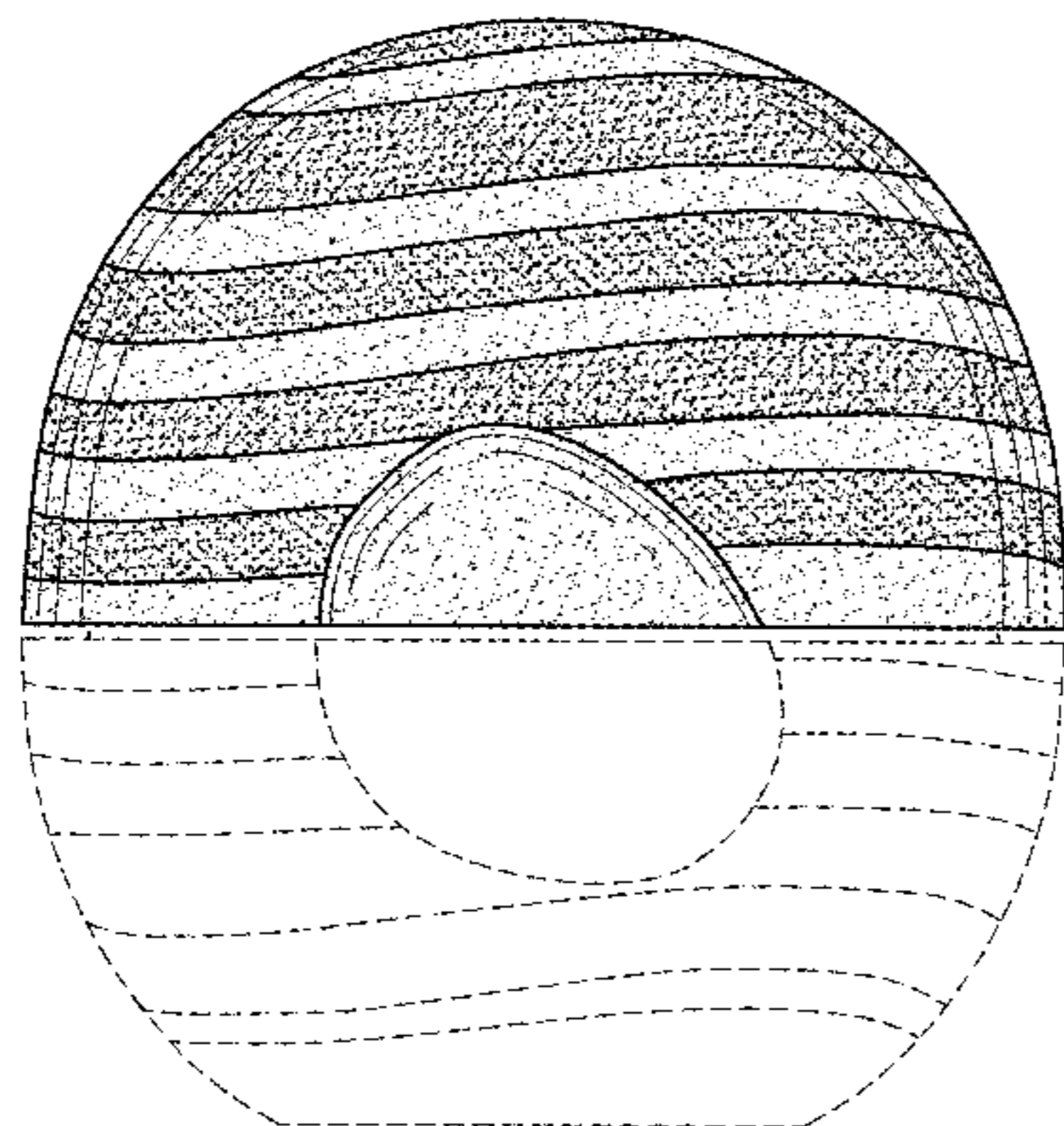

(57) **CLAIM**

The ornamental design for cosmetic product container, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a cosmetic product container;
FIG. 2 is a left side elevational view of the cosmetic product container of FIG. 1;
FIG. 3 is a right side elevational view of the cosmetic product container of FIG. 1;
FIG. 4 is a rear elevational view of the cosmetic product container of FIG. 1;
FIG. 5 is a top plan view of the cosmetic product container of FIG. 1; and,
FIG. 6 is a bottom plan view of the cosmetic product container of FIG. 1.
The broken lines are included for the purpose of illustrating portions of the cosmetic product container that form no part of the claimed design.
The stippling in FIGS. 1-6 shows contrast in appearance.

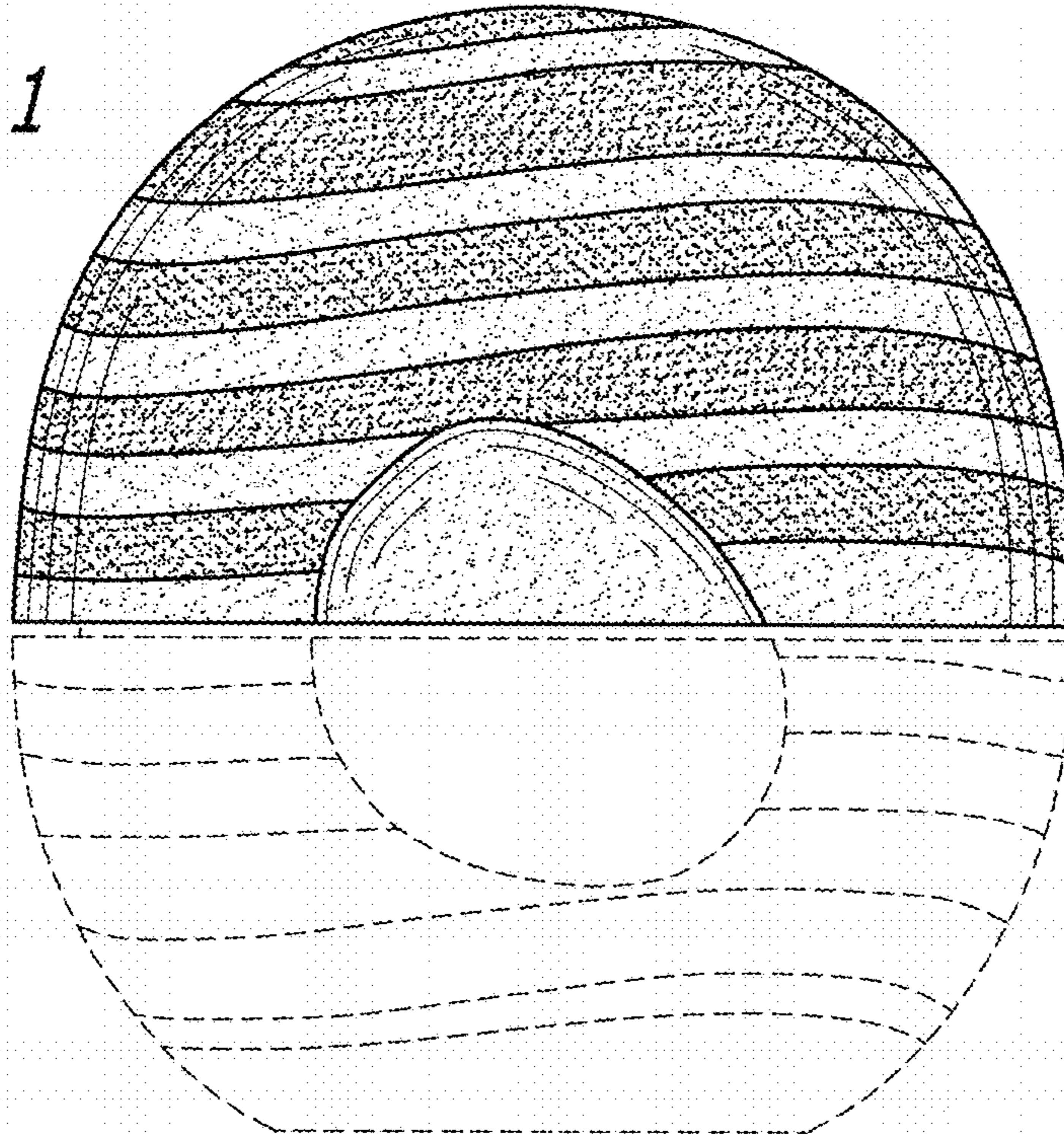

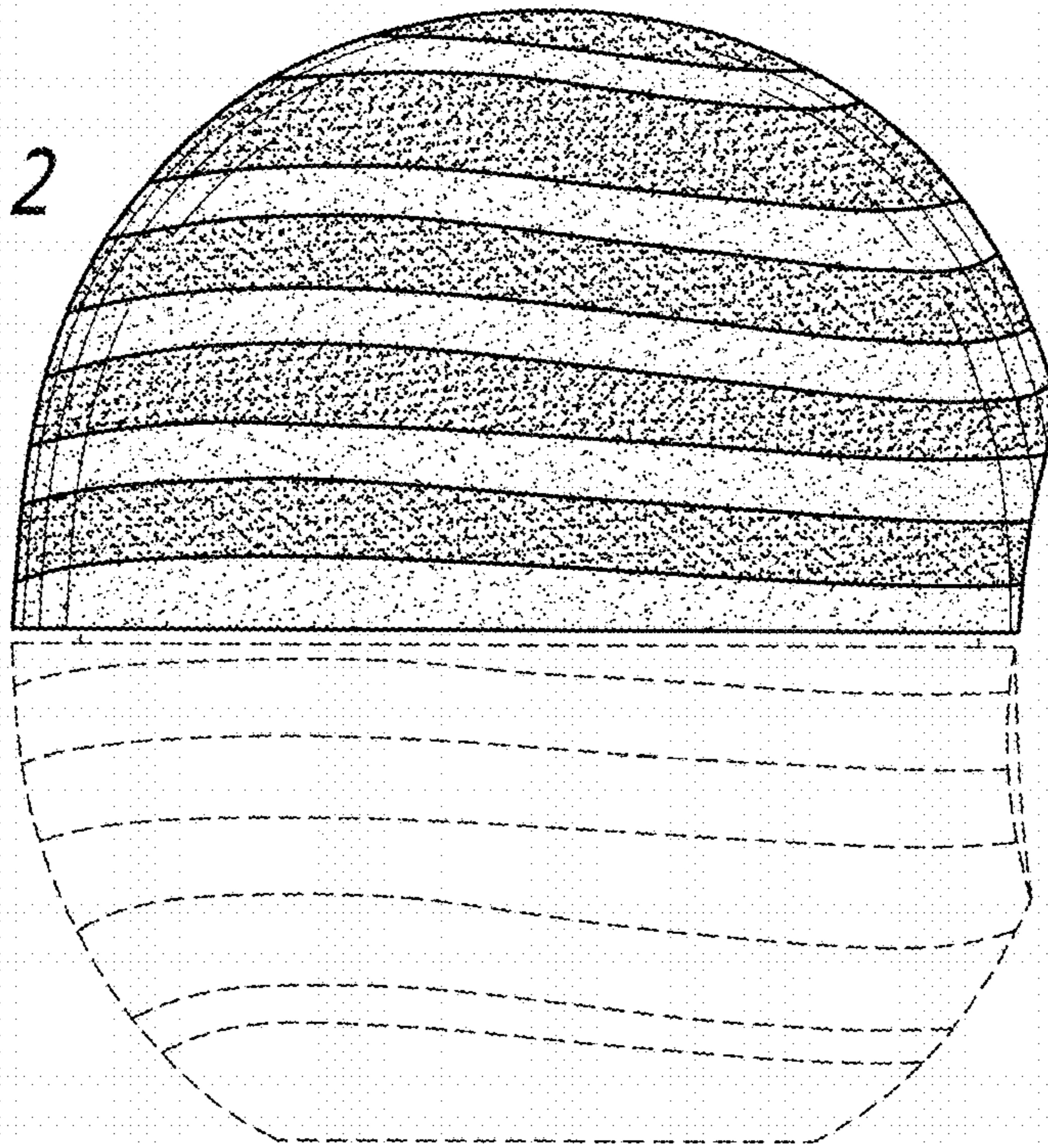

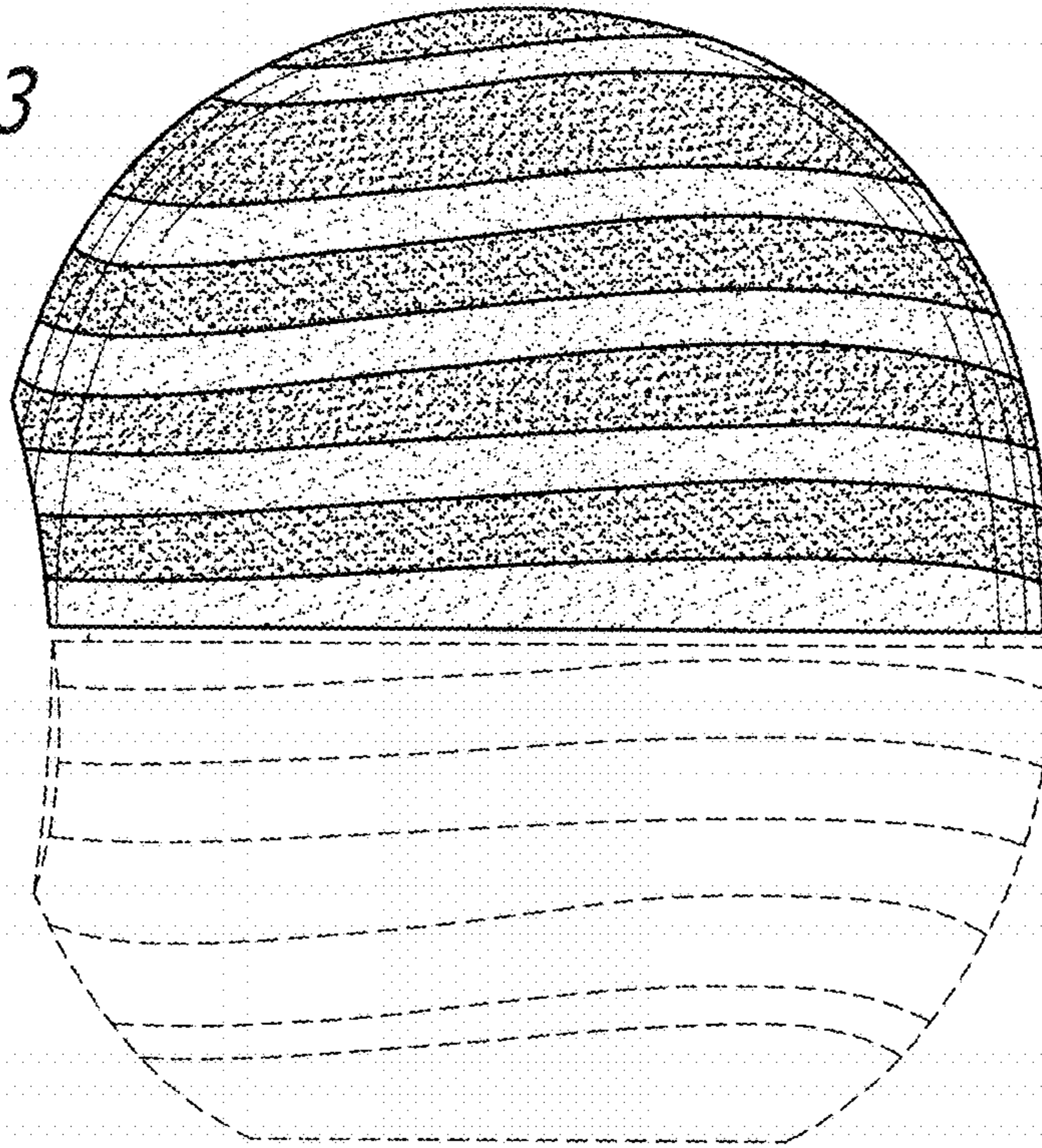

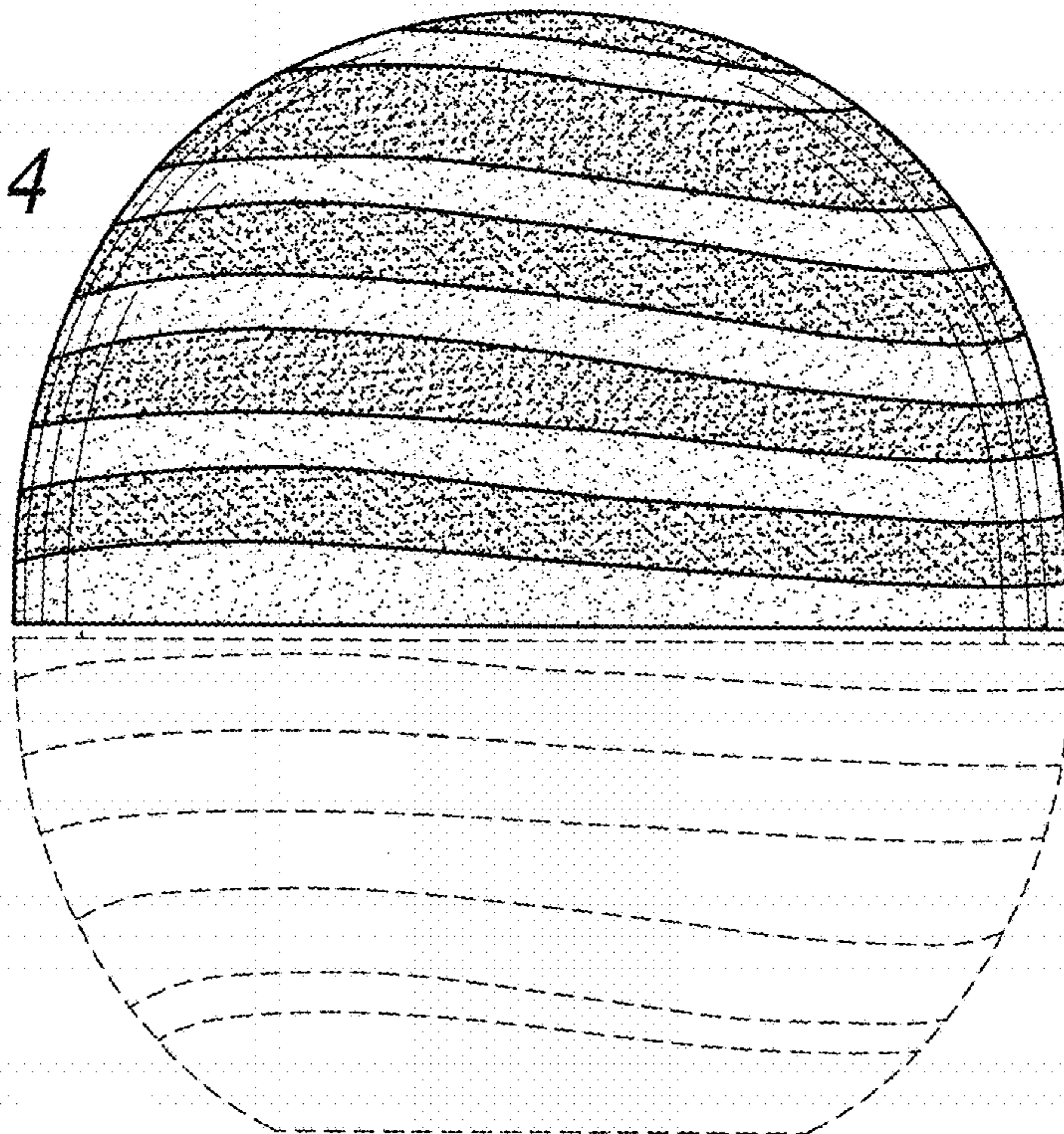

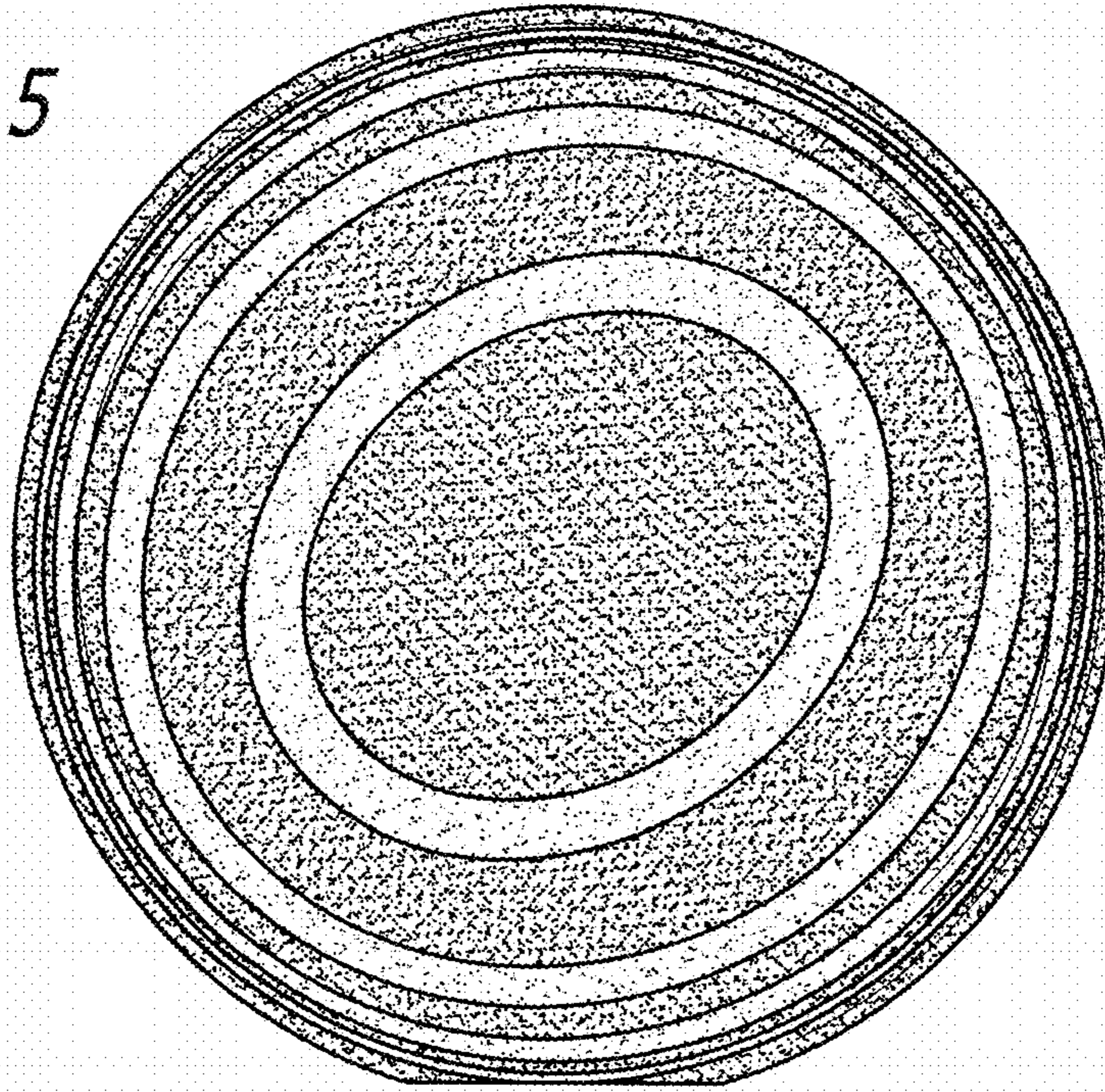
