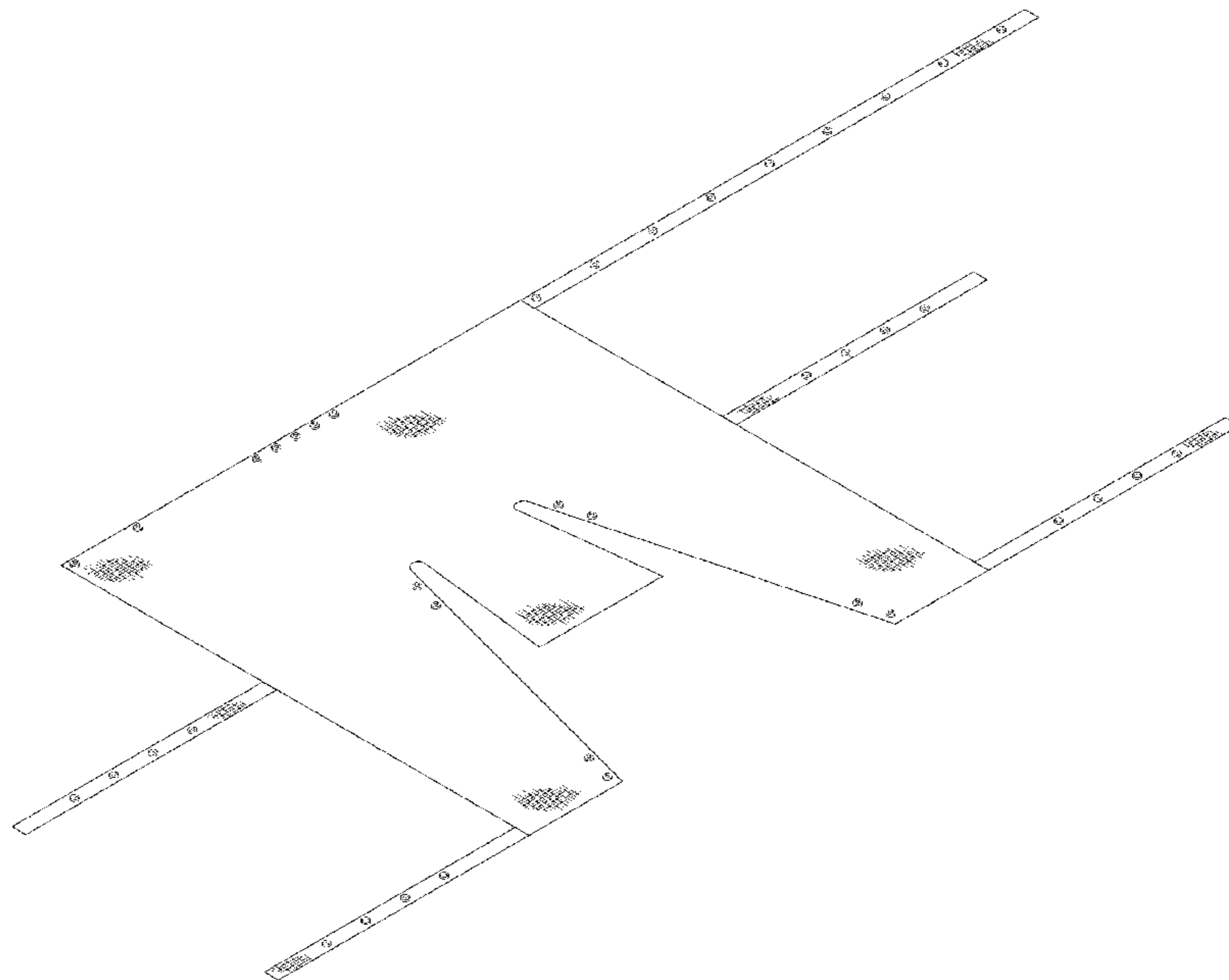
FIG. 1 is a perspective view of an adjustable garment, showing our new design;

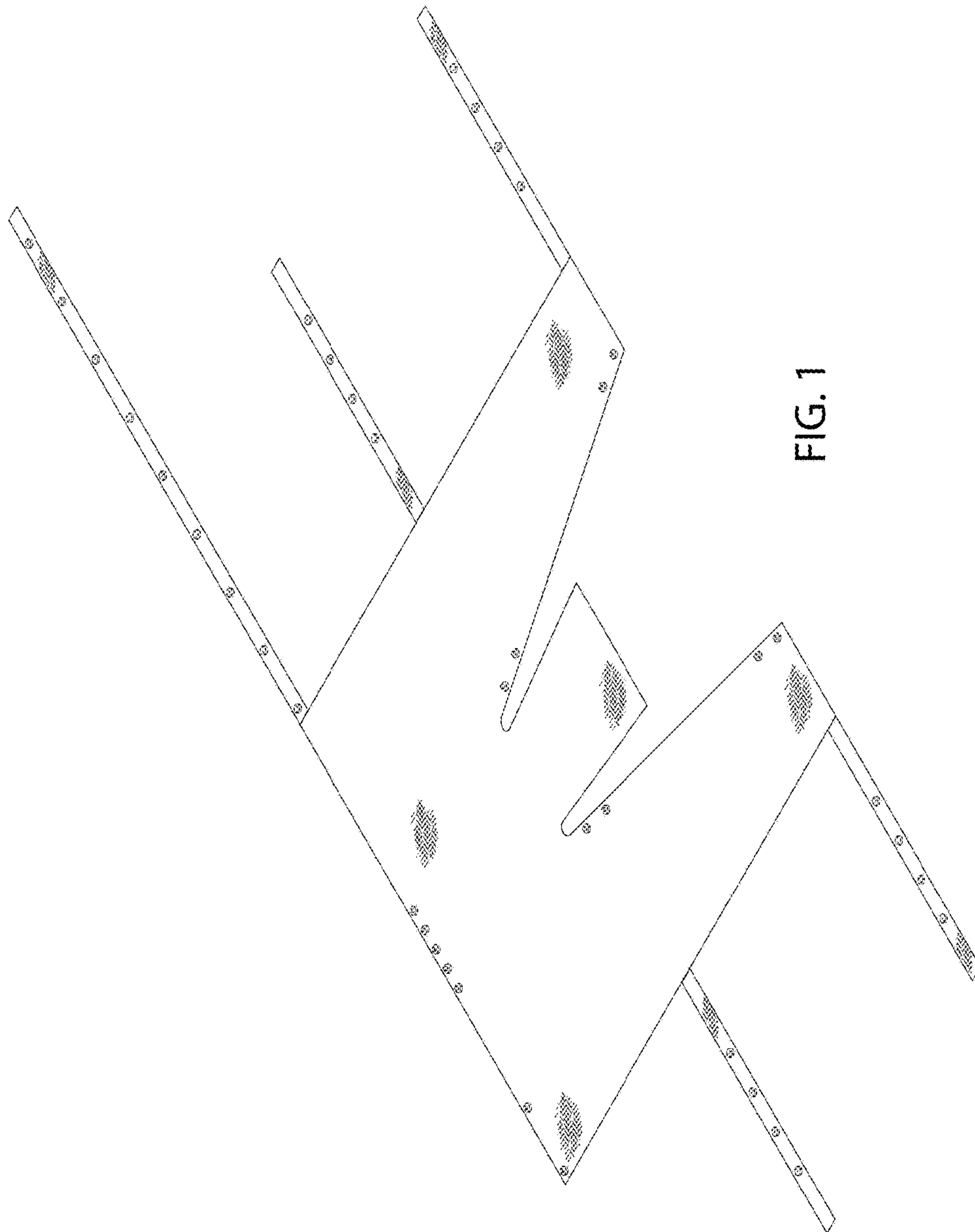

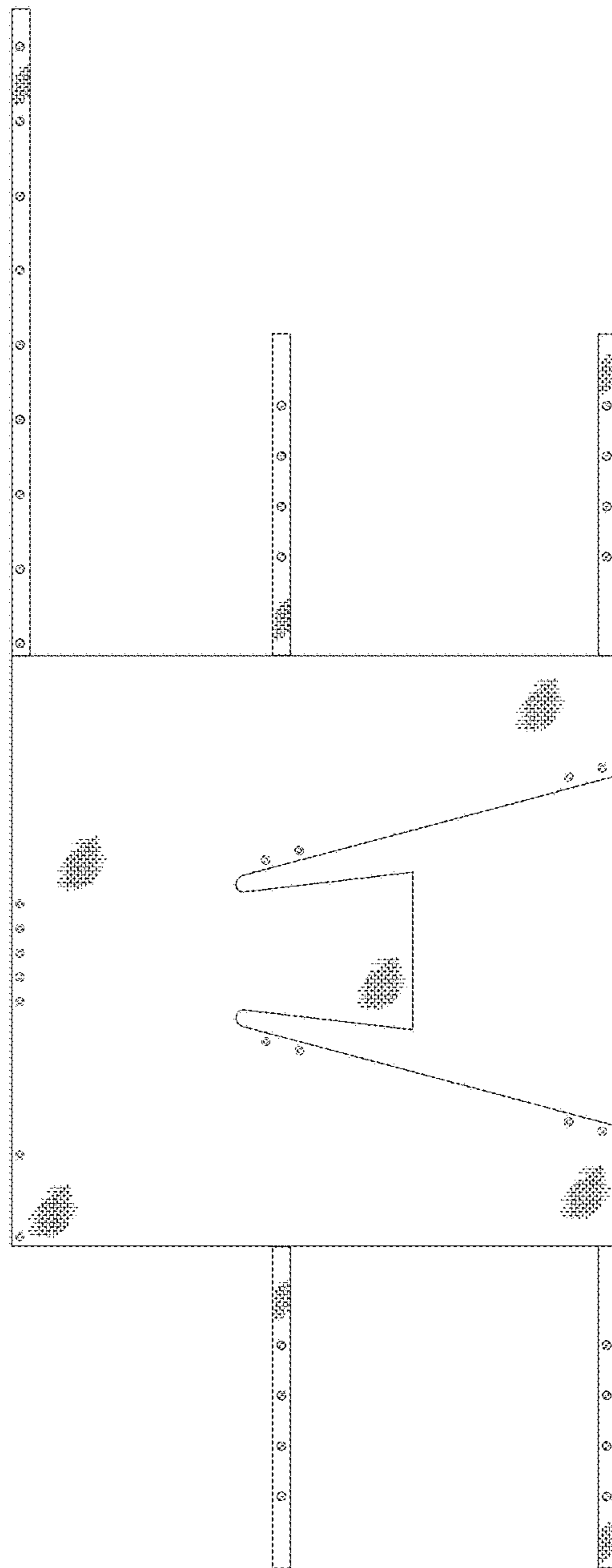

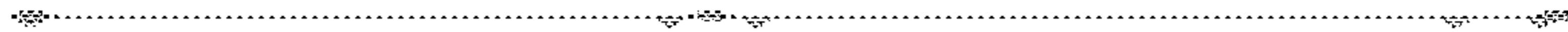

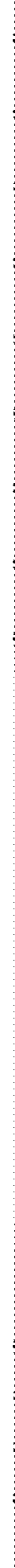

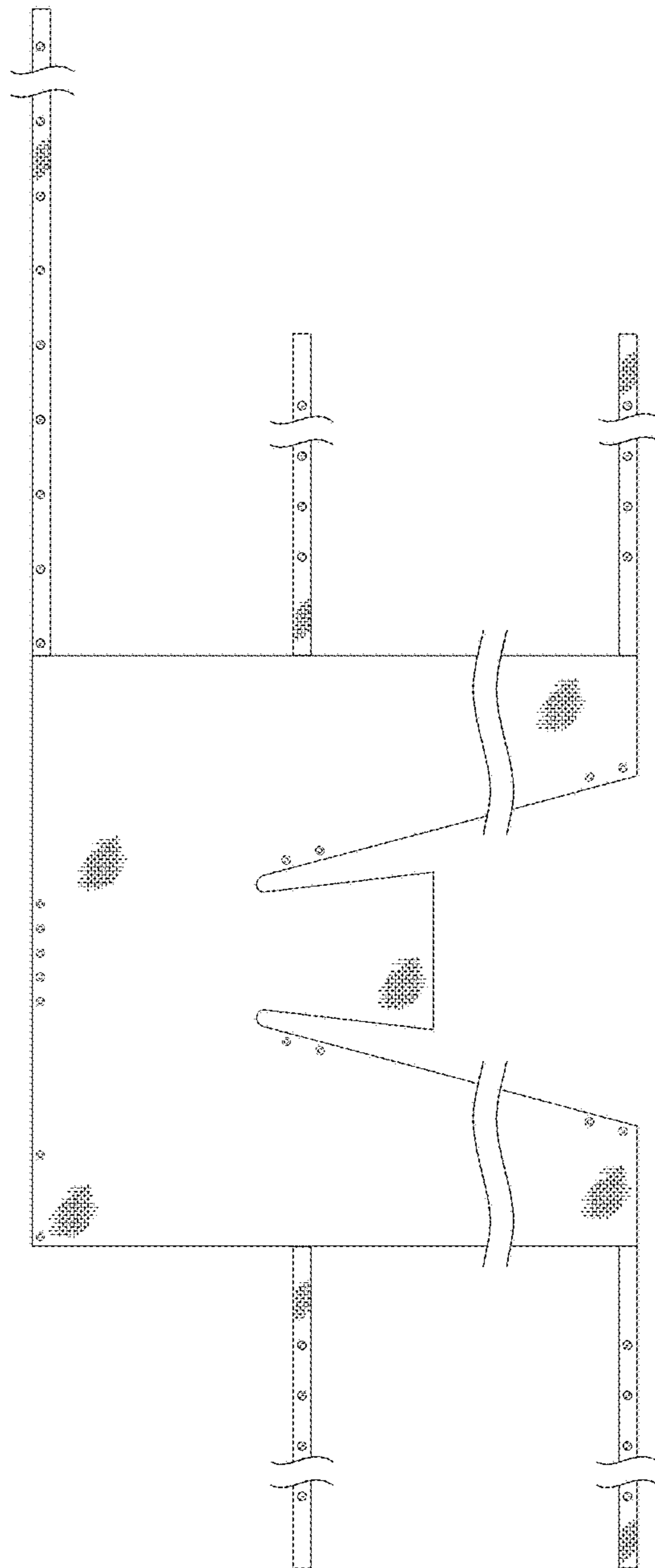

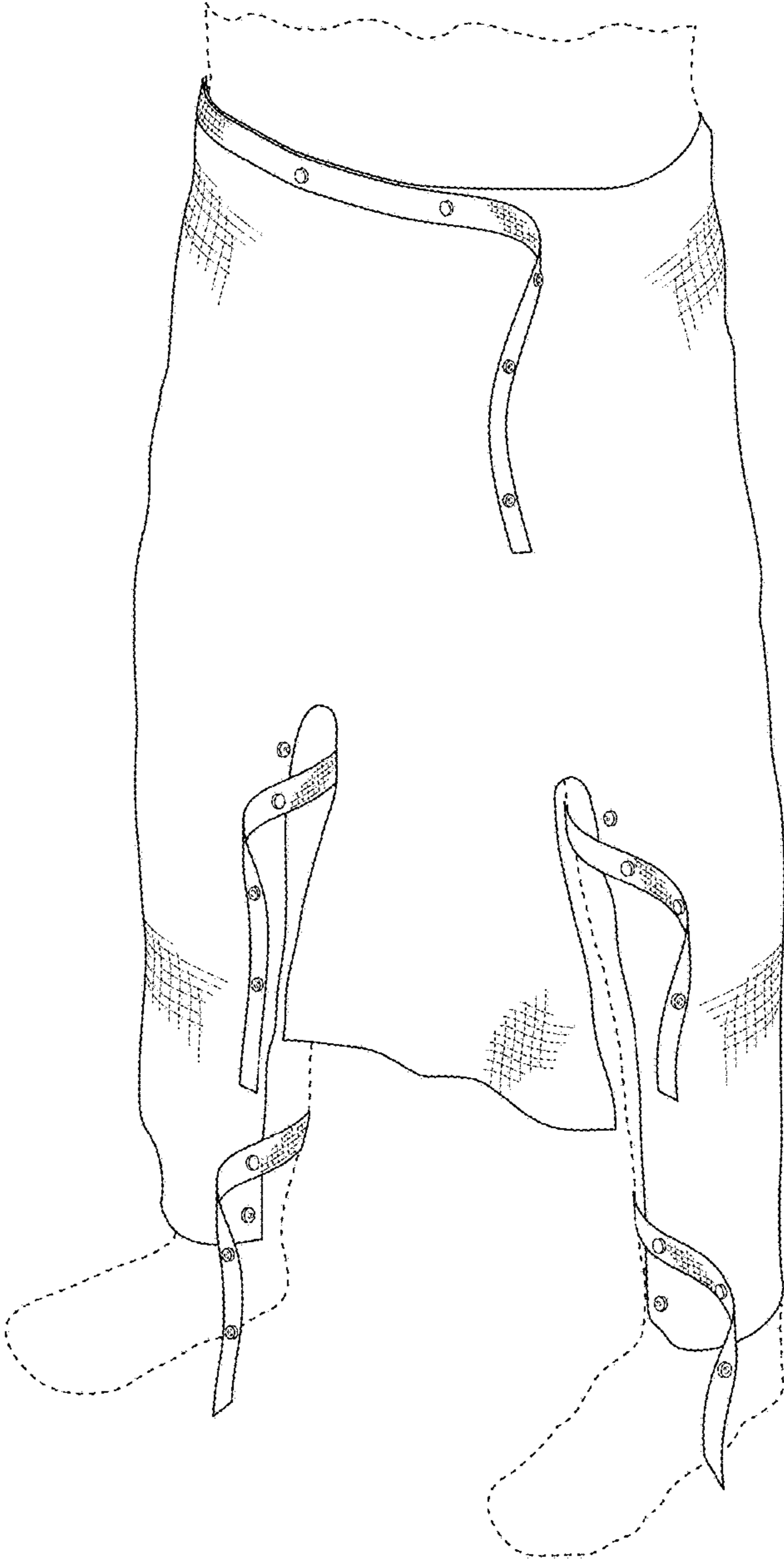

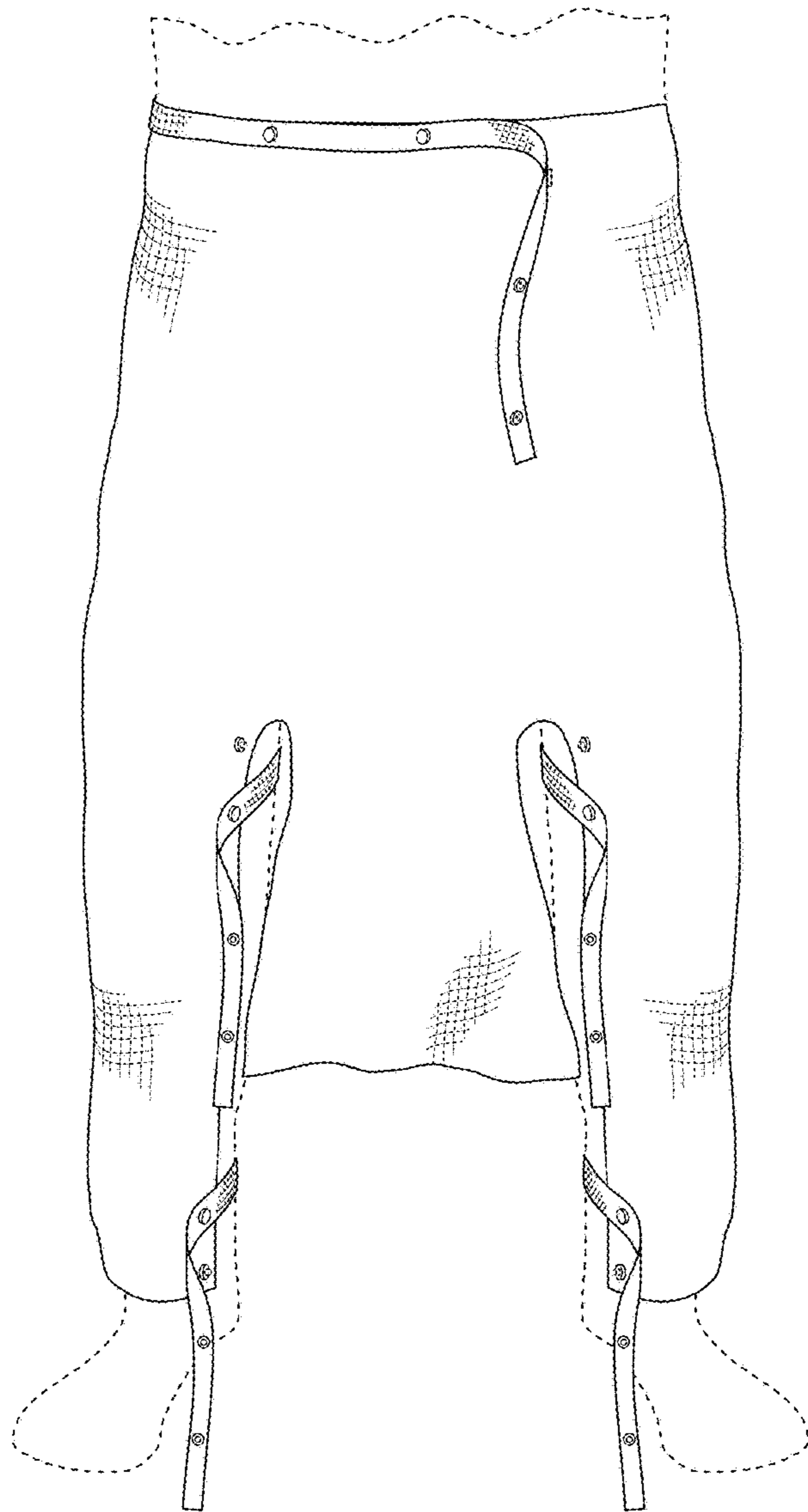

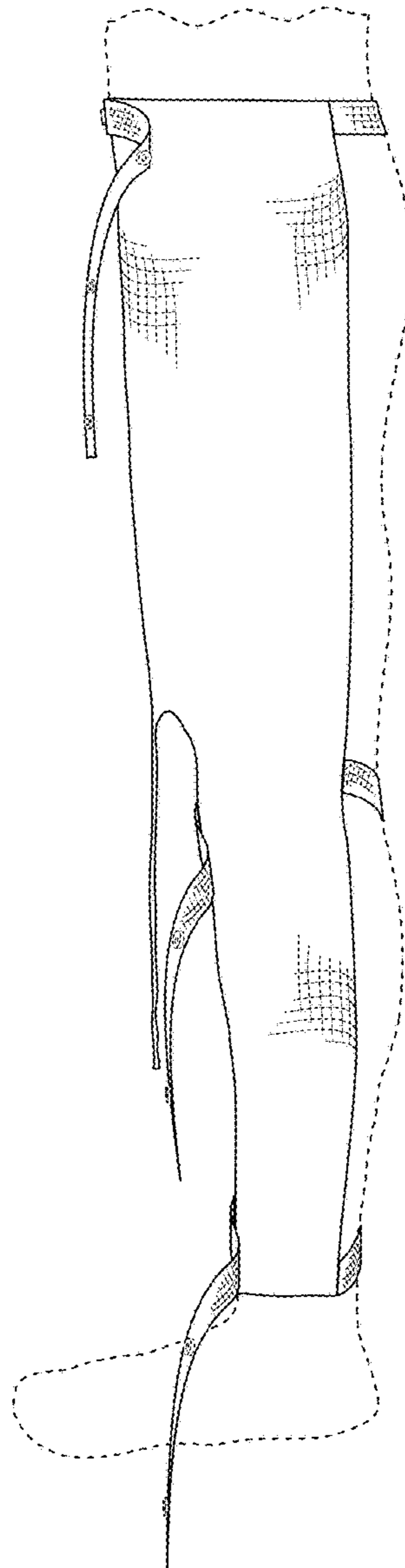
