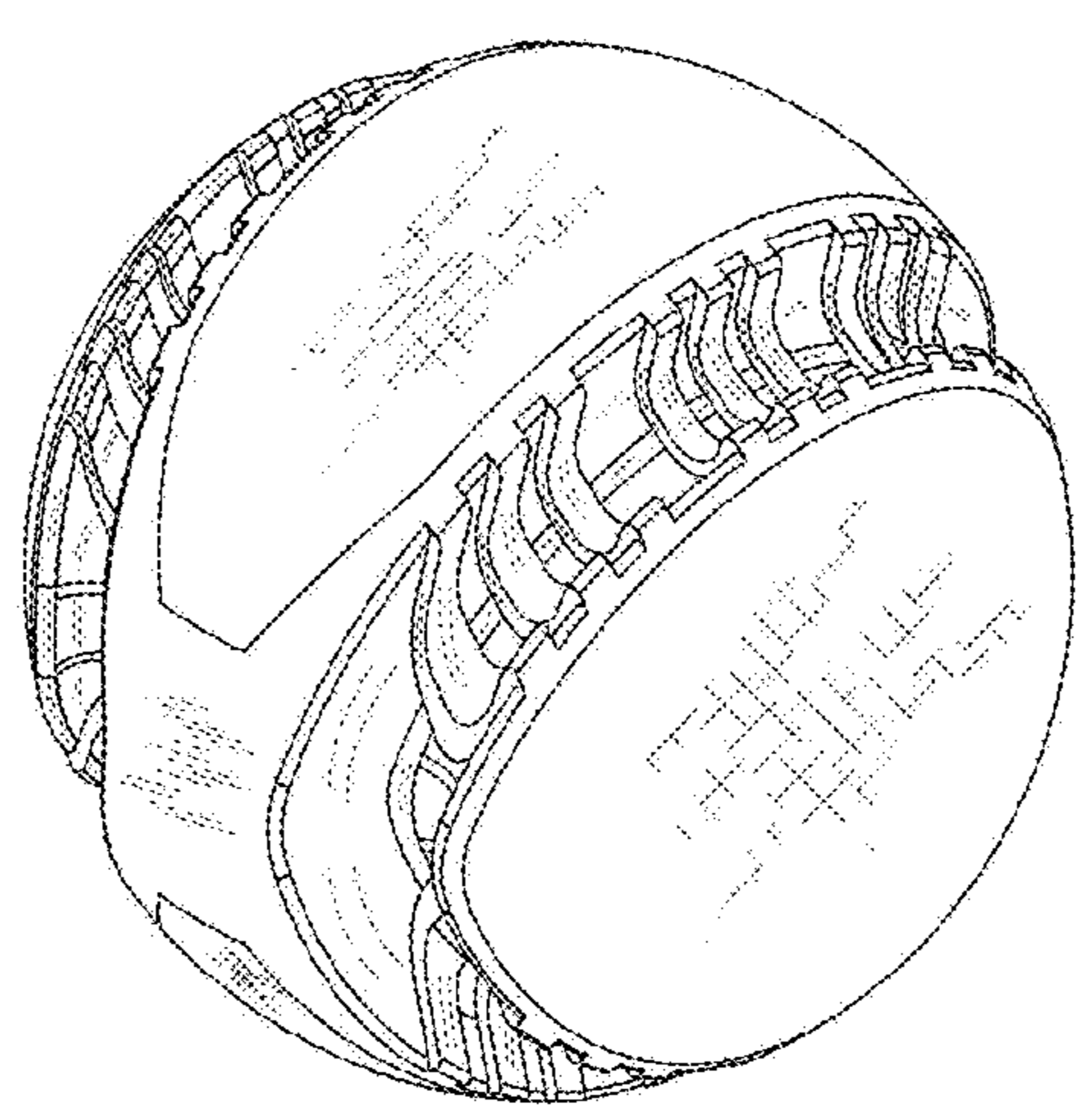

FIG. 1 is a front perspective view of a ball toy showing the new design;
FIG. 2 is a left side view thereof, wherein the right side view, not shown, is a mirror image;
FIG. 3 is a front view thereof, wherein the rear view, not shown, is a mirror image;
FIG. 4 is a top view thereof, wherein the bottom view, not shown, is a mirror image;
FIG. 5 is a first cross-sectional view side view, taken along line 5-5 in FIG. 3; and,
FIG. 6 is a second cross-sectional view side view, taken along line 6-6 in FIG. 3.

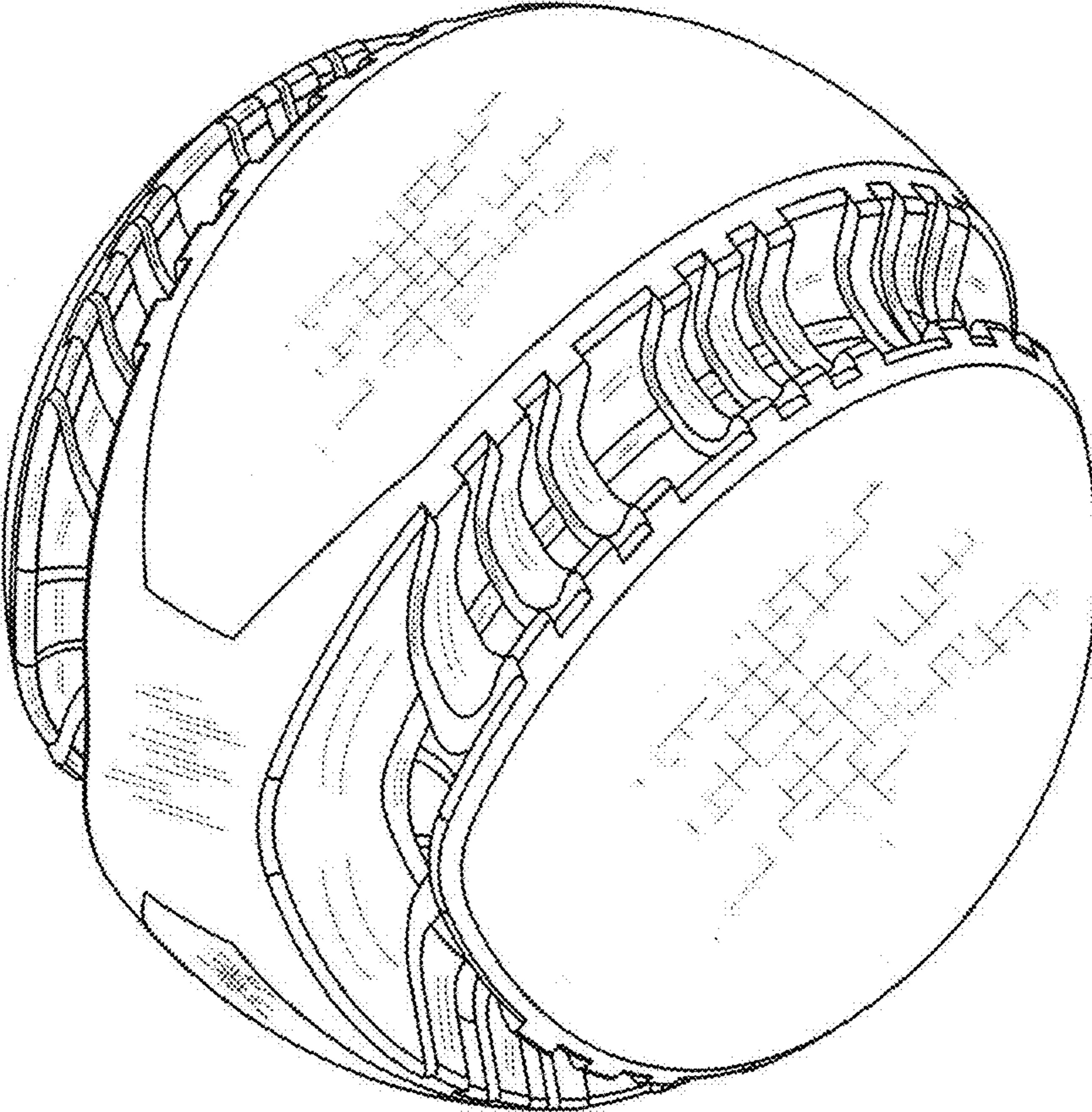

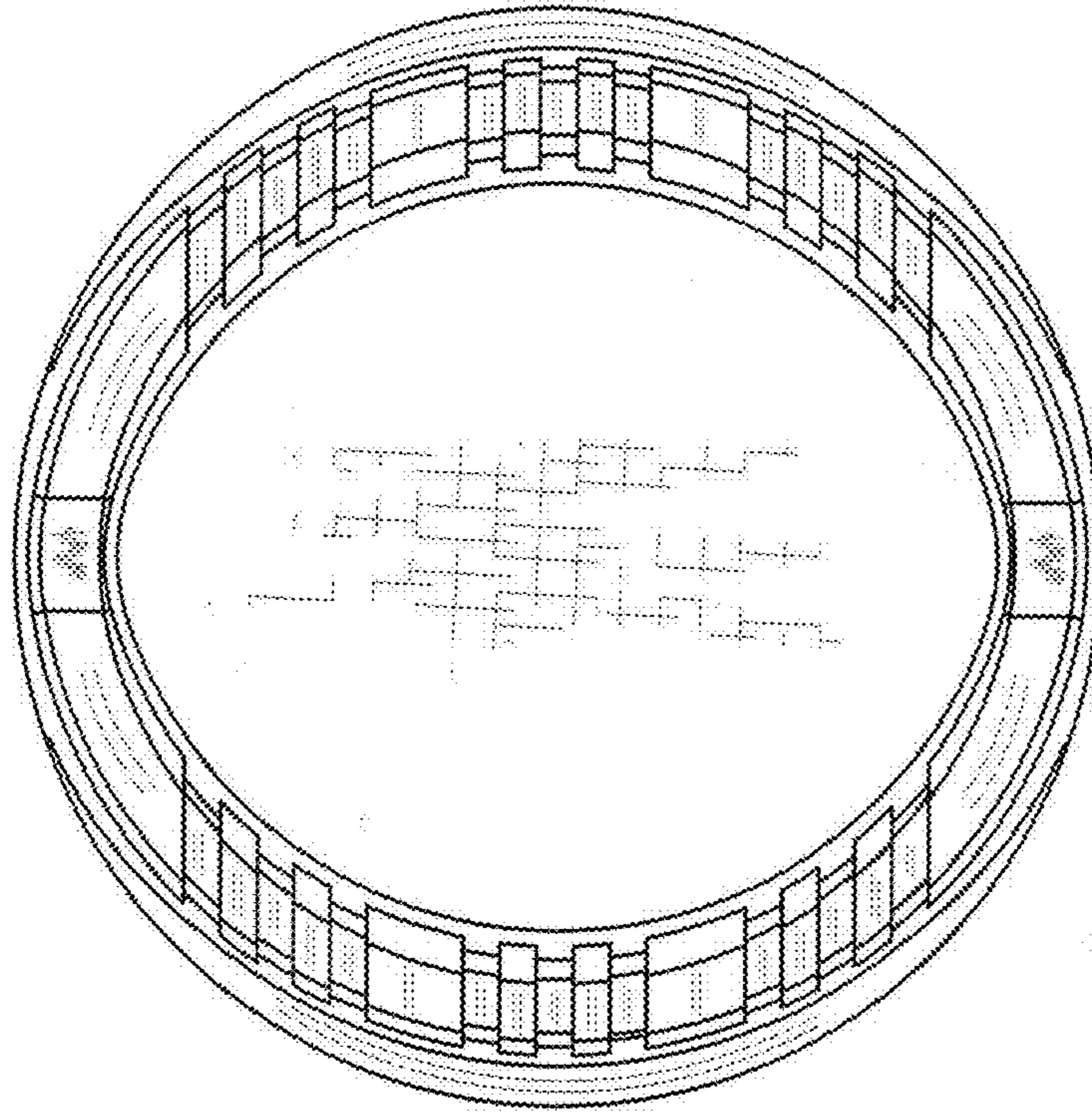

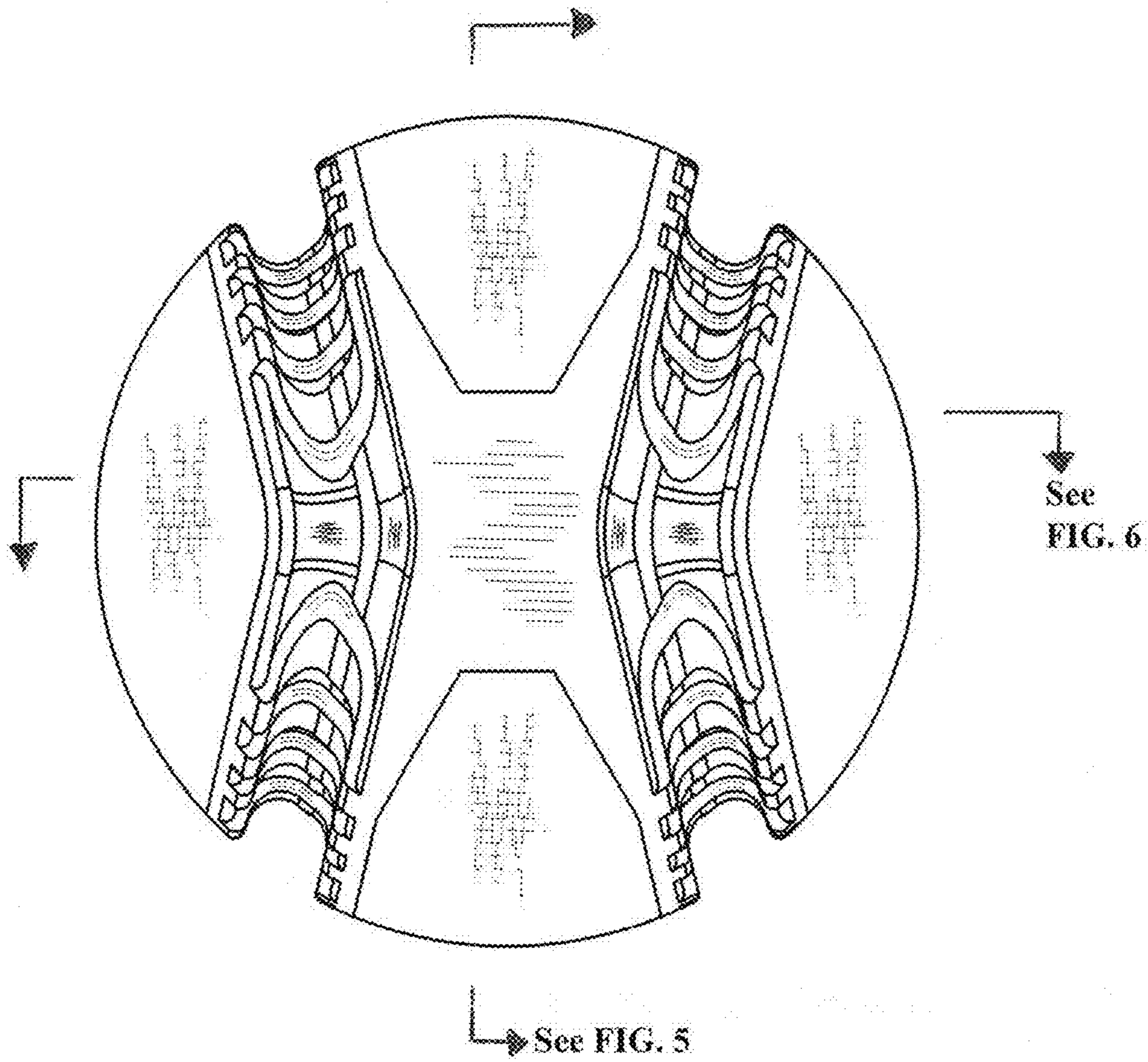

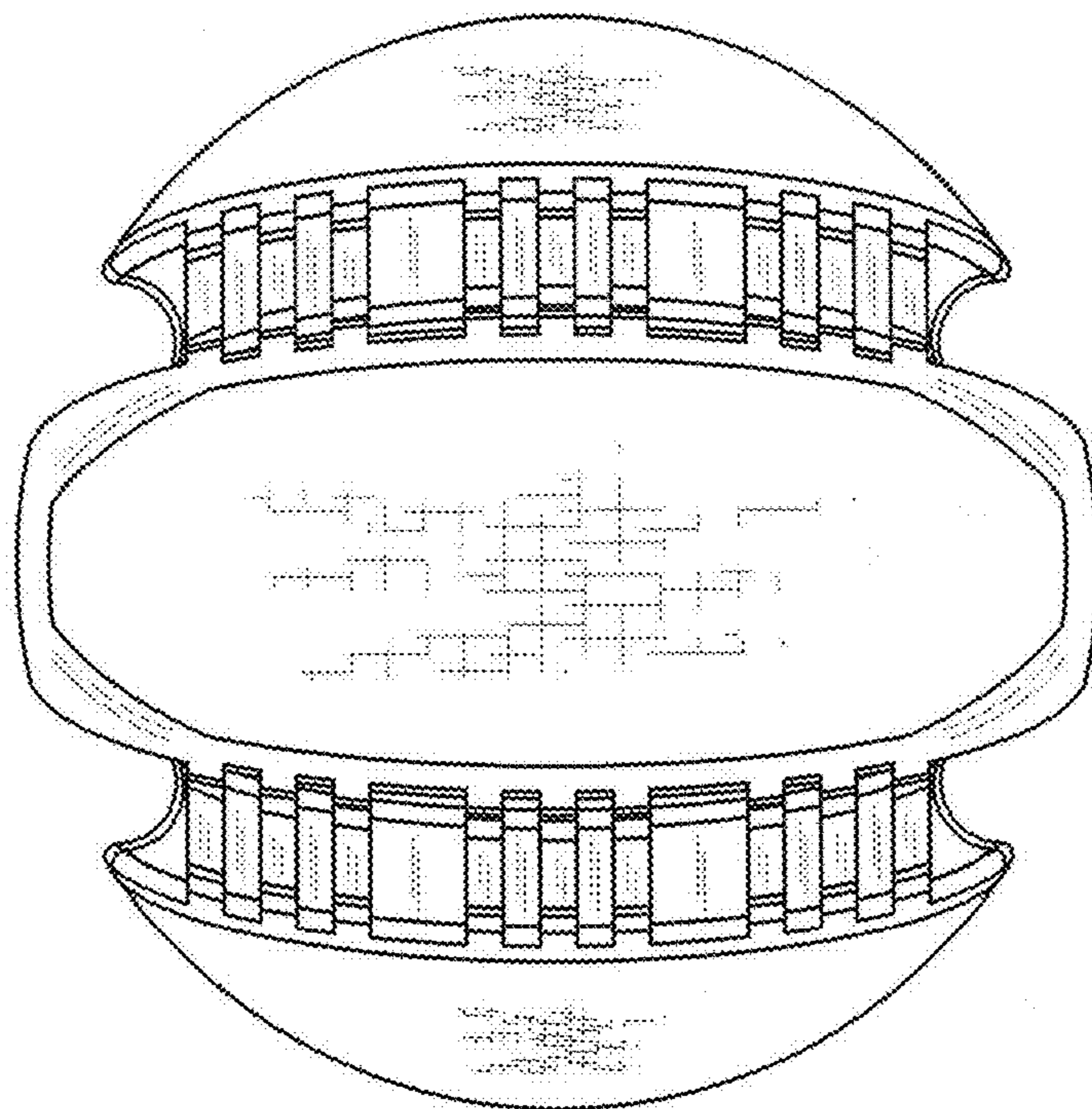

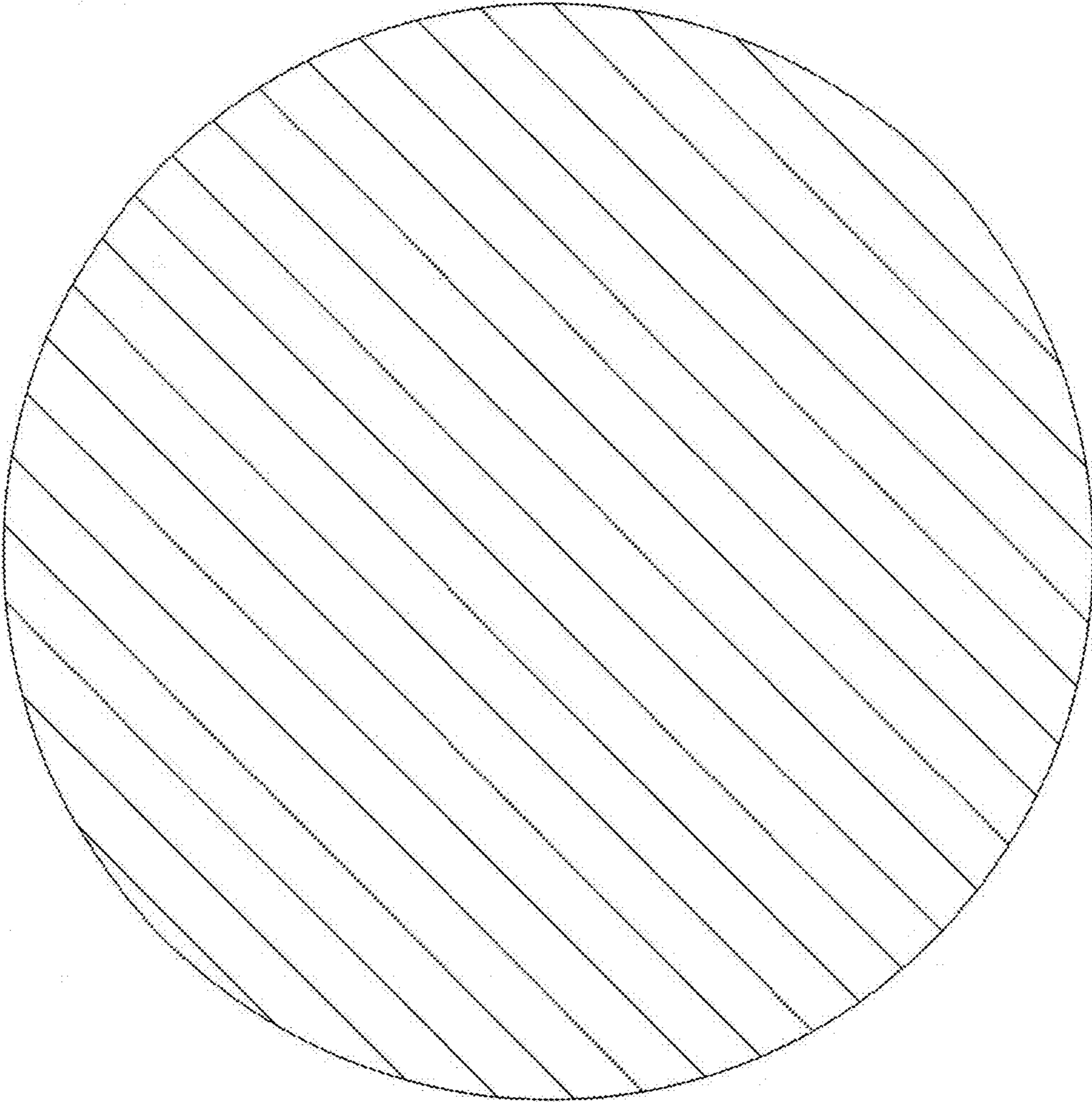

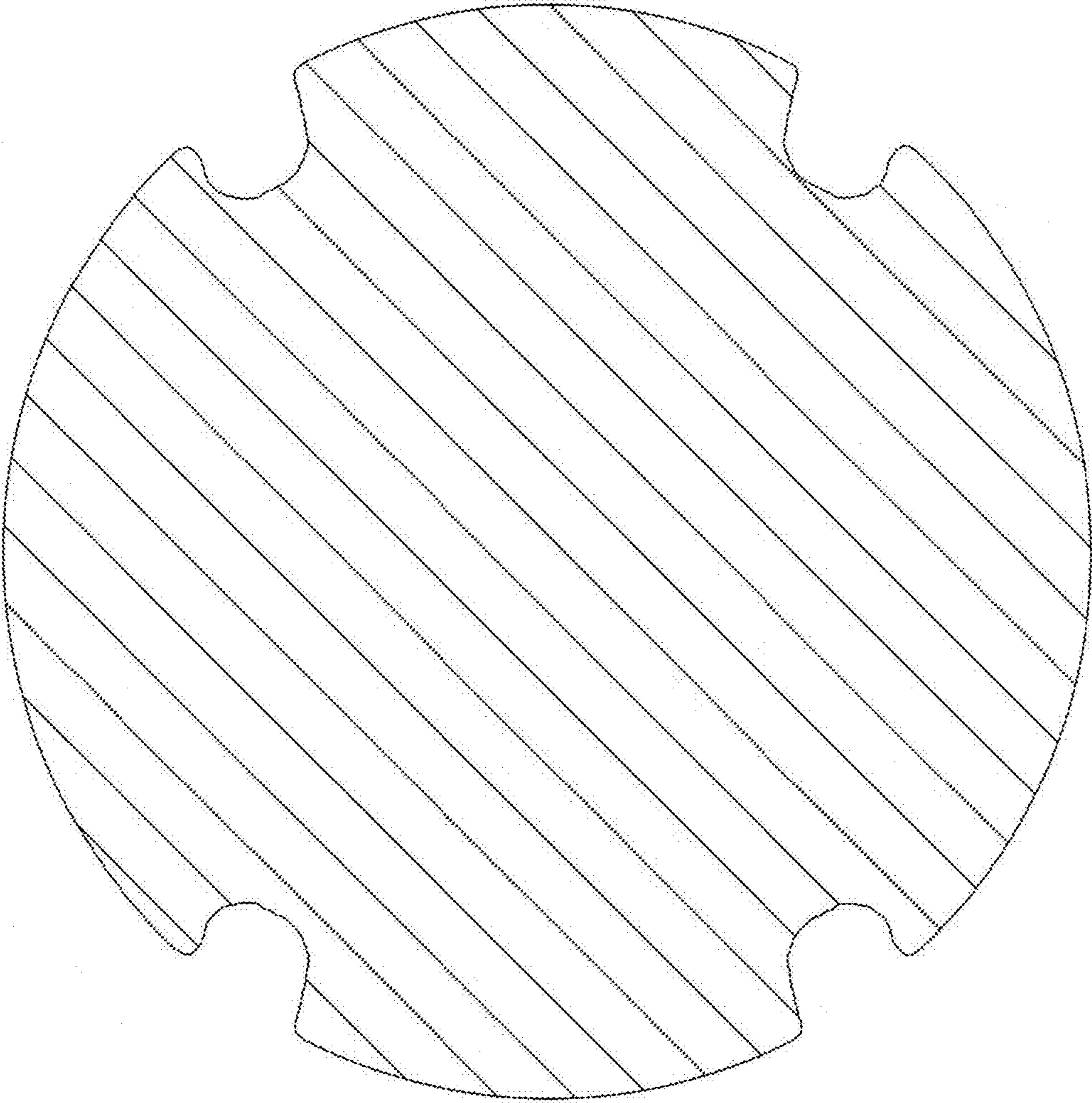
