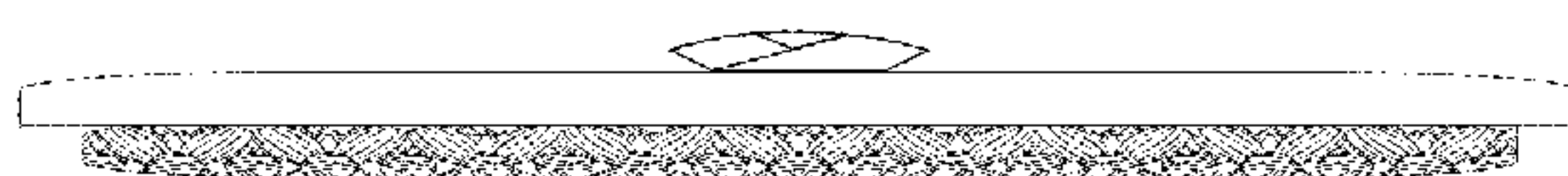
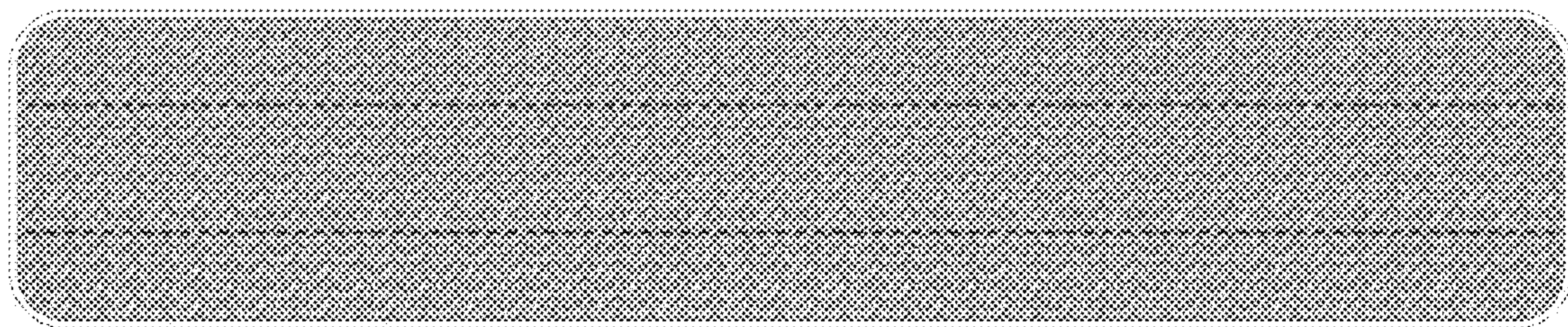
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom plan view of a dry mop pad showing our new design;

FIG. 3 is a front elevation view thereof, the rear elevation view being a mirror image thereof; and,

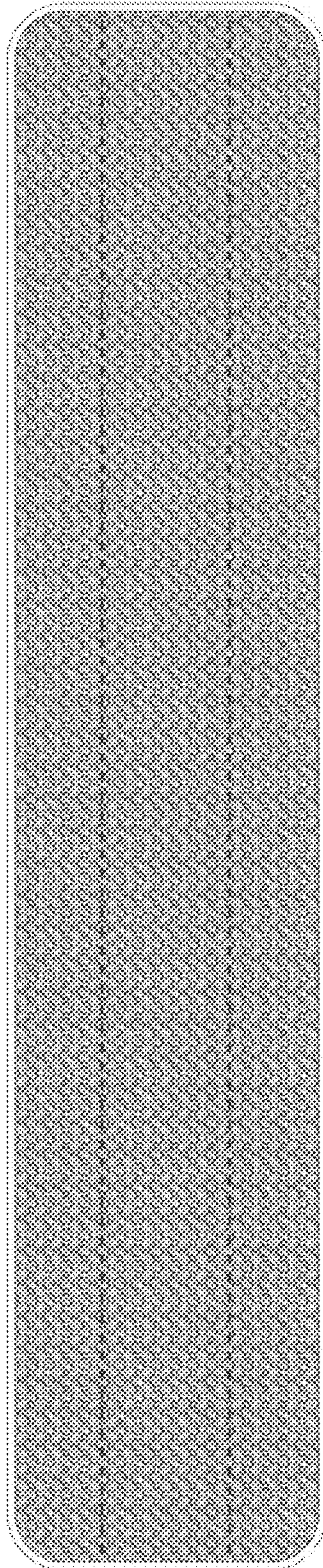

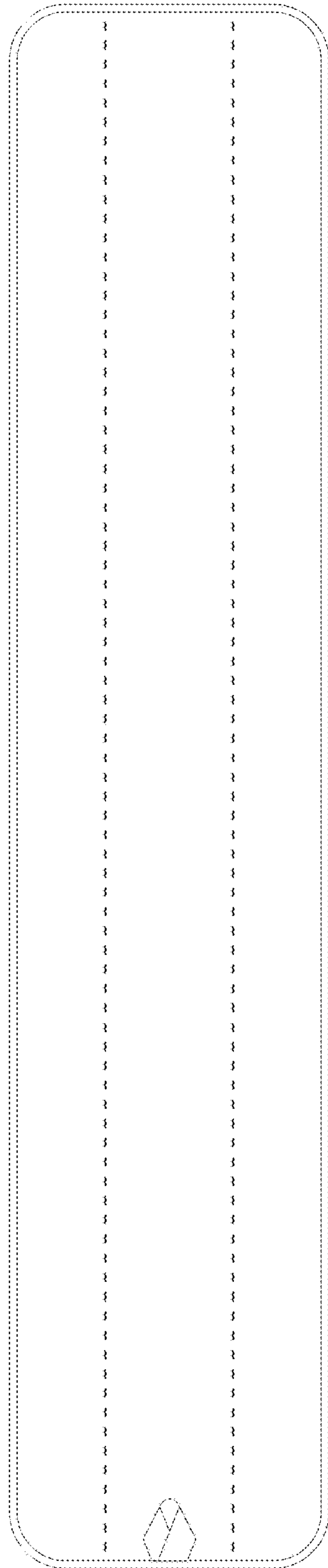

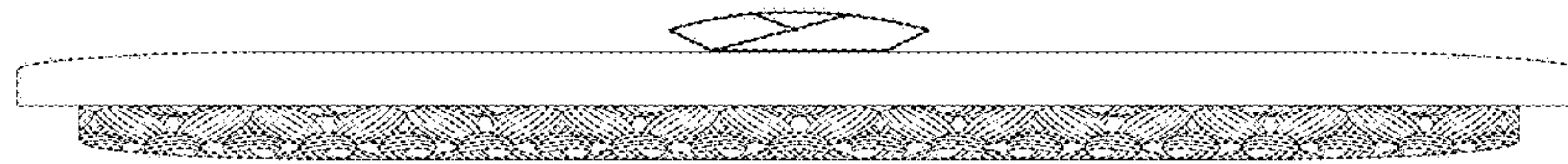
