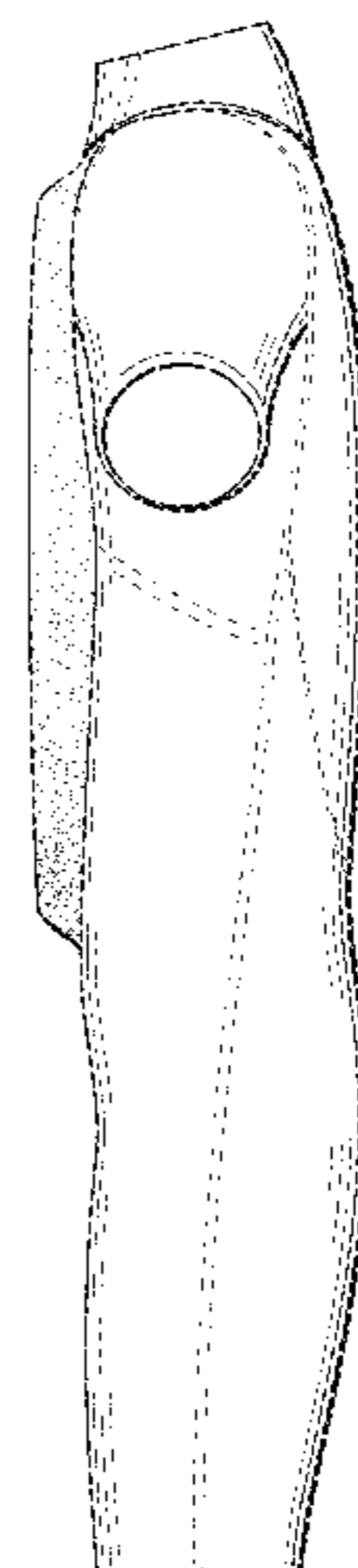
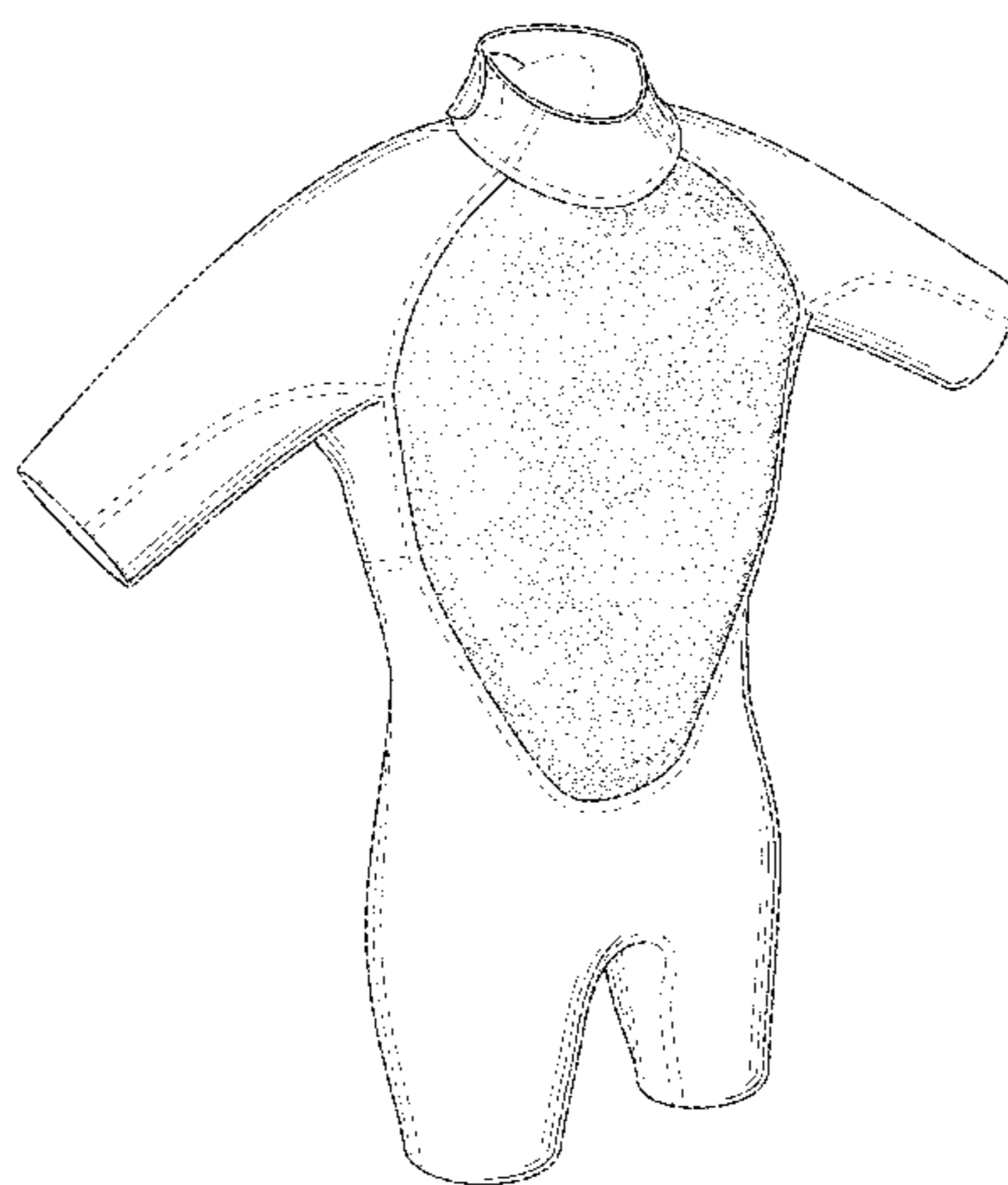
(57) **CLAIM**

The ornamental design for a water flotation suit, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a top, front, left side perspective view of a water flotation suit showing my new design.  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

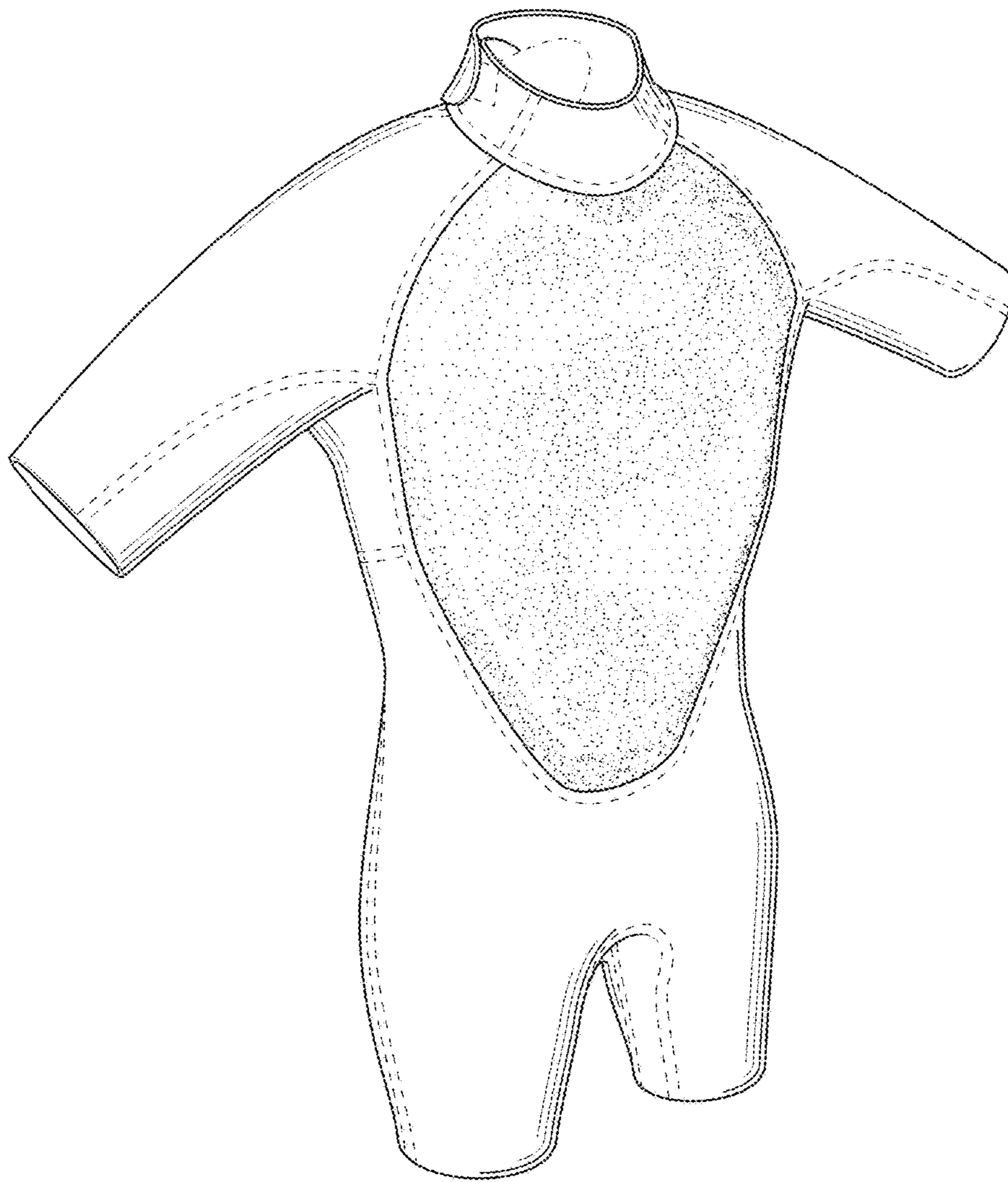

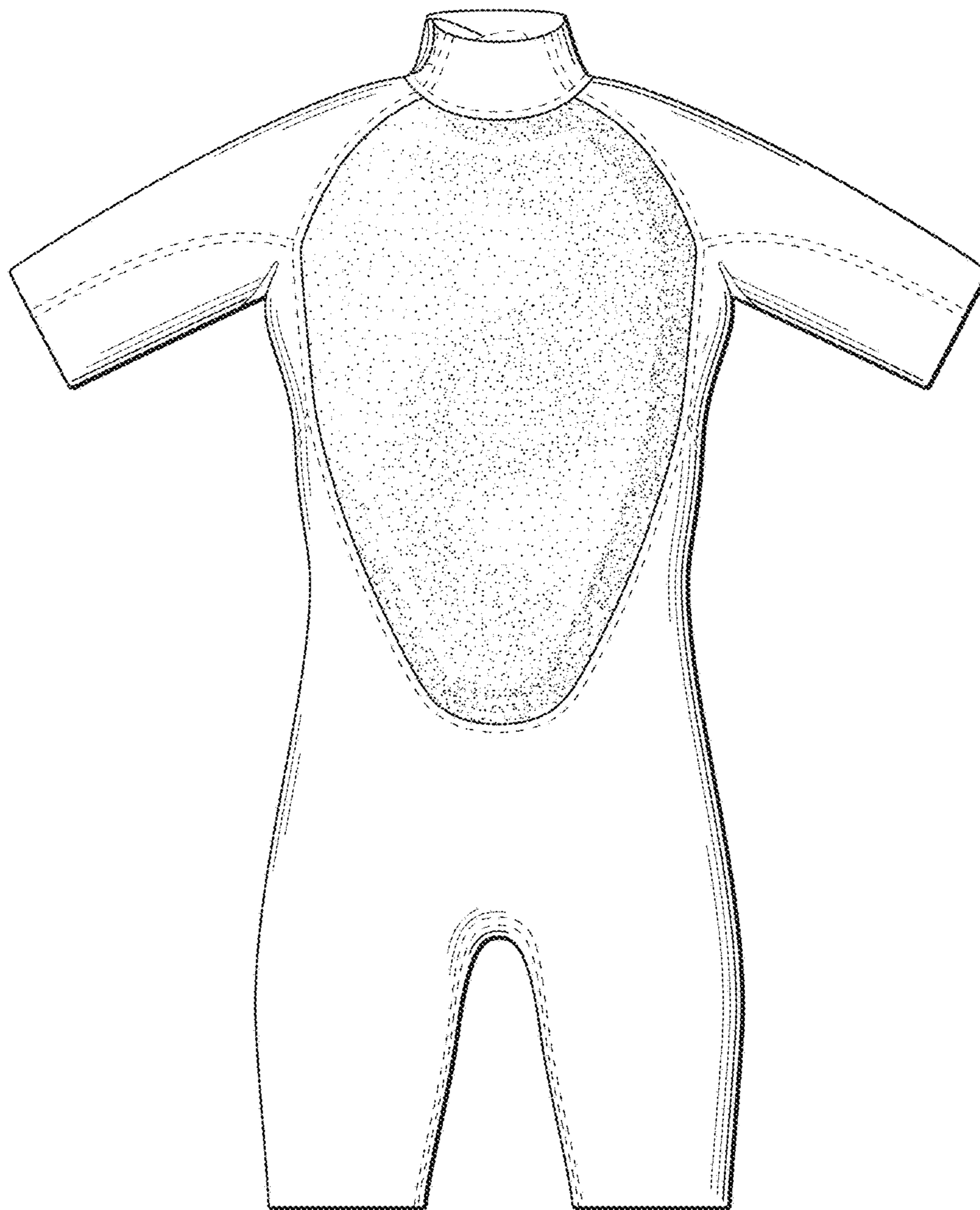

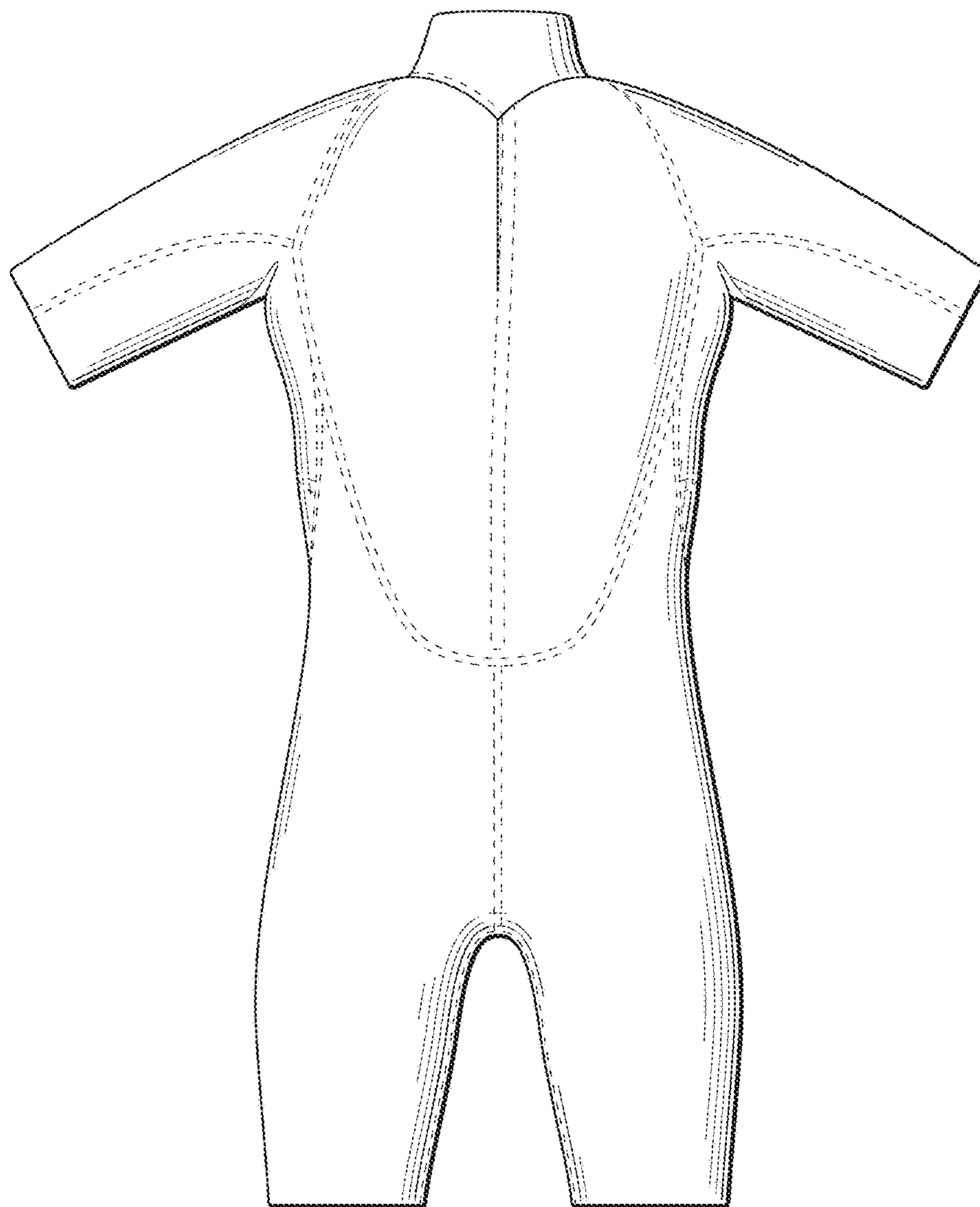

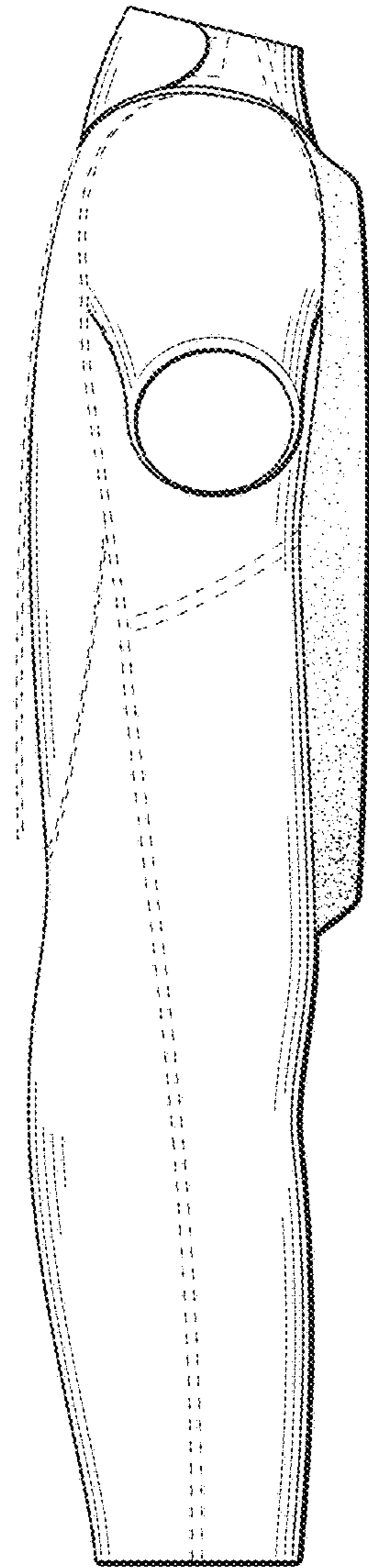

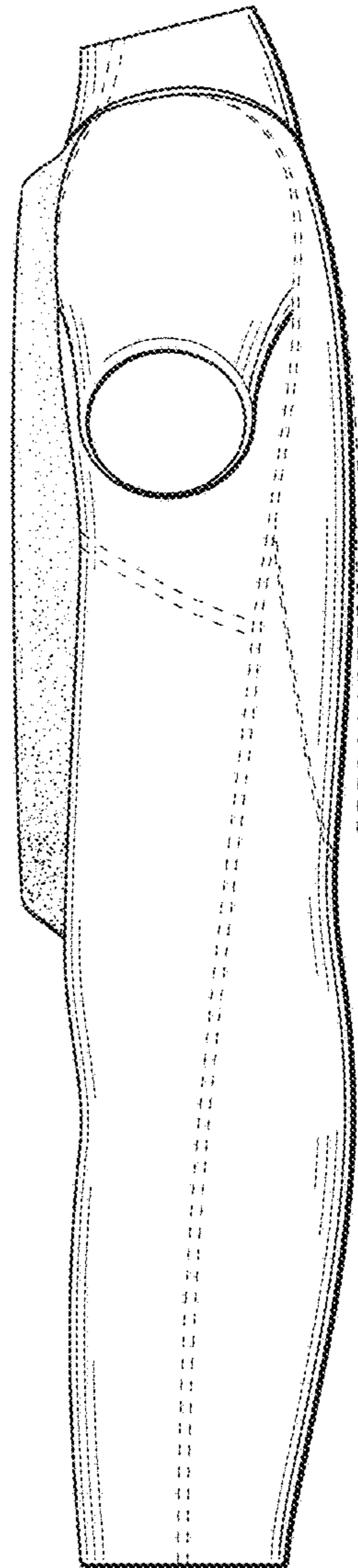

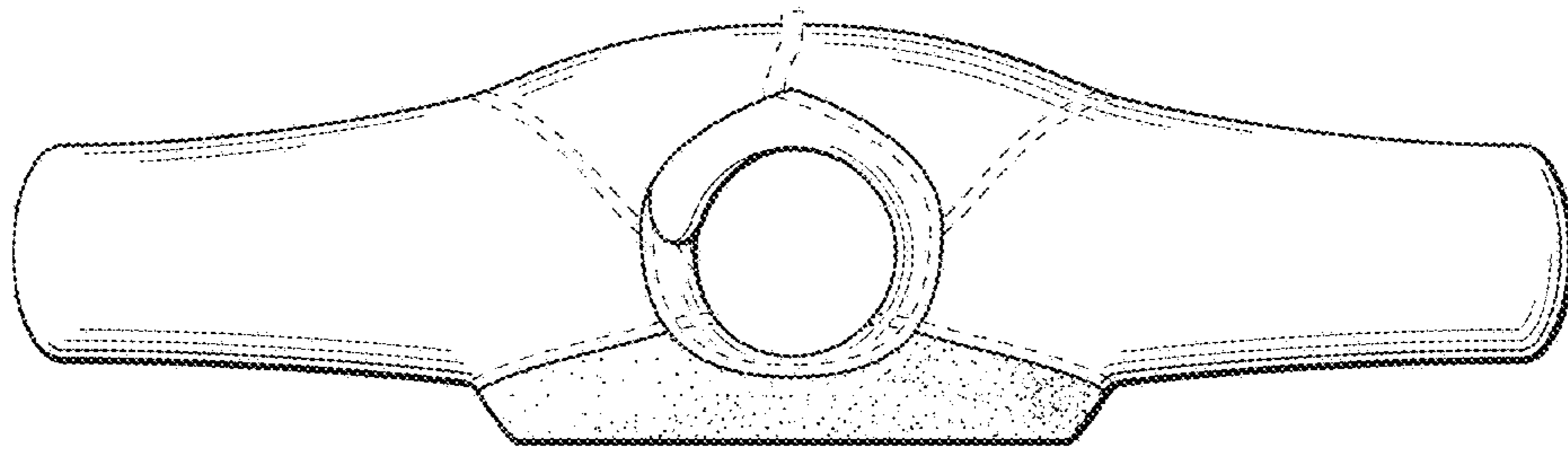

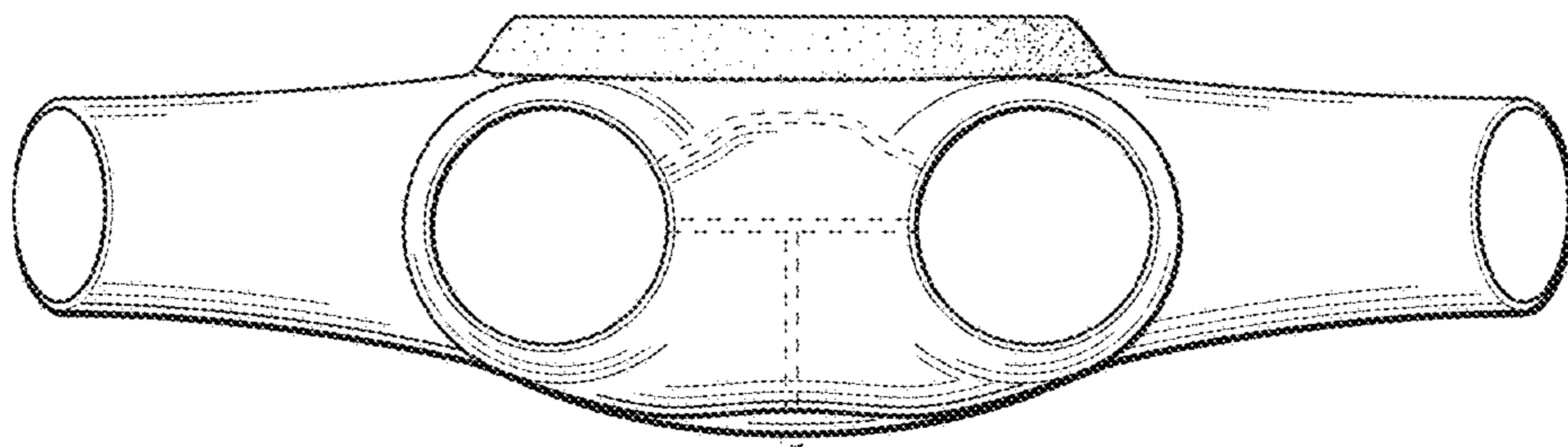
