The ornamental design for paper products including sheets,  
rolls and the like, as shown and described.

**DESCRIPTION**

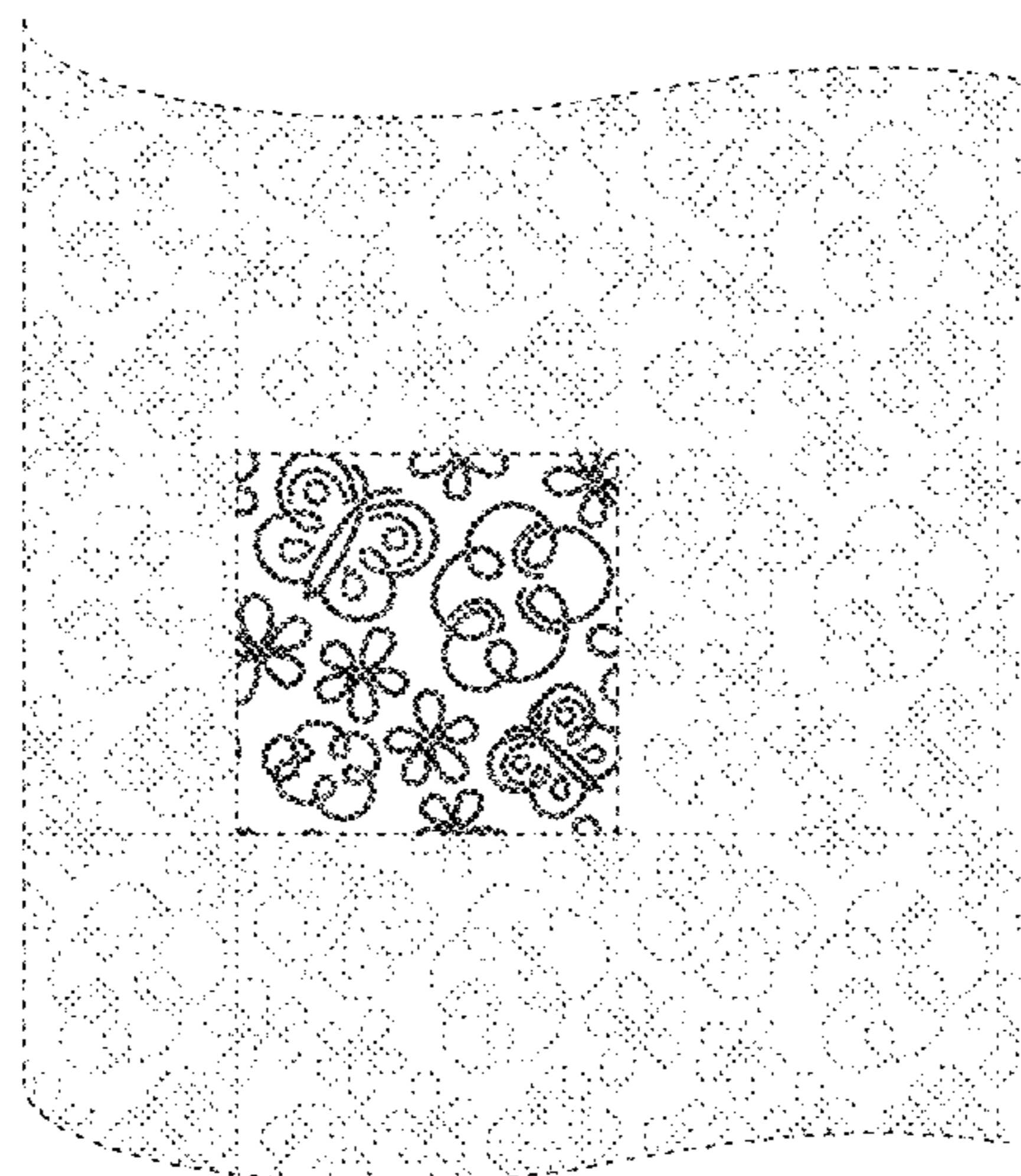
FIG. 1 is a top view of a paper product shown in a position  
of use as part of a roll;

FIG. 2 is the bottom view of the paper product of FIG. 1  
placed in a position on the roll closer to the outside edge;  
and,

FIG. 3 is a top view of the paper product.

The inner broken line surrounding the paper product depicts  
the boundary of the claim and forms no part thereof. The  
broken lines, greyscale features and areas outside of the  
boundary depict environmental subject matter that forms no  
part of the claimed design.

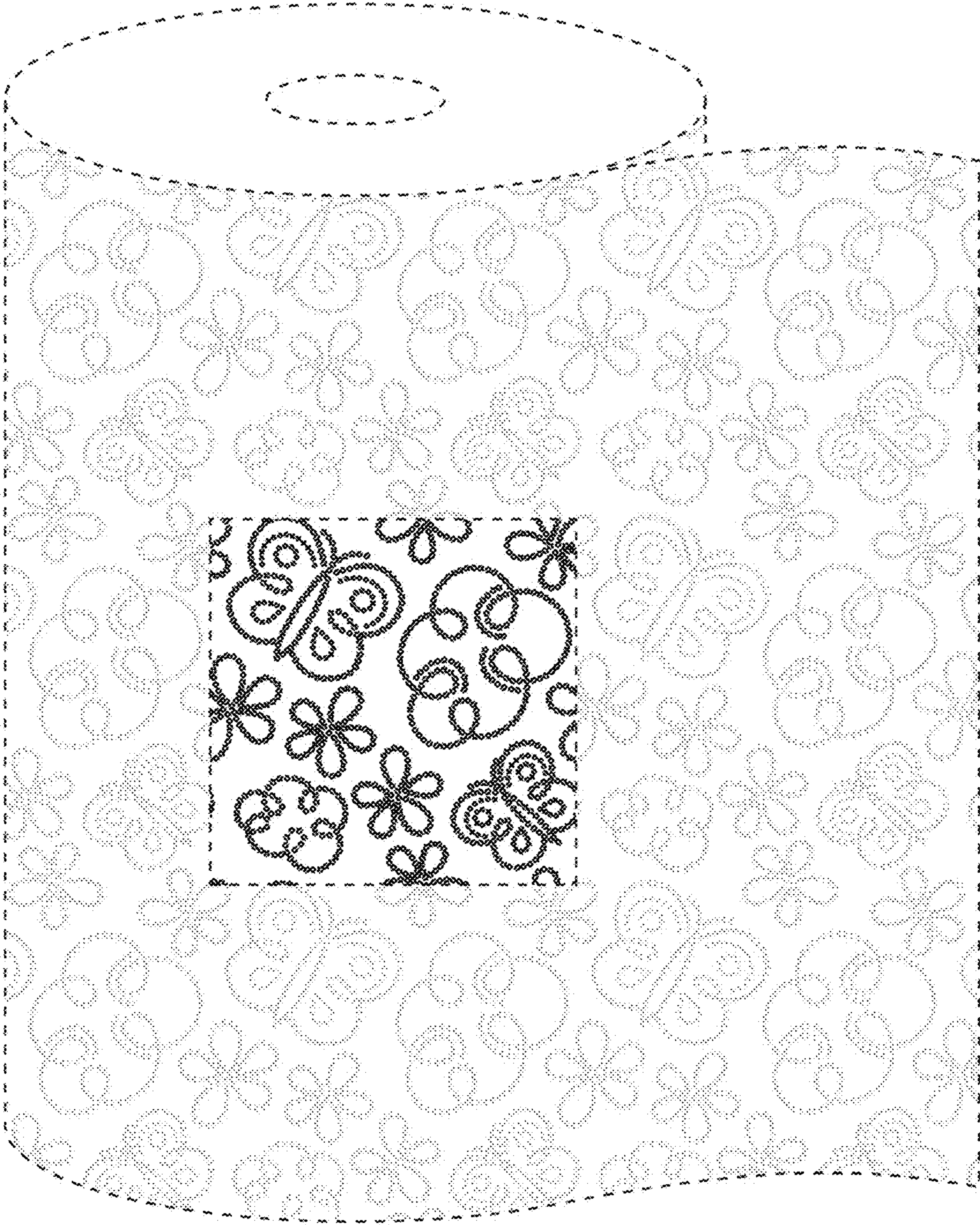

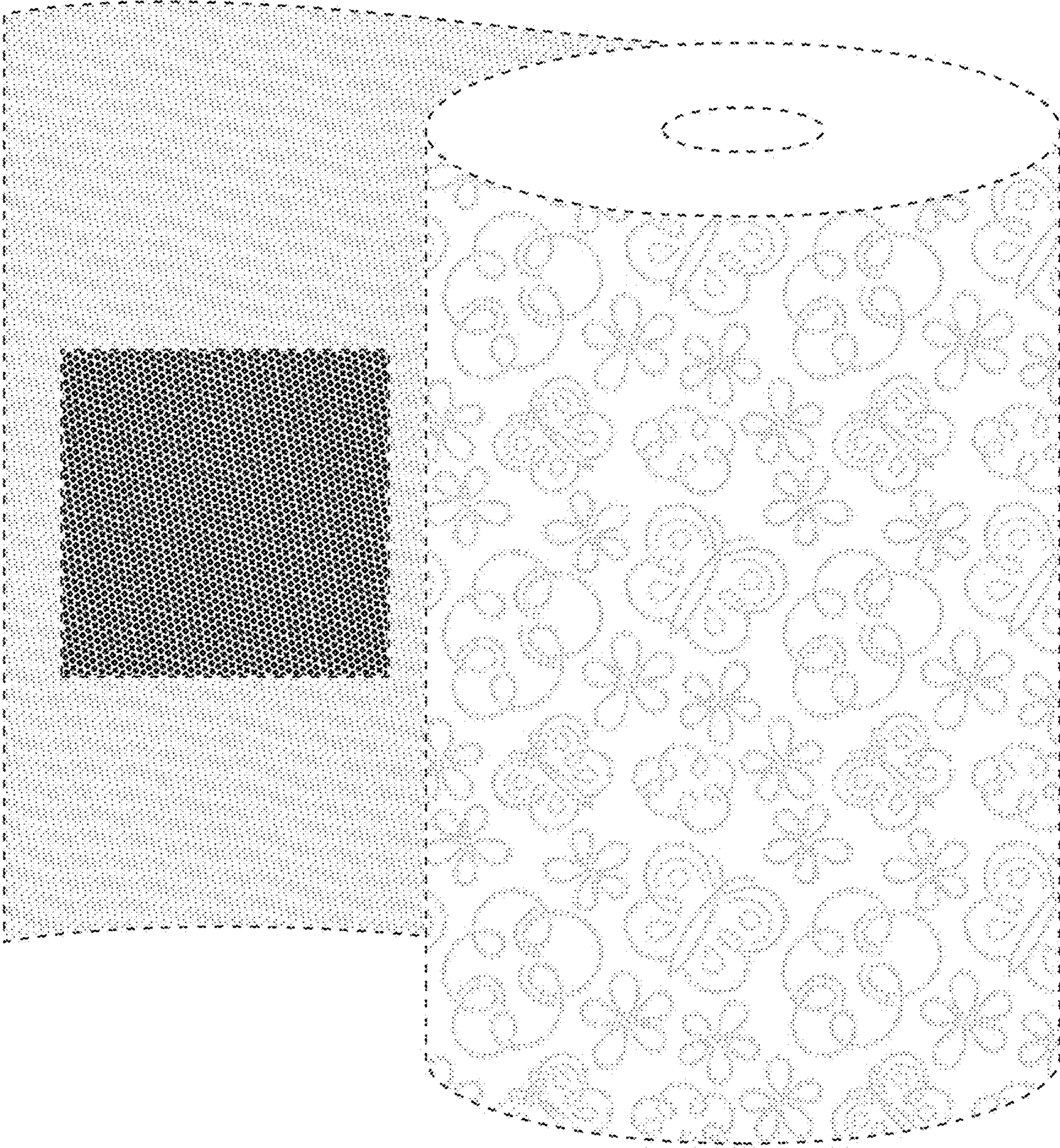

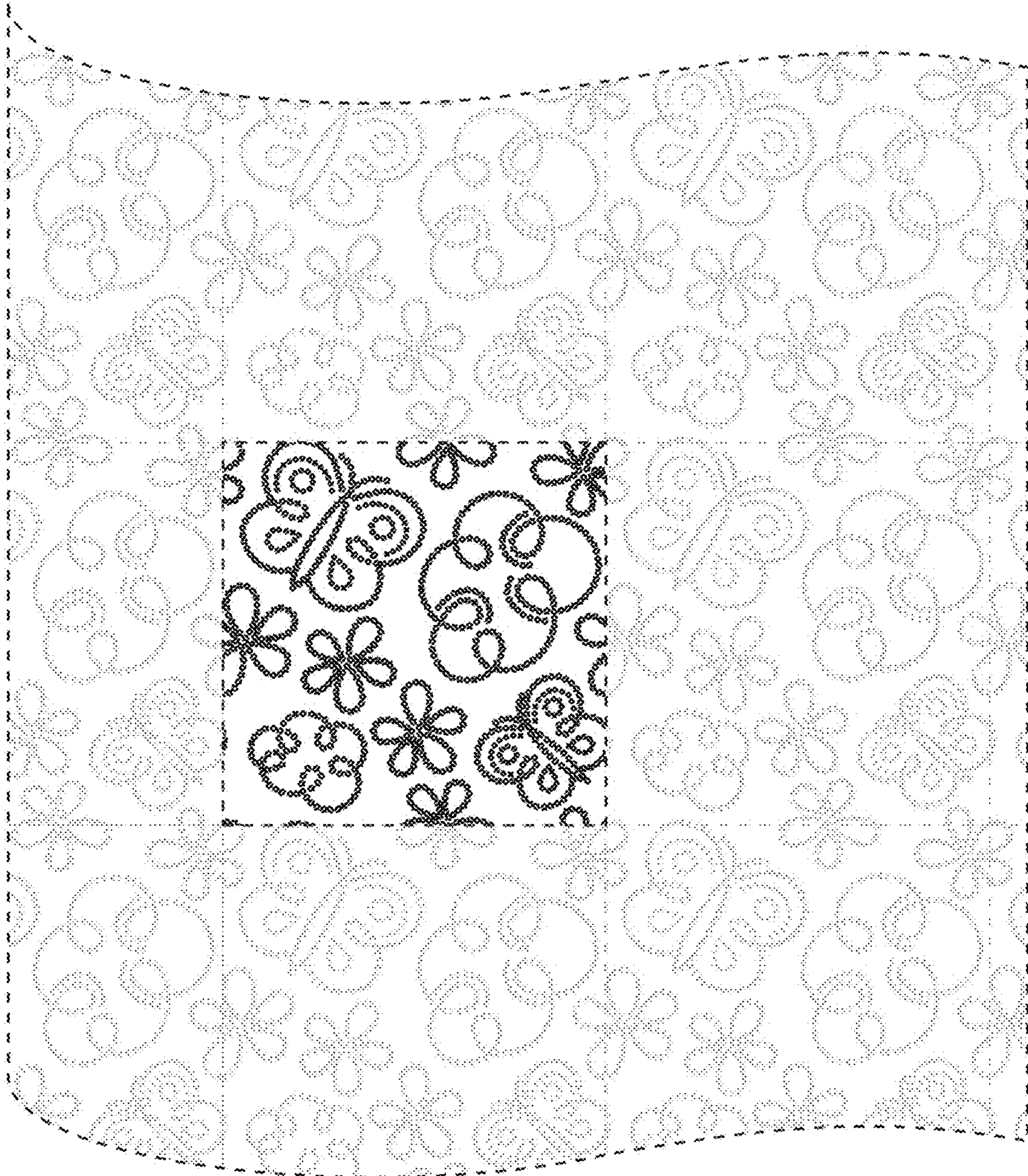
