The ornamental design for a water bottle with handle, as shown and described.

DESCRIPTION

FIG. 1 is an top, rear perspective view of a water bottle with handle, showing my new design;

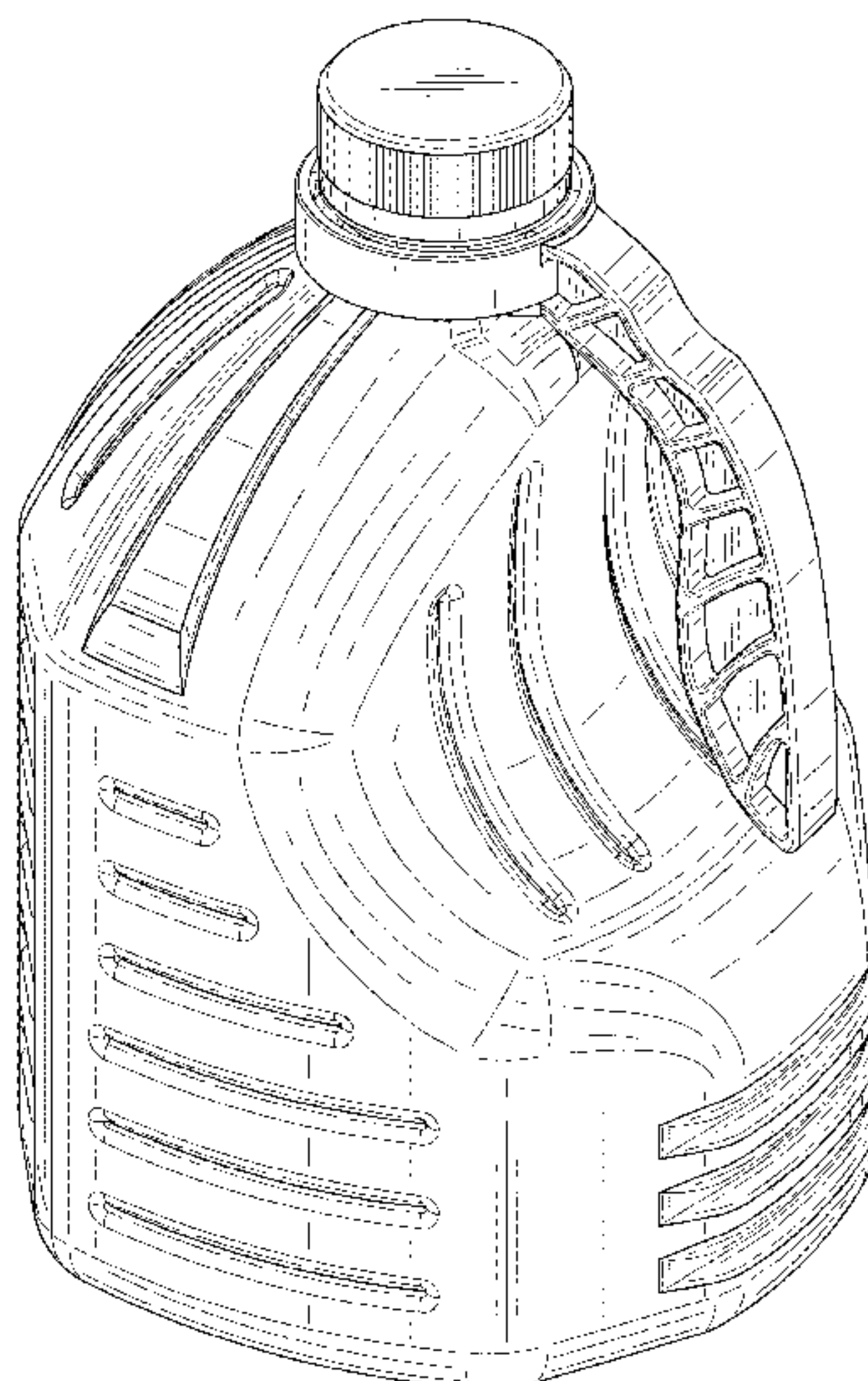

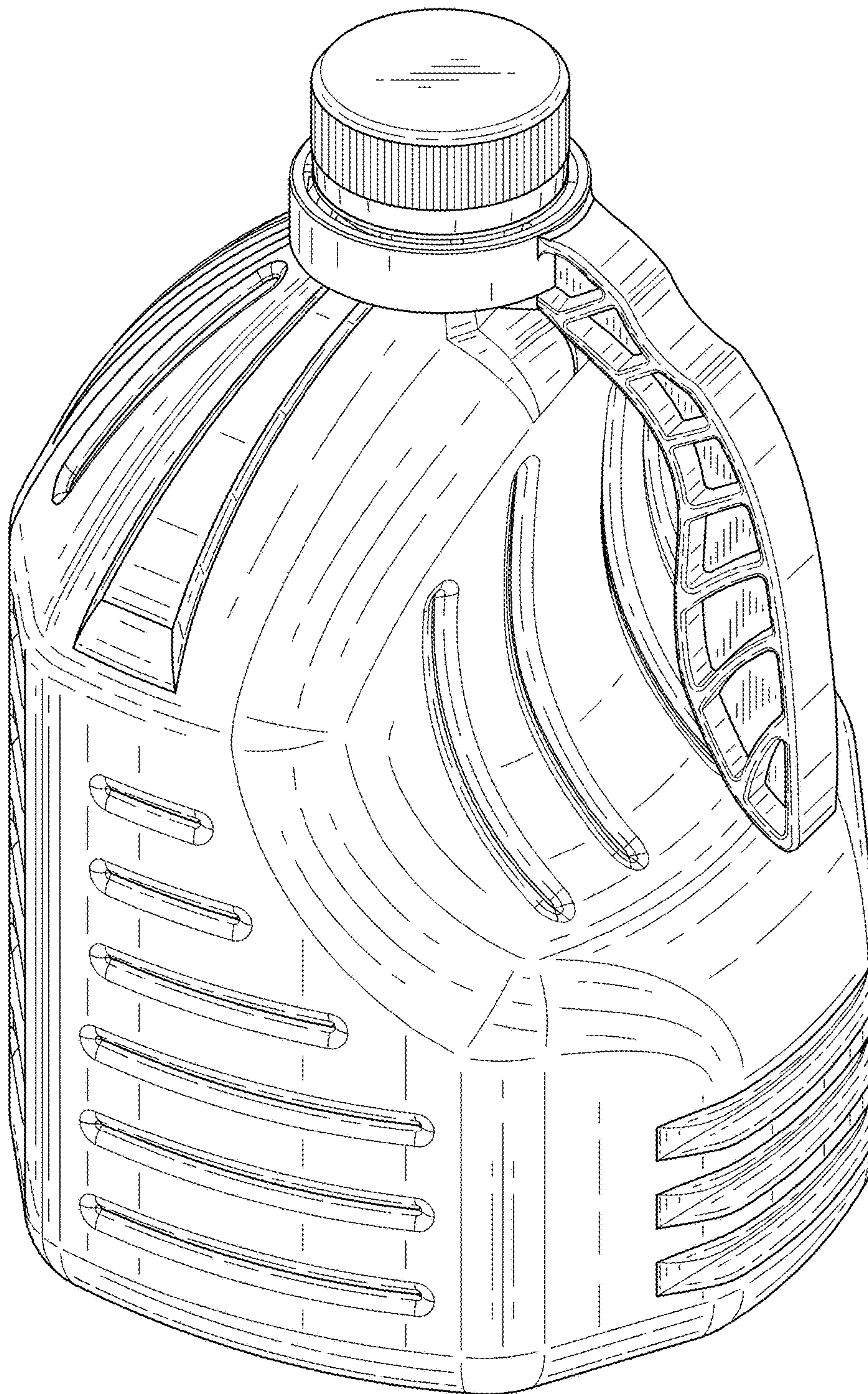

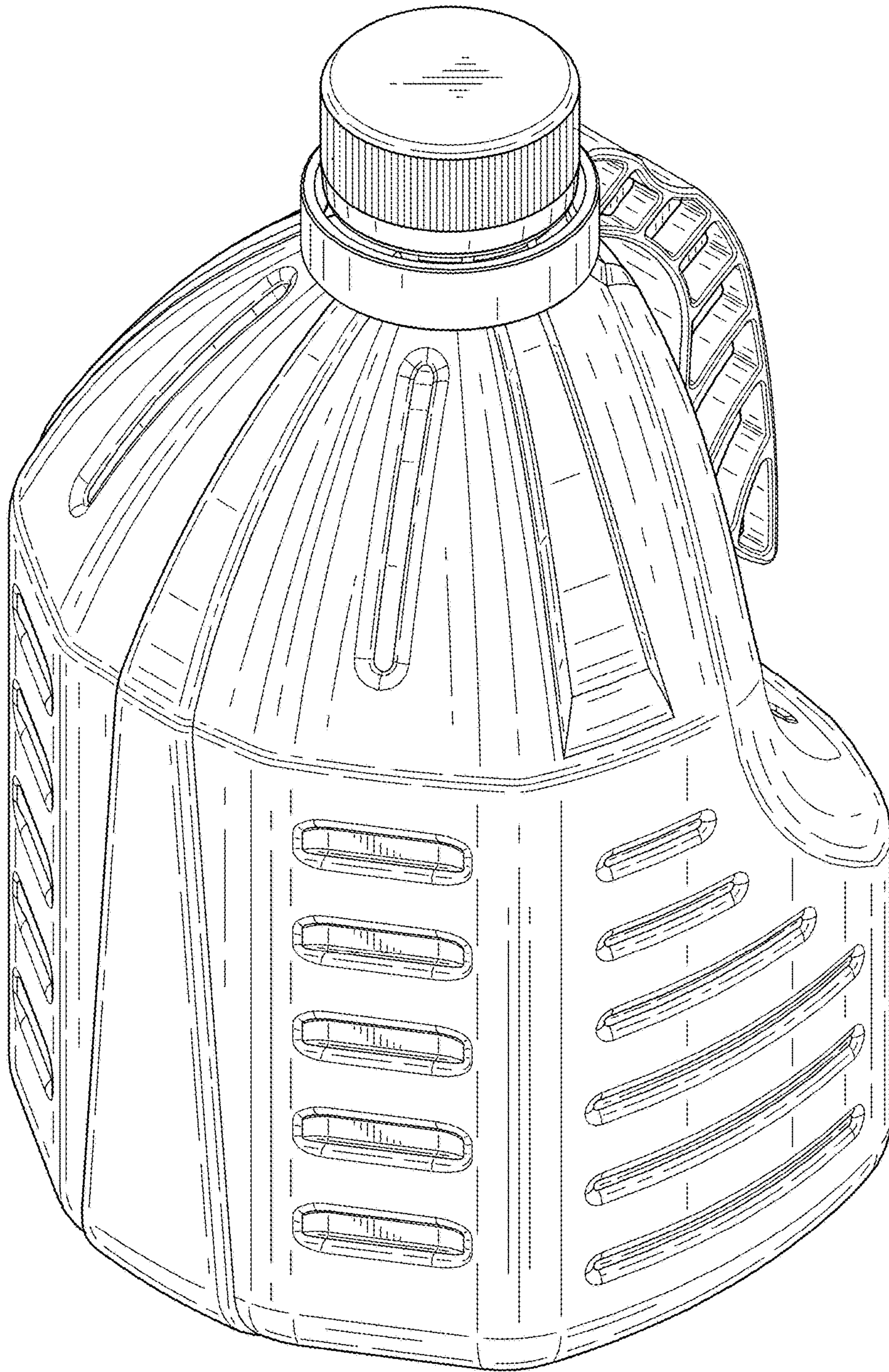

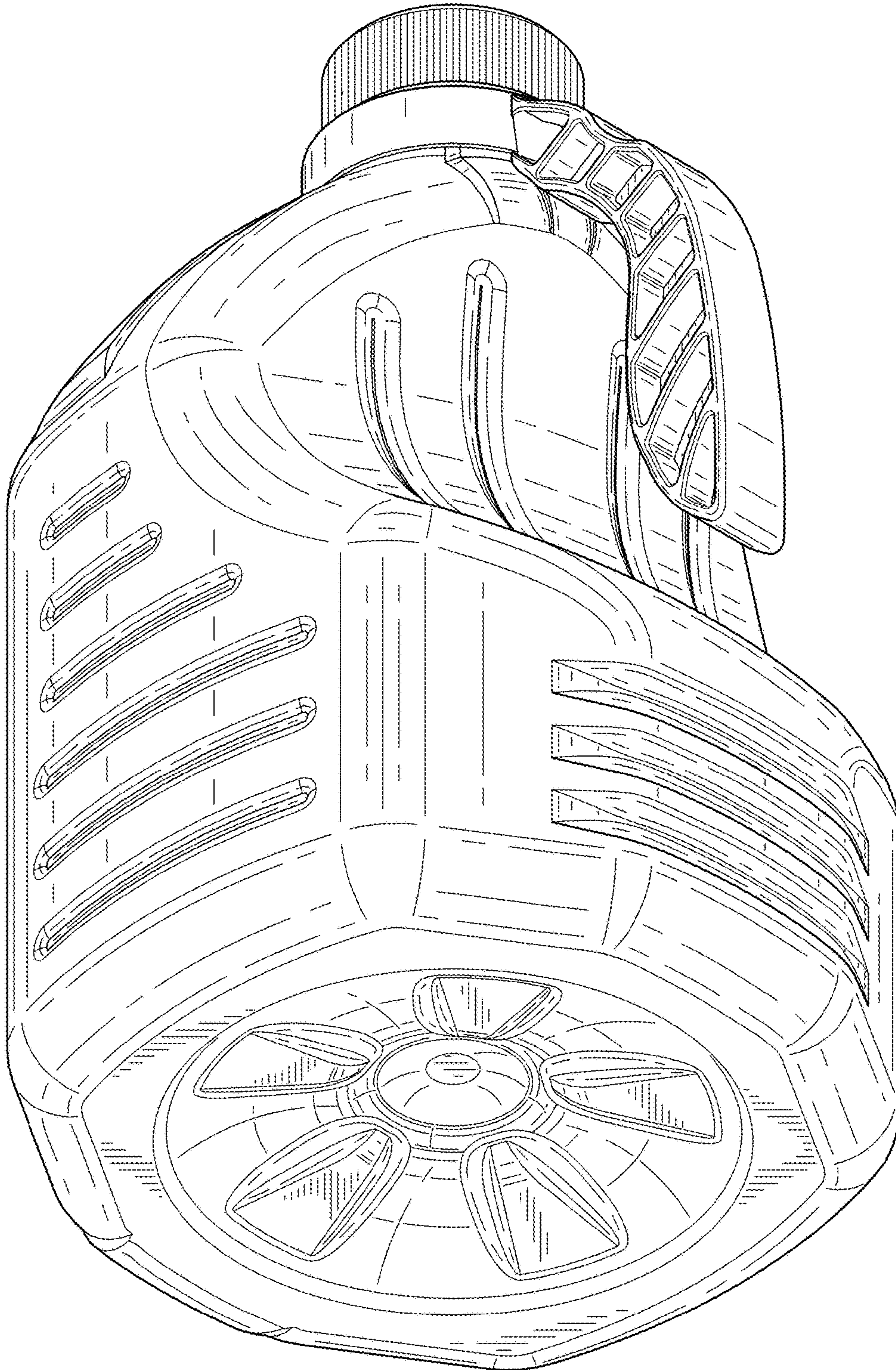

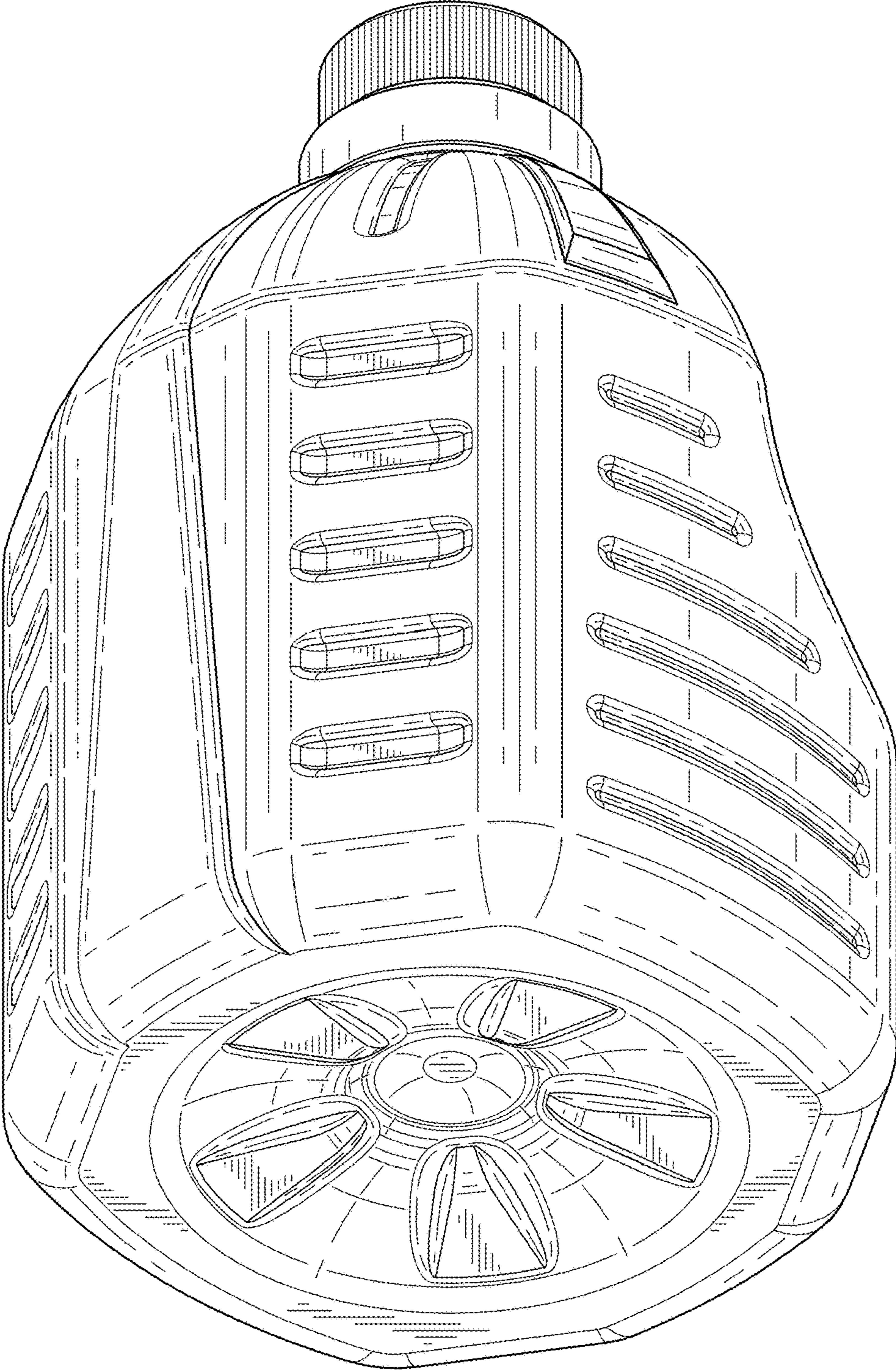

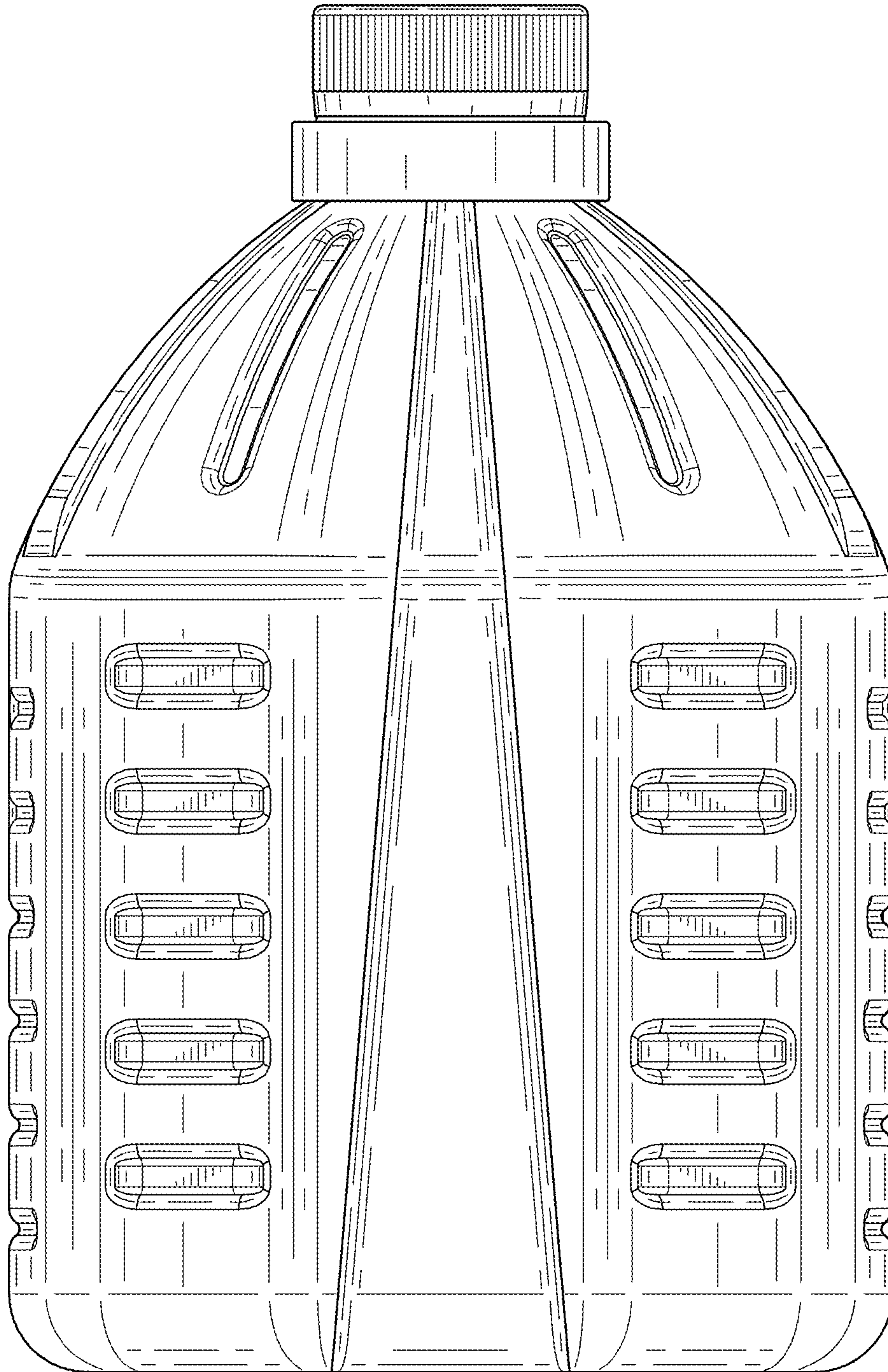

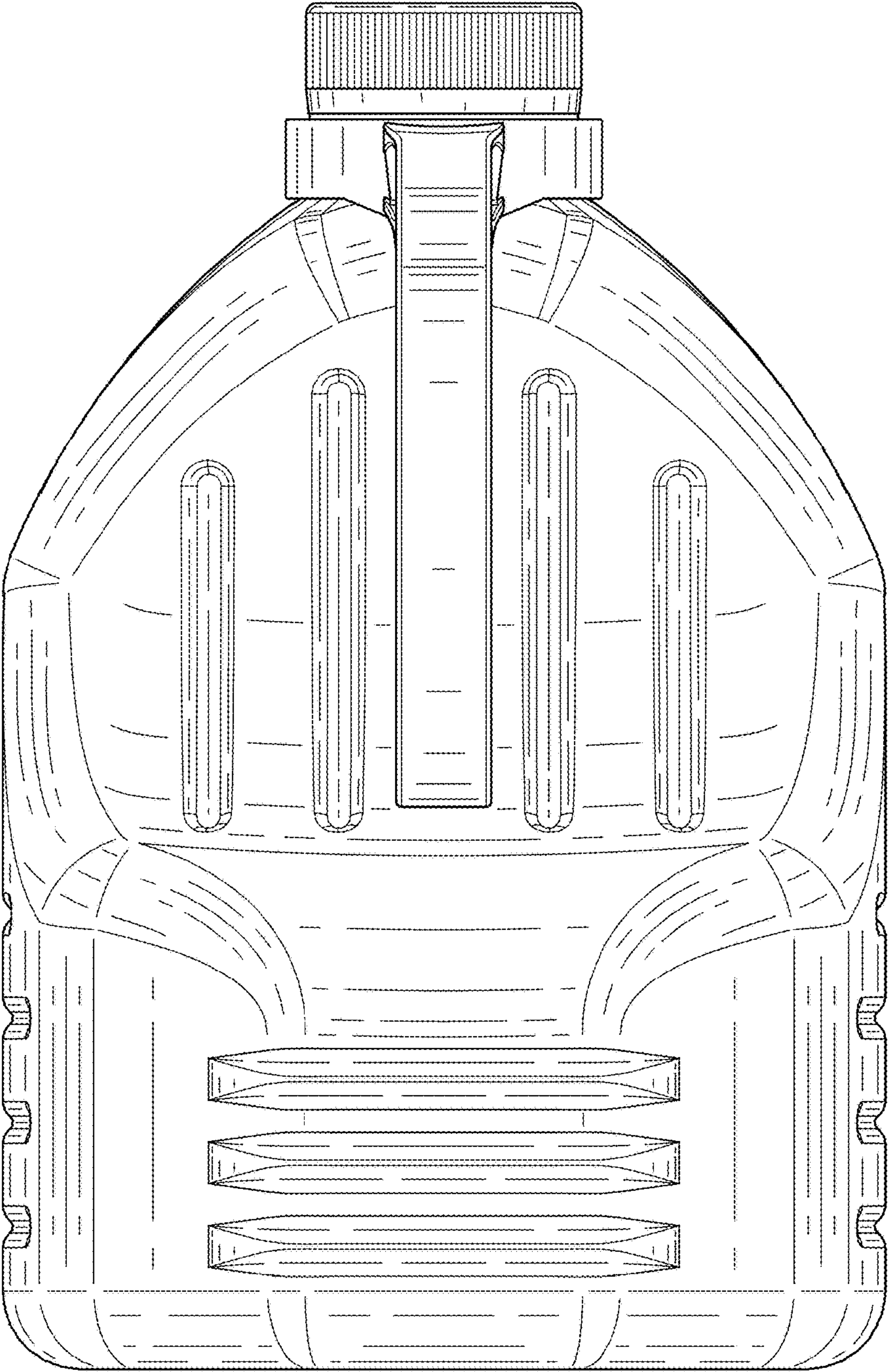

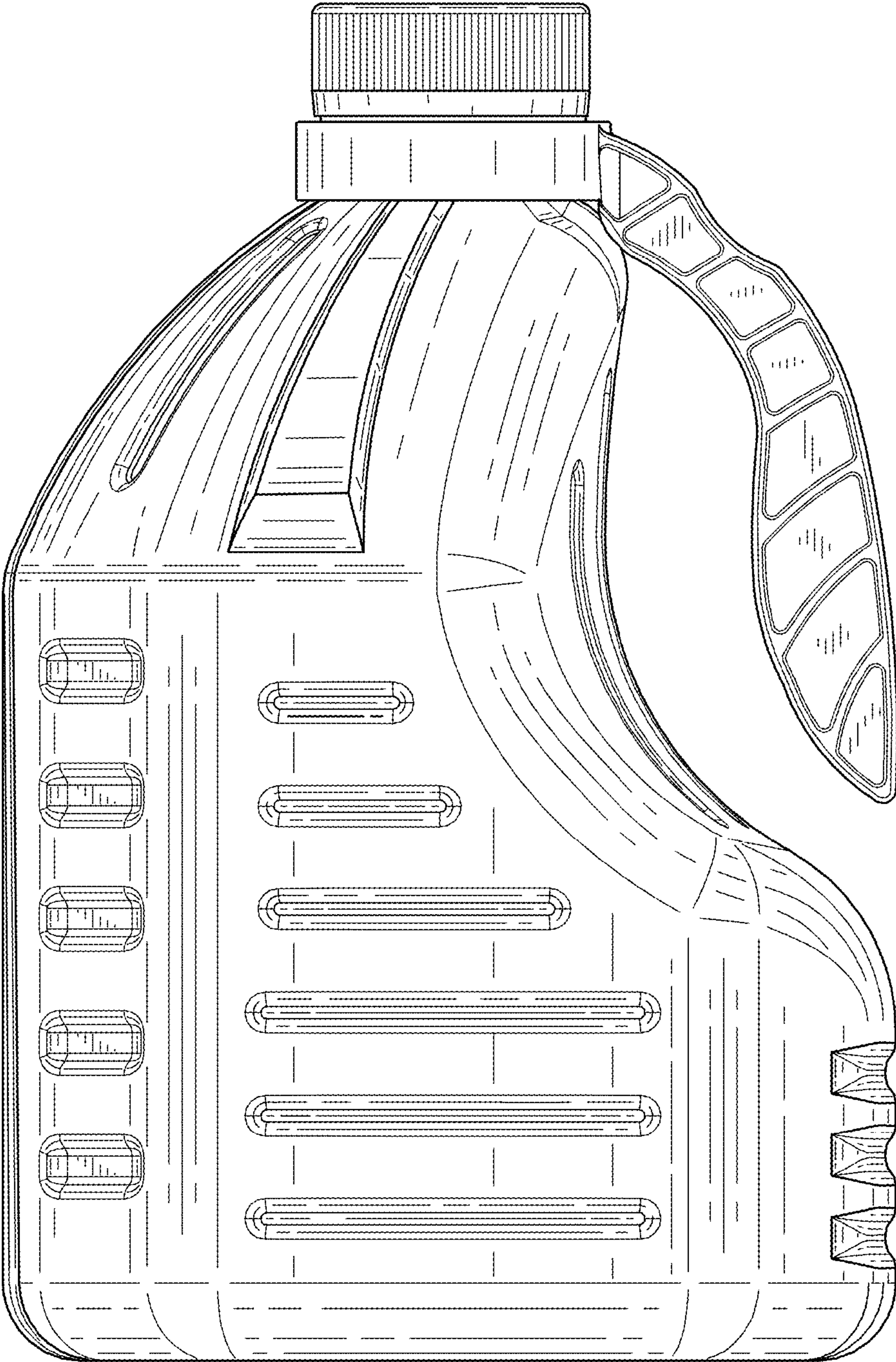

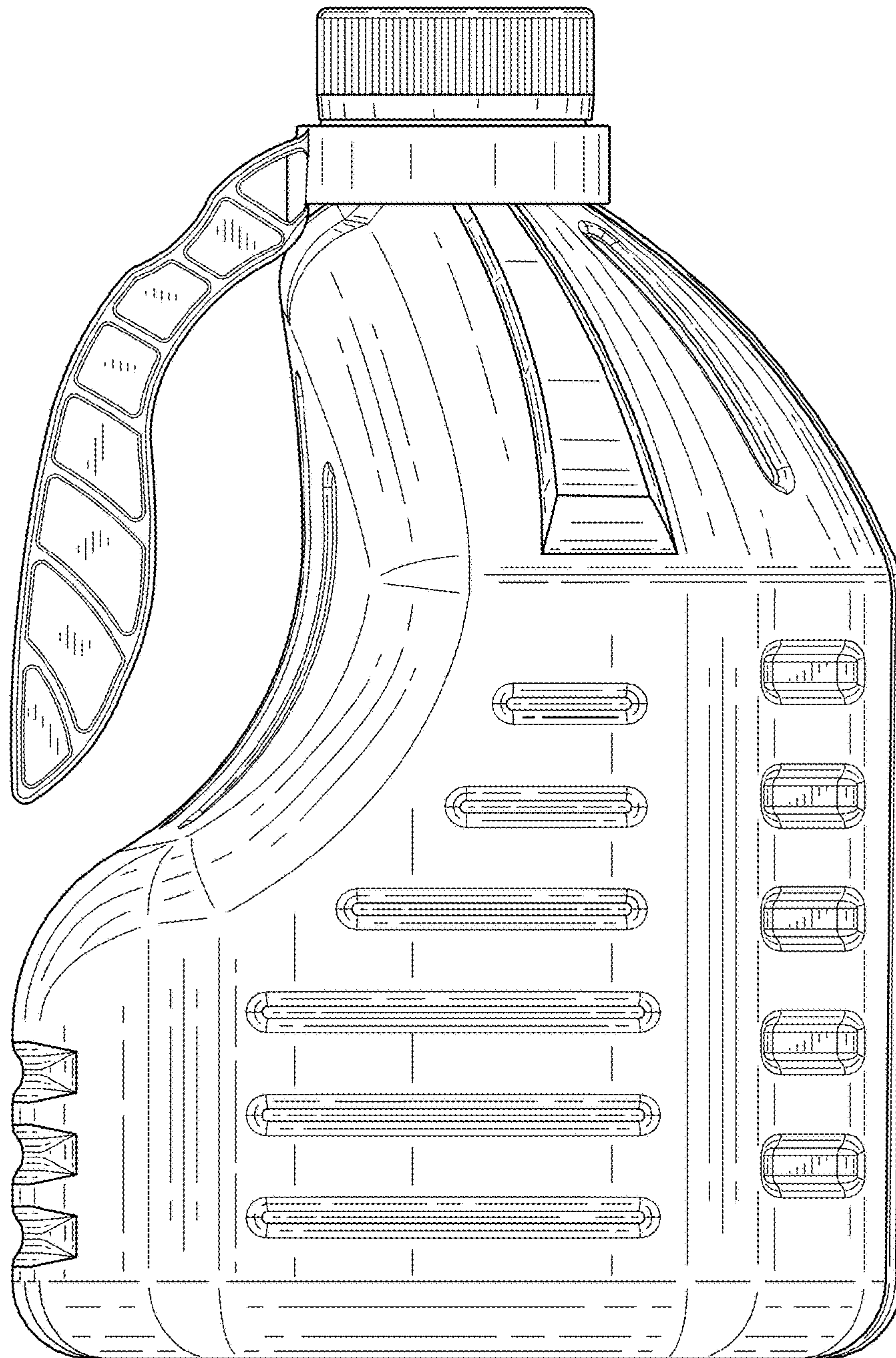

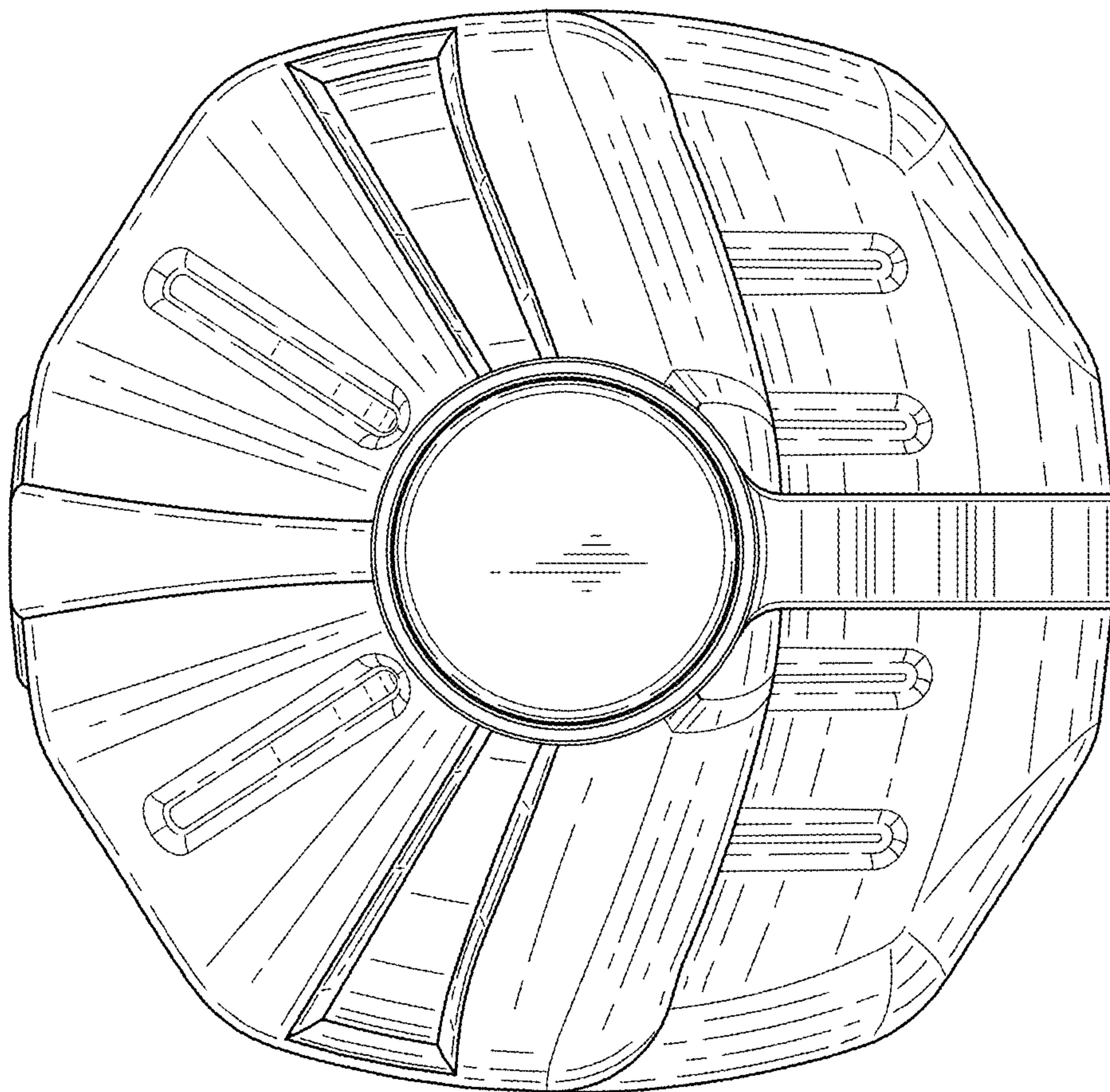
