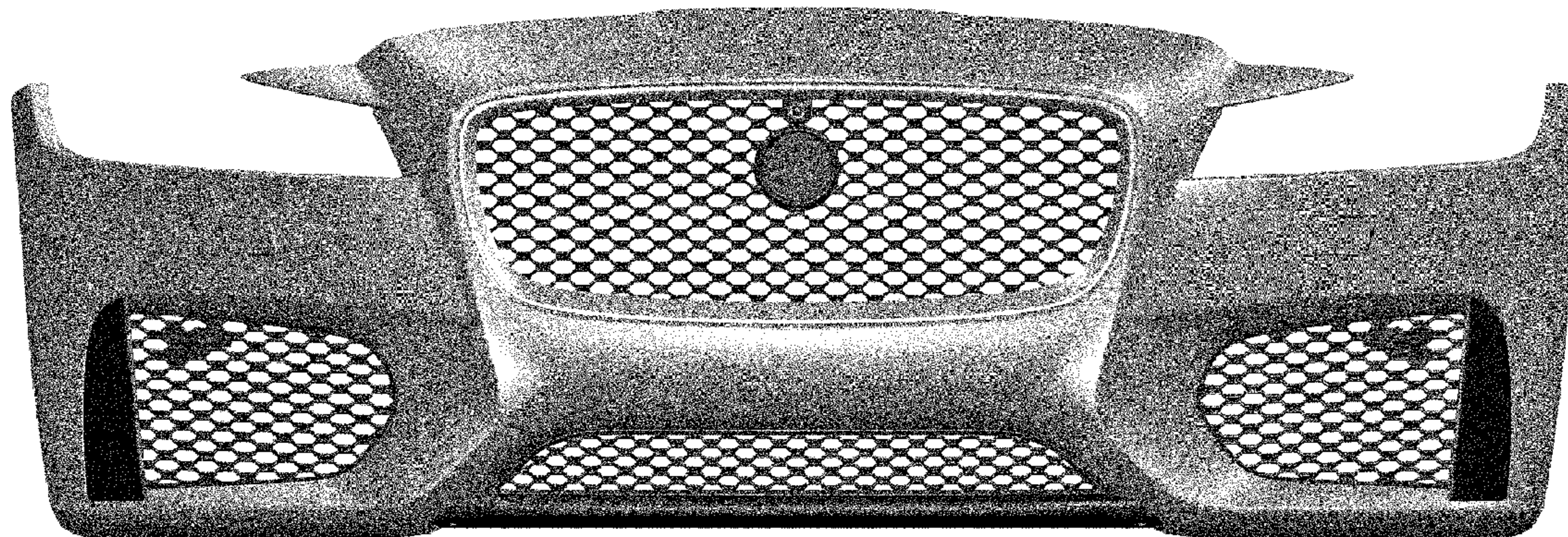
The ornamental design for a front bumper for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a left, front perspective view of a front bumper for a vehicle showing our new design;
FIG. 2 is a right, rear perspective view thereof;

FIG. 4 is a rear view thereof;

FIG. 6 is a right side view thereof;

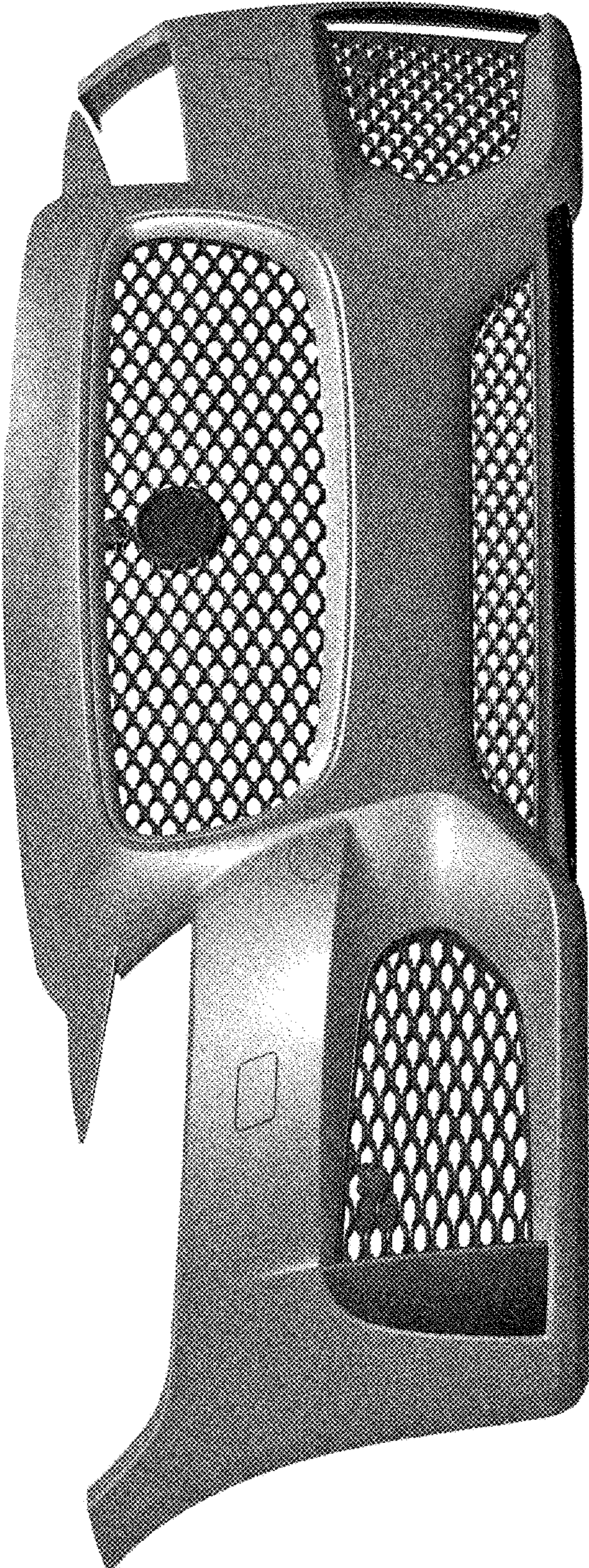

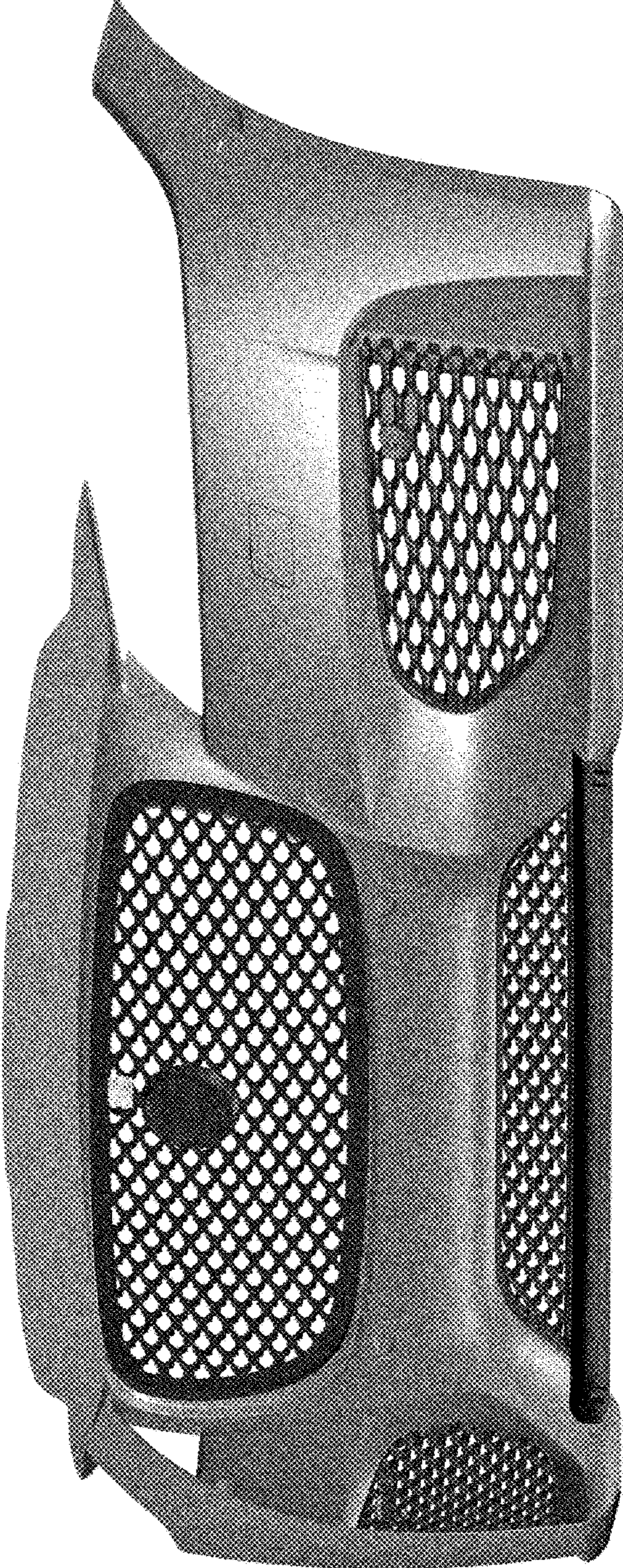

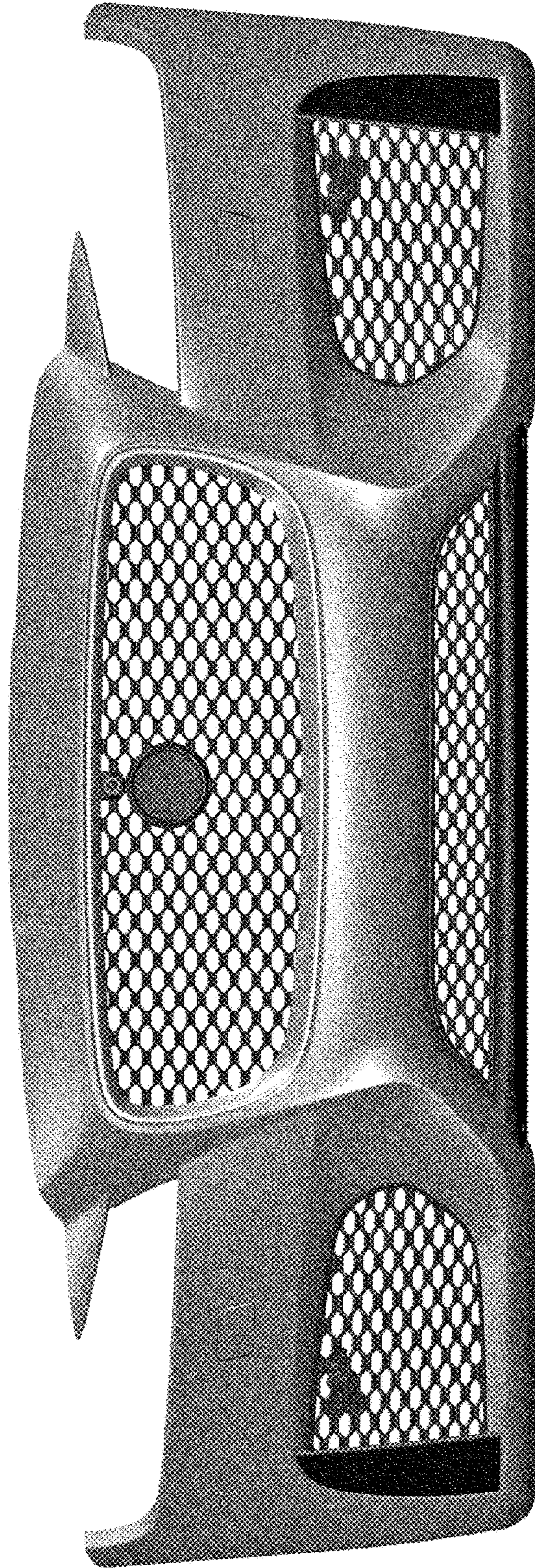

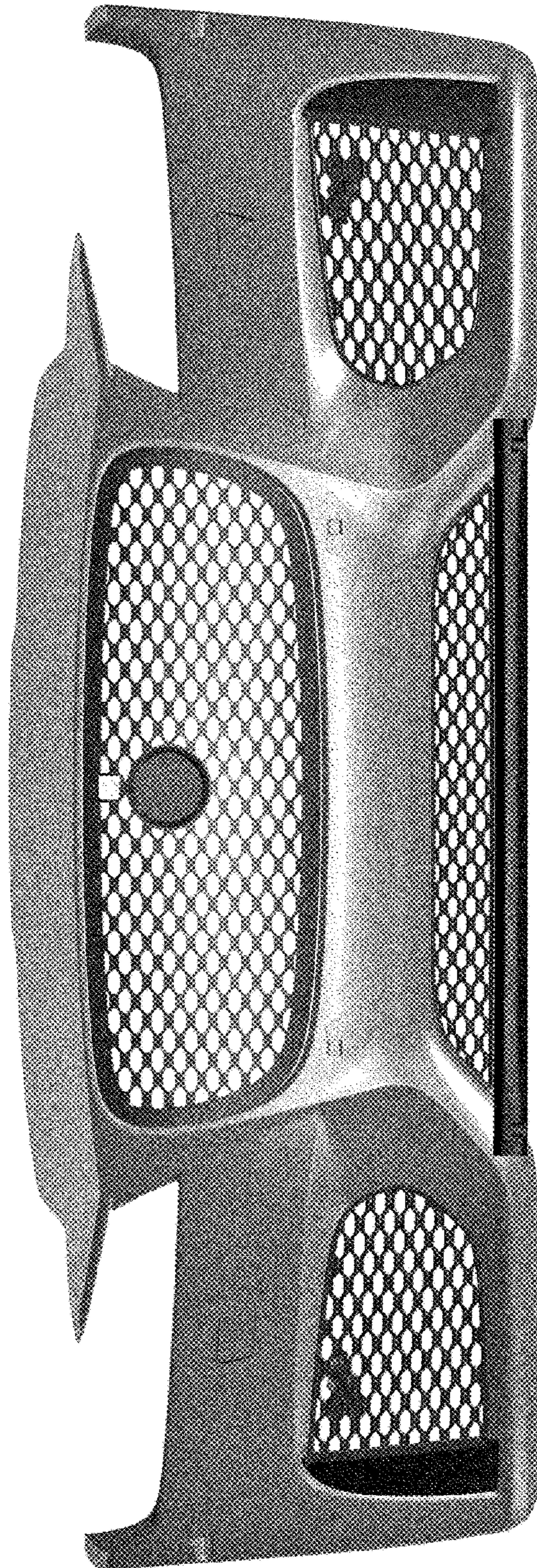

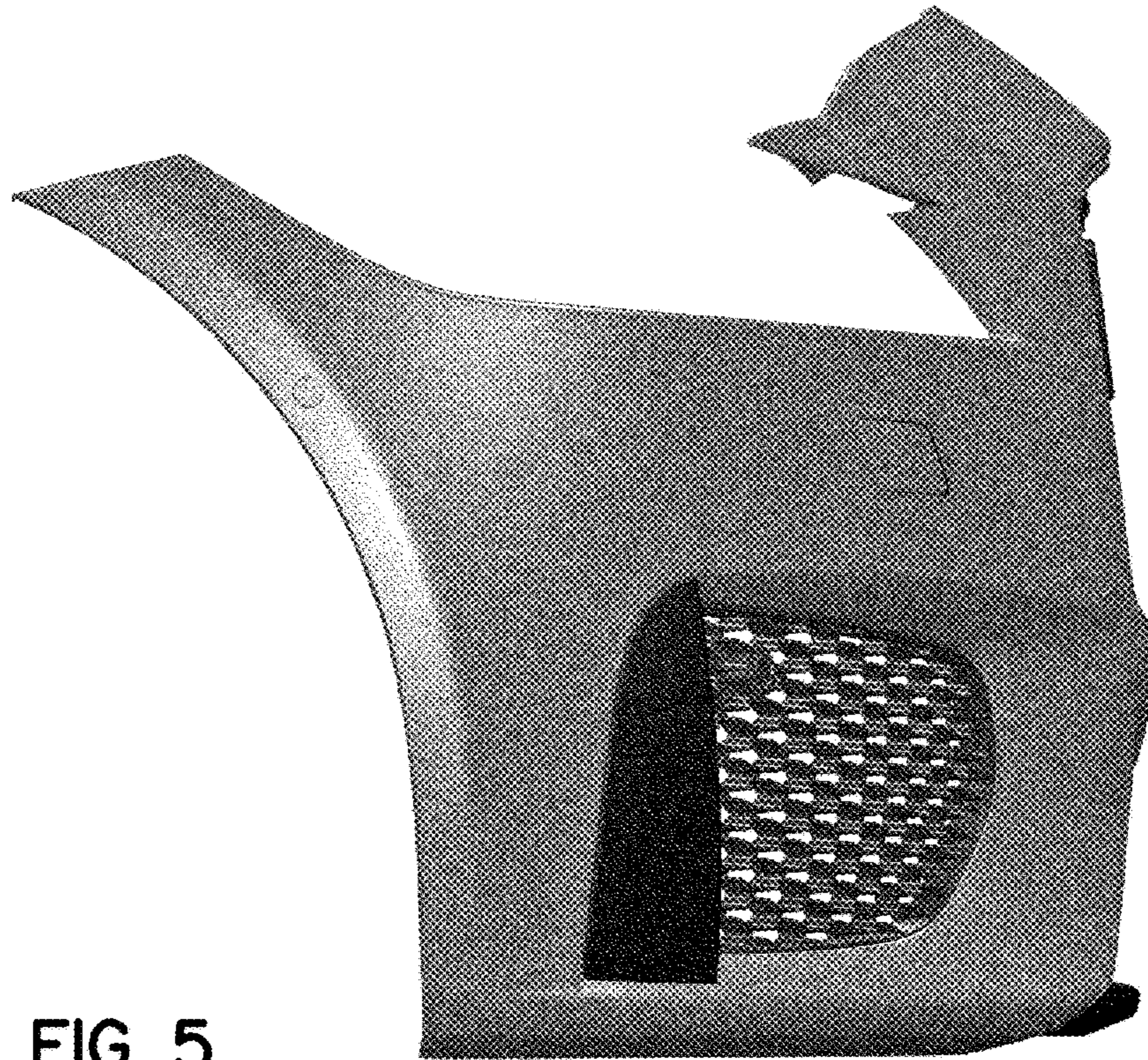

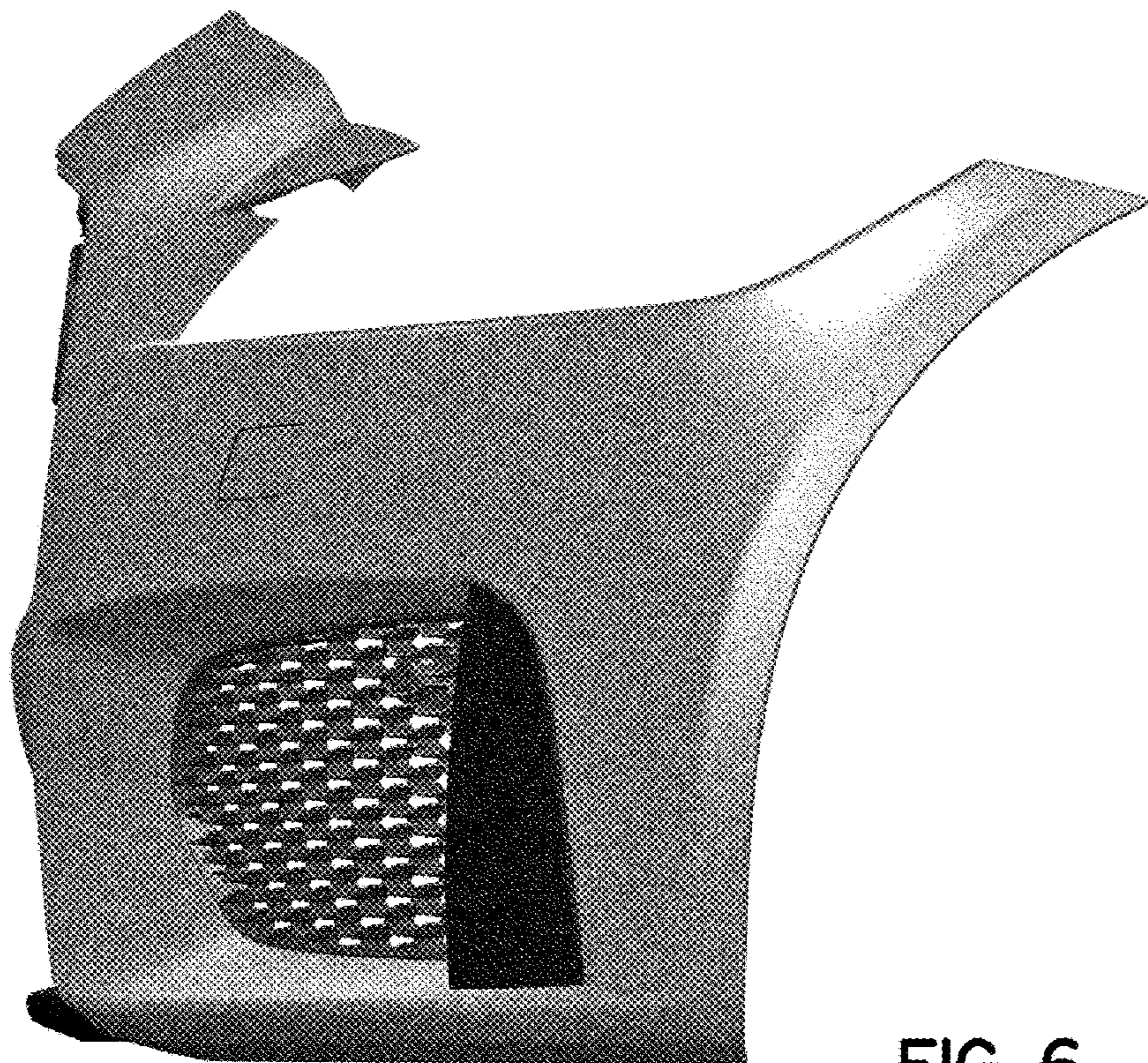

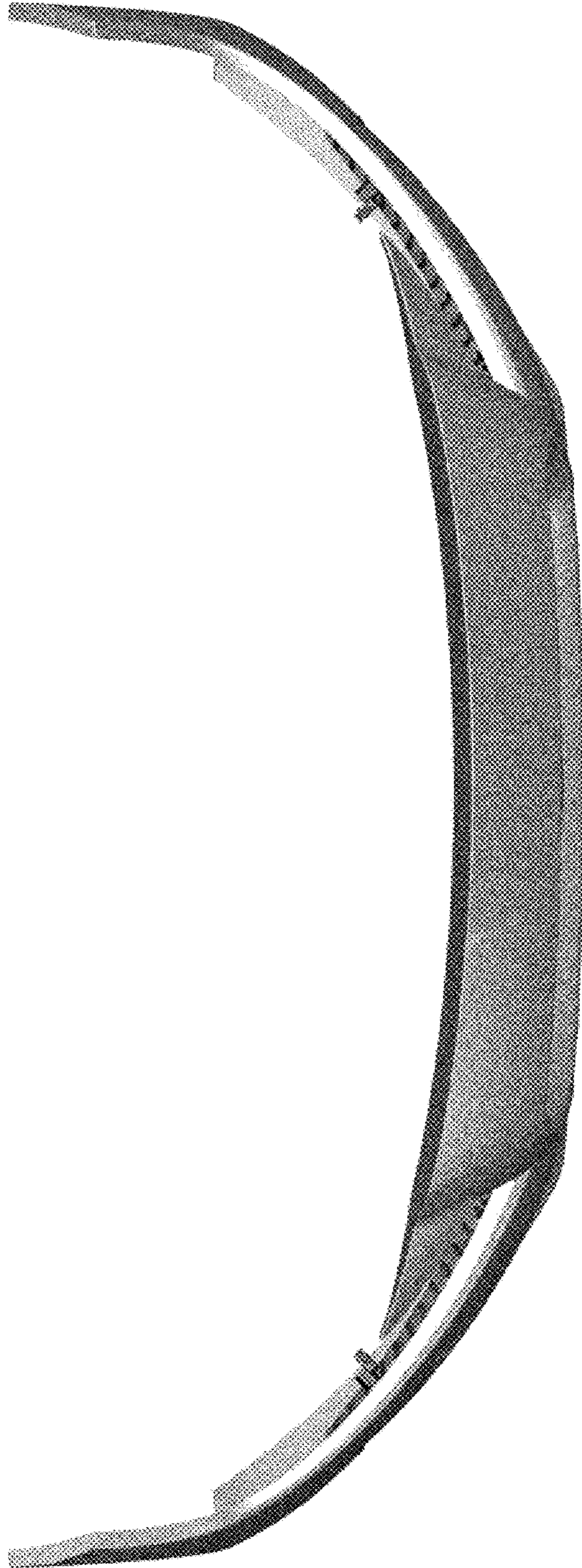

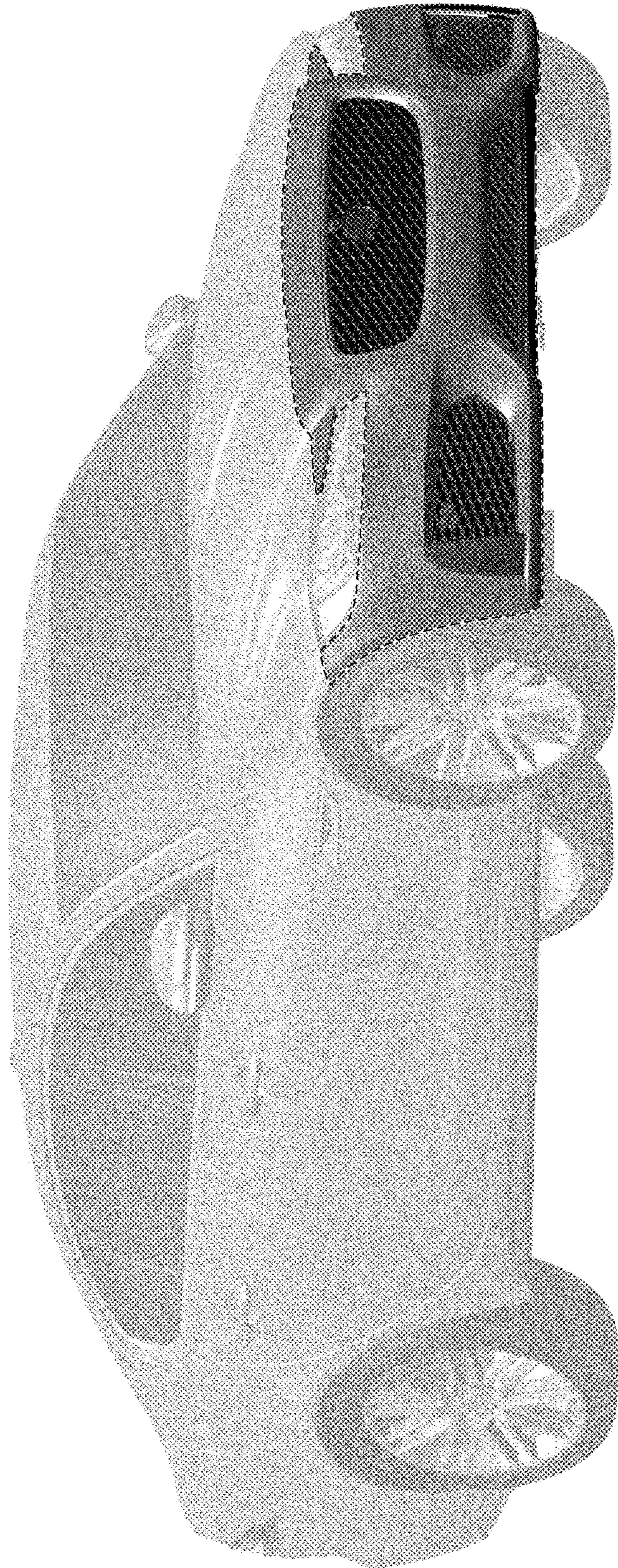
