The ornamental design for spoke segment of a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spoke segment of a vehicle wheel according to my new design;
 FIG. 2 is an elevational view thereof;
 FIG. 3 is a perspective view of a second embodiment of a spoke segment of a vehicle wheel according to my new design;
 FIG. 4 is an elevational view of the second embodiment;
 FIG. 5 is a perspective view of a third embodiment of a spoke segment of a vehicle wheel according to my new design;
 FIG. 6 is an elevational view of the third embodiment;
 FIG. 7 is a perspective view of a fourth embodiment of a spoke segment of a vehicle wheel according to my new invention; and,
 FIG. 8 is an elevational view of the fourth embodiment.

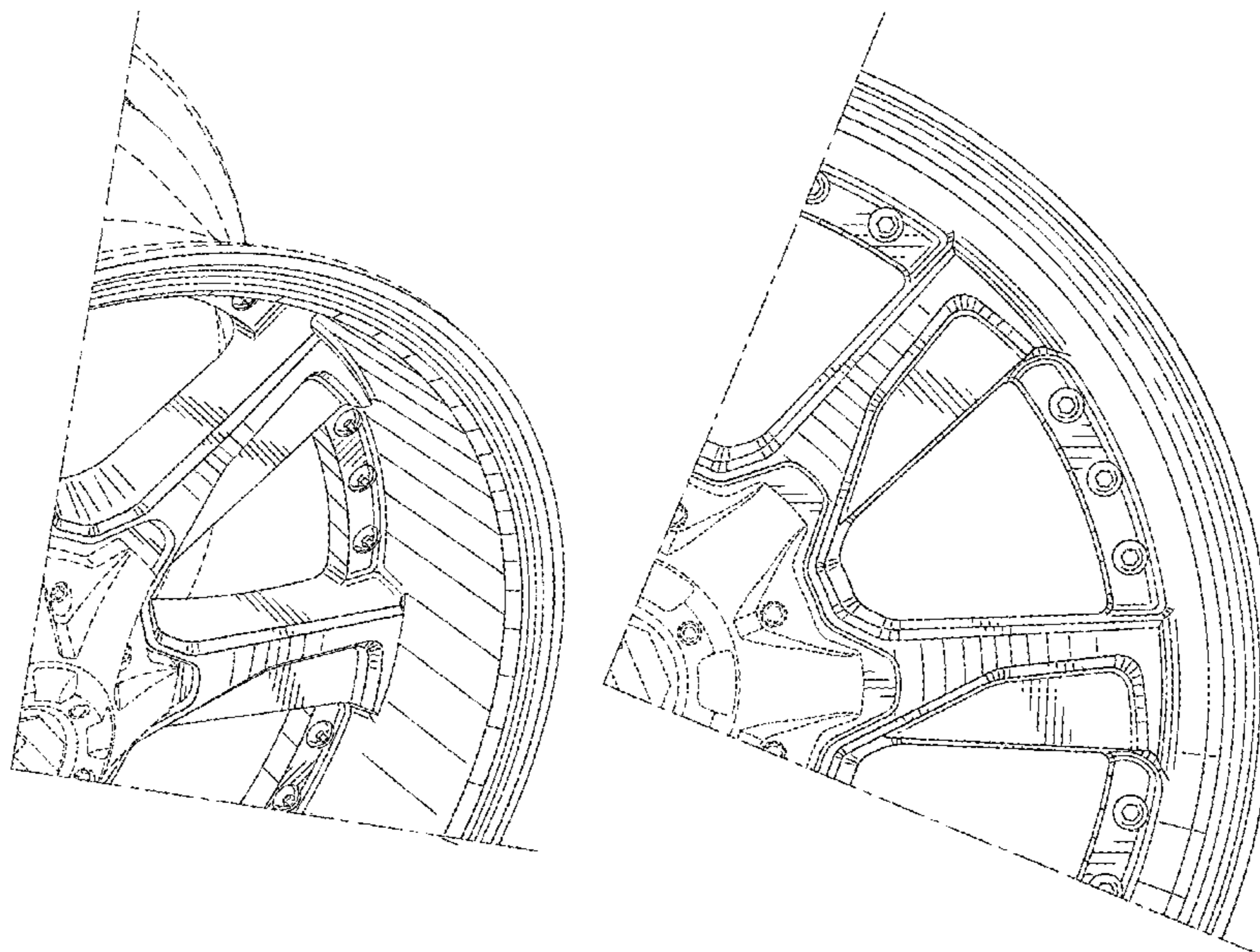

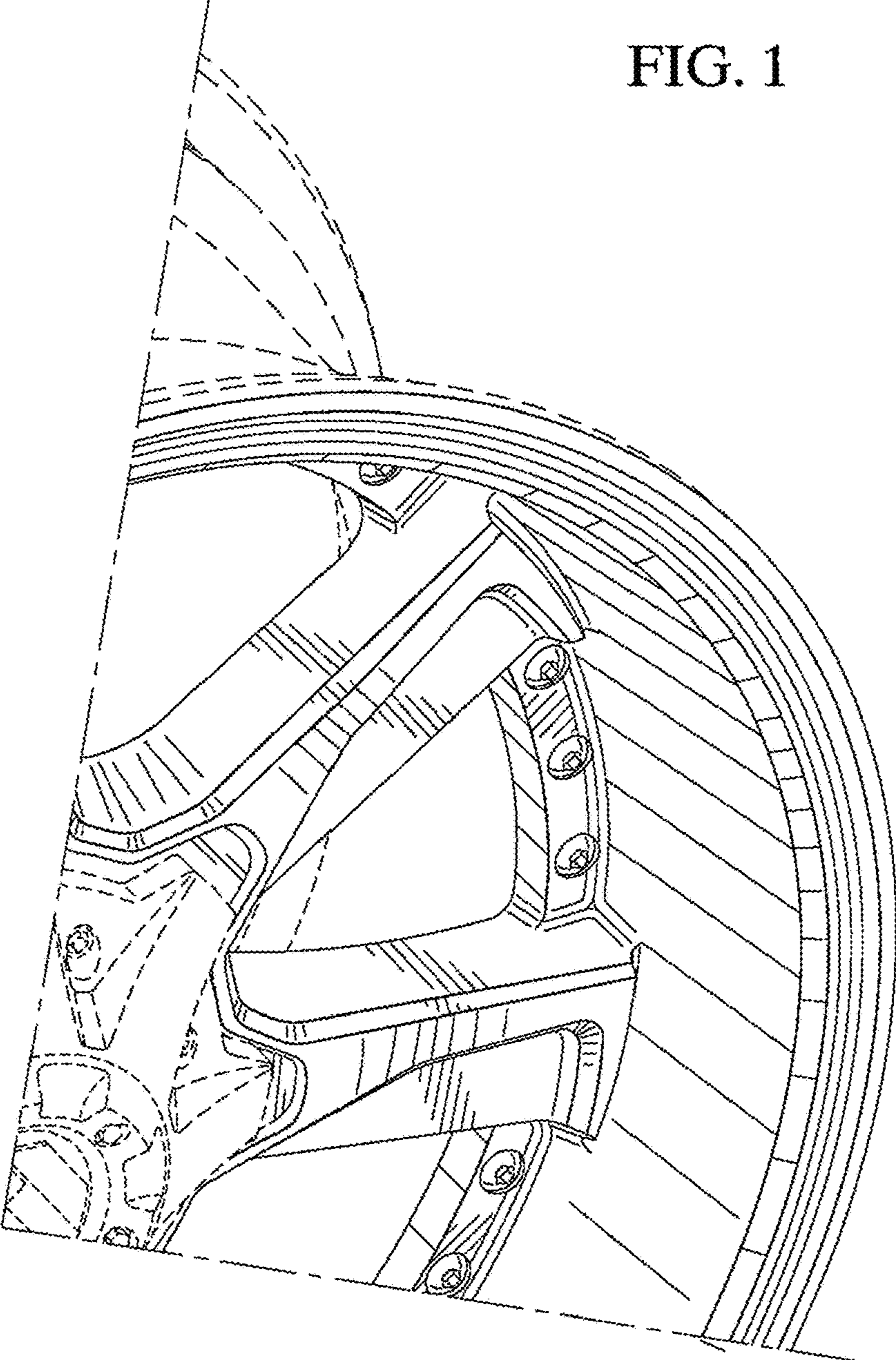

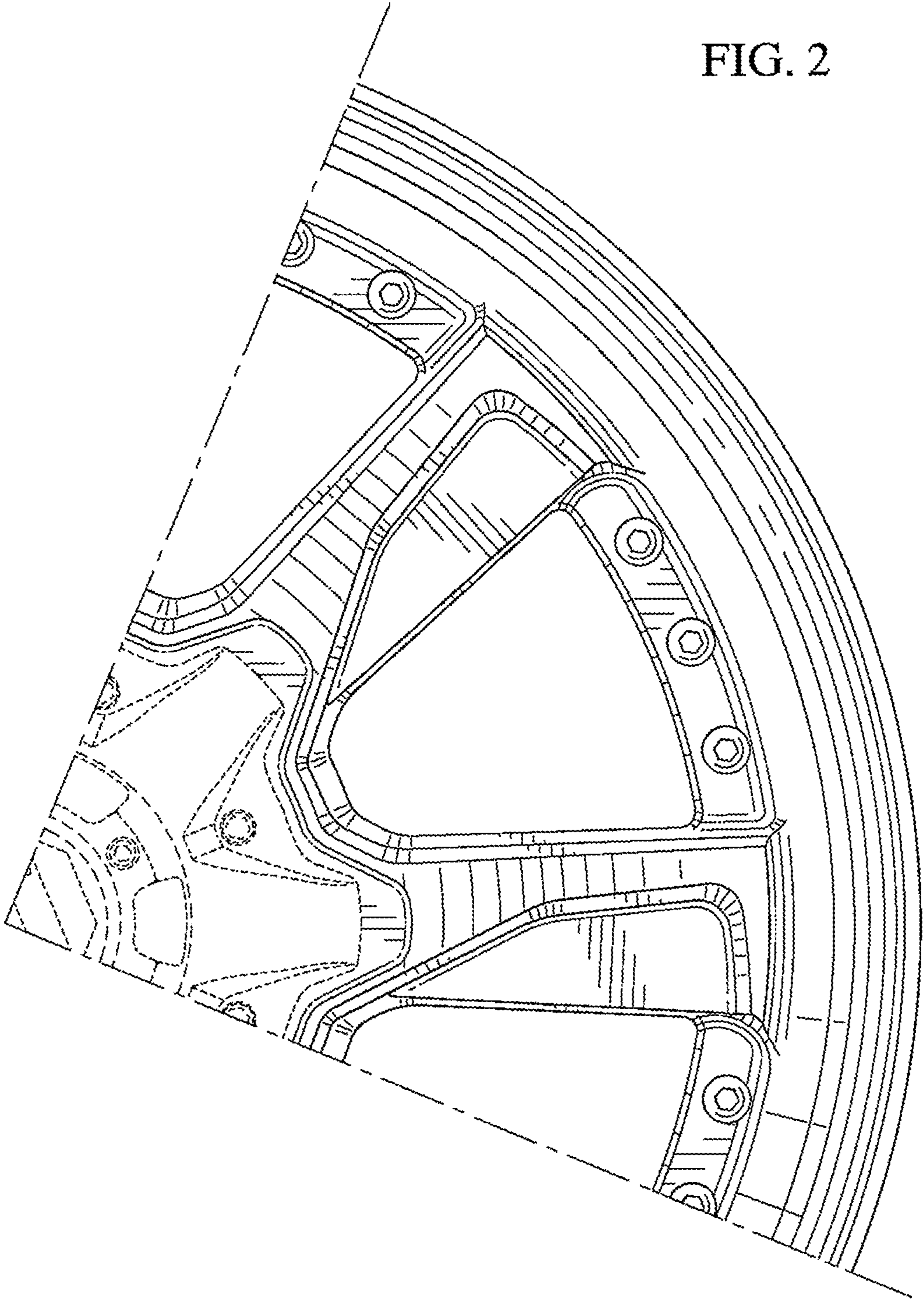

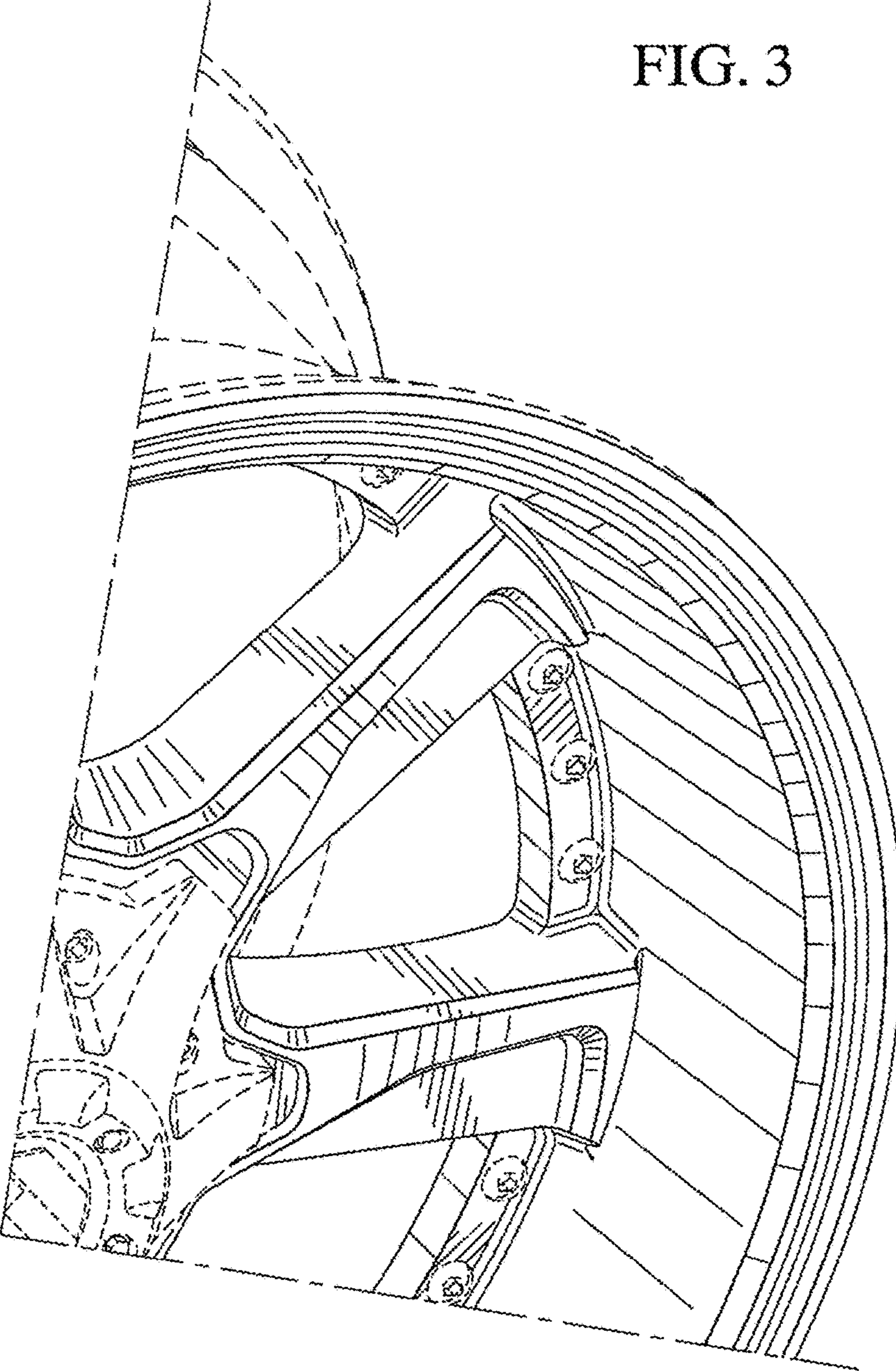

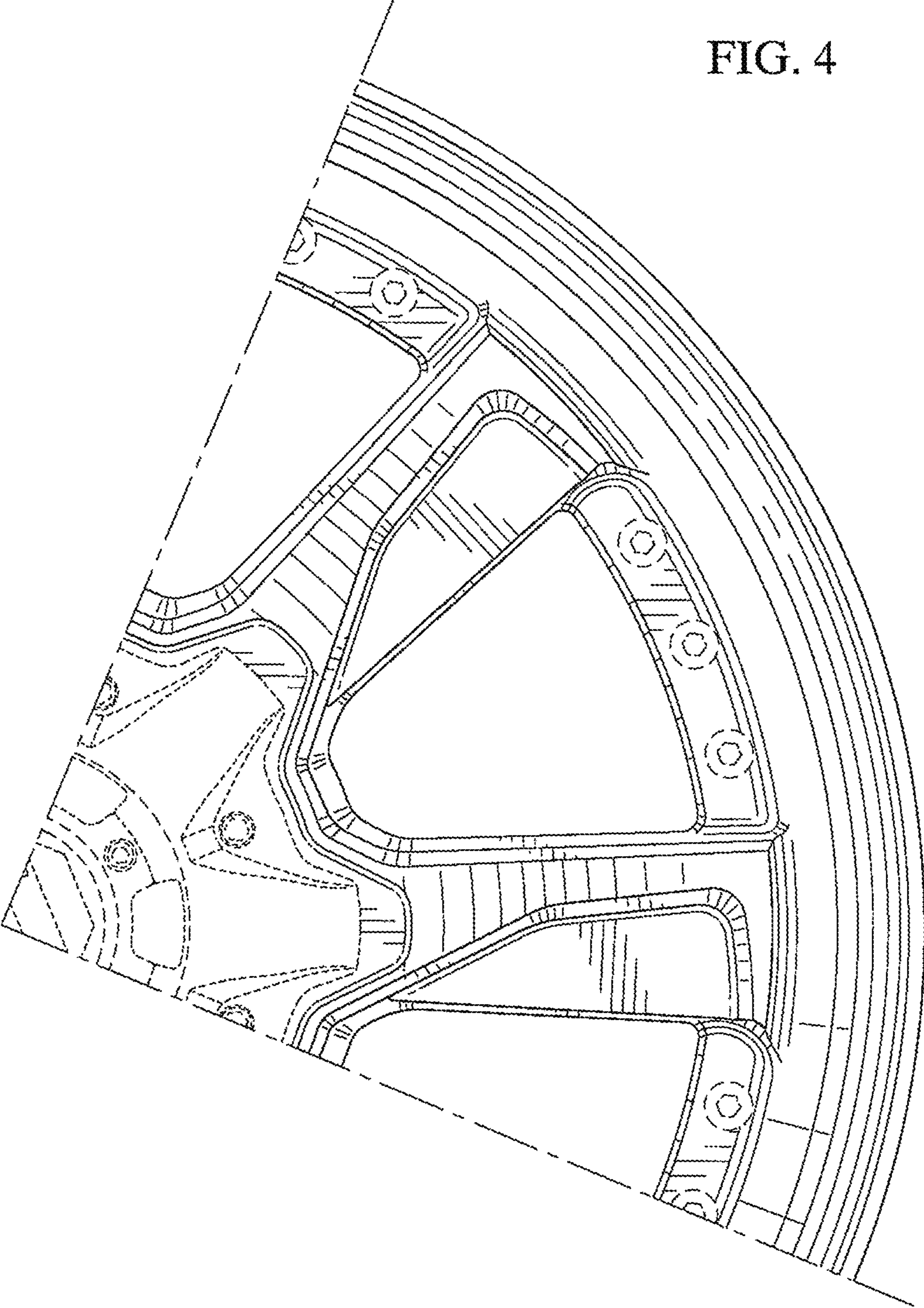

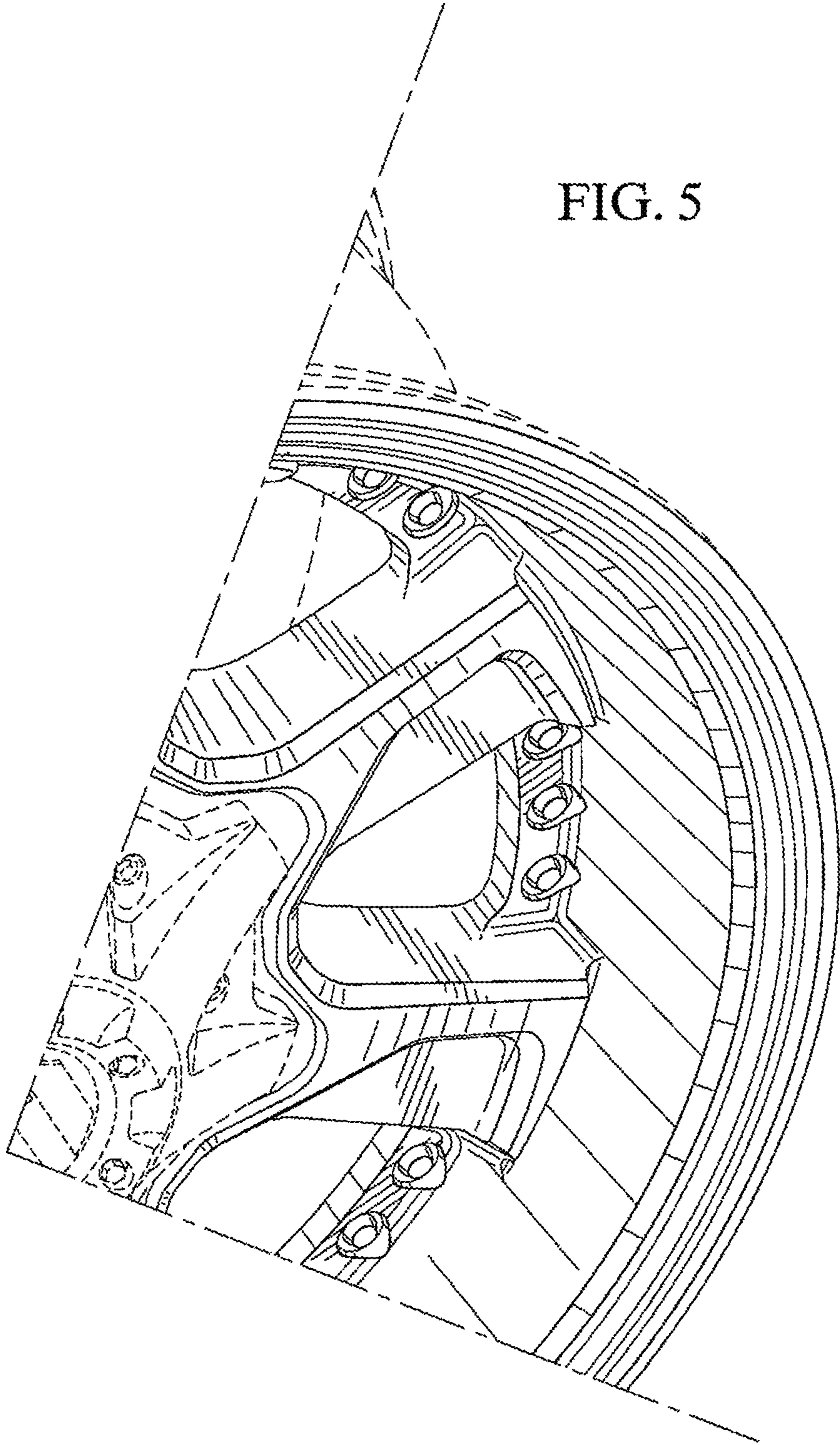

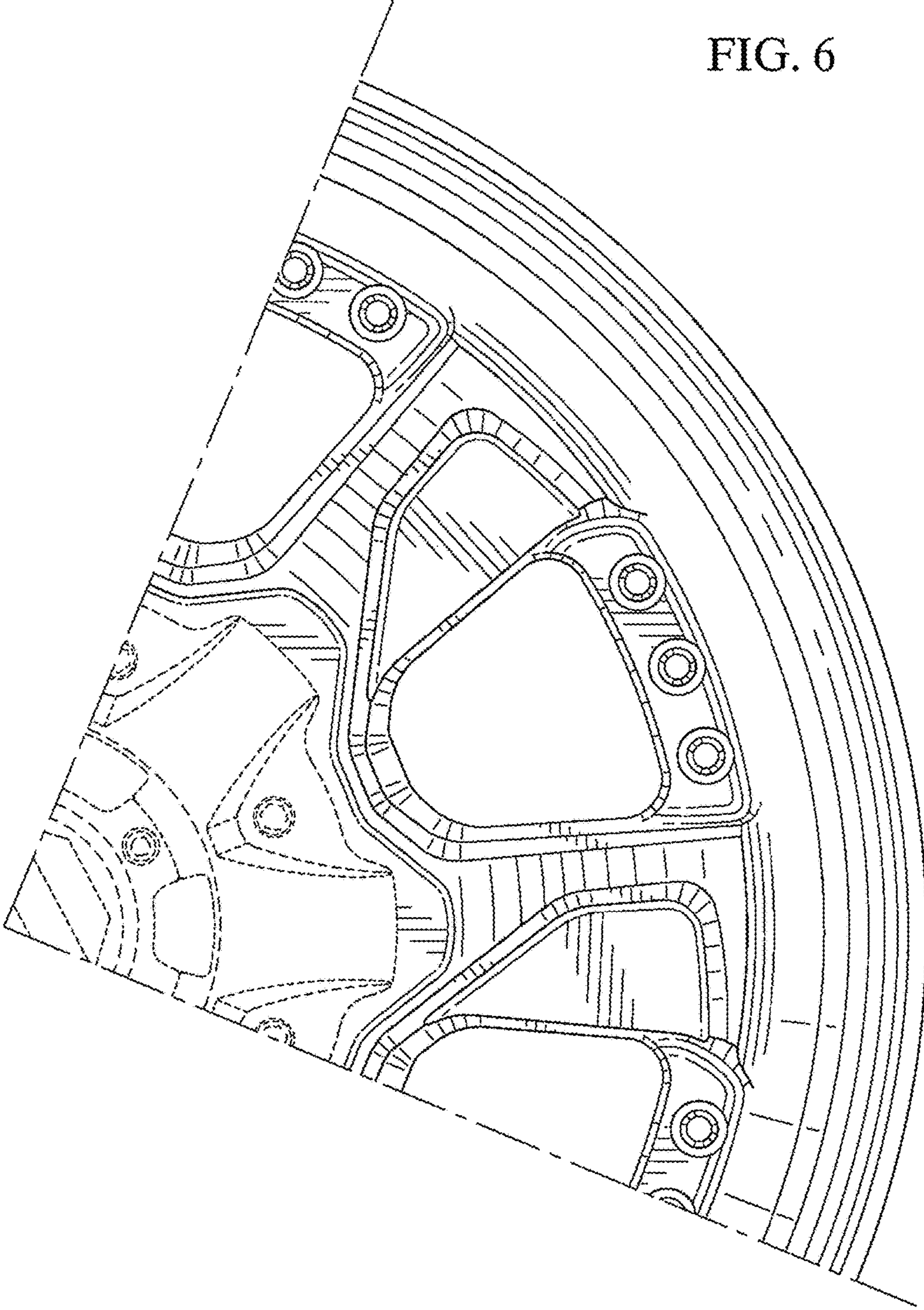

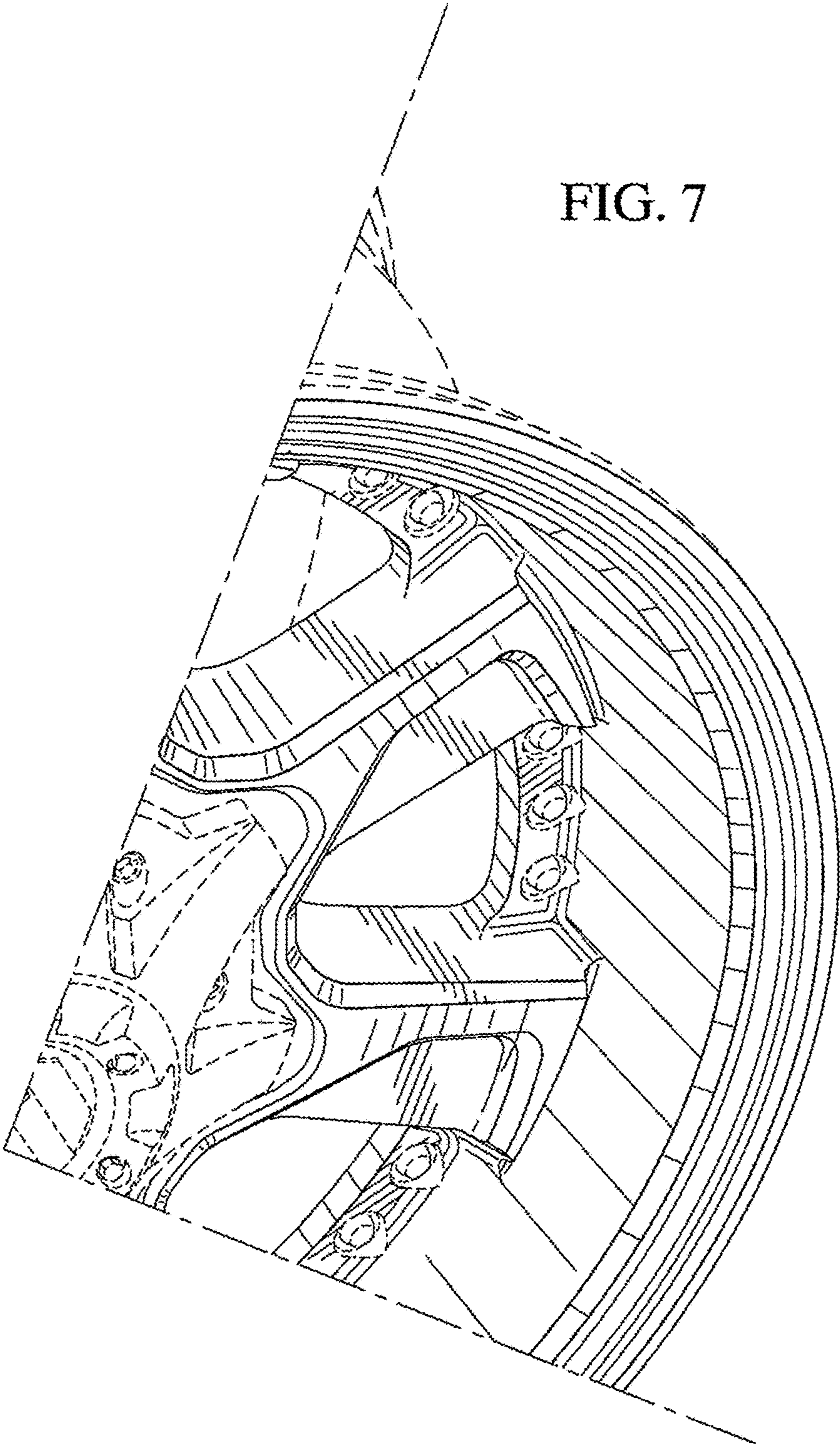
