The ornamental design for spoke segment of a vehicle
wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a spoke segment of a vehicle
wheel according to my new design;

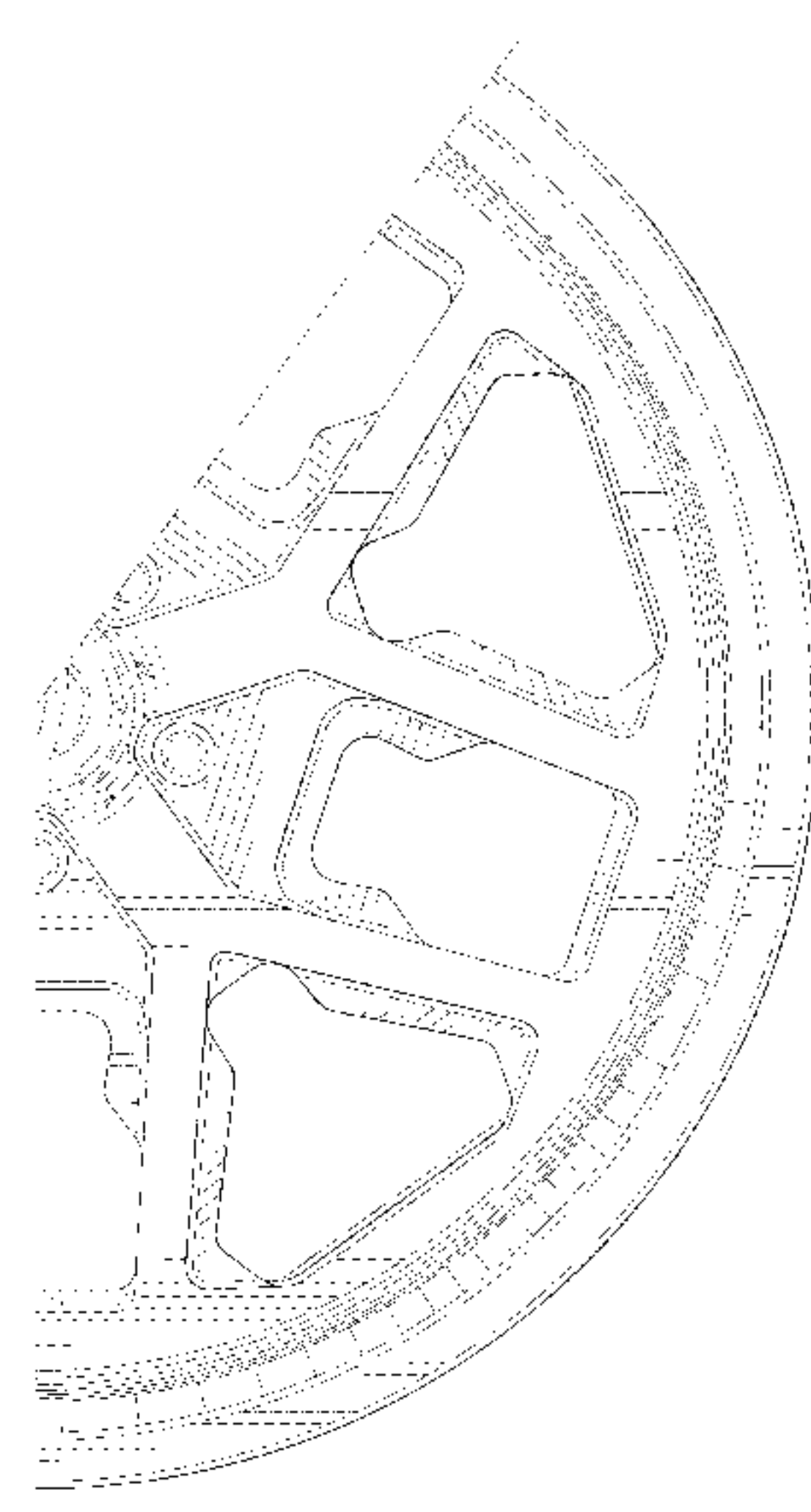
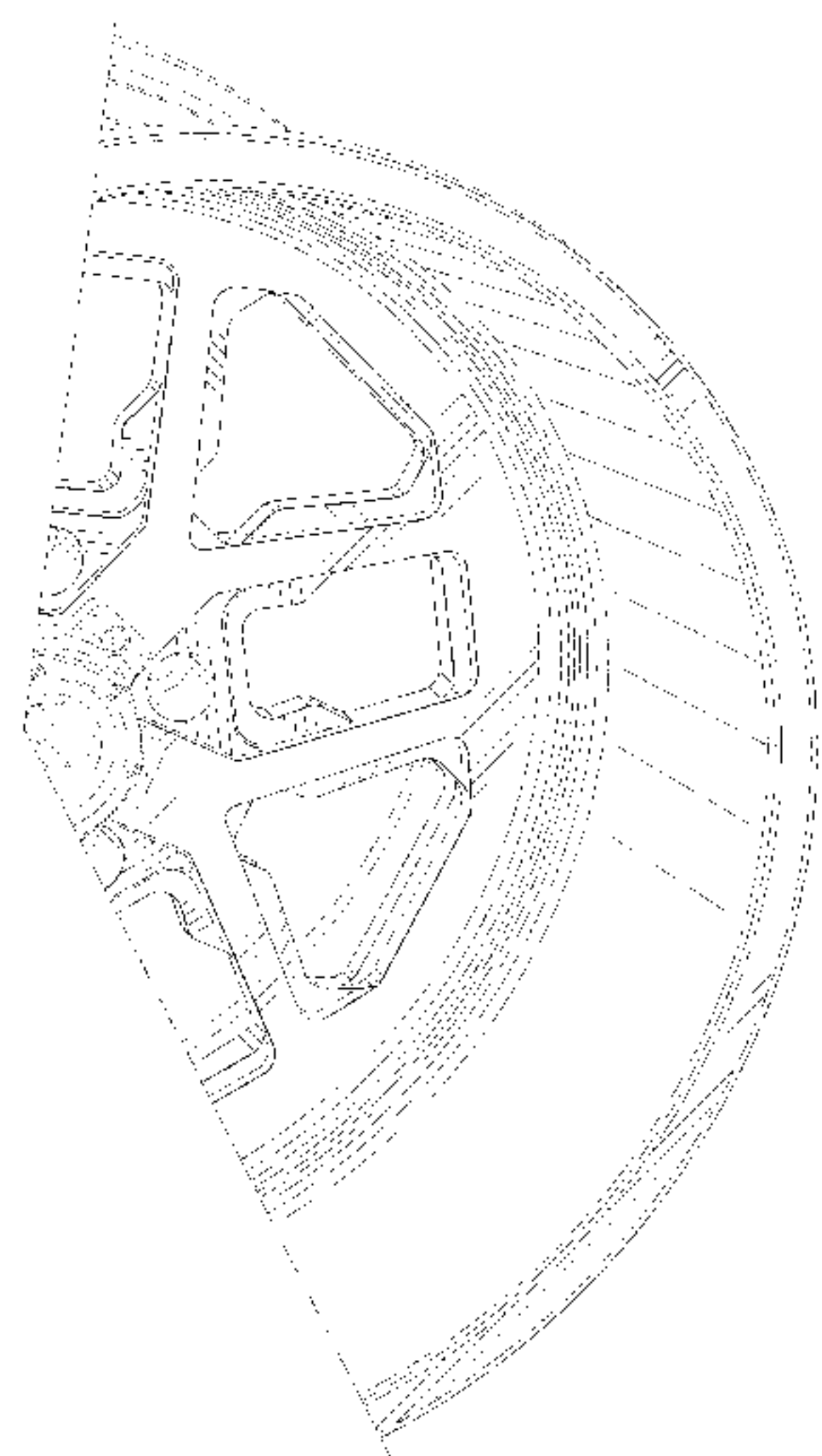

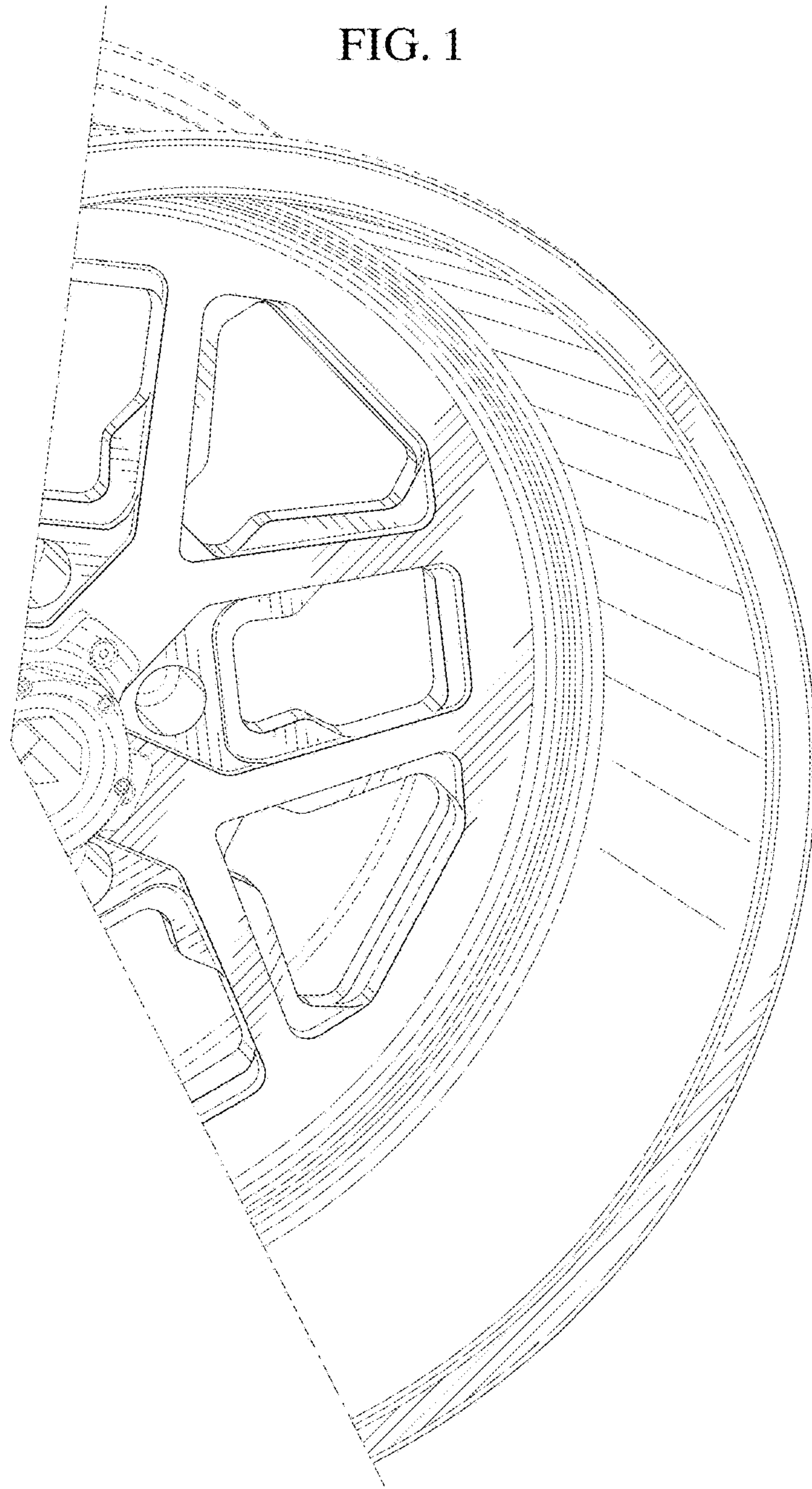

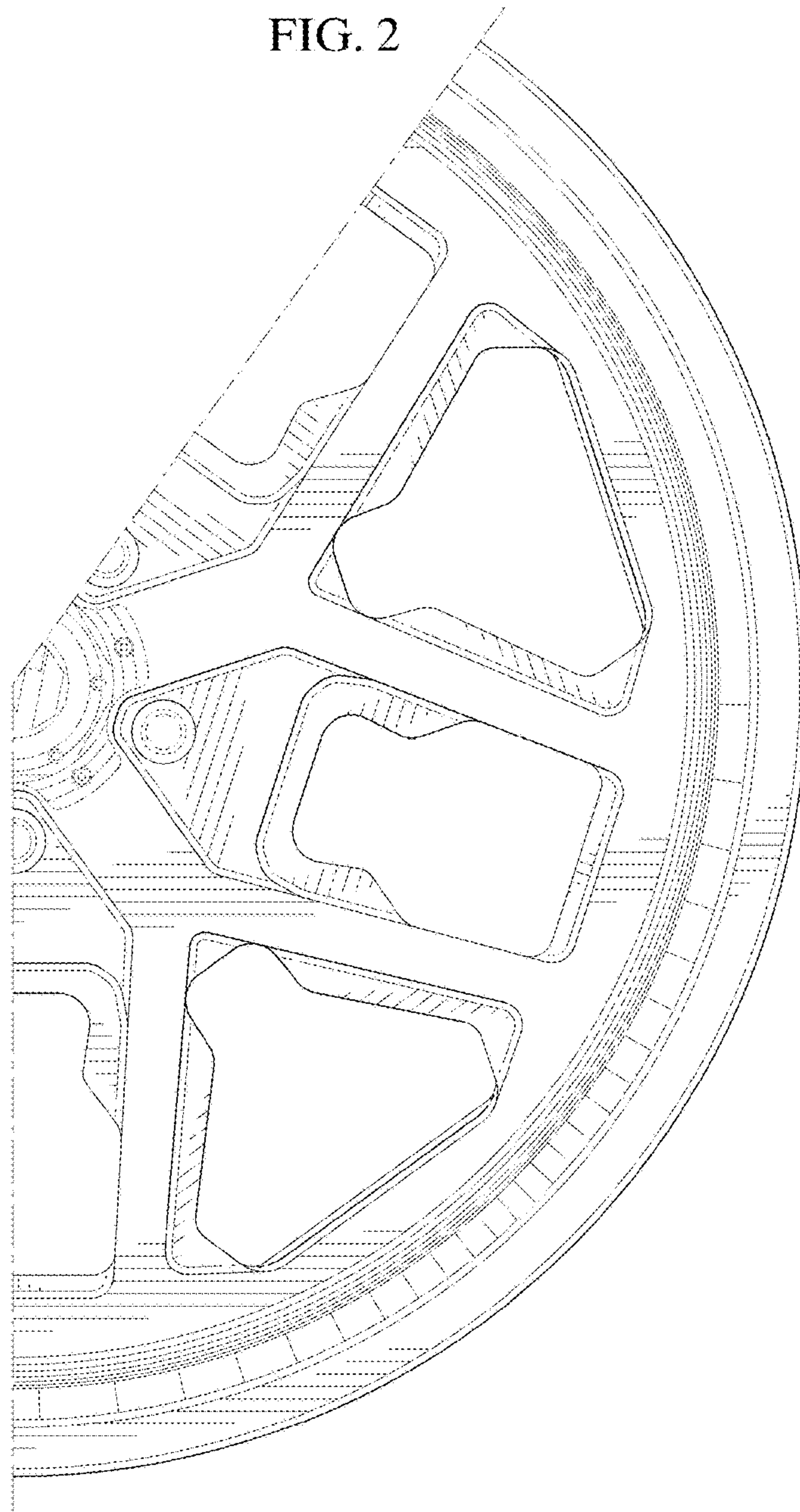

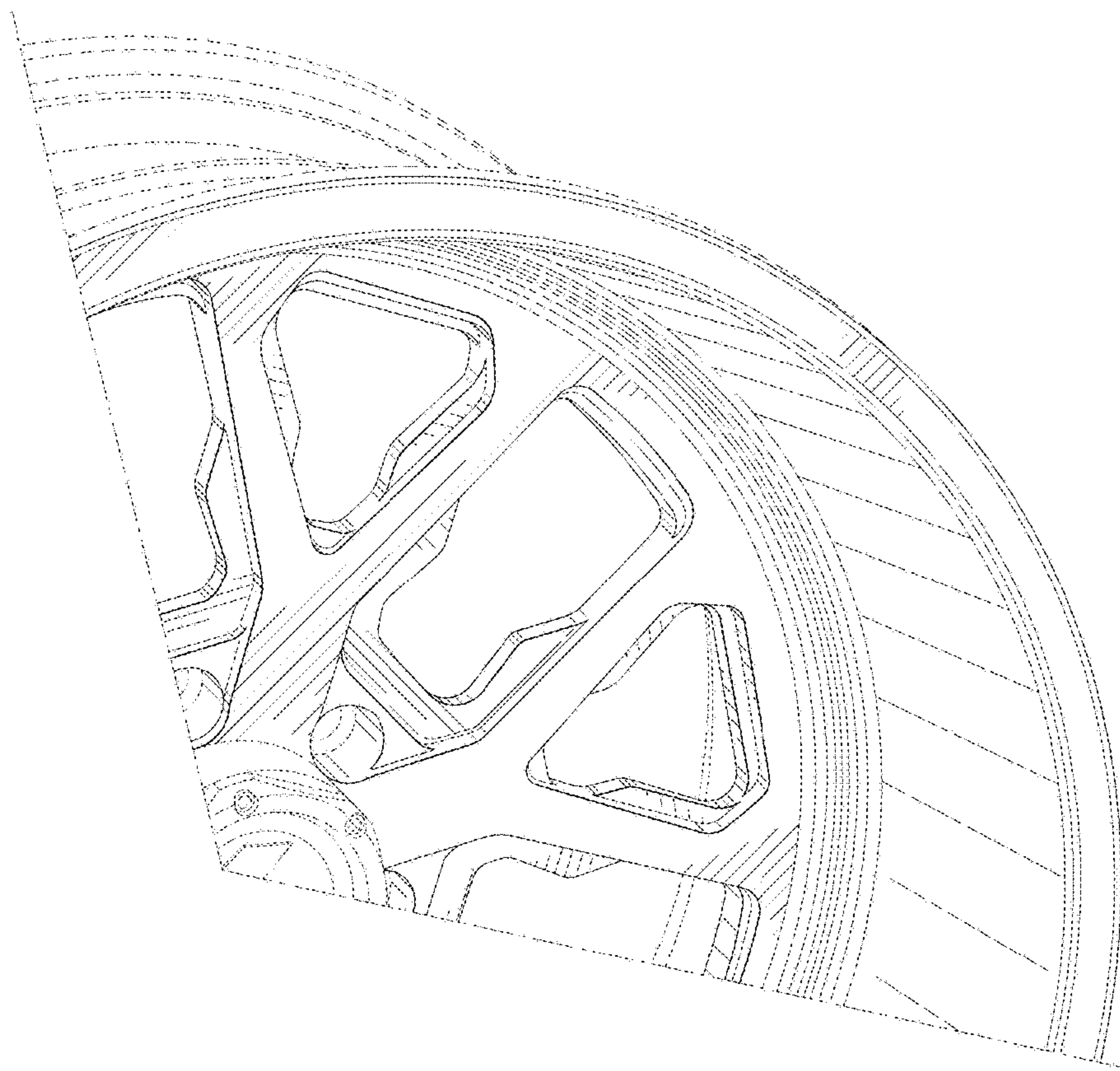

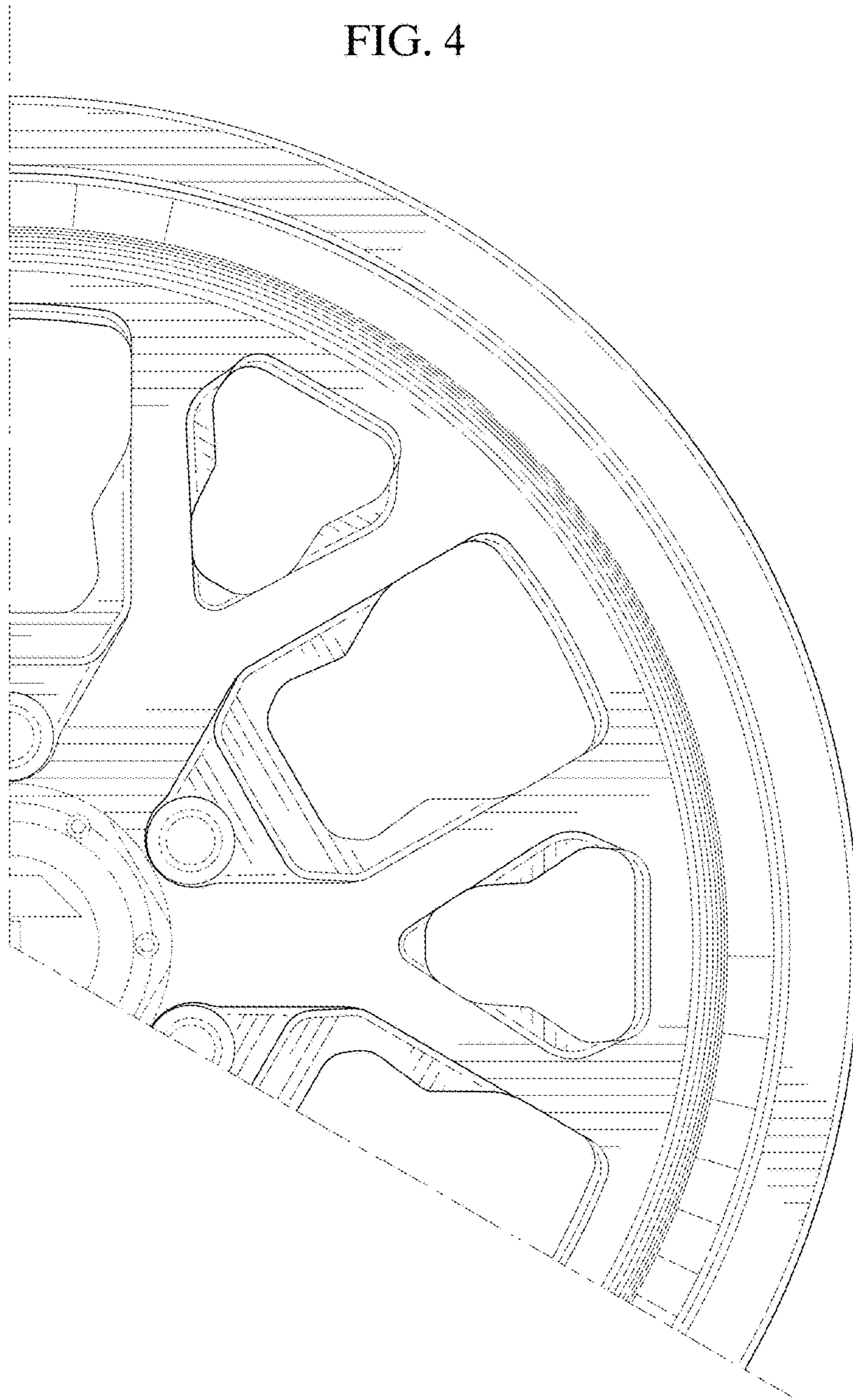

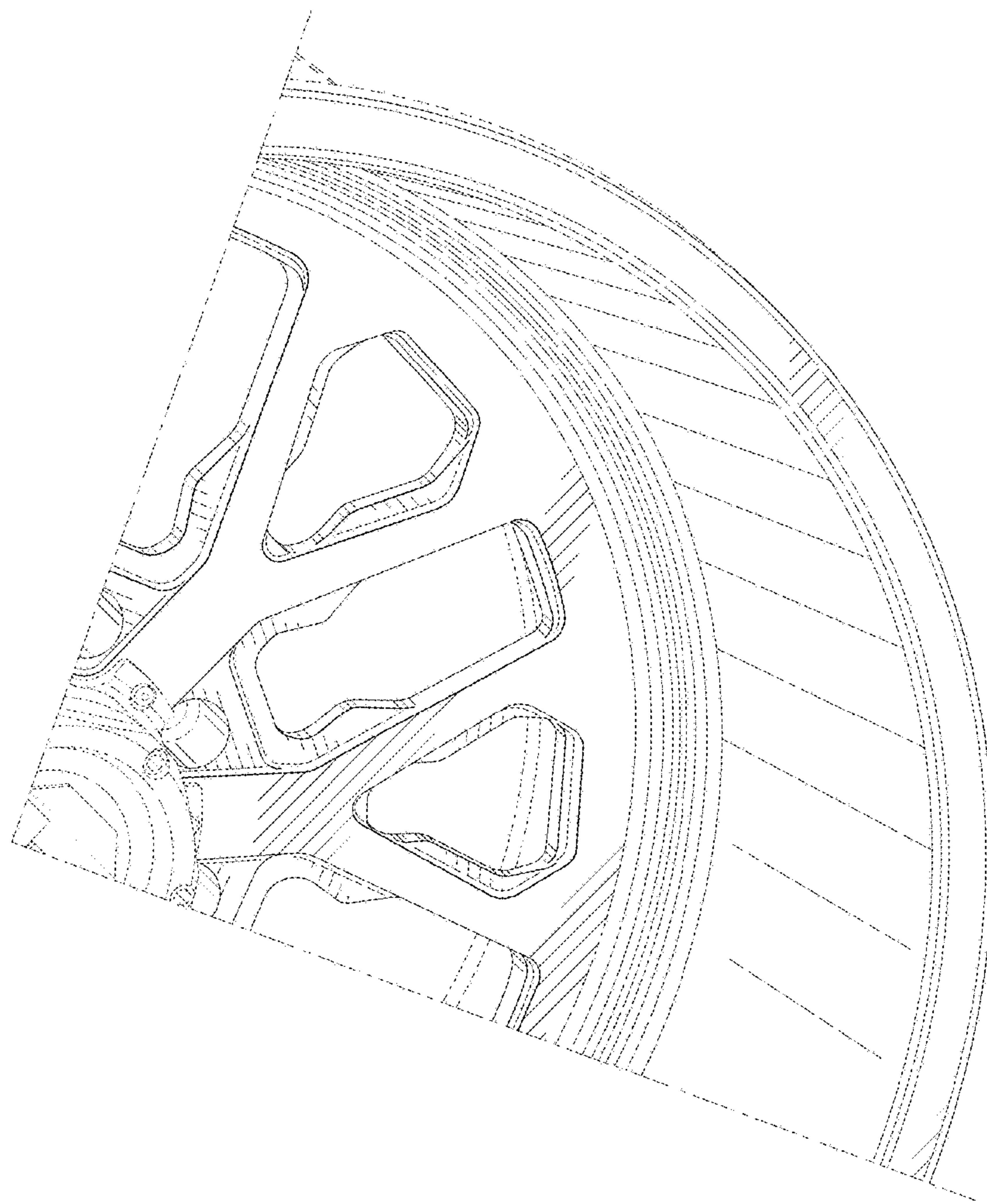

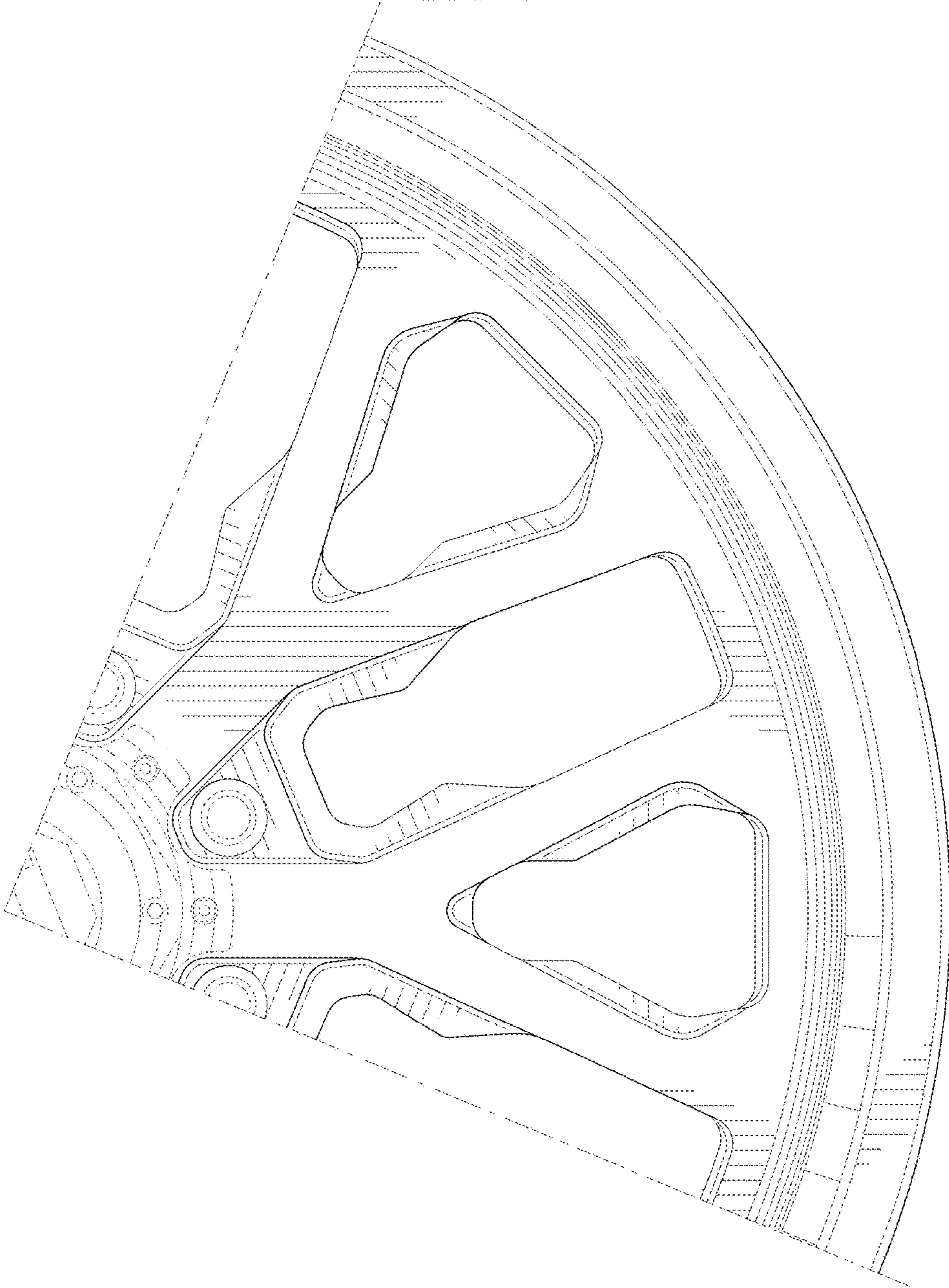

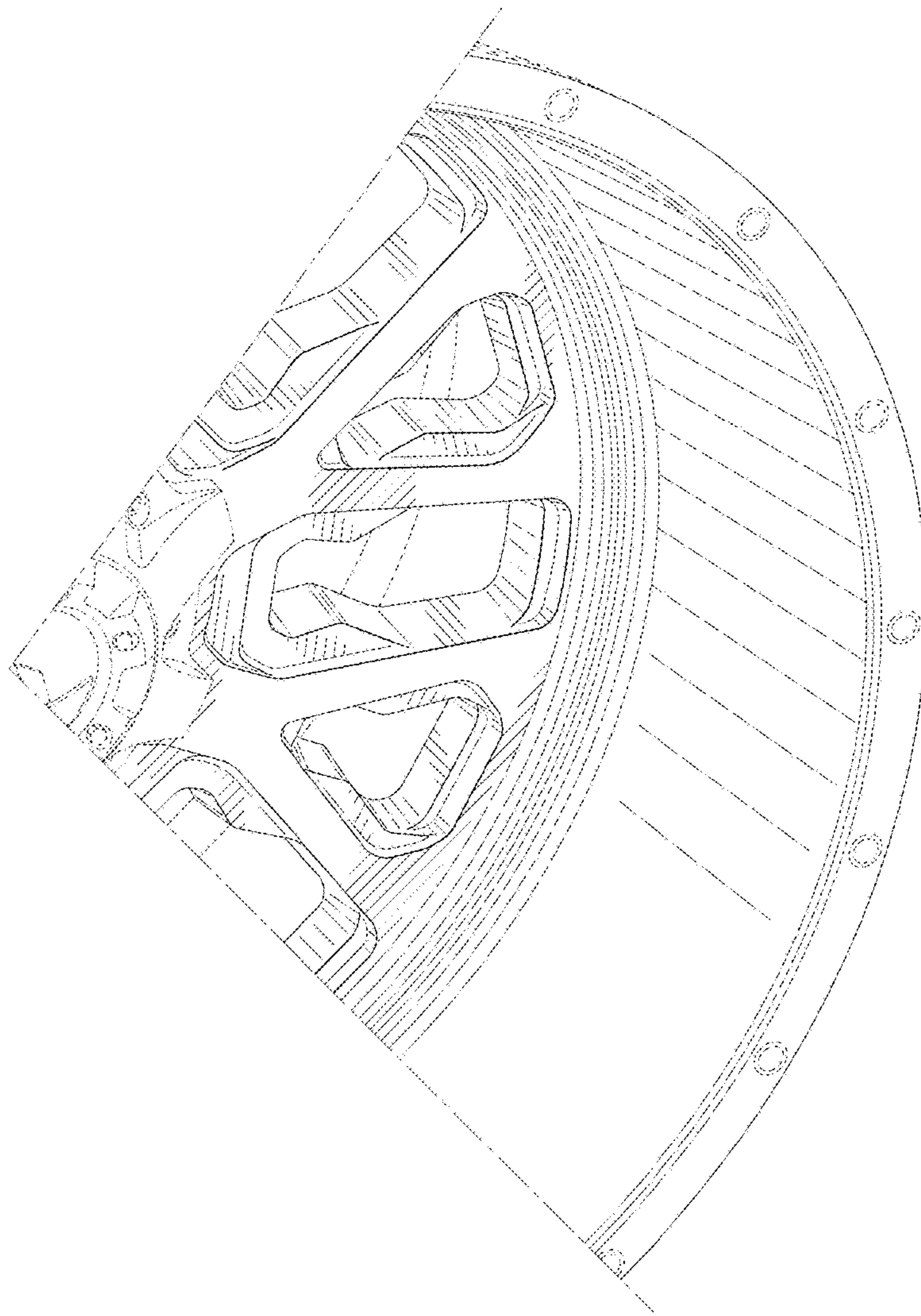
