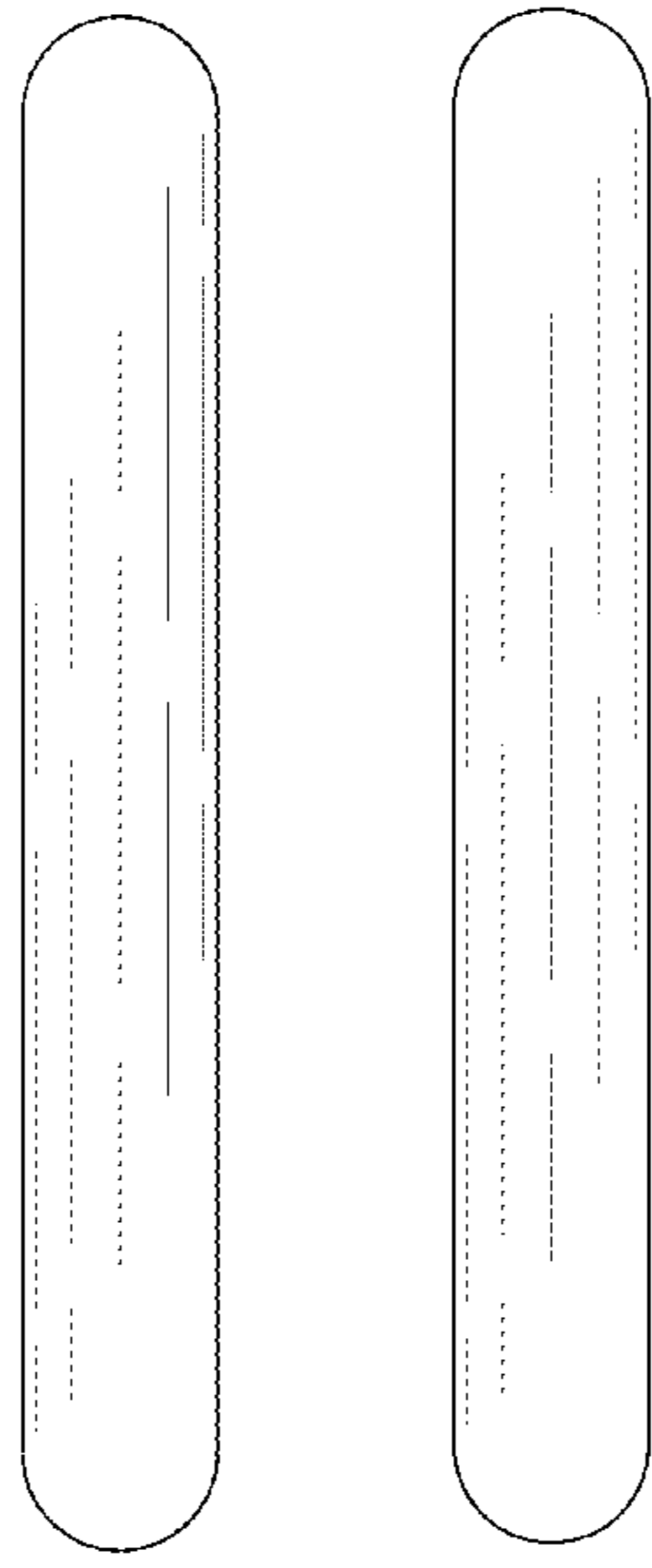

The ornamental design for a tire insert, as shown and described.

DESCRIPTION
FIG. 1 is a left side view of a tire insert, showing the new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof.
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top, front and right side perspective view thereof;
and,
FIG. 8 is a cross section view of the tire insert of FIG. 4, taken along line 8-8.

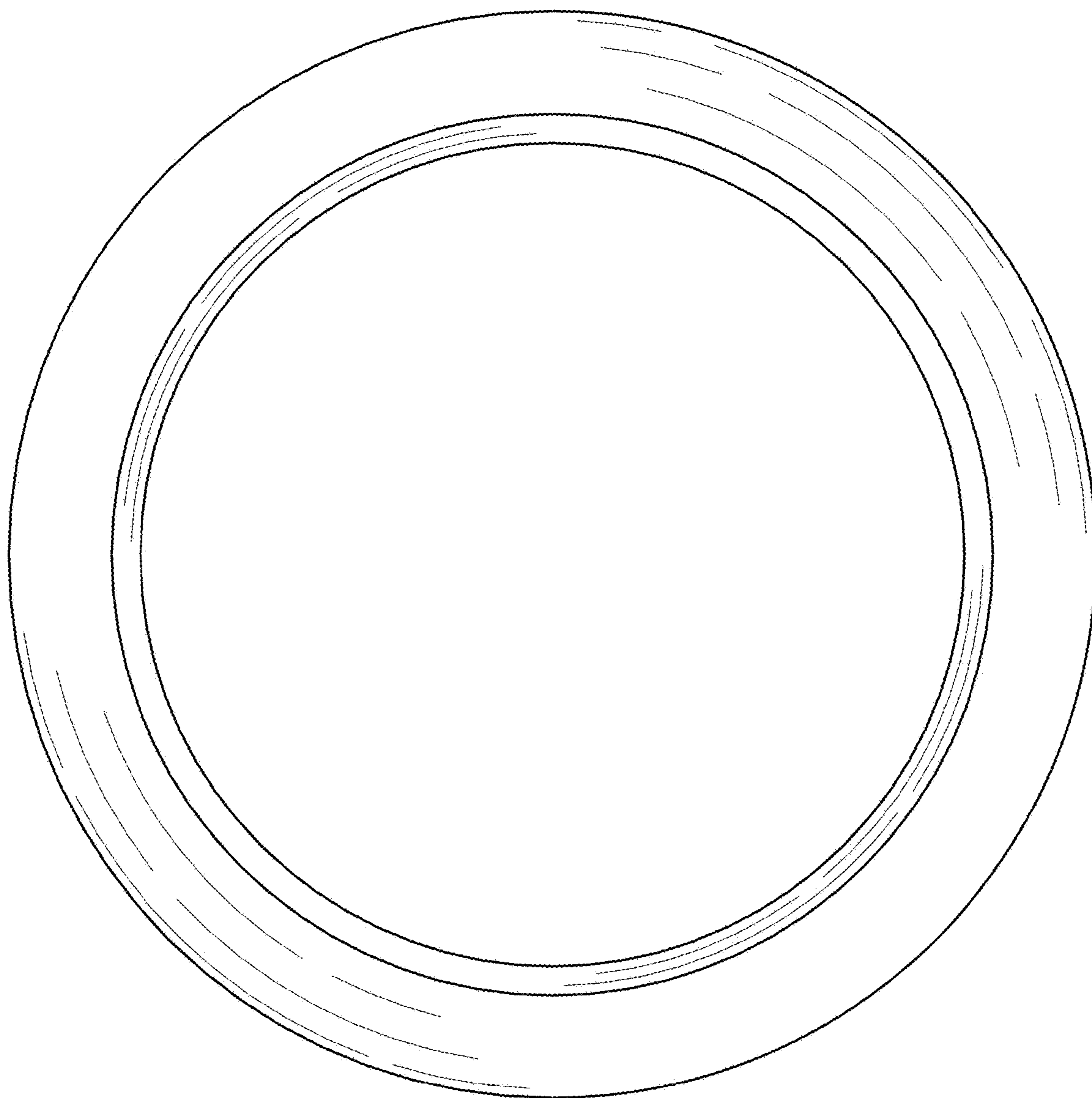

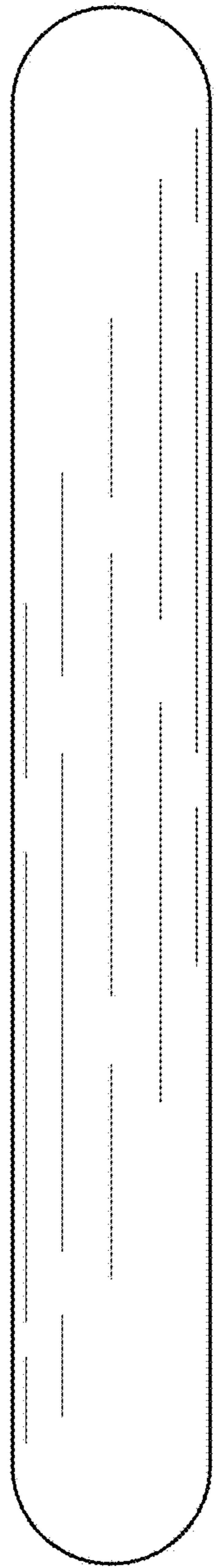

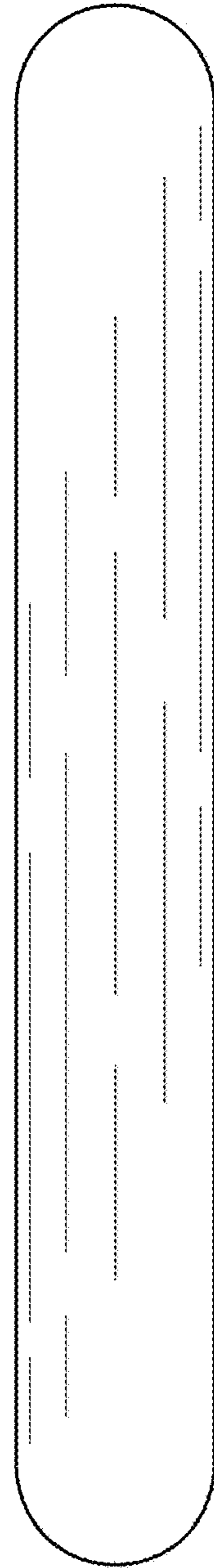

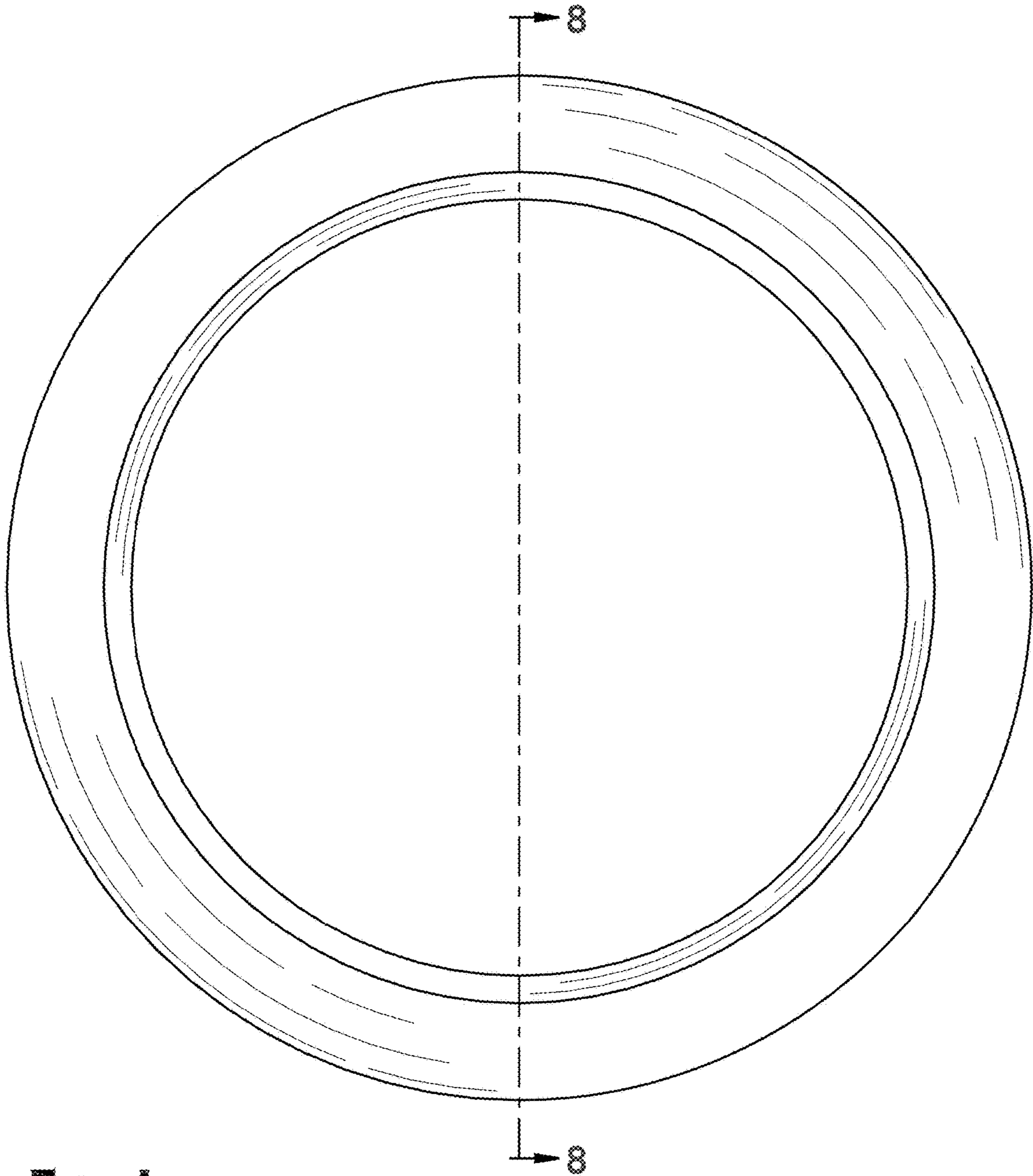

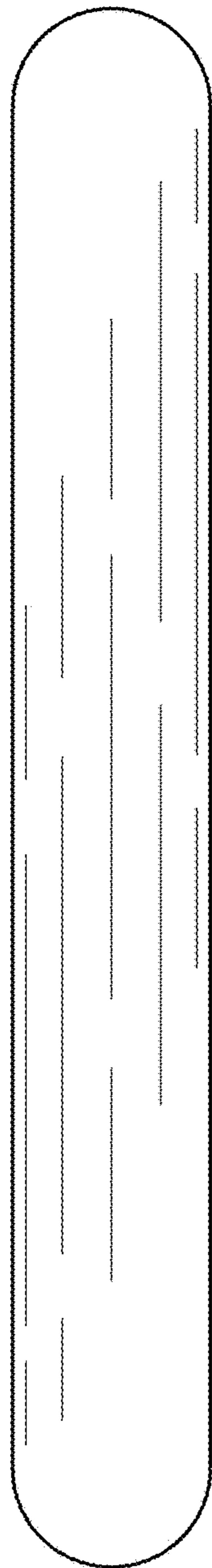

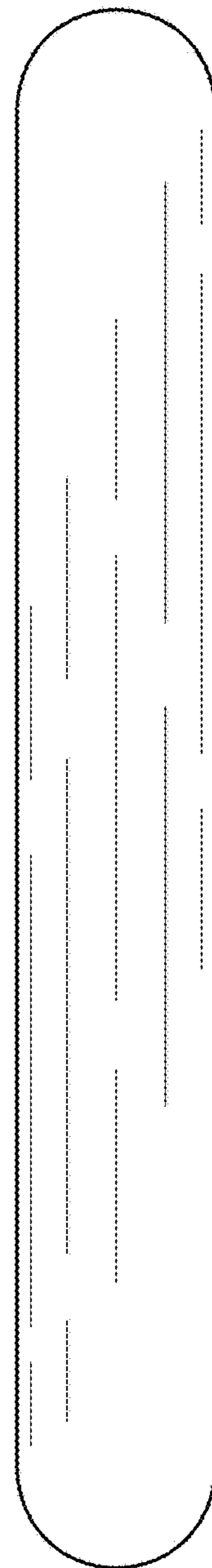

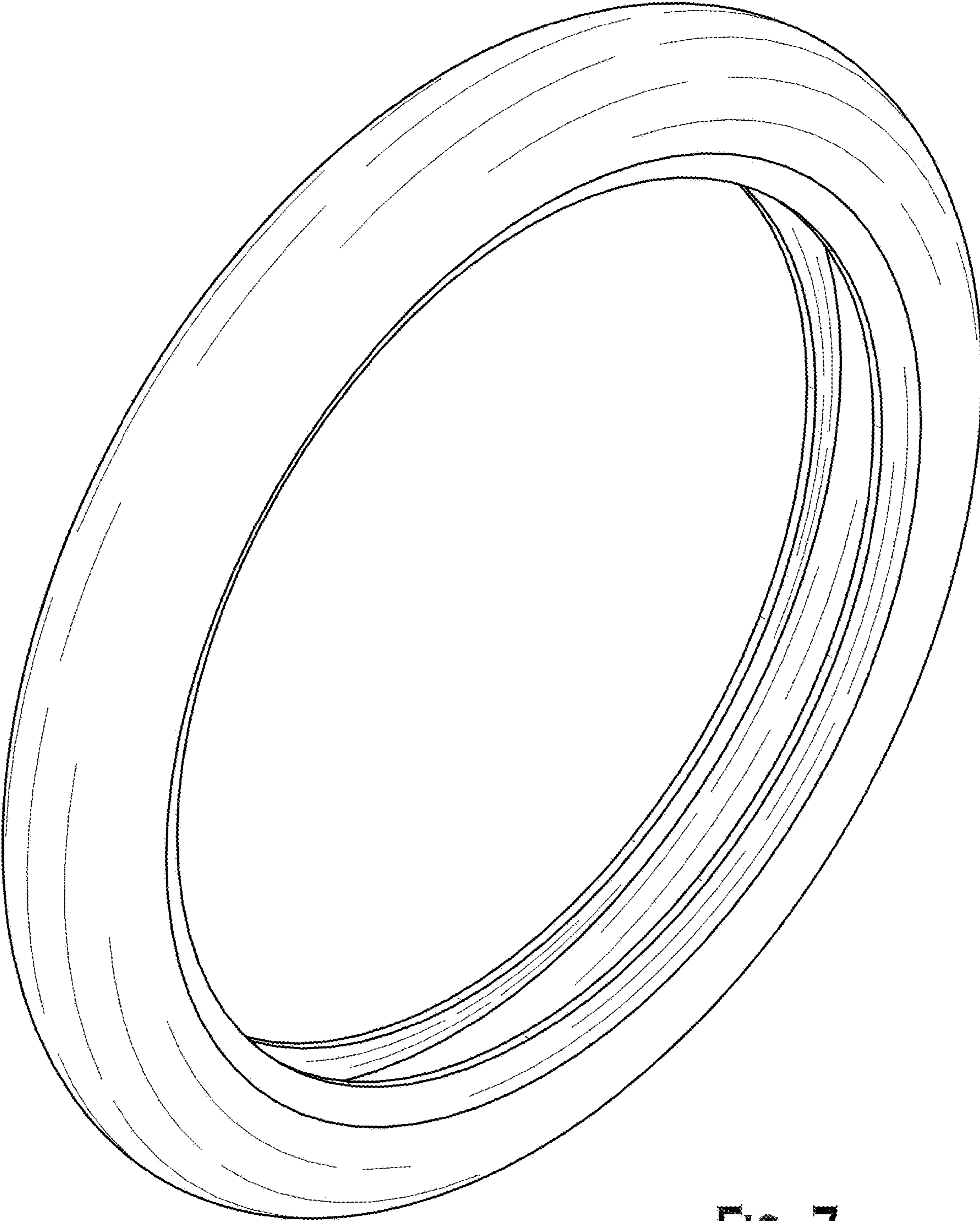

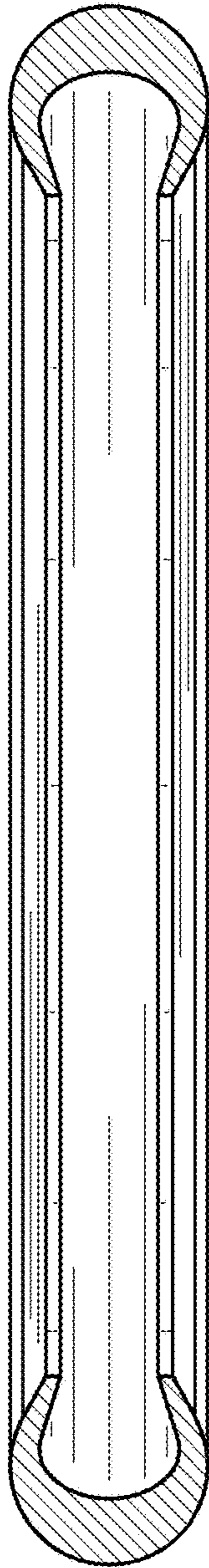
