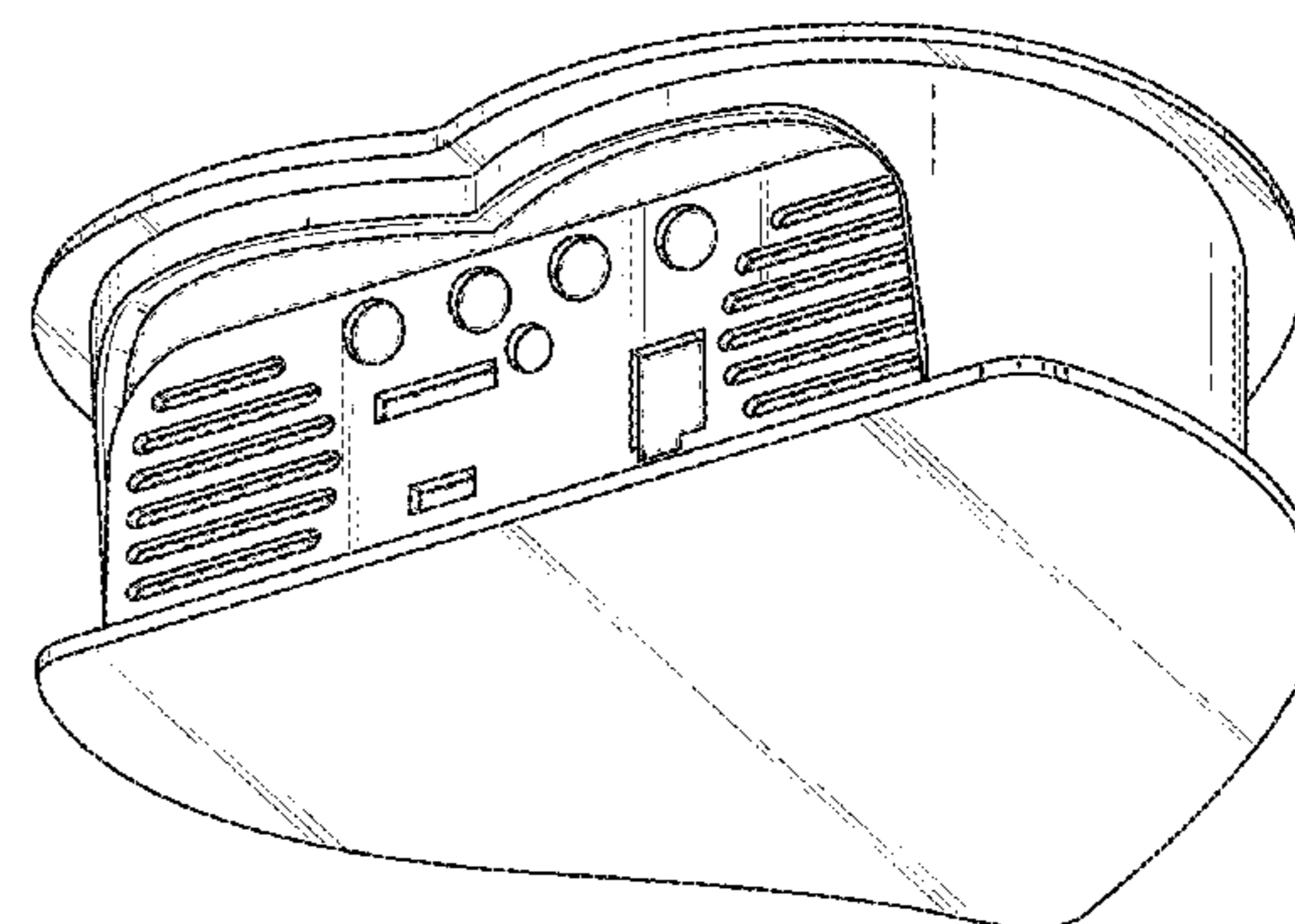
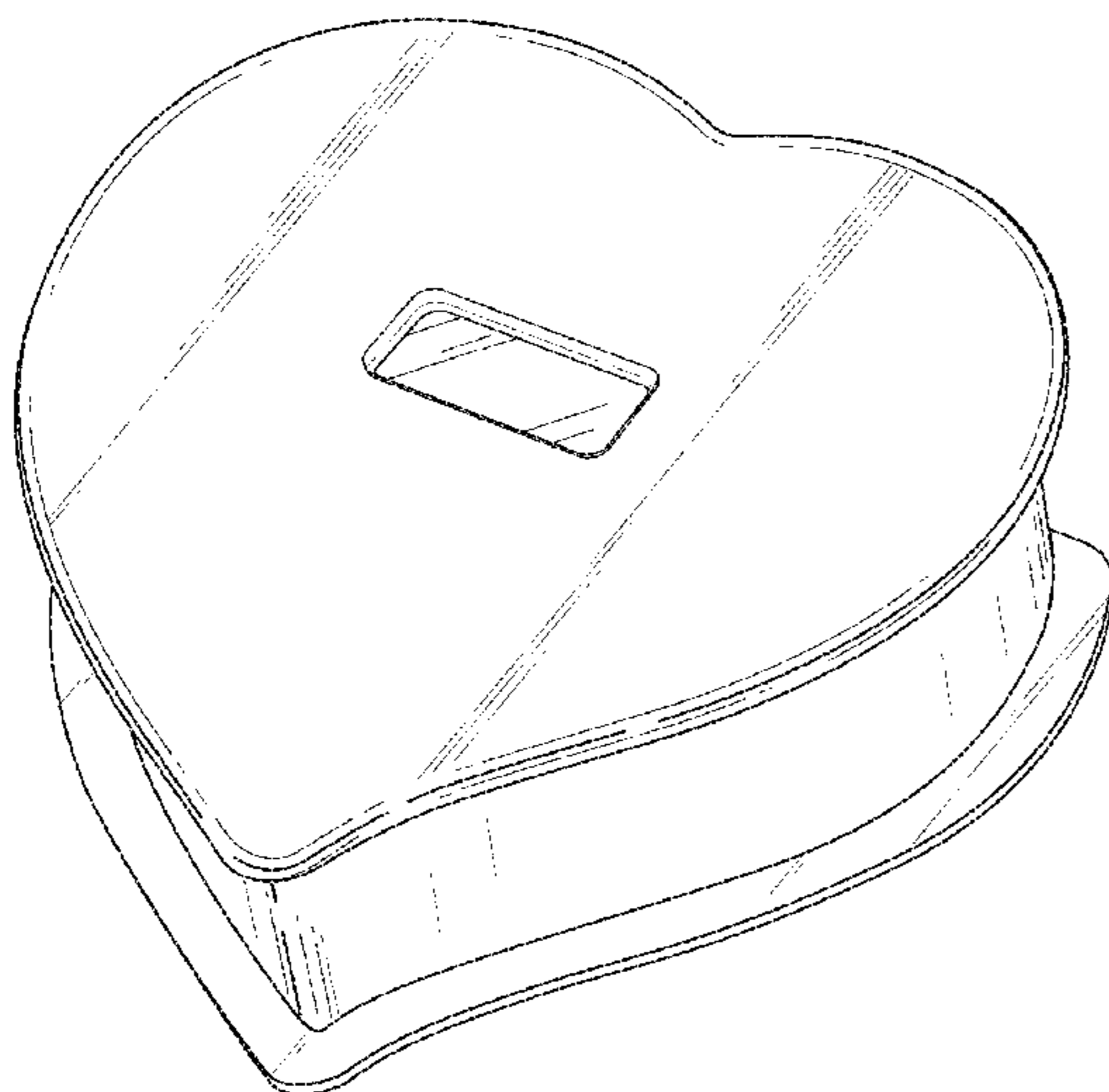
(57) **CLAIM**

I claim the ornamental design for a heart-shaped MP3 music box, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a heart-shaped MP3 music box, showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left-side elevational view thereof;  
FIG. 5 is a right-side elevational view thereof;  
FIG. 6 is a rear elevational view thereof;  
FIG. 7 is a front elevational view thereof; and,  
FIG. 8 is a bottom perspective view thereof.  
The broken lines in the figures depict portions of the heart-shaped MP3 music box that form no part of the claimed design.

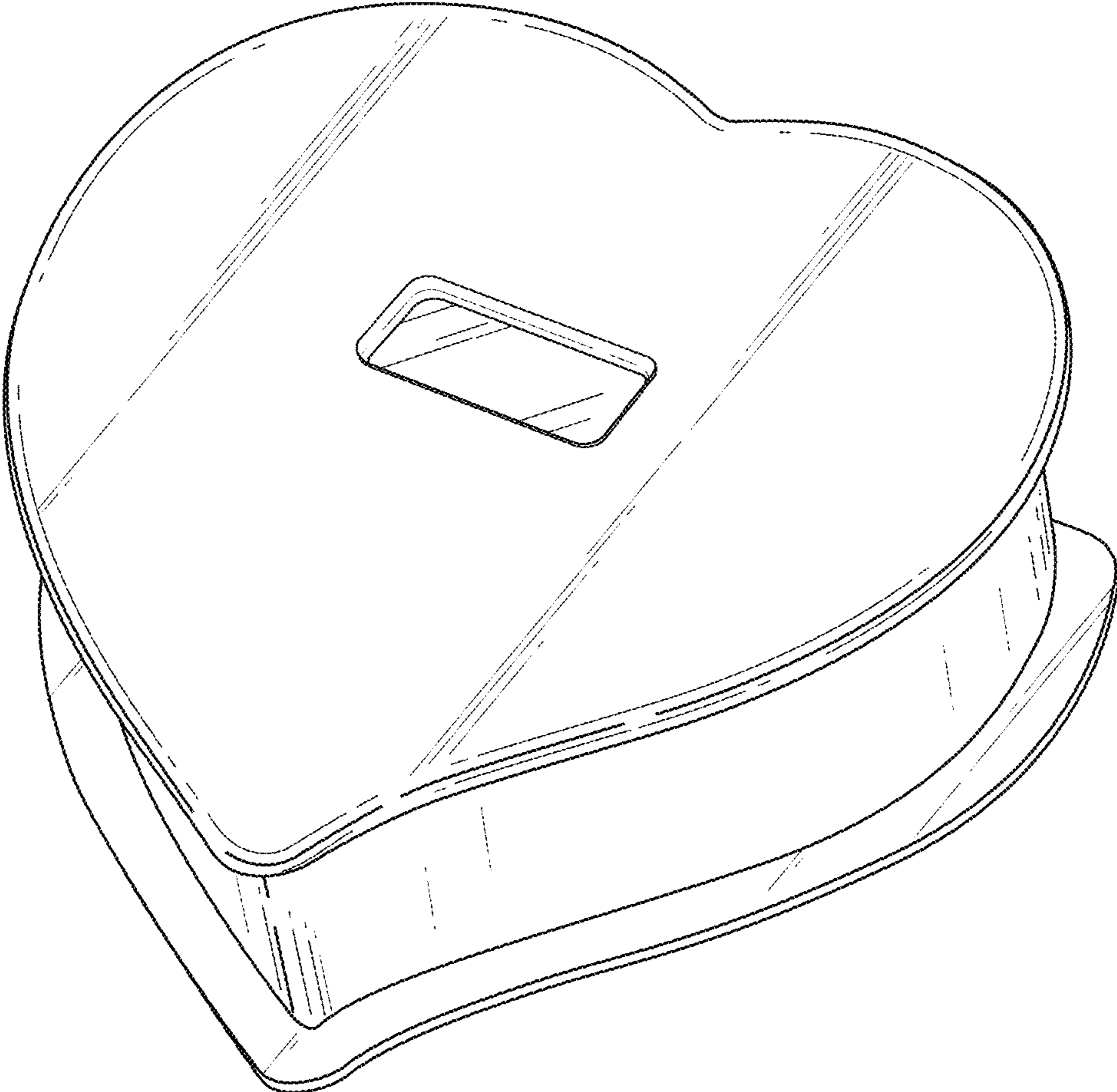

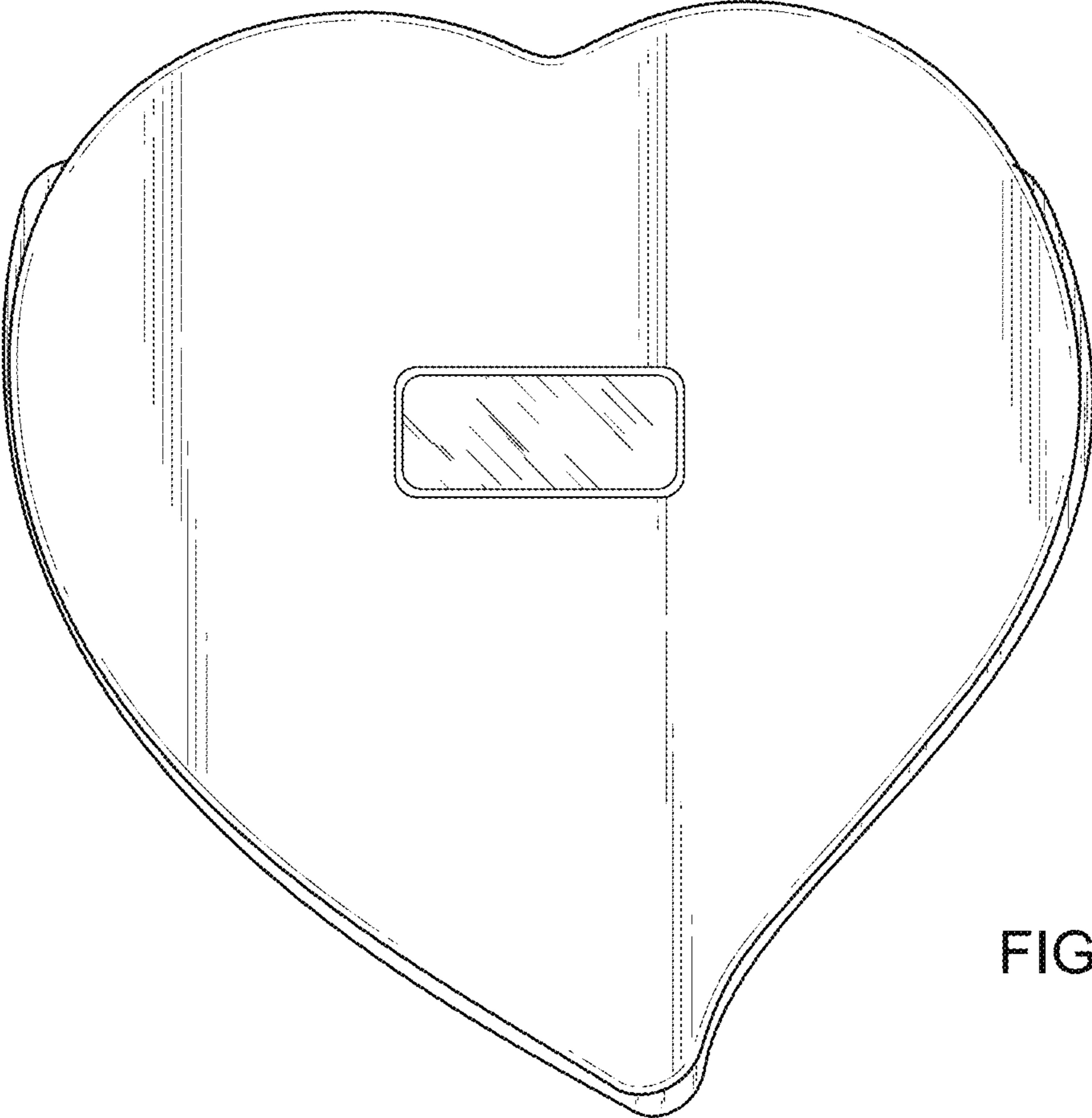

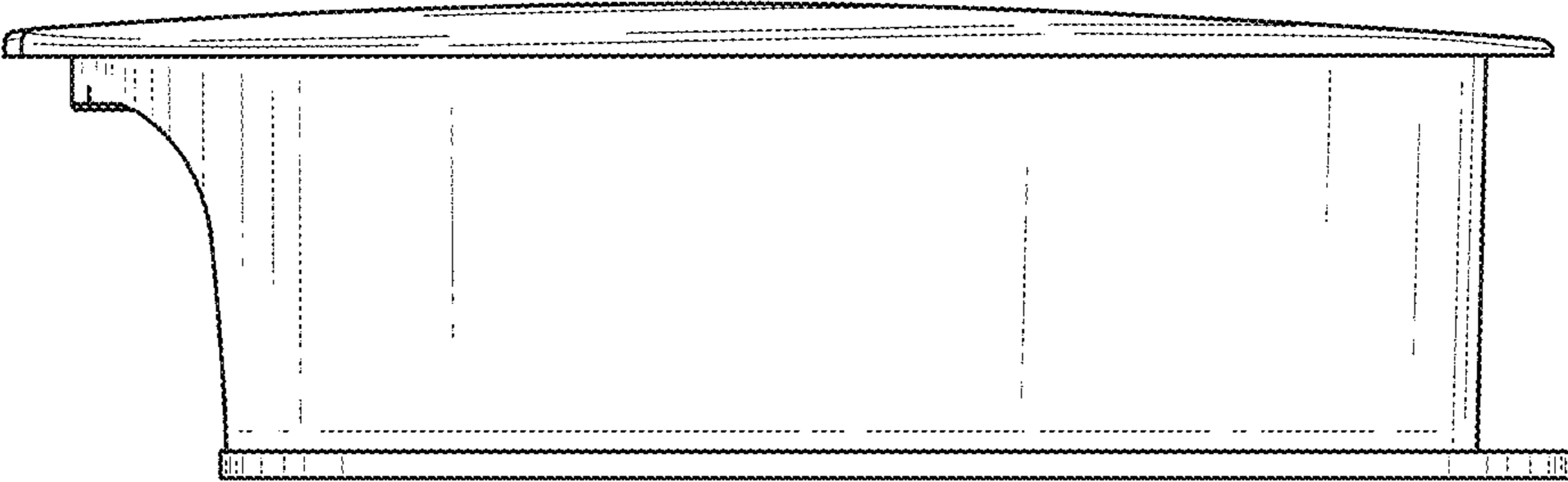

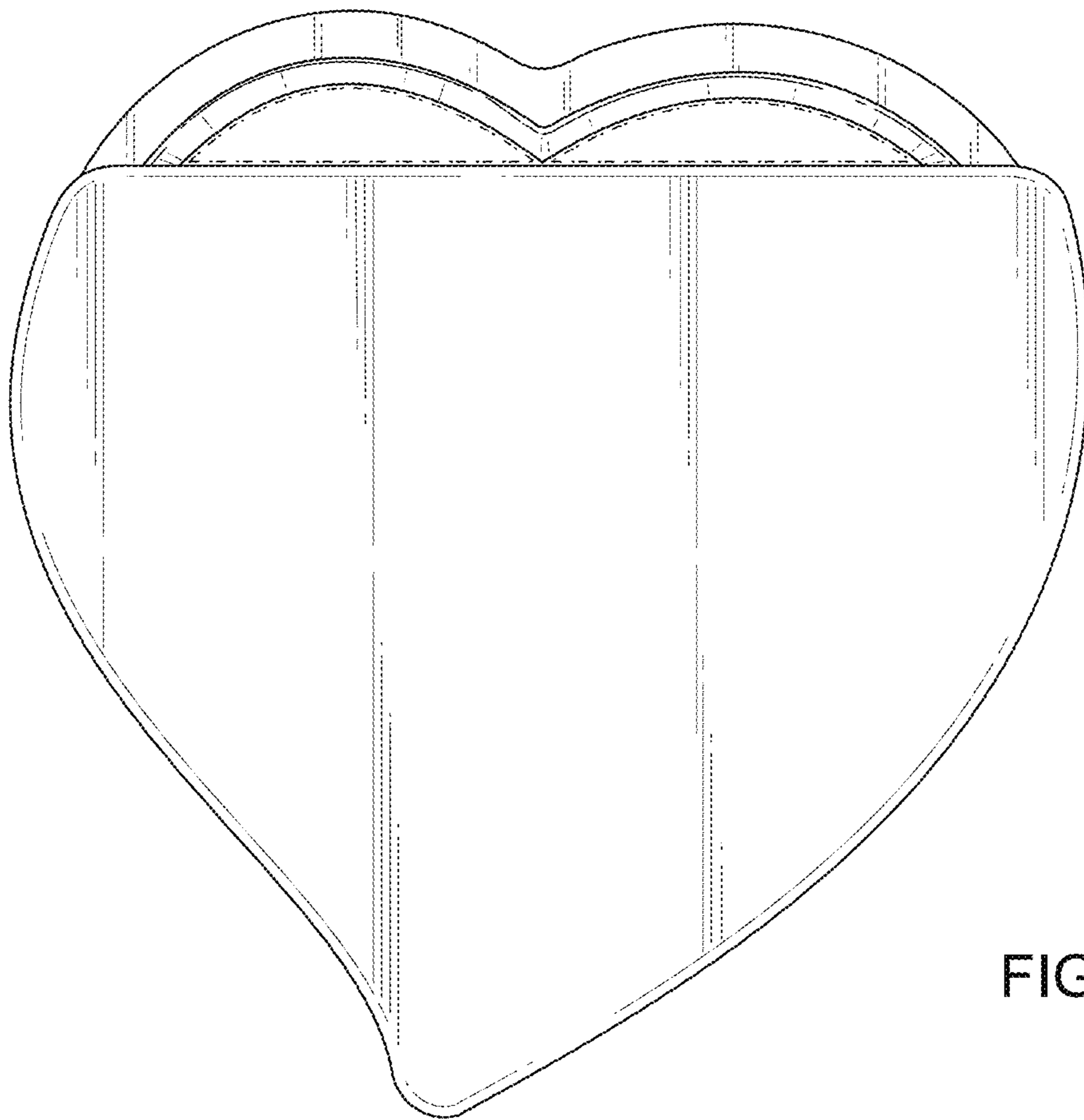

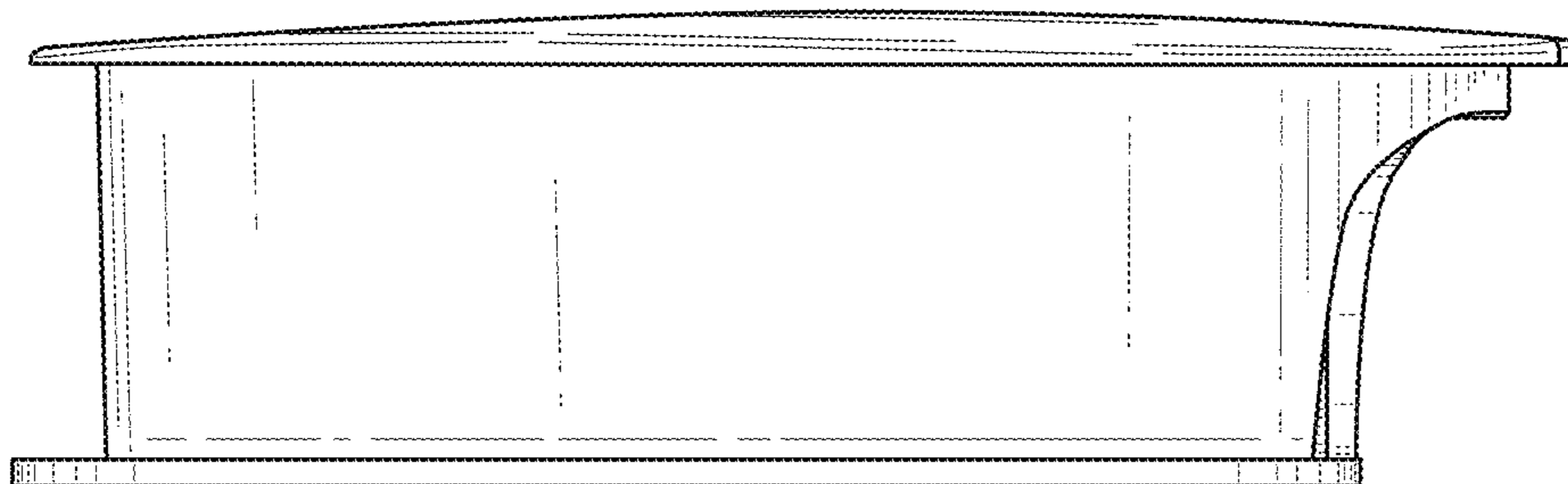

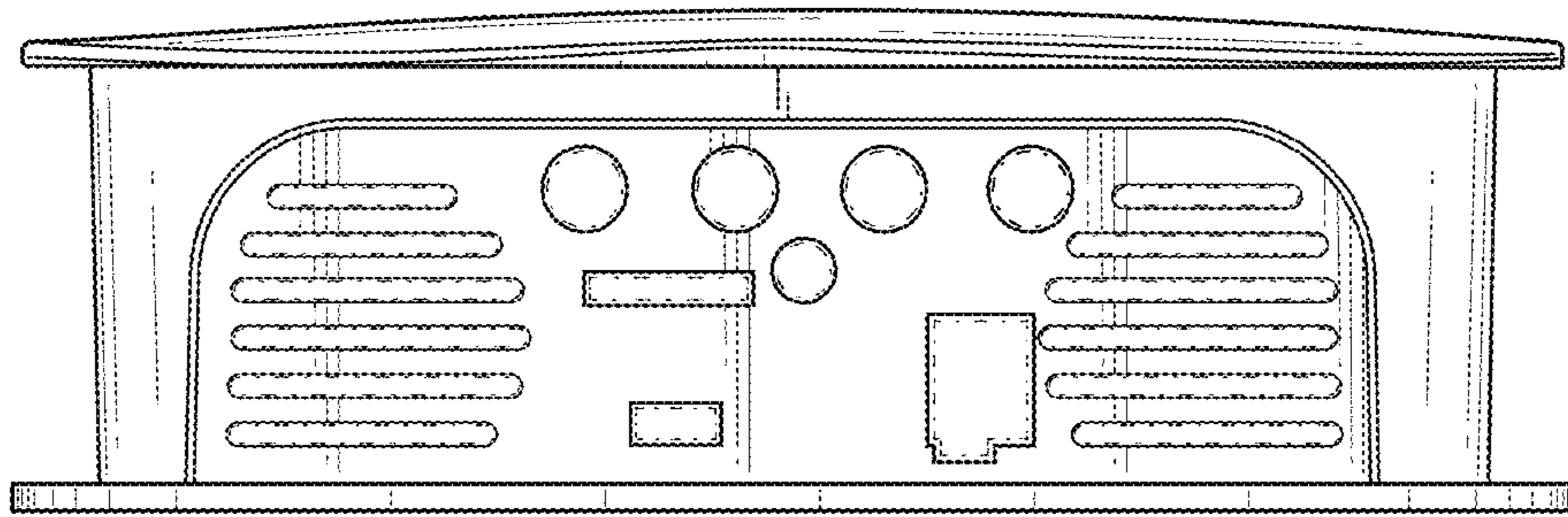

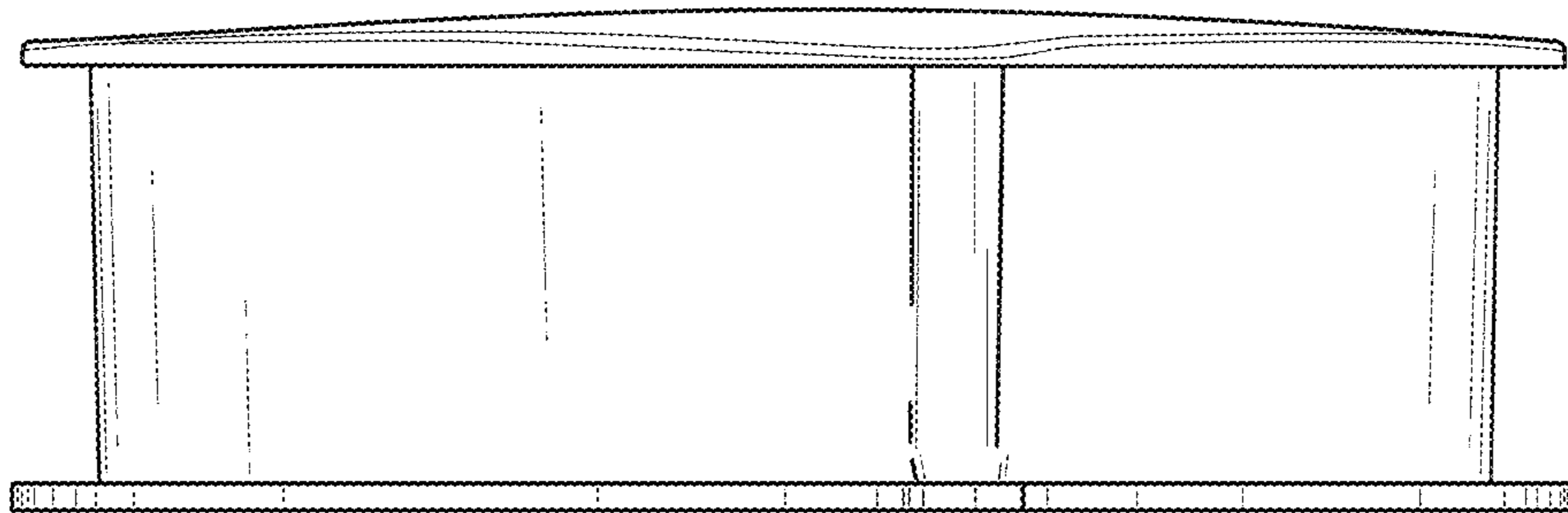

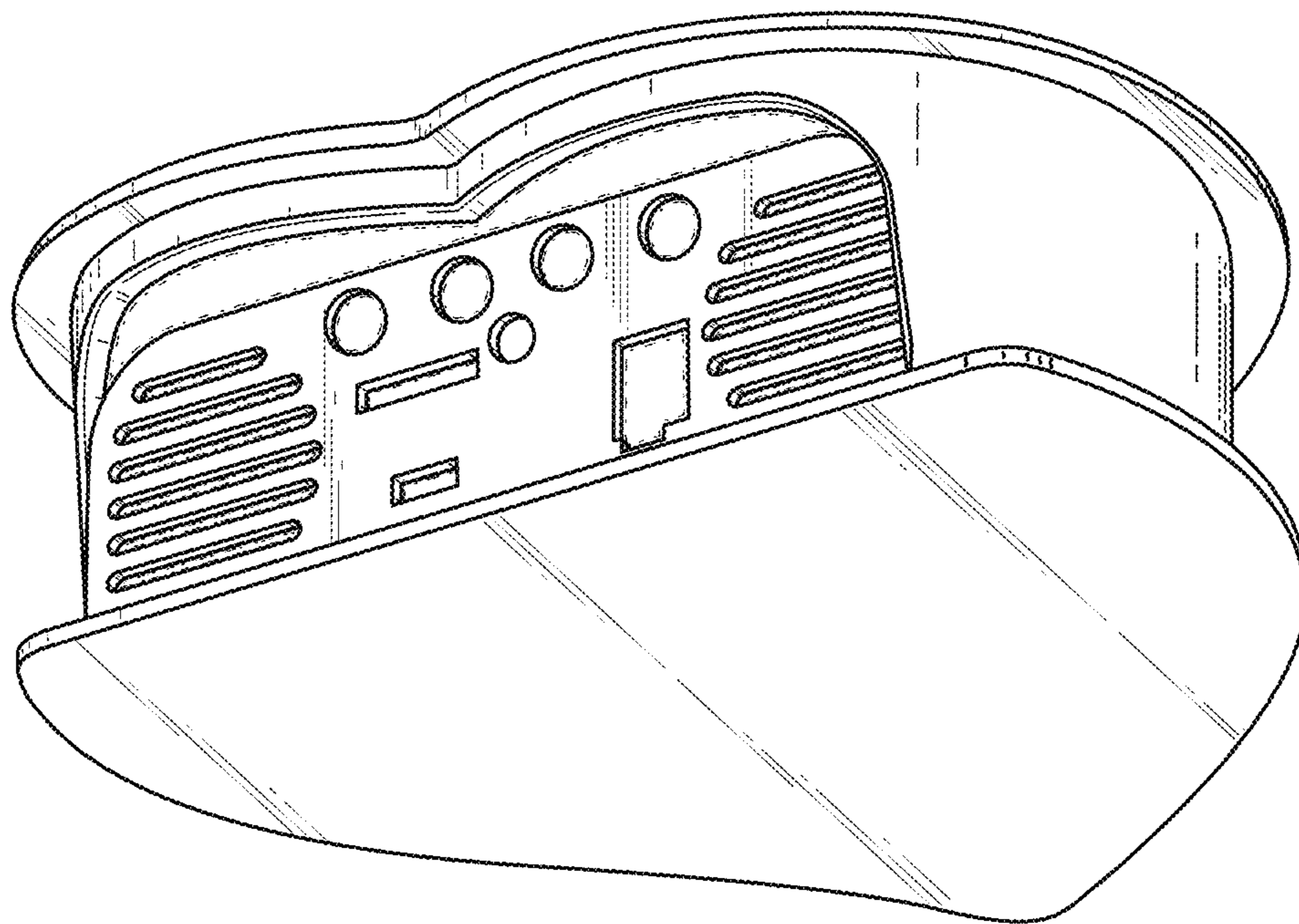
