(57) **CLAIM**

We claim the ornamental design for an electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an electronic device showing our new design;

FIG. 8 is an enlarged view of the encircled portion in FIG. 6; and,

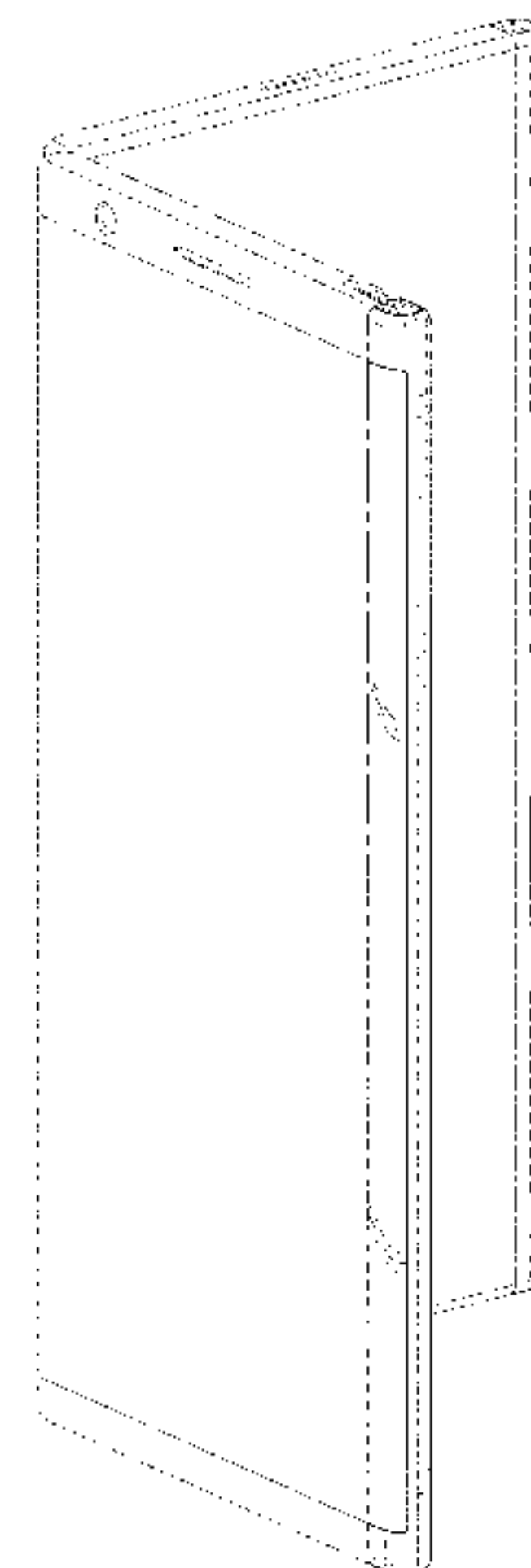
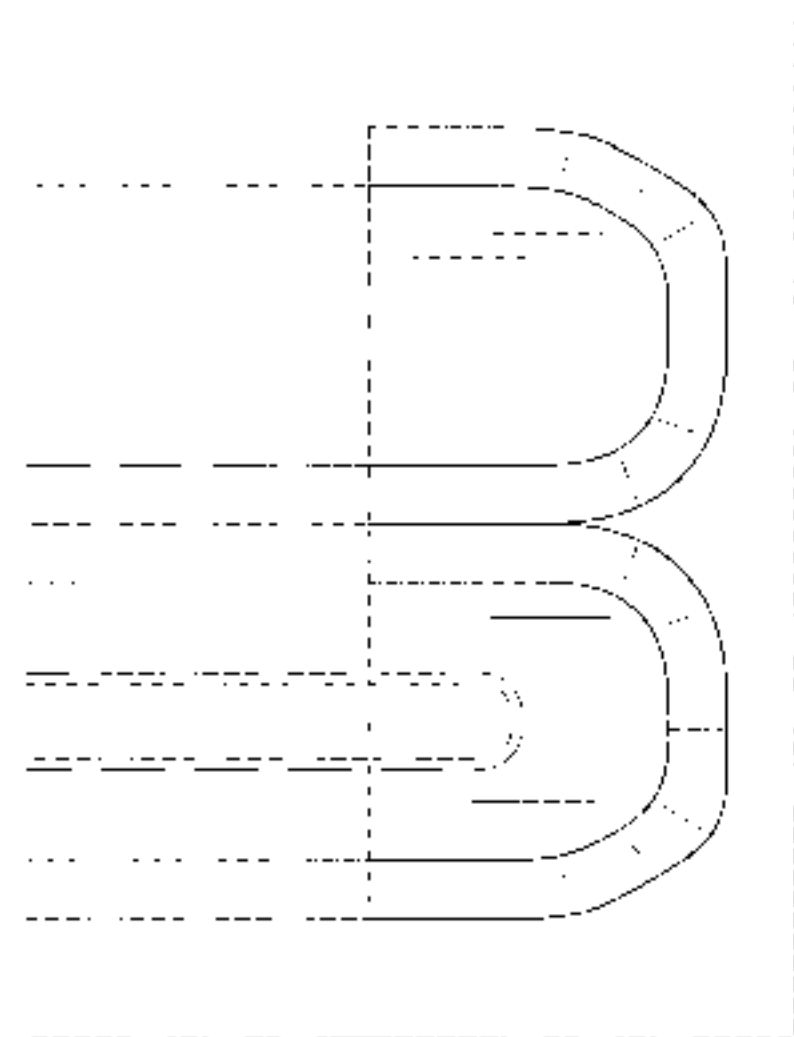
FIG. 9 is another front perspective view thereof in which the electronic device is shown in an open position.

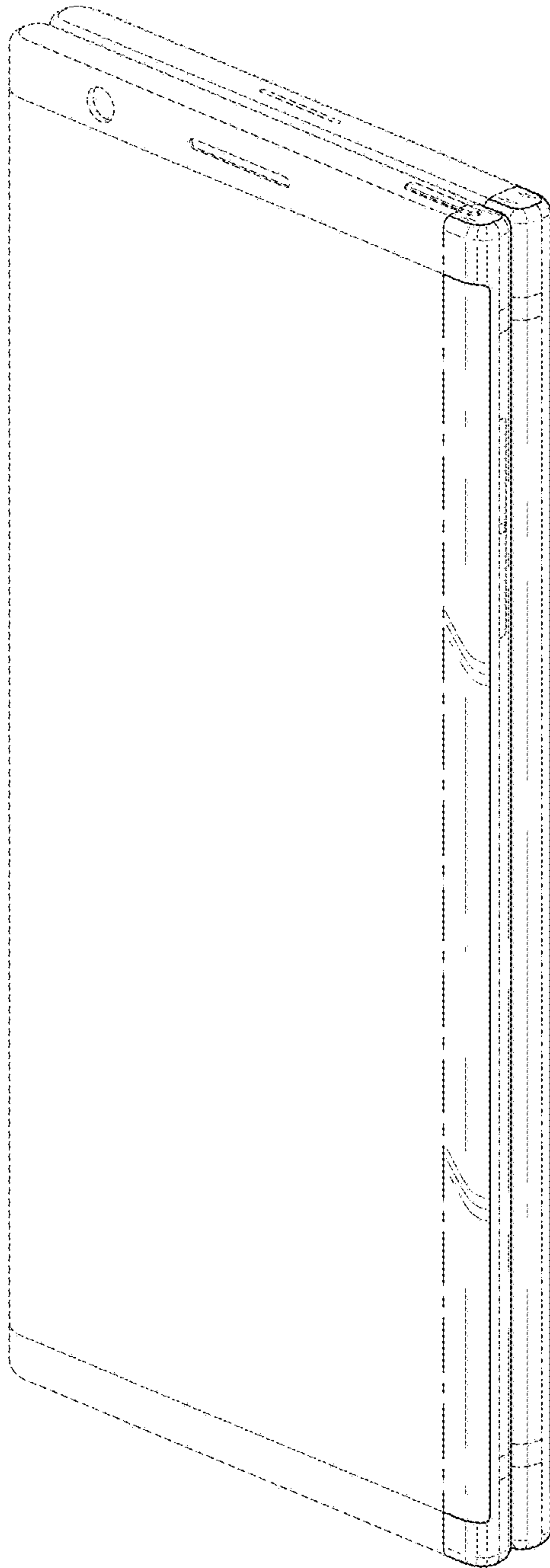

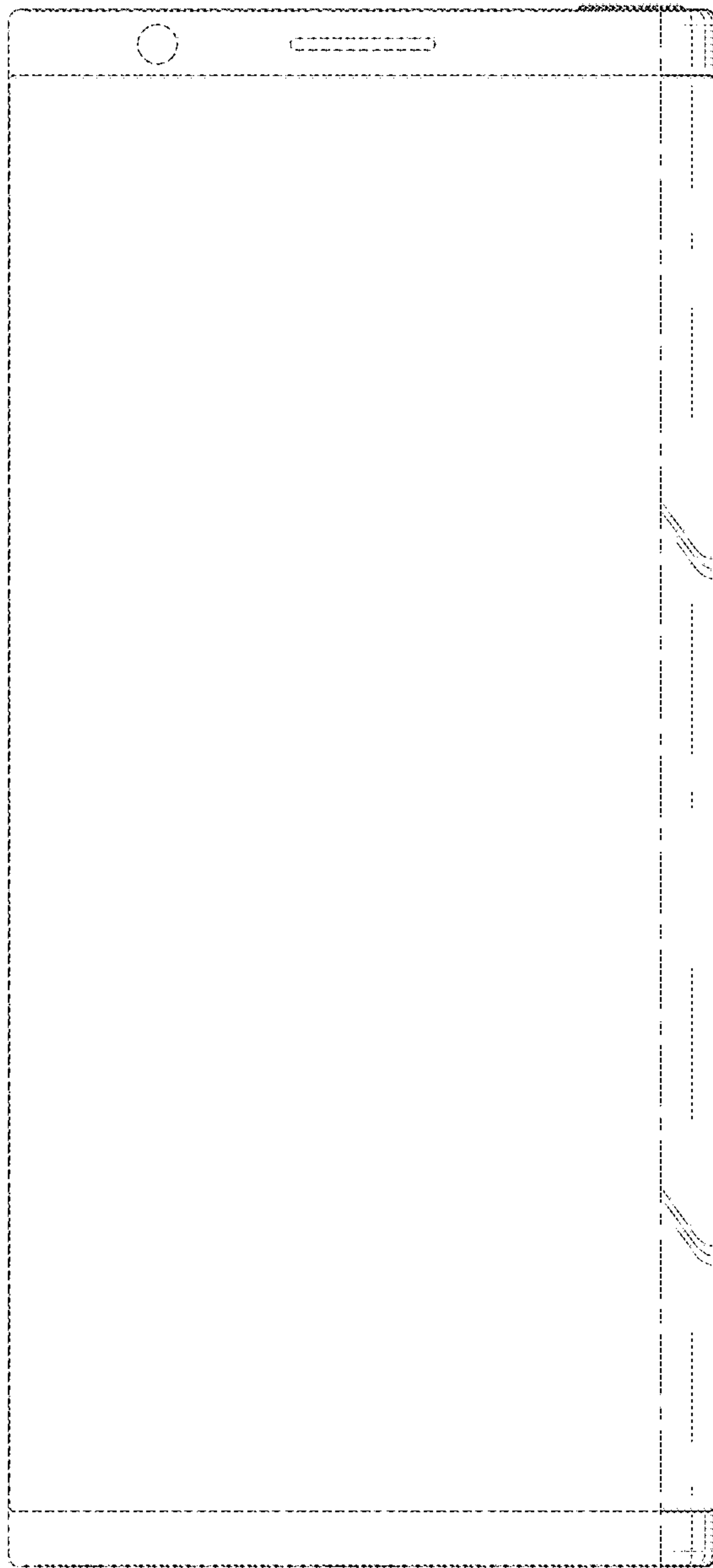

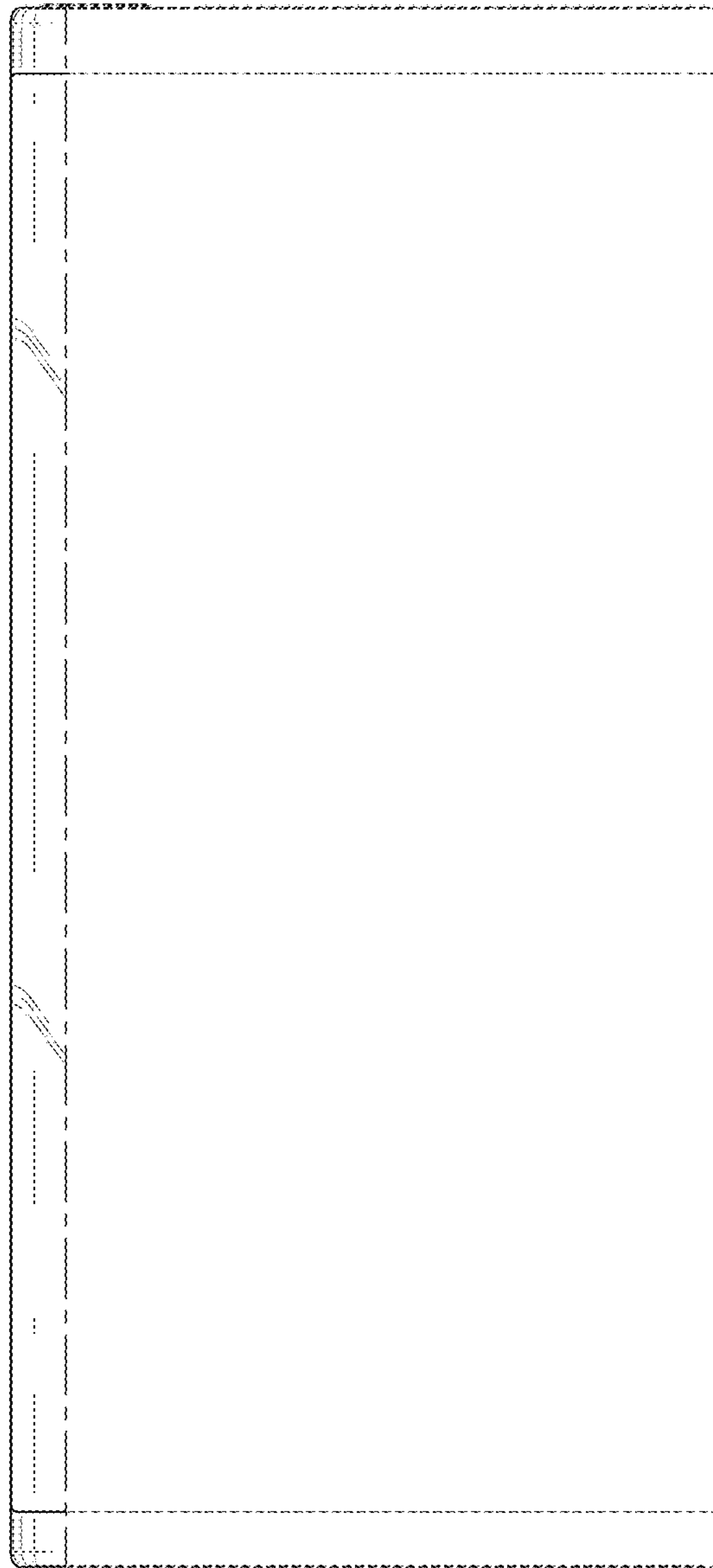

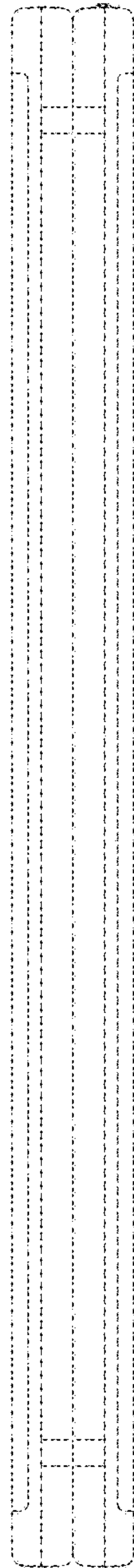

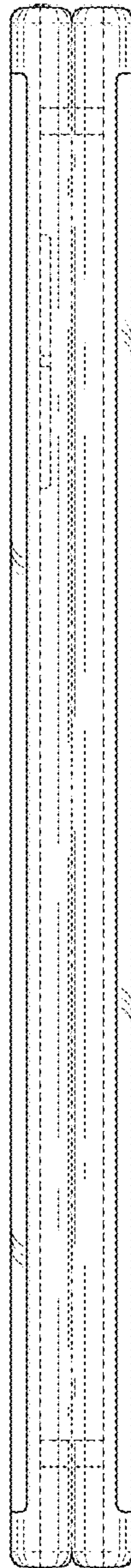

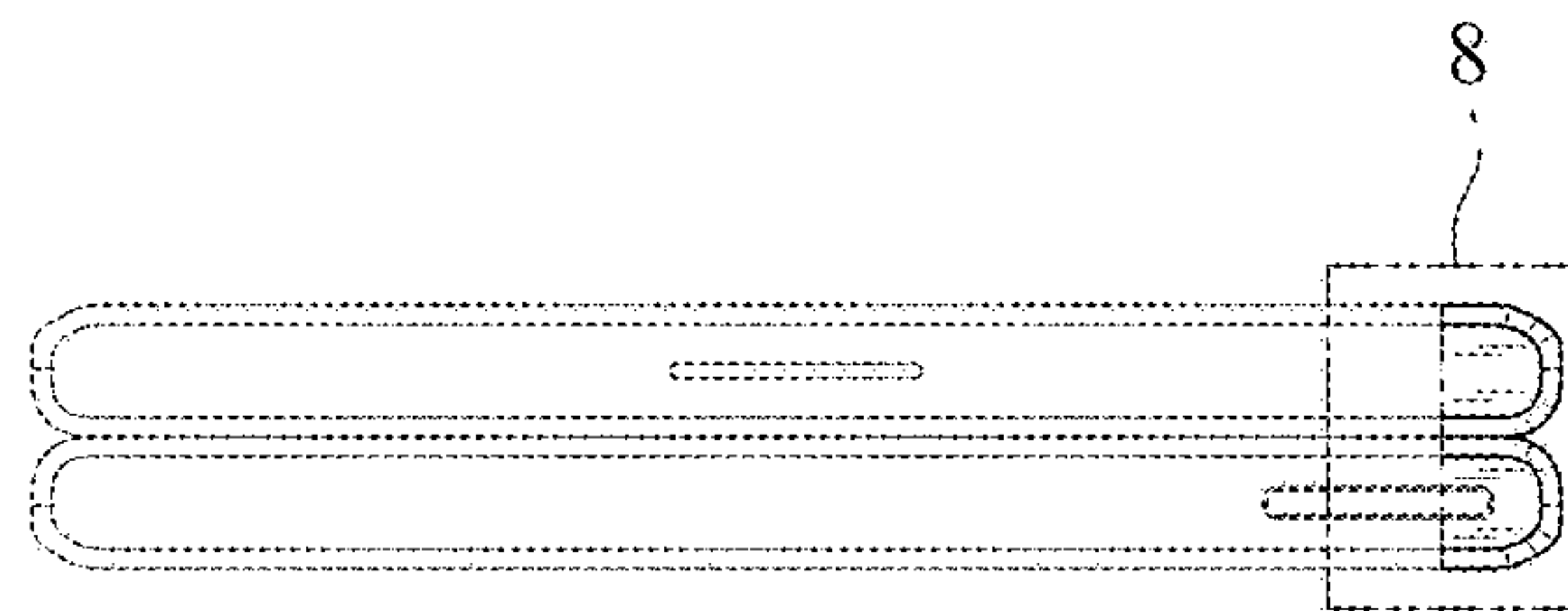

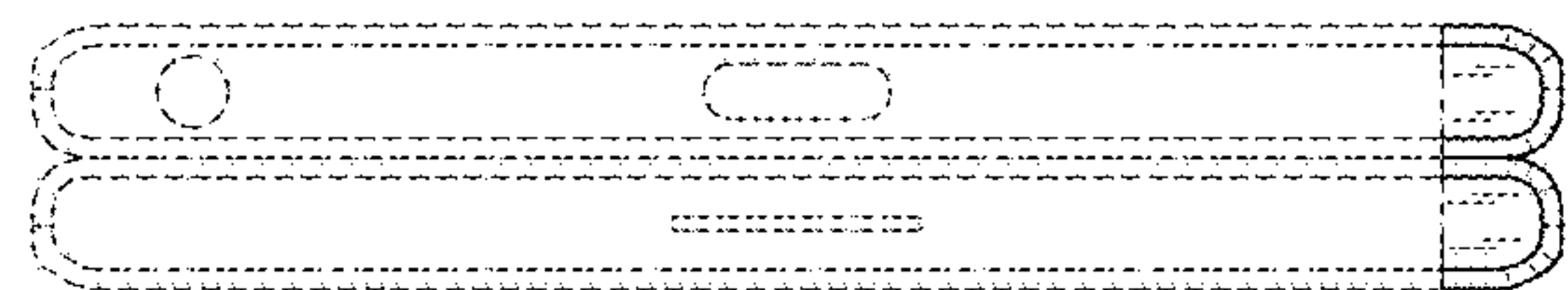

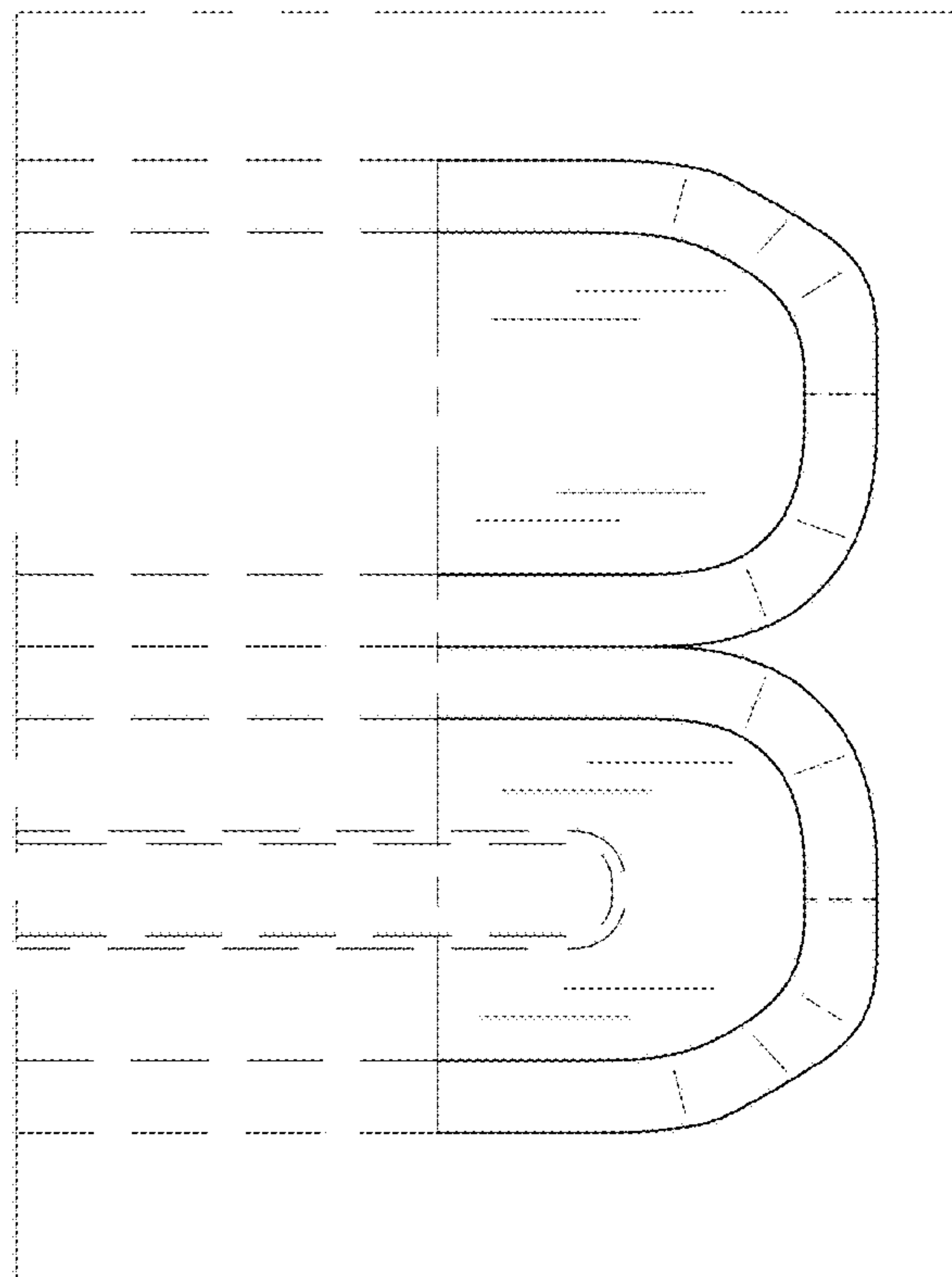
