FIG. 7 is a bottom view thereof.

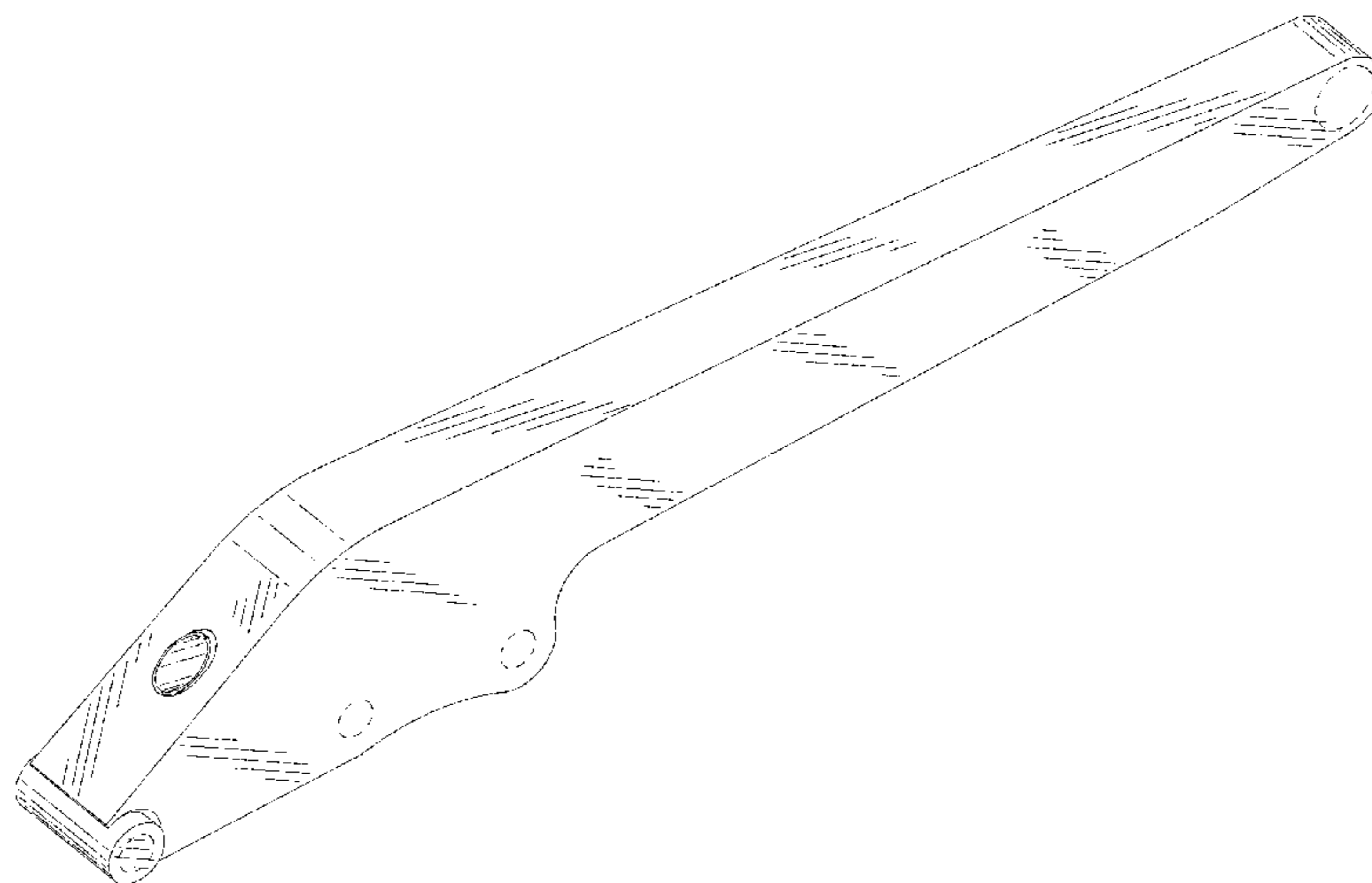
The broken line representations of environmental structure in FIGS. 1-7 is for illustrative purposes only and forms no part of the claimed design.

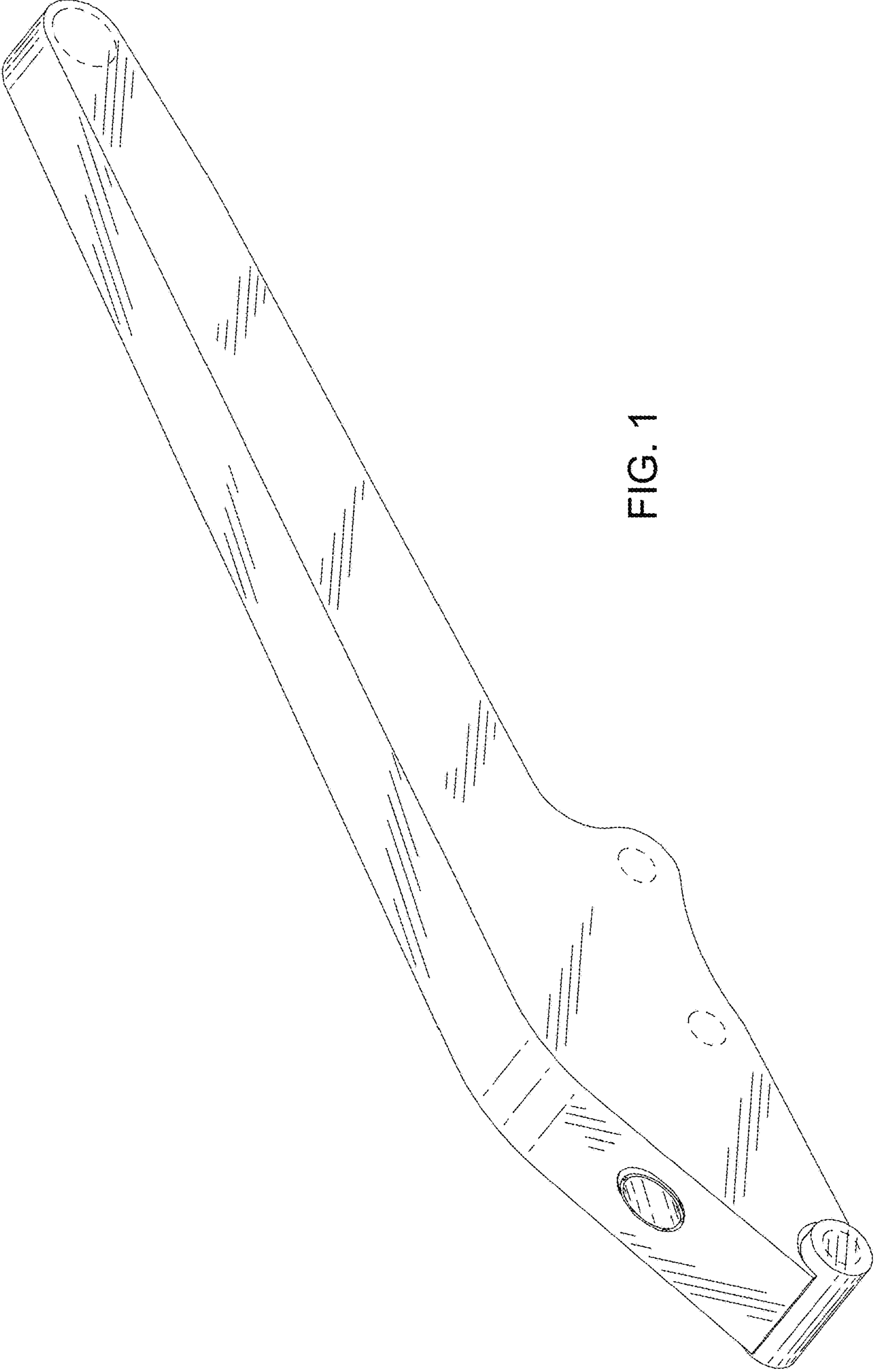

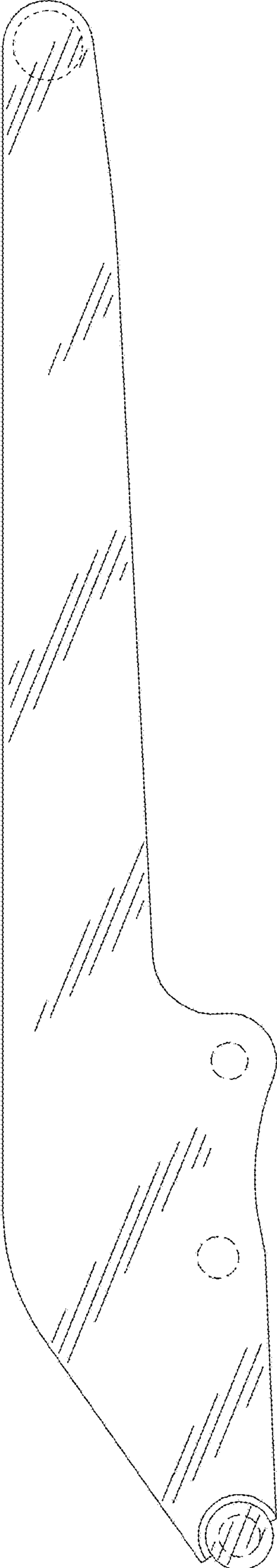

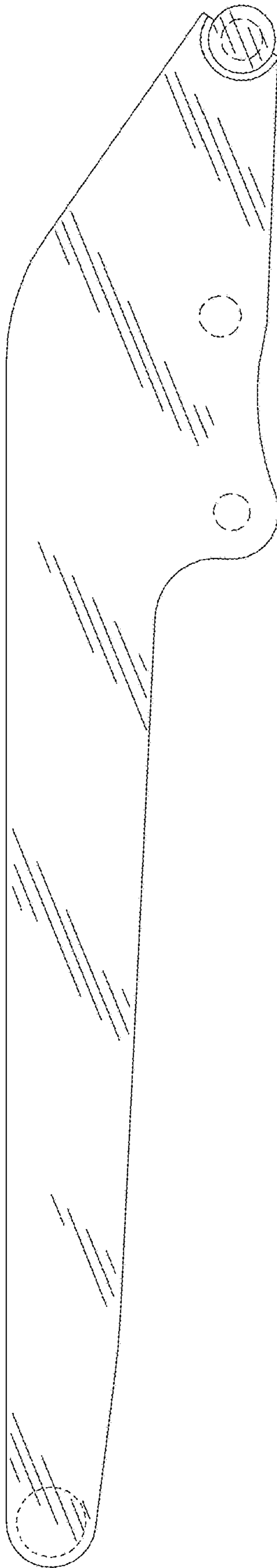

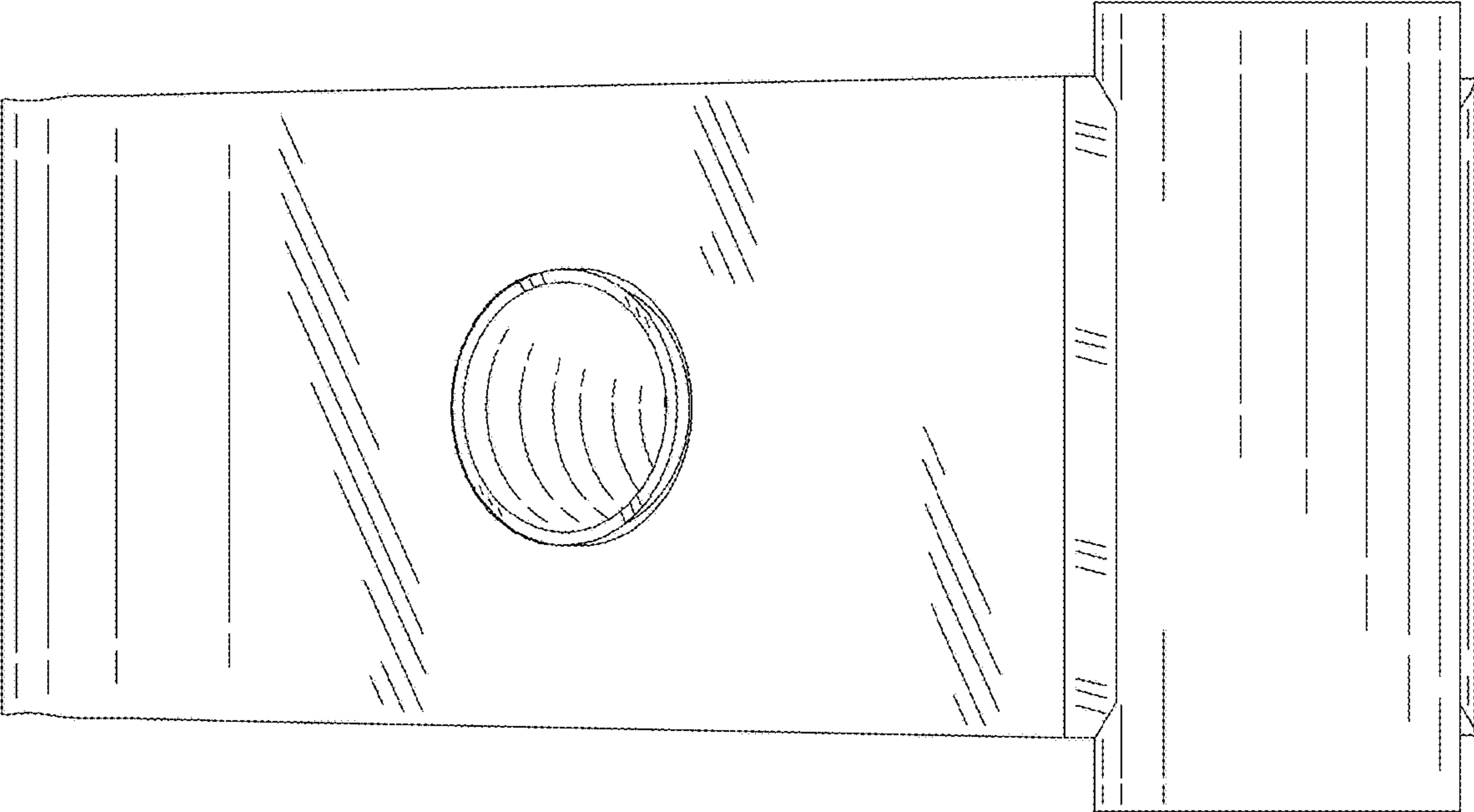

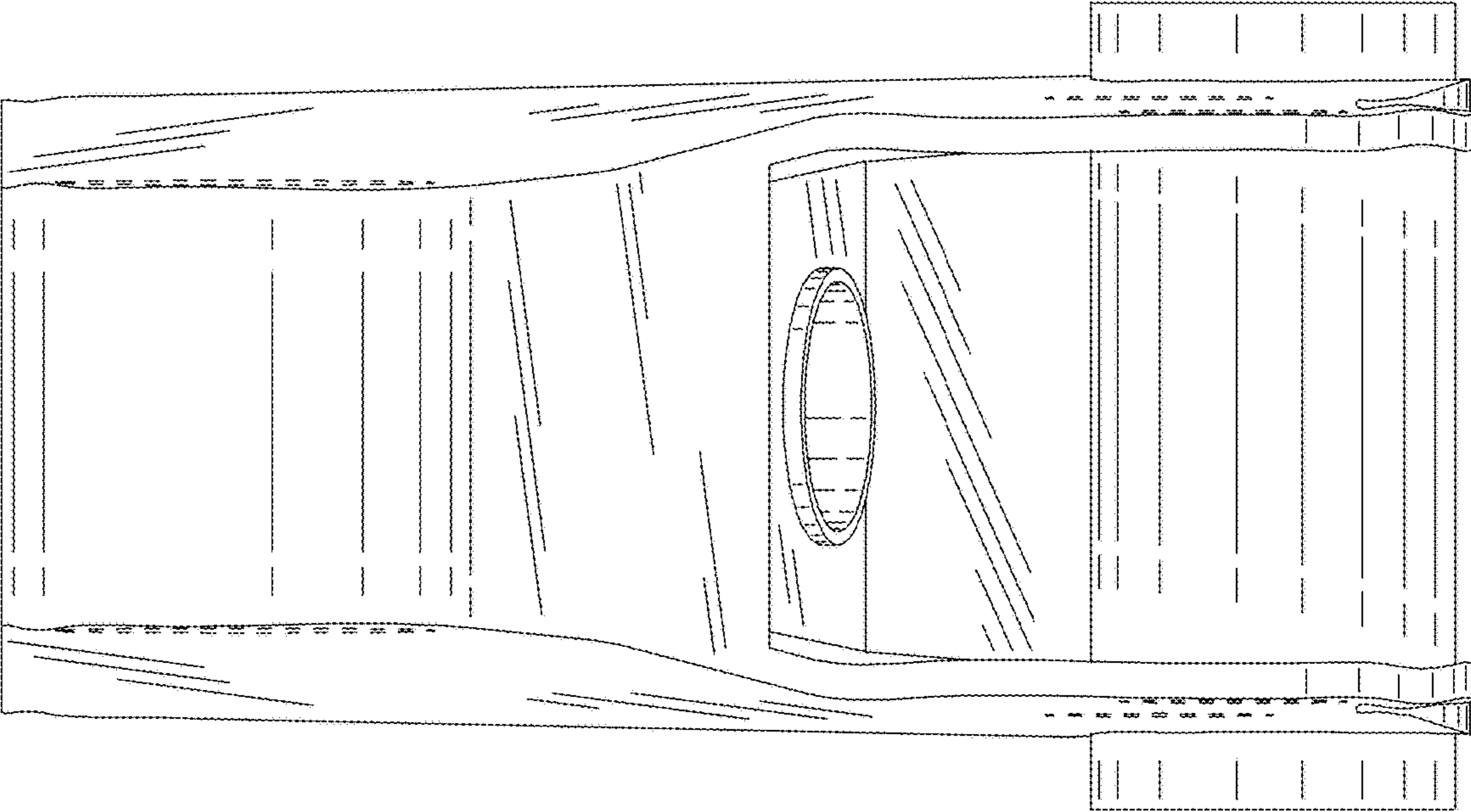

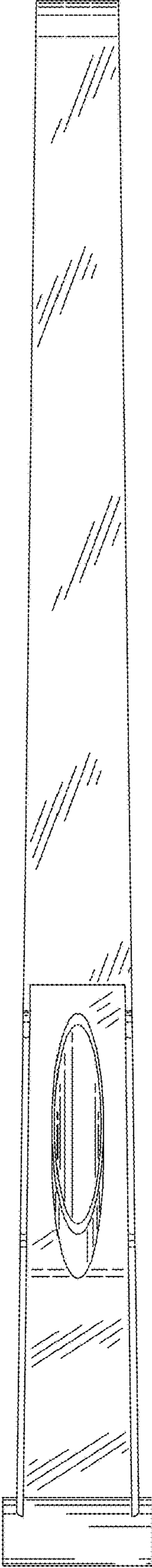
