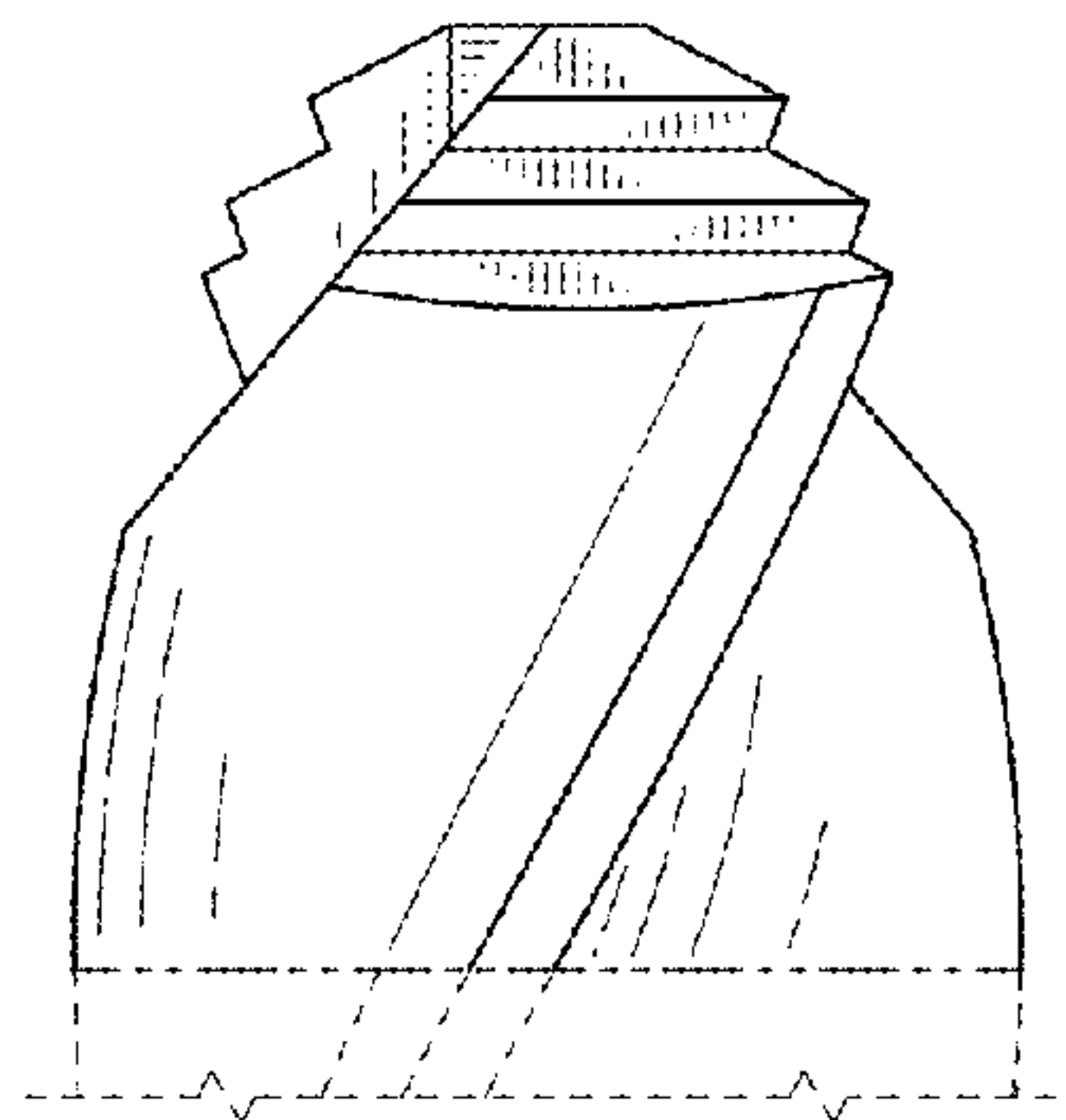
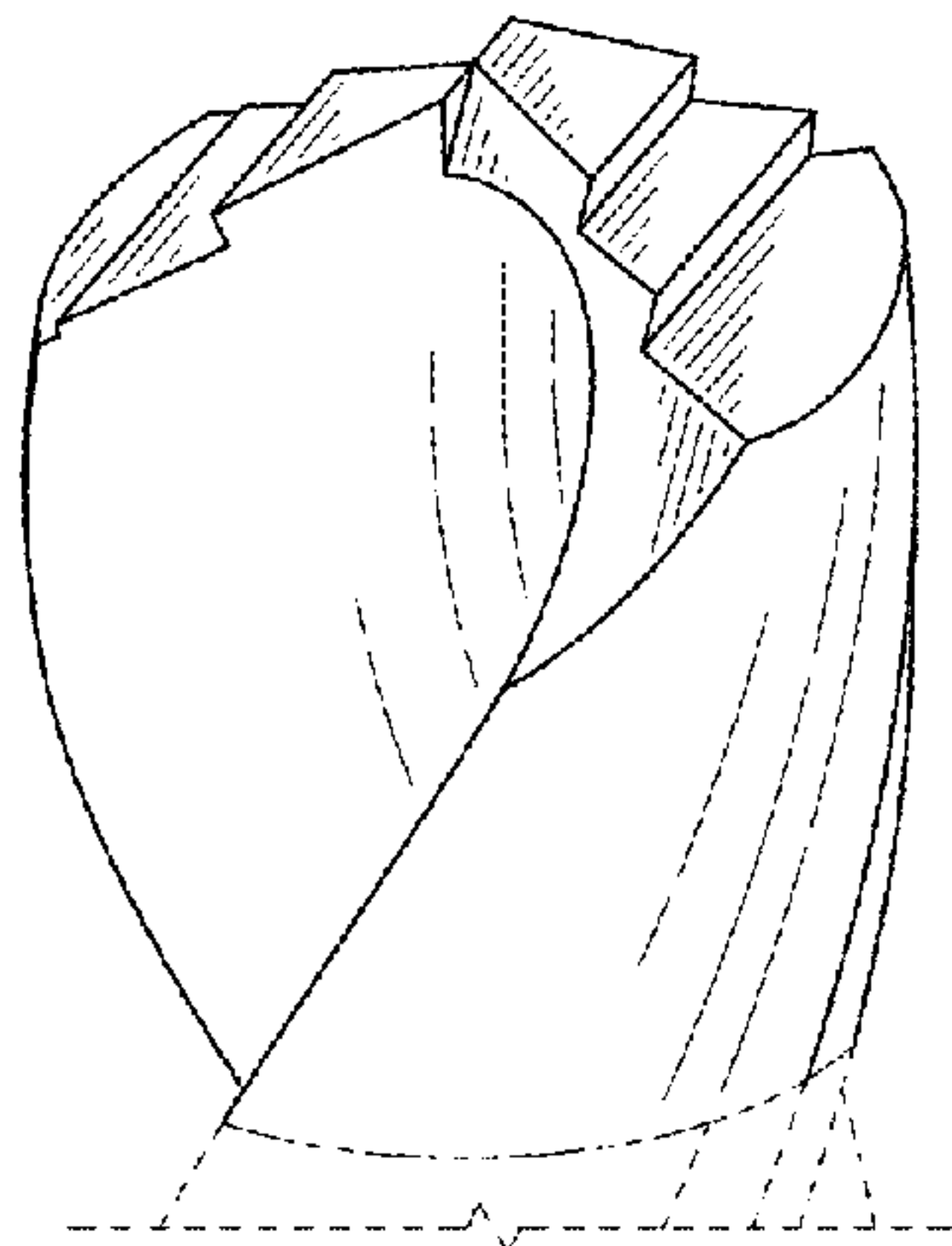
(57) **CLAIM**

The ornamental design for a twisted drill bit tip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a twisted drill bit tip showing our new design;
 FIG. 2 is a front elevation view thereof, to which the rear elevation view is a mirror image;
 FIG. 3 is a right side elevation view thereof, to which the left side elevation view is a mirror image;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is an enlarged perspective view thereof, wherein the area of enlargement is indicated by the reference circle 6 in FIG. 1;
 FIG. 7 is an enlarged front elevation view thereof, wherein the area of enlargement is indicated by the reference circle 7 in FIG. 2; and,
 FIG. 8 is an enlarged right side elevation view thereof, wherein the area of enlargement is indicated by the reference circle 8 in FIG. 3.
 The dash-dot-dot-dash broken line, of which forms no part of the claimed design, is provided to define the boundary of the claimed design. The even broken line showing of the drill bit is provided for the purpose of illustrating environmental structure and forms no part of the claimed design.

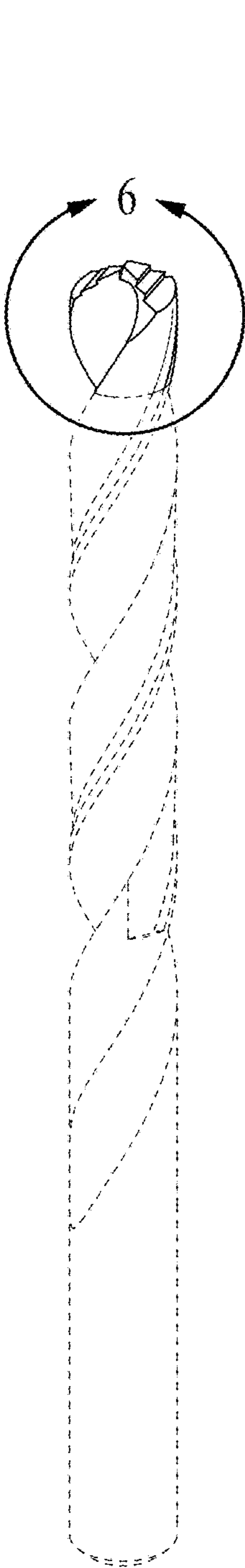

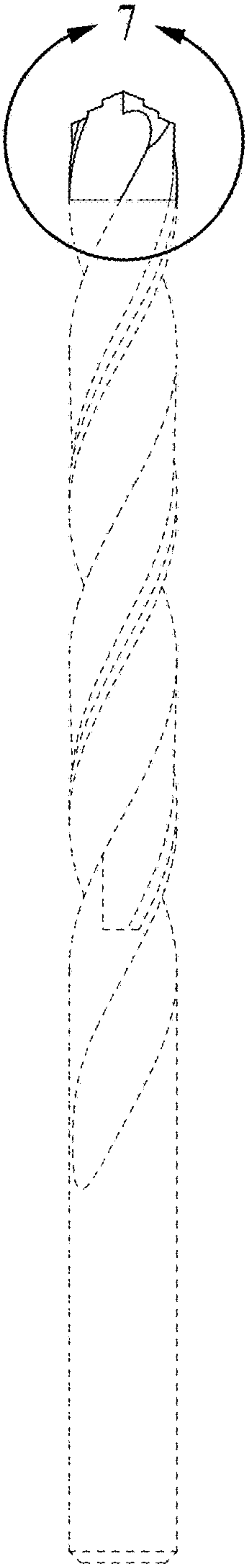

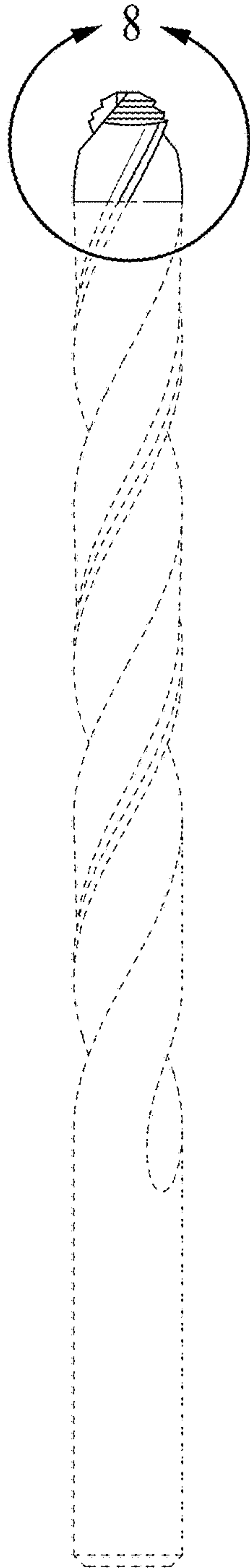

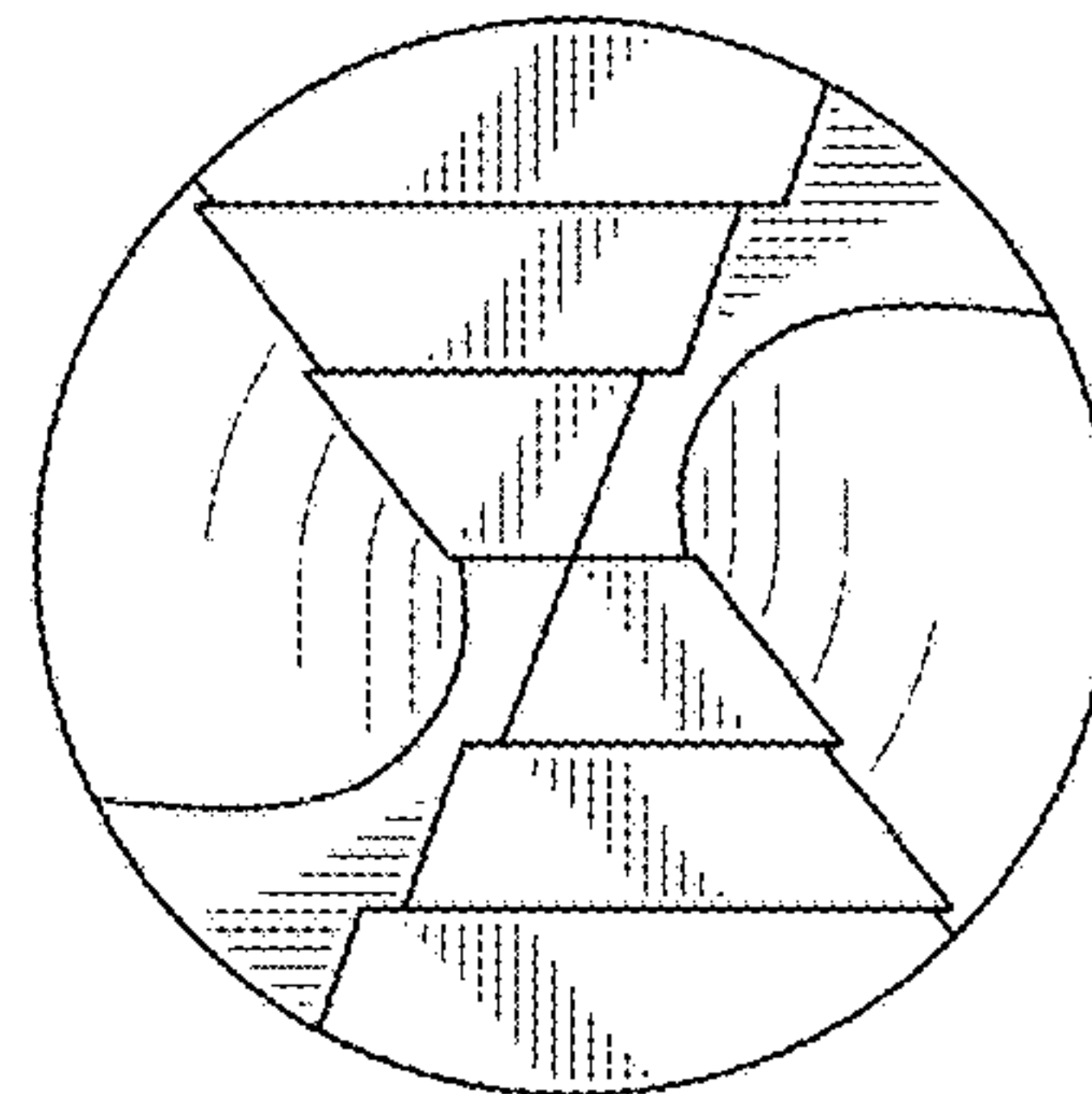

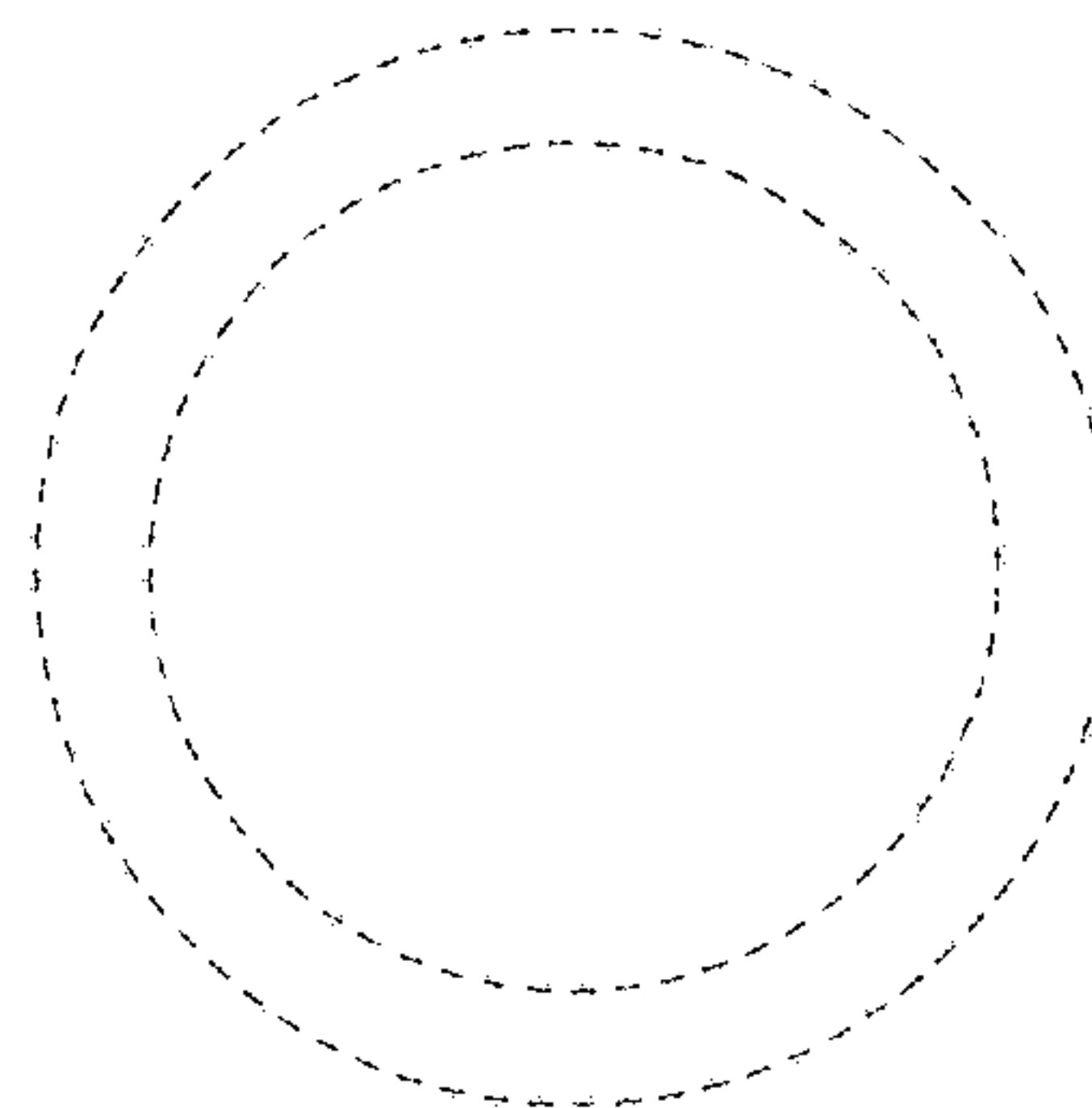

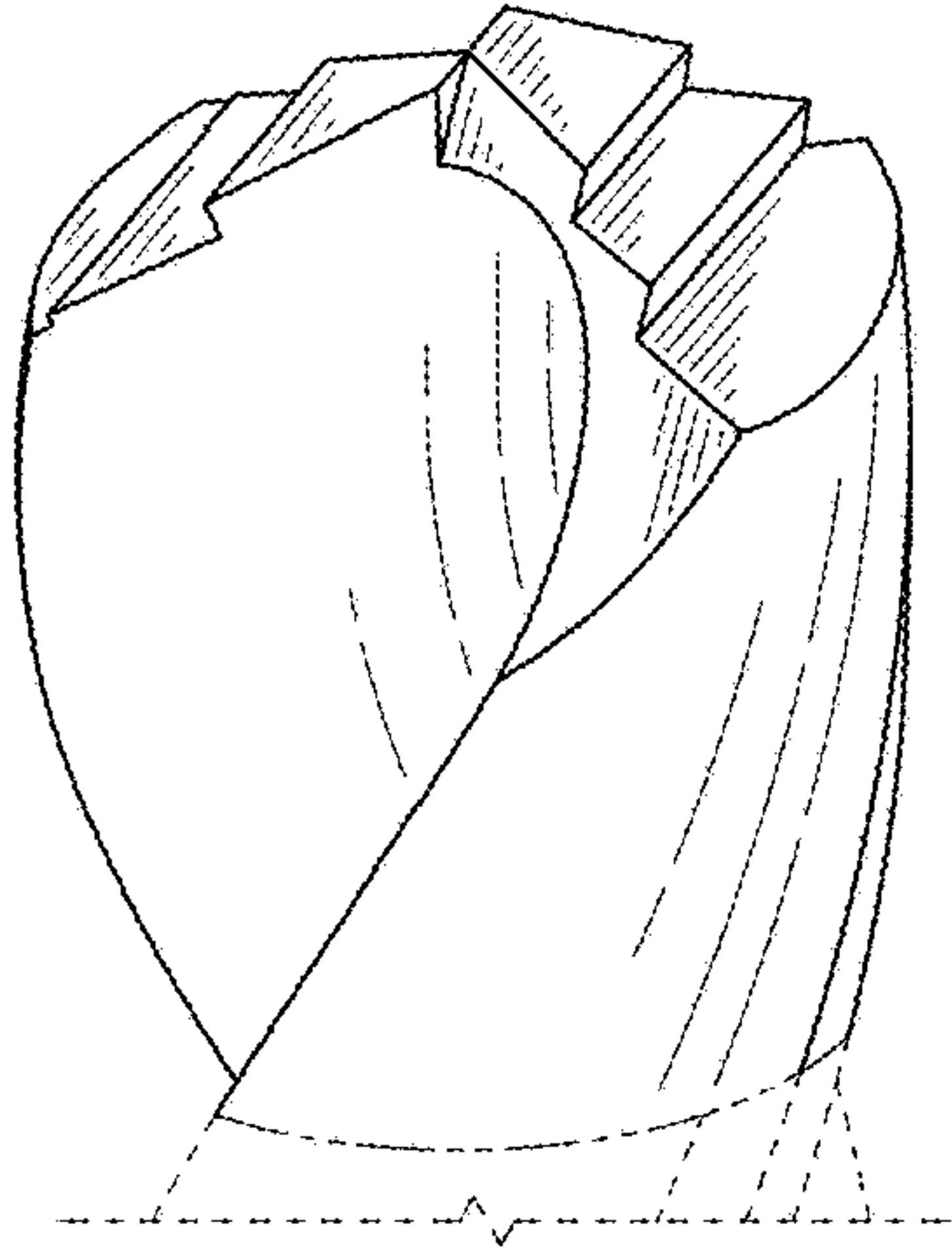

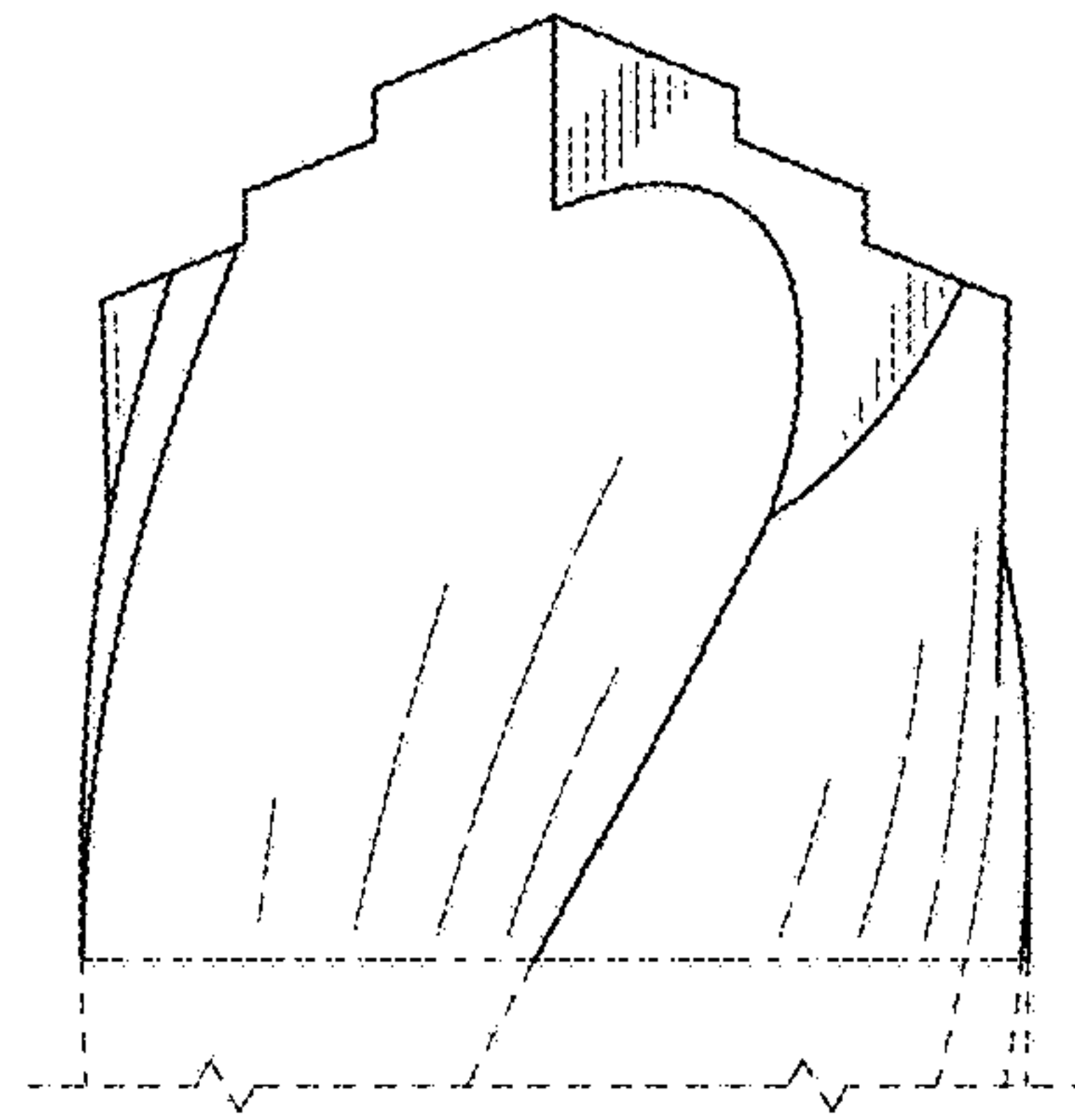

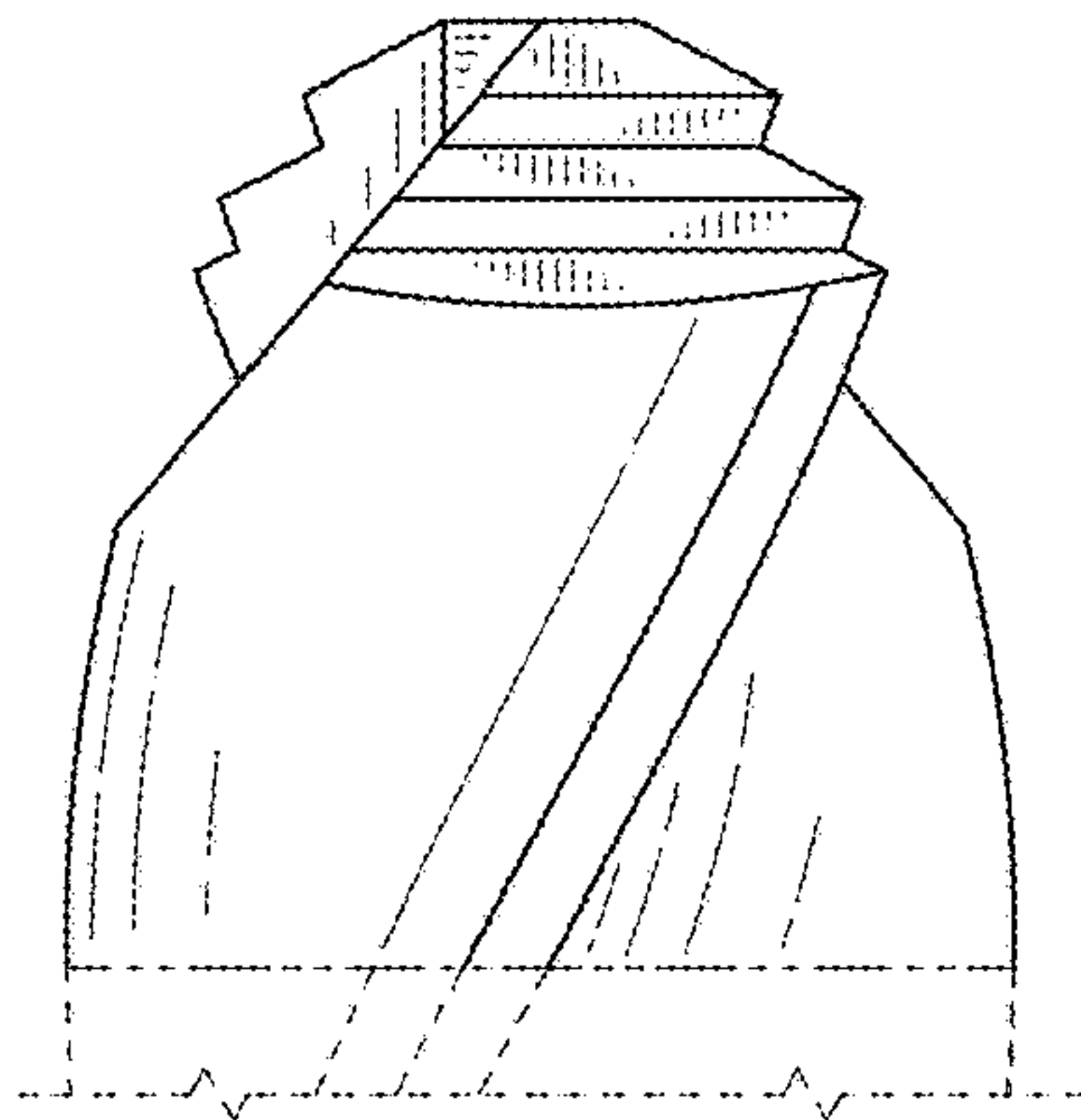
