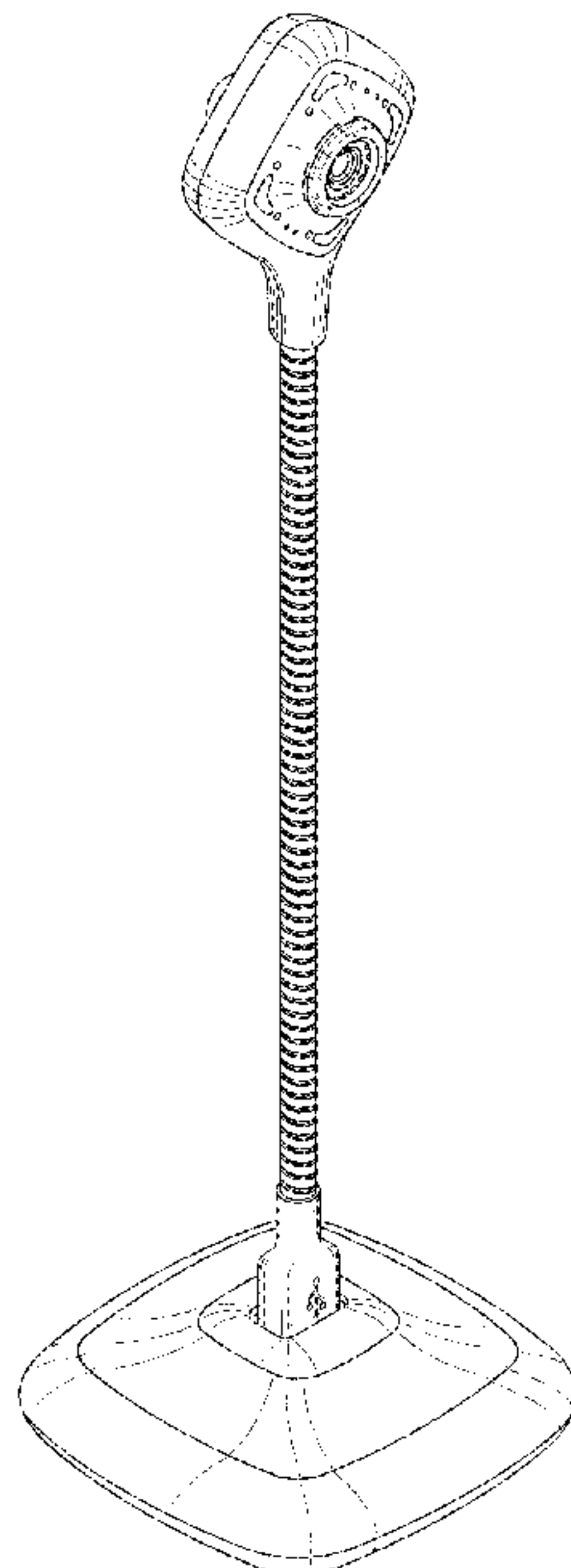
FIG. 1 is a front and right side perspective view of a web camera;

FIG. 6 is a top plan view thereof.

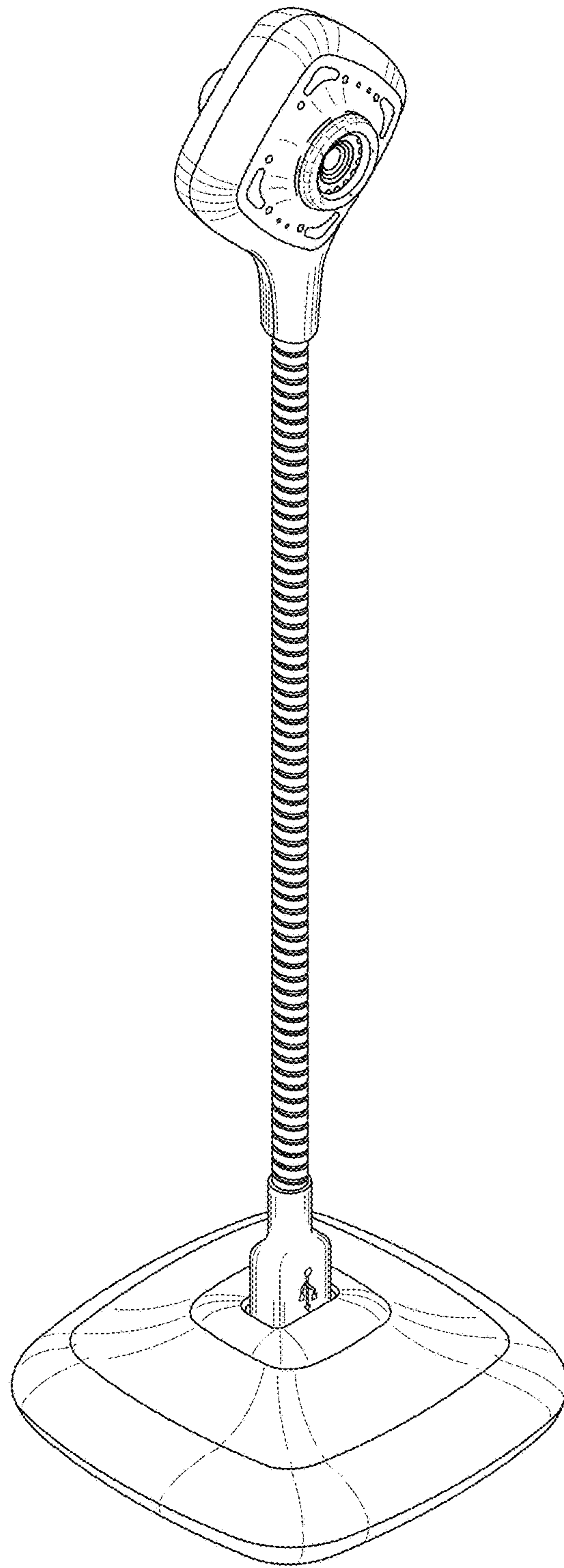

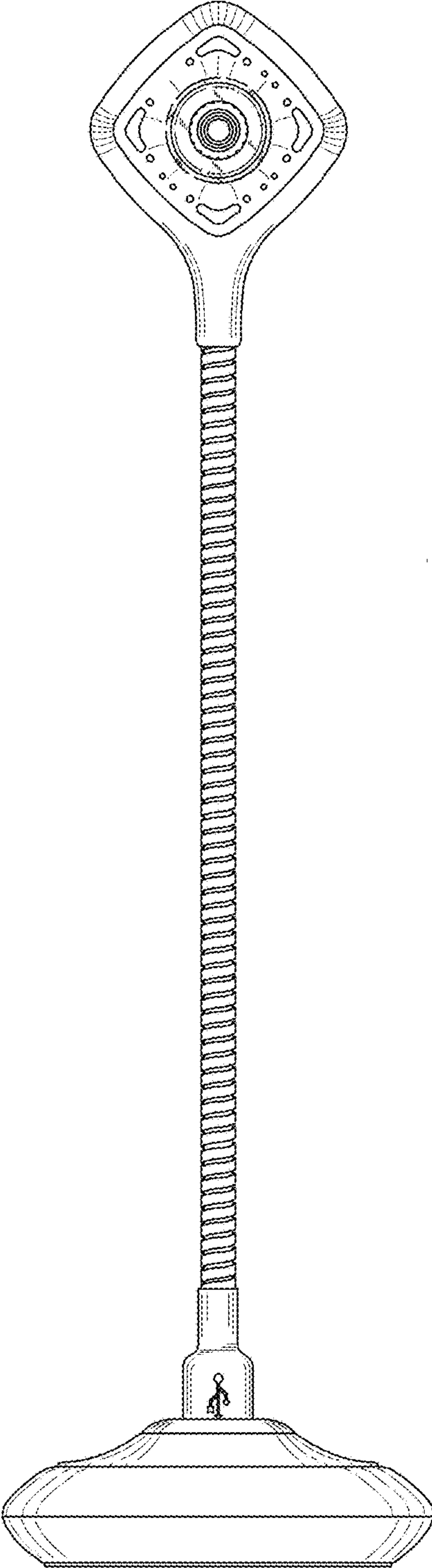
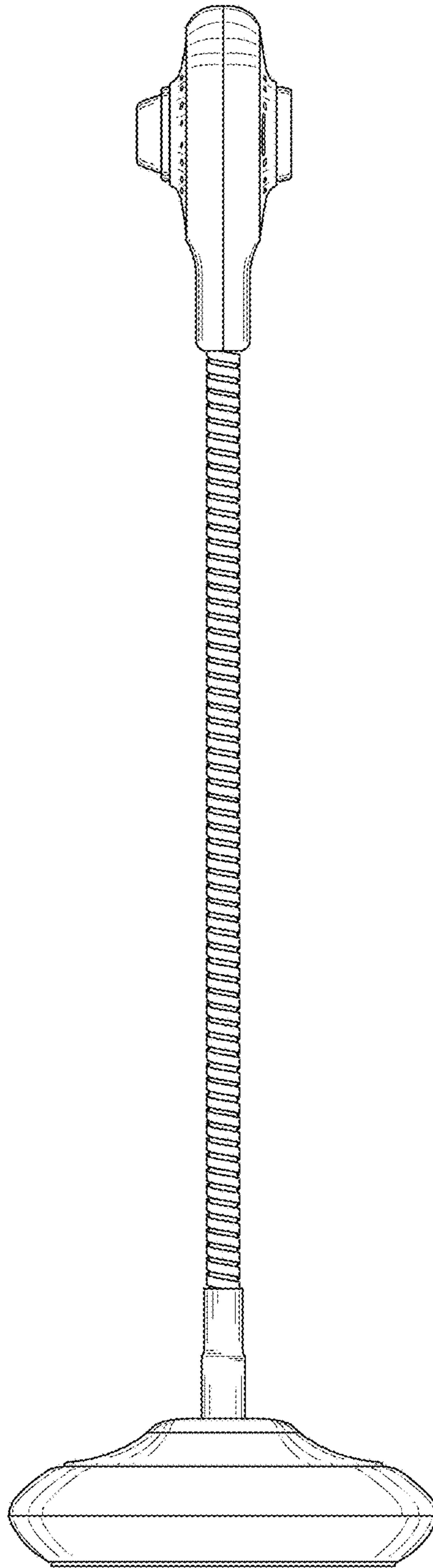
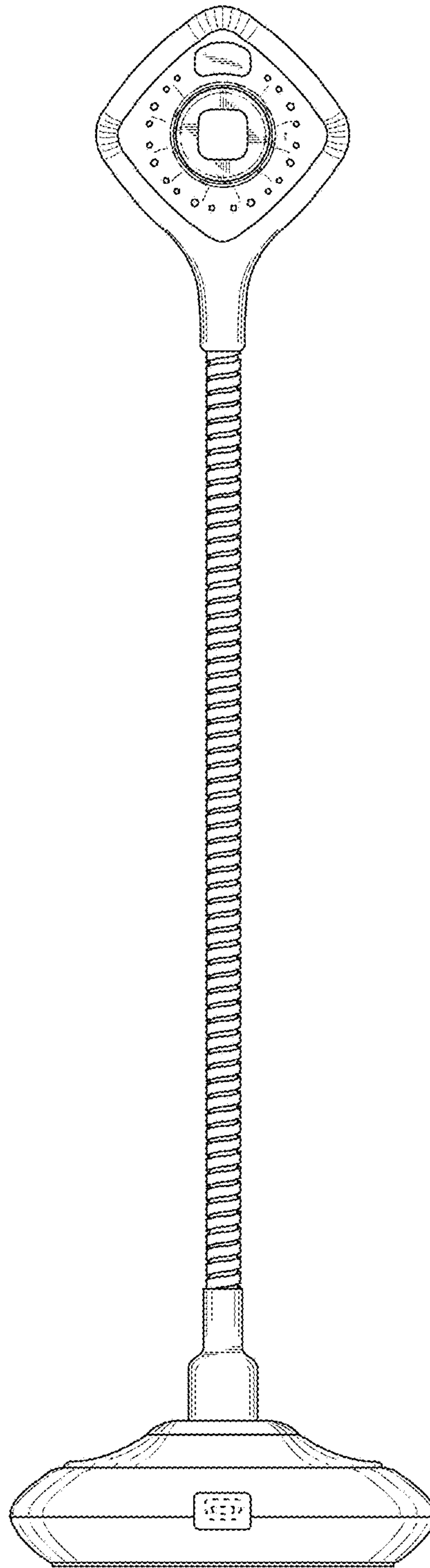


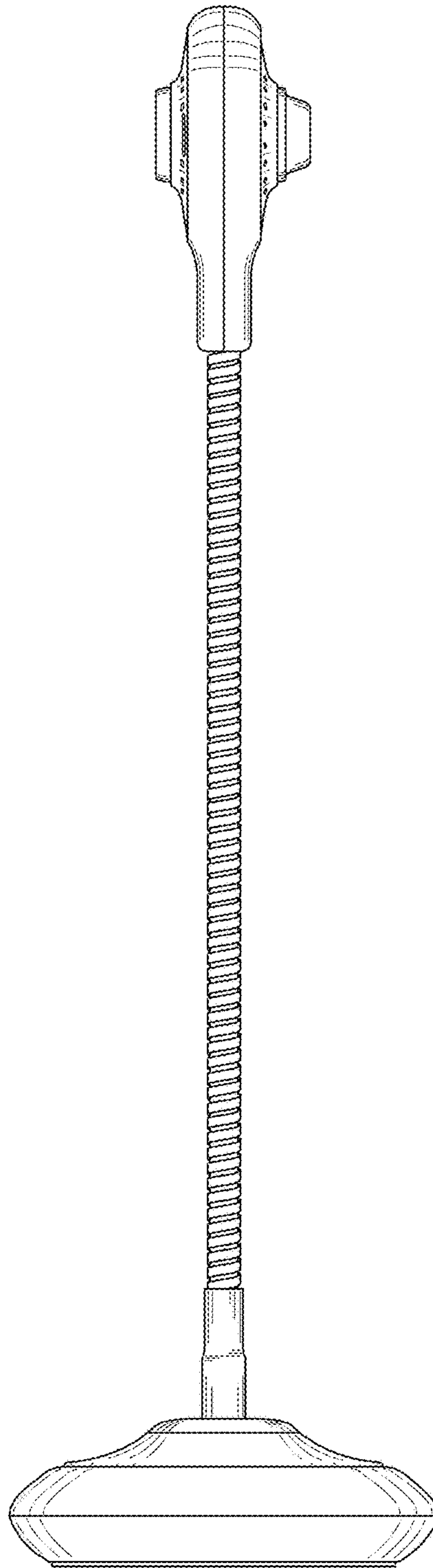

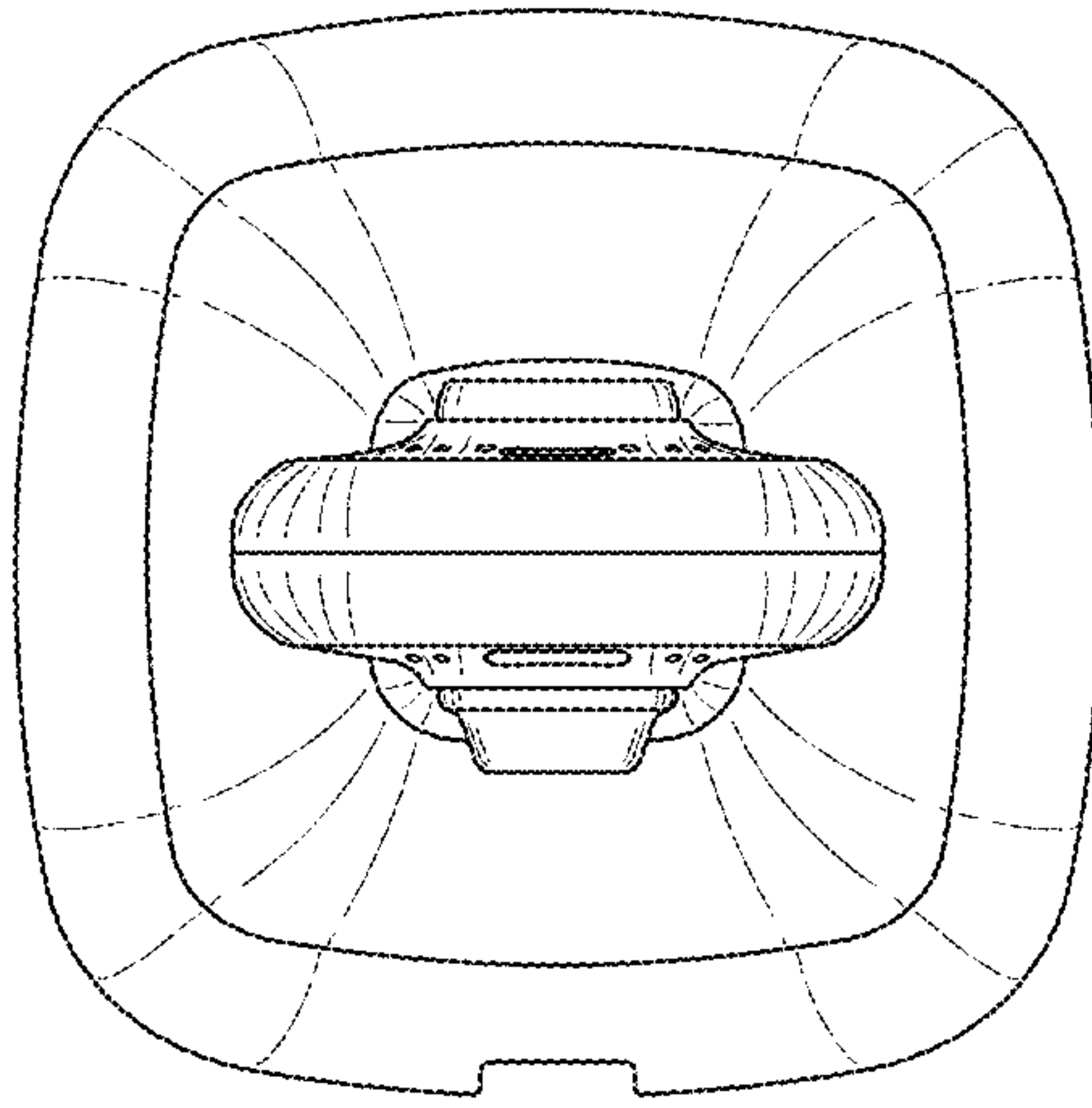
