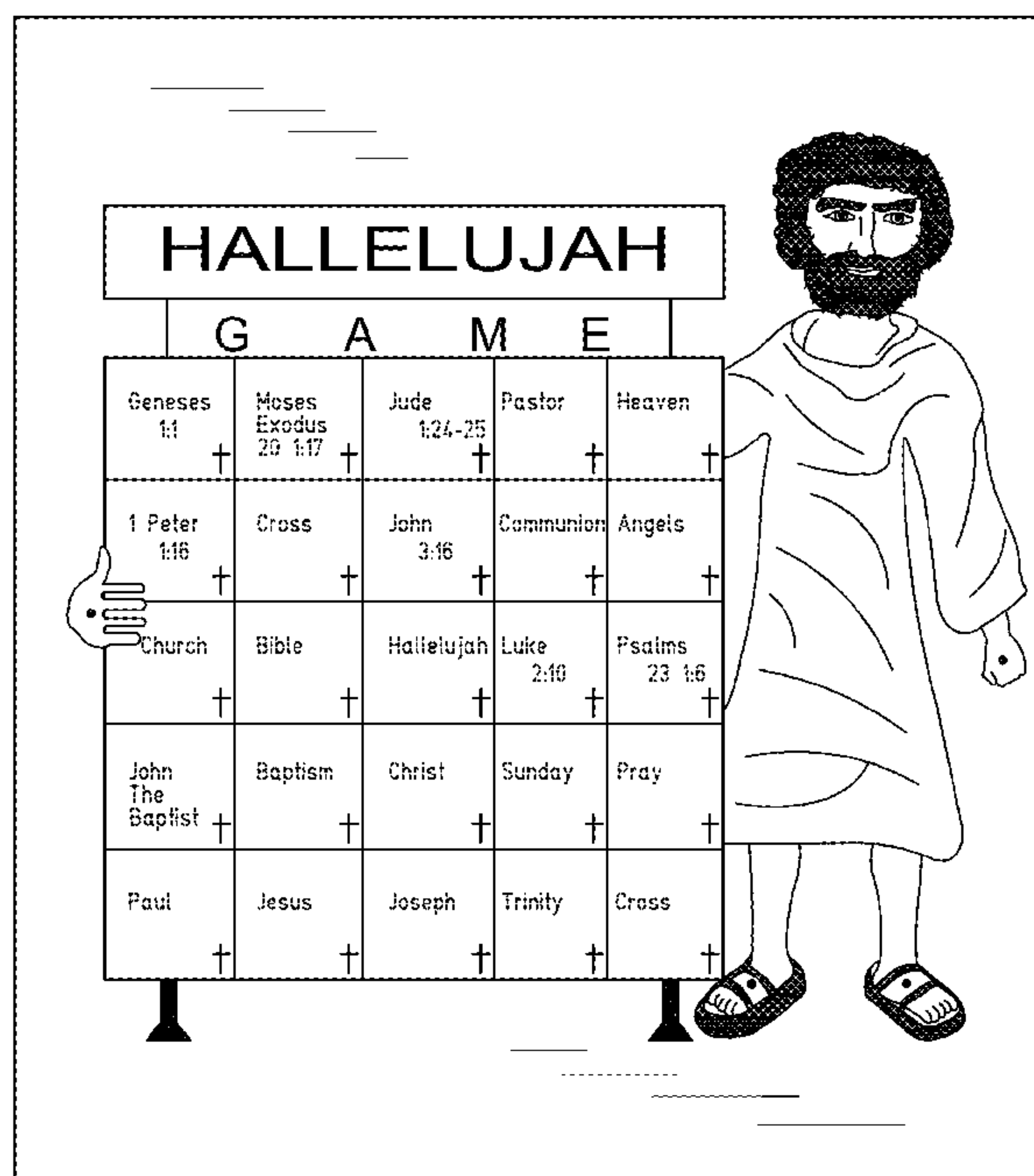
The ornamental design for a game card, as shown and described.

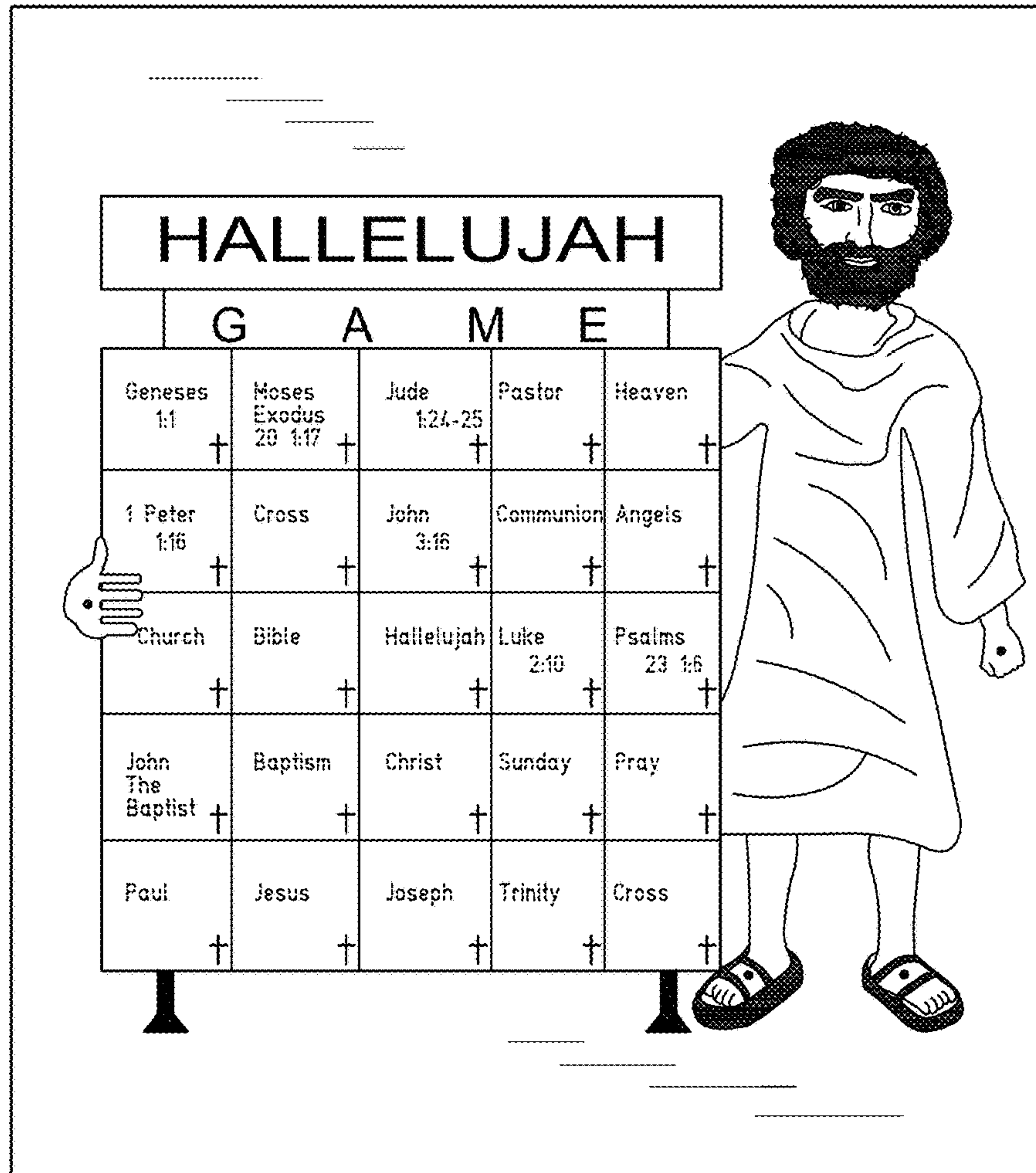

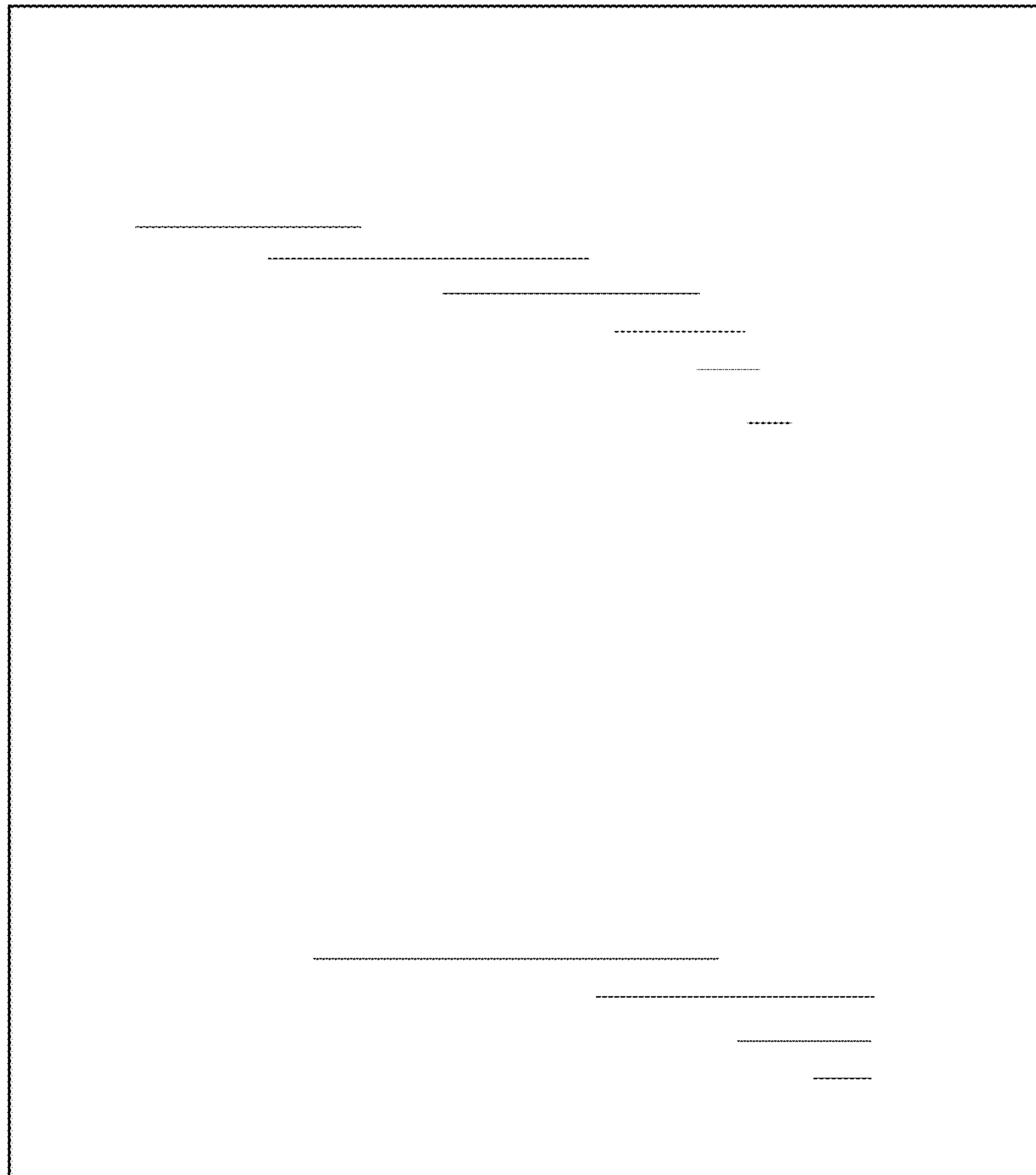

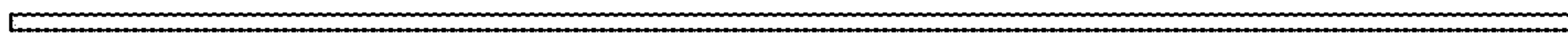
