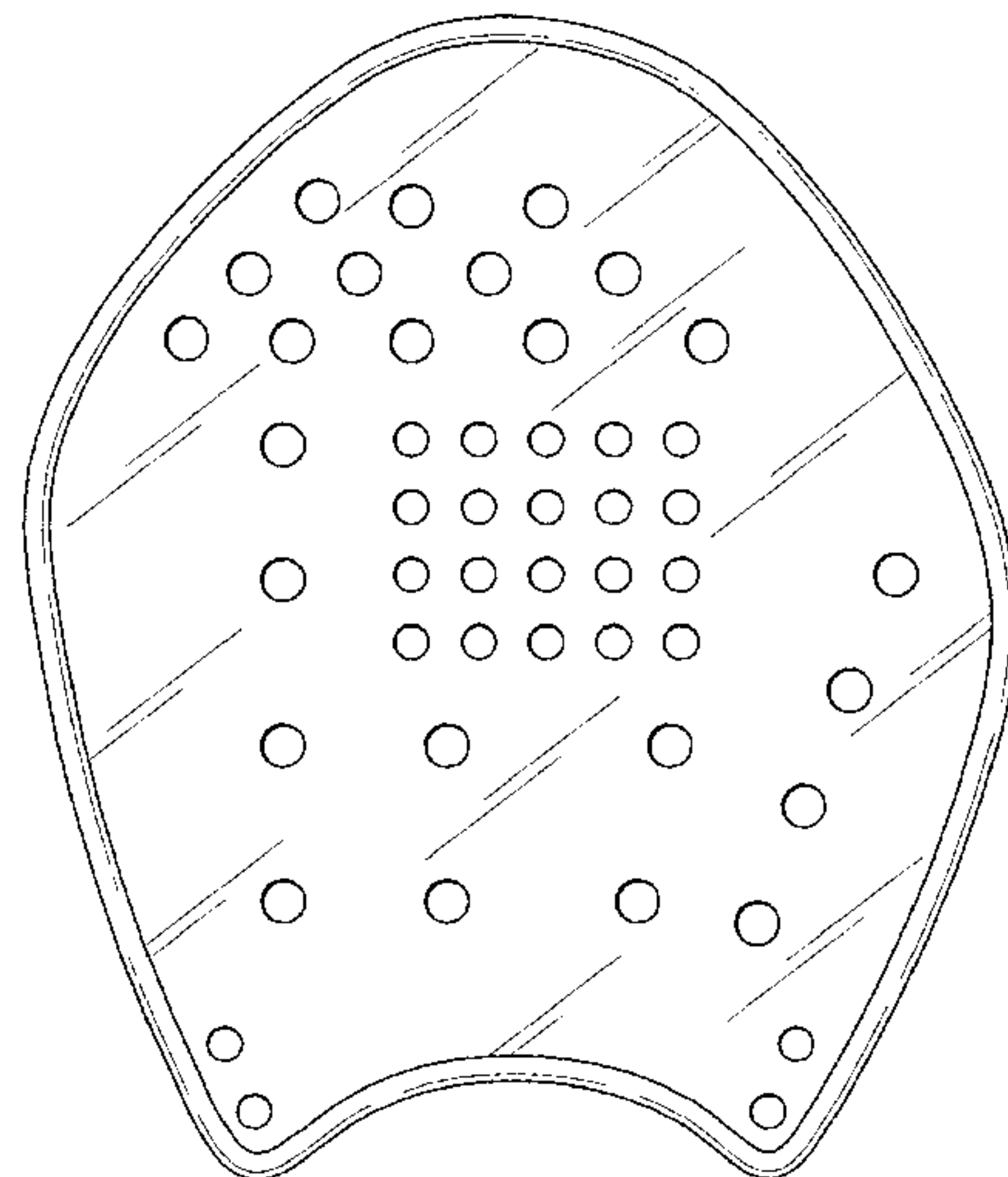
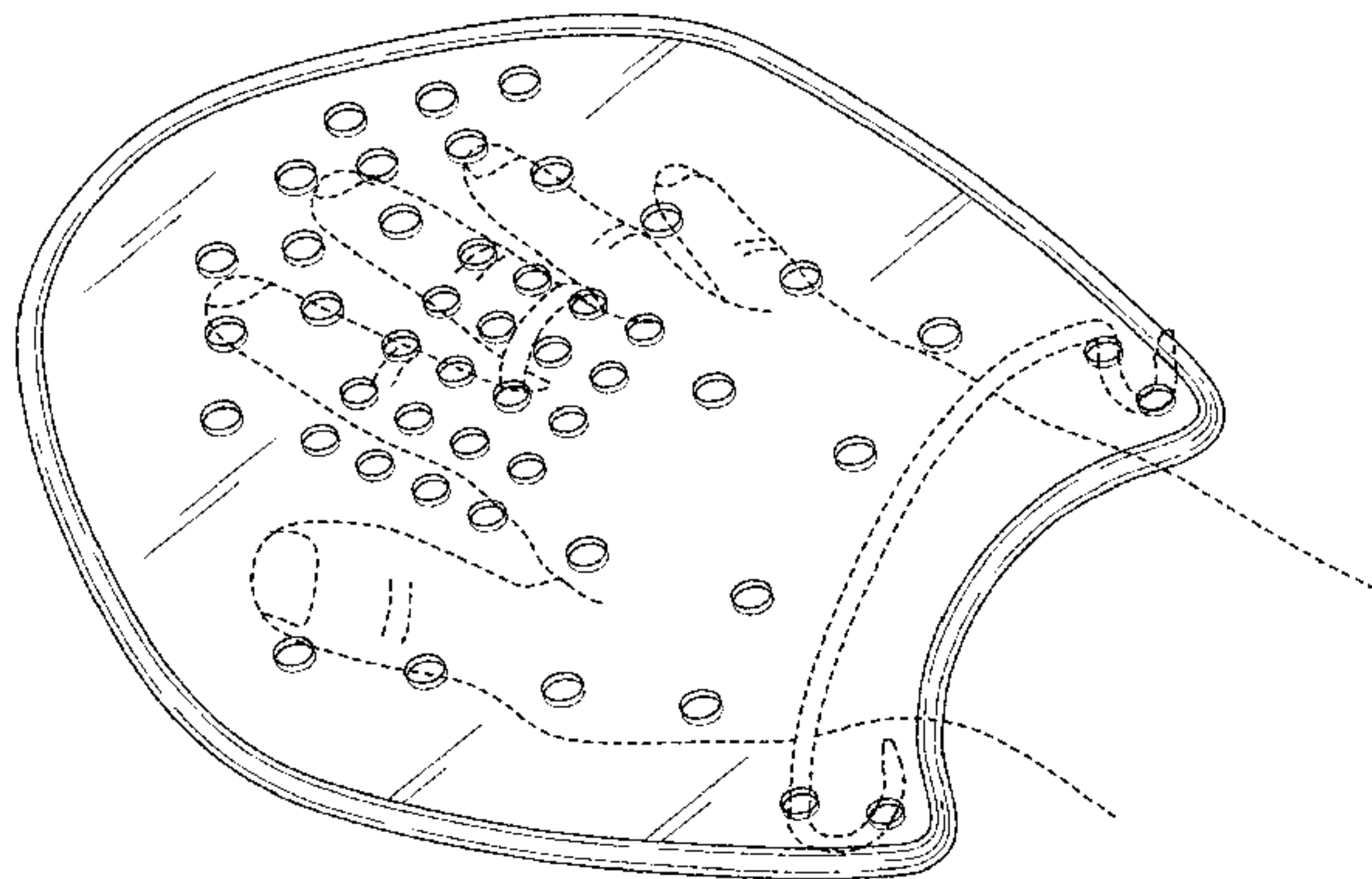
(57) **CLAIM**

The ornamental design for a swim paddle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the swim paddle of the present invention showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a front end view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a rear end view thereof. The dotted lines shown in the figures are for environmental structure and form no part of the claimed design.

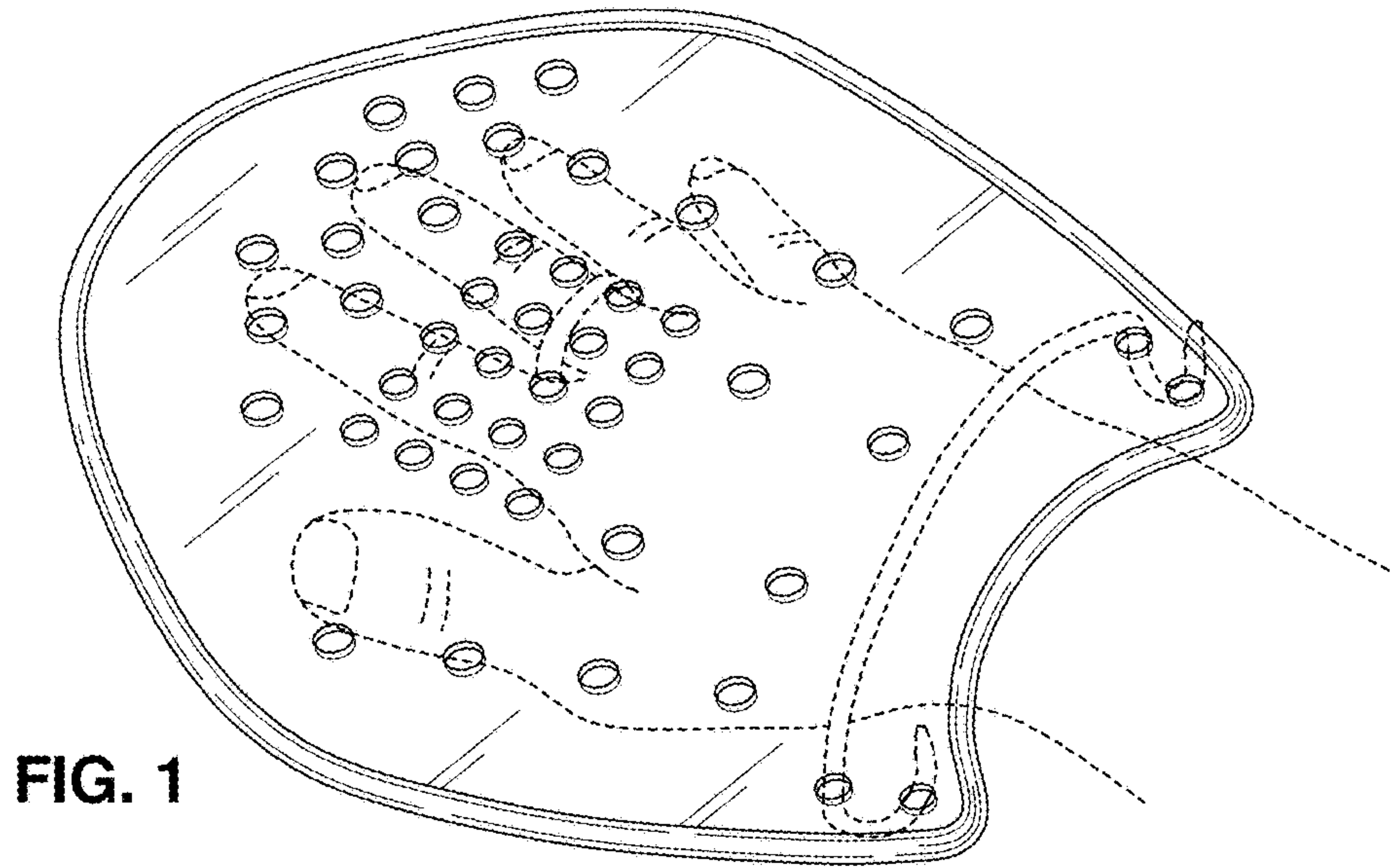

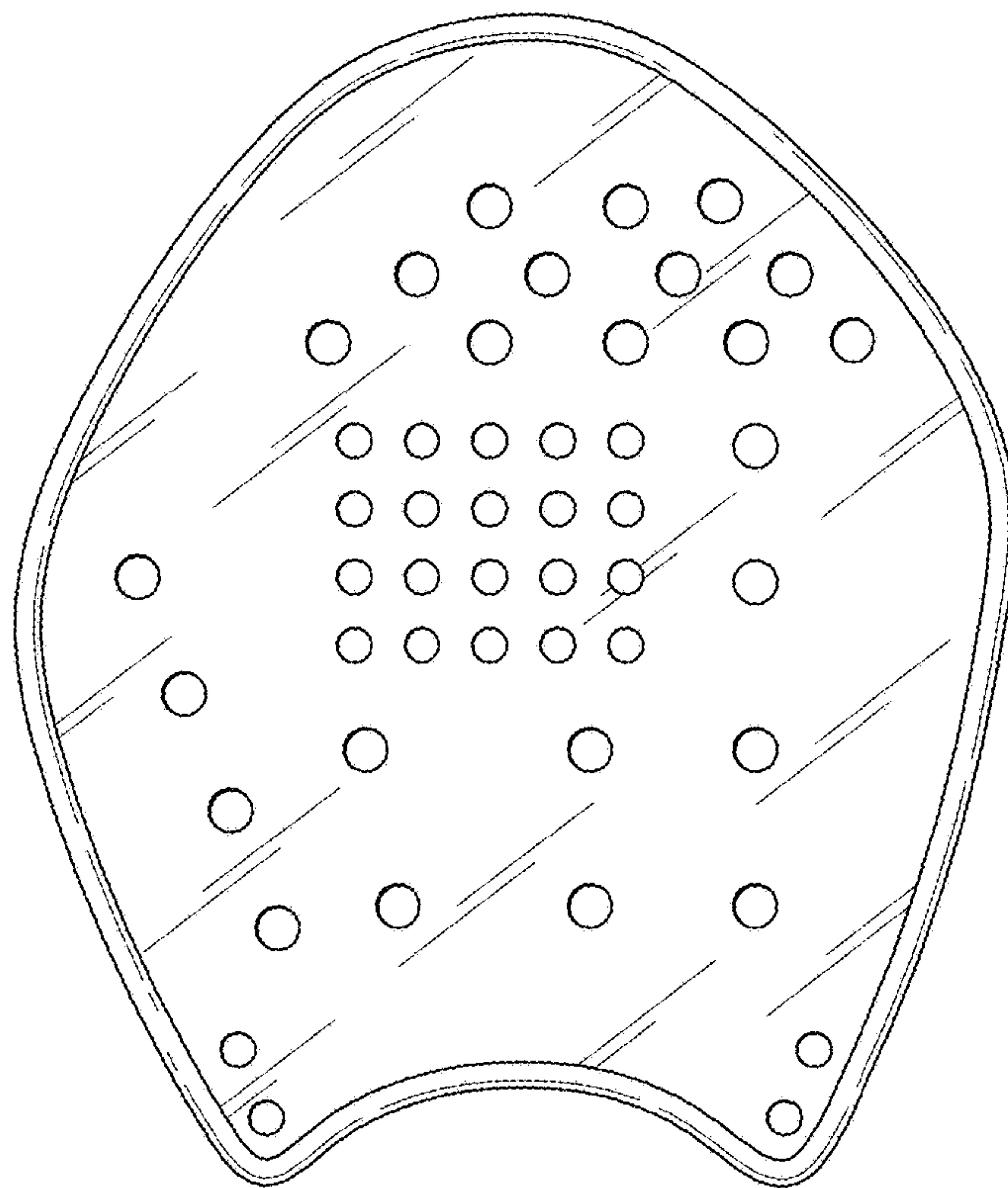

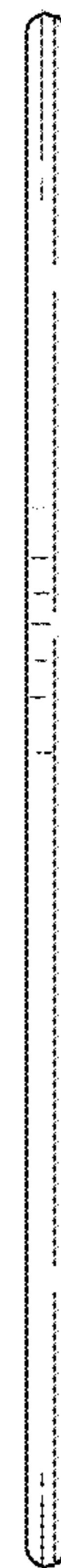

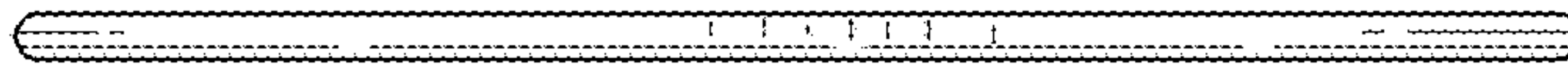

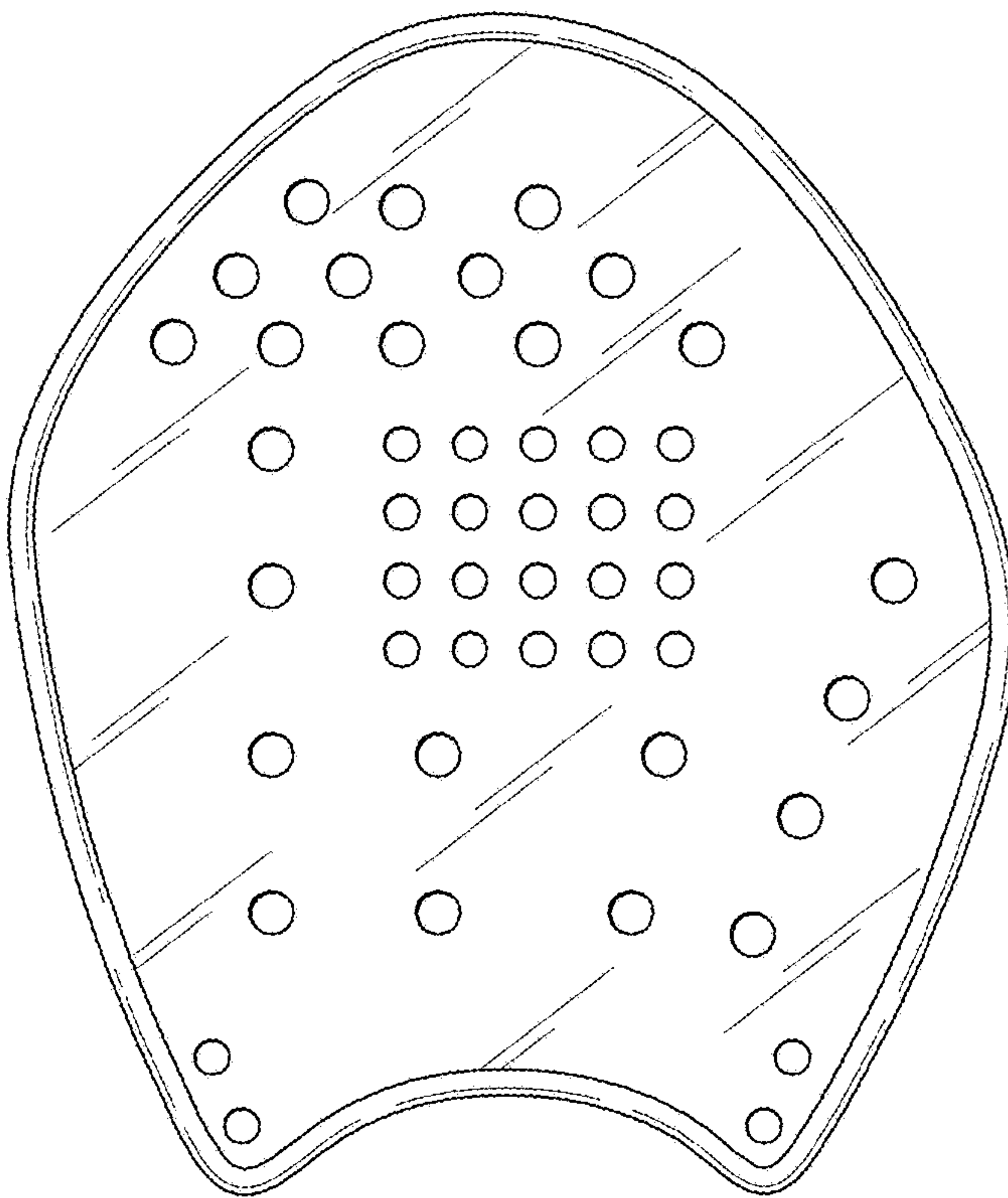

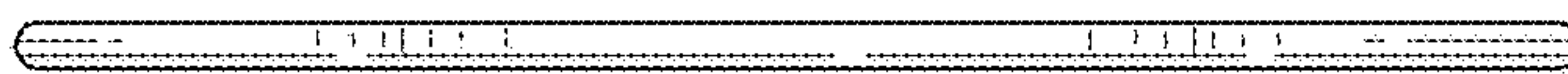
