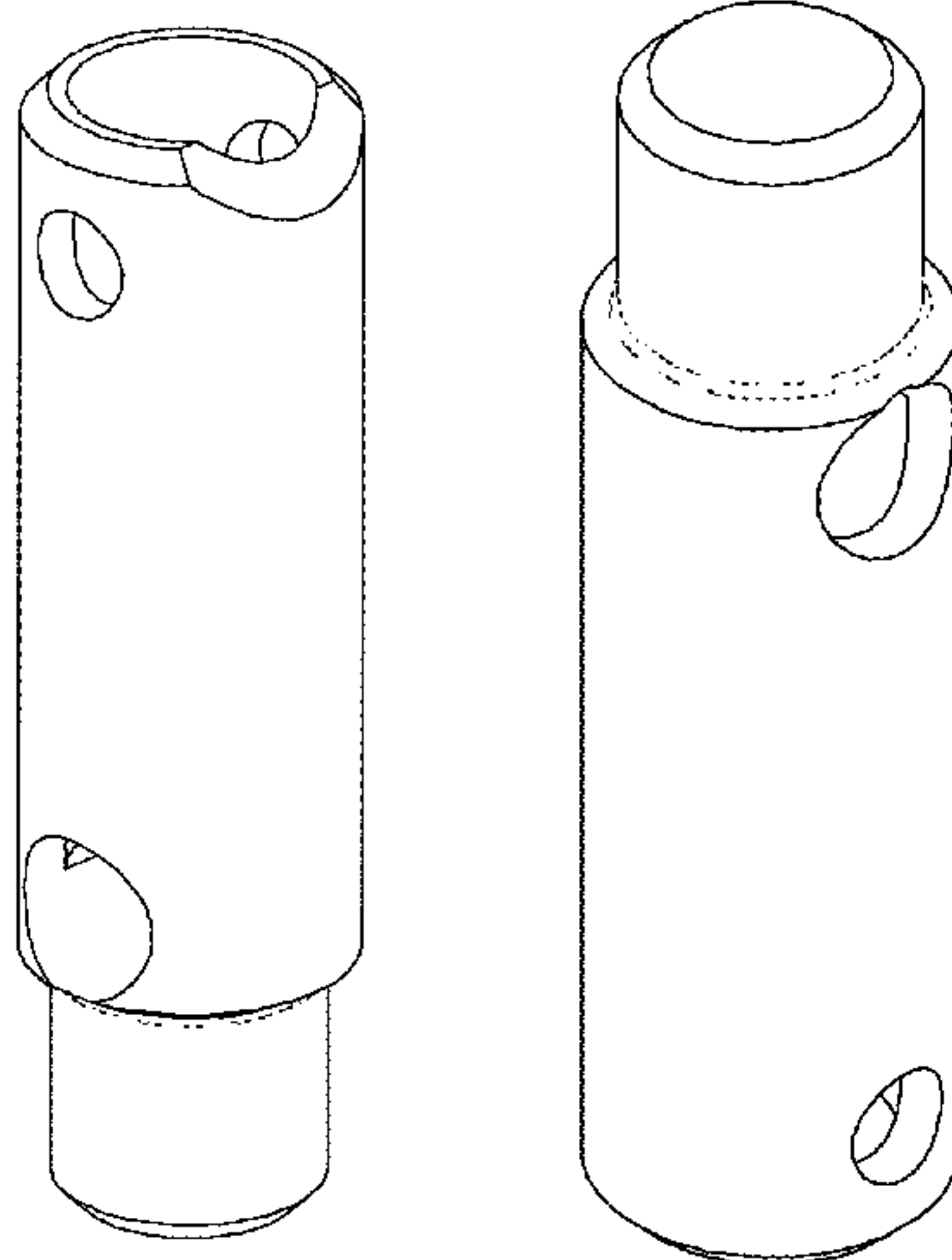
(57) **CLAIM**

The ornamental design for a collapsible pin for firearm stocks, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a collapsible pin of the invention; FIG. 2 is another side view thereof; FIG. 3 is an enlarged top view thereof; FIG. 4 is an enlarged bottom view thereof; FIG. 5 is another side view thereof; FIG. 6 is a view of the cross-section along the line 6-6 in FIG. 5; FIG. 7 is a perspective view of the pin in an upside-down position; and, FIG. 8 is a perspective view of the pin.

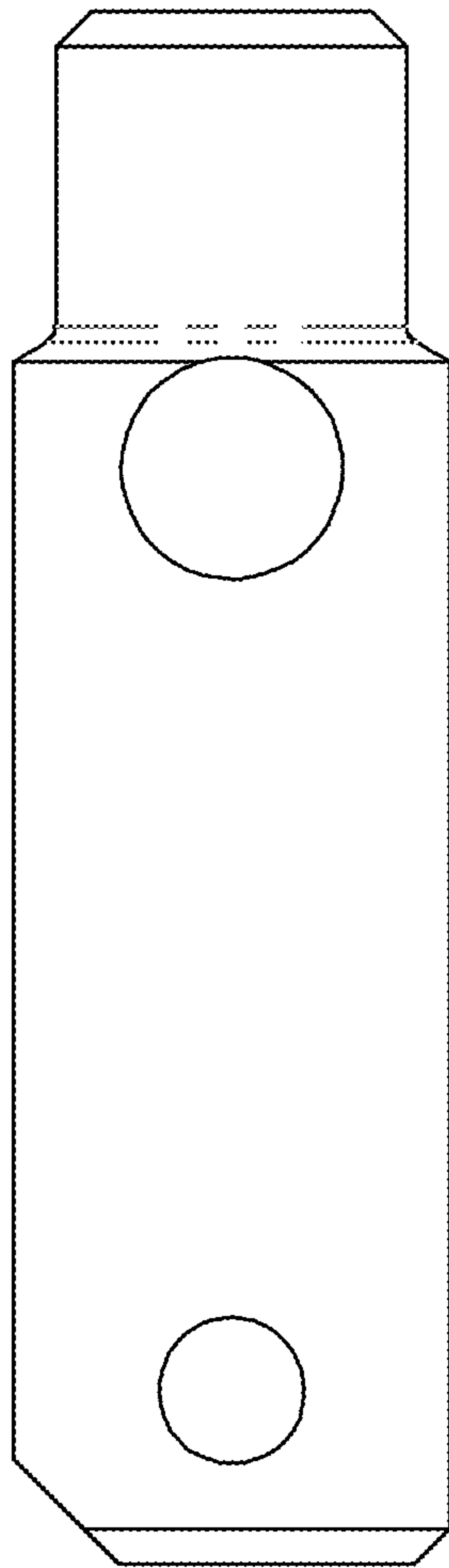

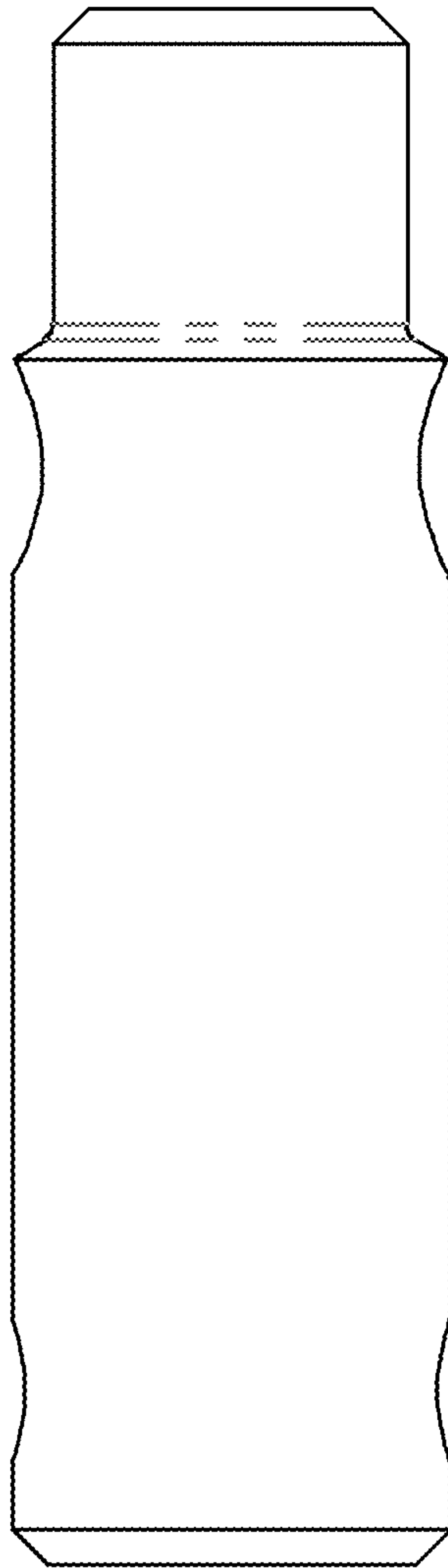

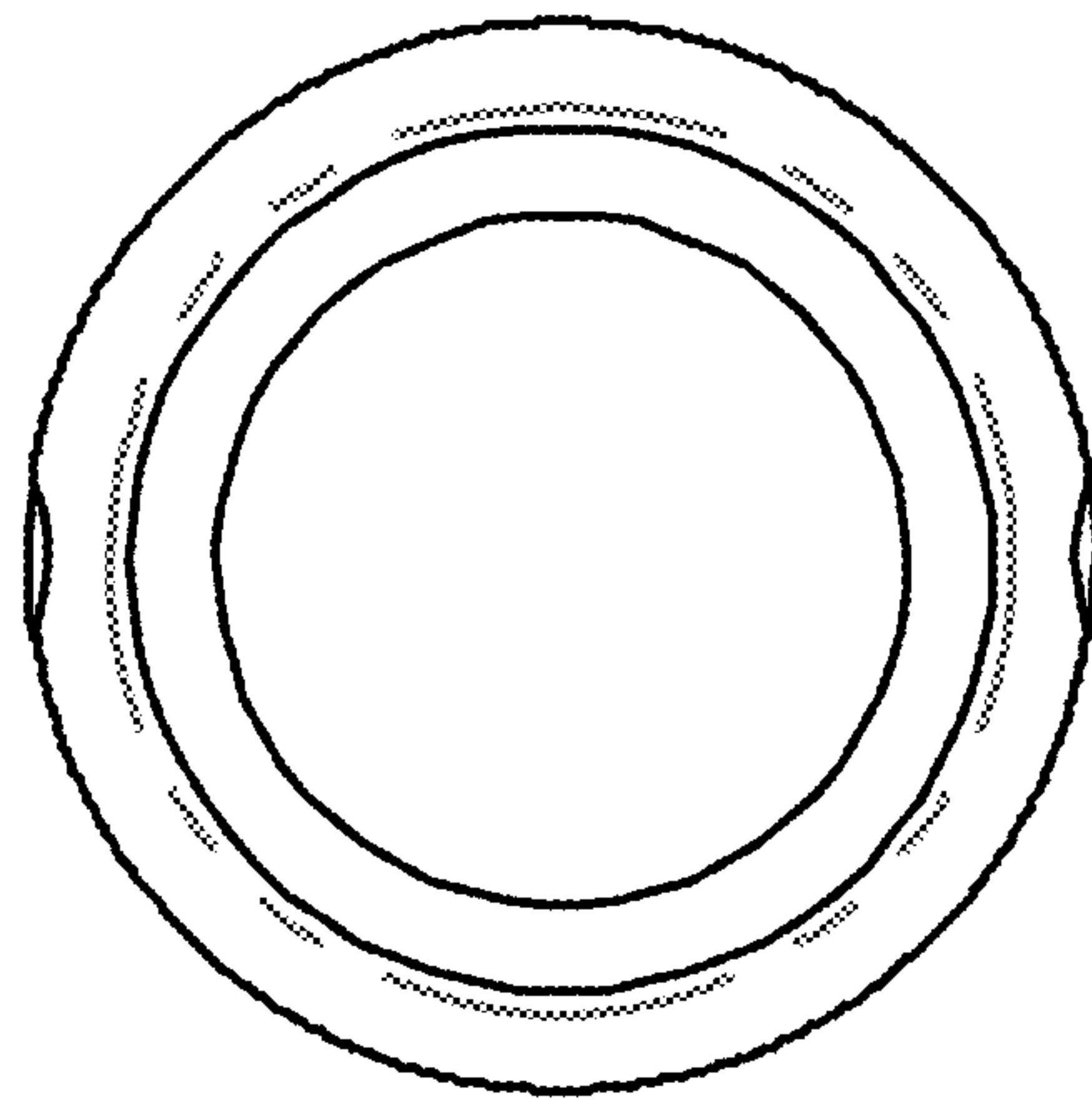

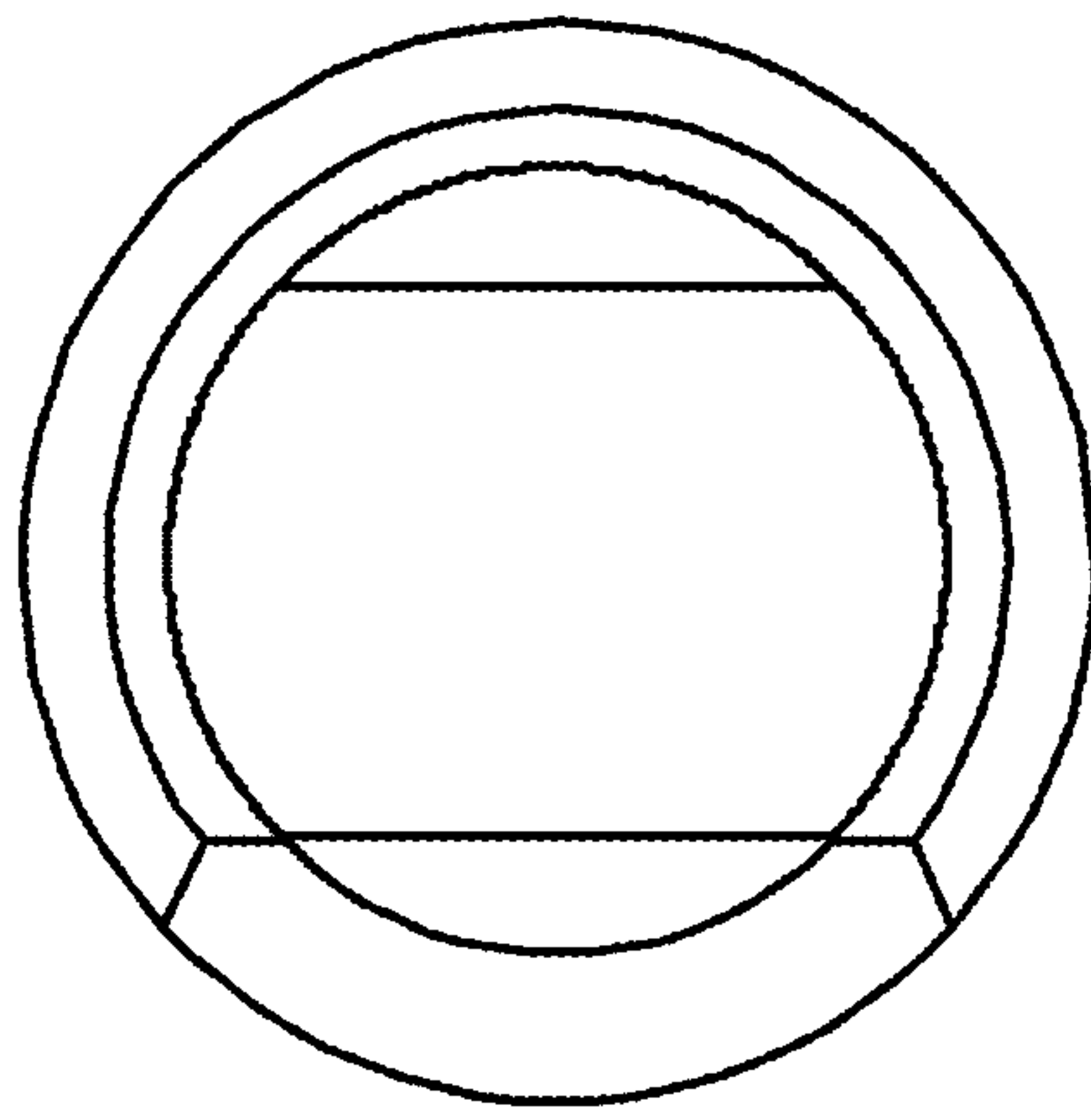

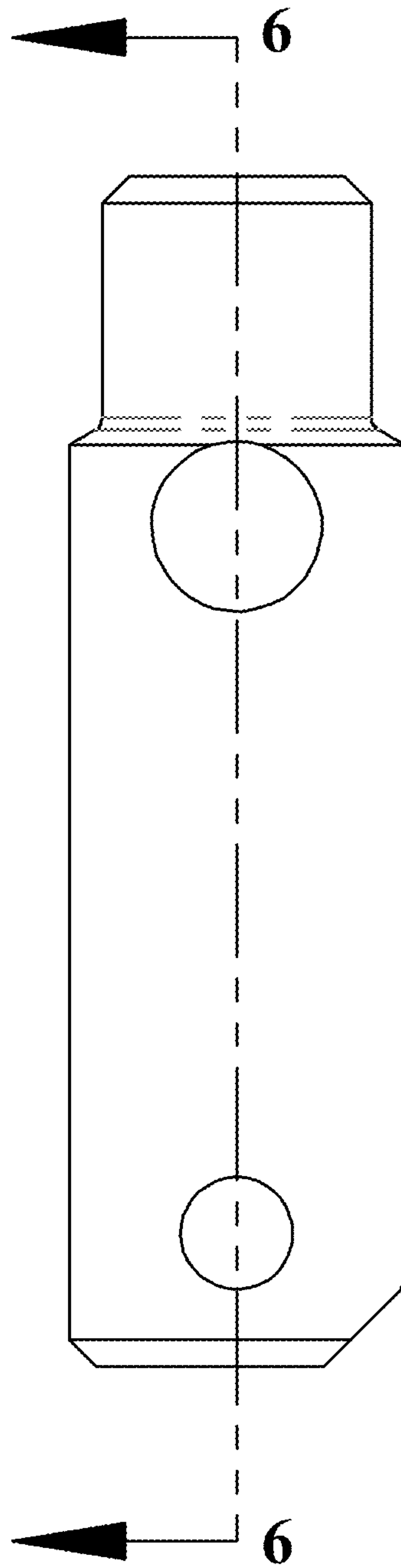

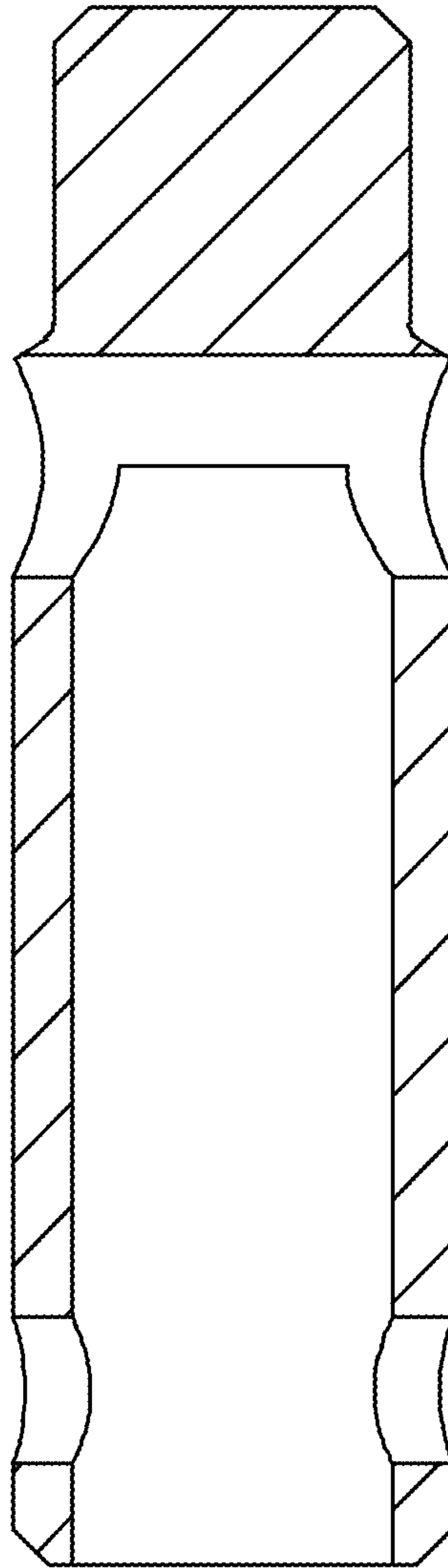

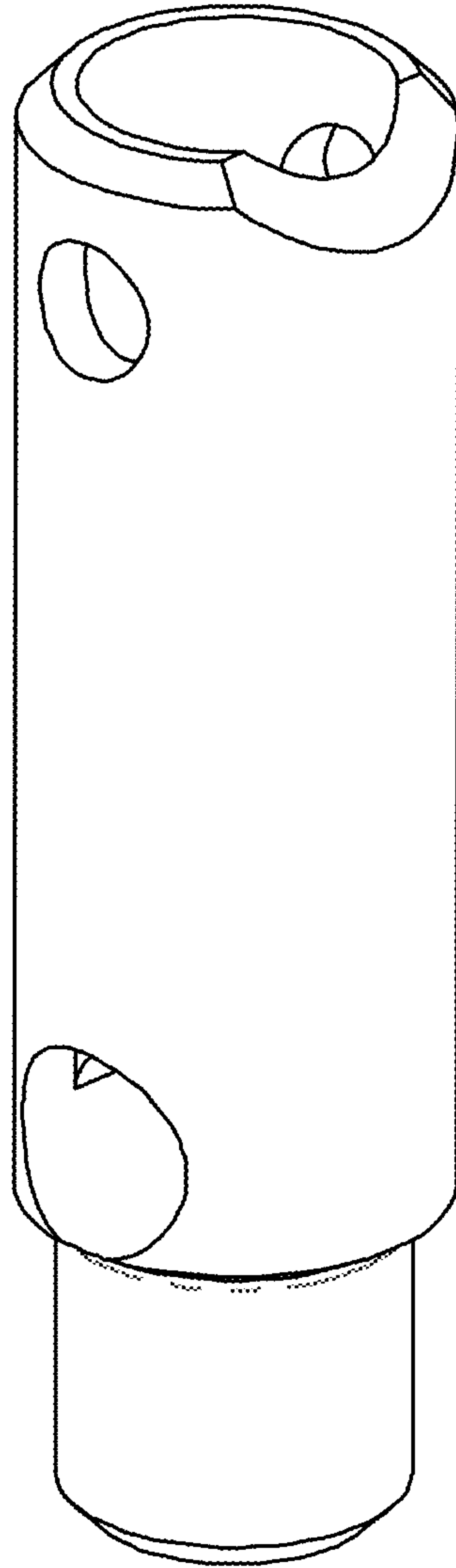

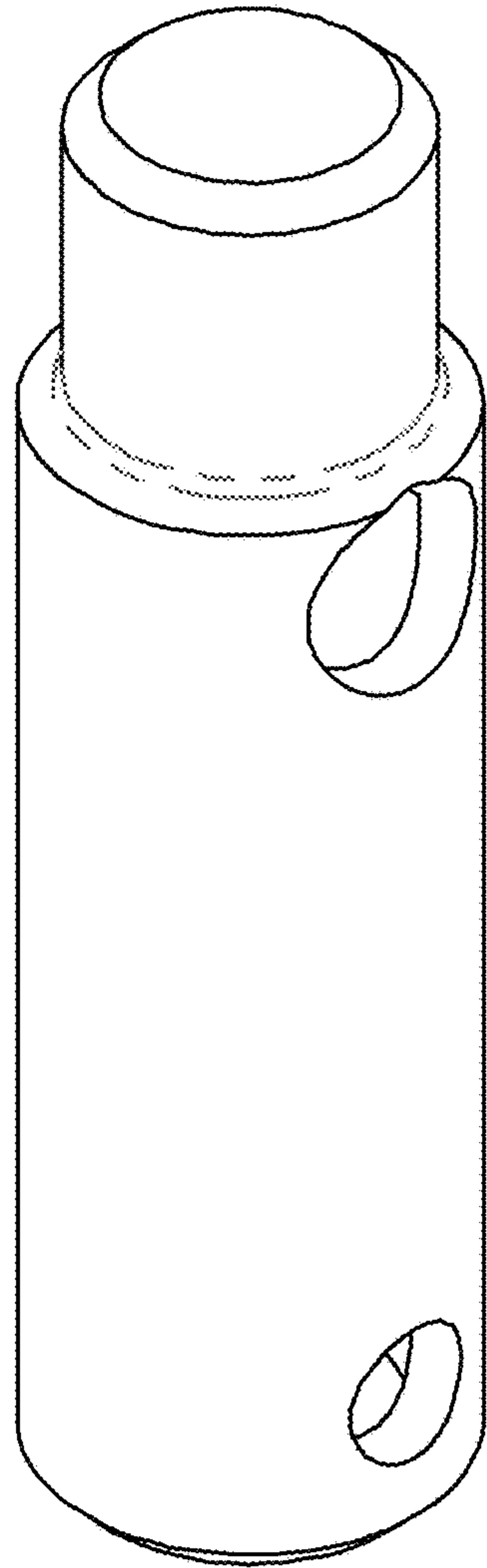
