FIG. 1.

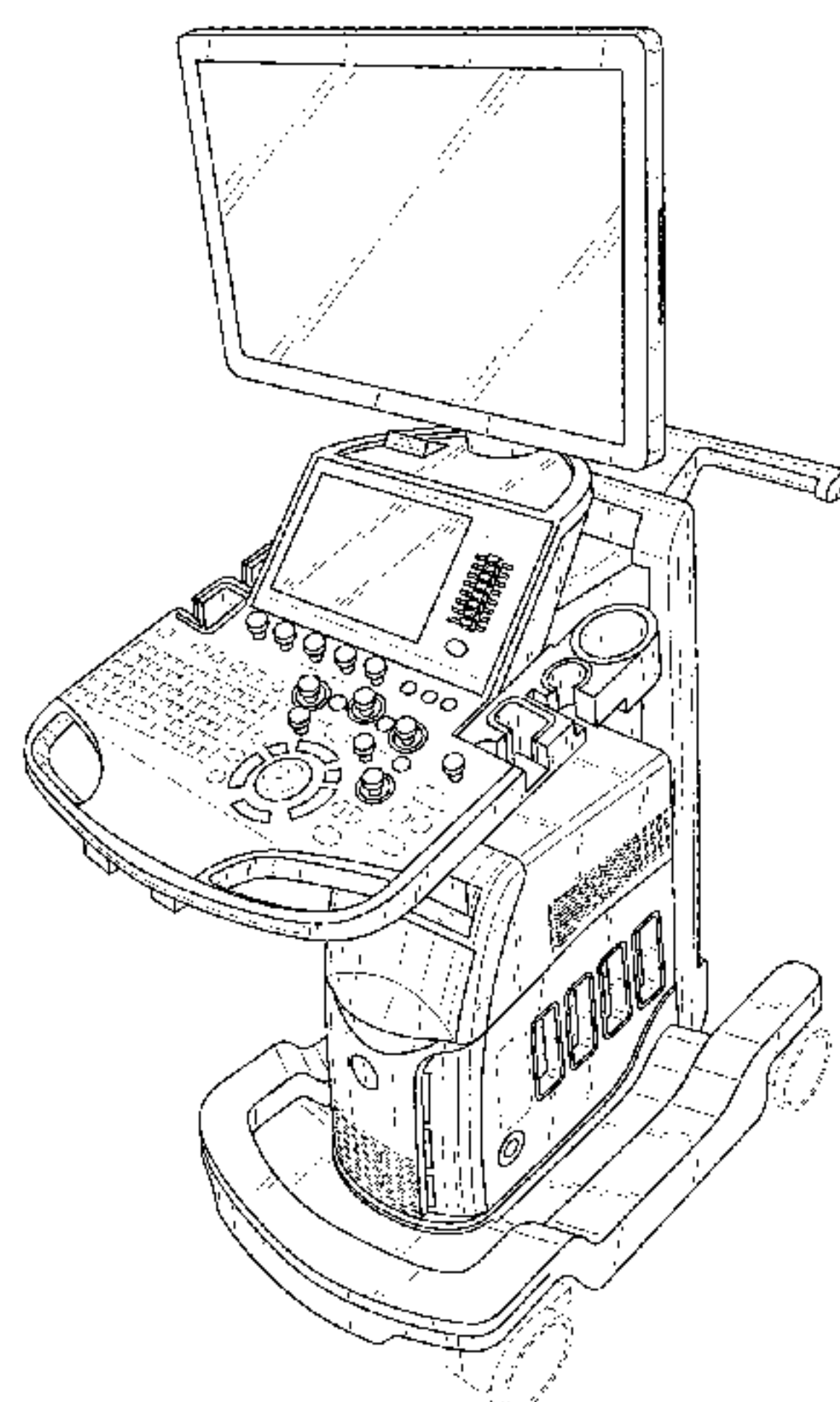
FIG. 6 is a bottom view of the ultrasonic diagnosis apparatus

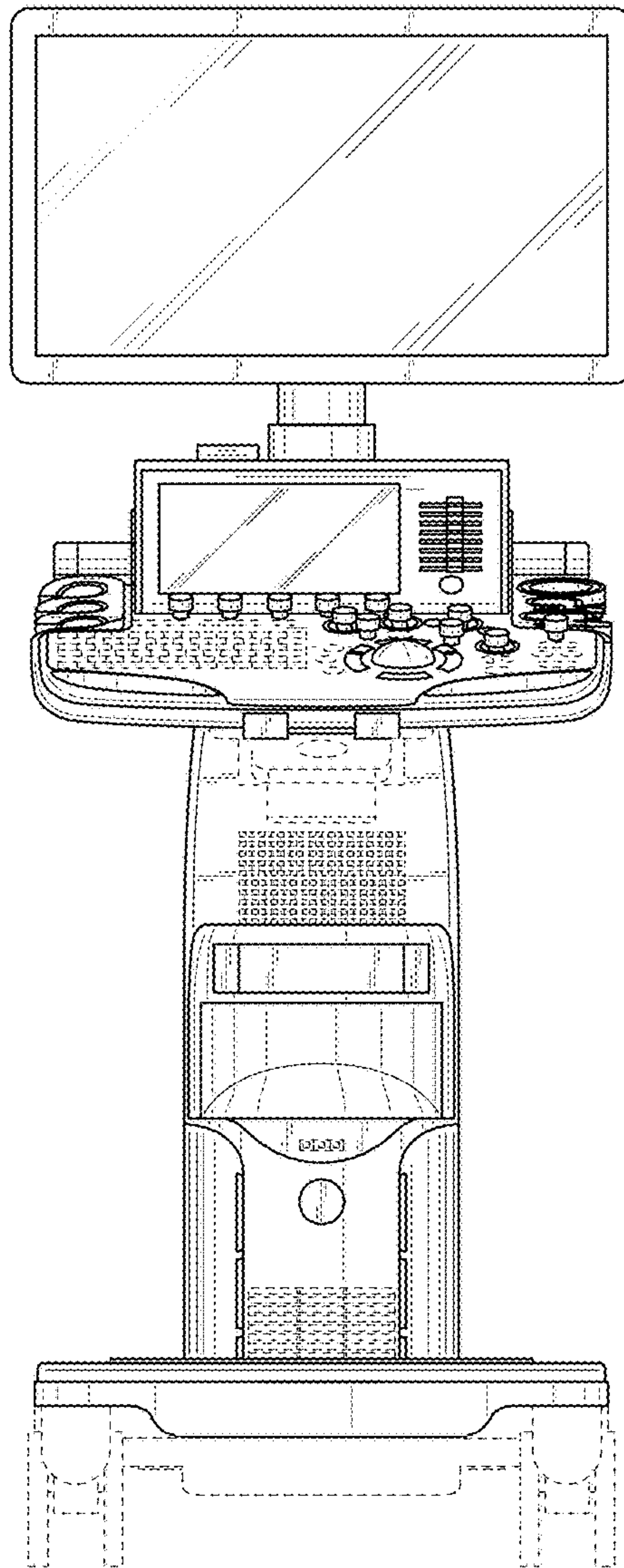

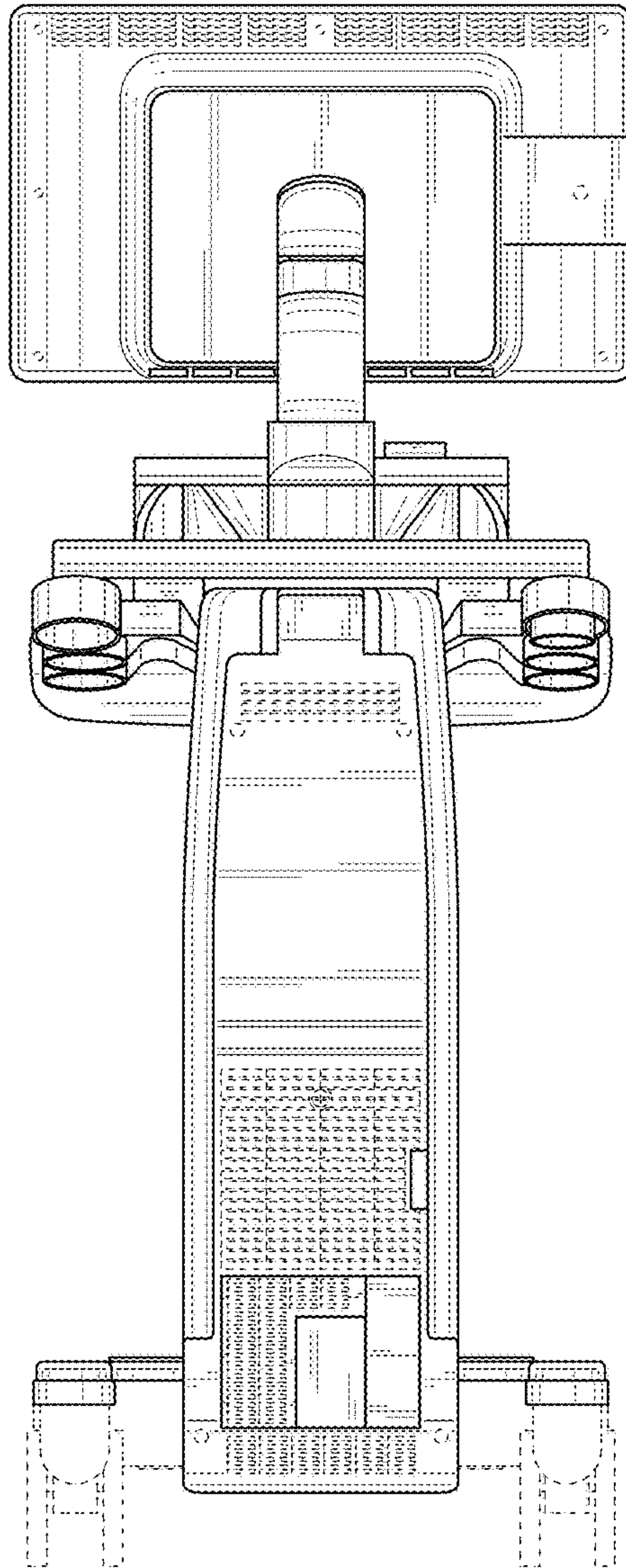

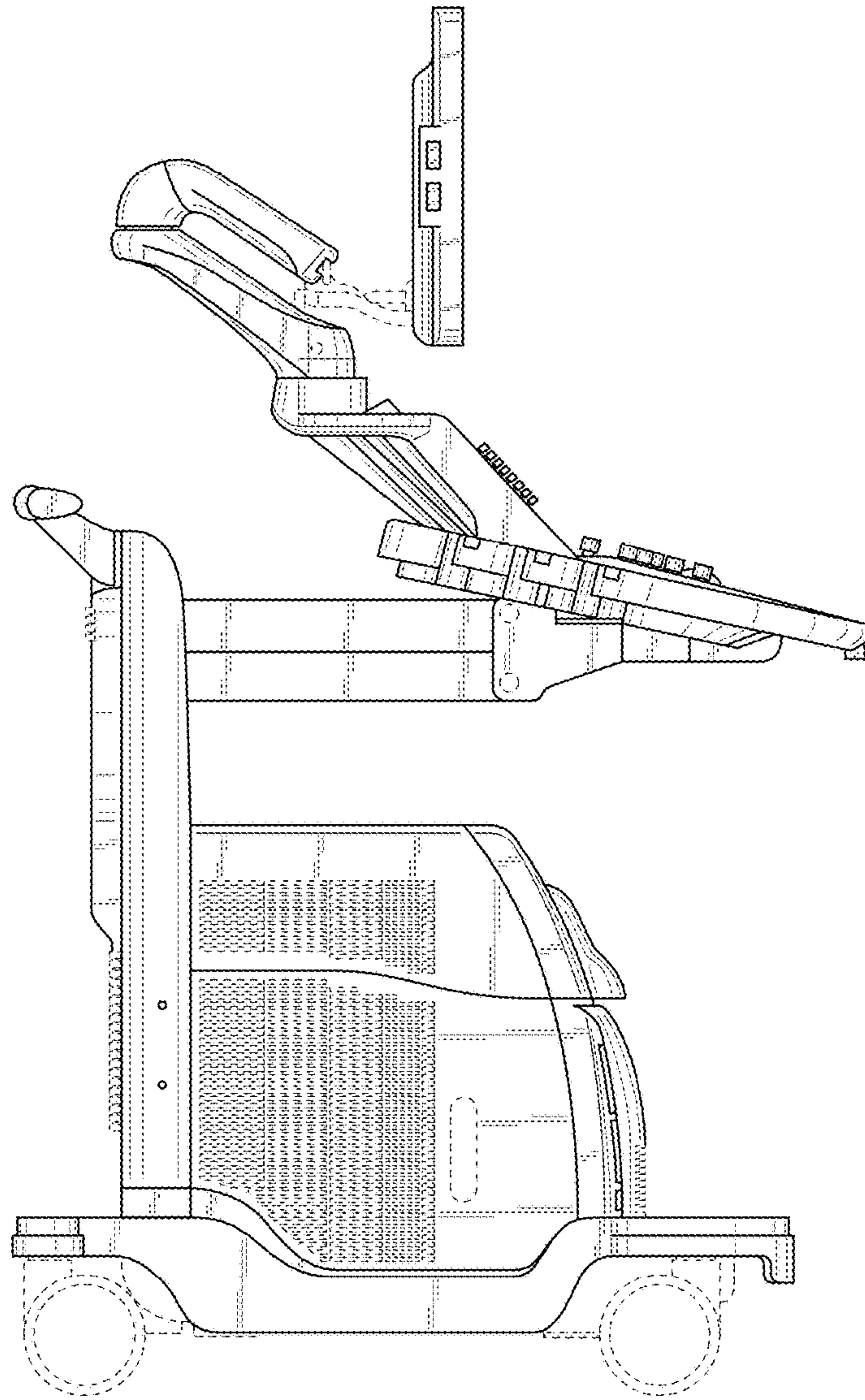

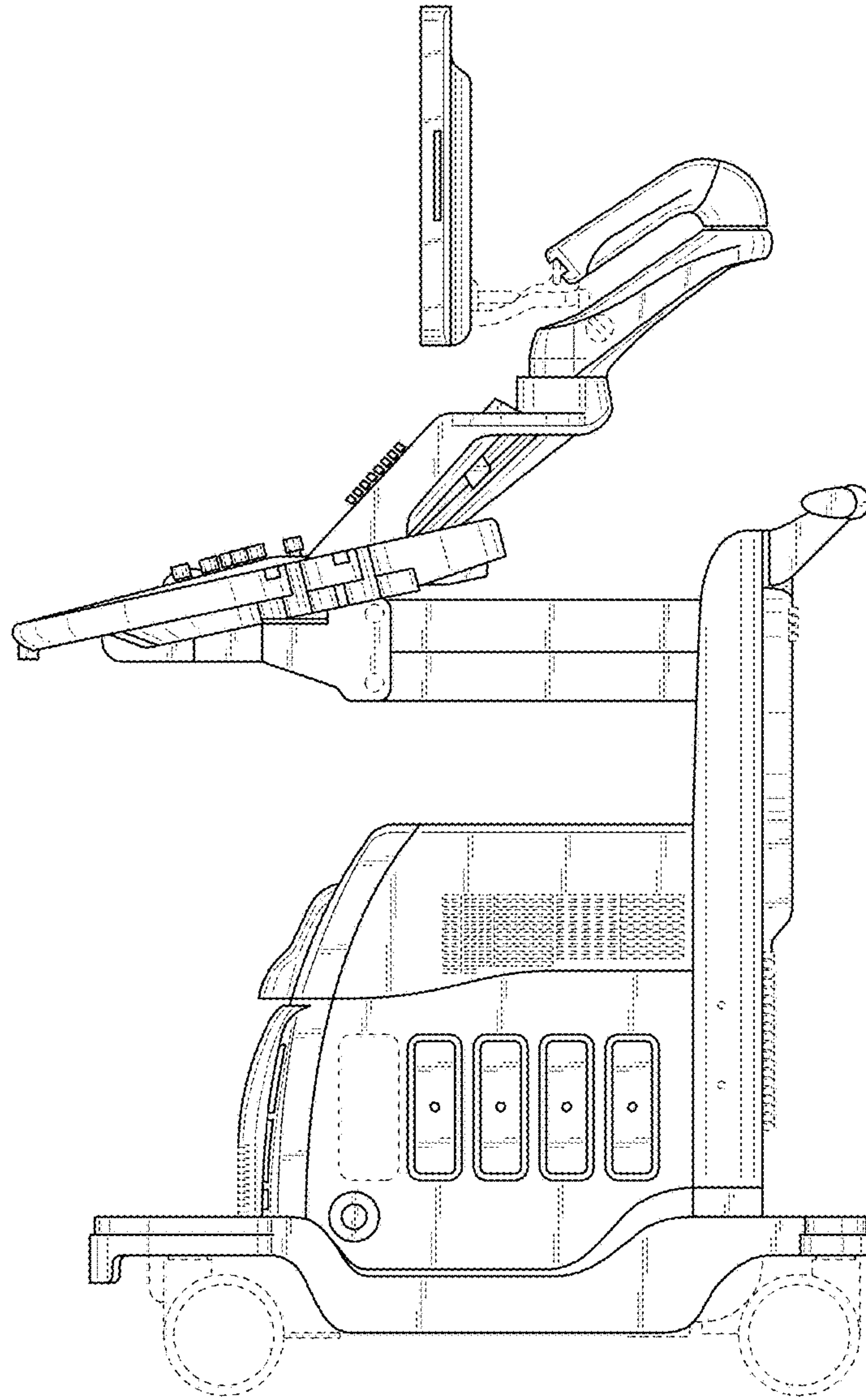

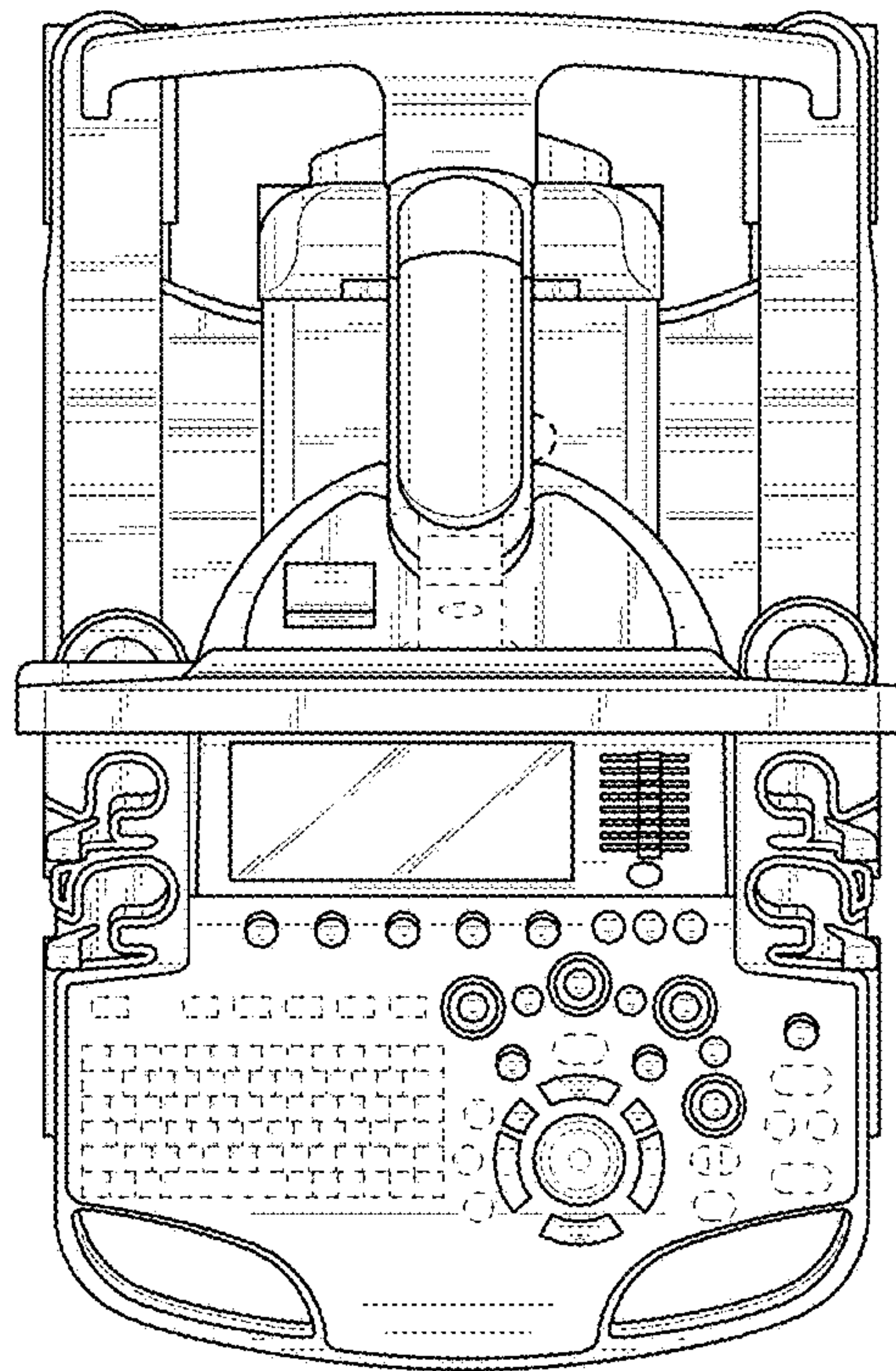

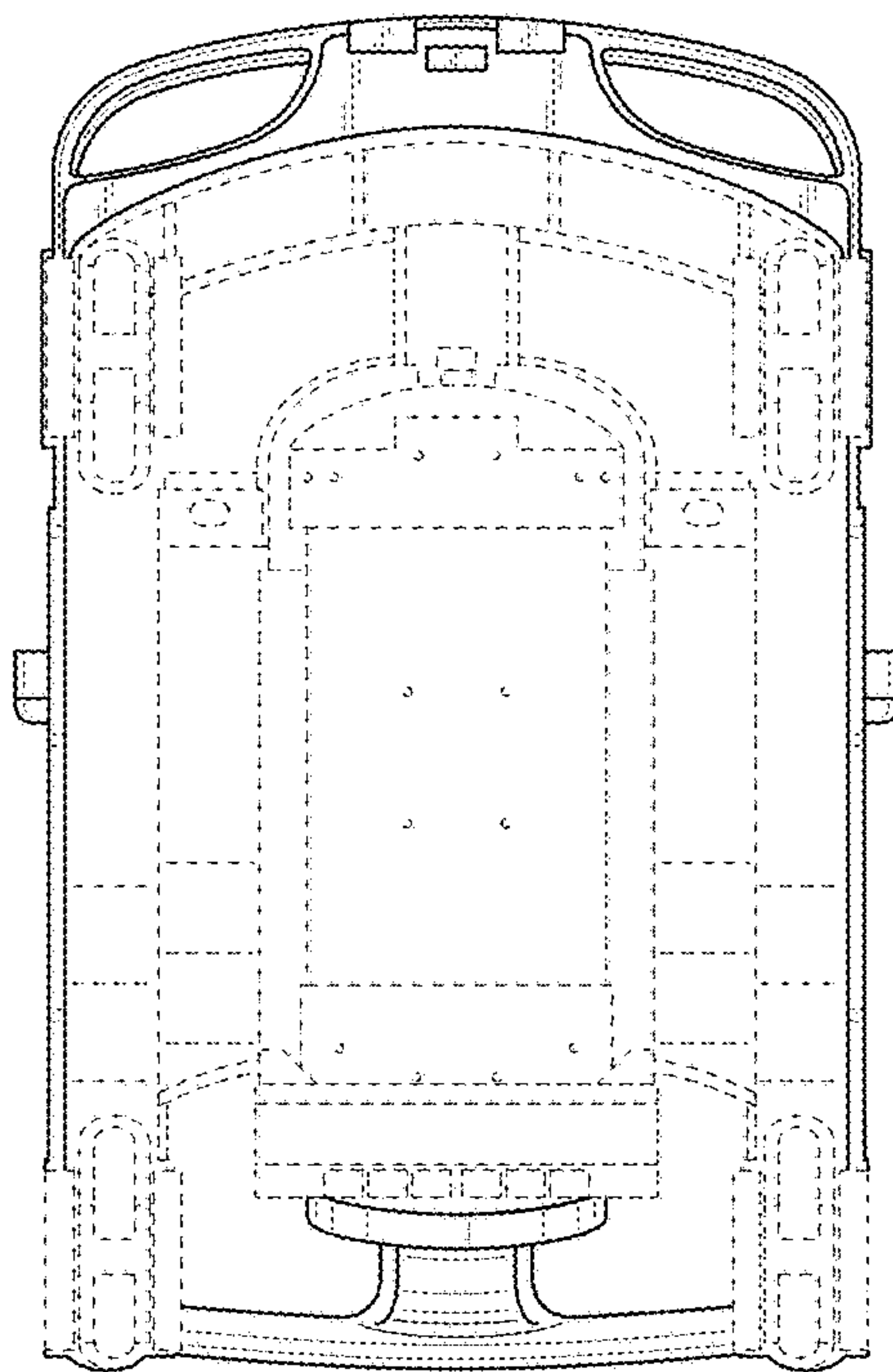

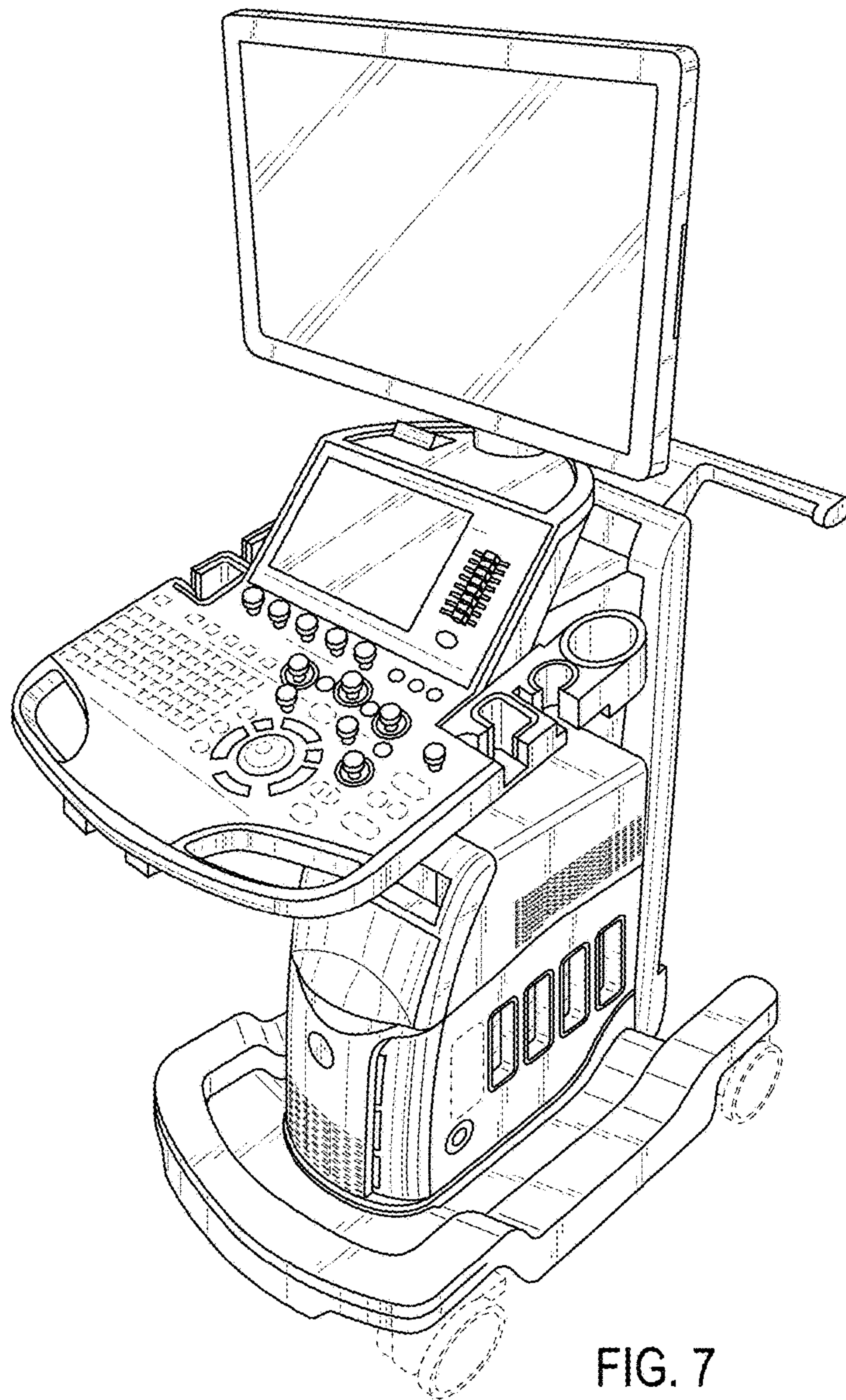
