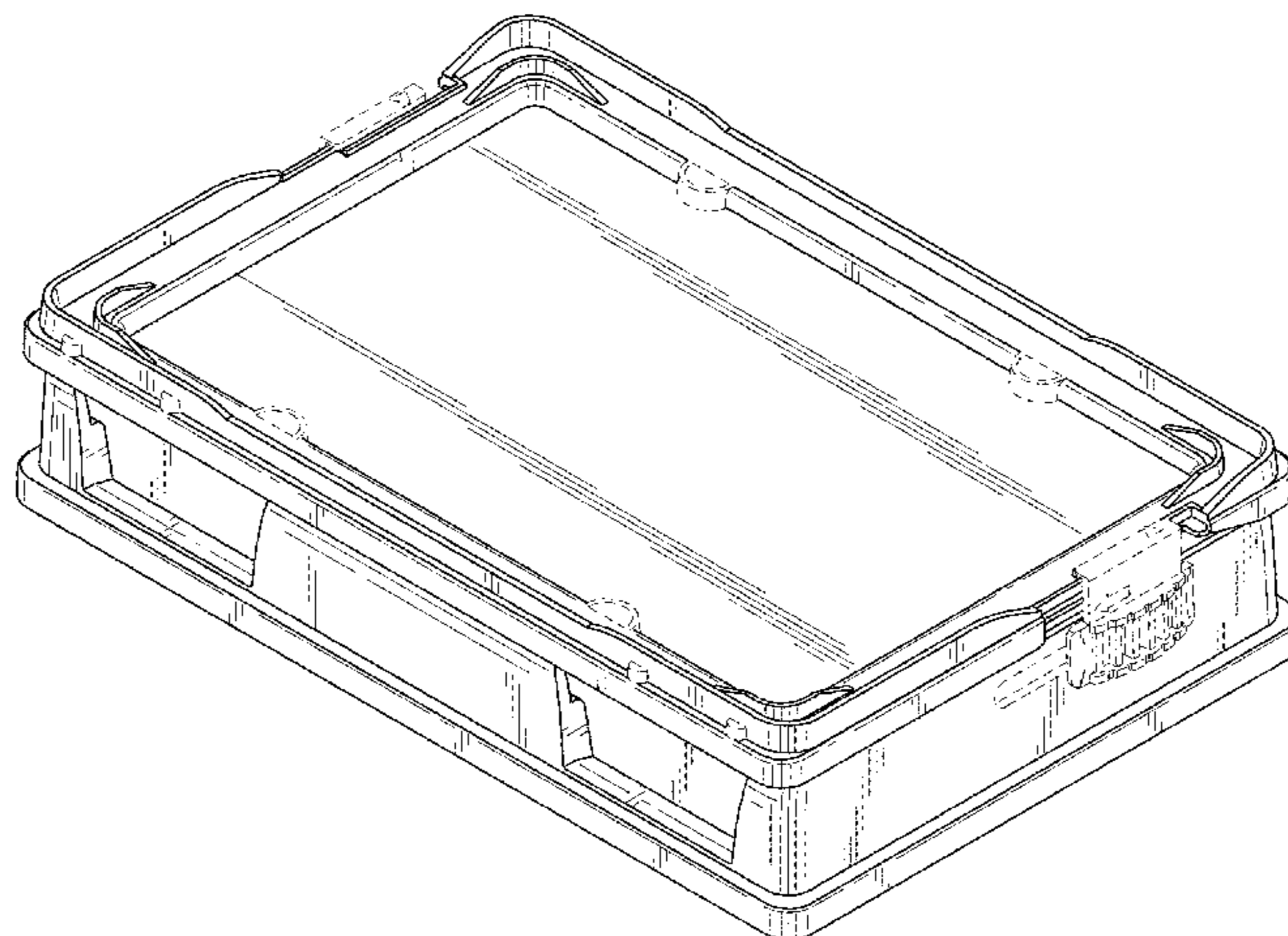


FIG. 27 is a rear side elevation view thereof;

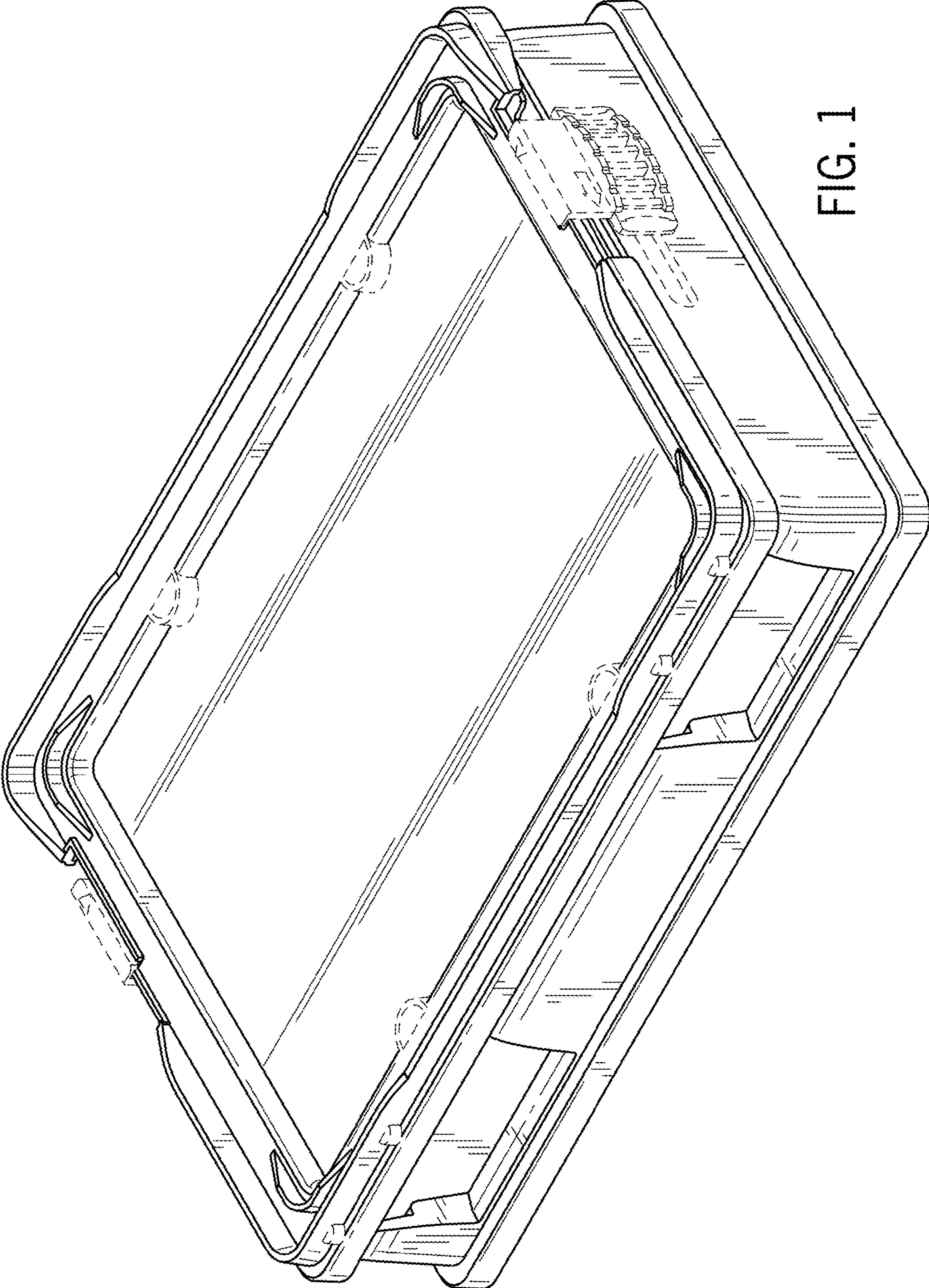
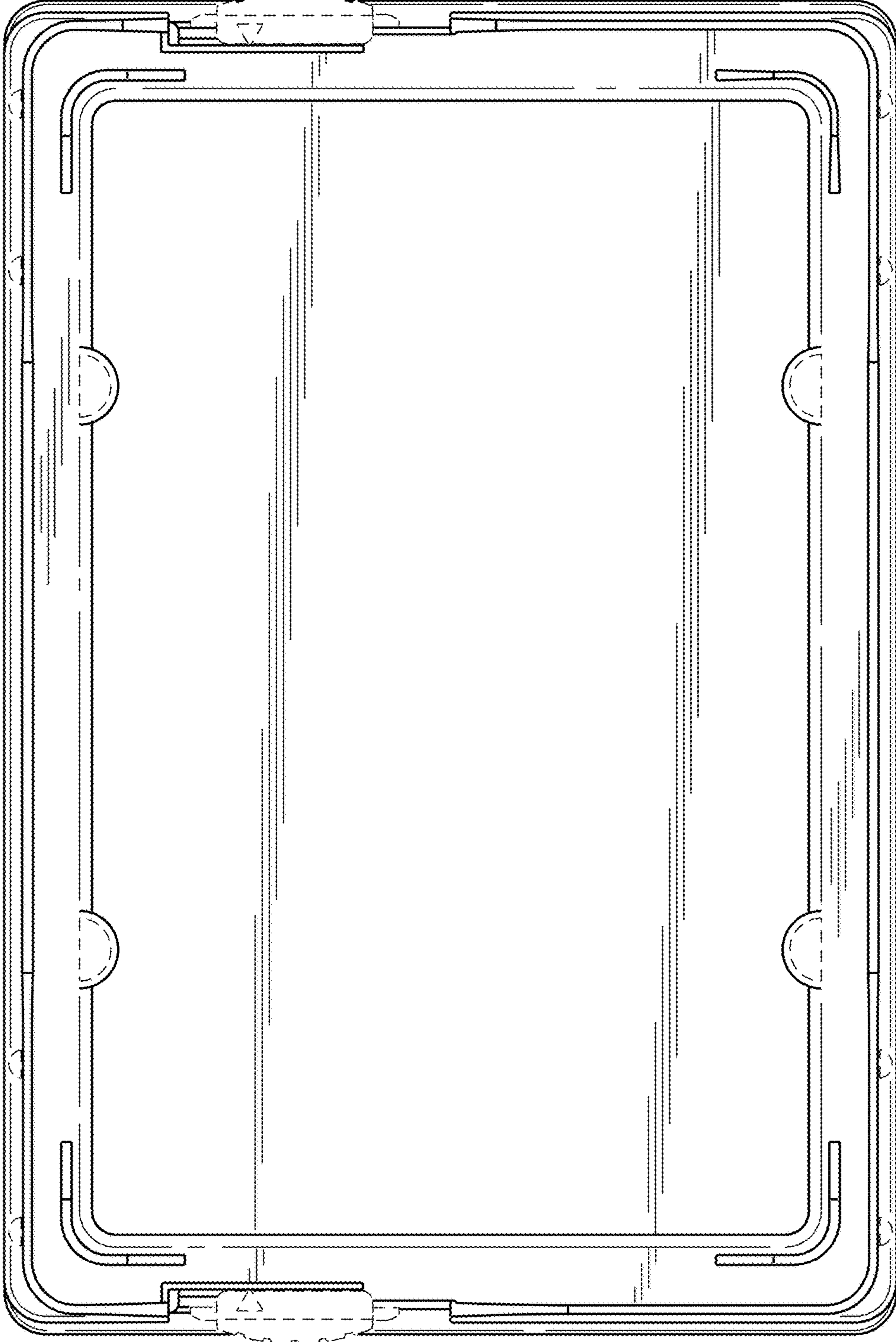

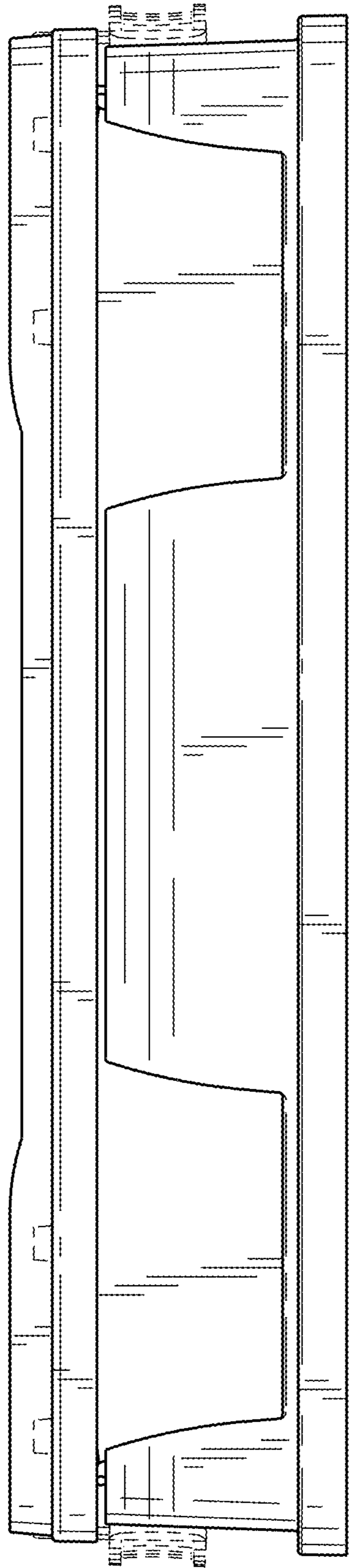

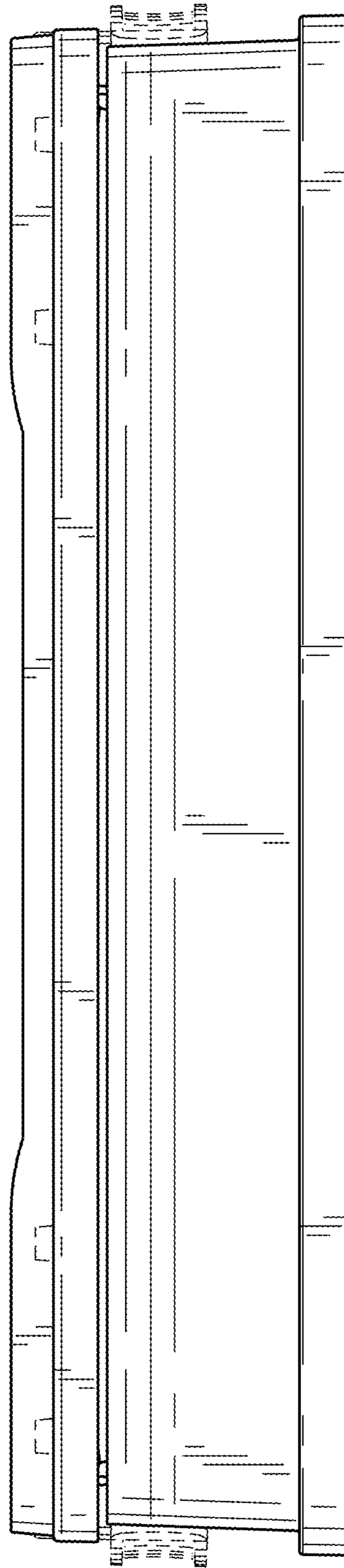

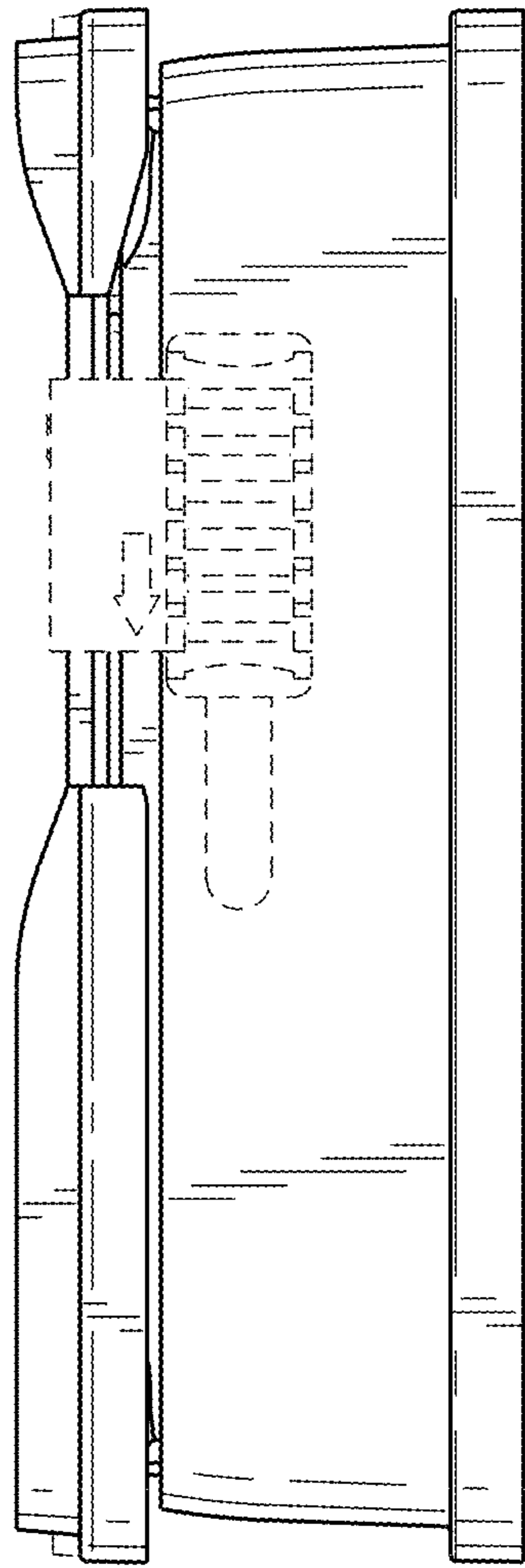

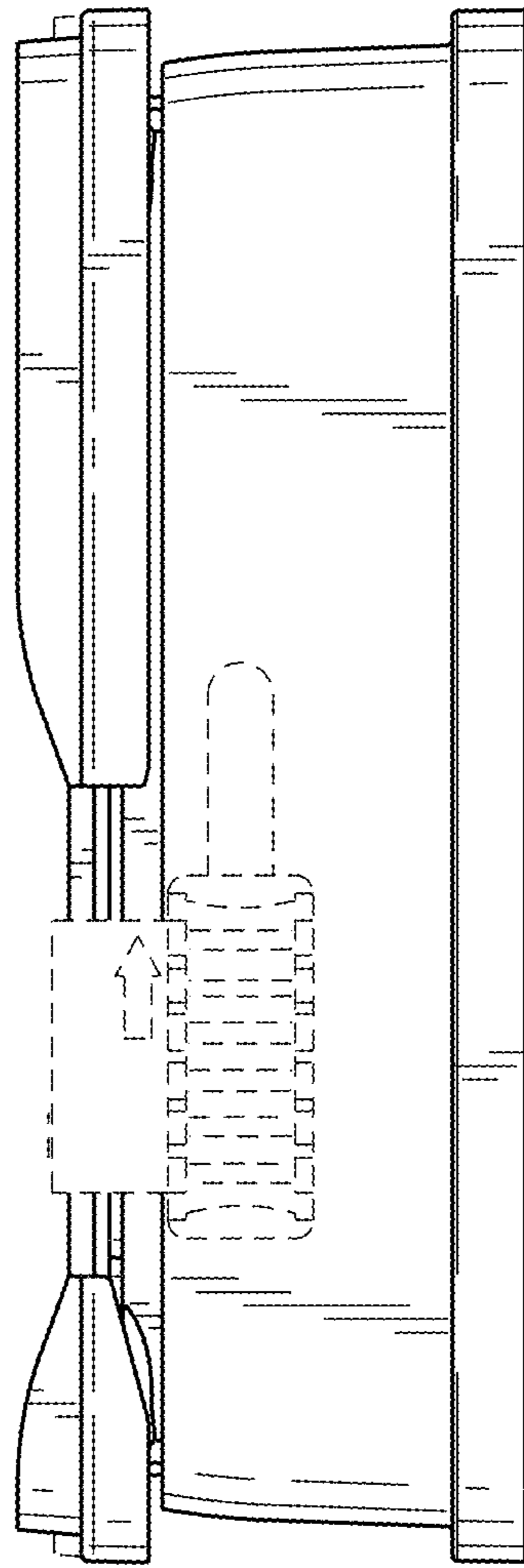

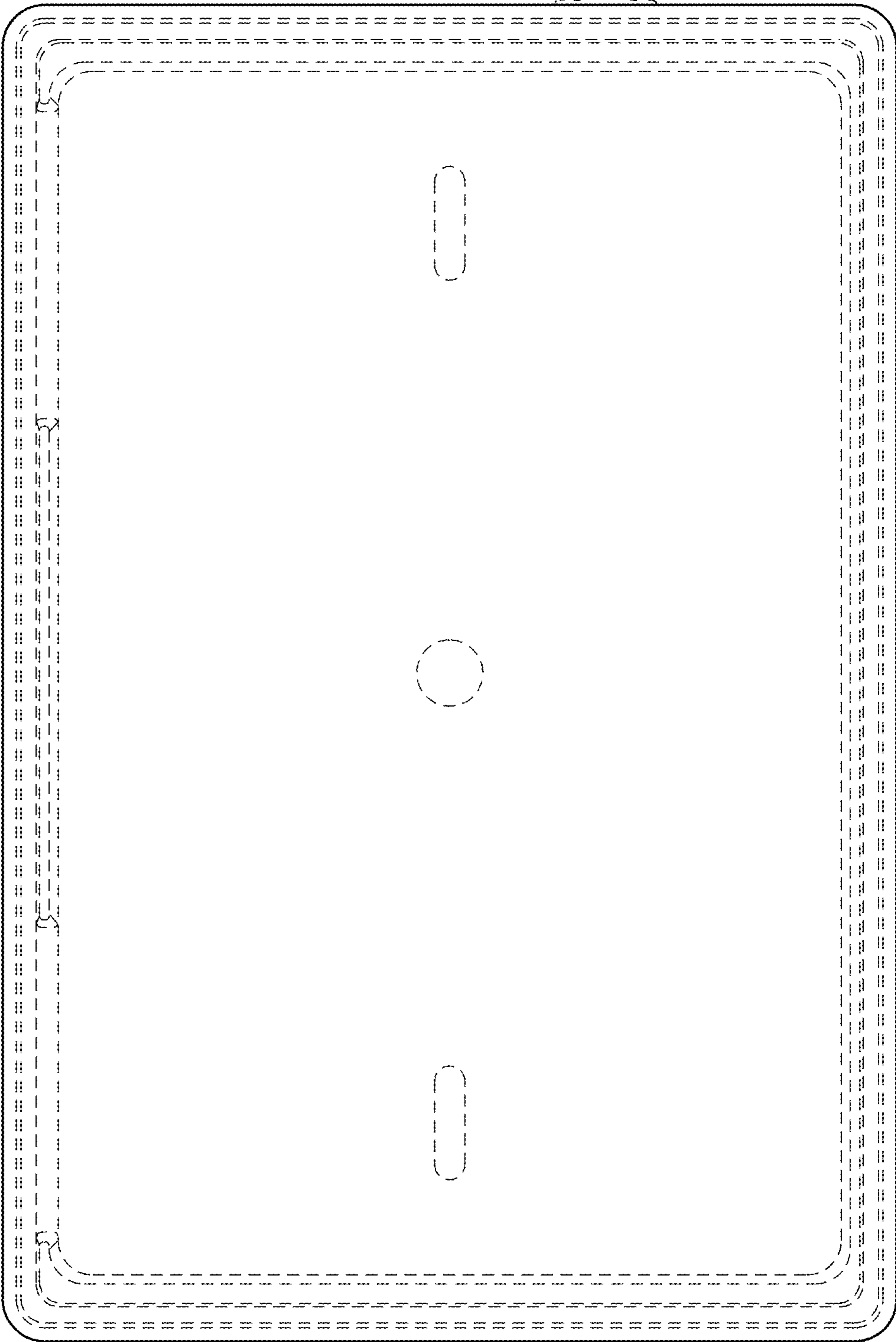

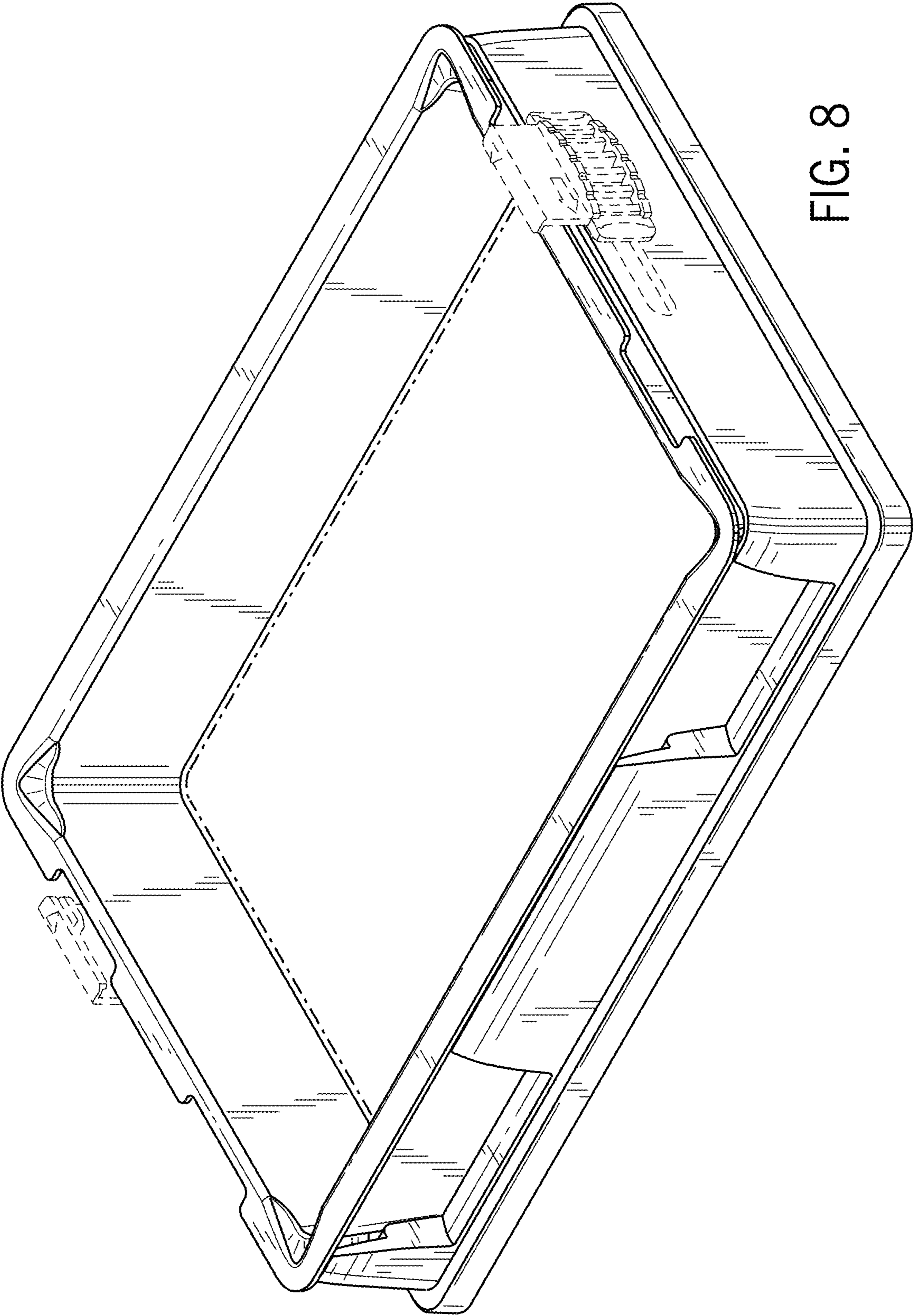
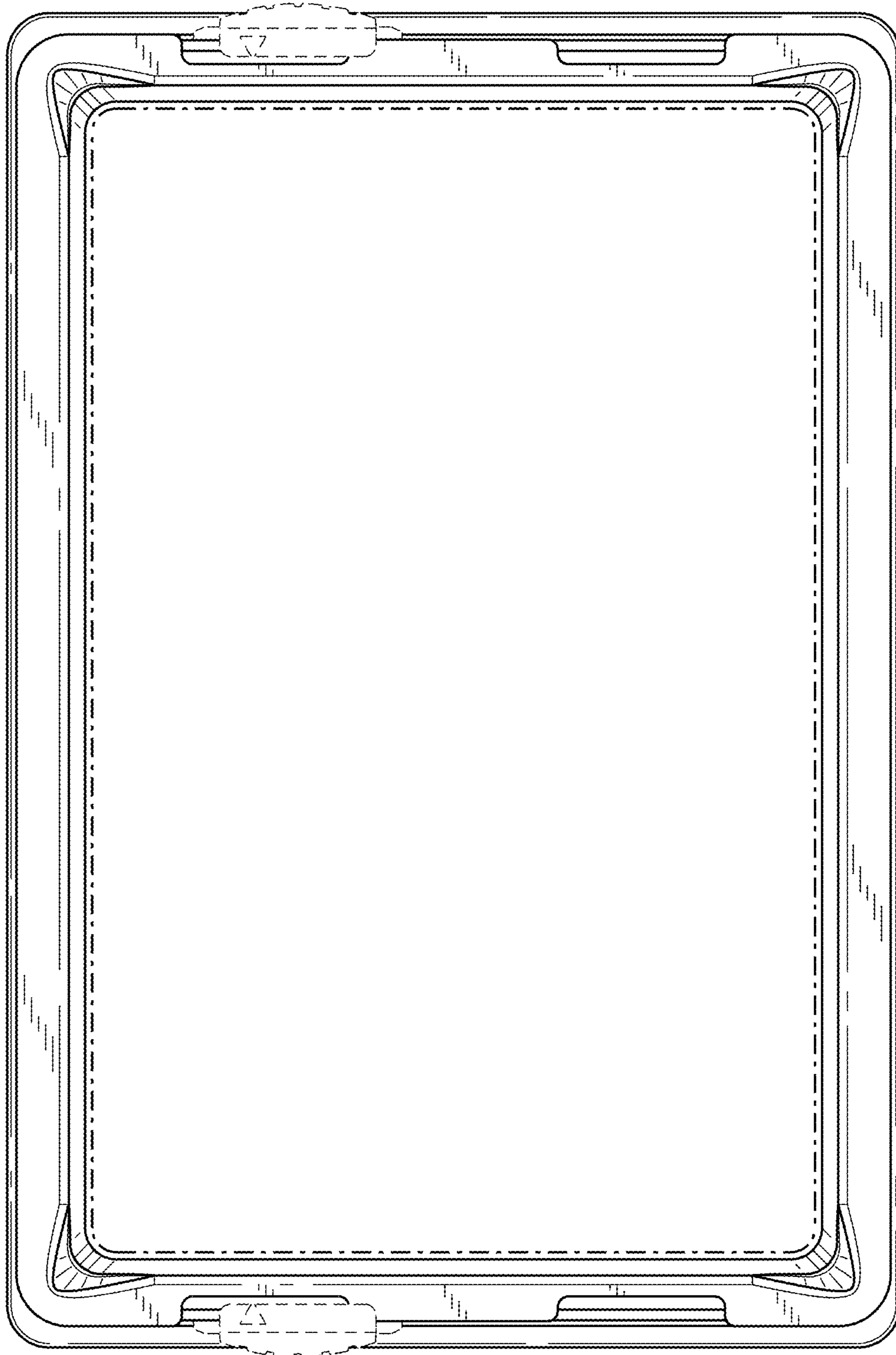

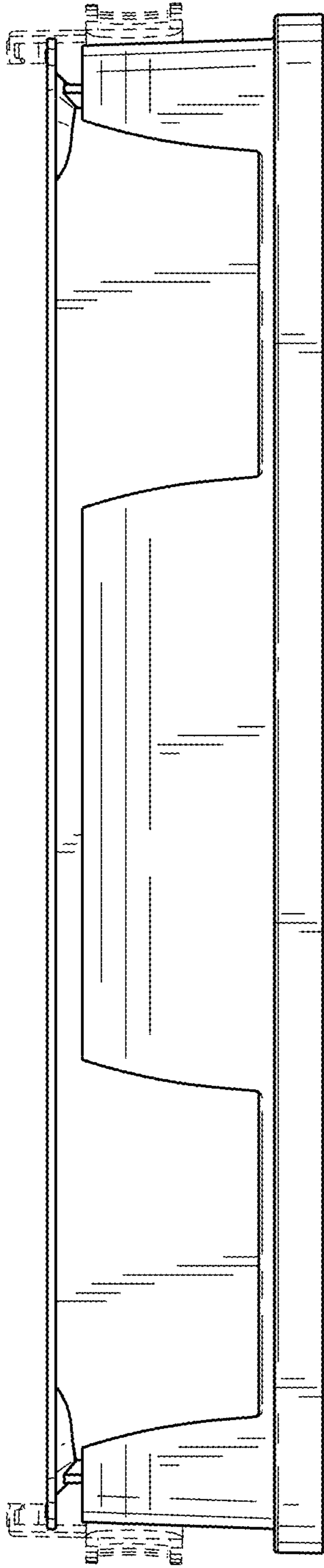

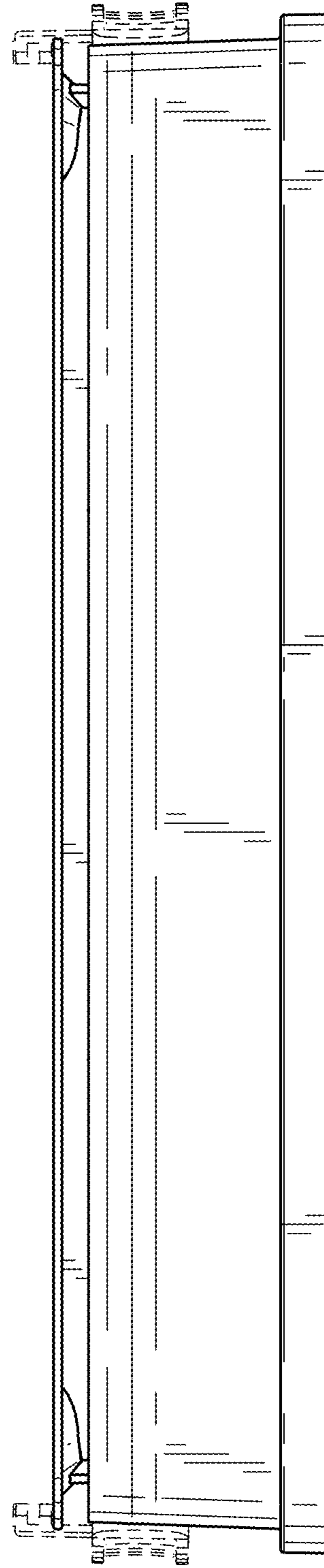

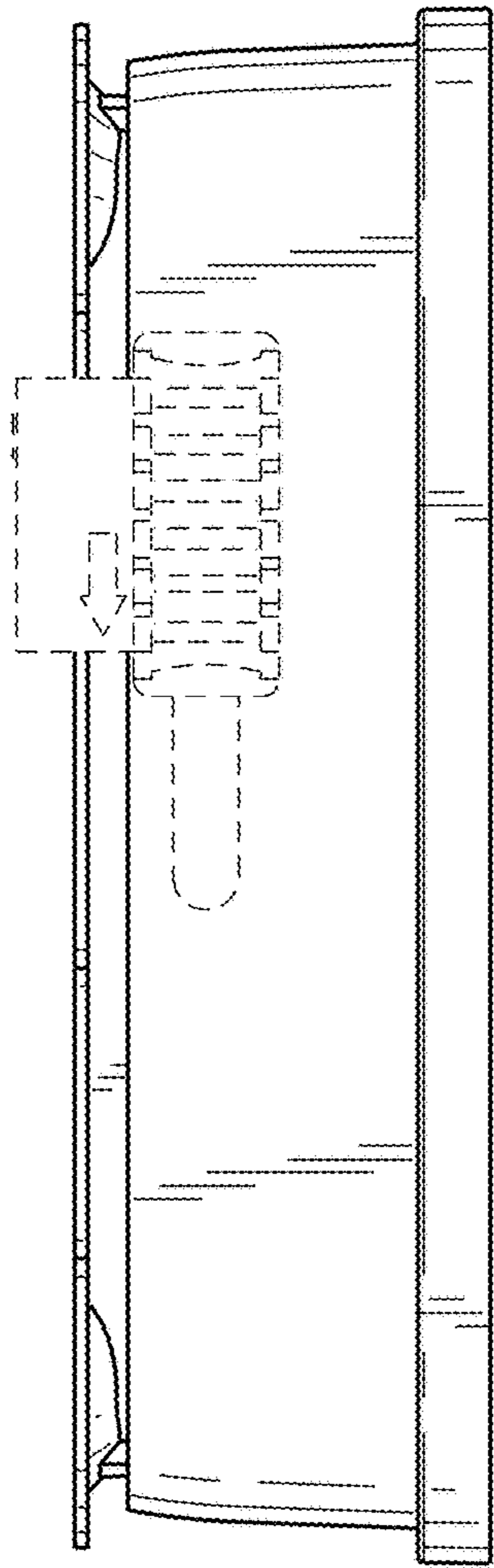

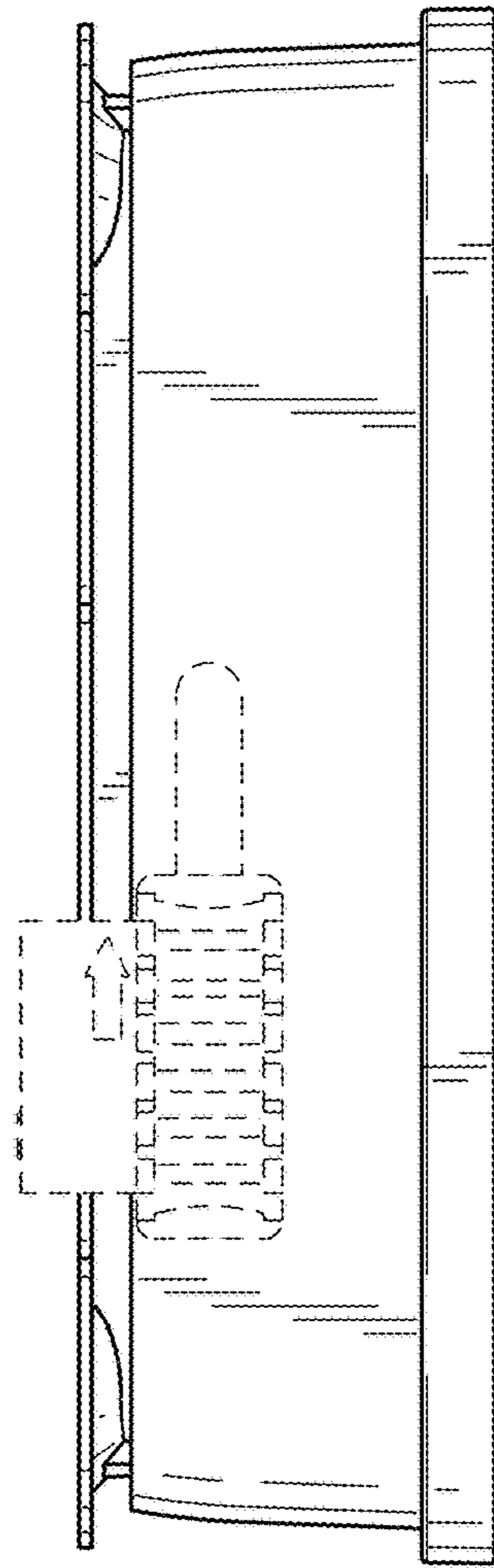

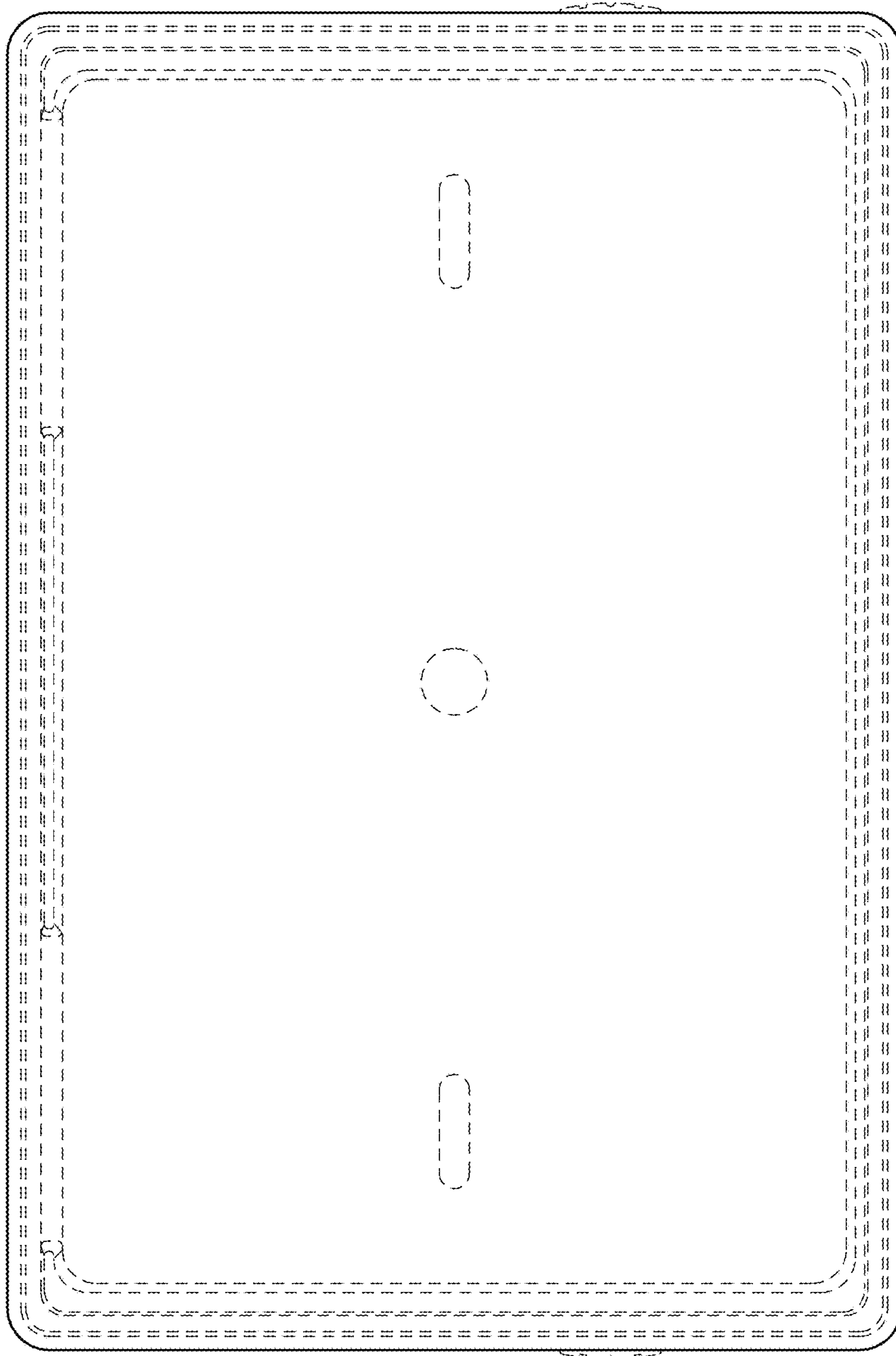

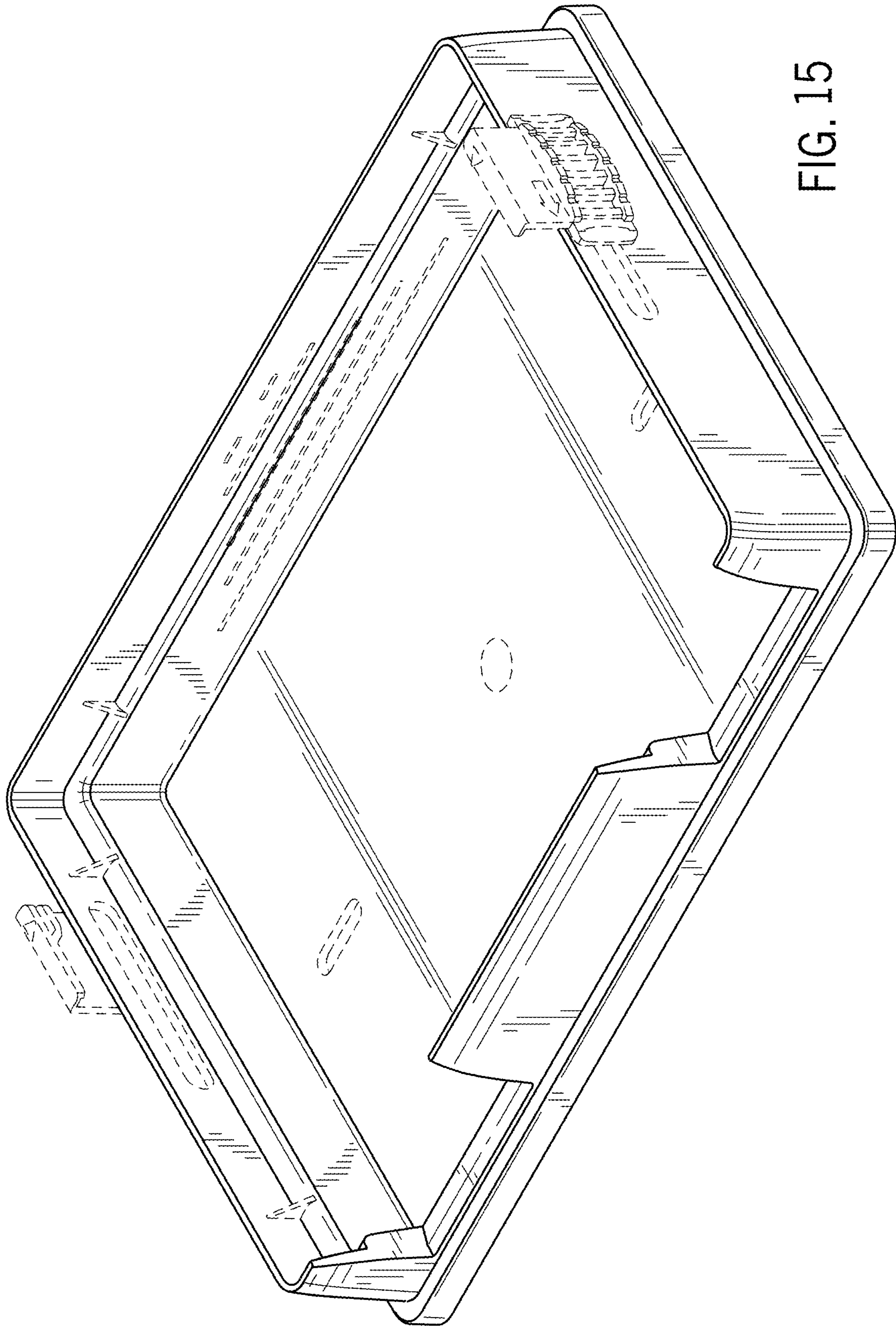
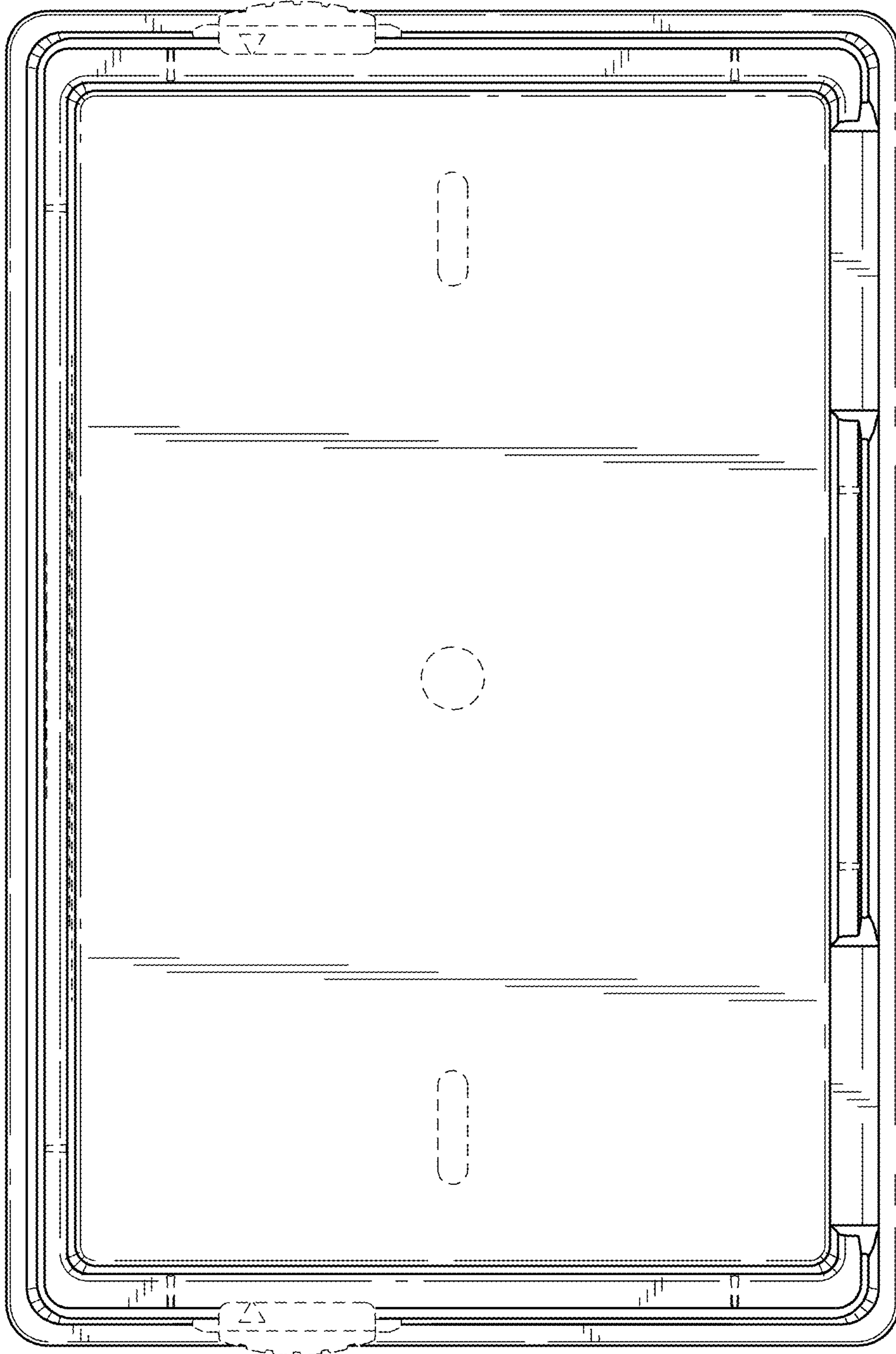

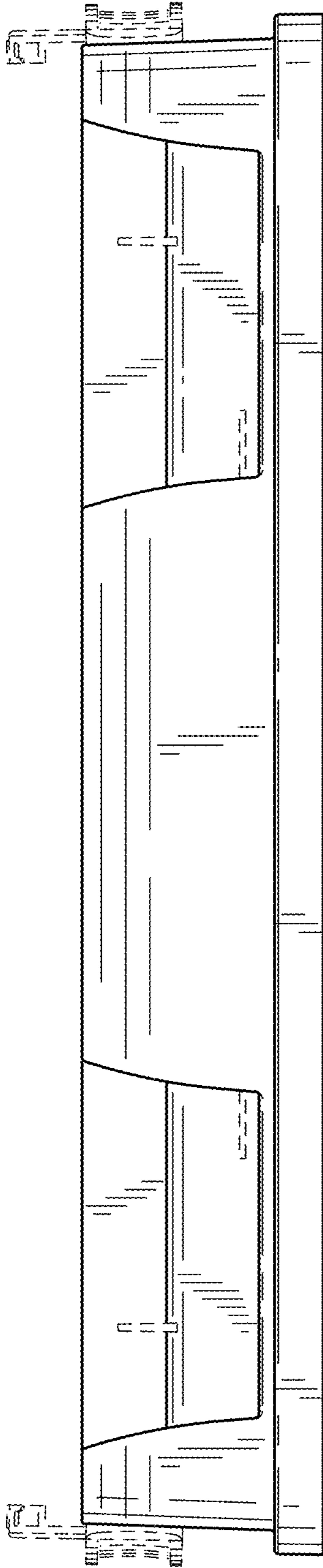

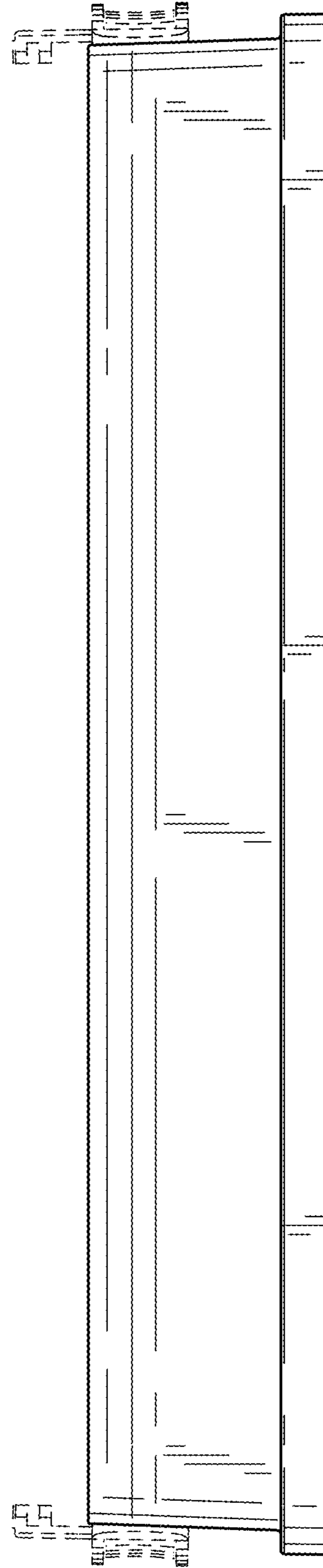

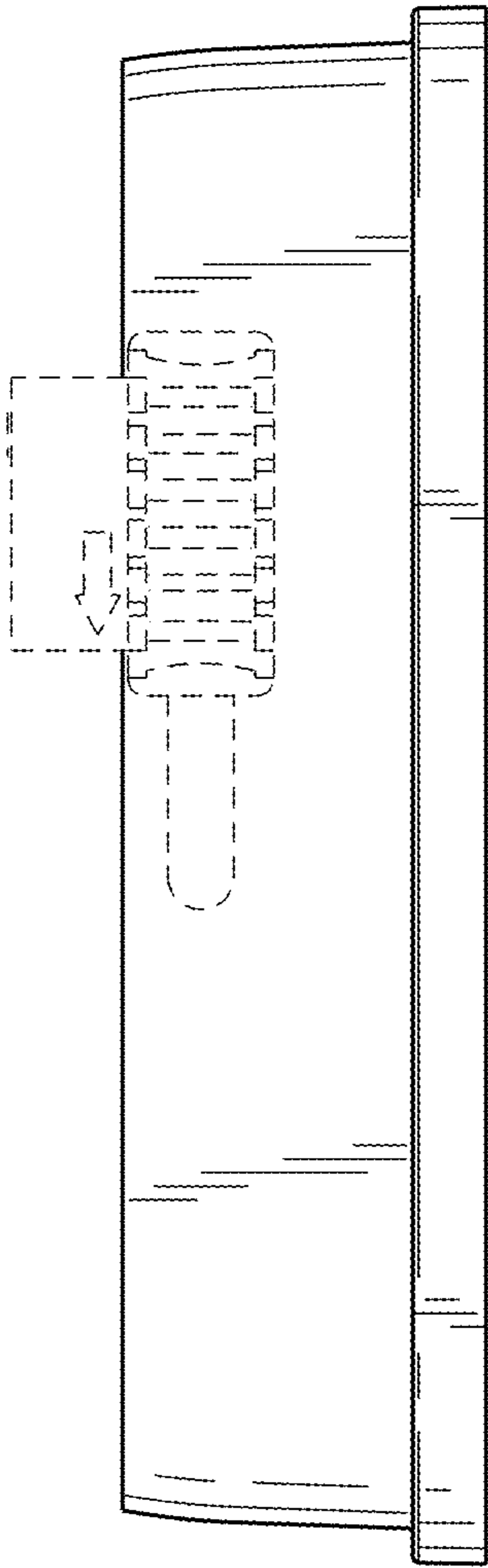

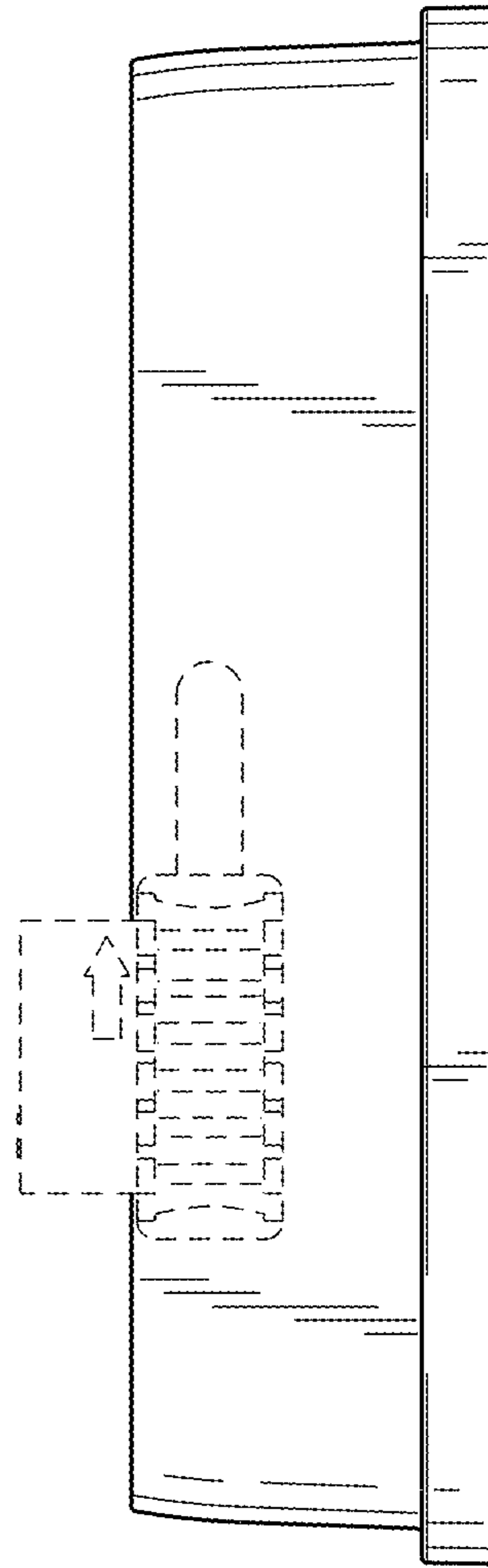

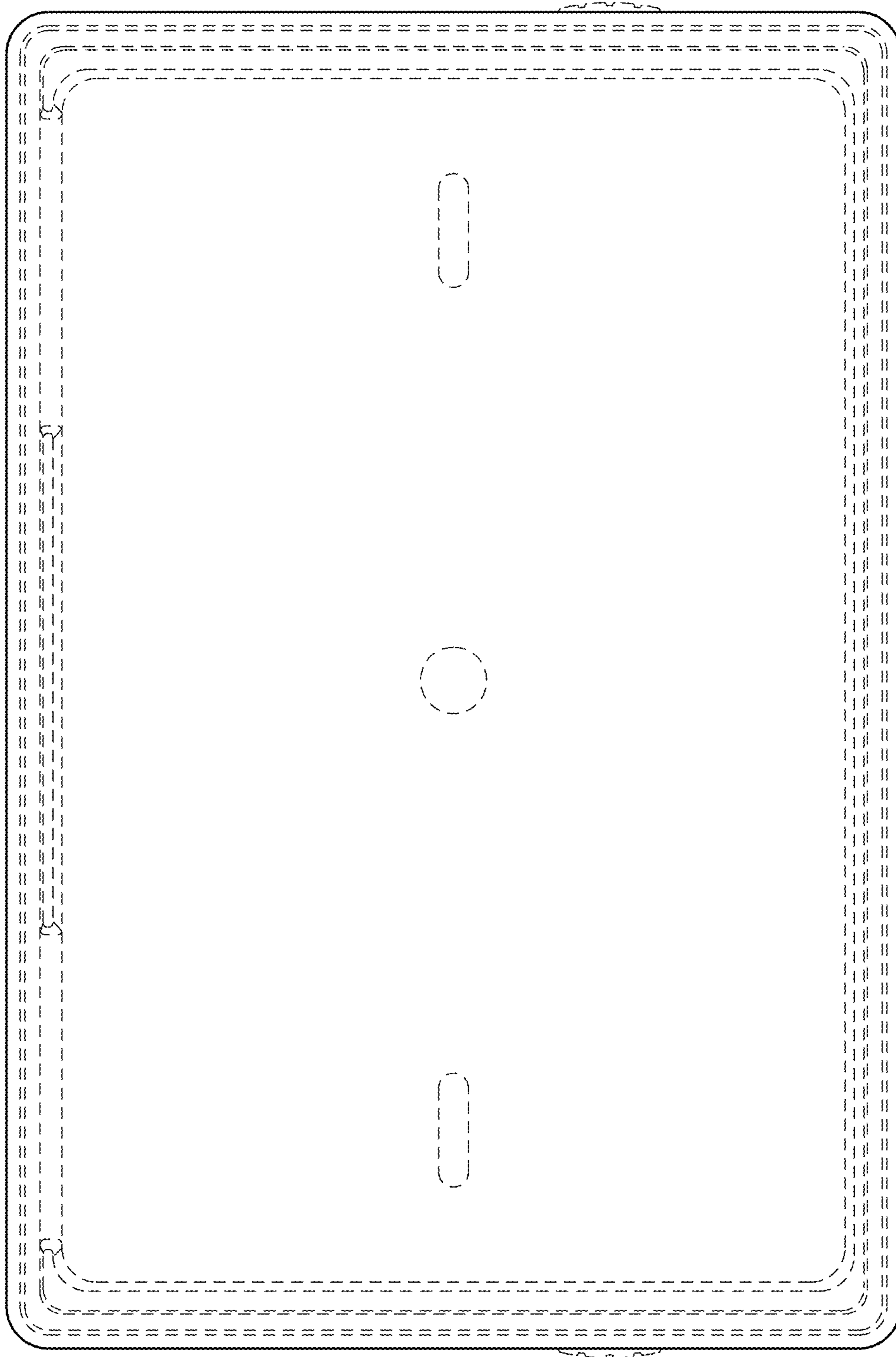

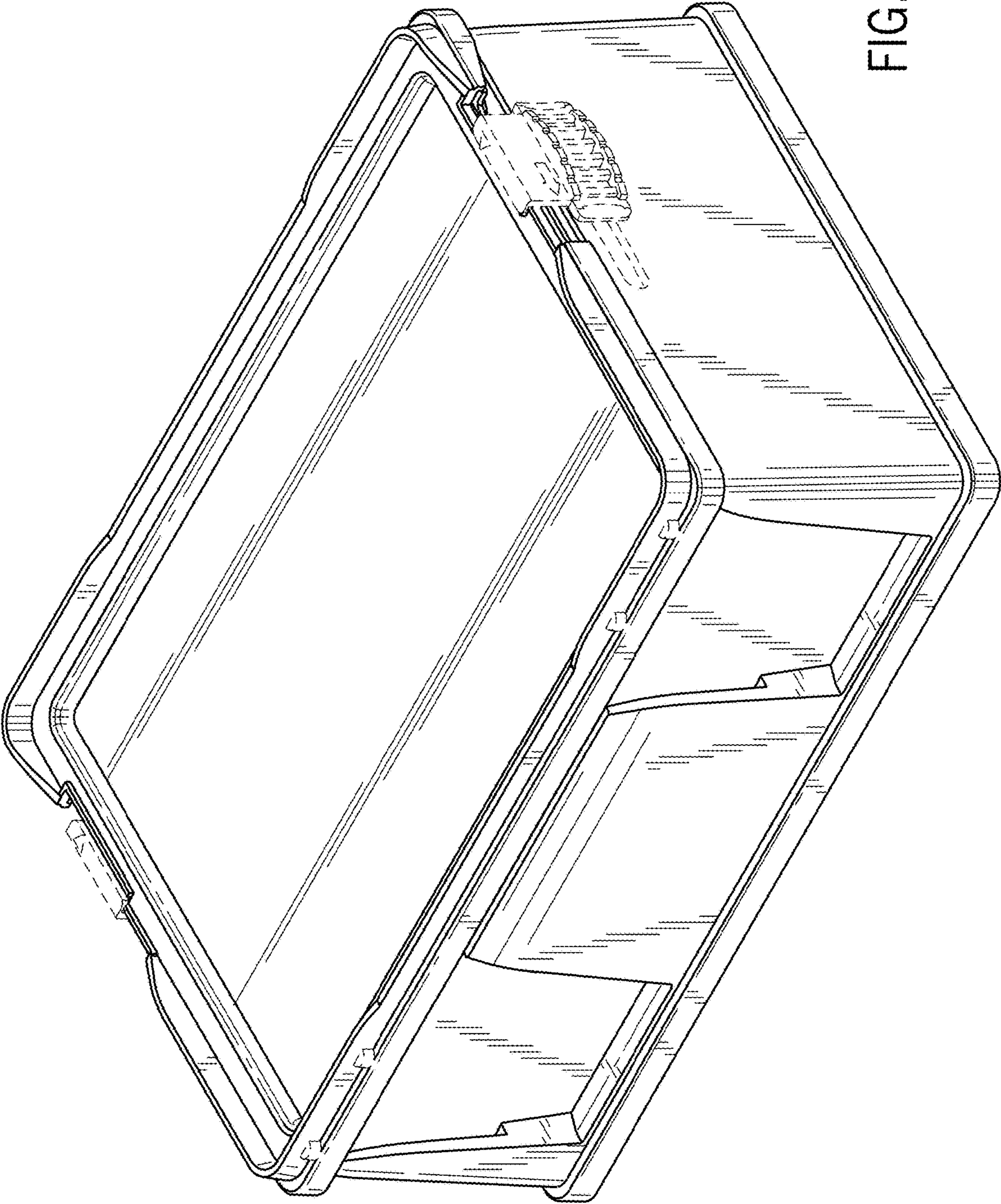
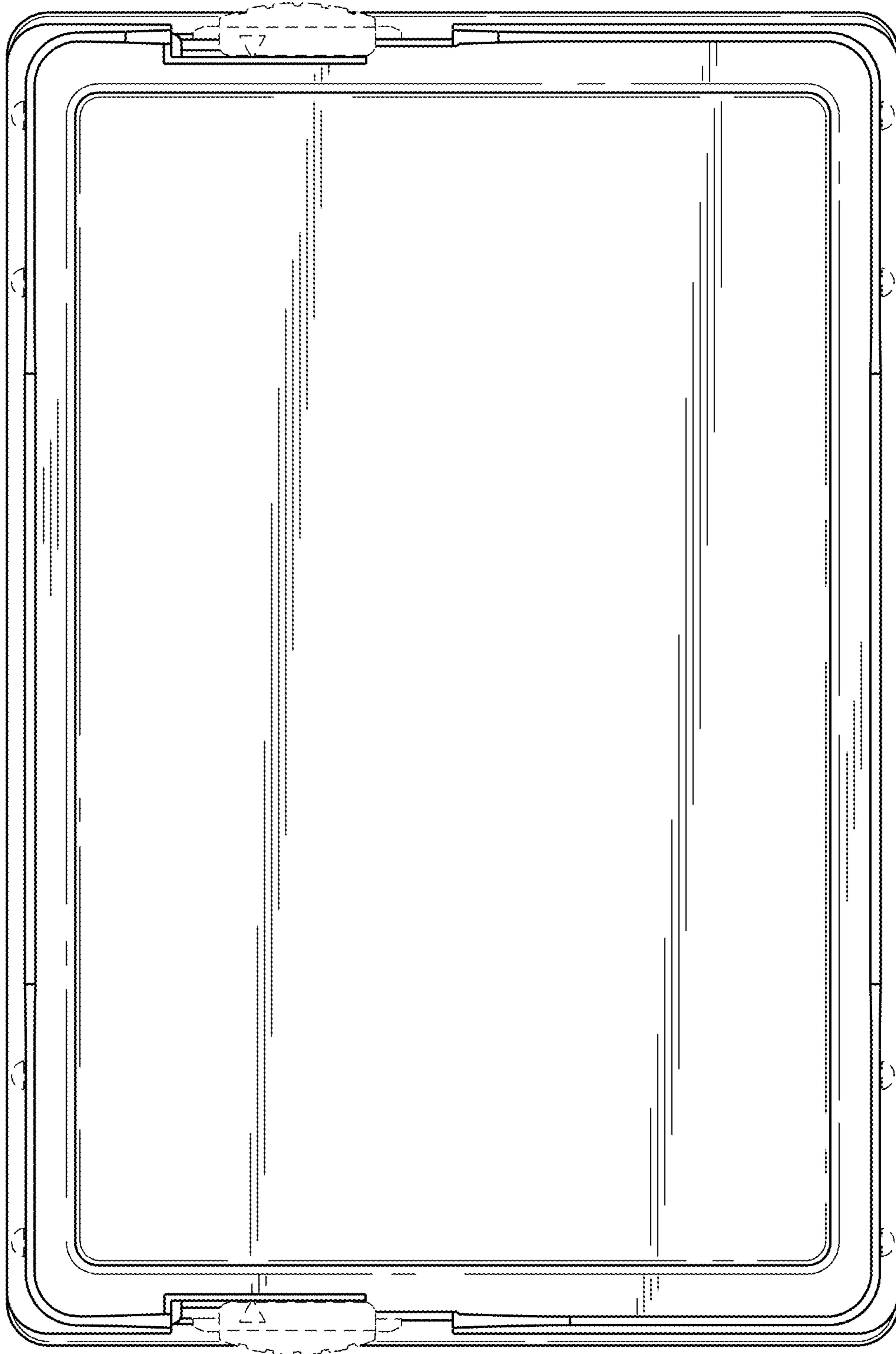

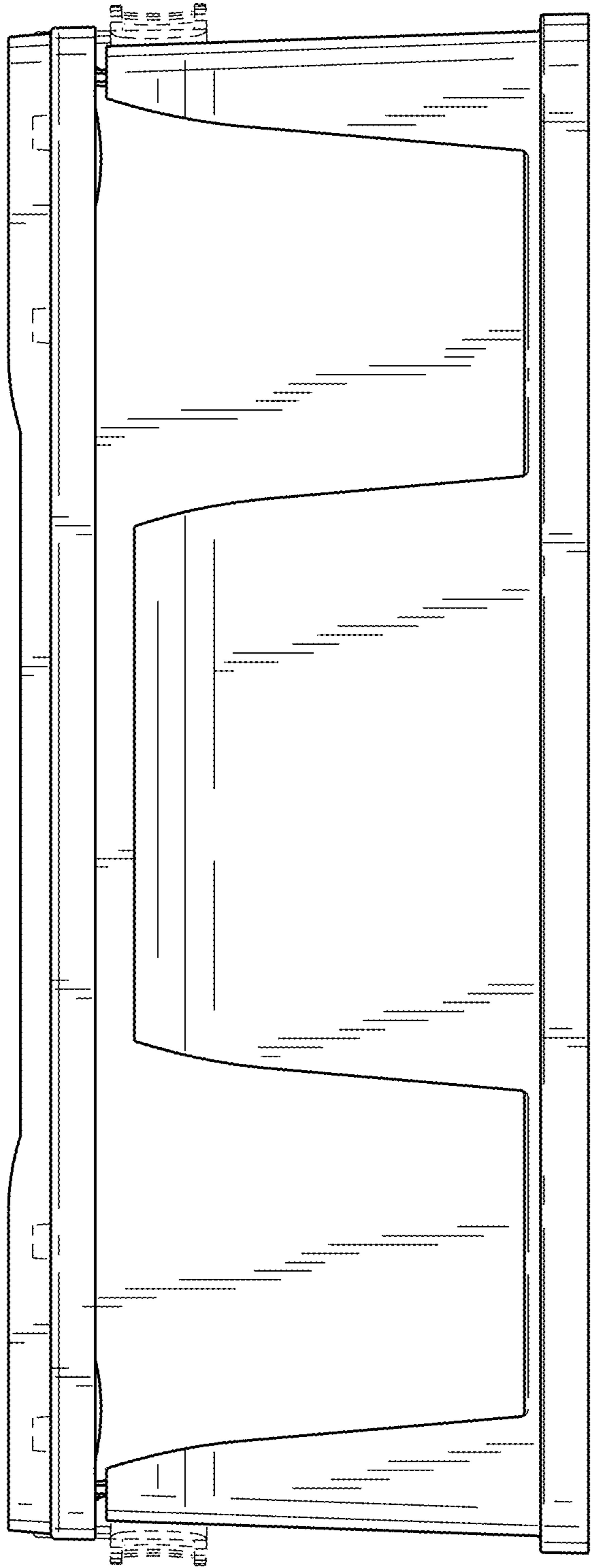

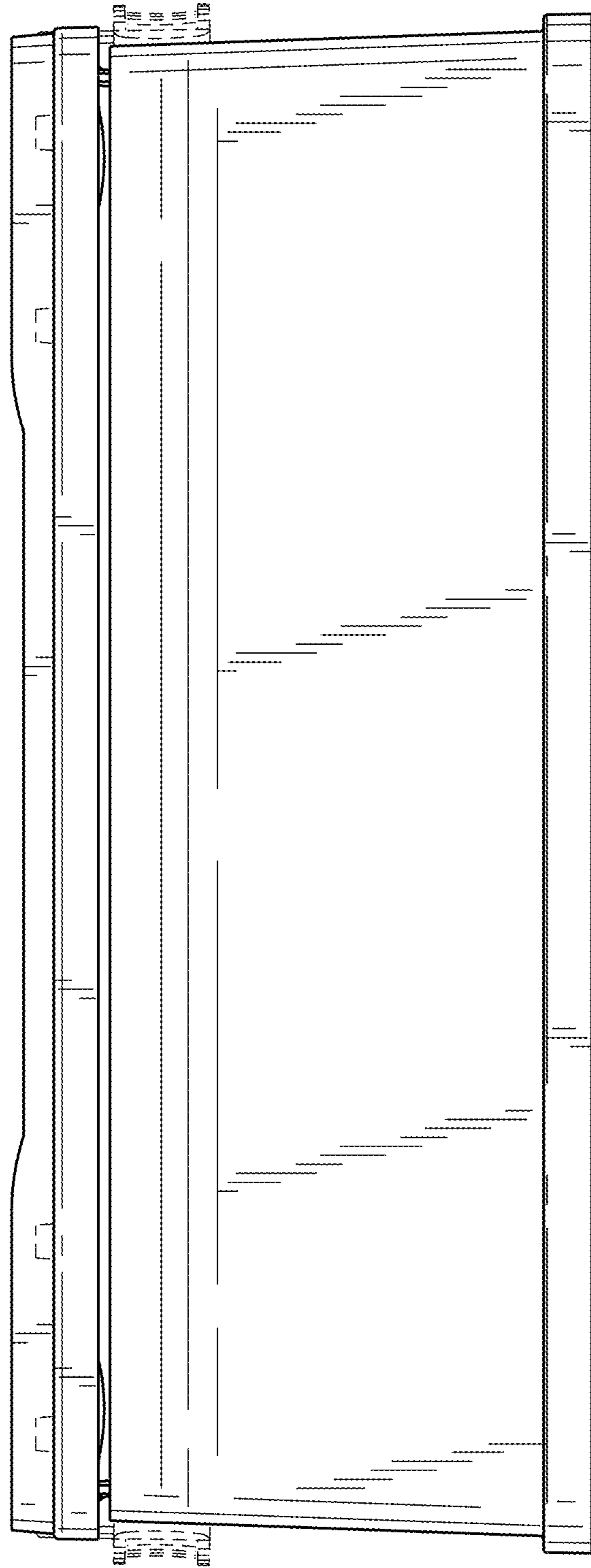

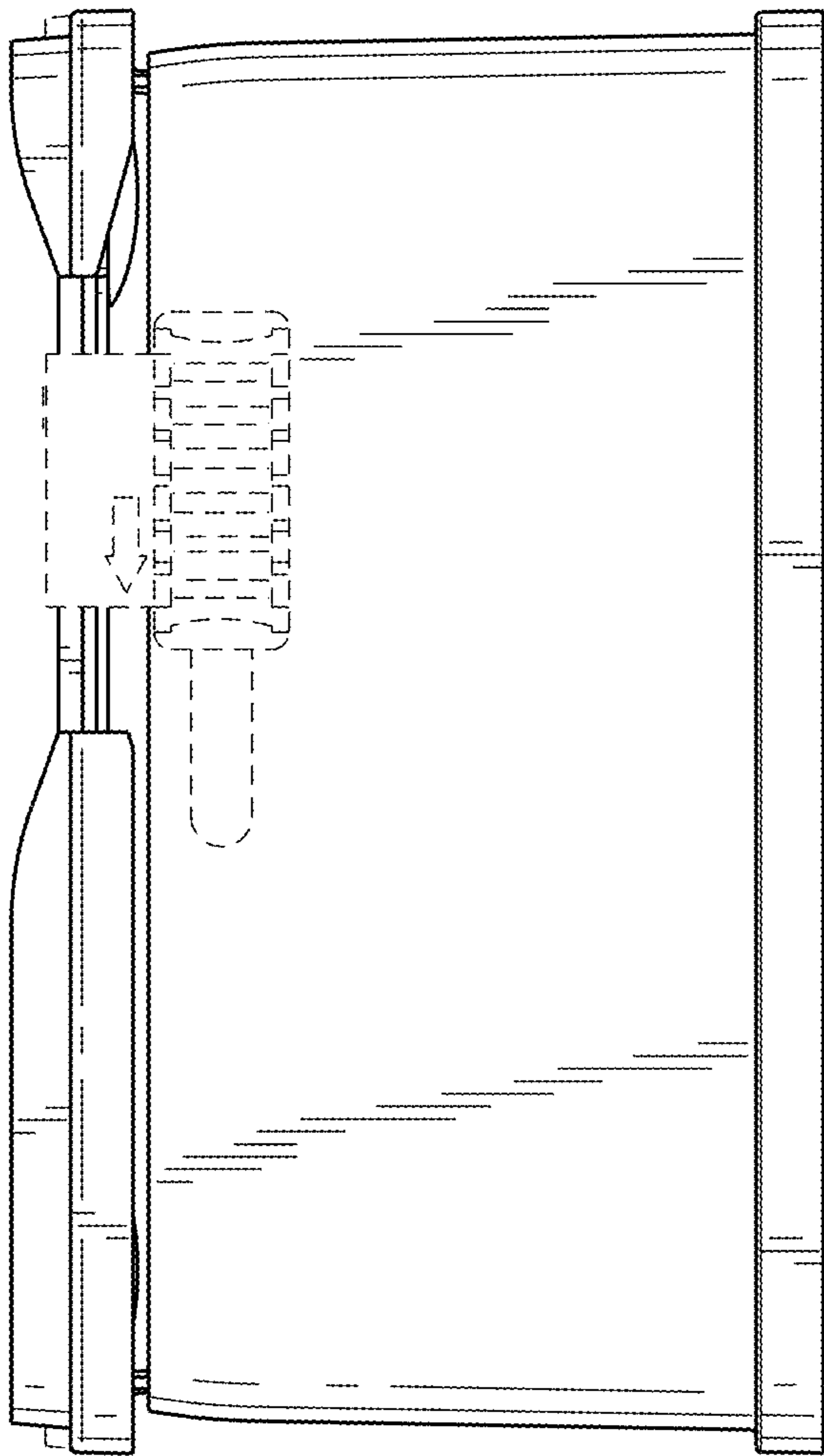

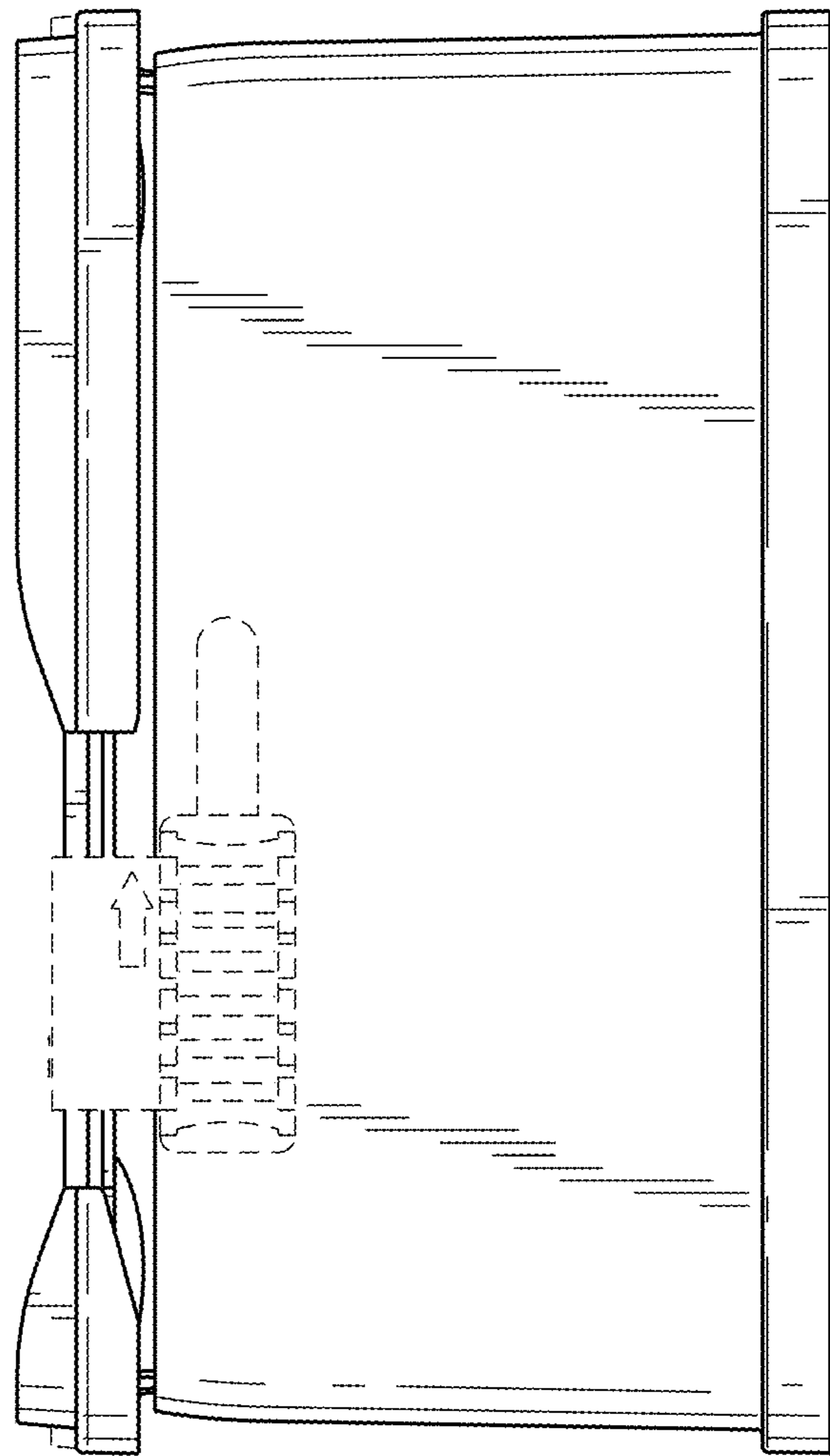

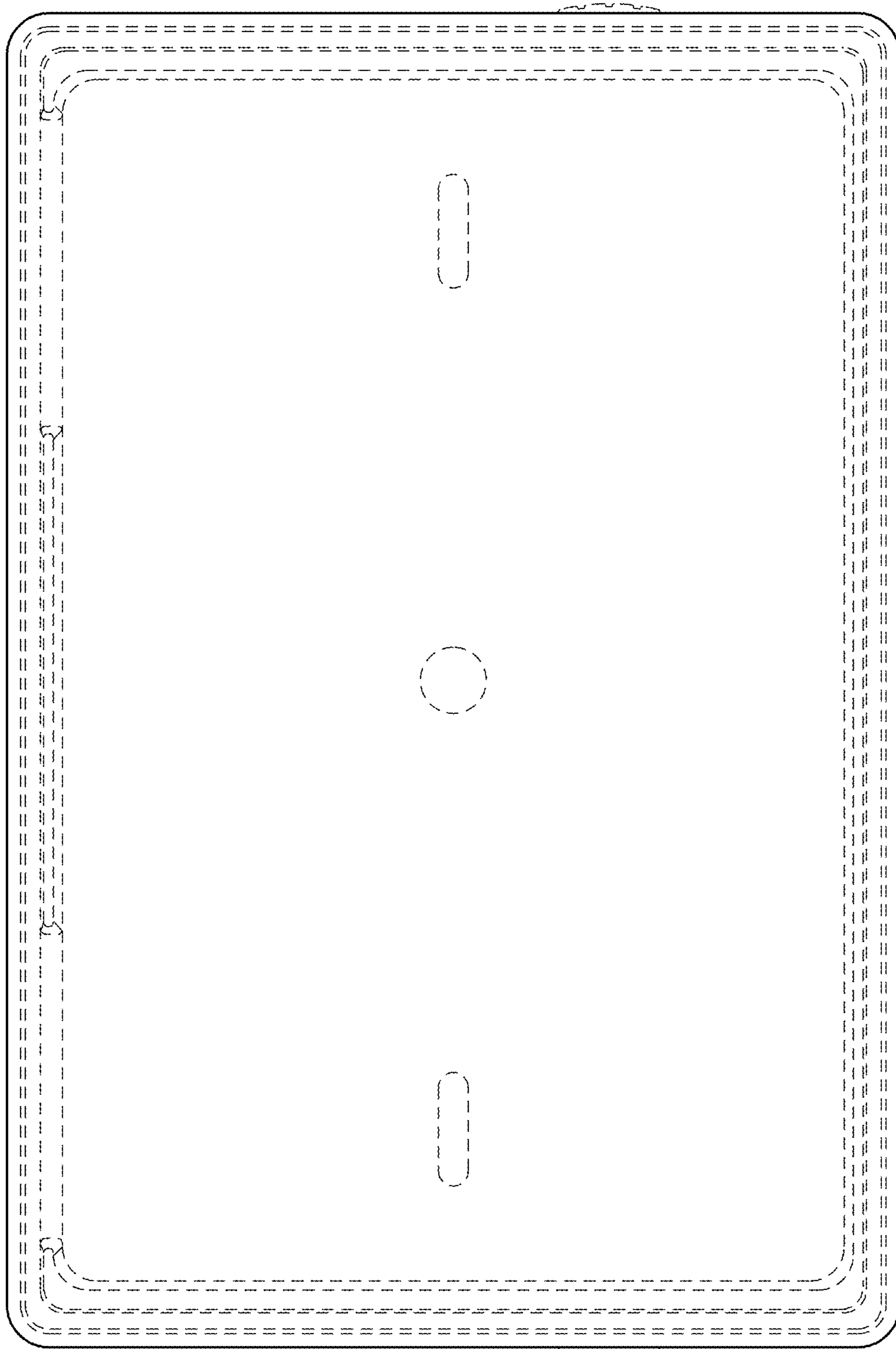

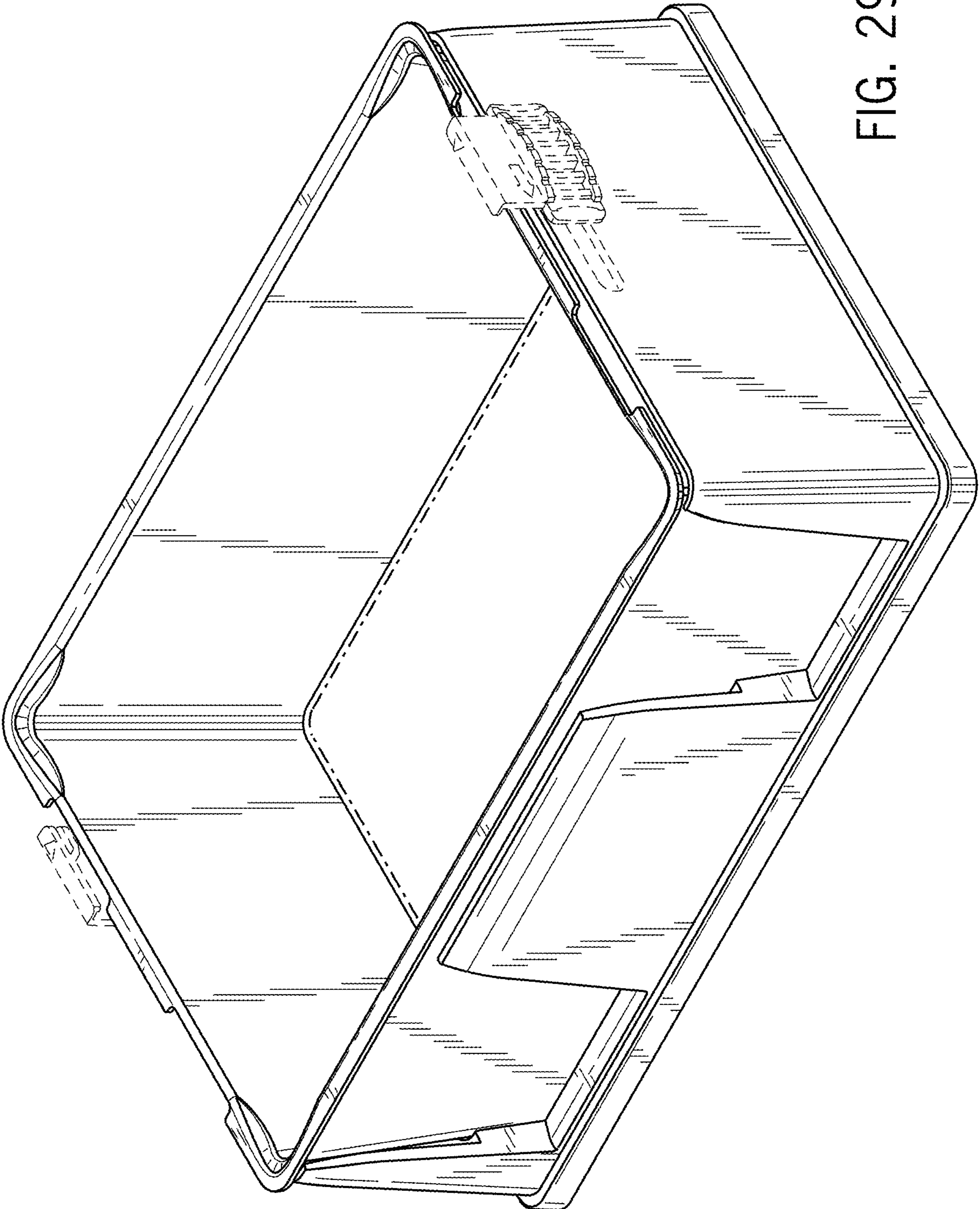
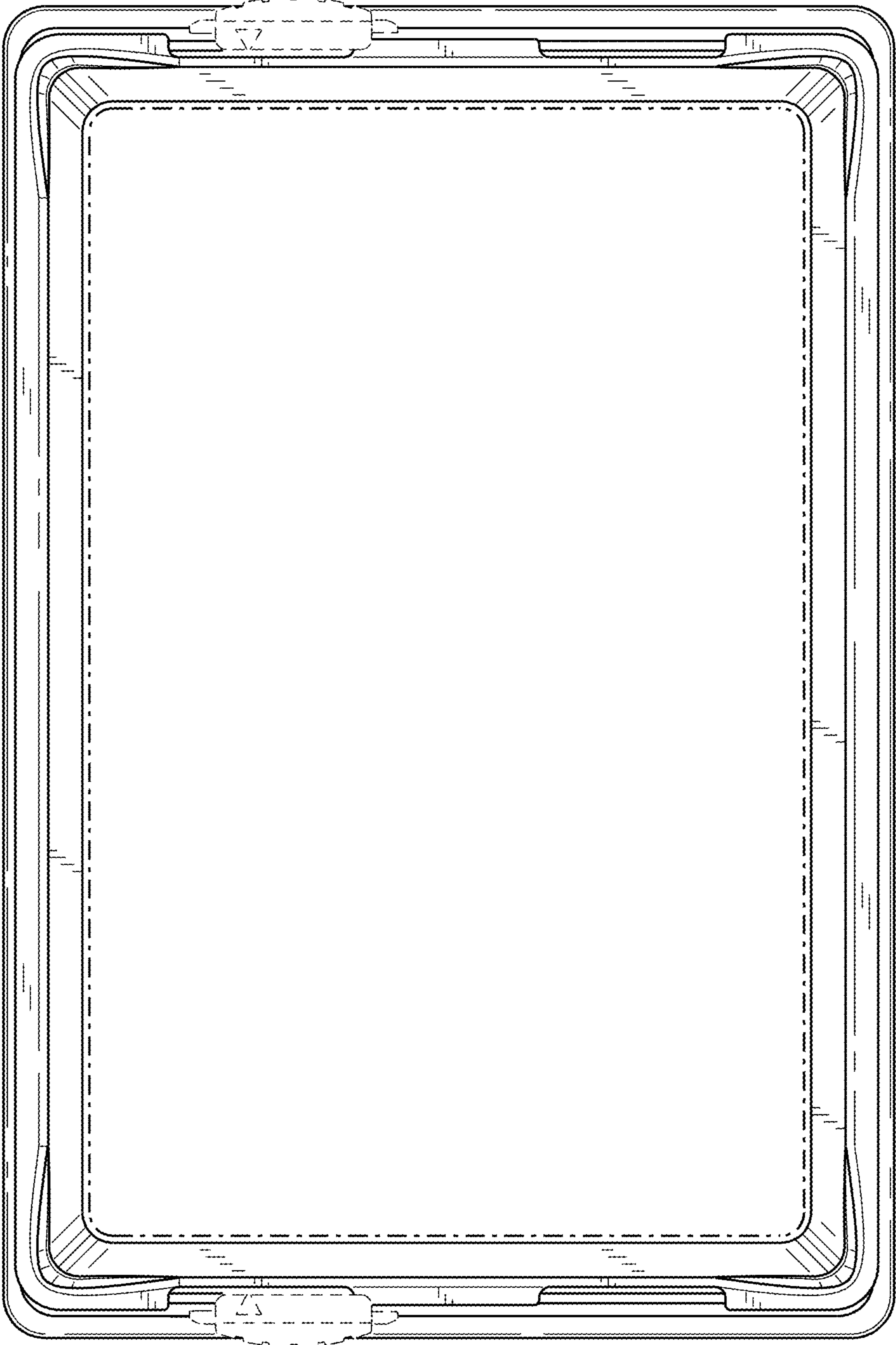

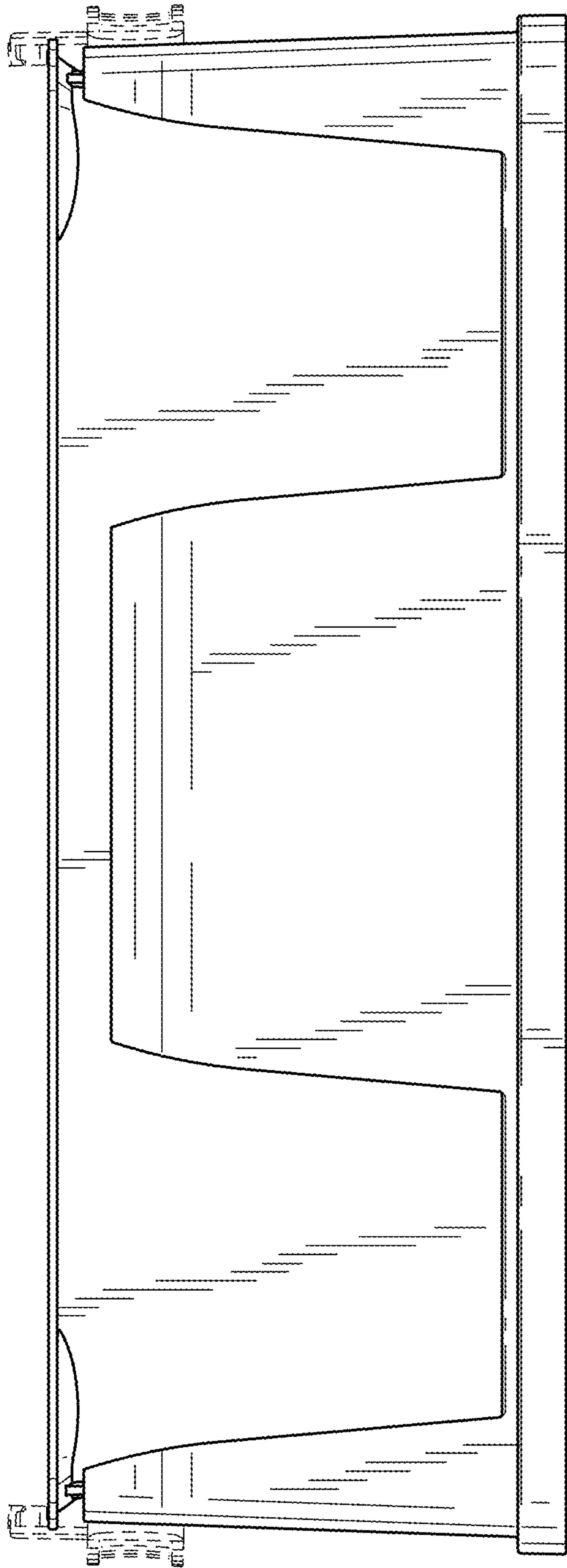

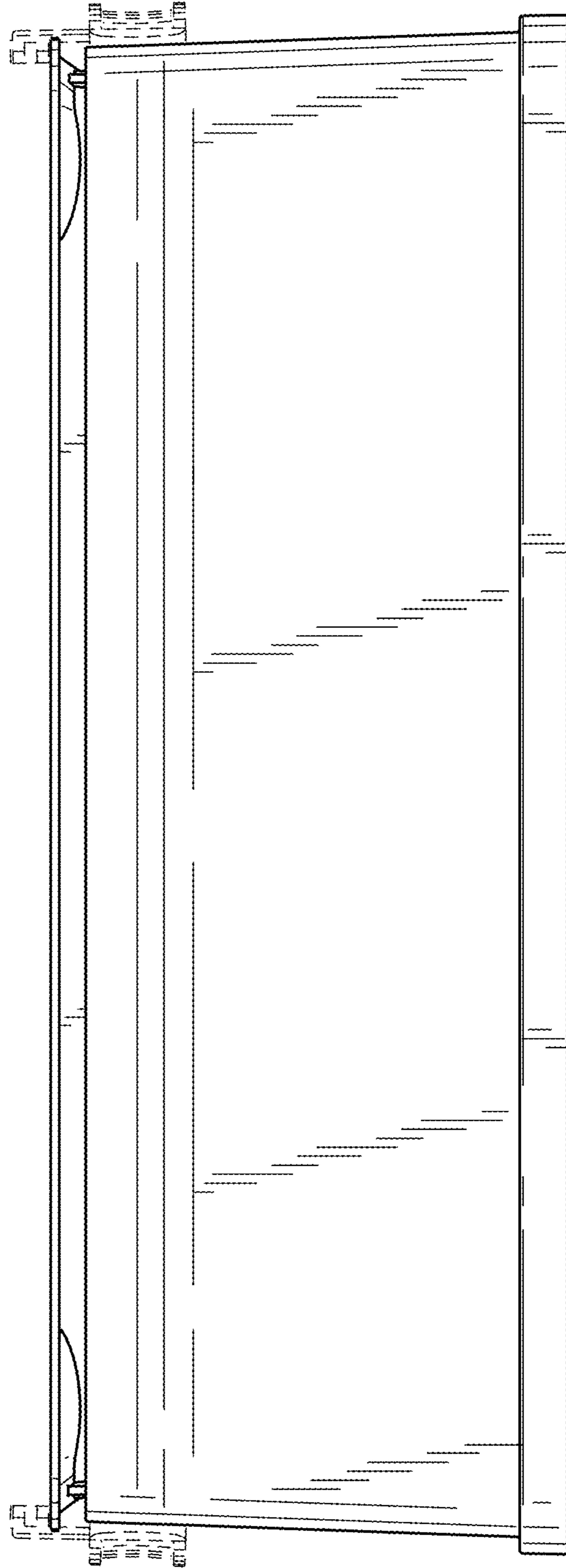

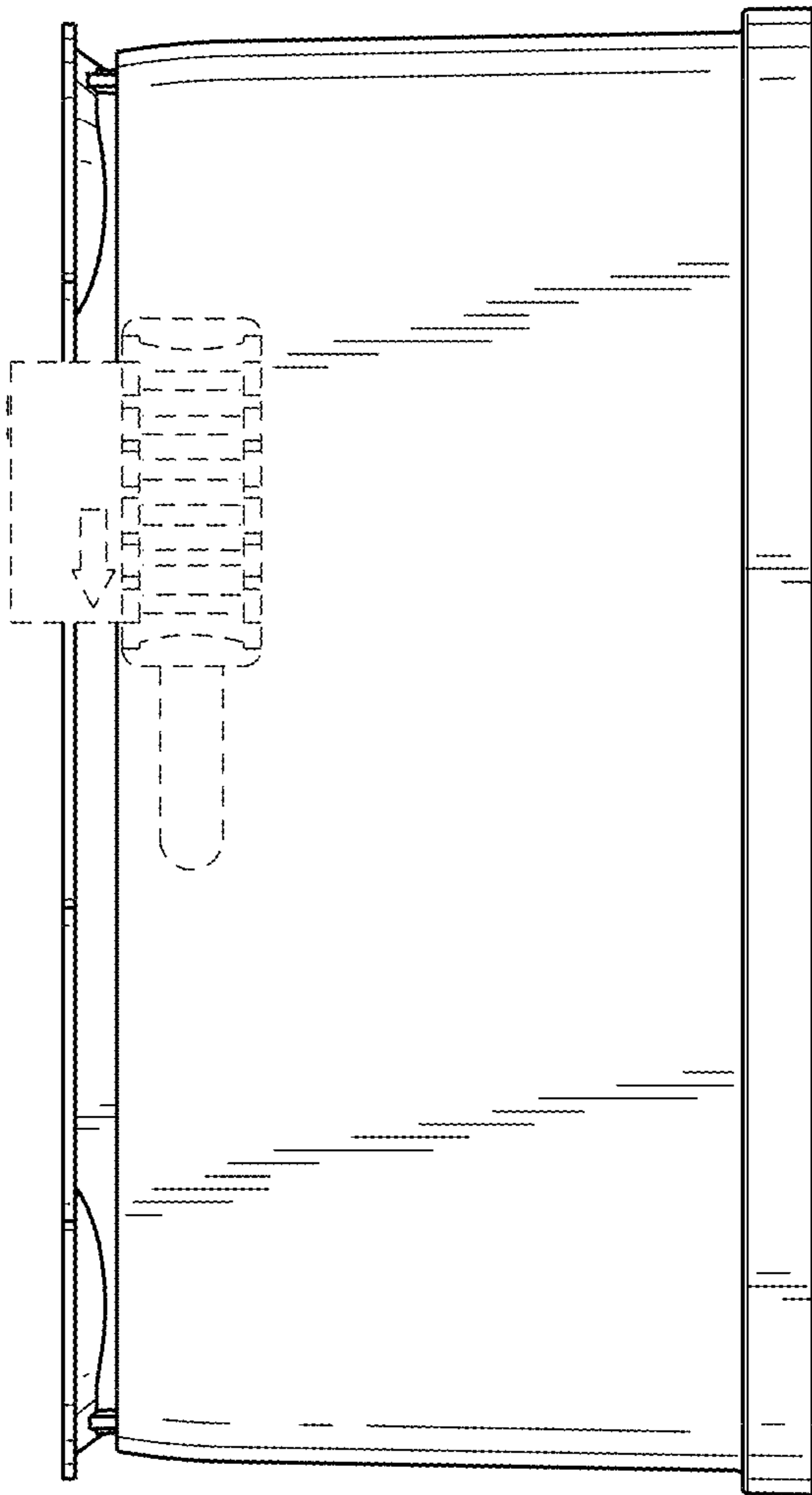

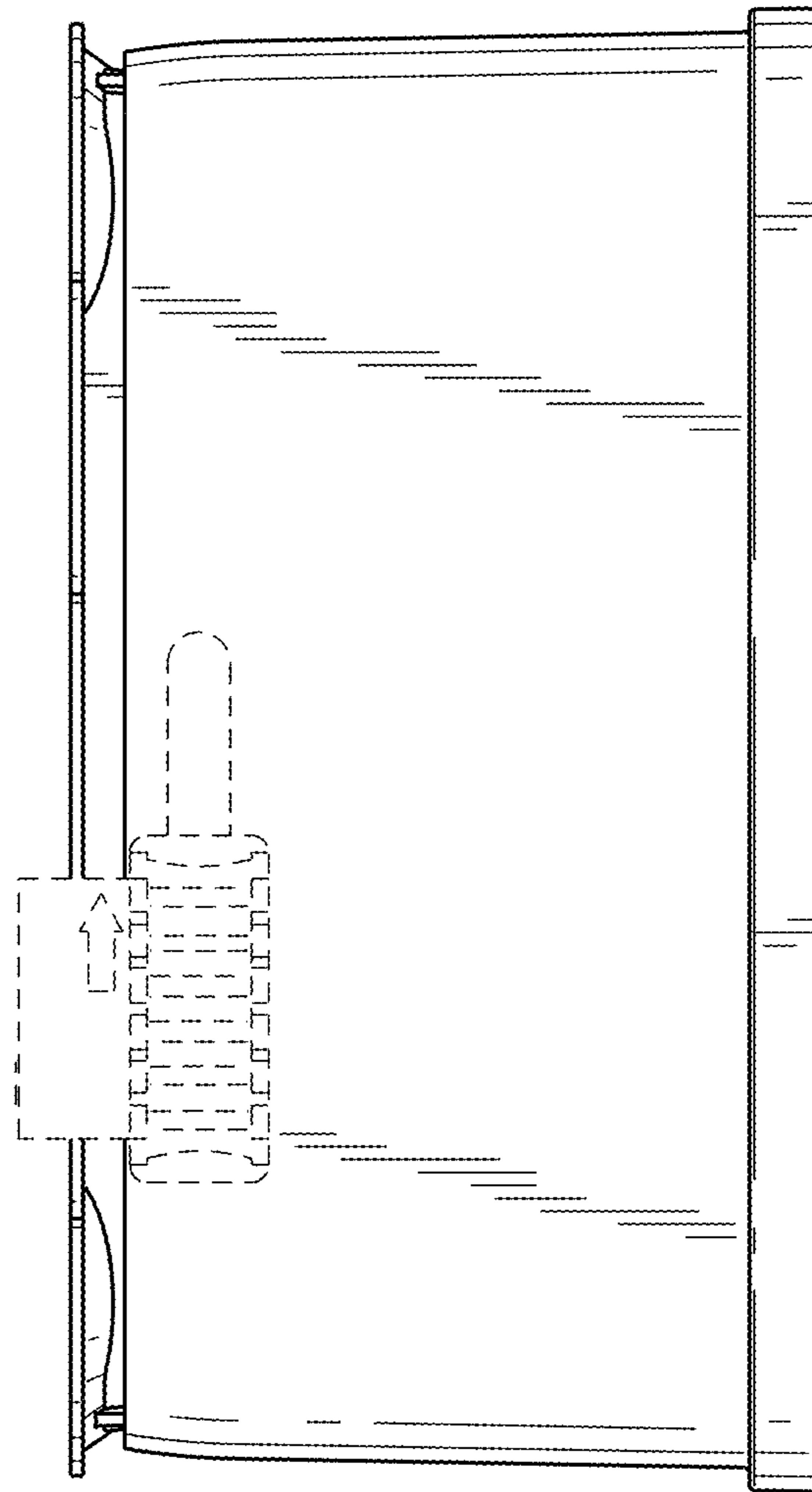

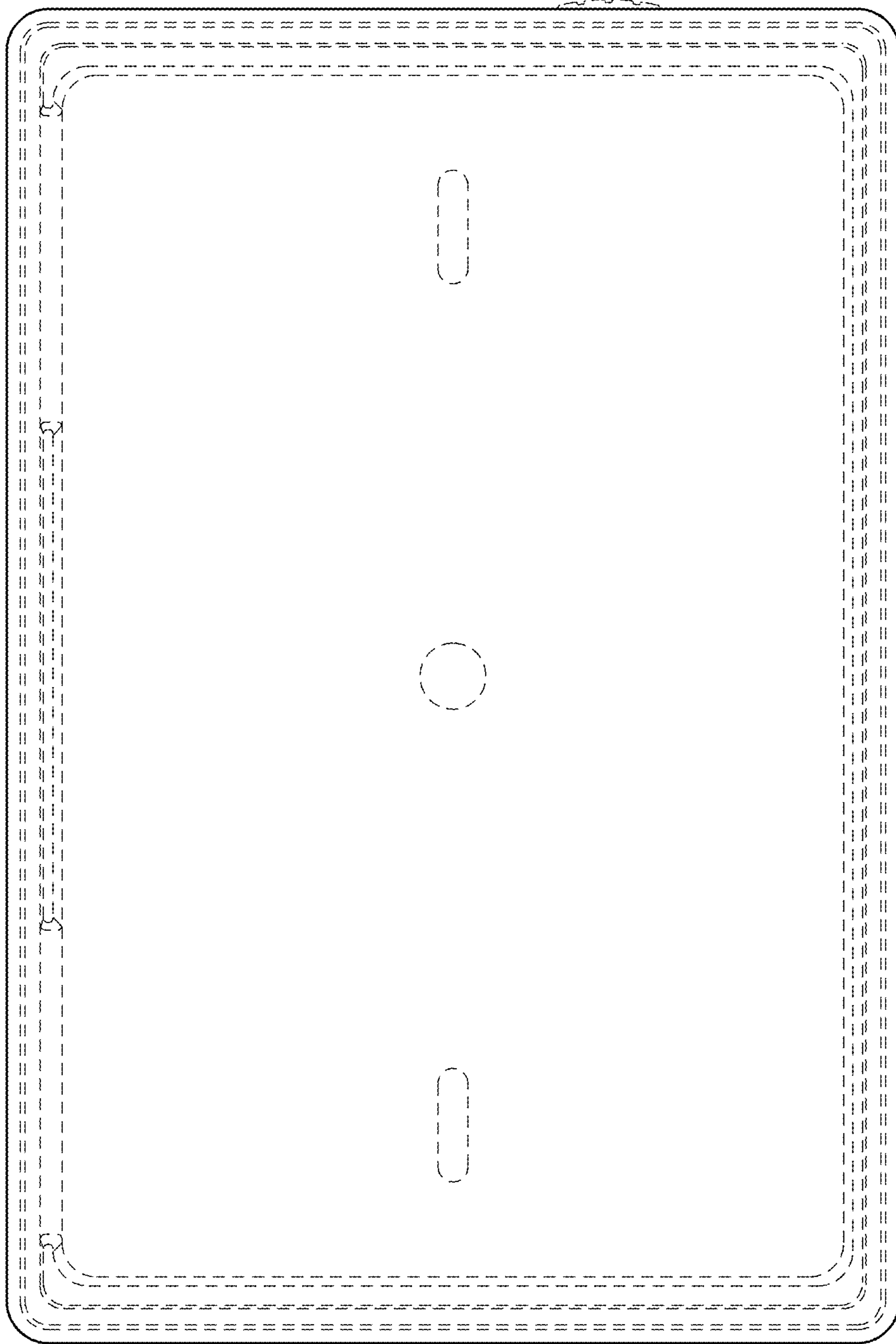

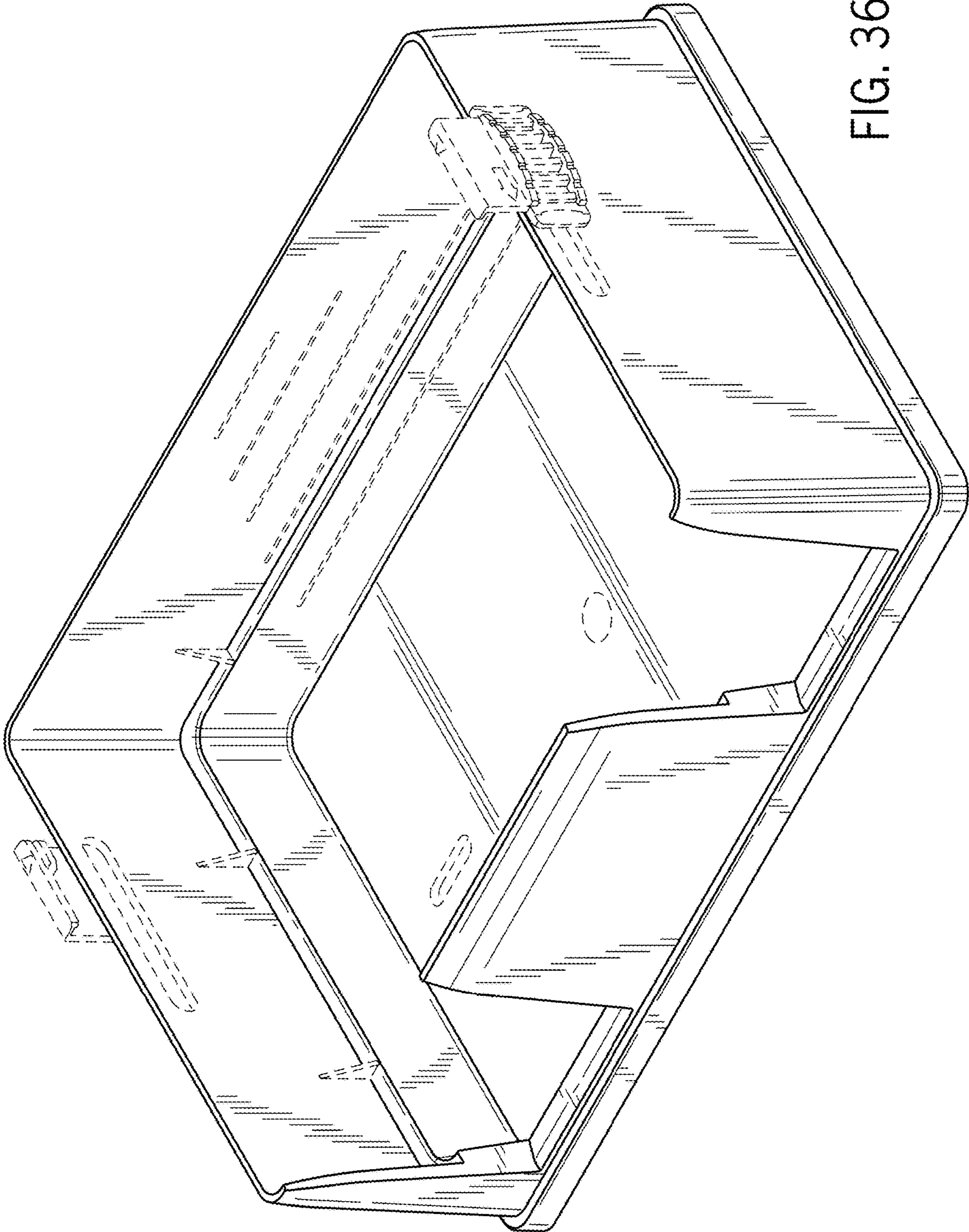
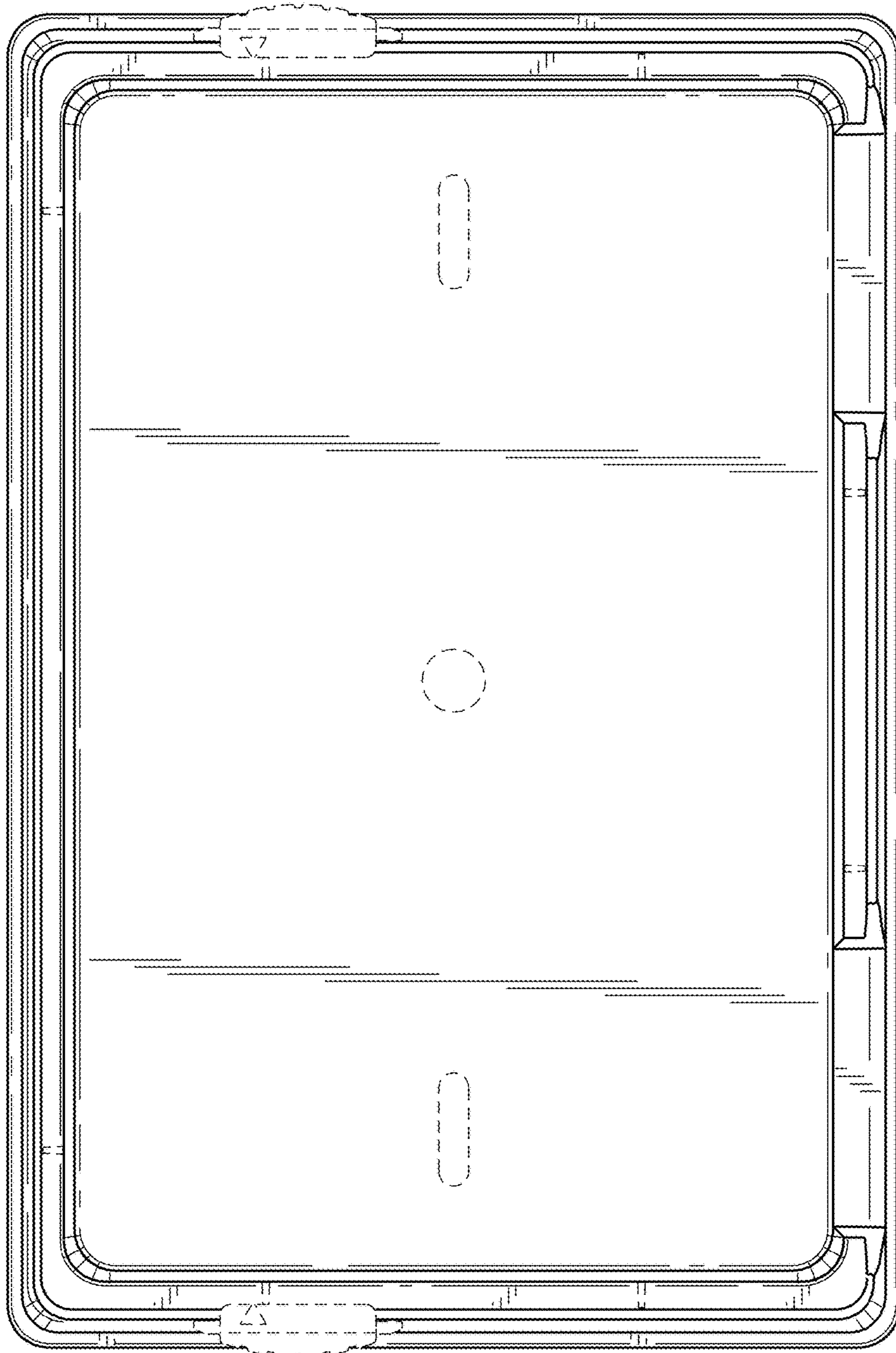

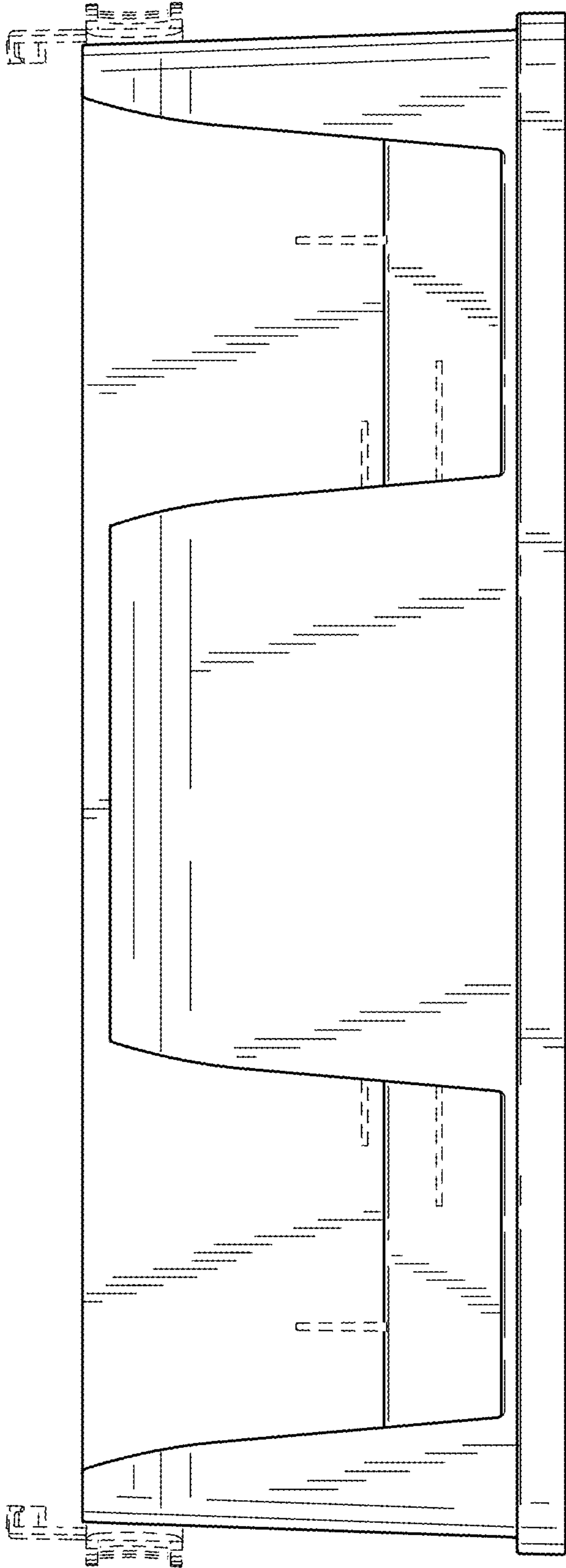

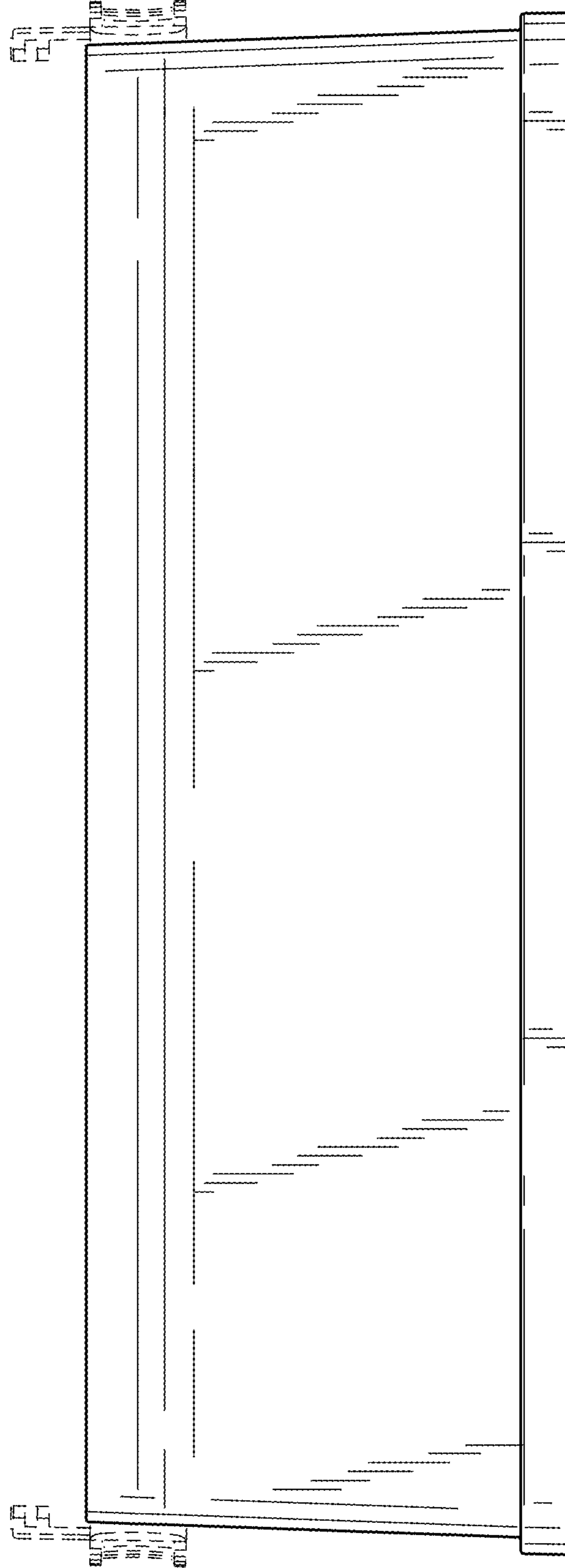

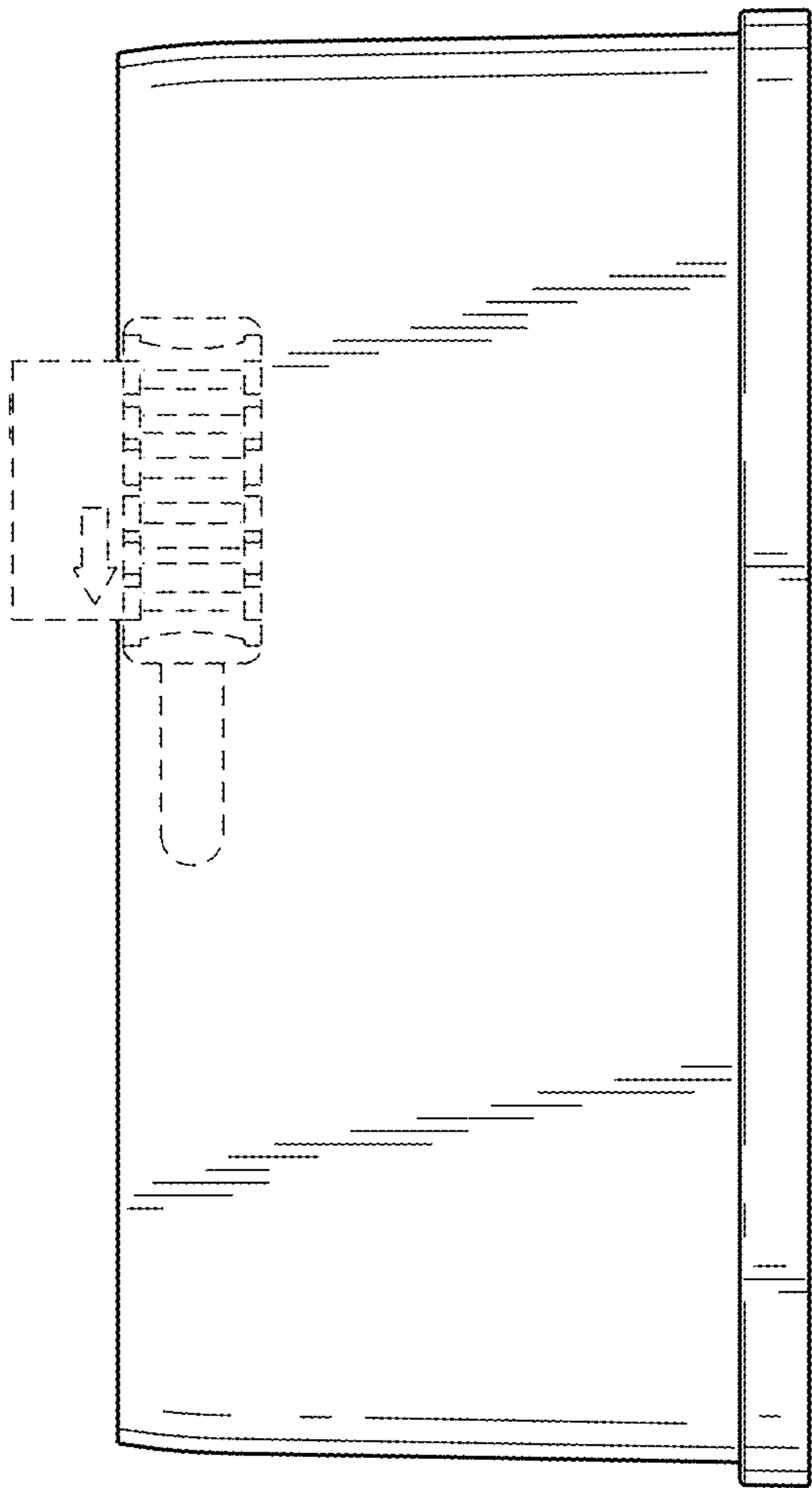

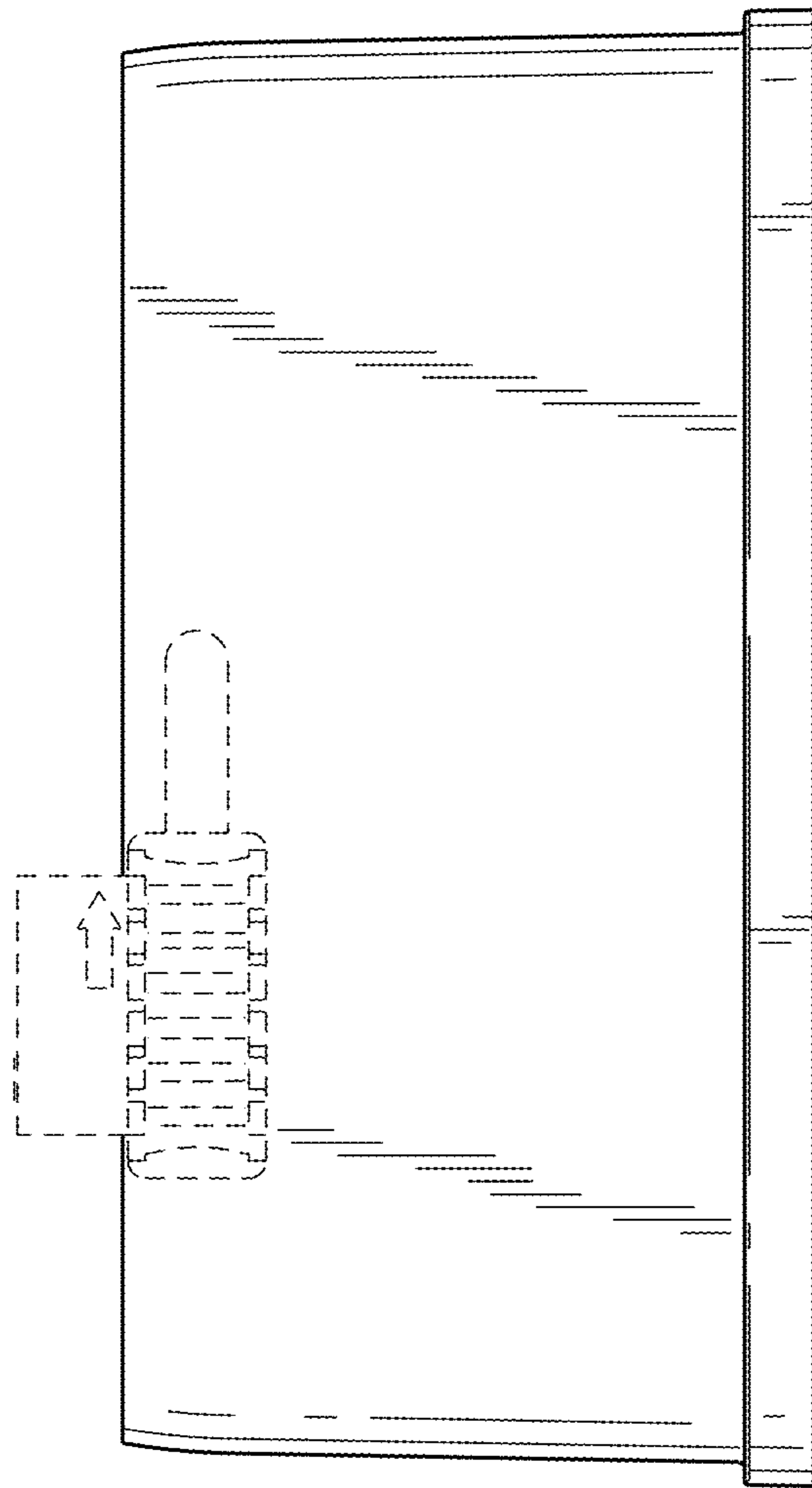

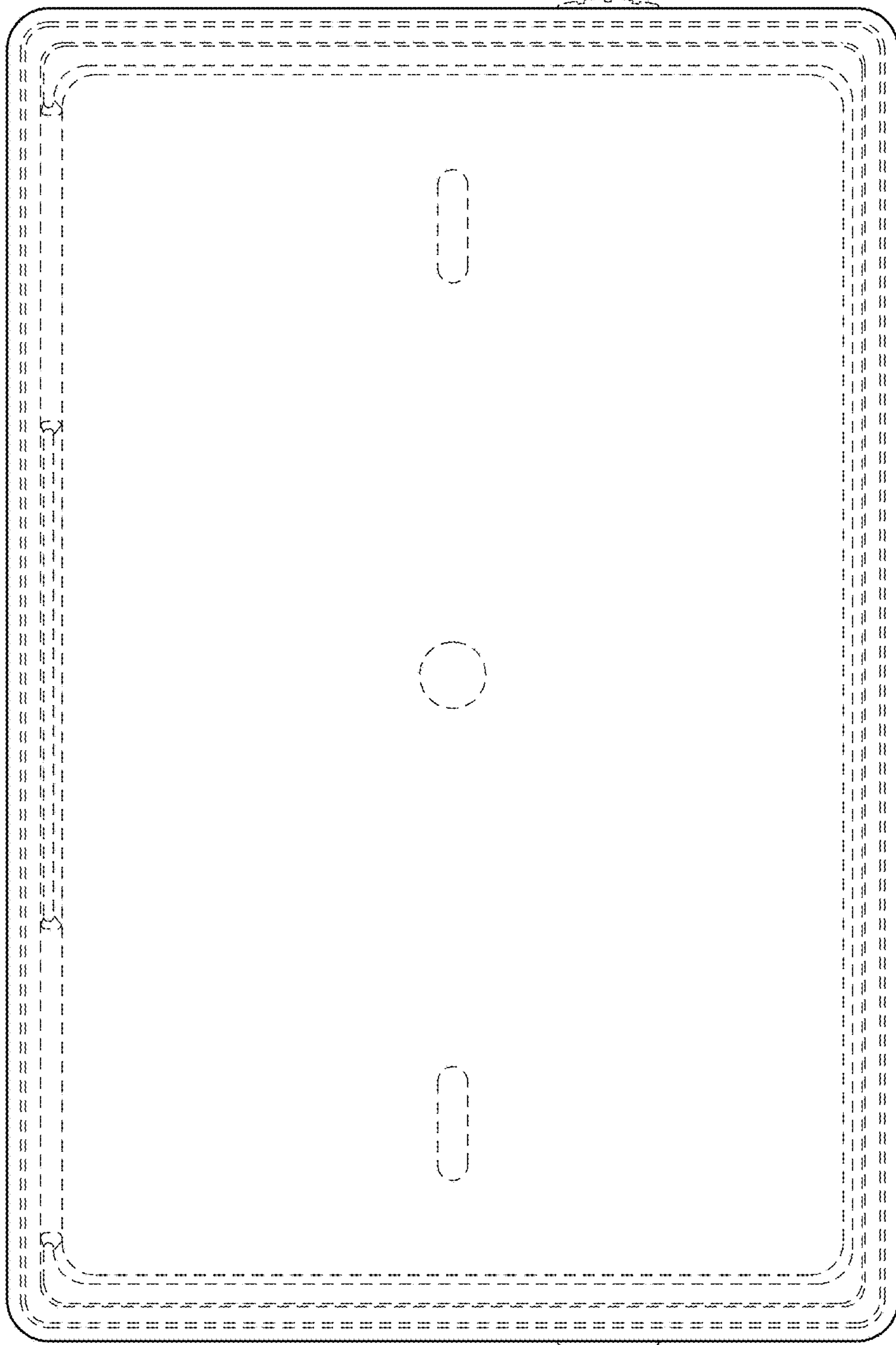
