The ornamental design for a hair curling wand, as shown and described.

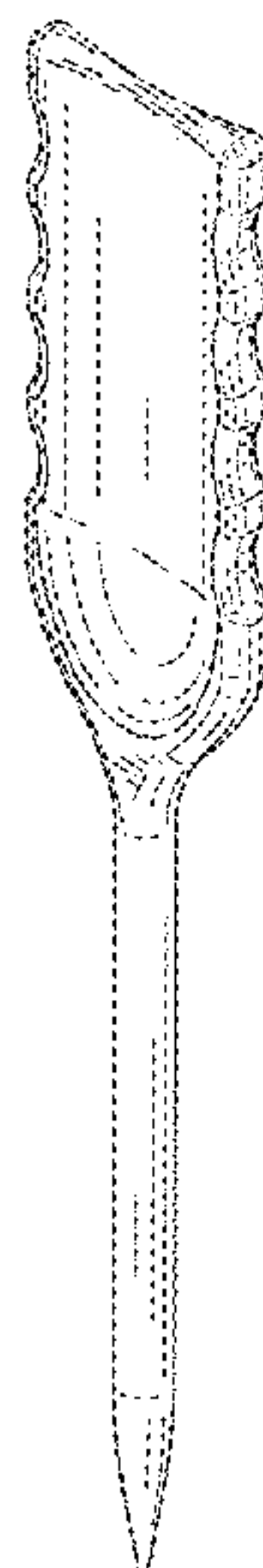
DESCRIPTION

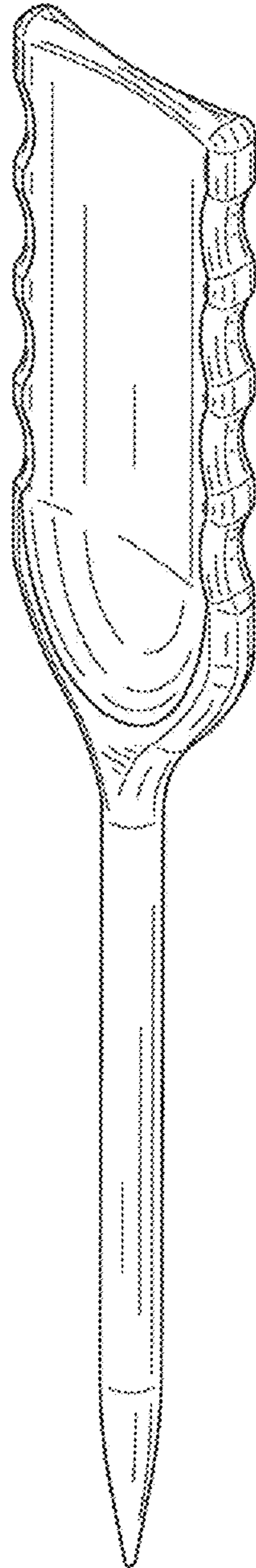

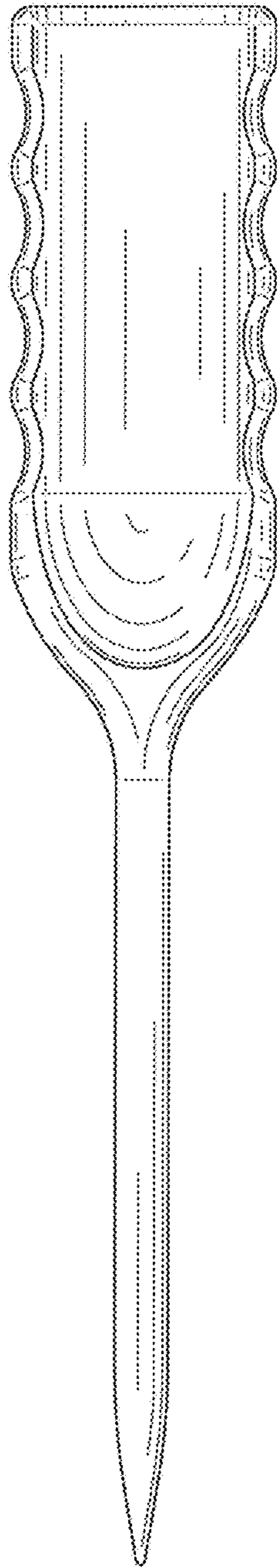

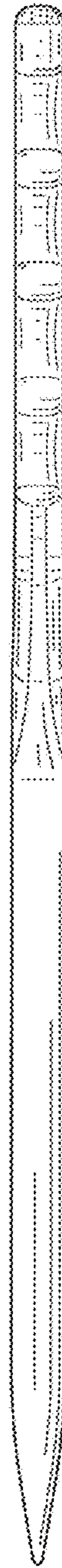

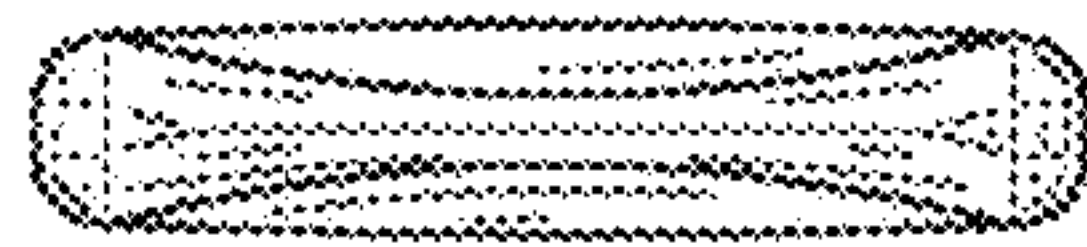
