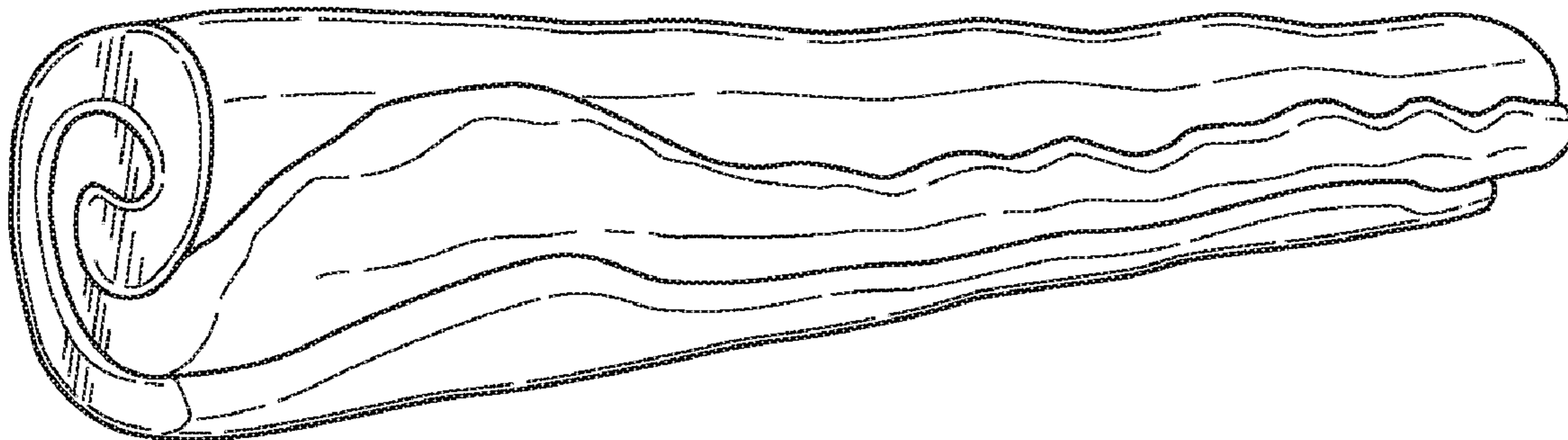
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a non-edible rawhide roll pet toy of the present invention;
FIG. 2 is a left side view of the non-edible rawhide roll pet toy of FIG. 1;

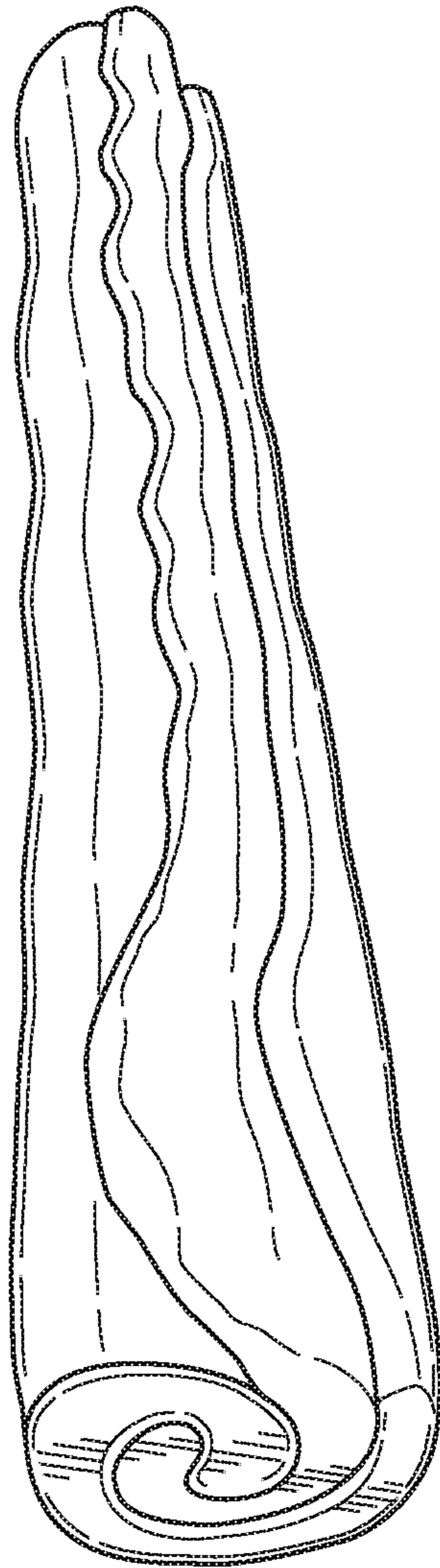

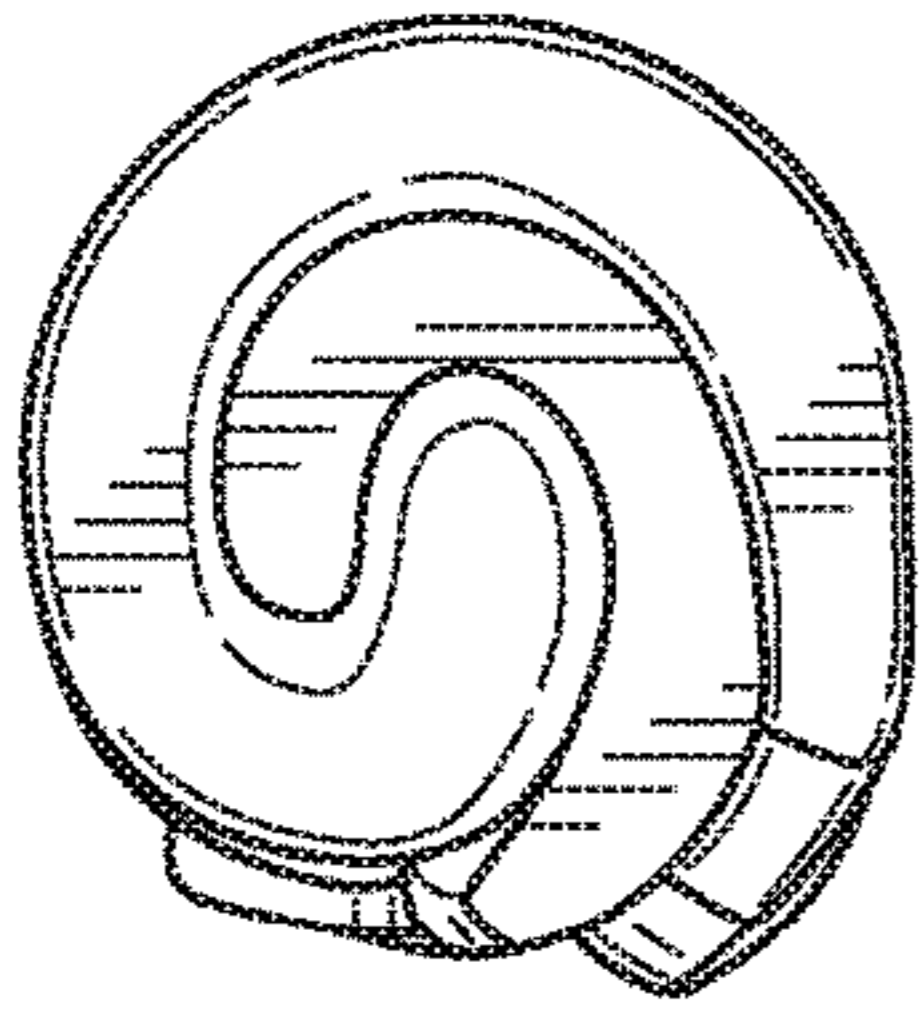

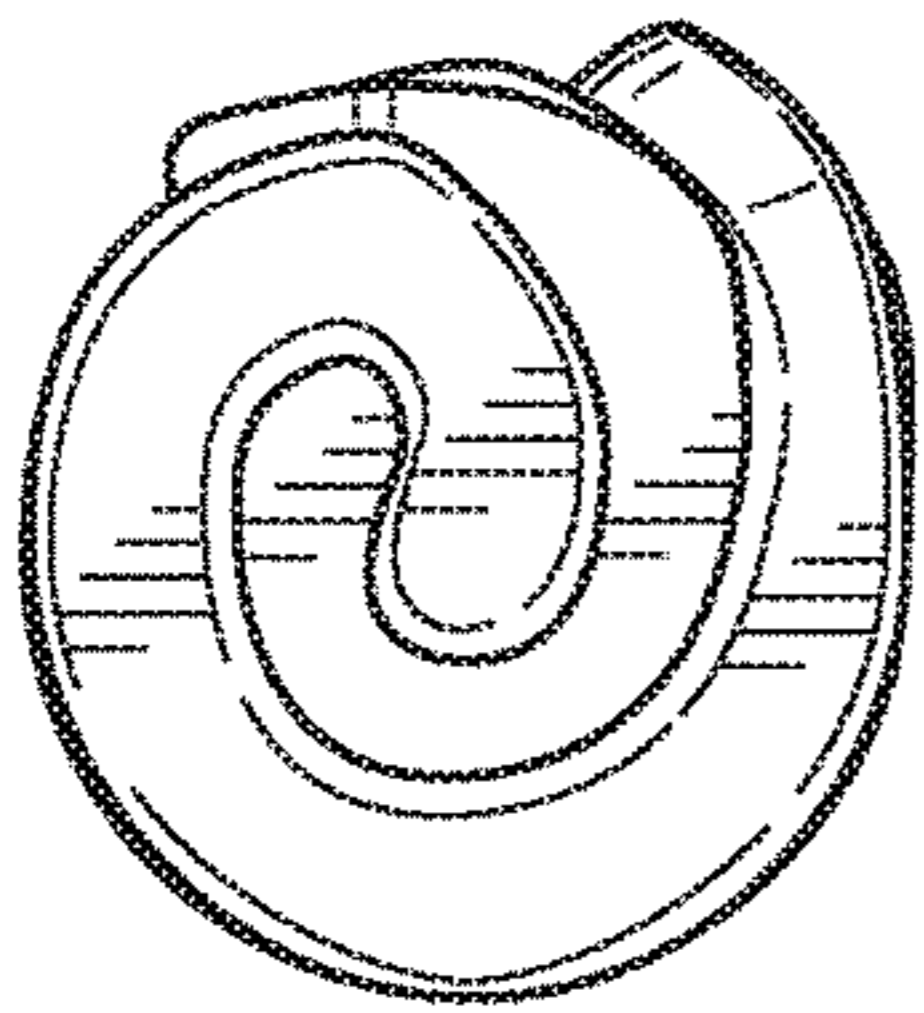

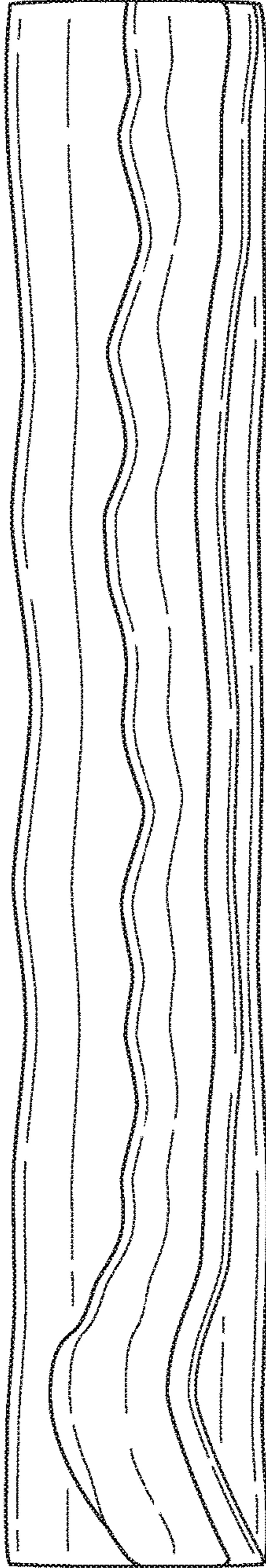

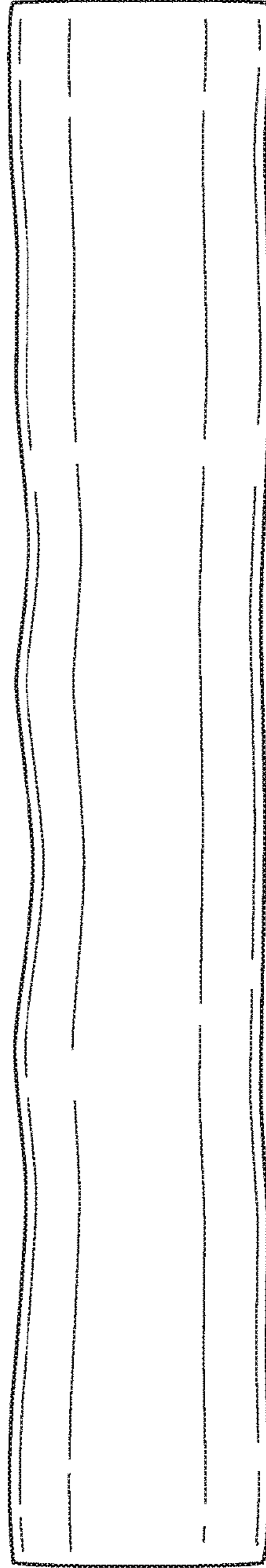

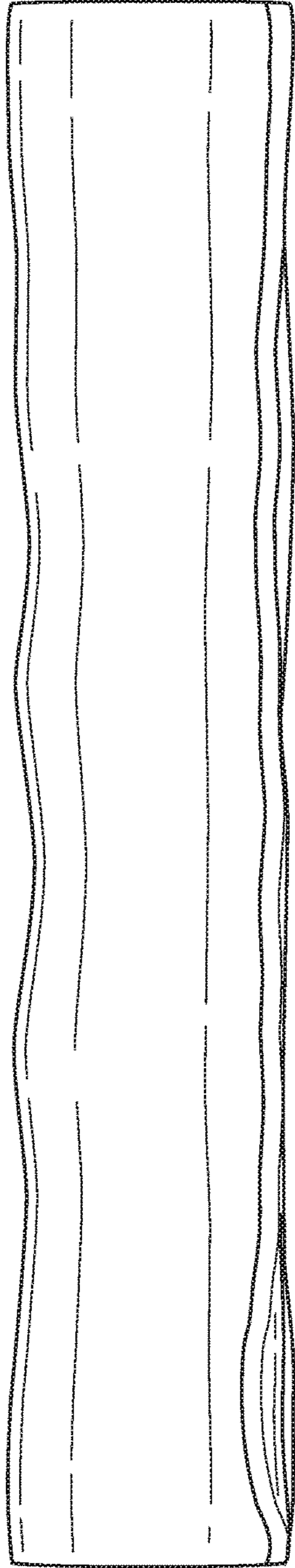

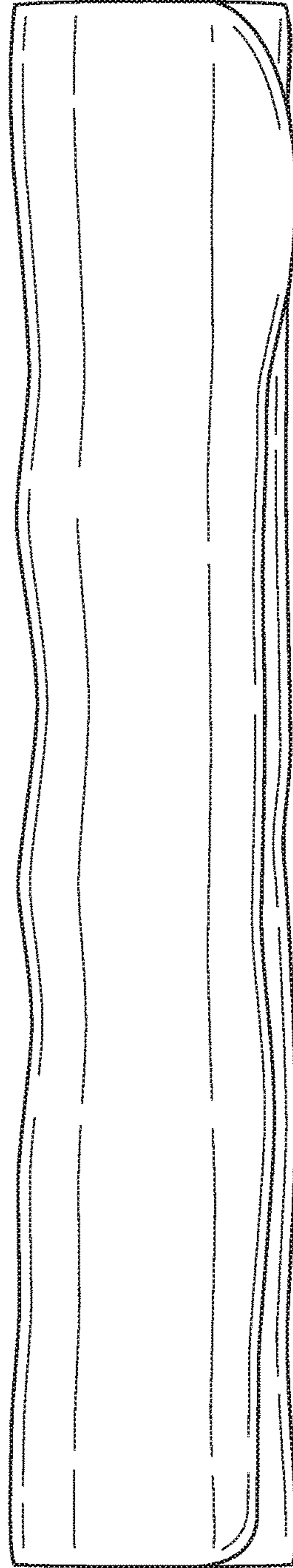
