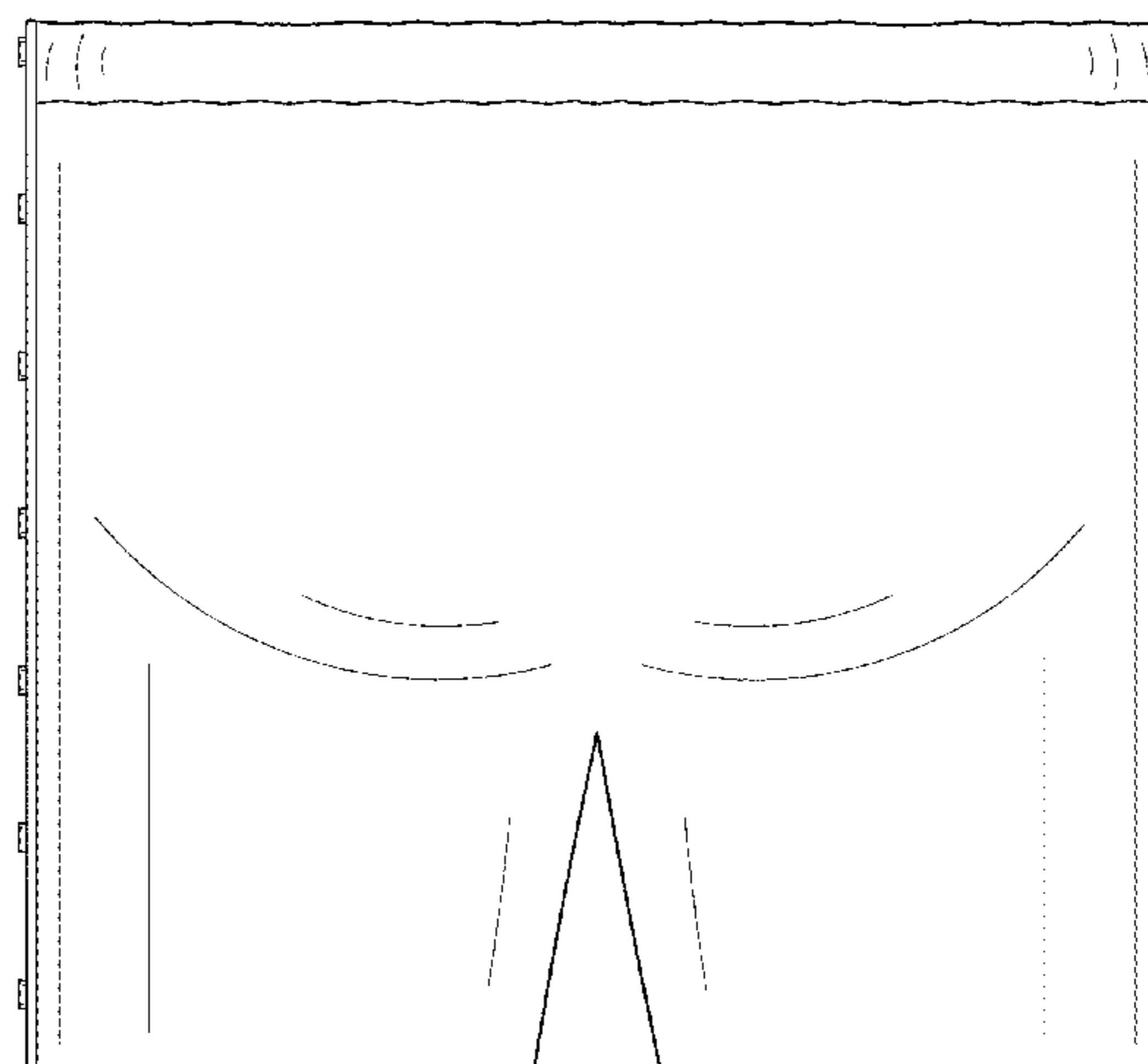
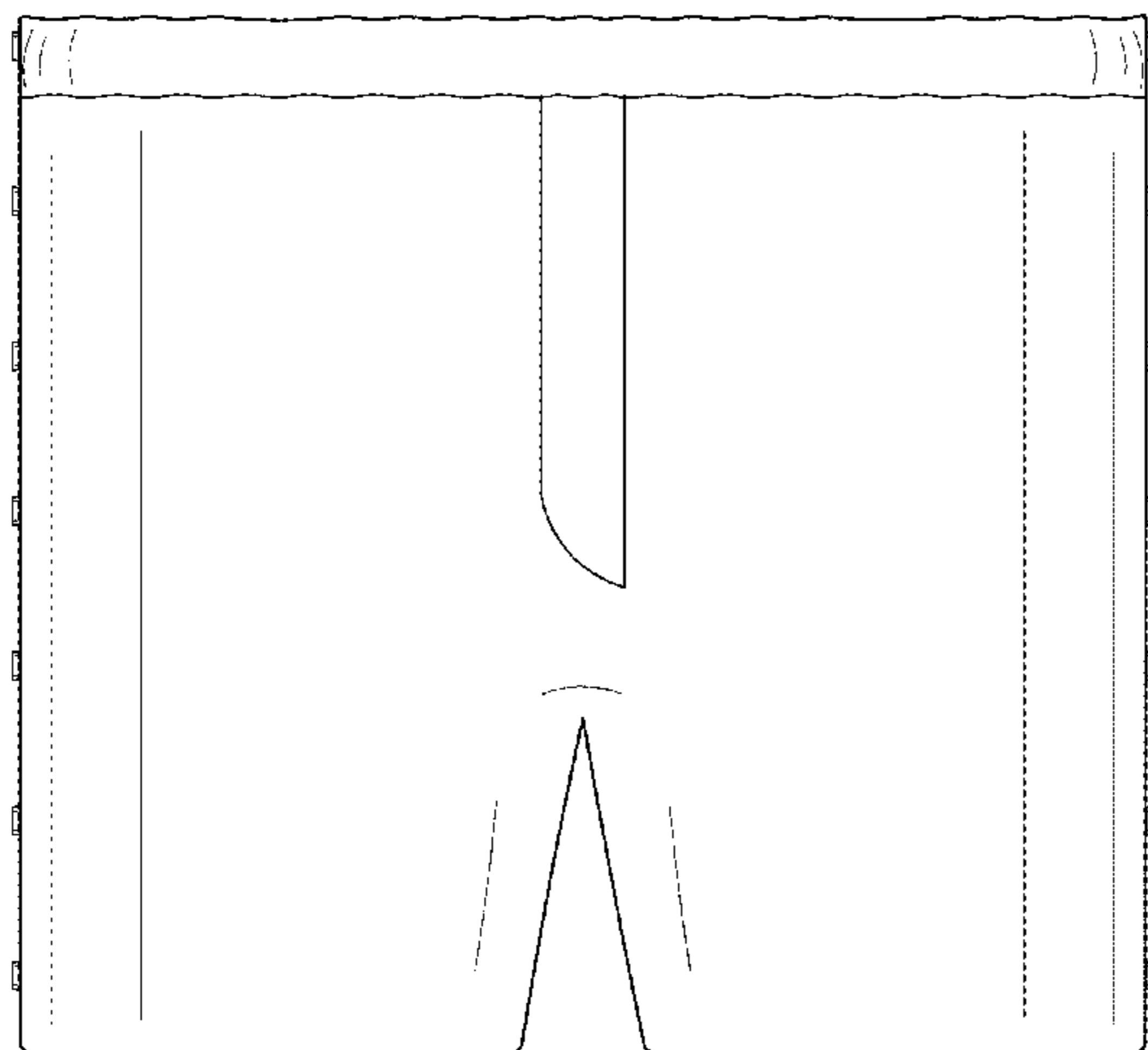
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front view of an underpants showing my new design;  
FIG. 2 is a rear view of the underpants;  
FIG. 3 is a left side view of the underpants;  
FIG. 4 is a right side view of the underpants;  
FIG. 5 is a top view of the underpants; and,  
FIG. 6 is a bottom view of the underpants.

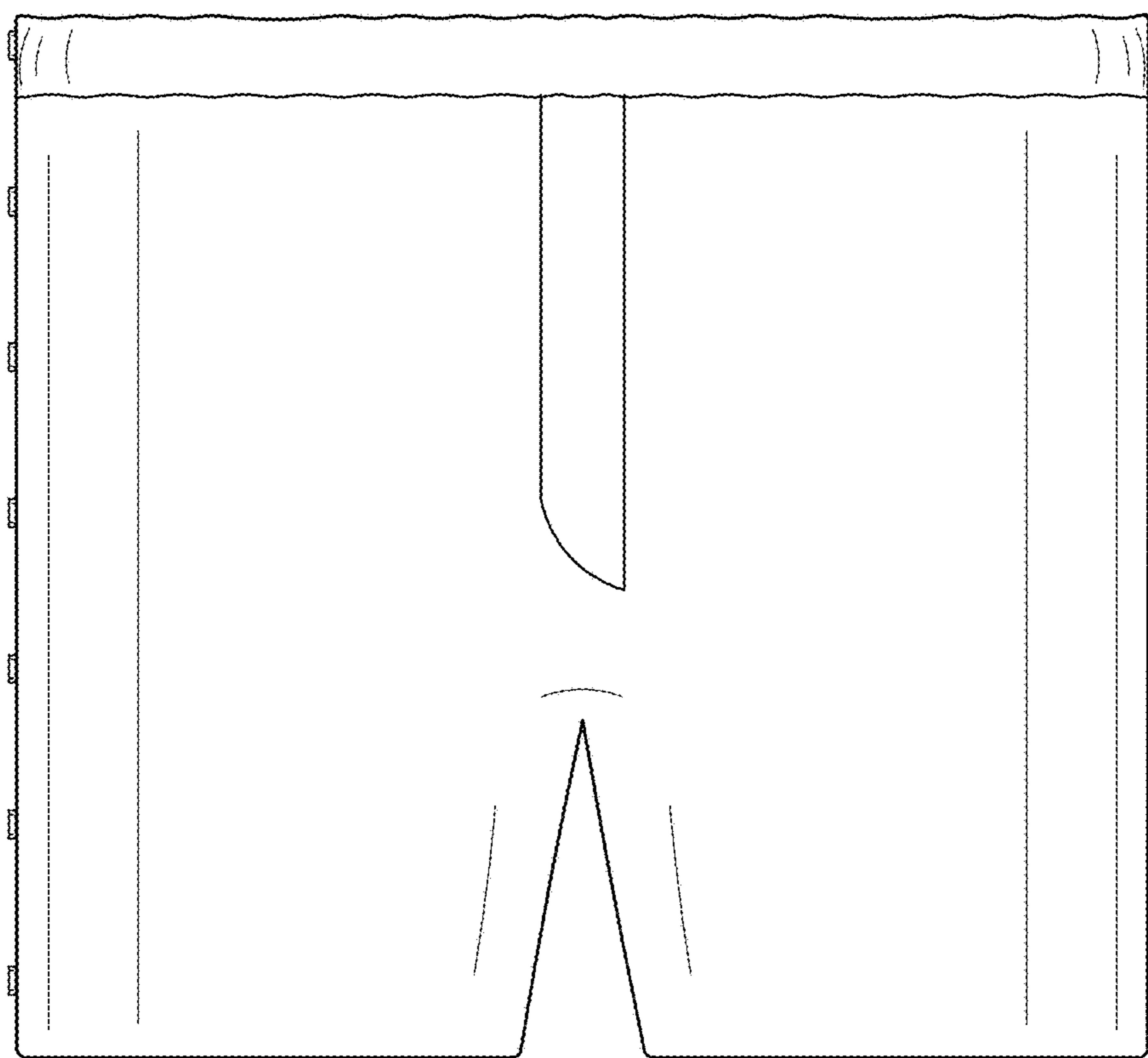

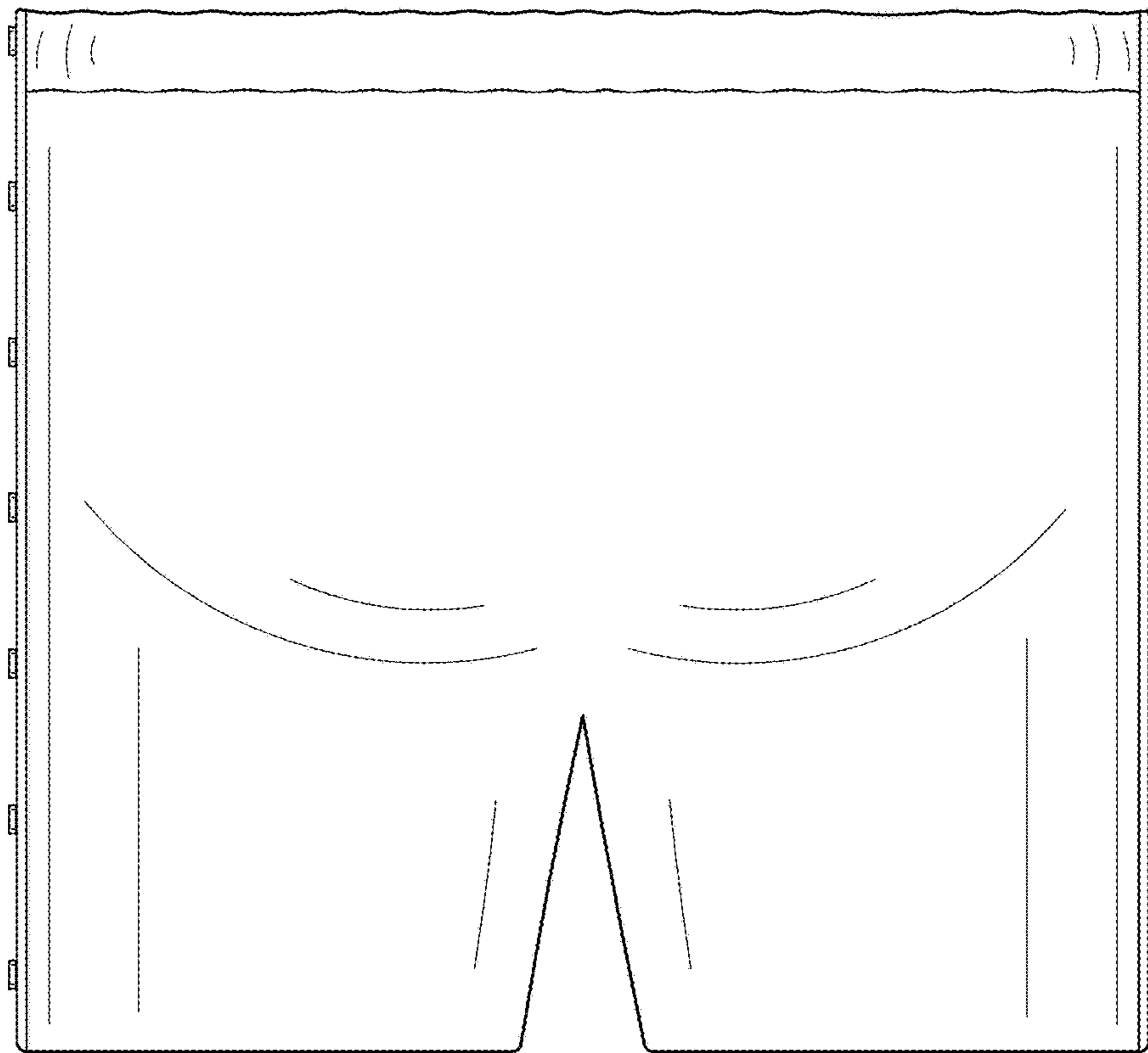

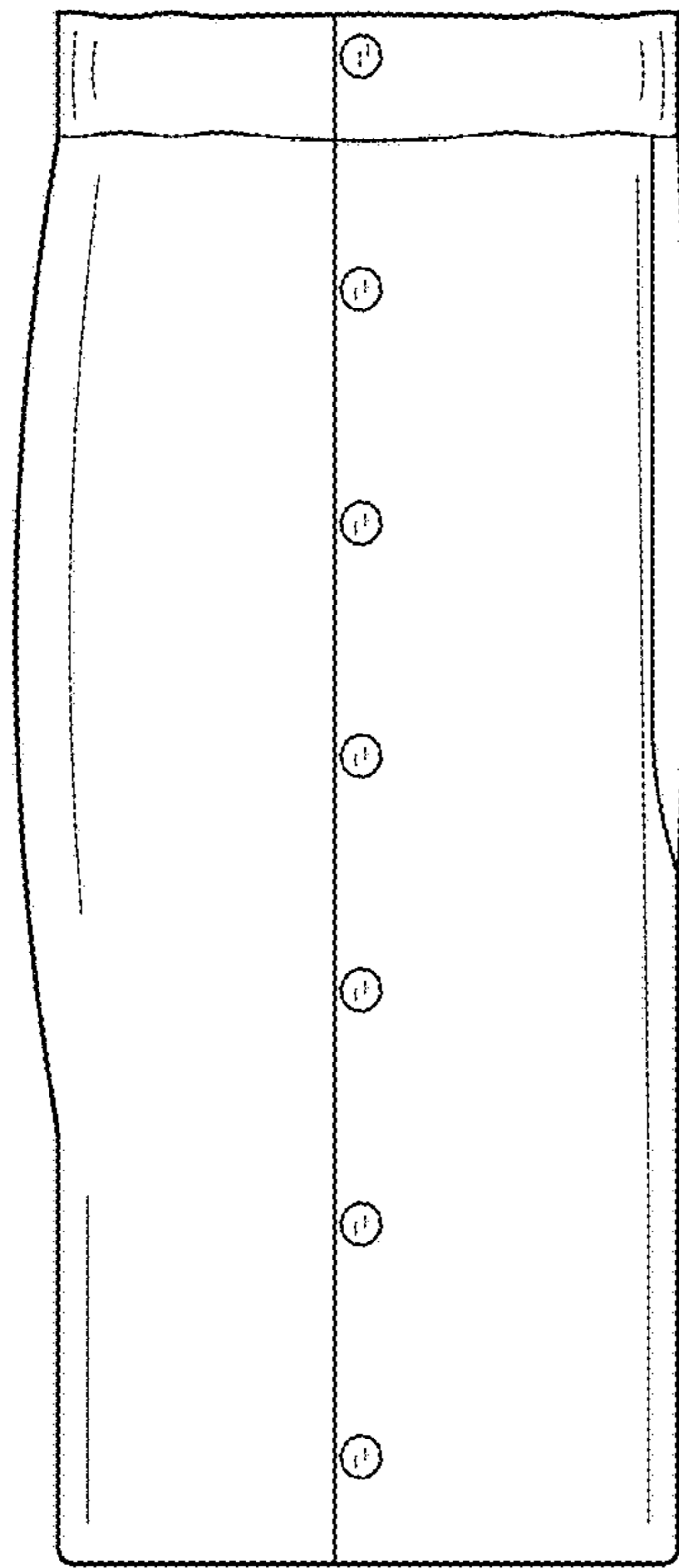

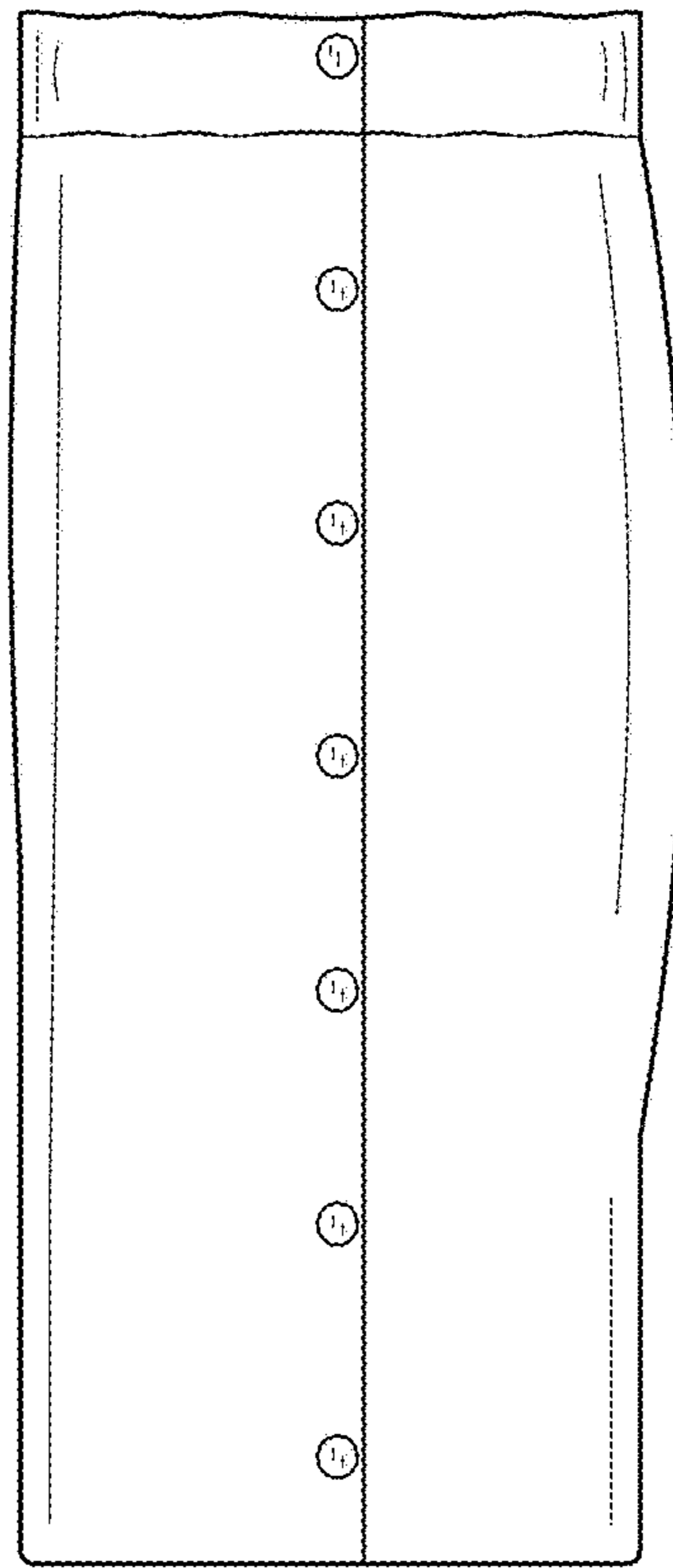

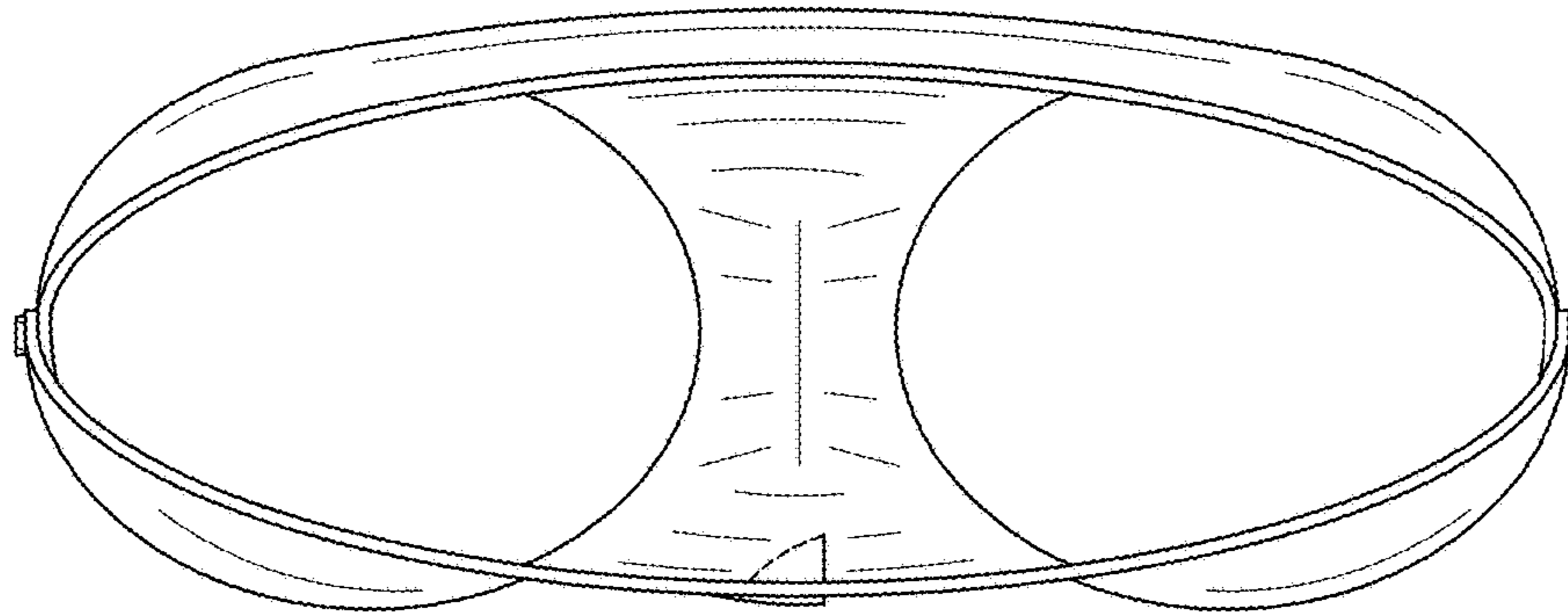

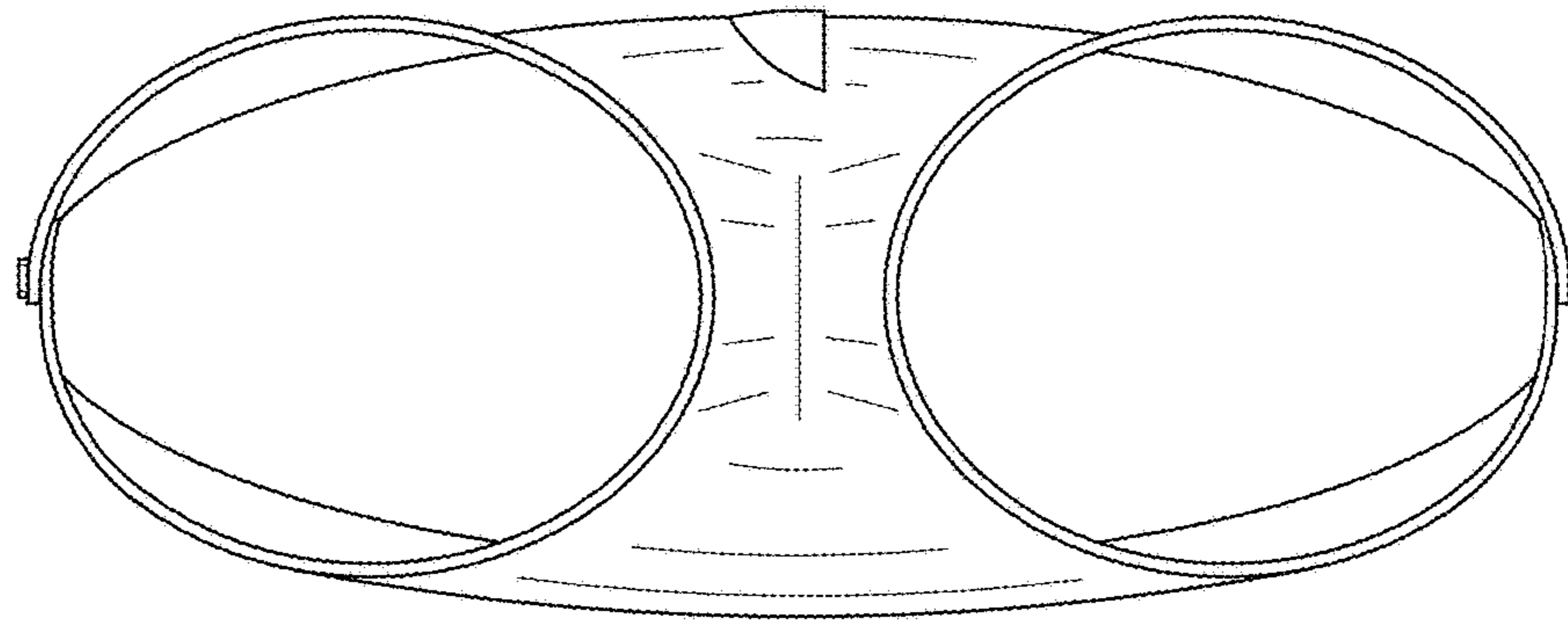
