(57) **CLAIM**

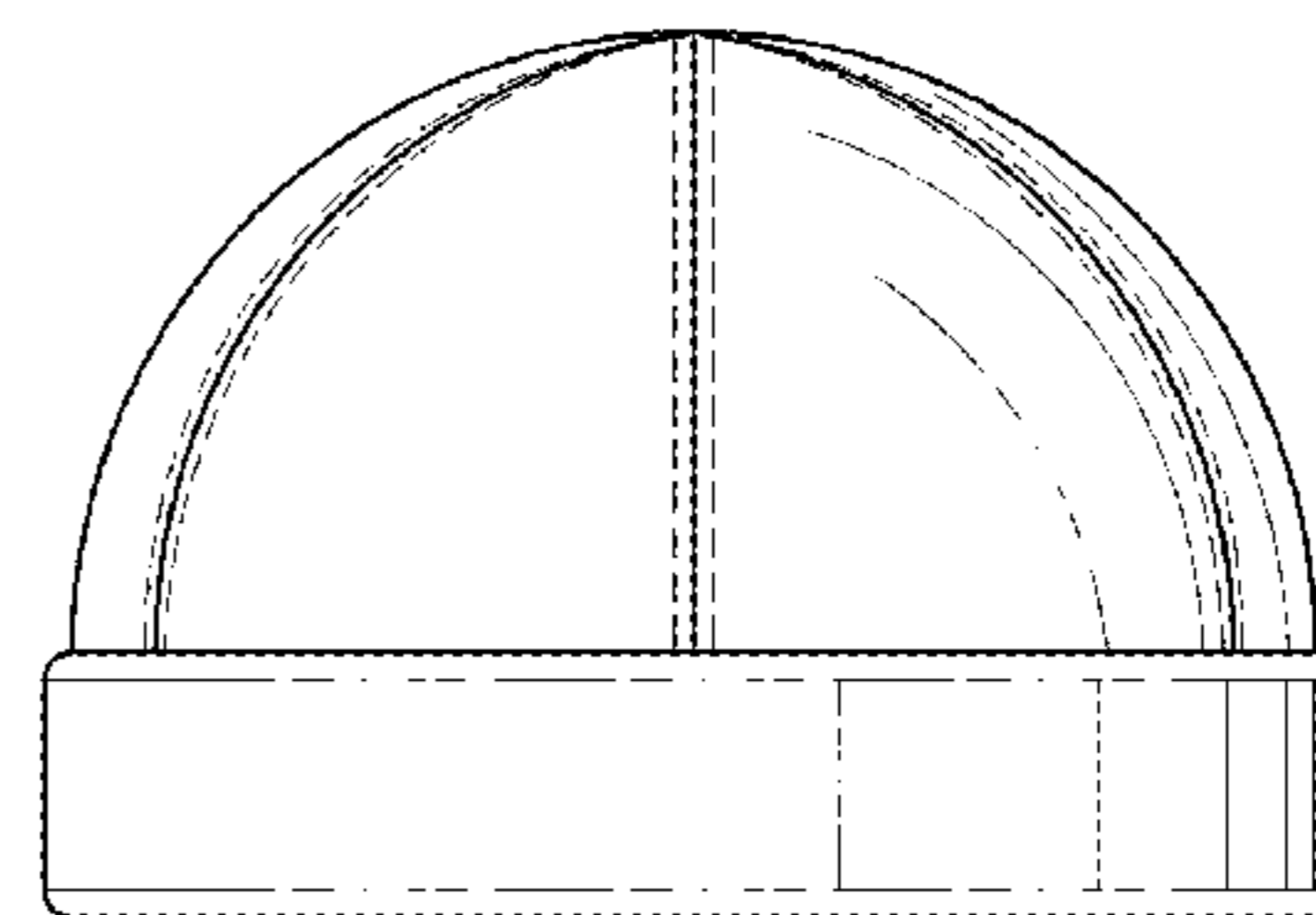
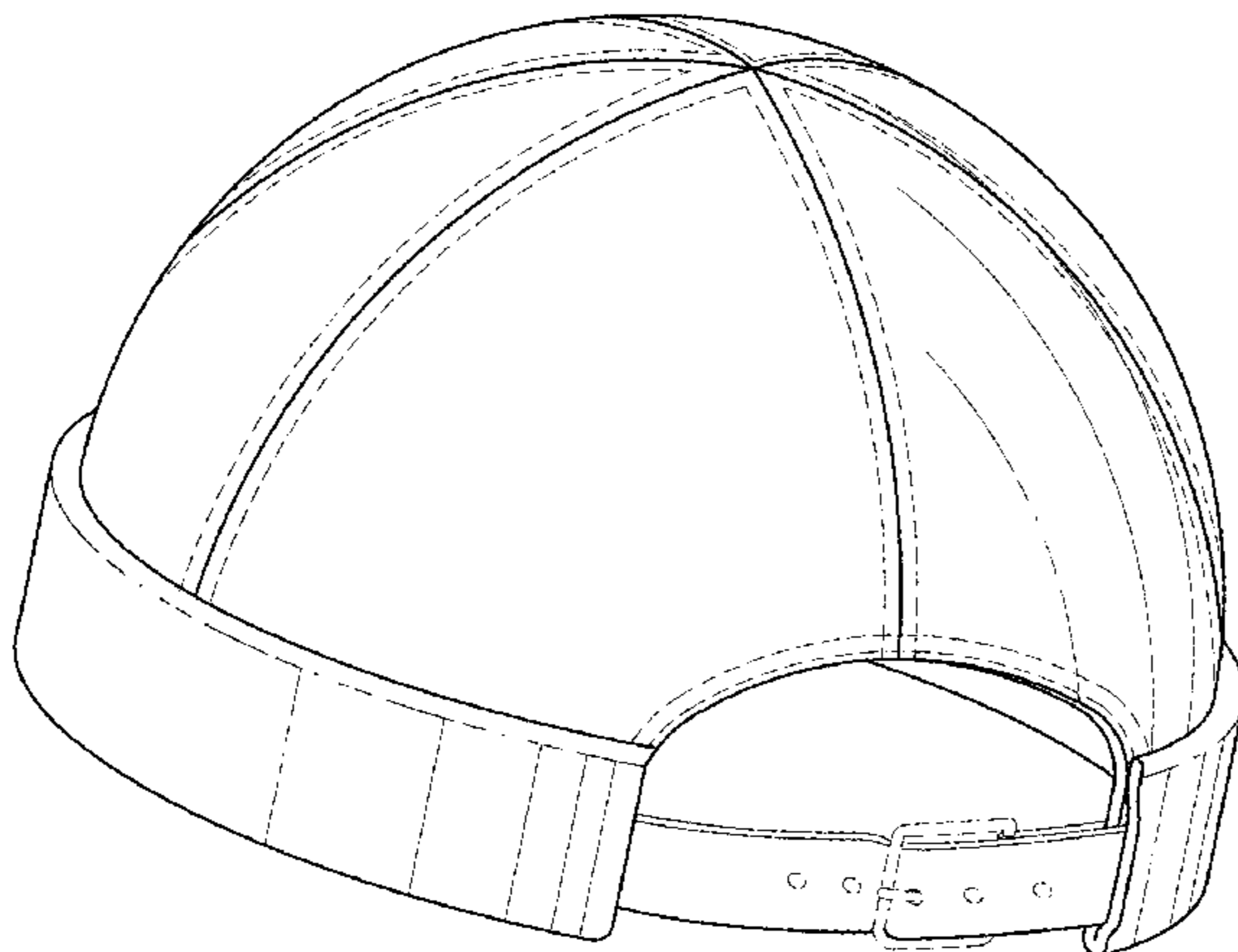
I claim the ornamental design for a cap, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a cap showing my new design;
FIG. 2 is a front elevation view of the cap illustrated in FIG. 1;
FIG. 3 is a rear elevation view of the cap illustrated in FIG. 1;
FIG. 4 is a first side elevation view of the cap illustrated in FIG. 1;
FIG. 5 is a second side elevation view of the cap illustrated in FIG. 1;
FIG. 6 is a top plan view of the cap illustrated in FIG. 1; and,
FIG. 7 is a bottom plan view of the cap illustrated in FIG. 1.

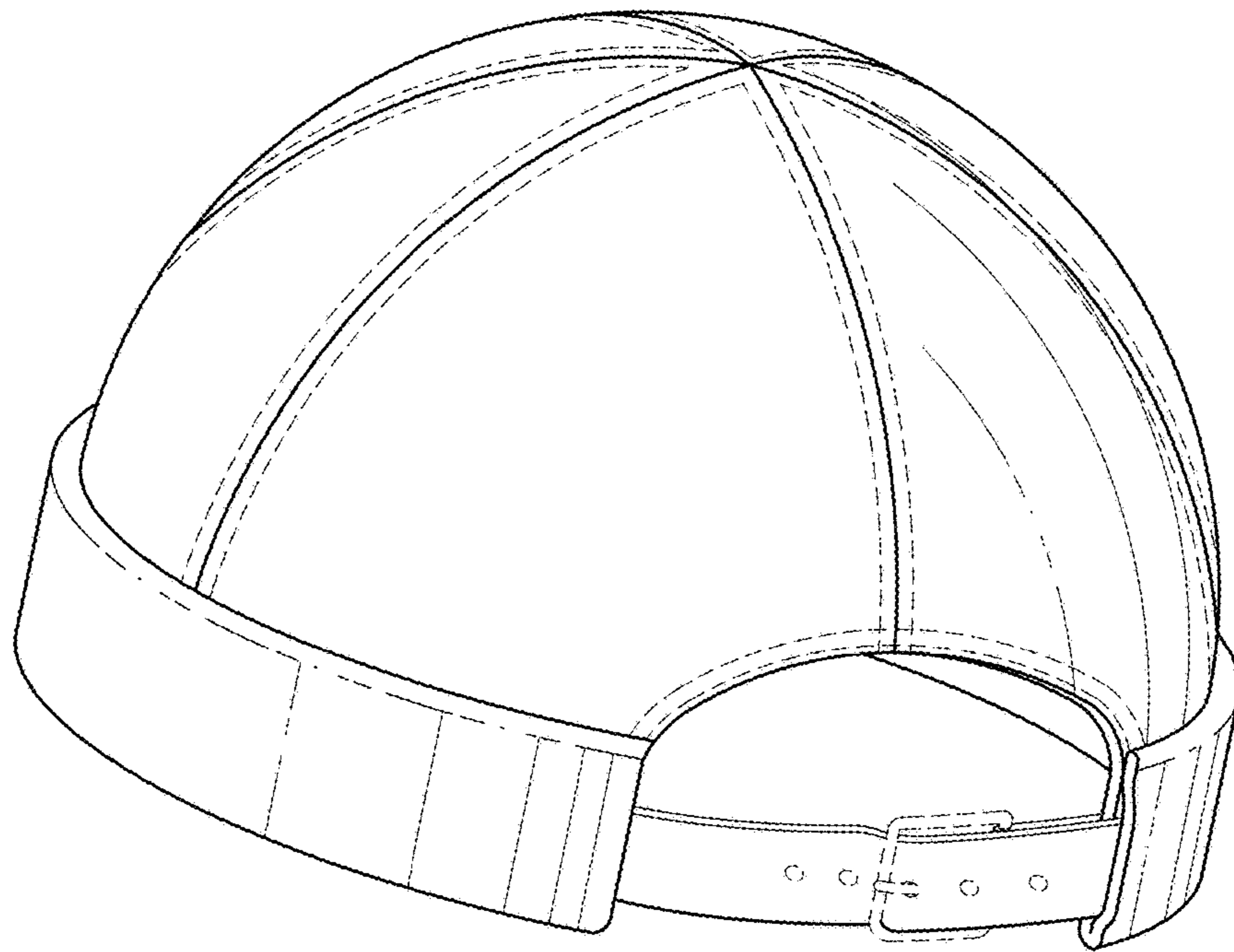

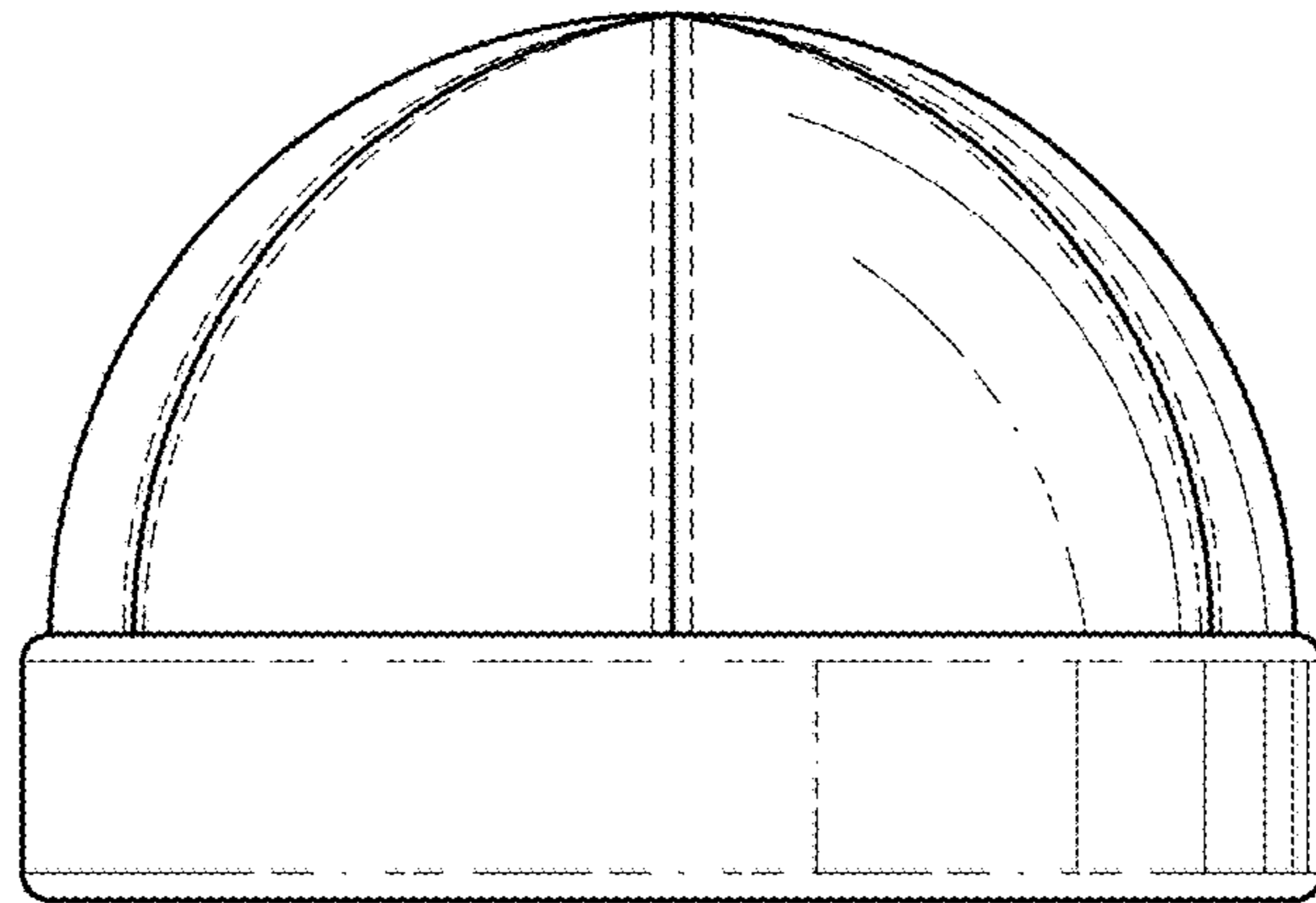

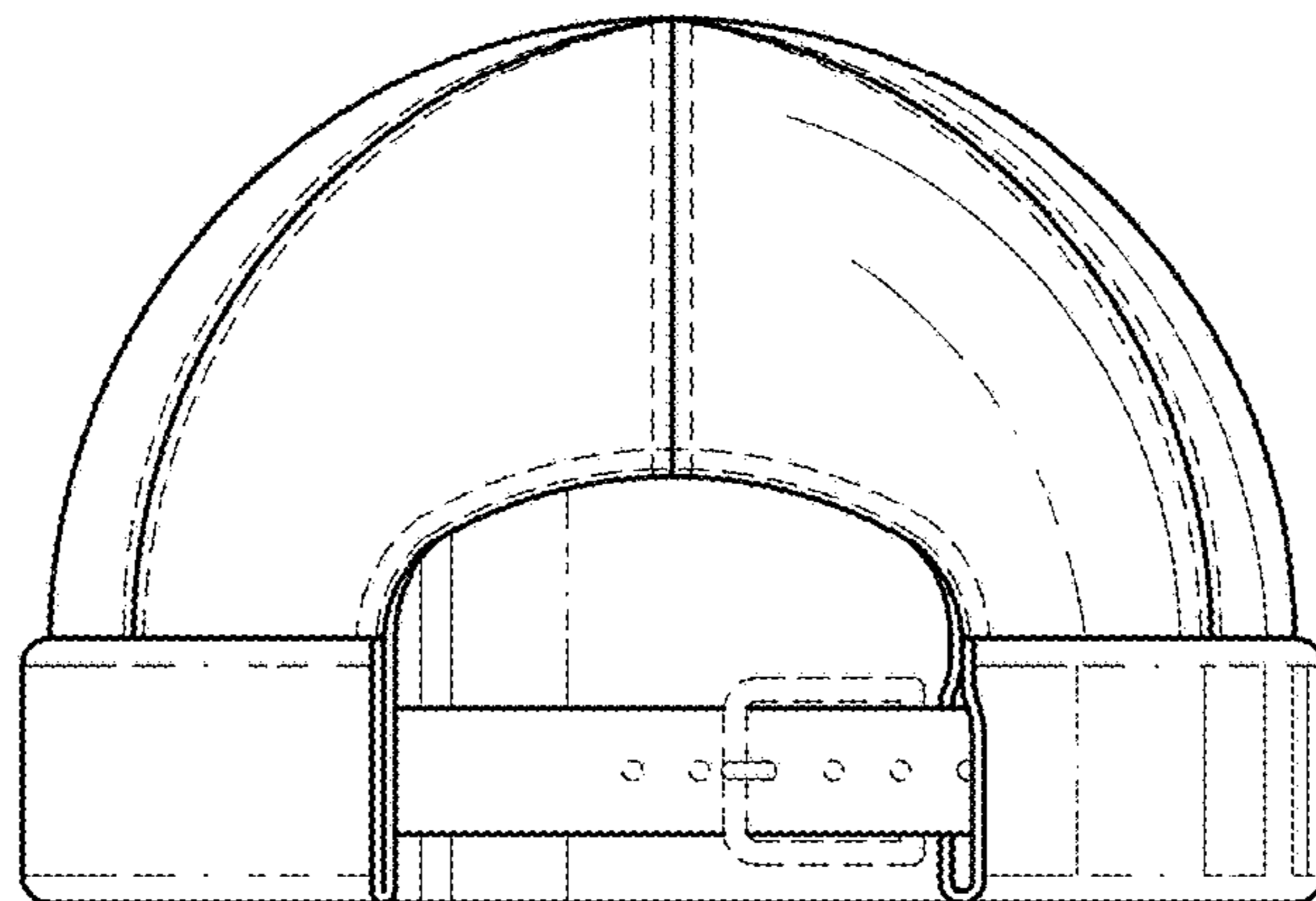

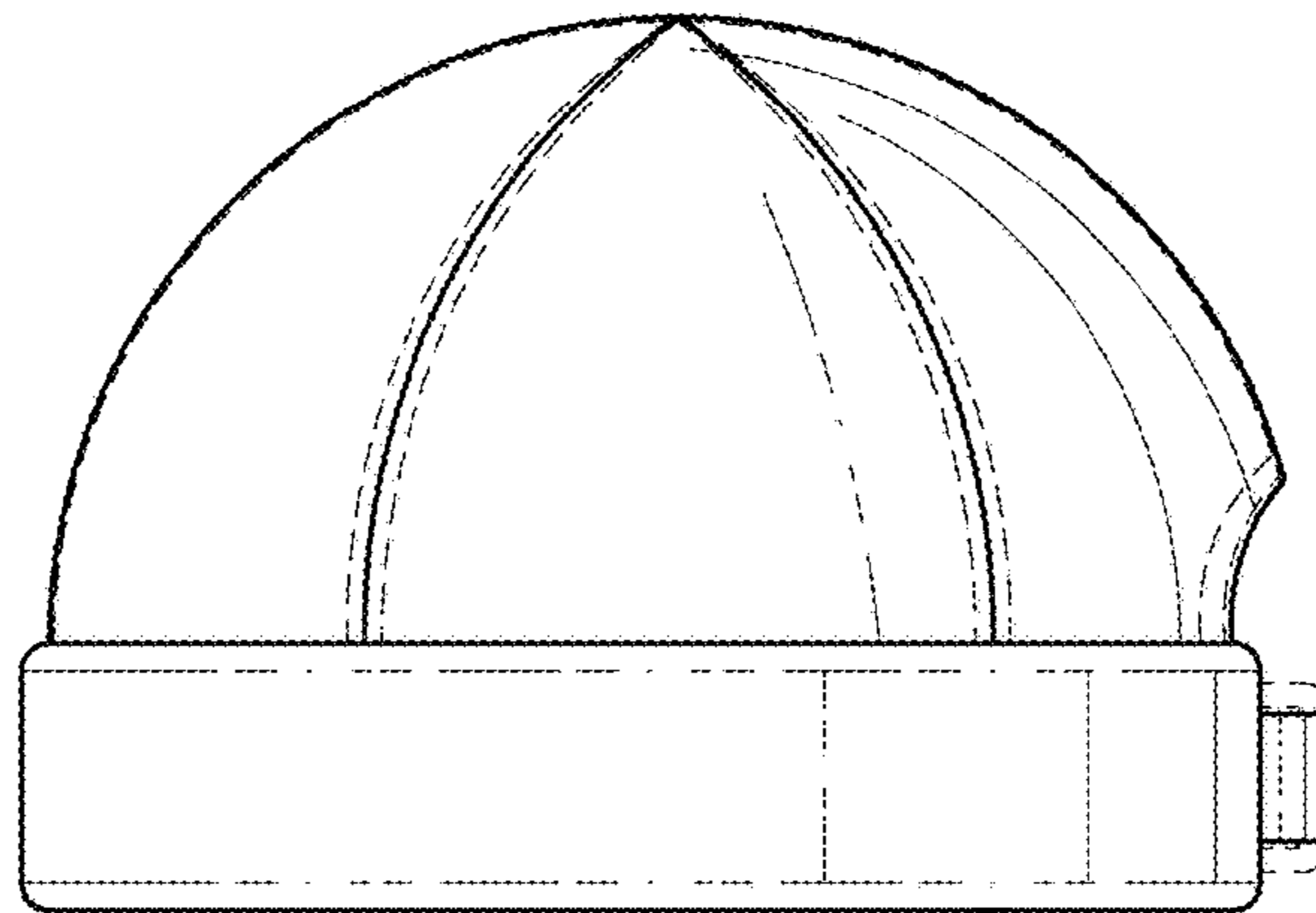

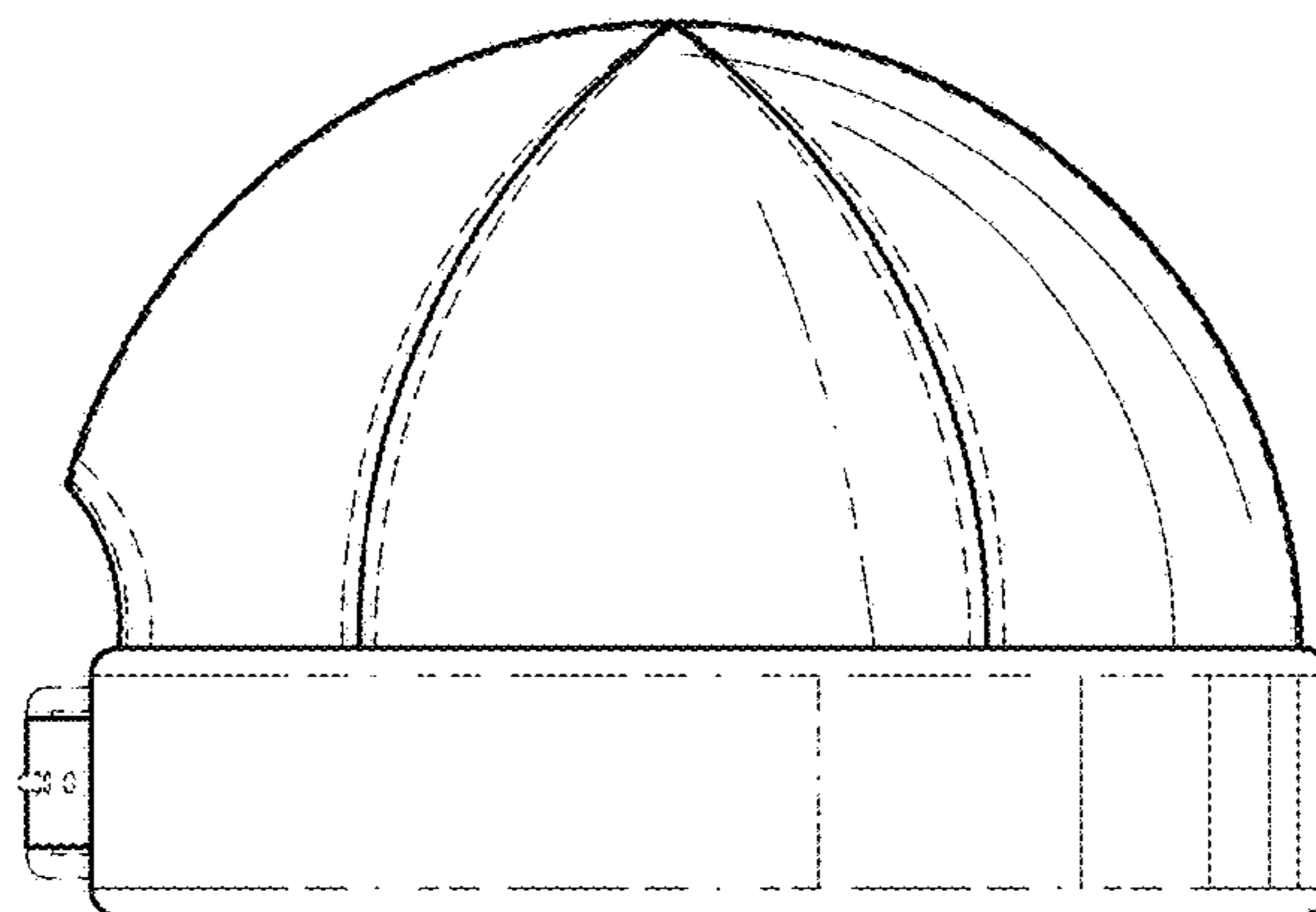

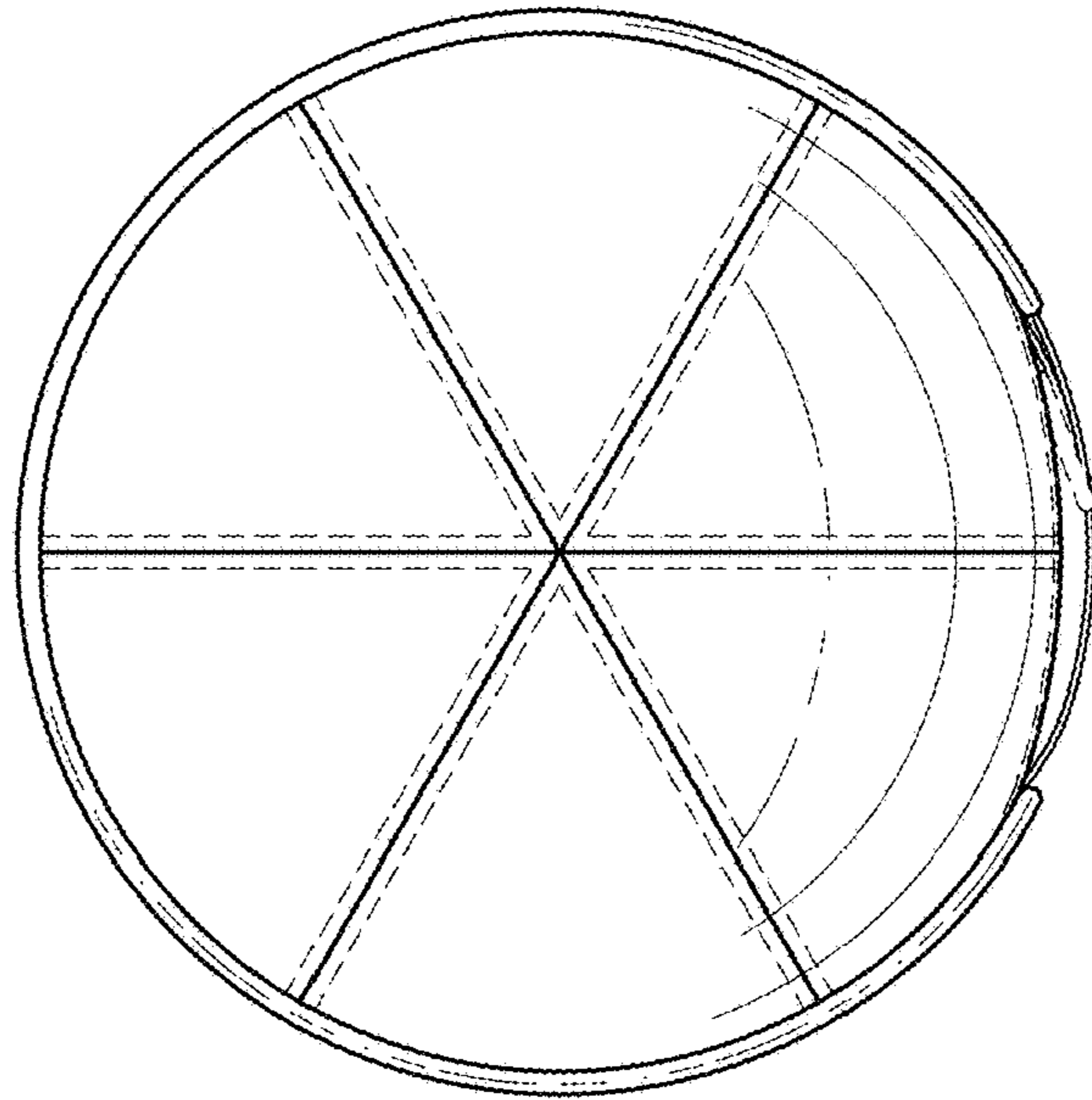

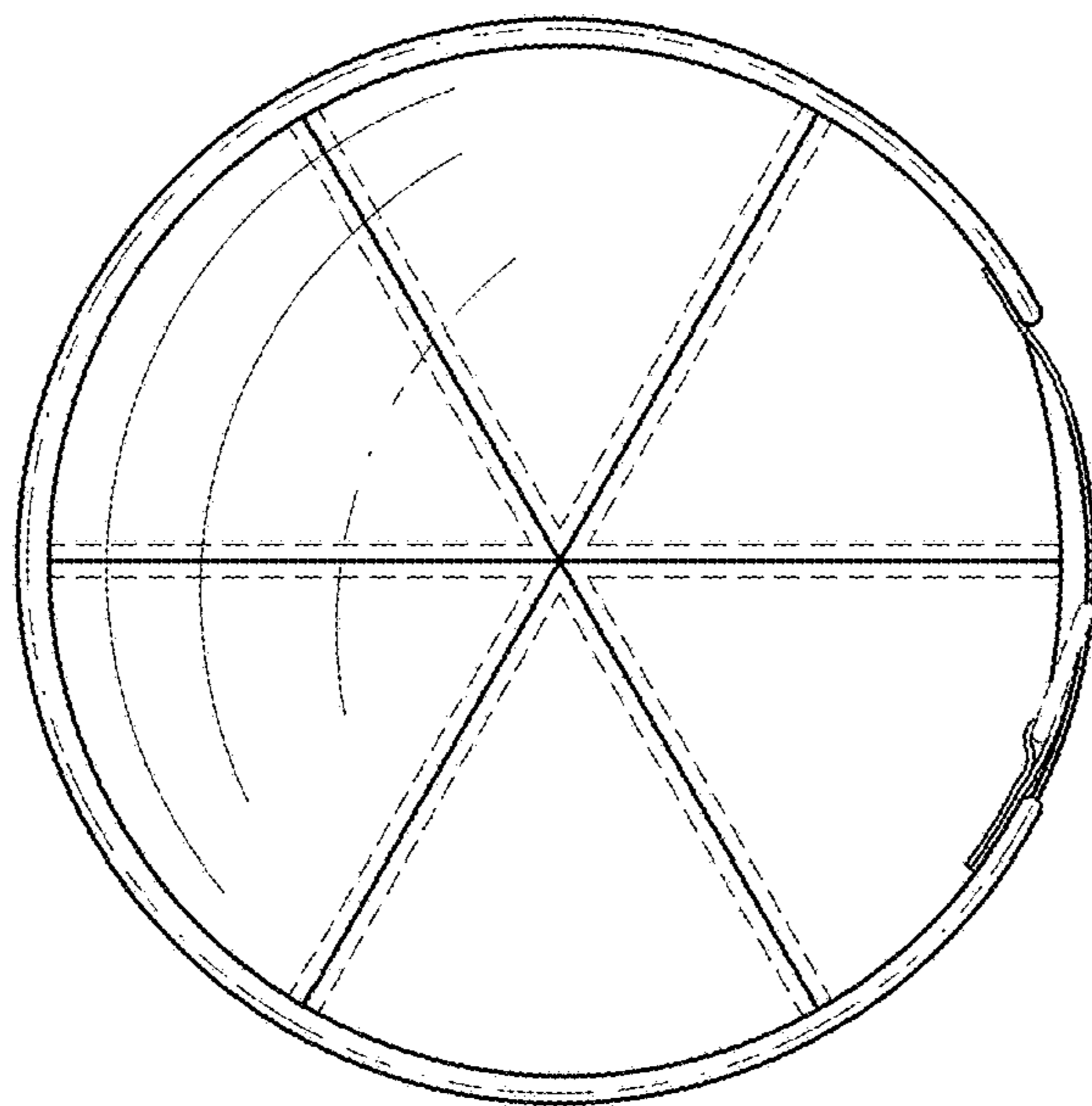
