DESCRIPTION

FIG. 4 is a right side view thereof; and,

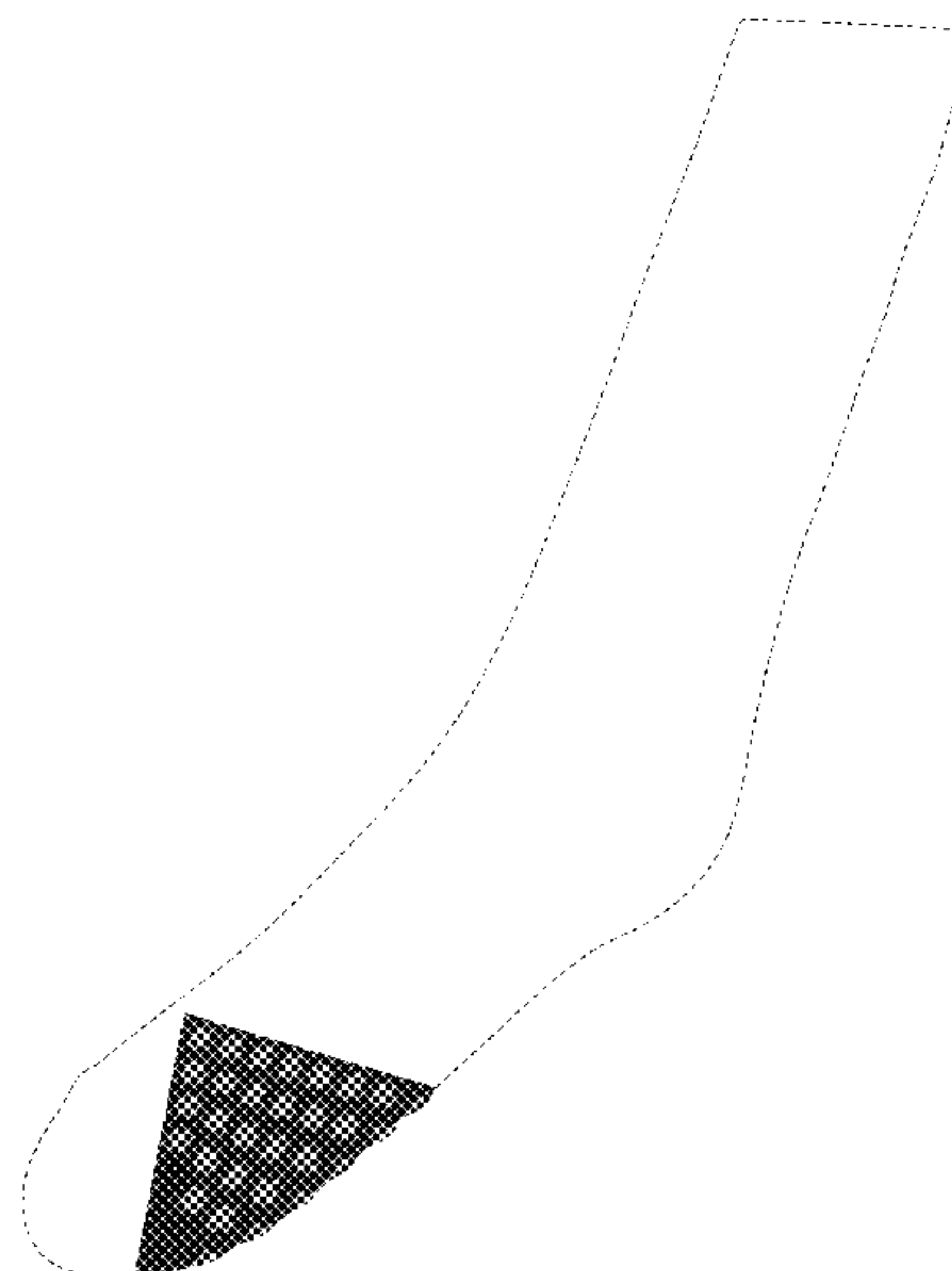
FIG. 5 is a rear view thereof.

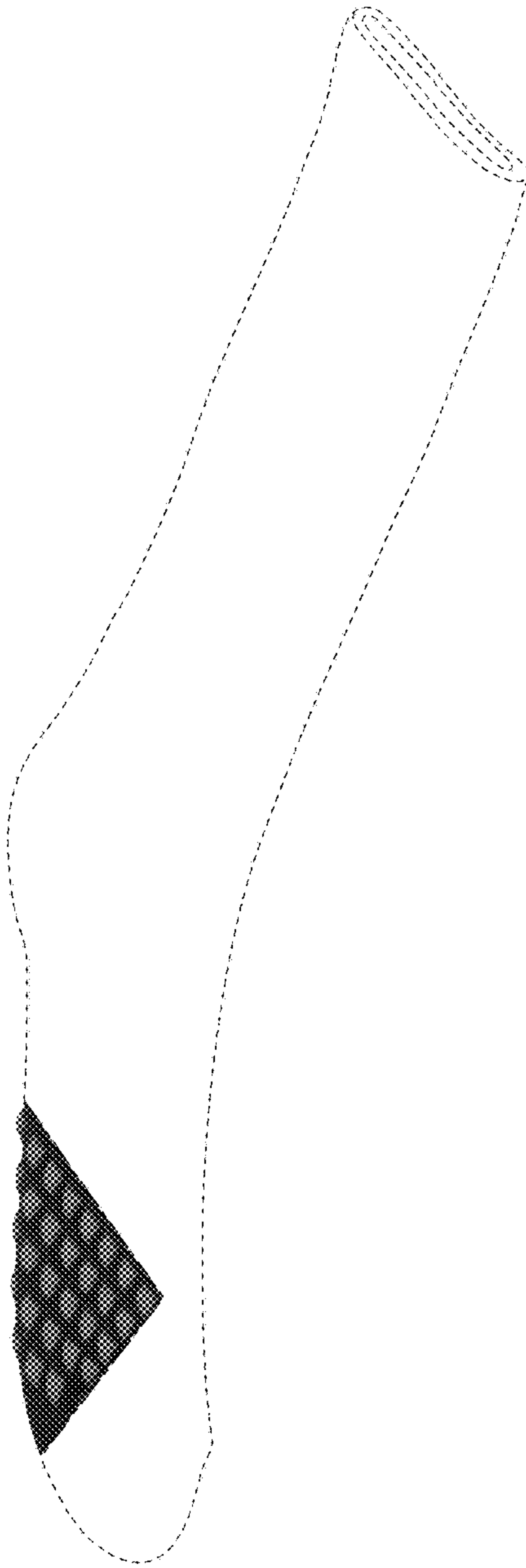

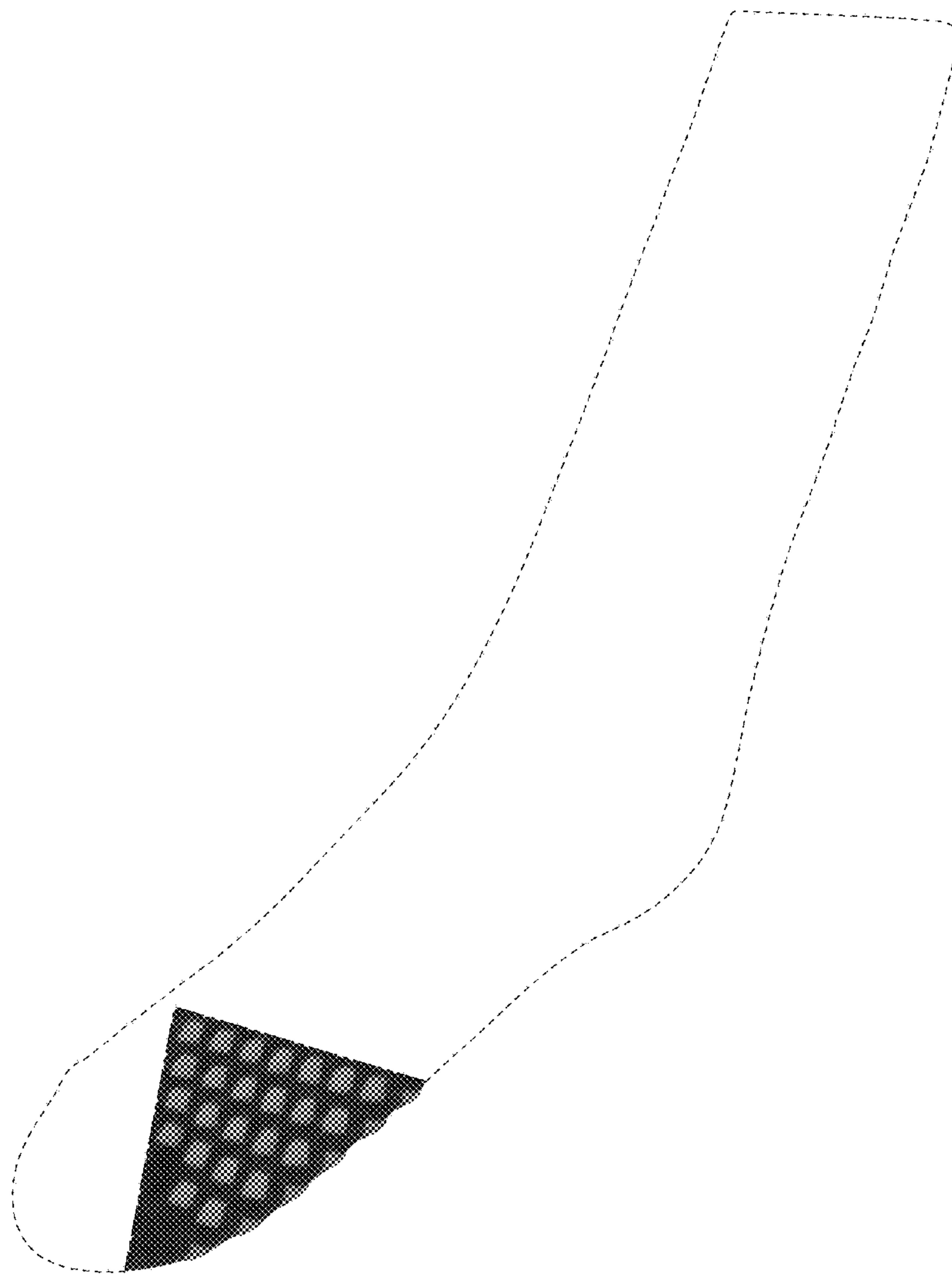

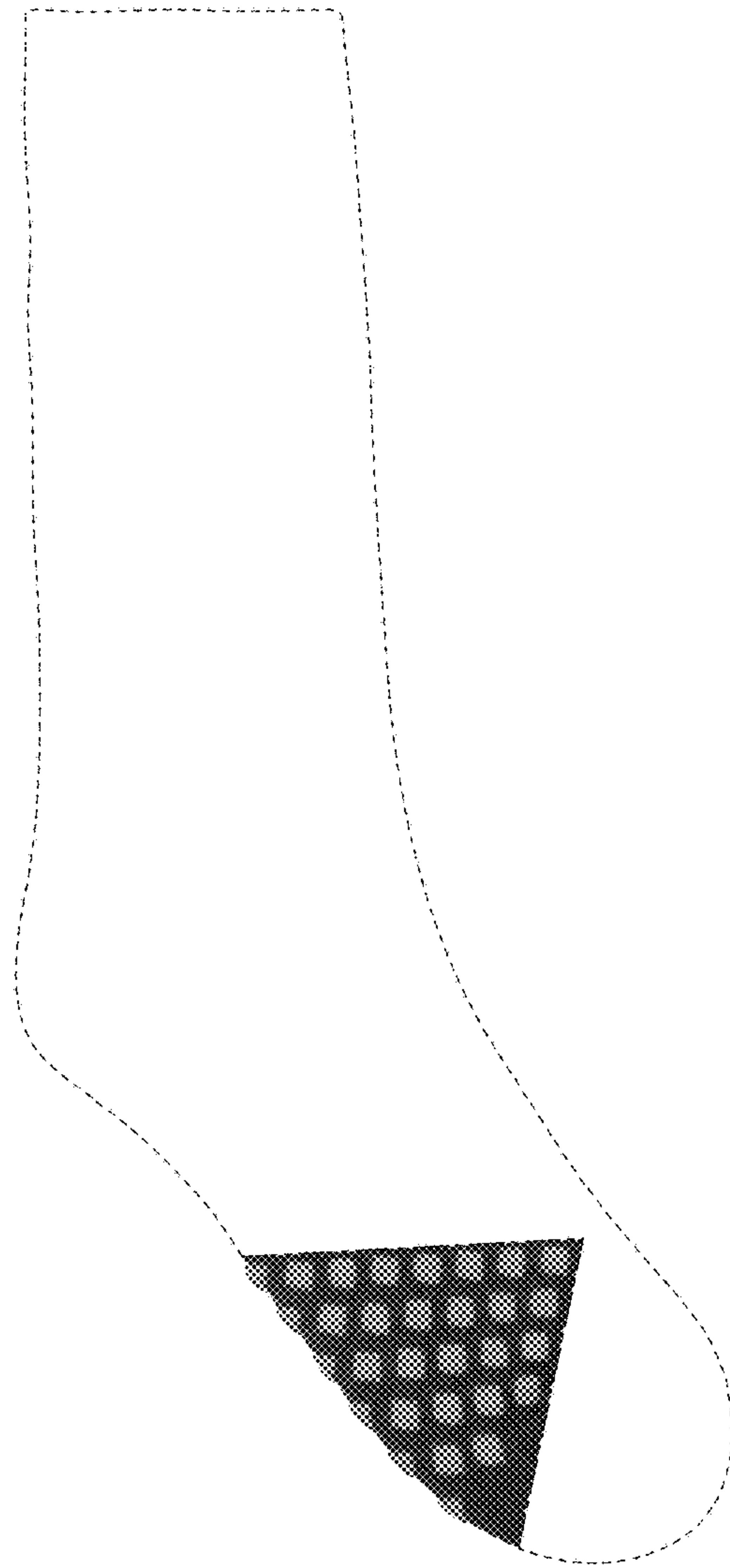

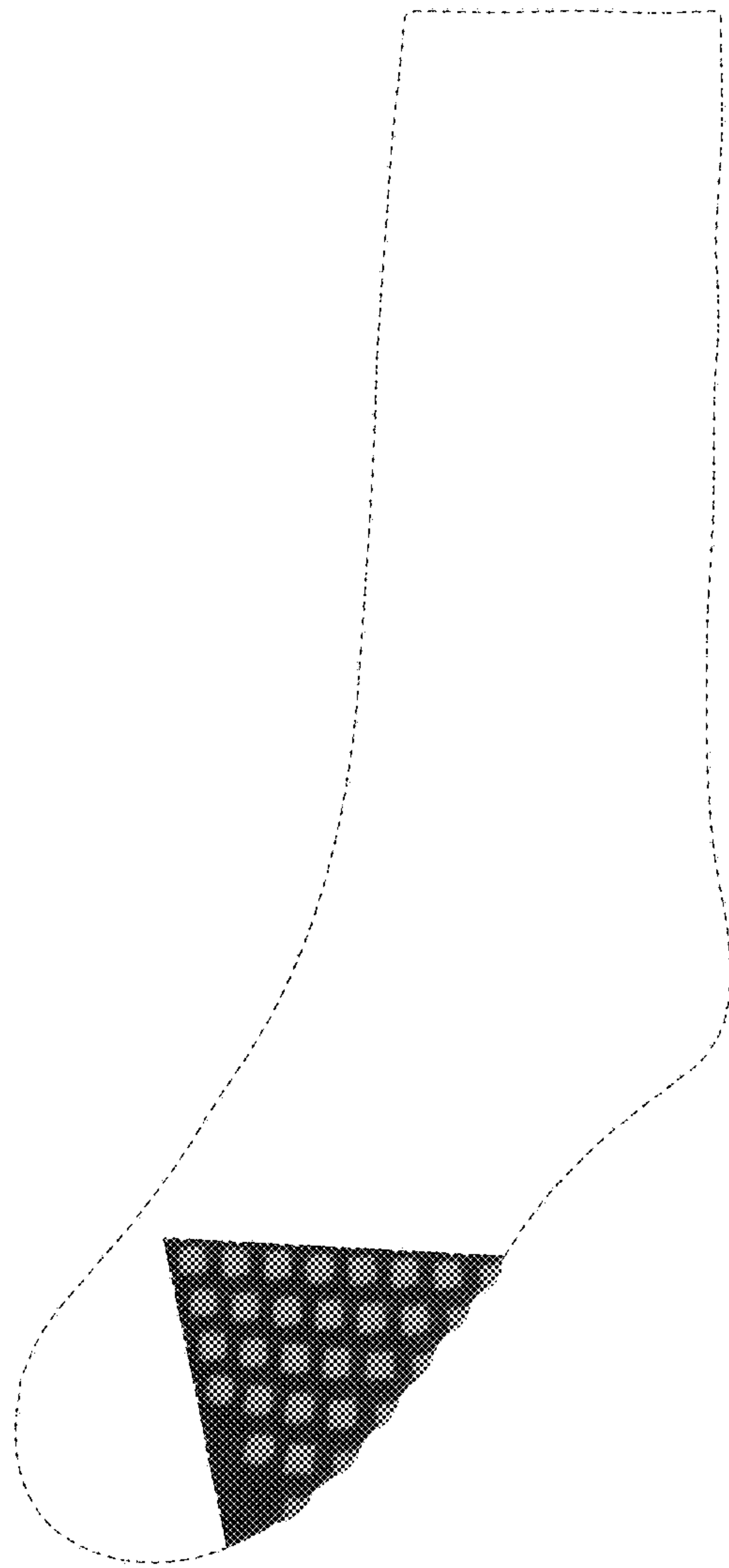

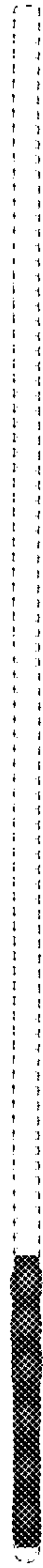
