**DESCRIPTION**

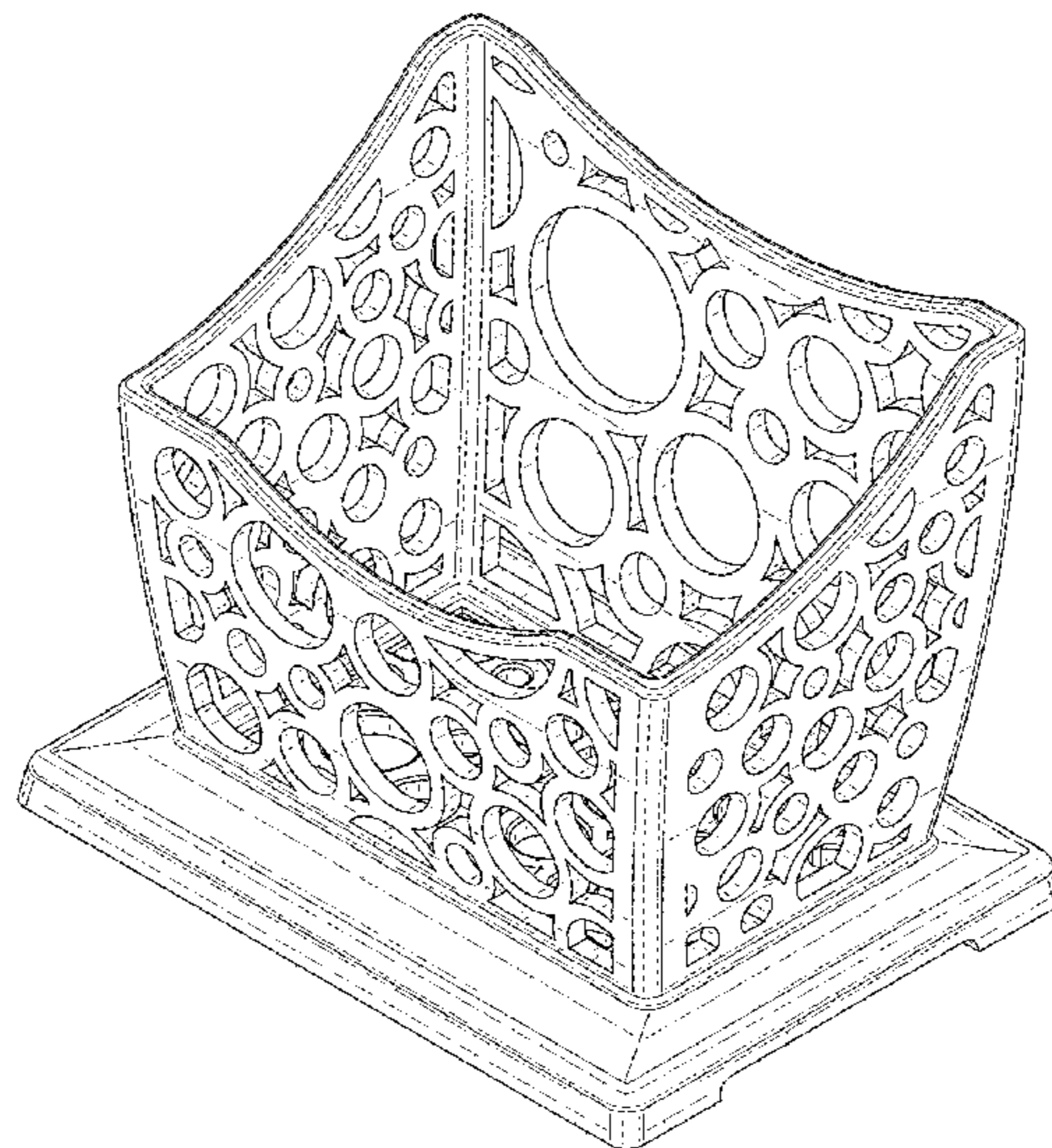
FIG. 1 is a perspective view of a bar soap container showing my new design;

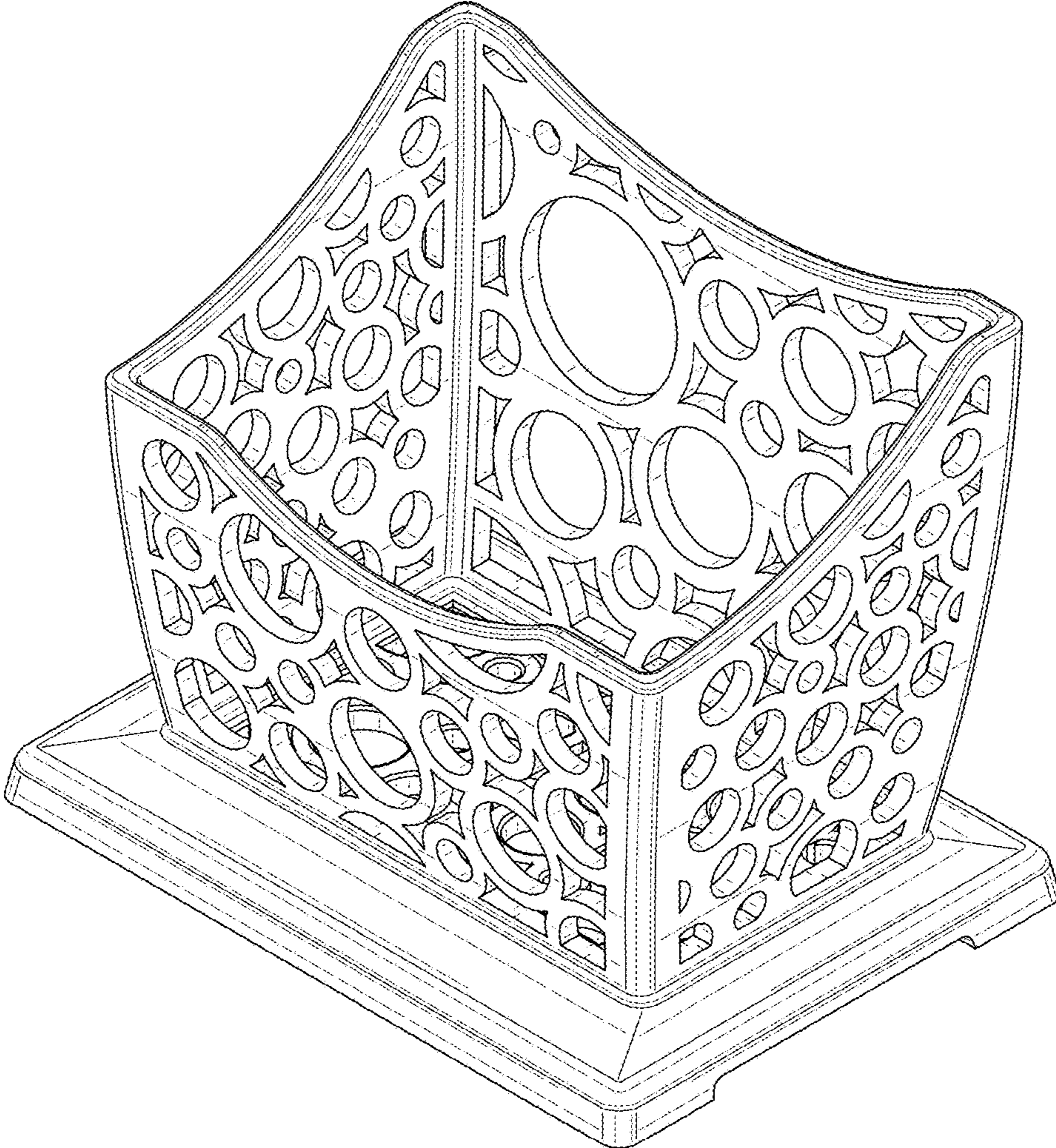

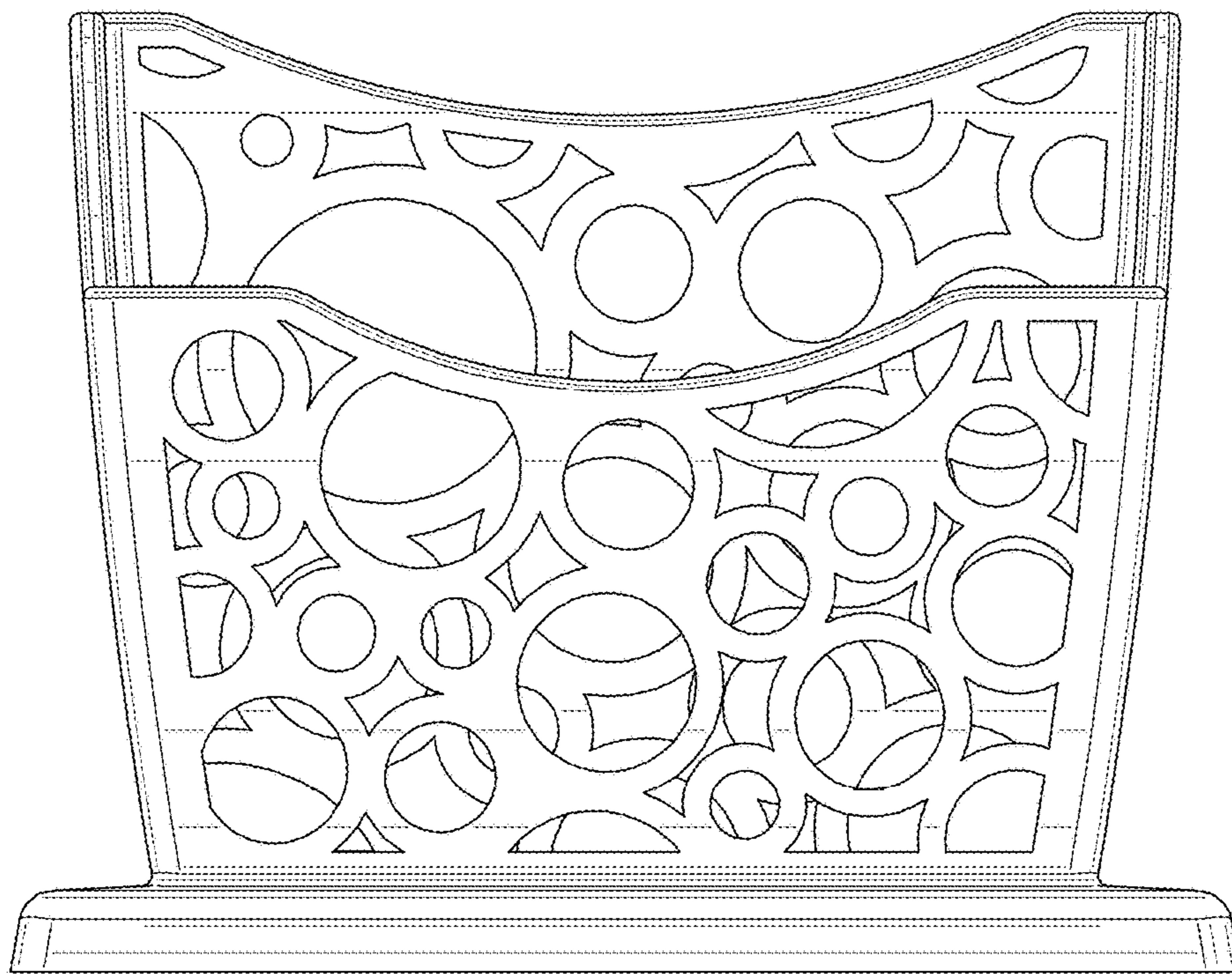

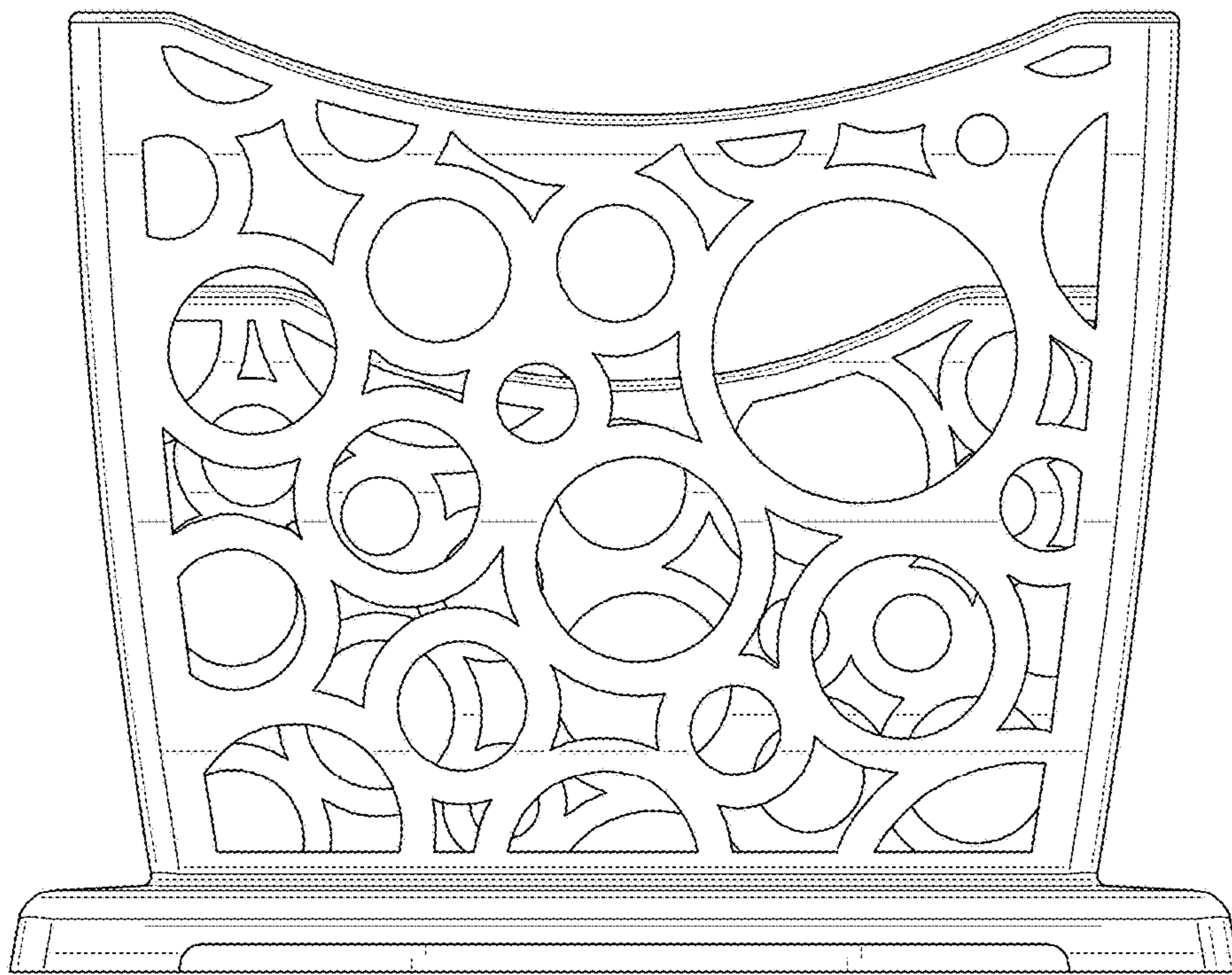

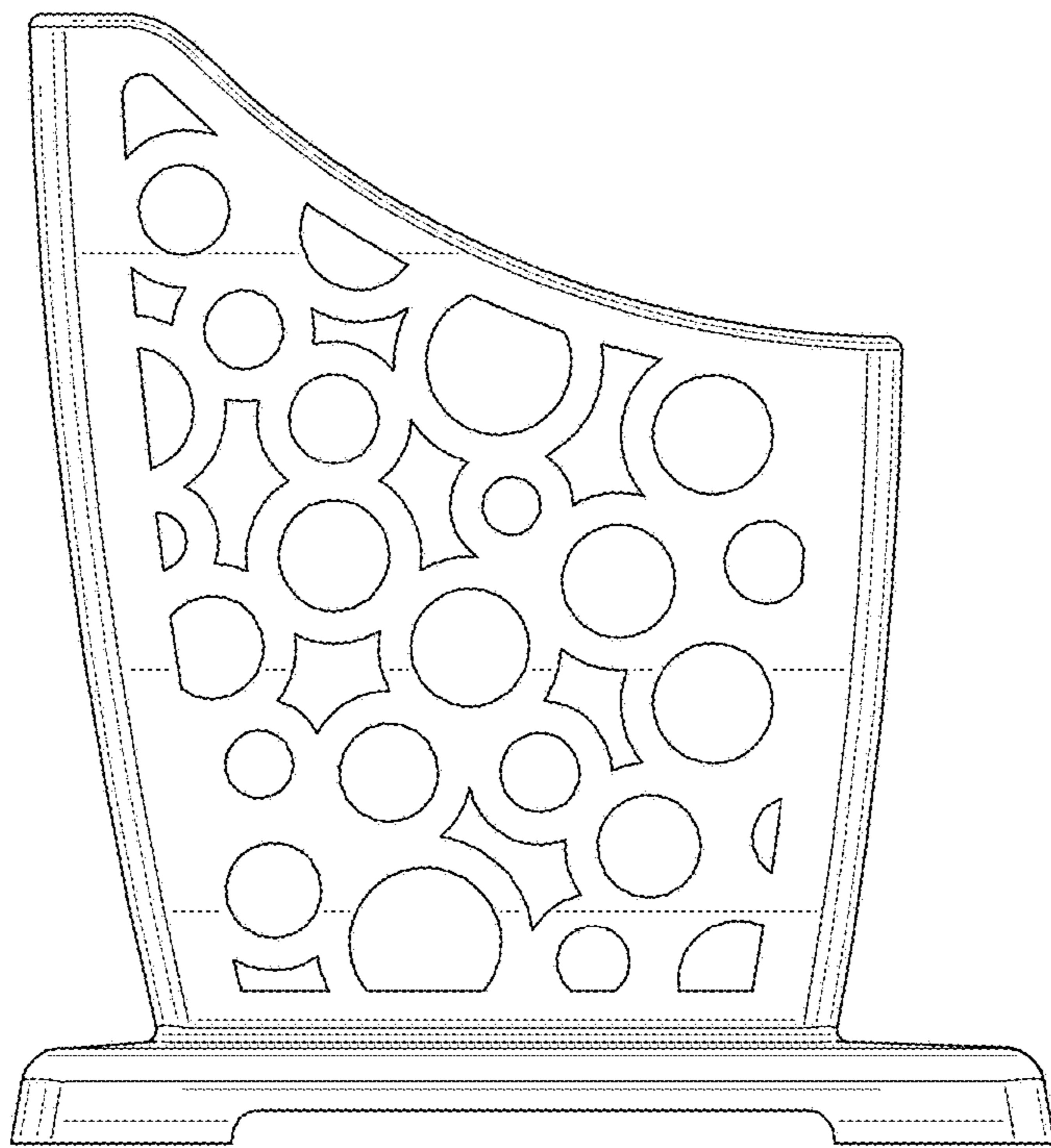

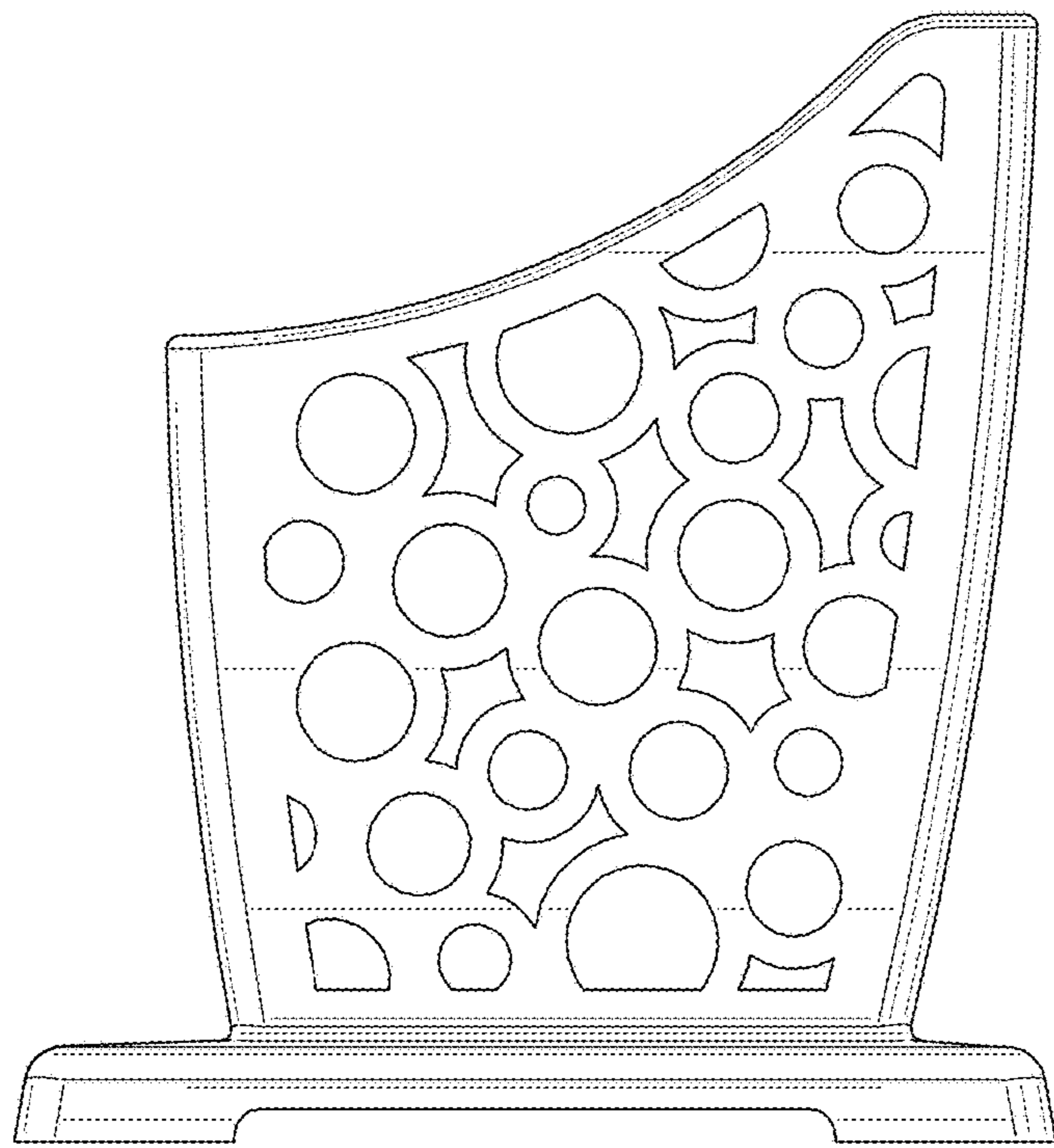

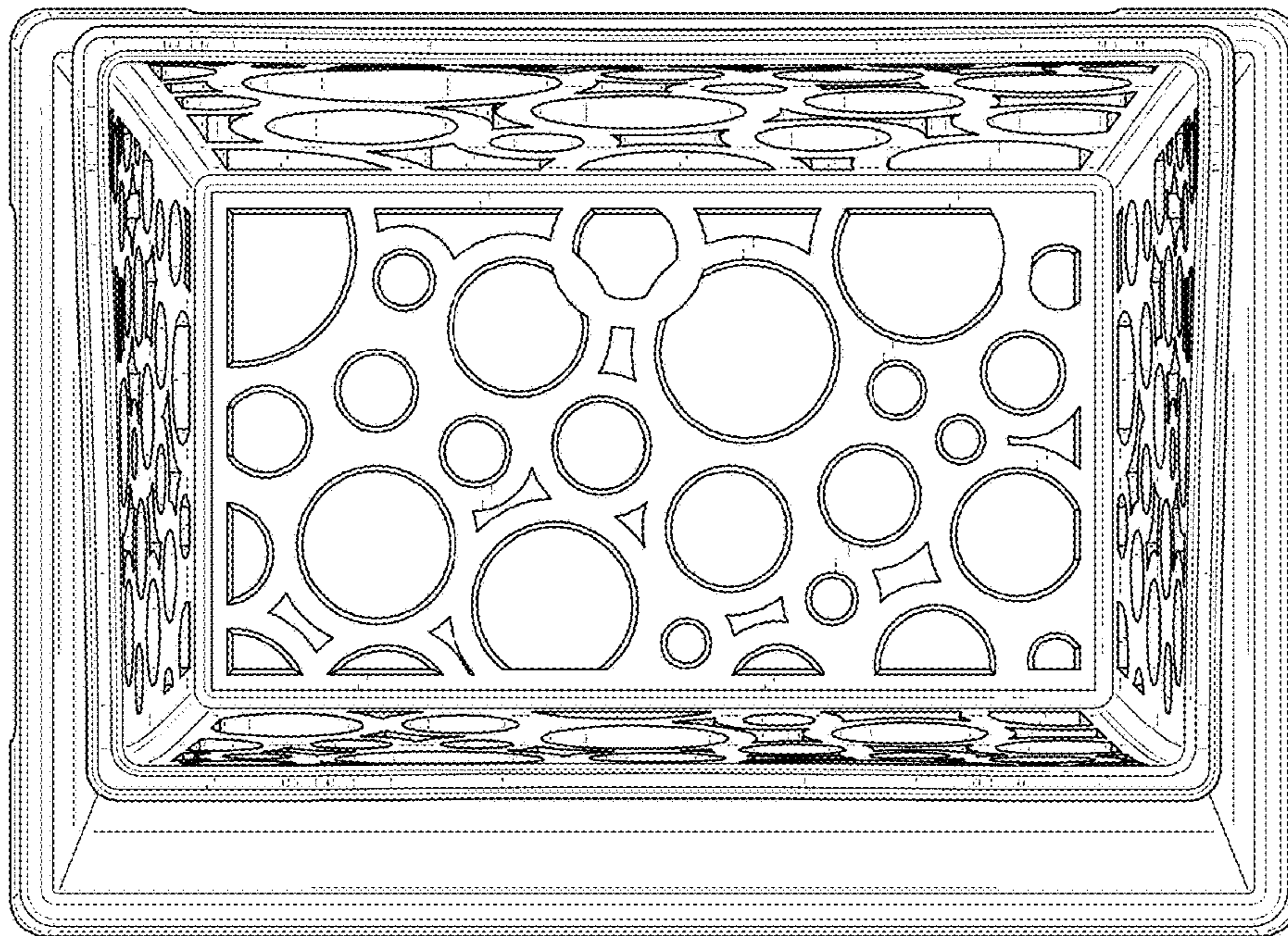

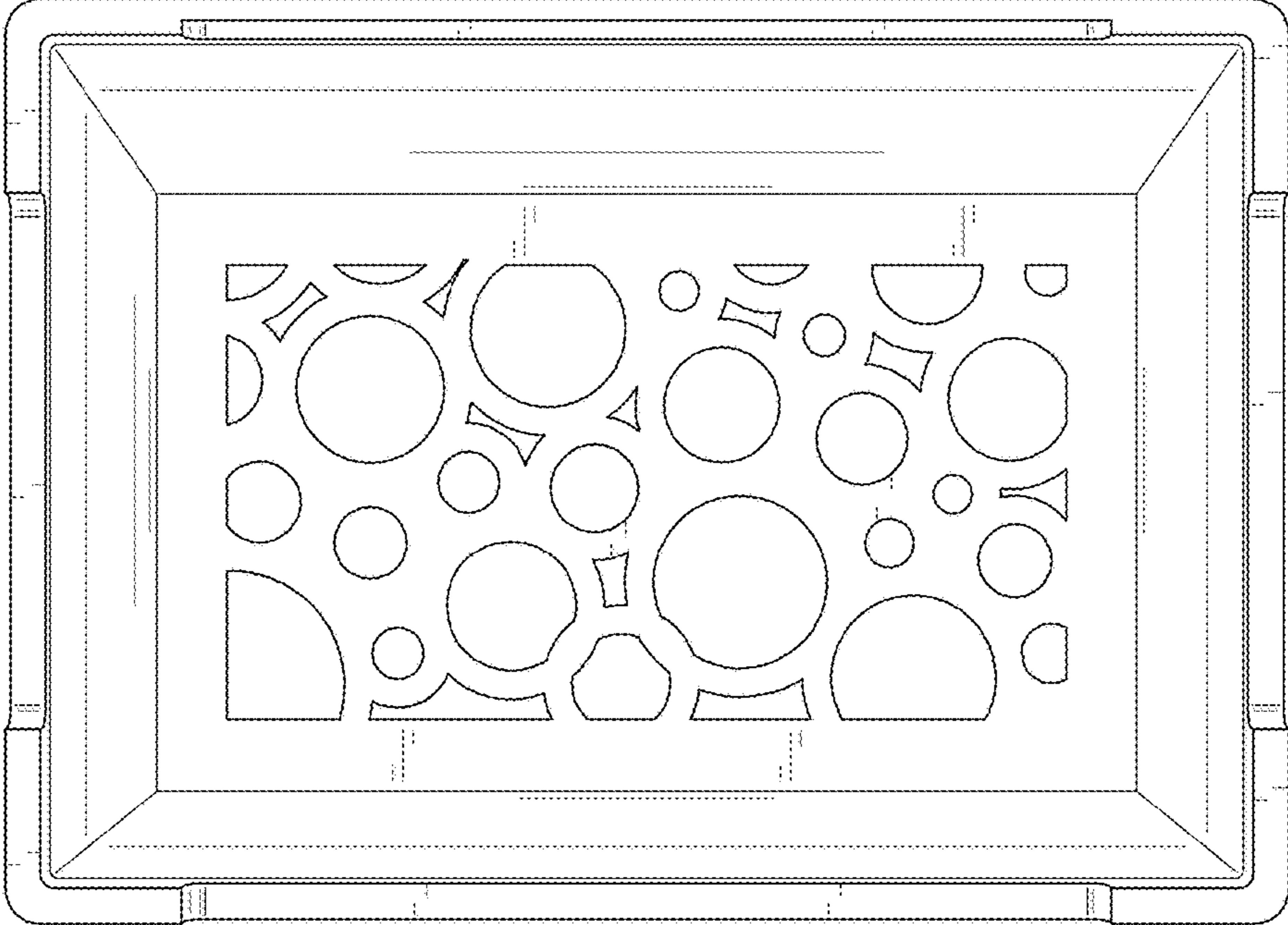
