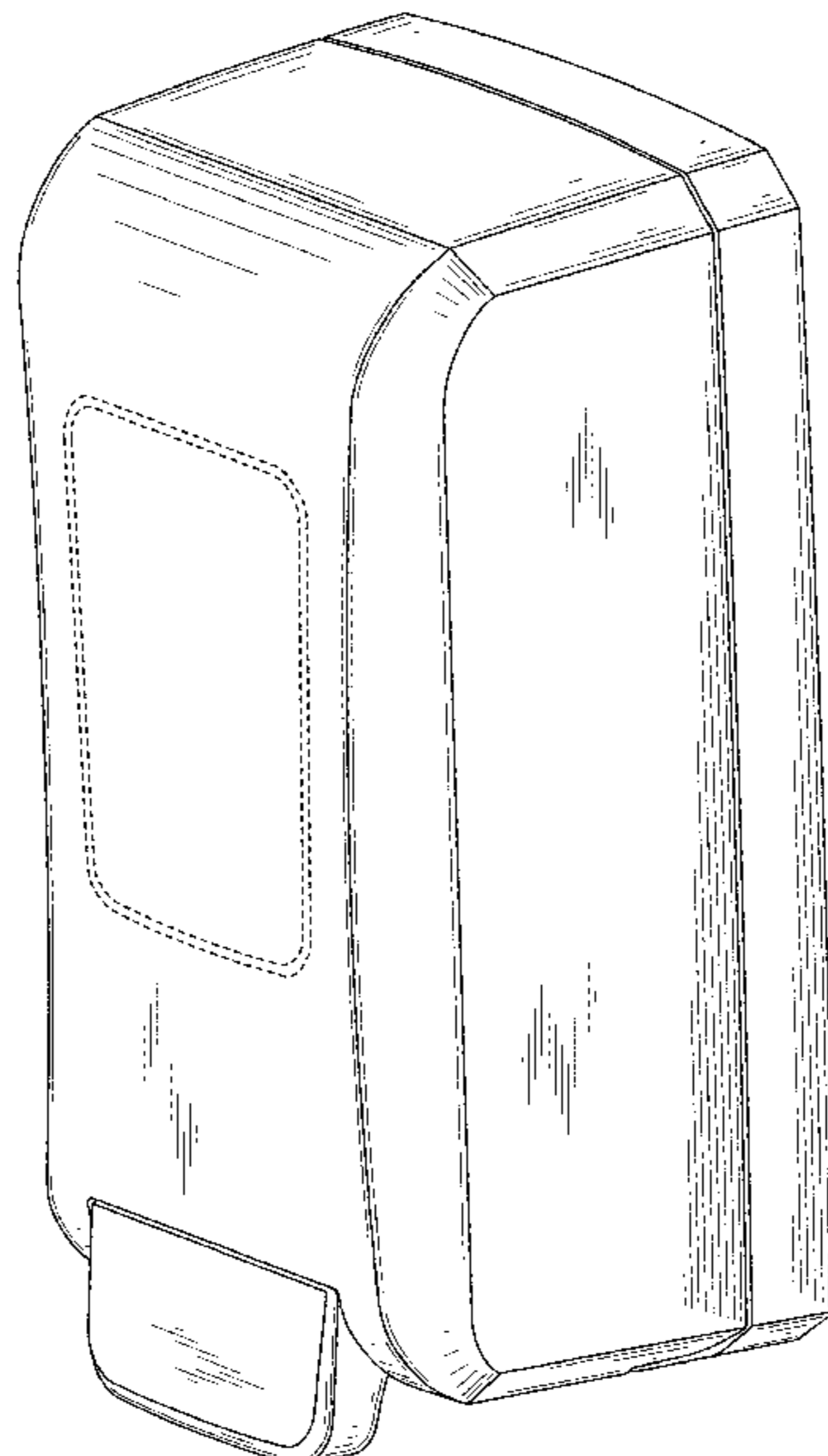
FIG. 1 is a perspective view of a dispenser, showing our new design;

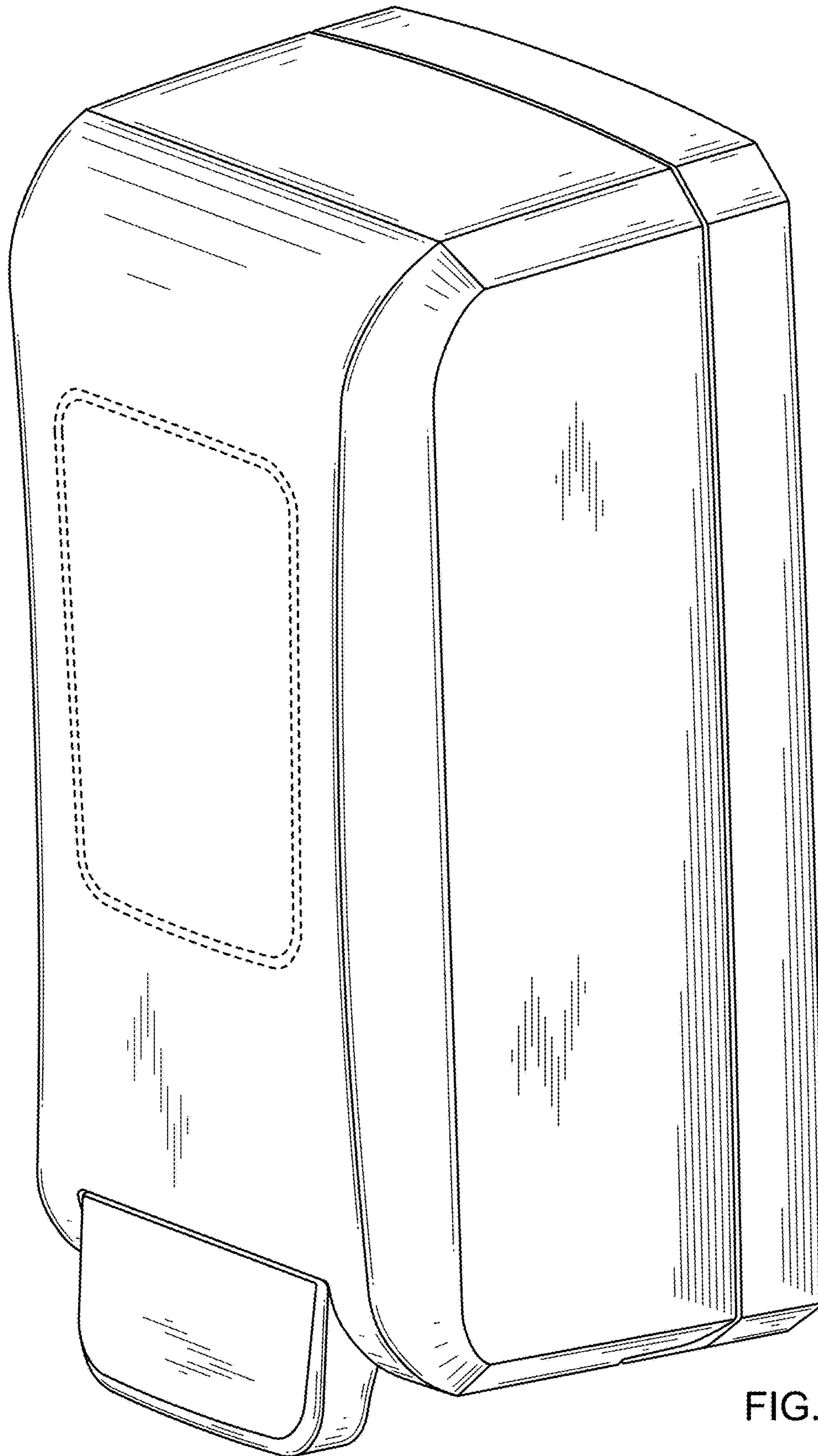

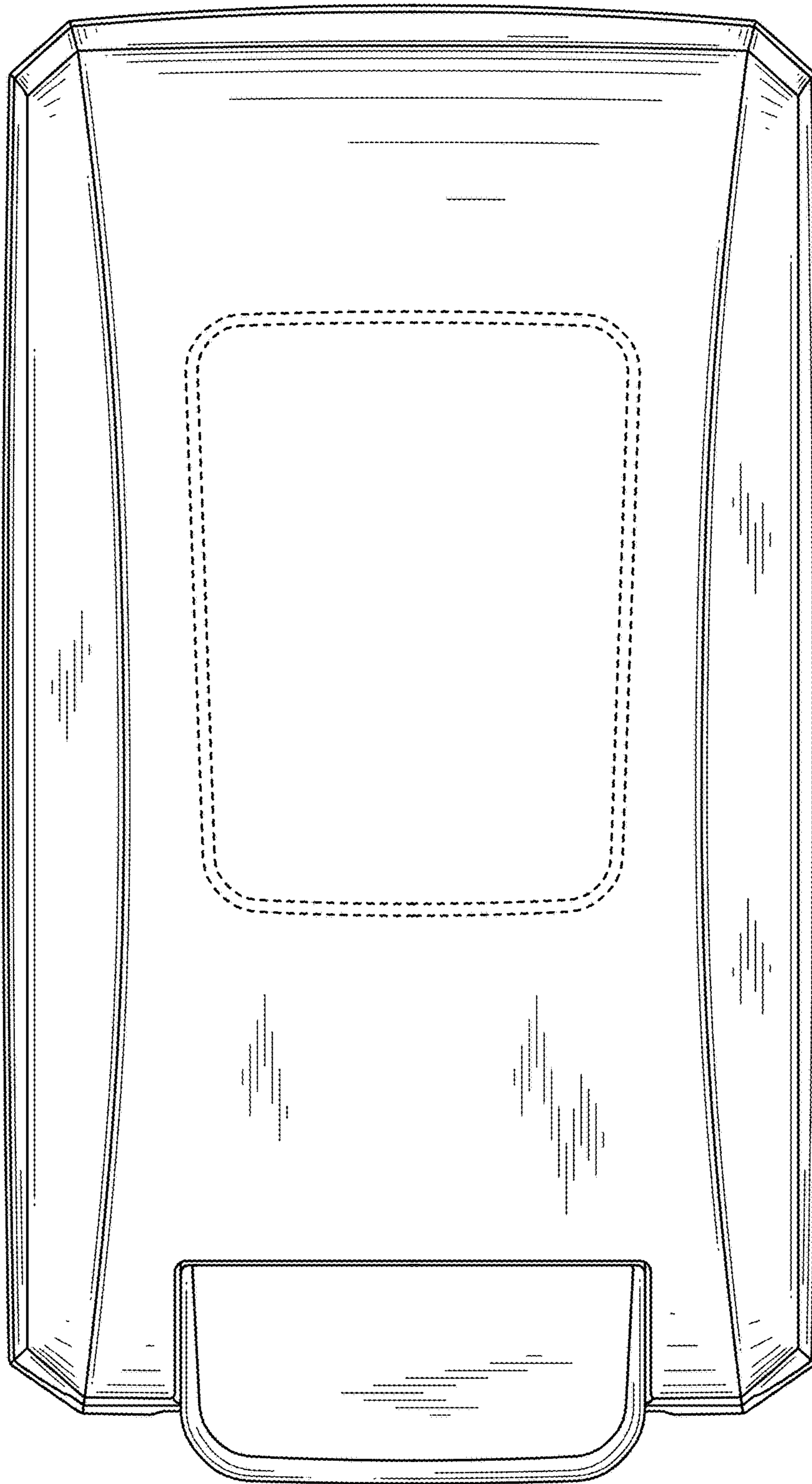

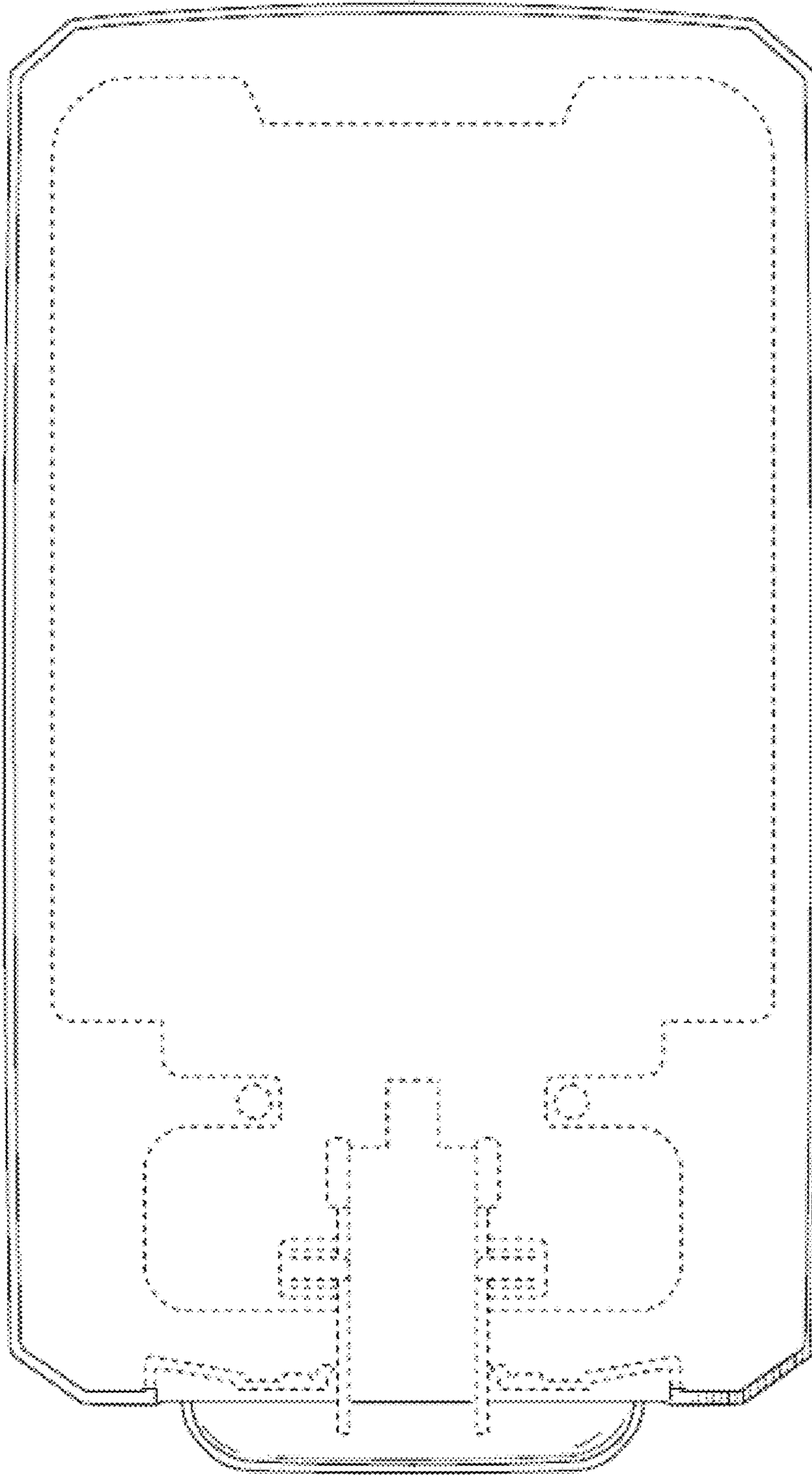

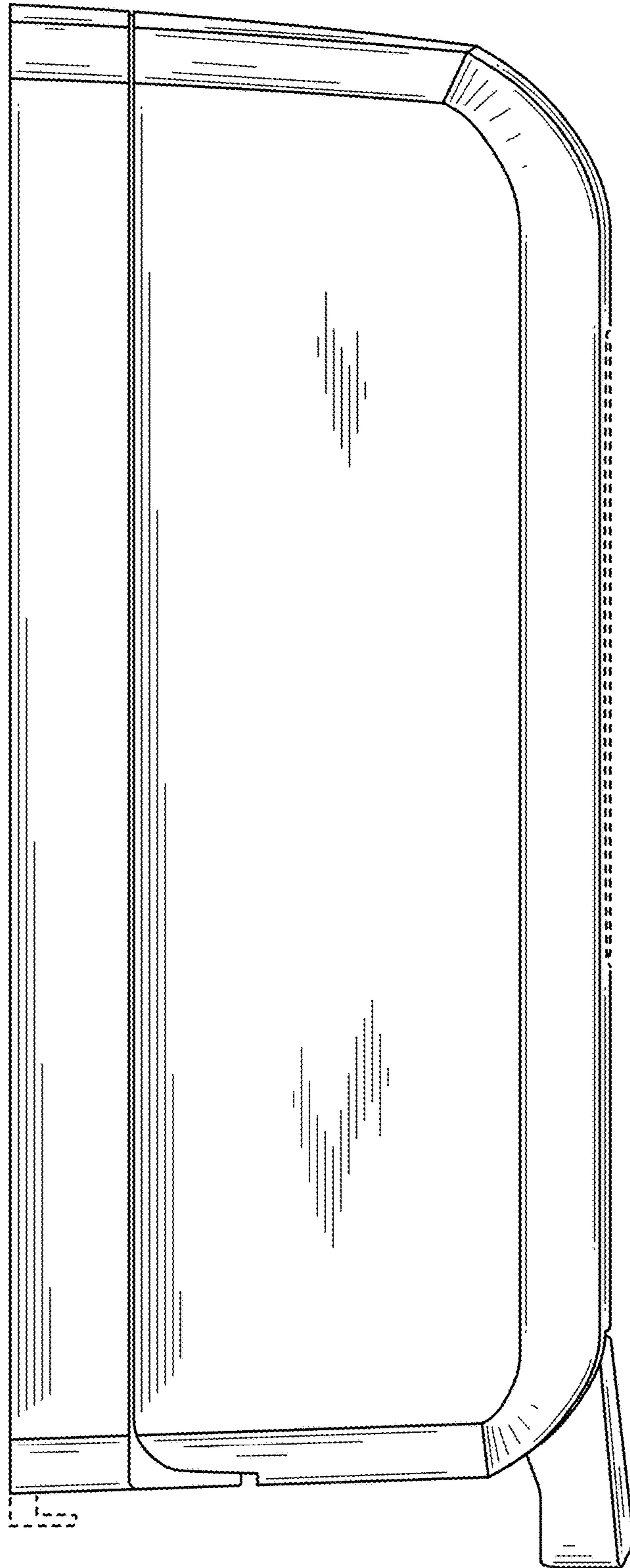

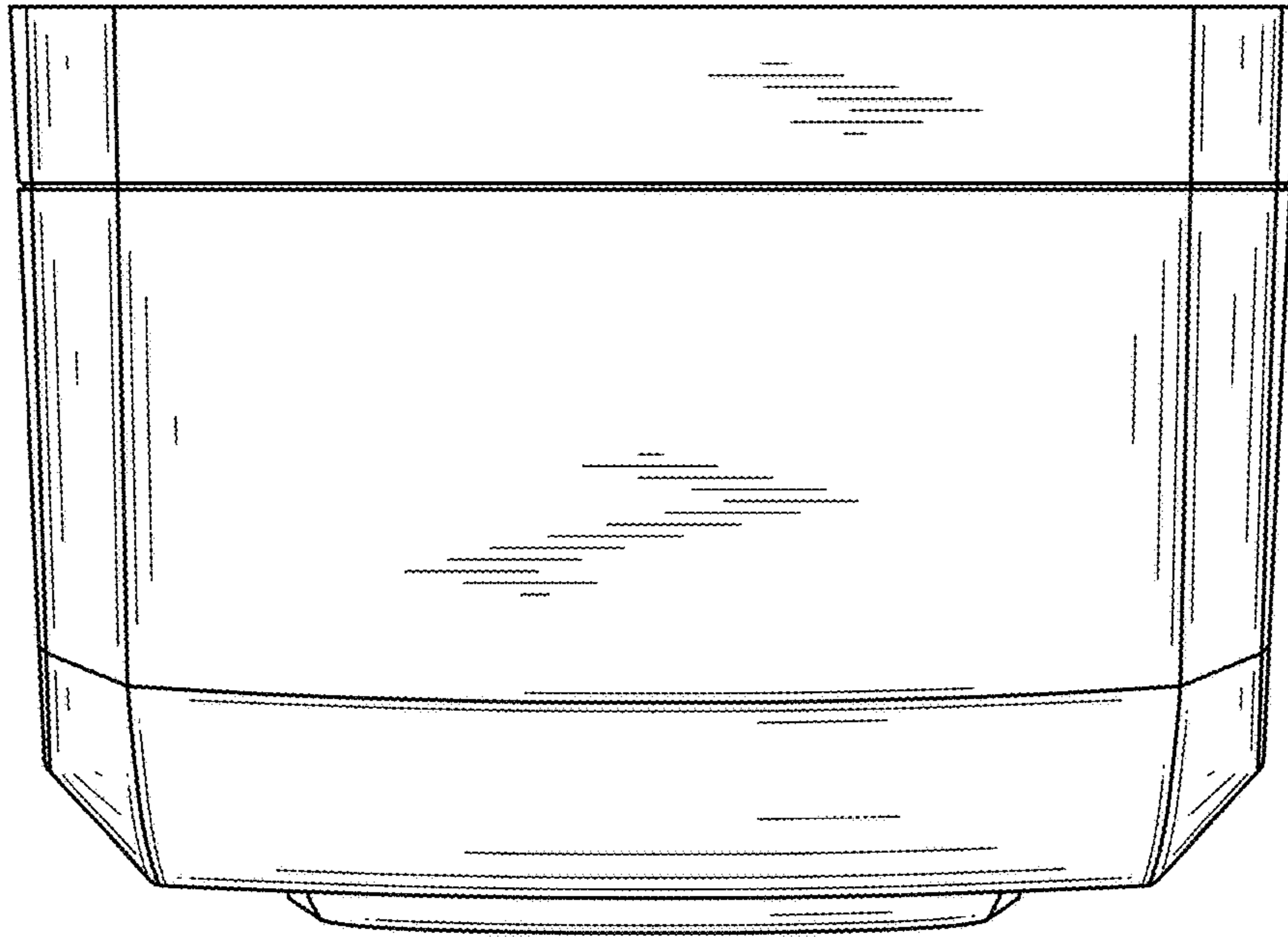

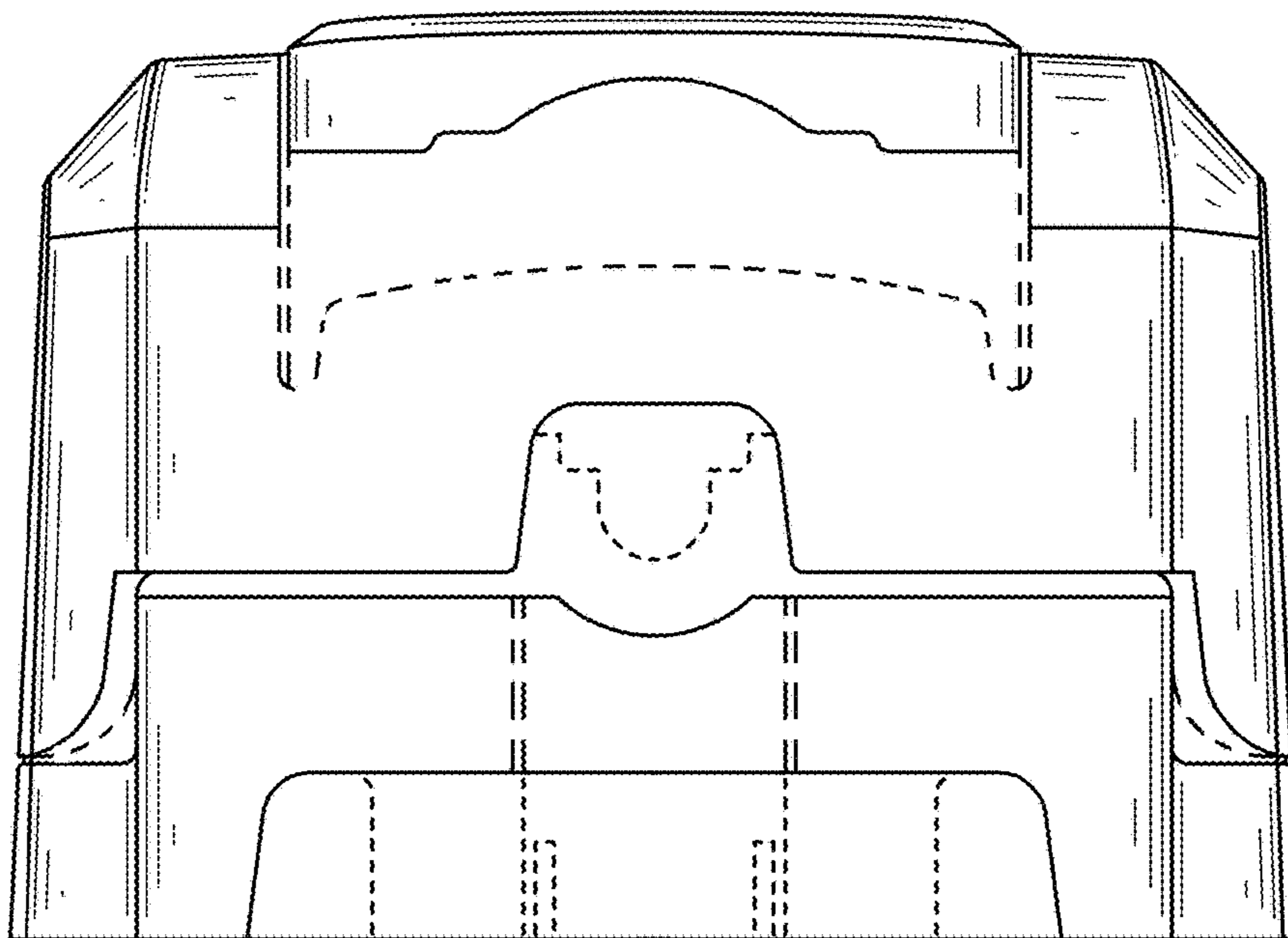
