(57) **CLAIM**

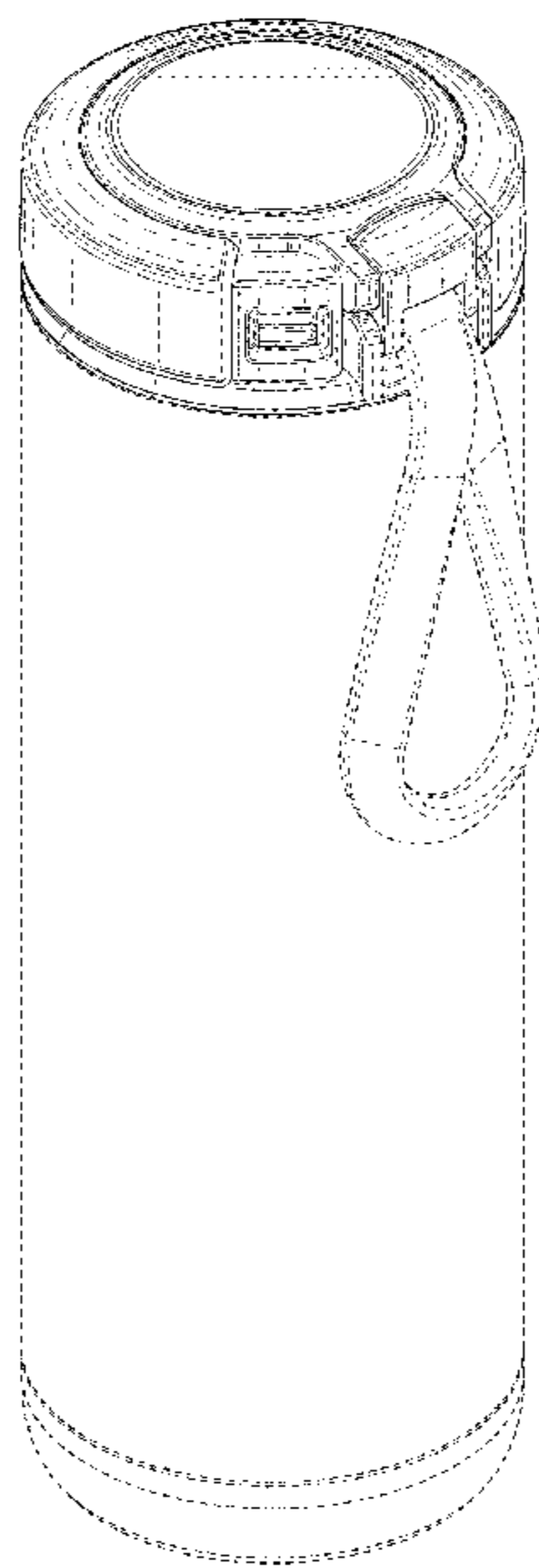
The ornamental design for a lid for beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a lid for beverage container according to the new design;
FIG. 2 is a left side view of the lid for beverage container shown in FIG. 1;
FIG. 3 is a right side view of the lid for beverage container shown in FIG. 1;
FIG. 4 is a front view of the lid for beverage container shown in FIG. 1;
FIG. 5 is a rear view of the lid for beverage container shown in FIG. 1;

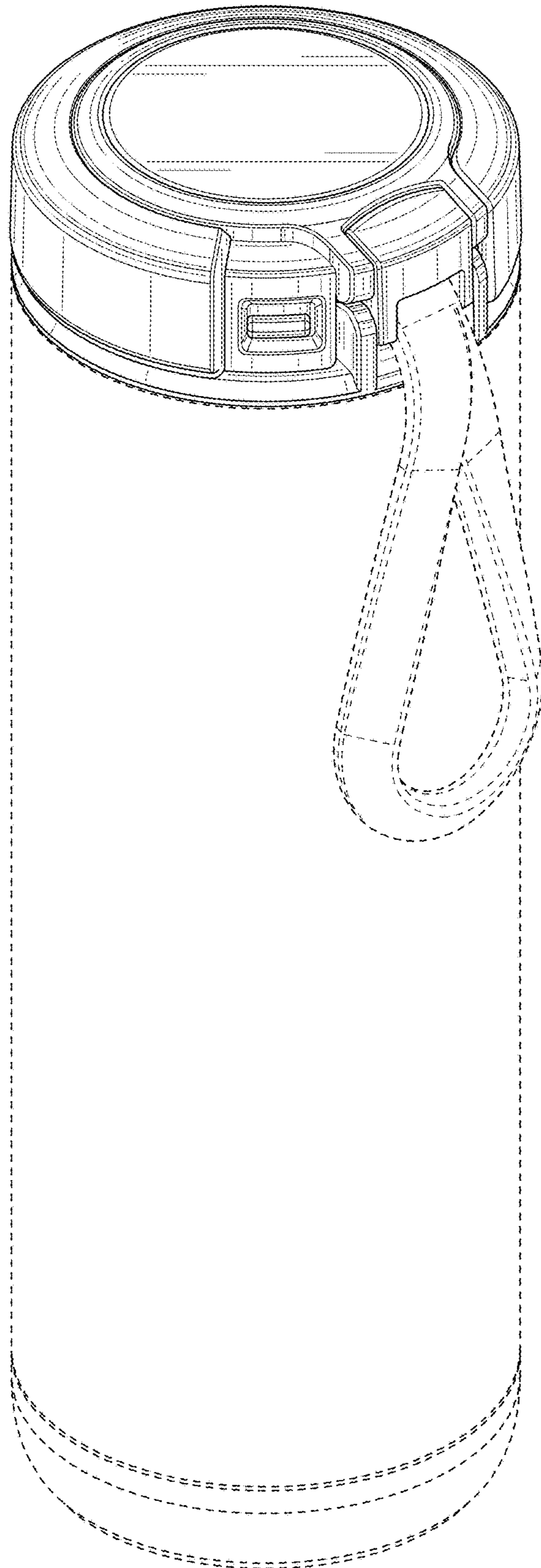

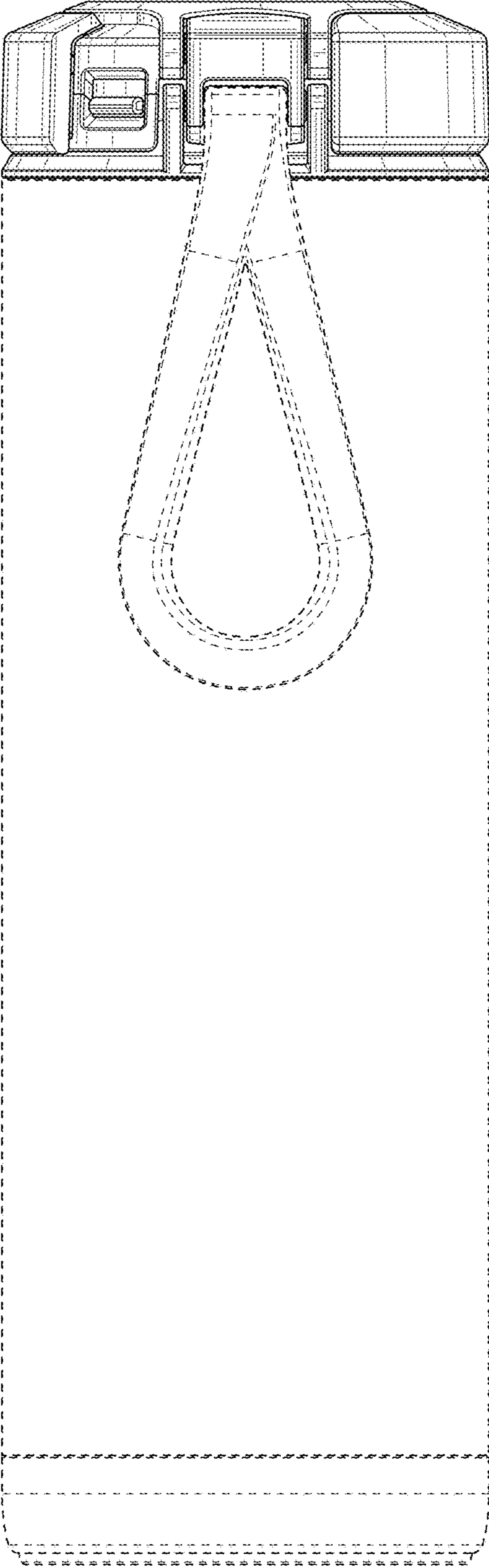

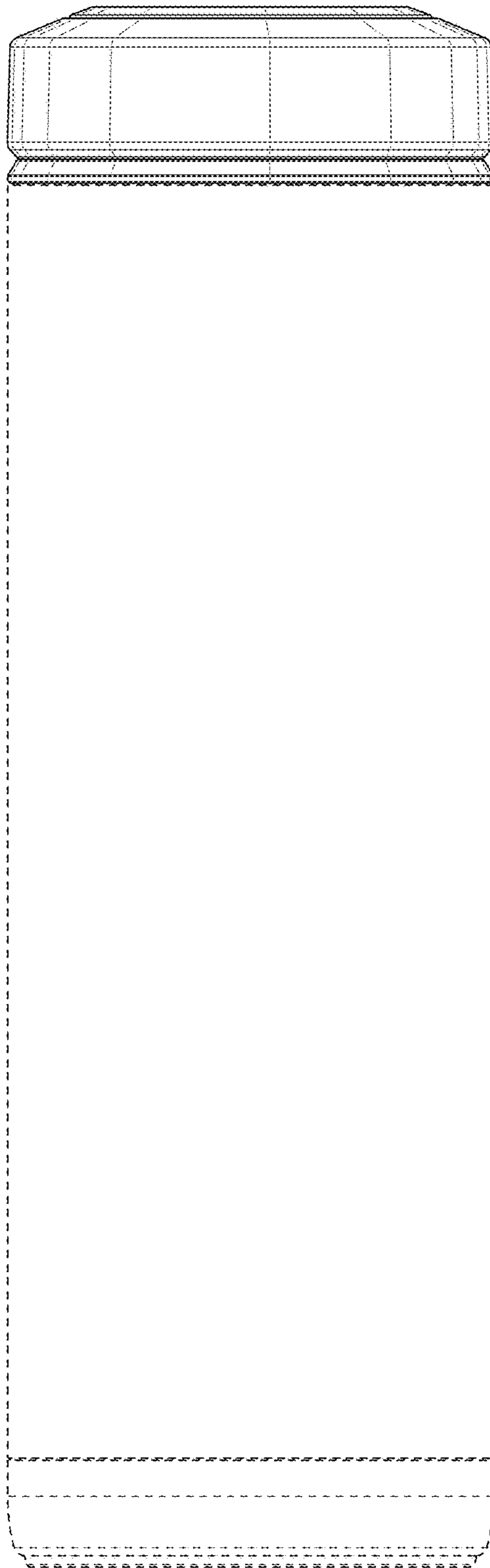

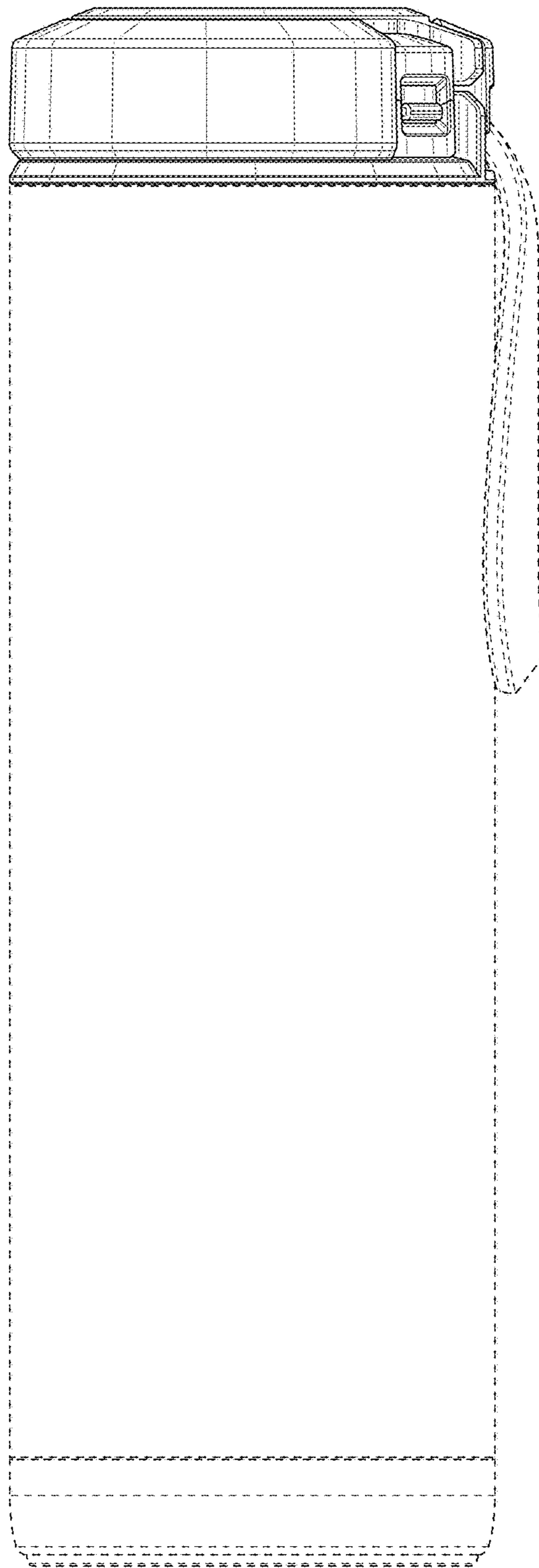

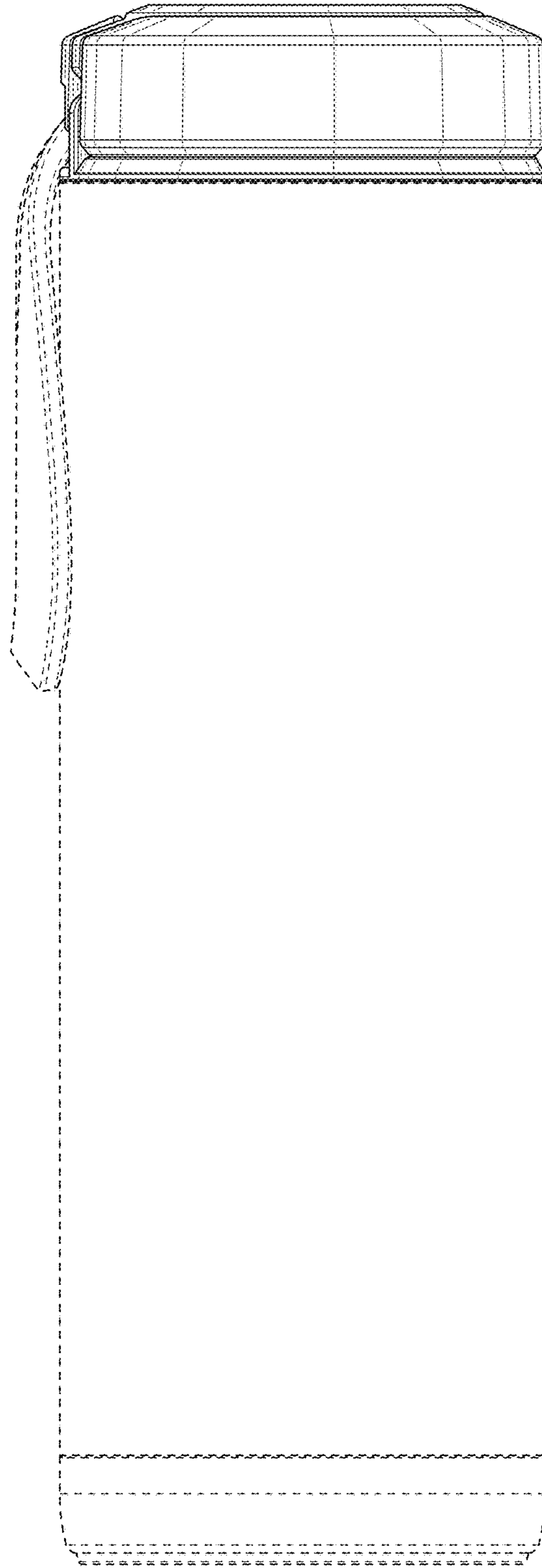

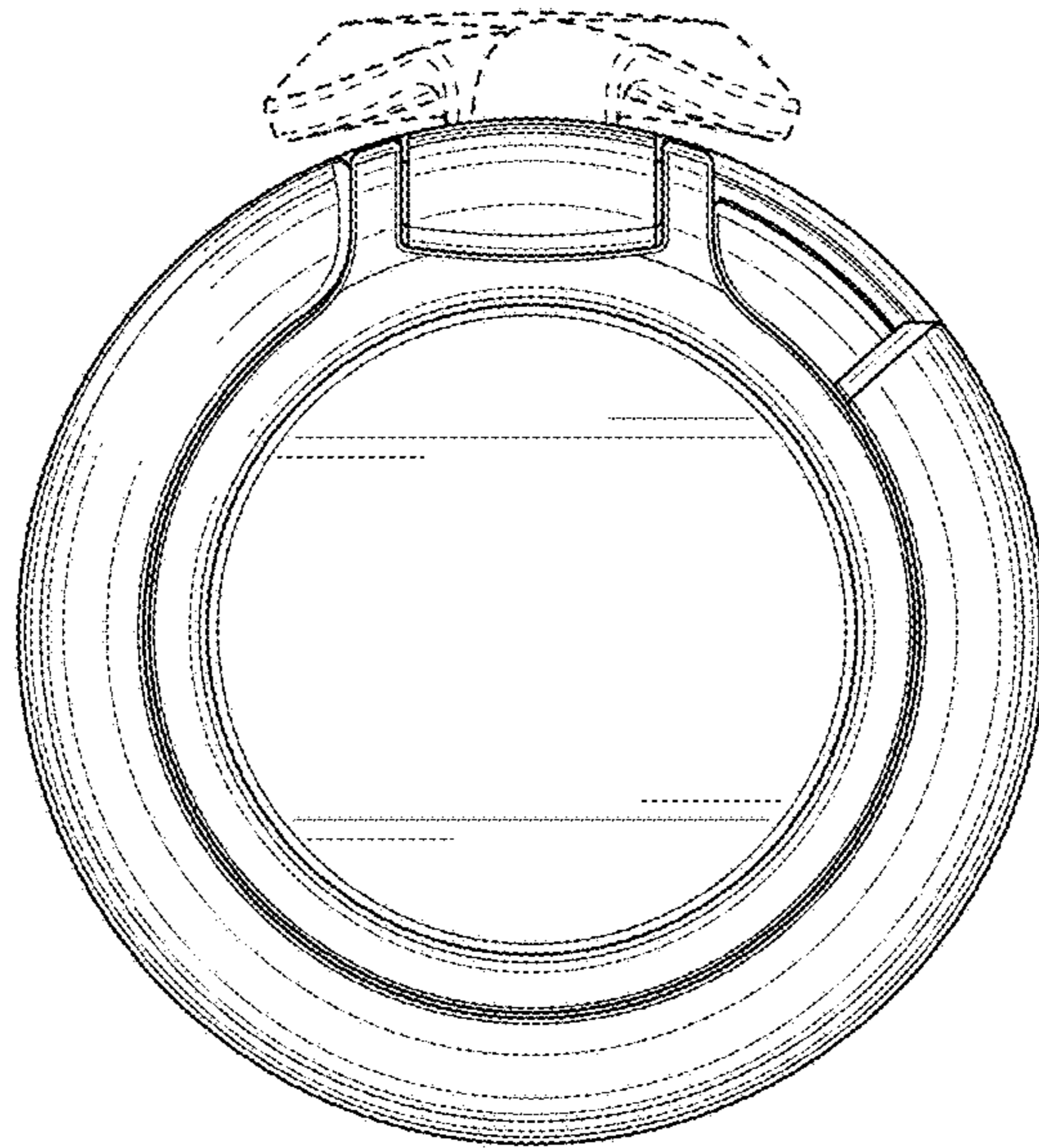

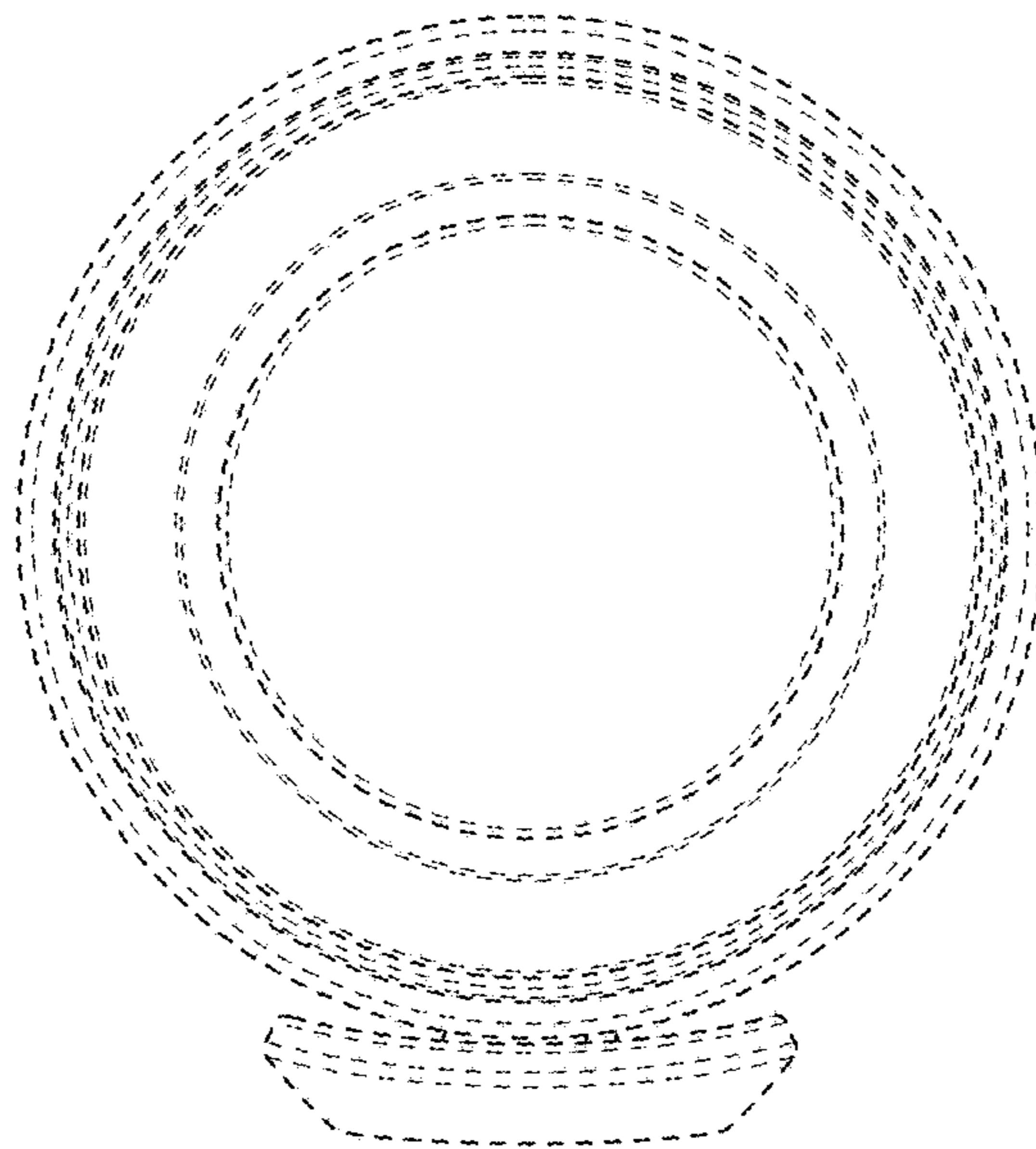
