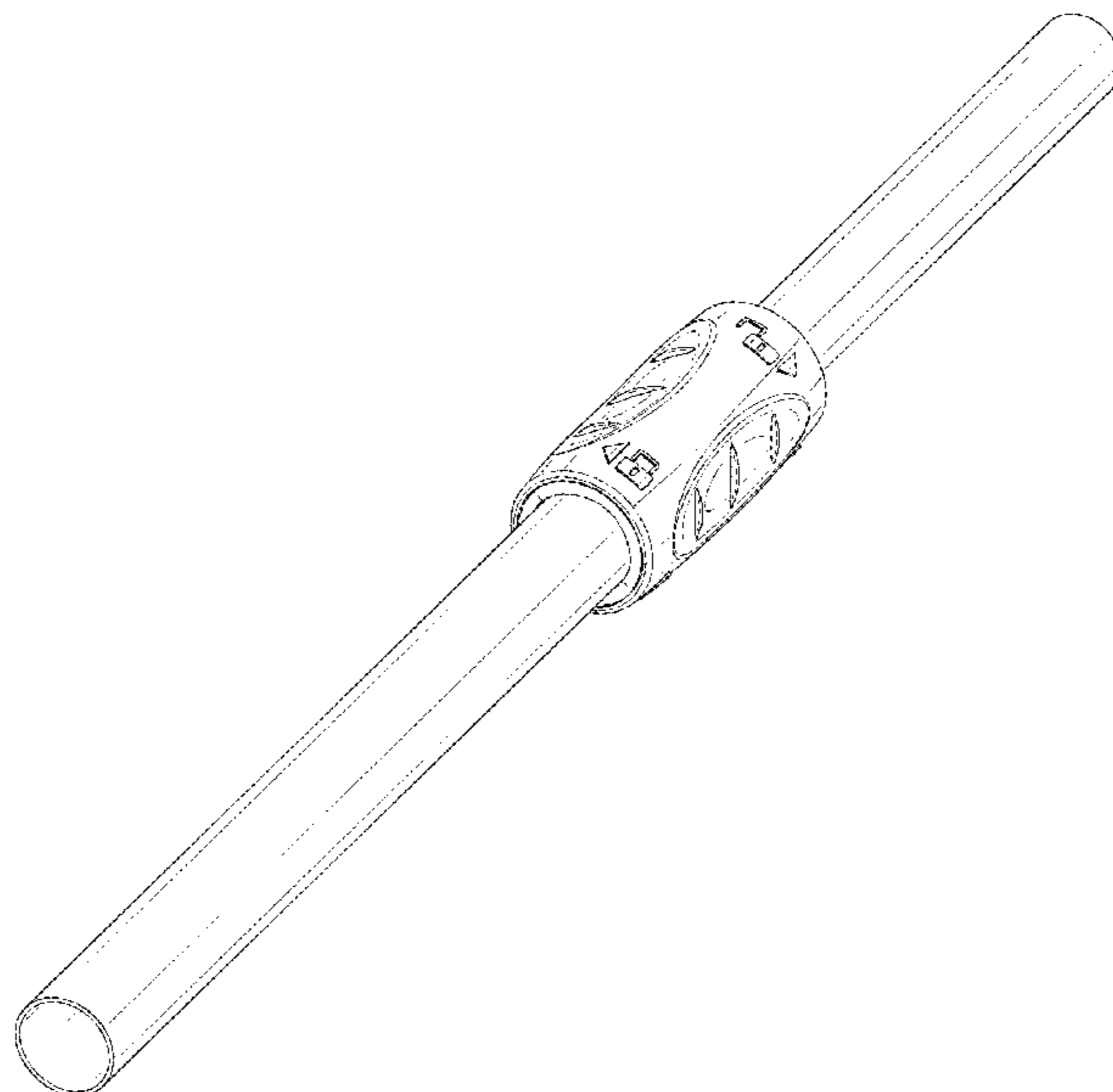
(57) **CLAIM**

The ornamental design for a locking extension pole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a locking extension pole showing my new design;  
FIG. 2 is a front elevation view thereof;

FIG. 4 is a first side elevation view thereof;

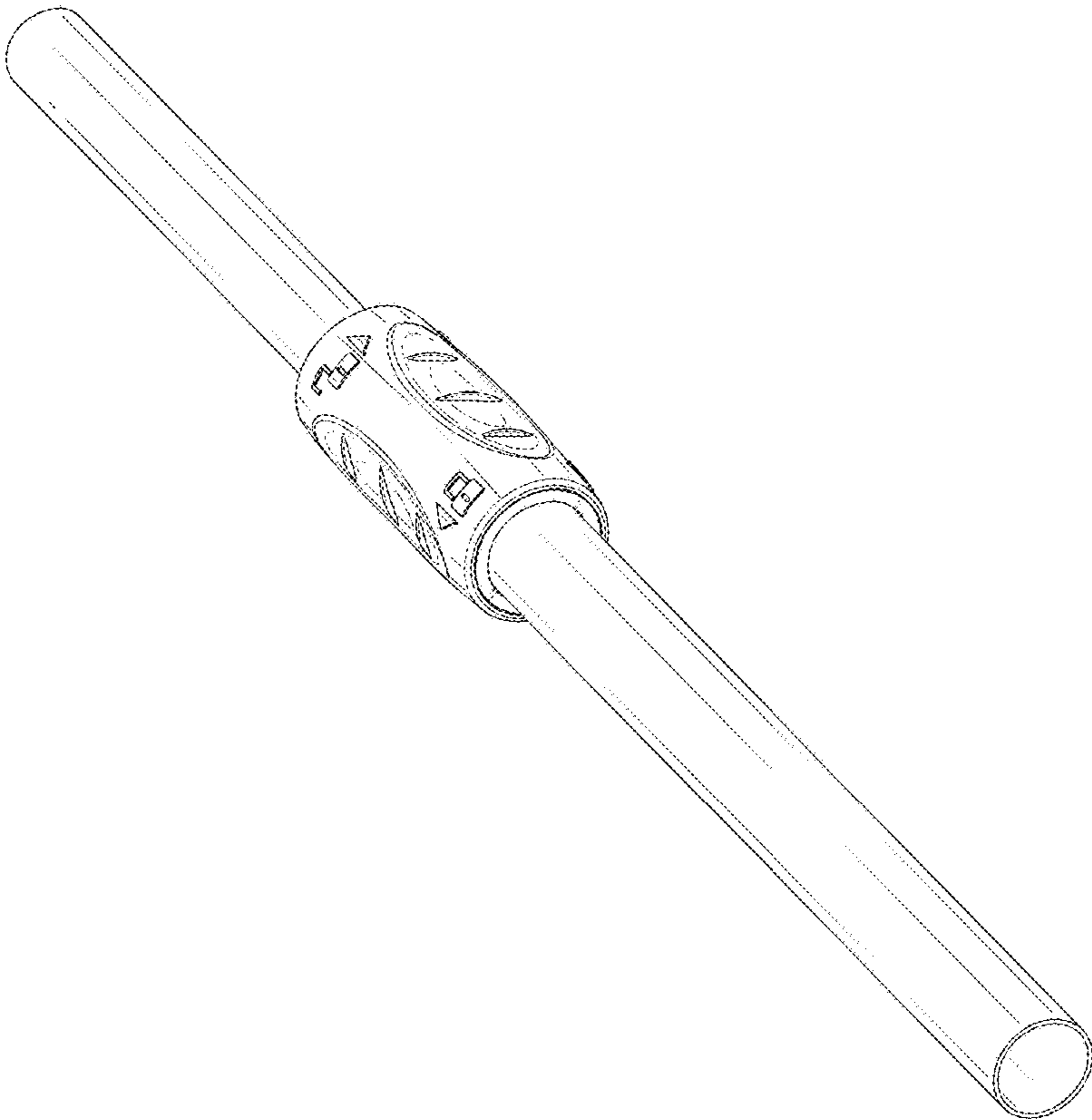

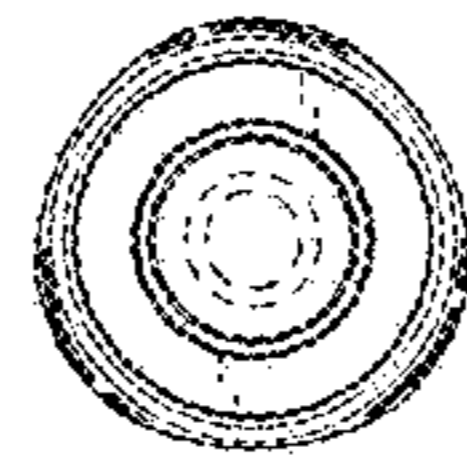

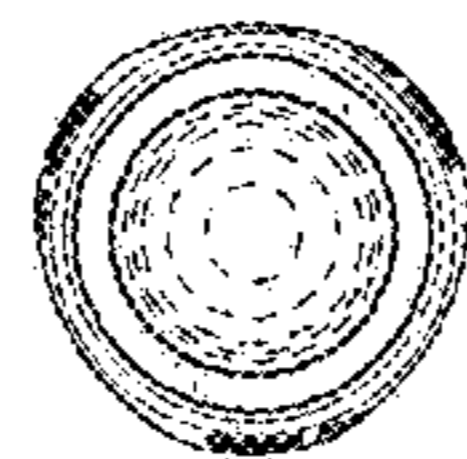

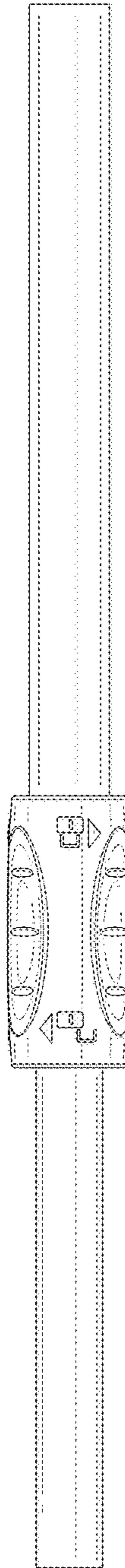

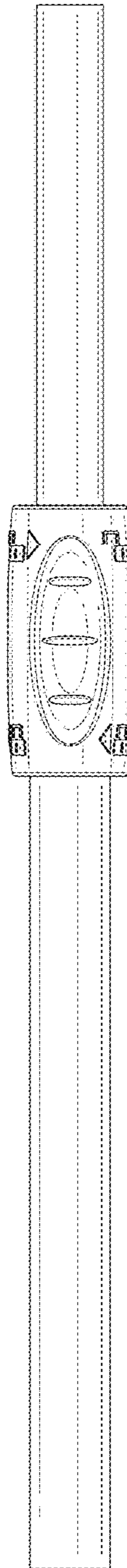

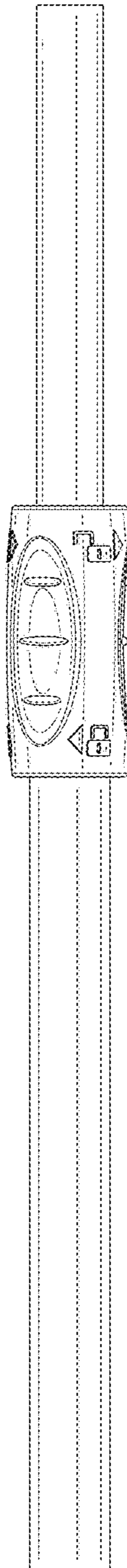

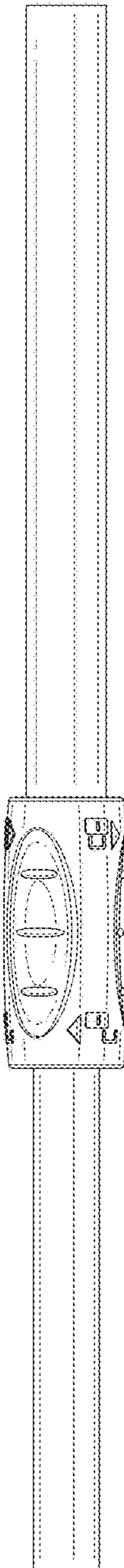
