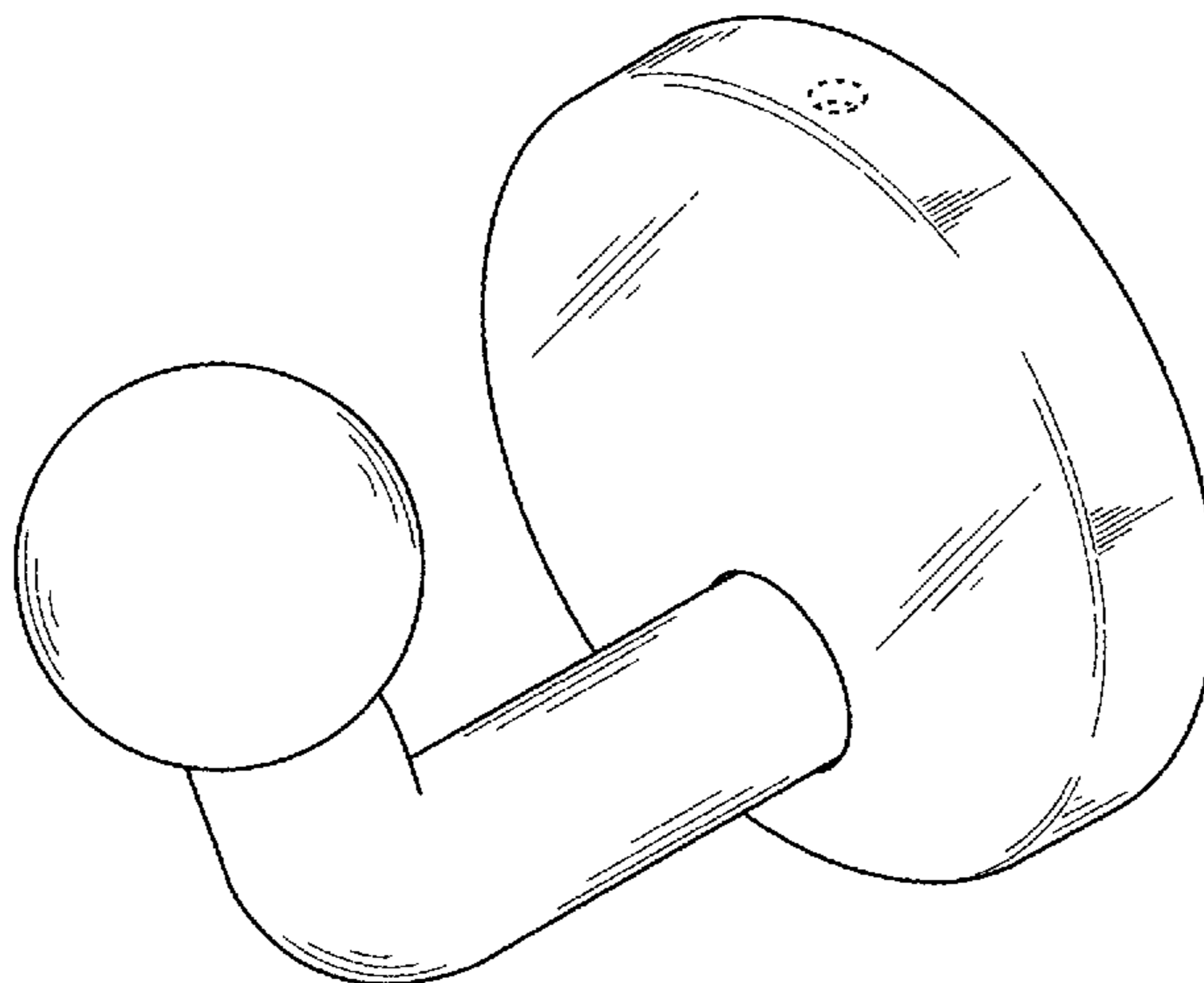
(57) **CLAIM**

The ornamental design for a hanger for small articles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hanger for small articles according to the invention;
 FIG. 2 is a front elevation view of the hanger for small articles of FIG. 1, the rear elevation view being a mirror image thereof;
 FIG. 3 is a top plan view of the hanger for small articles of FIG. 1;
 FIG. 4 is a bottom plan view of the hanger for small articles of FIG. 1;
 FIG. 5 is a left side elevation view of the hanger for small articles of FIG. 1; and,
 FIG. 6 is a right side elevation view of the hanger for small articles of FIG. 1.
 The broken lines represent portions of the hanger for small articles that form no part of the claim.

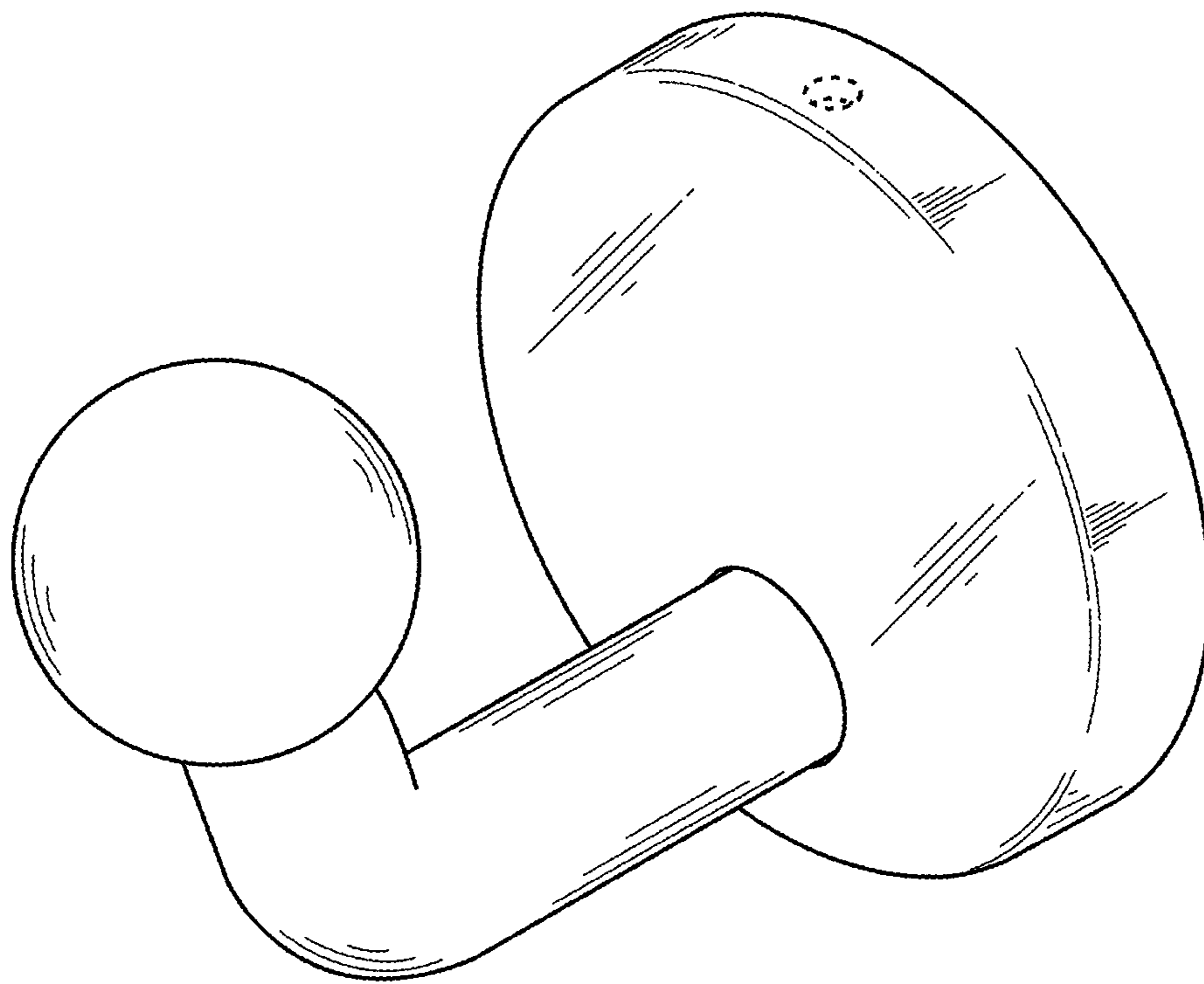

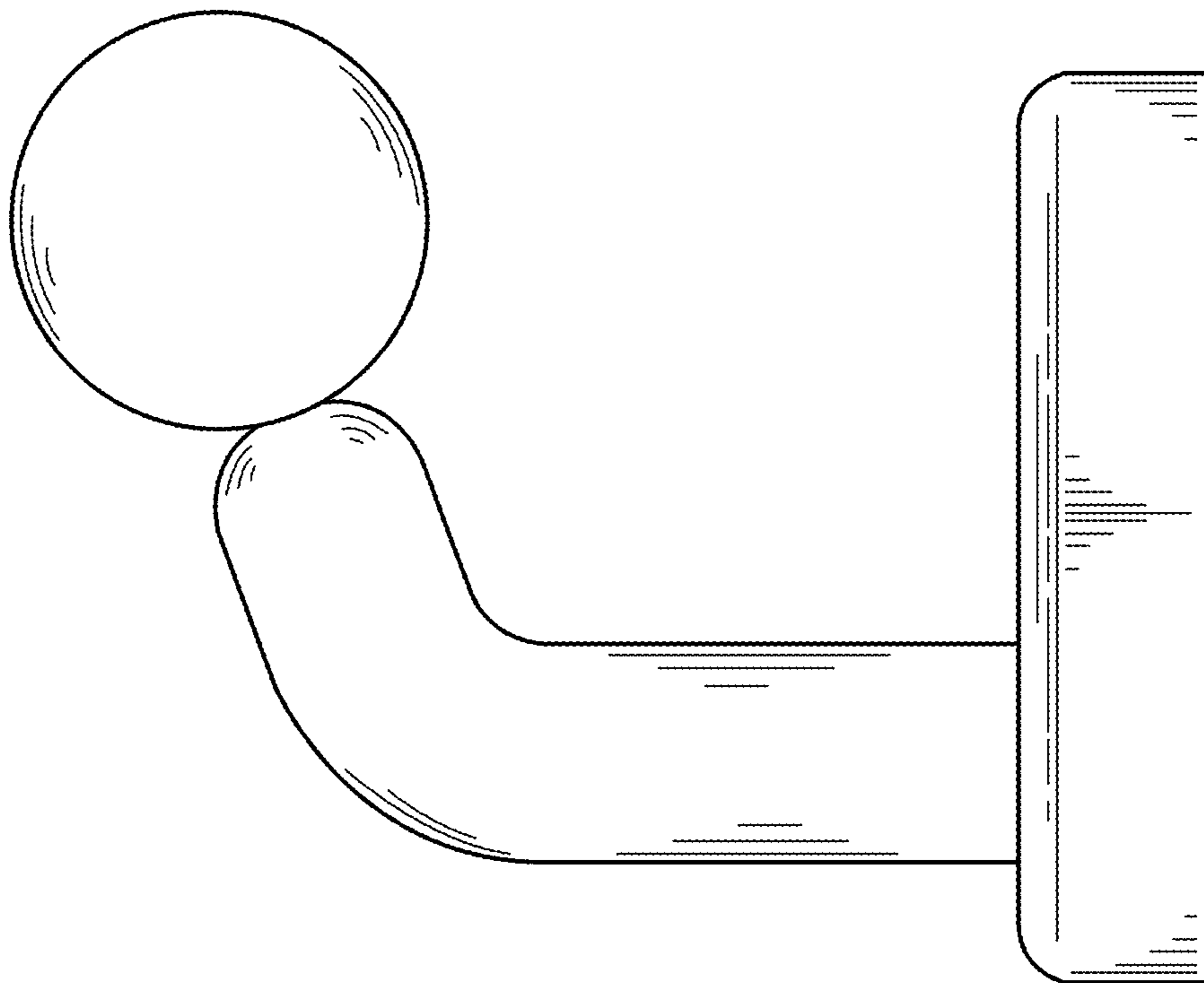

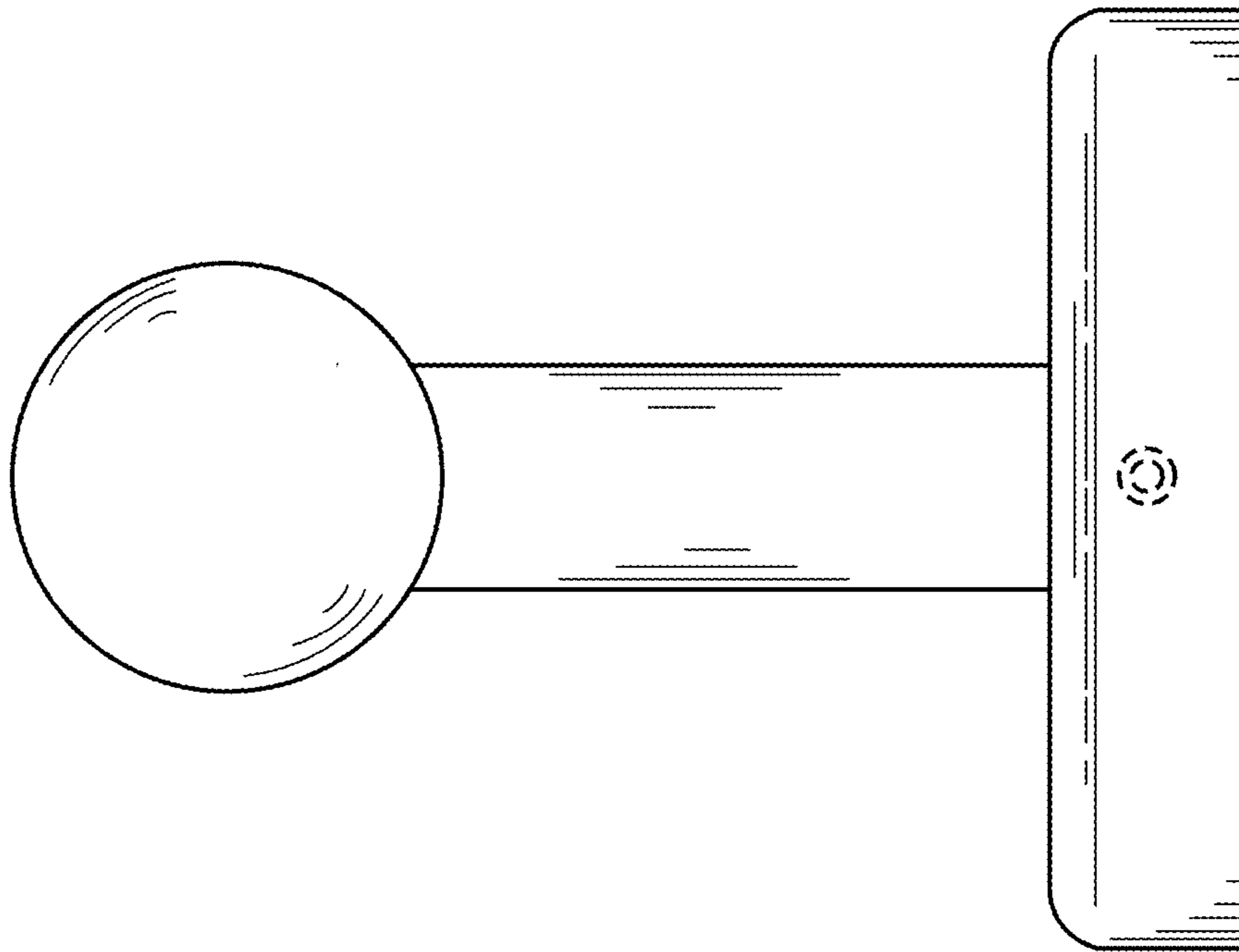

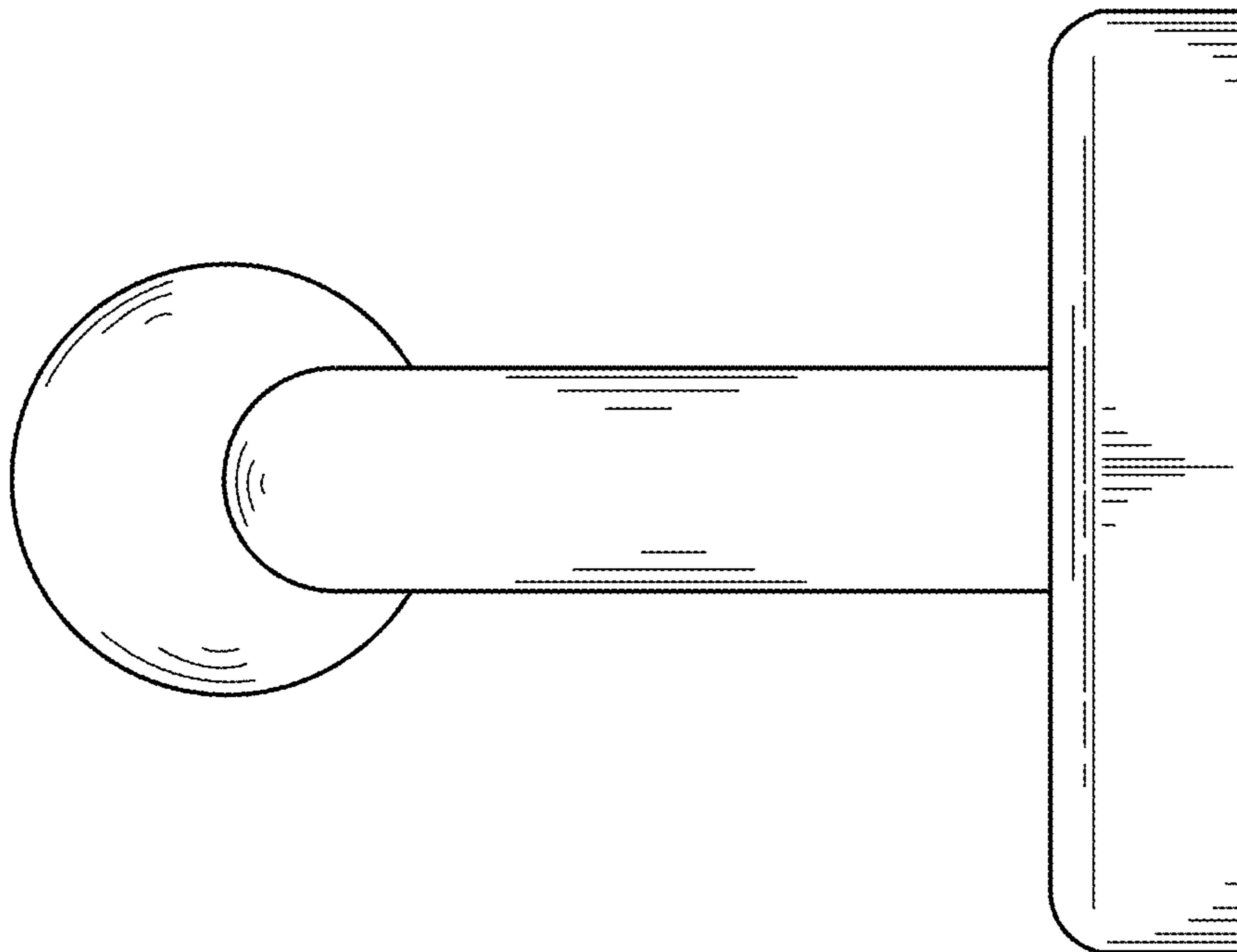

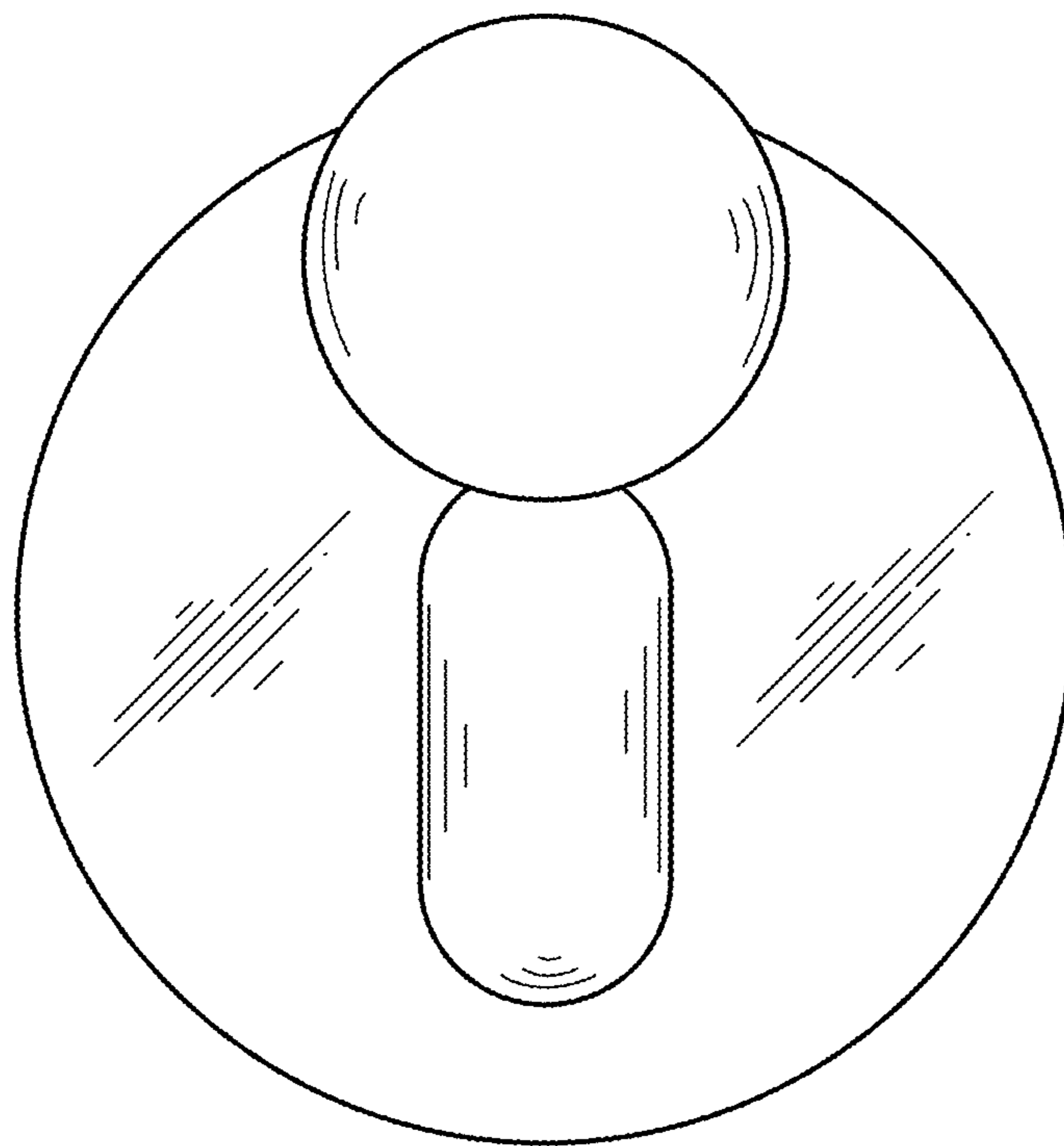
