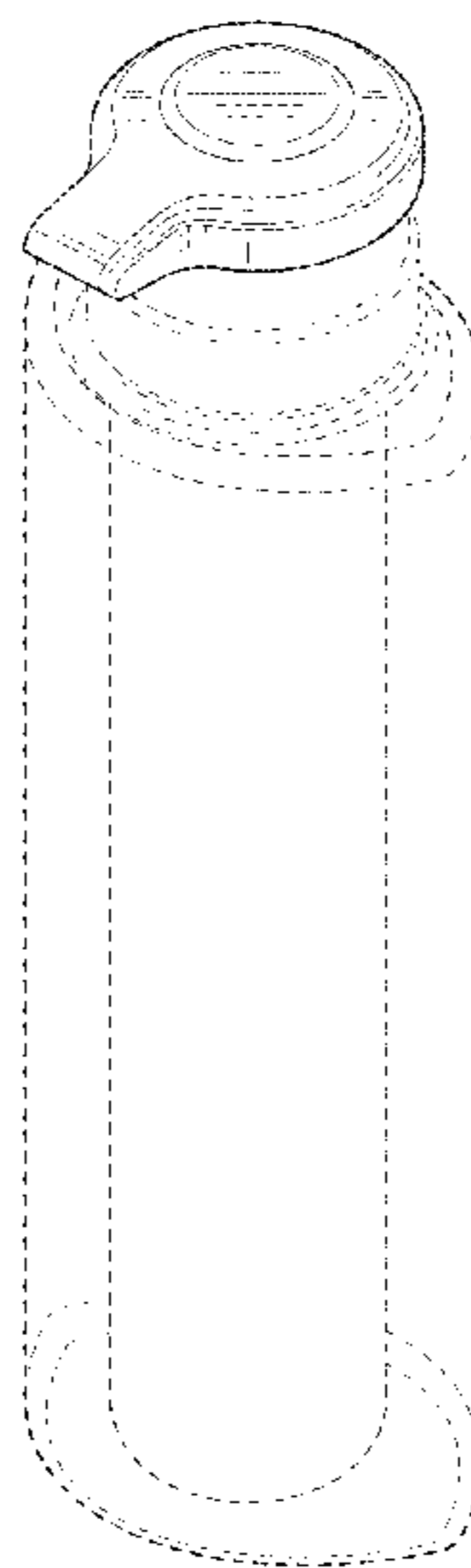
The ornamental design for an oral care implement, as shown and described.

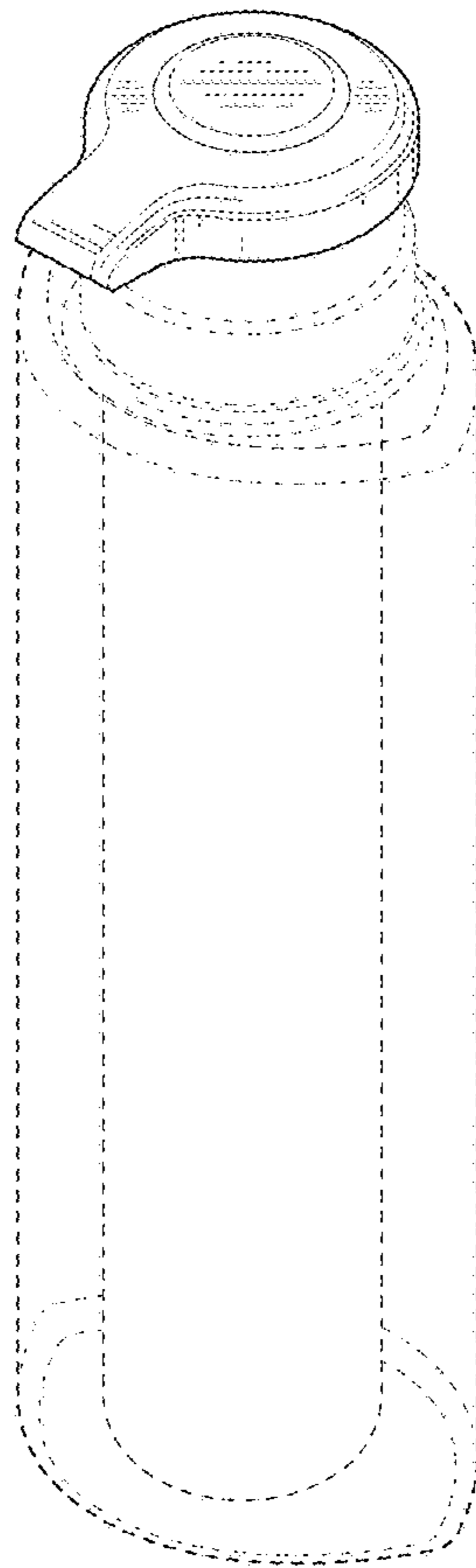

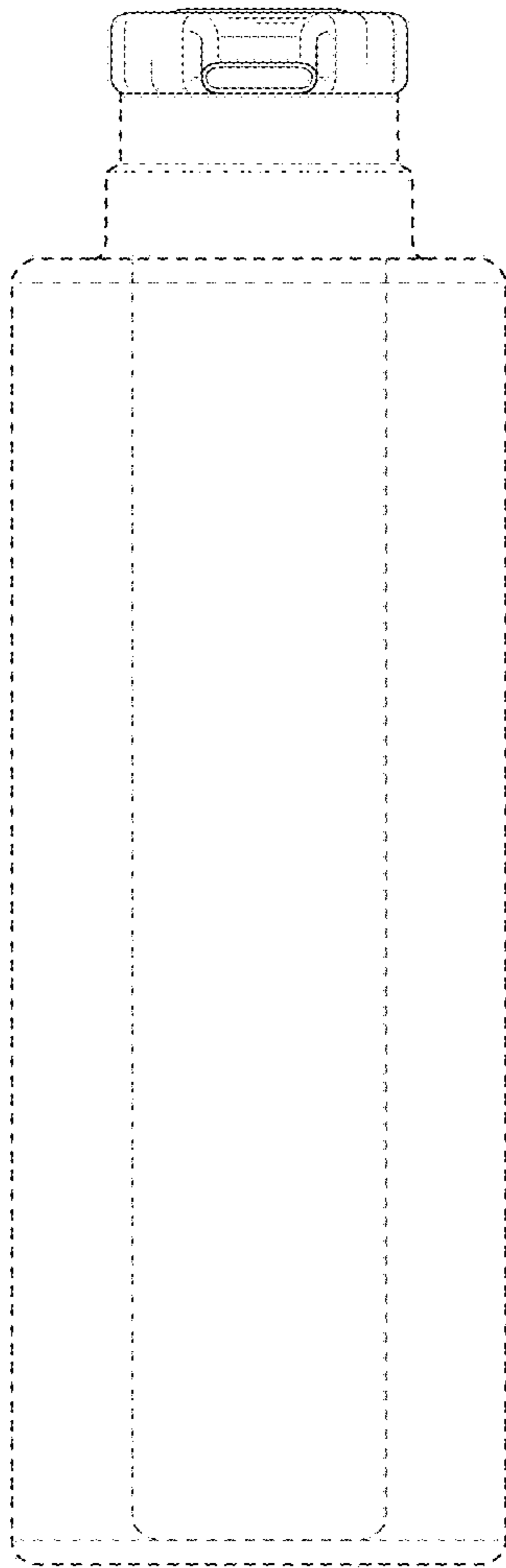

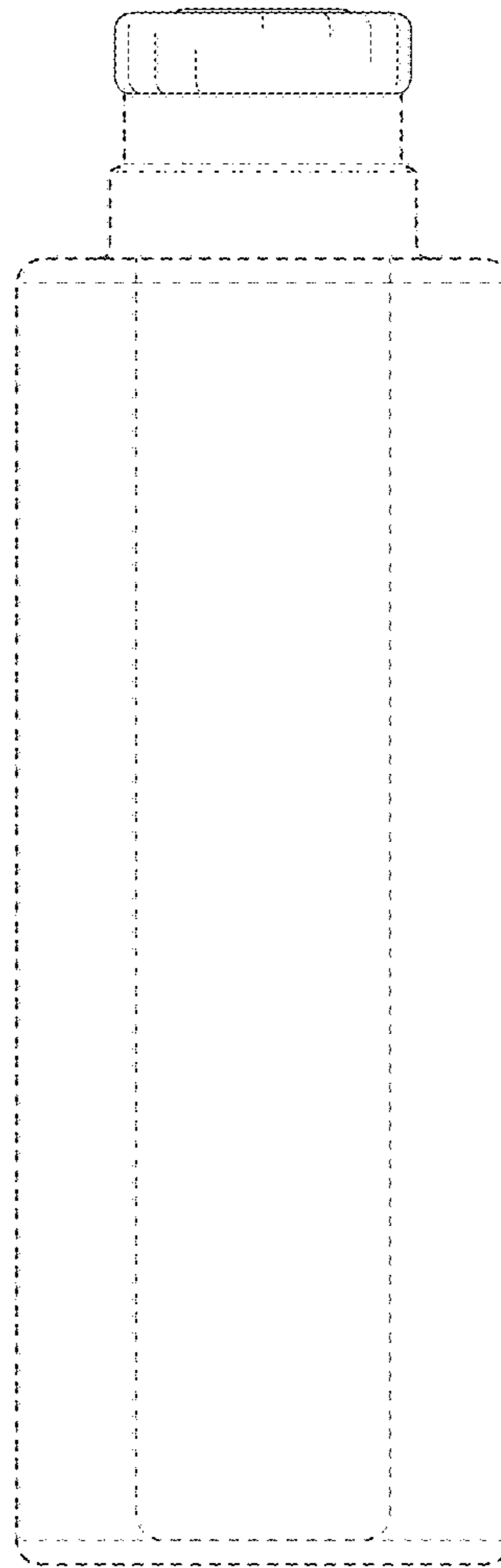

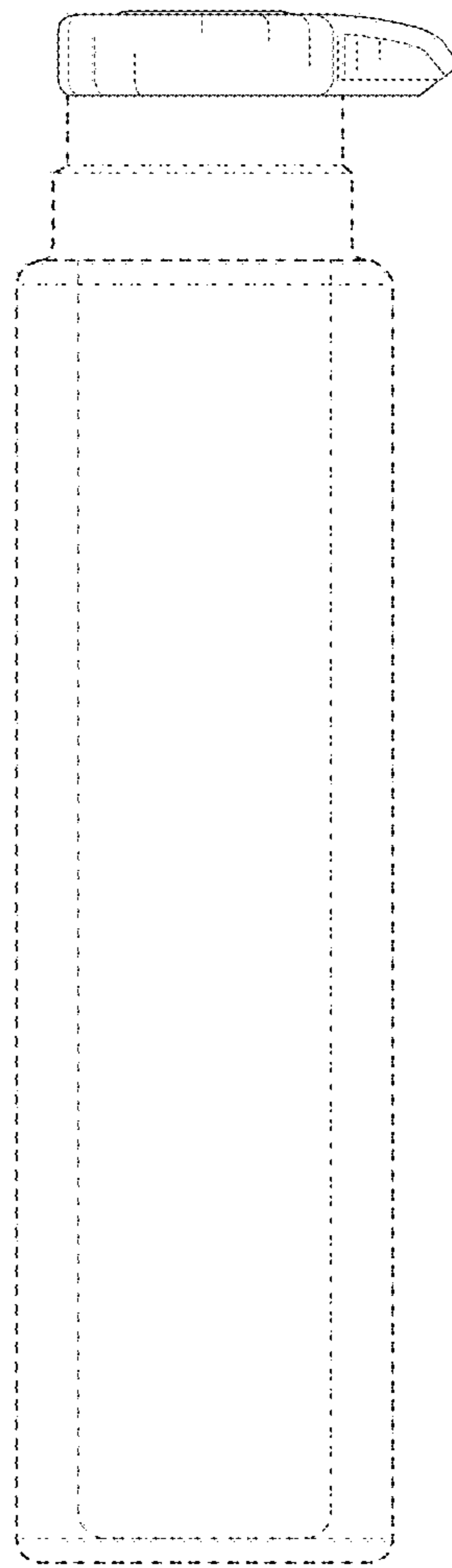

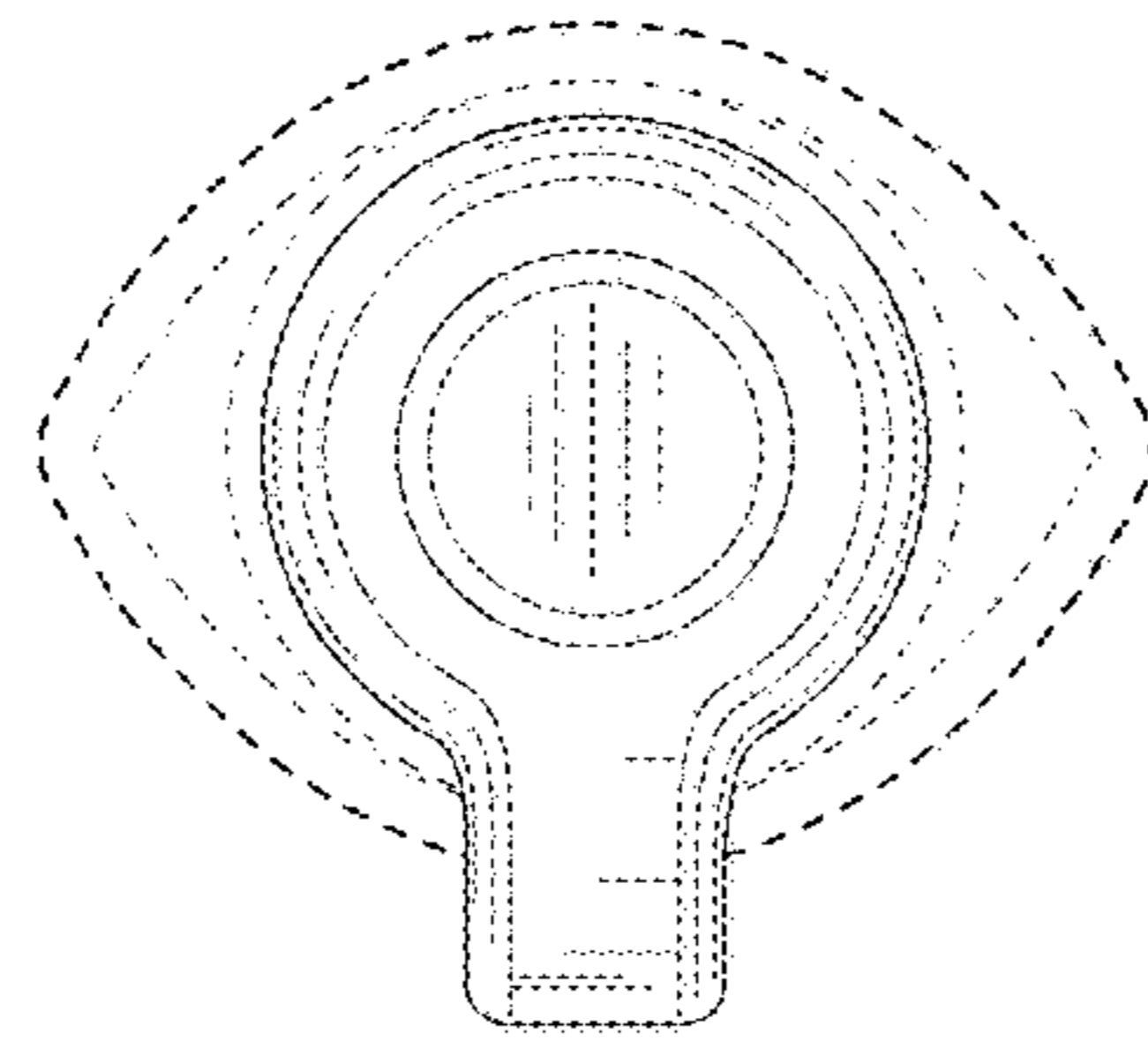

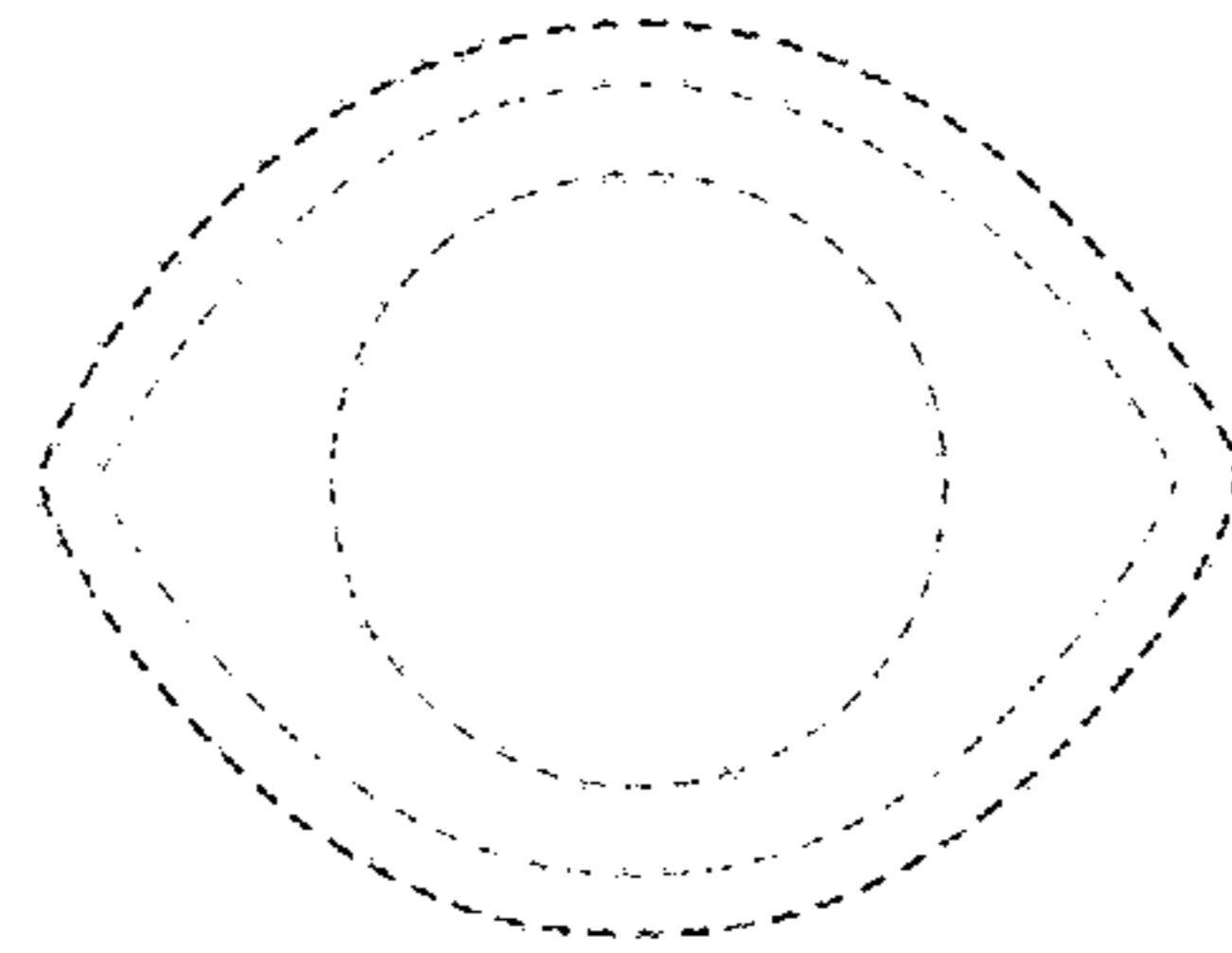
