**DESCRIPTION**

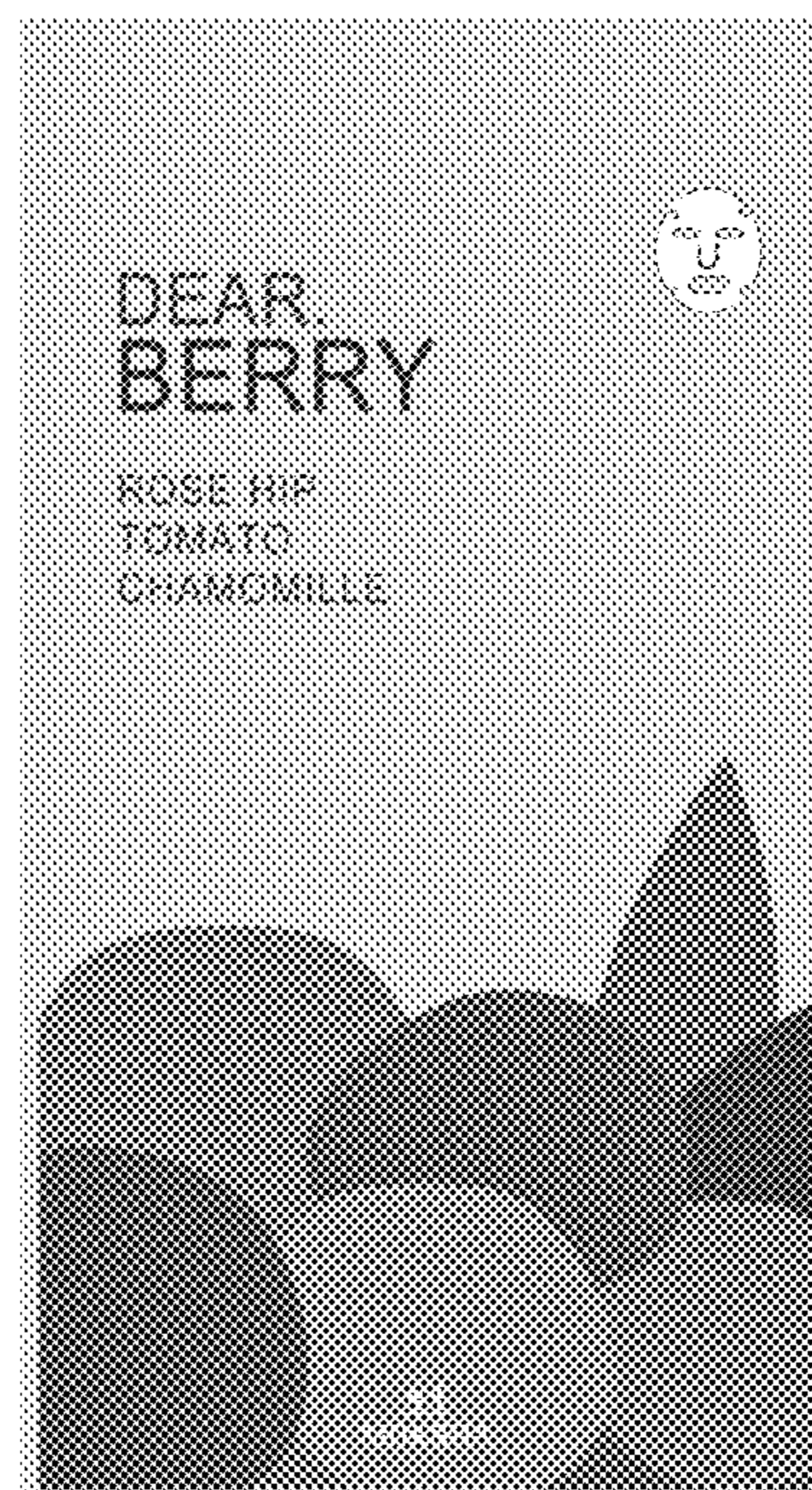
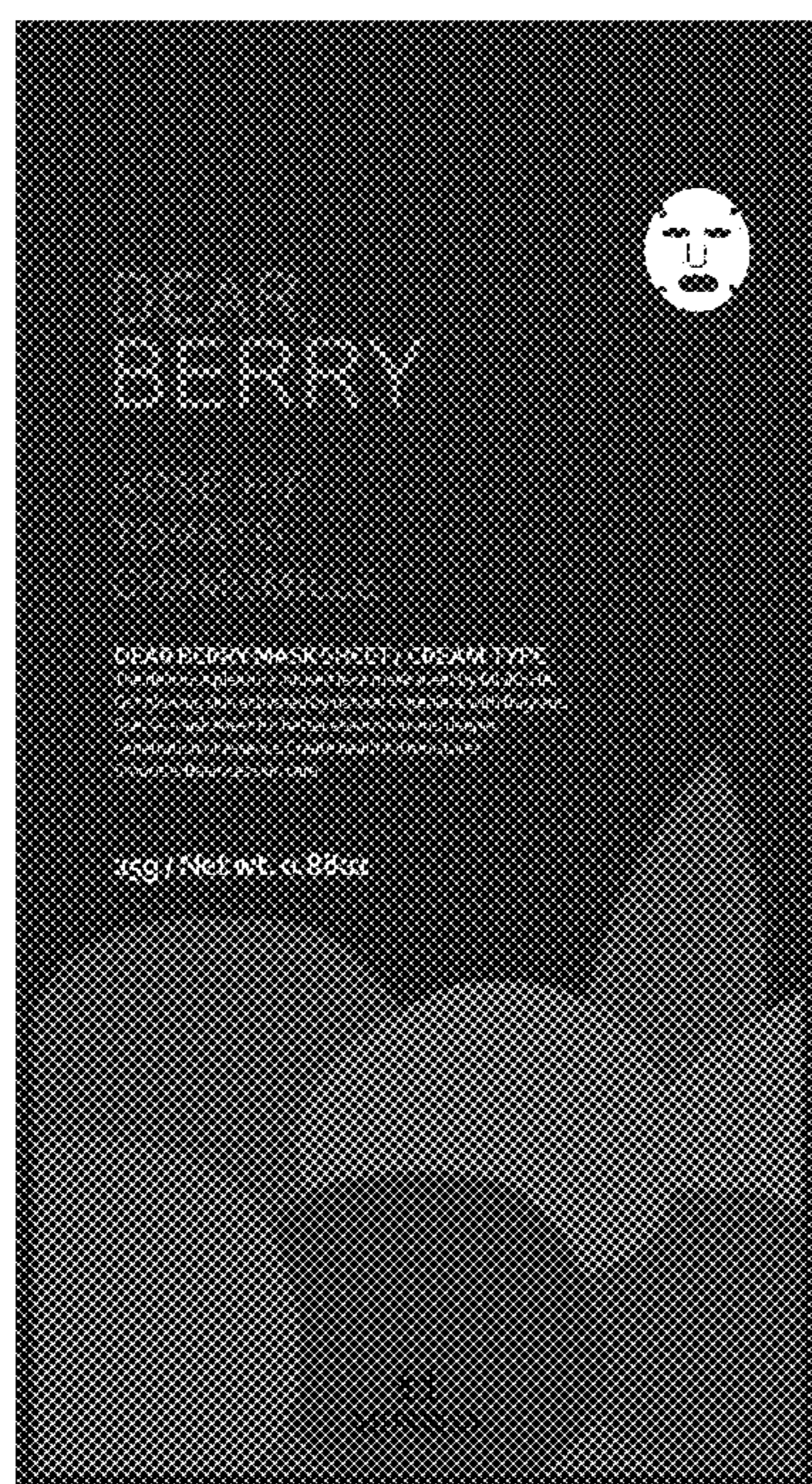

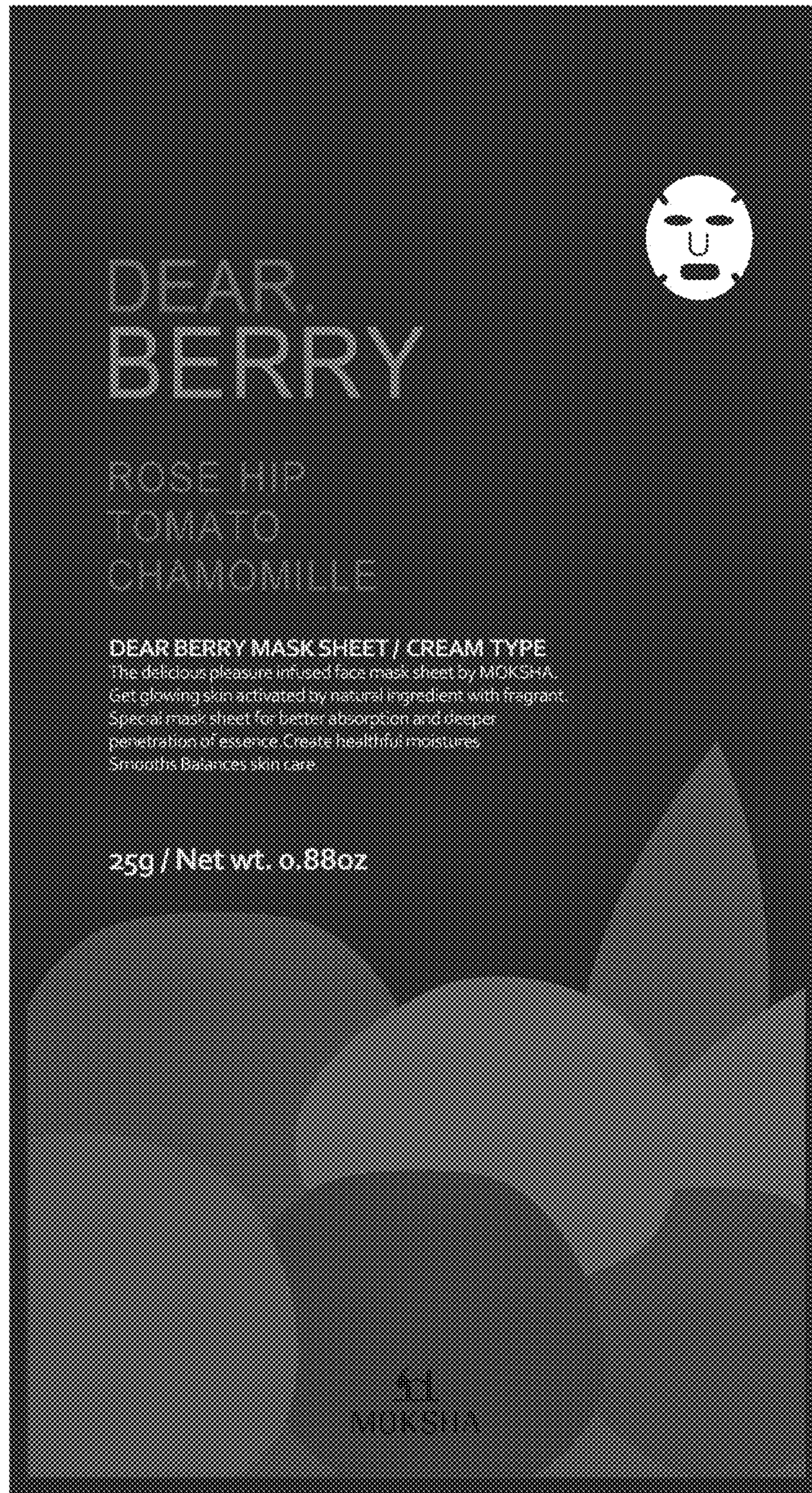
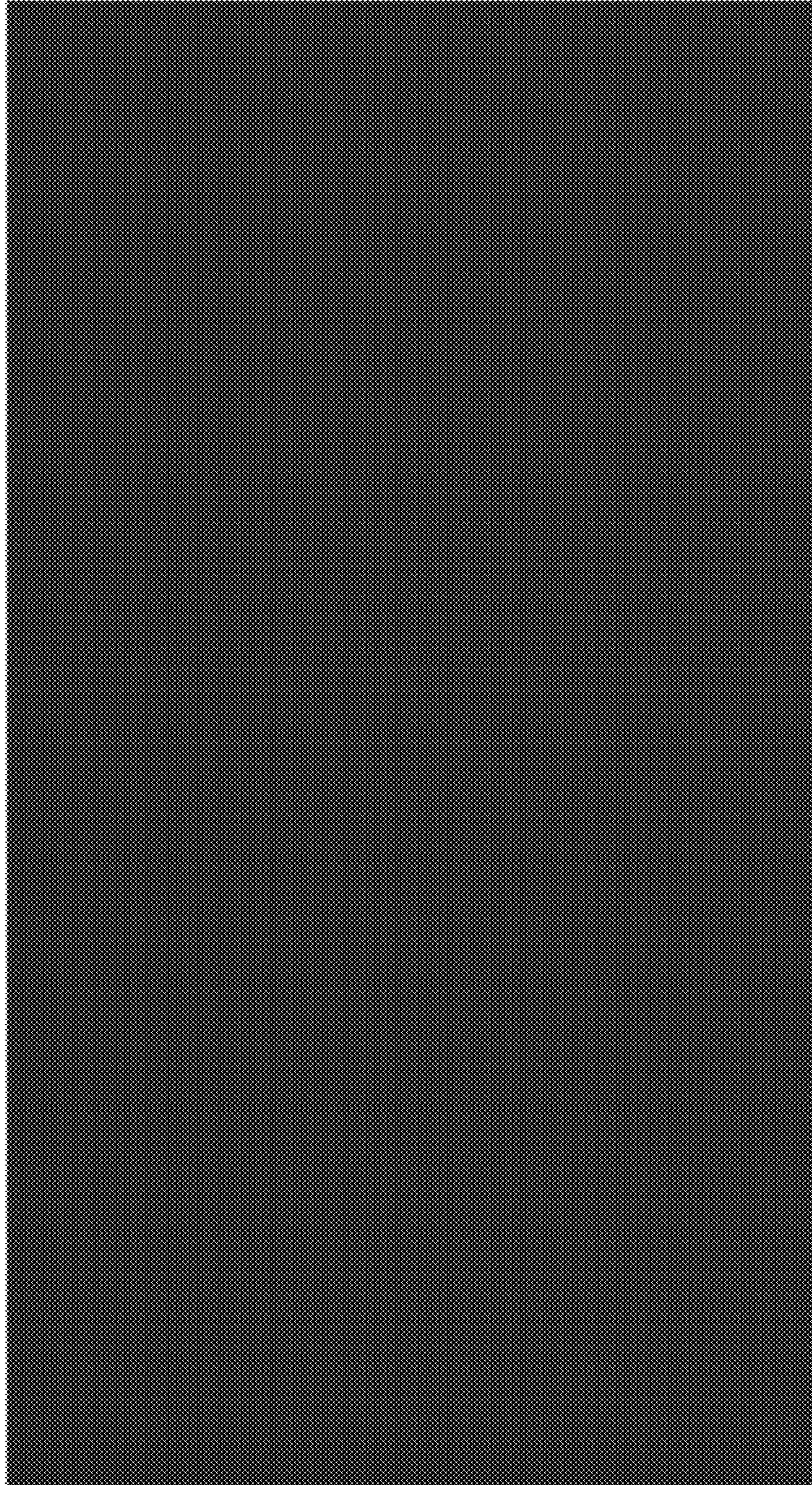

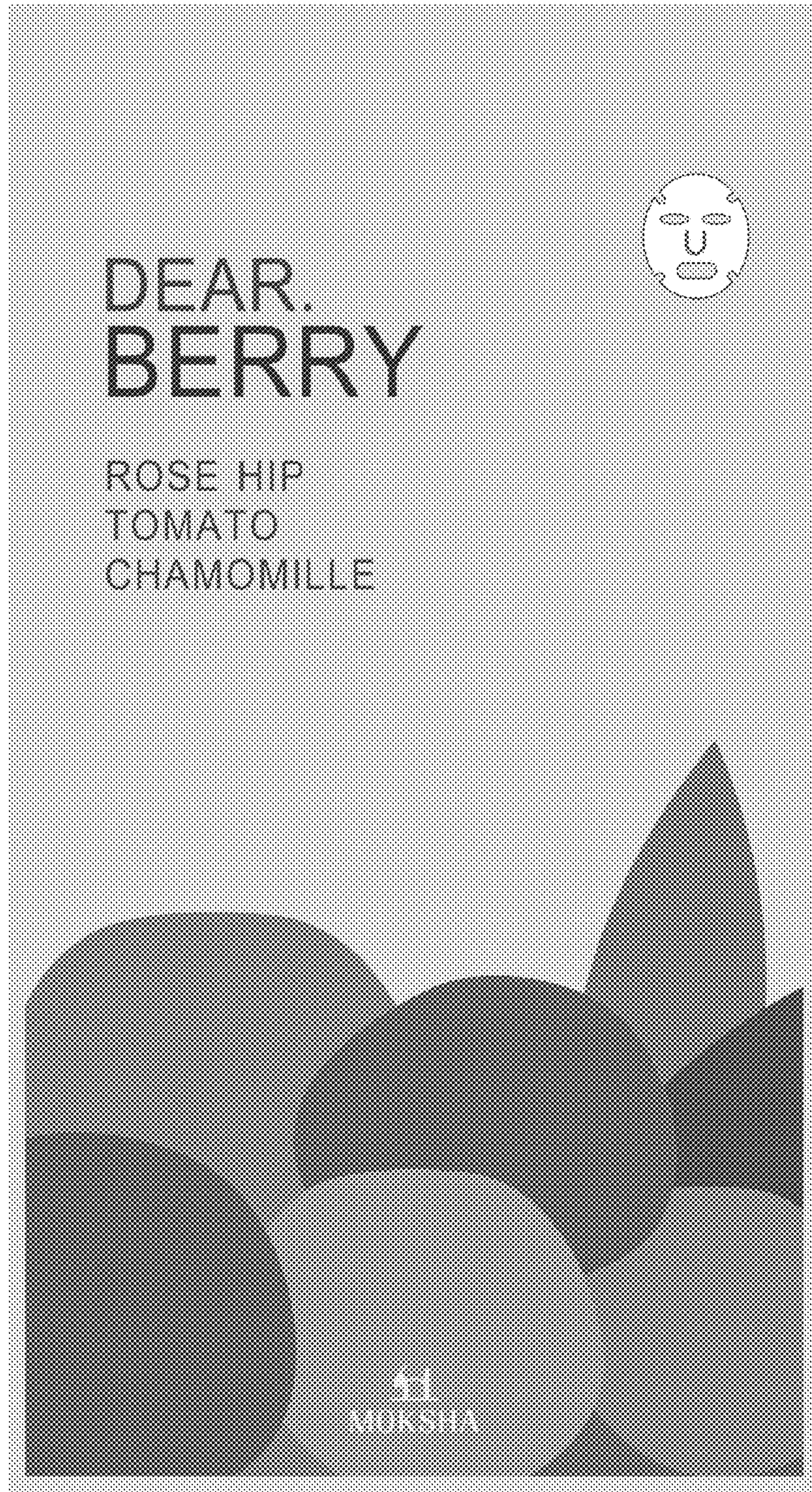
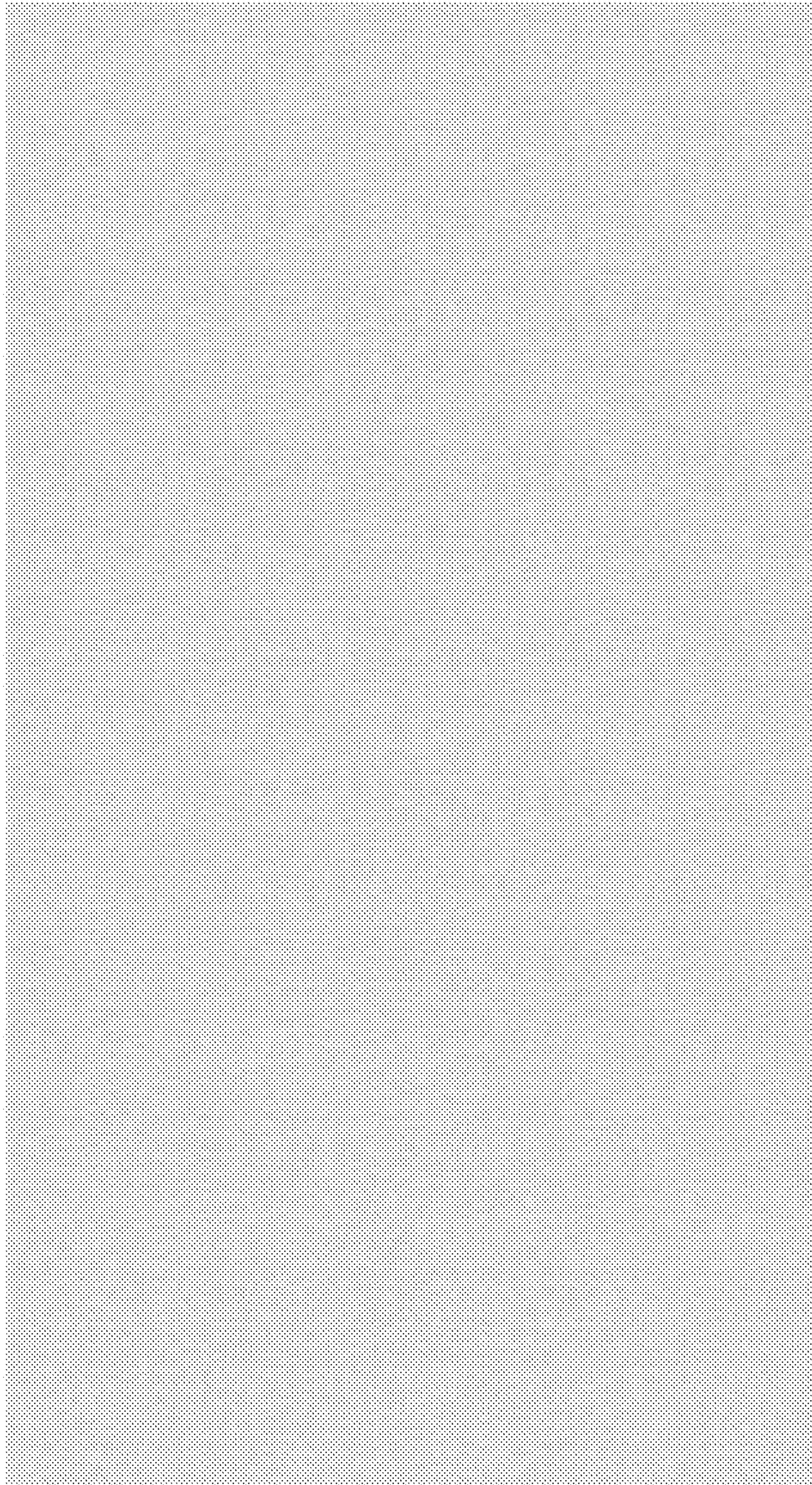
