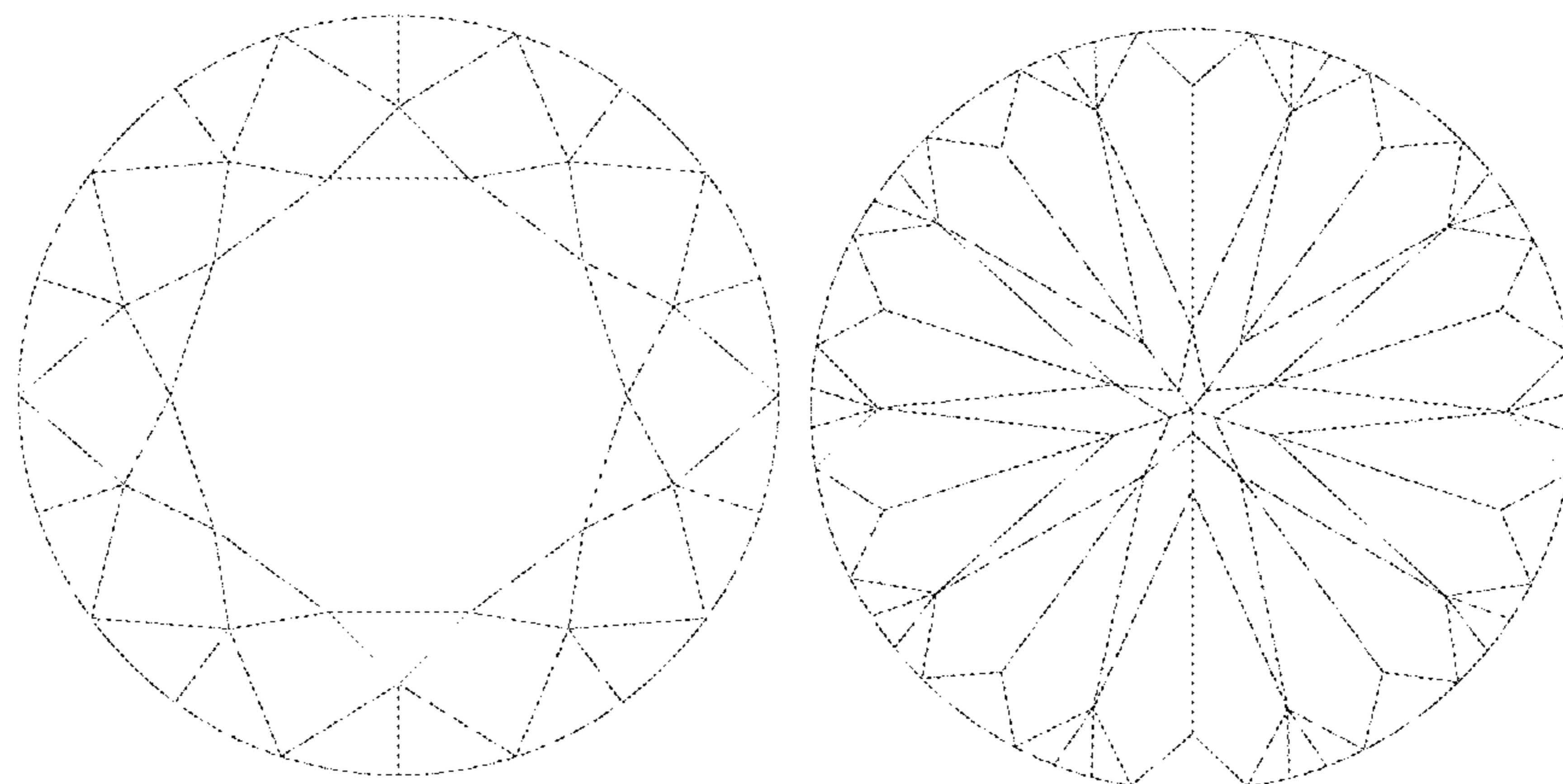
The ornamental design for a faceted gemstone, as shown and described.

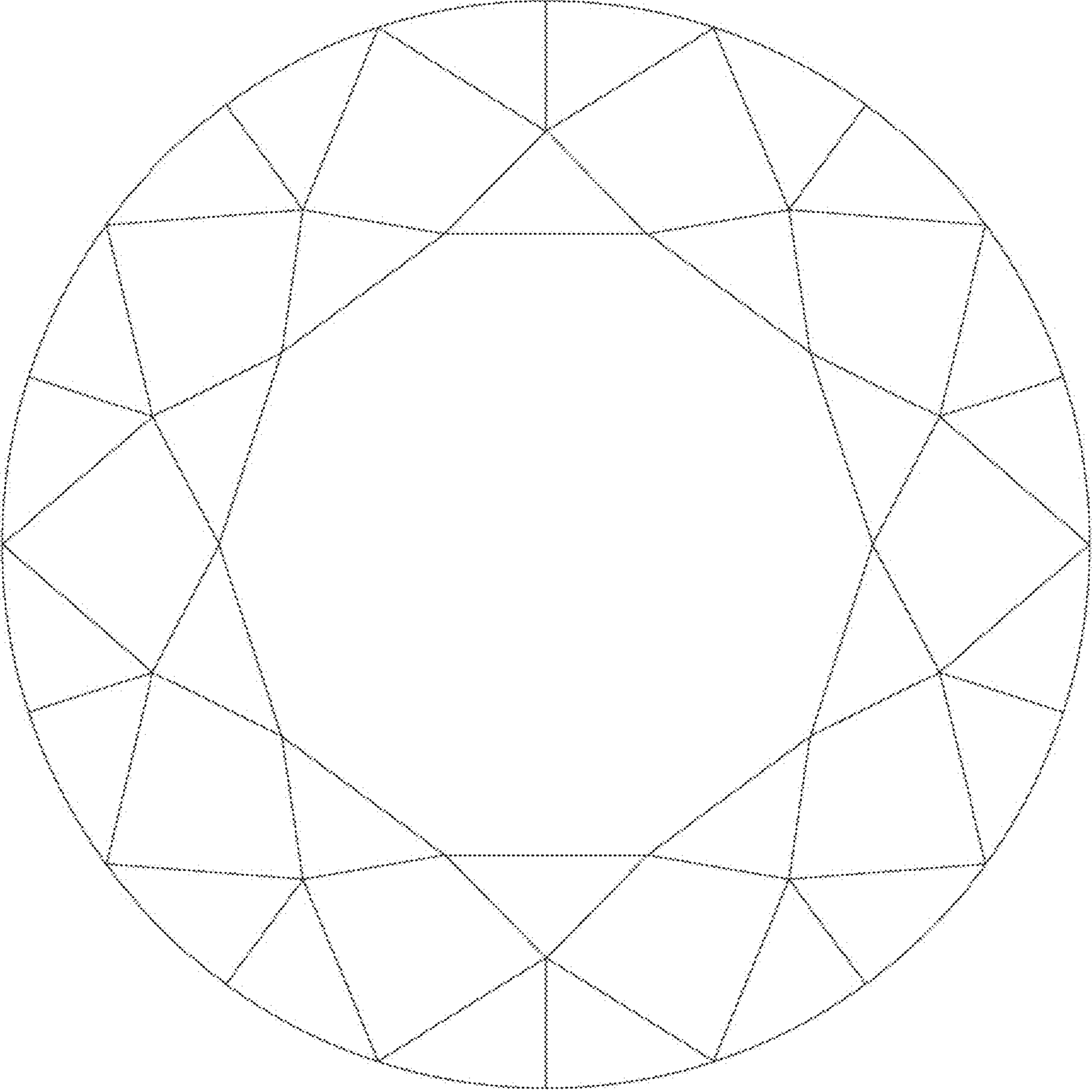

The right side view is omitted as it is a mirror image of the left side view.

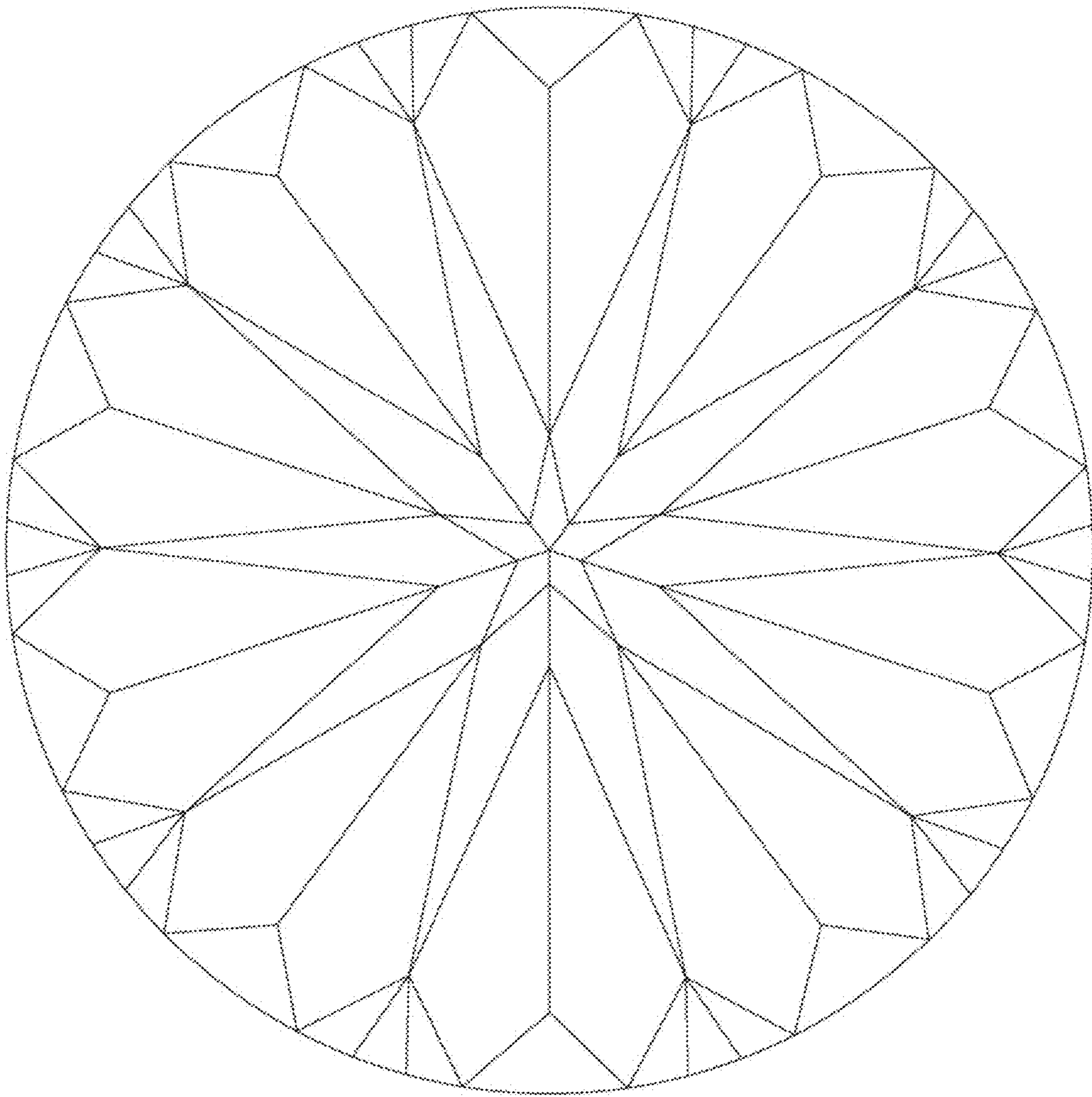

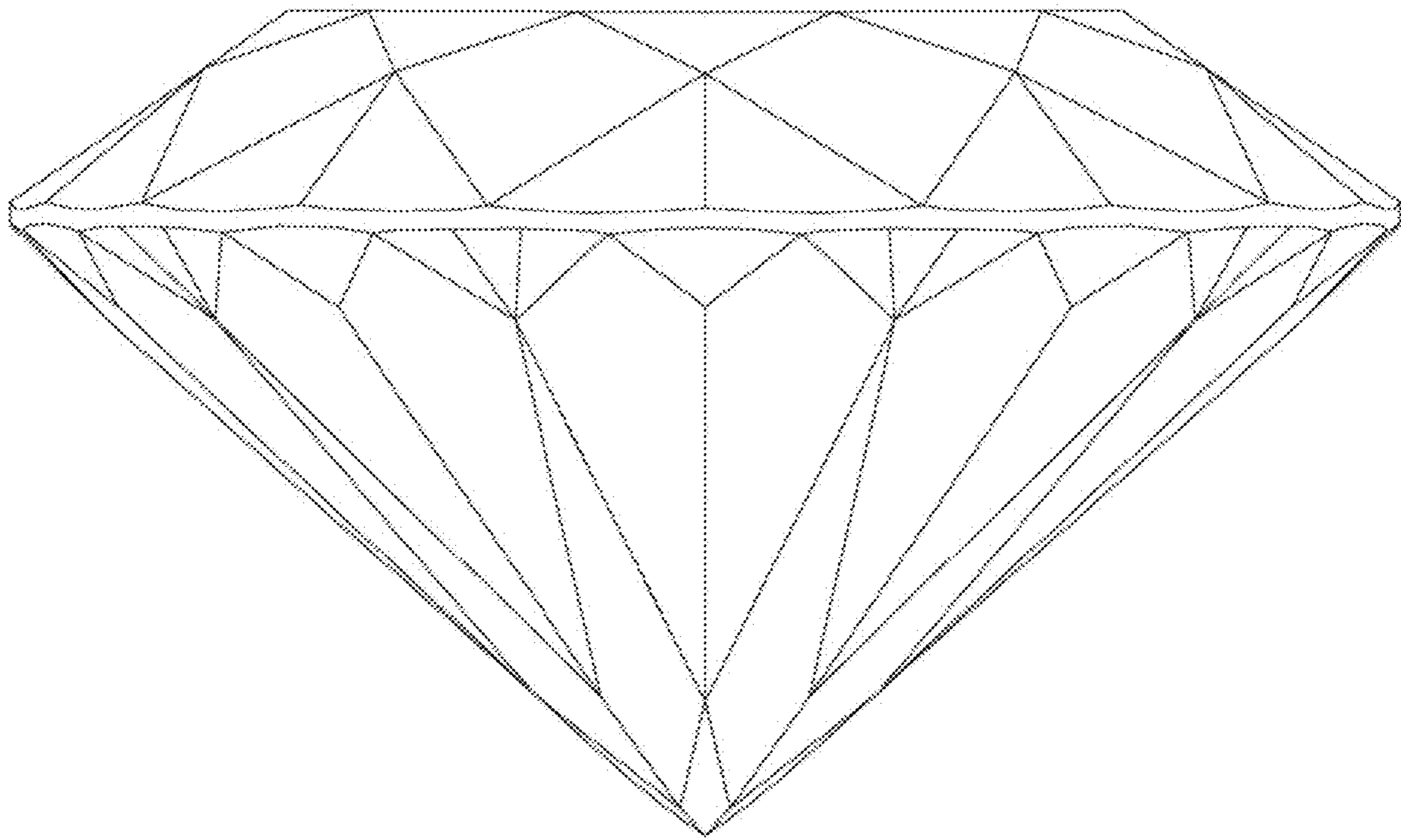

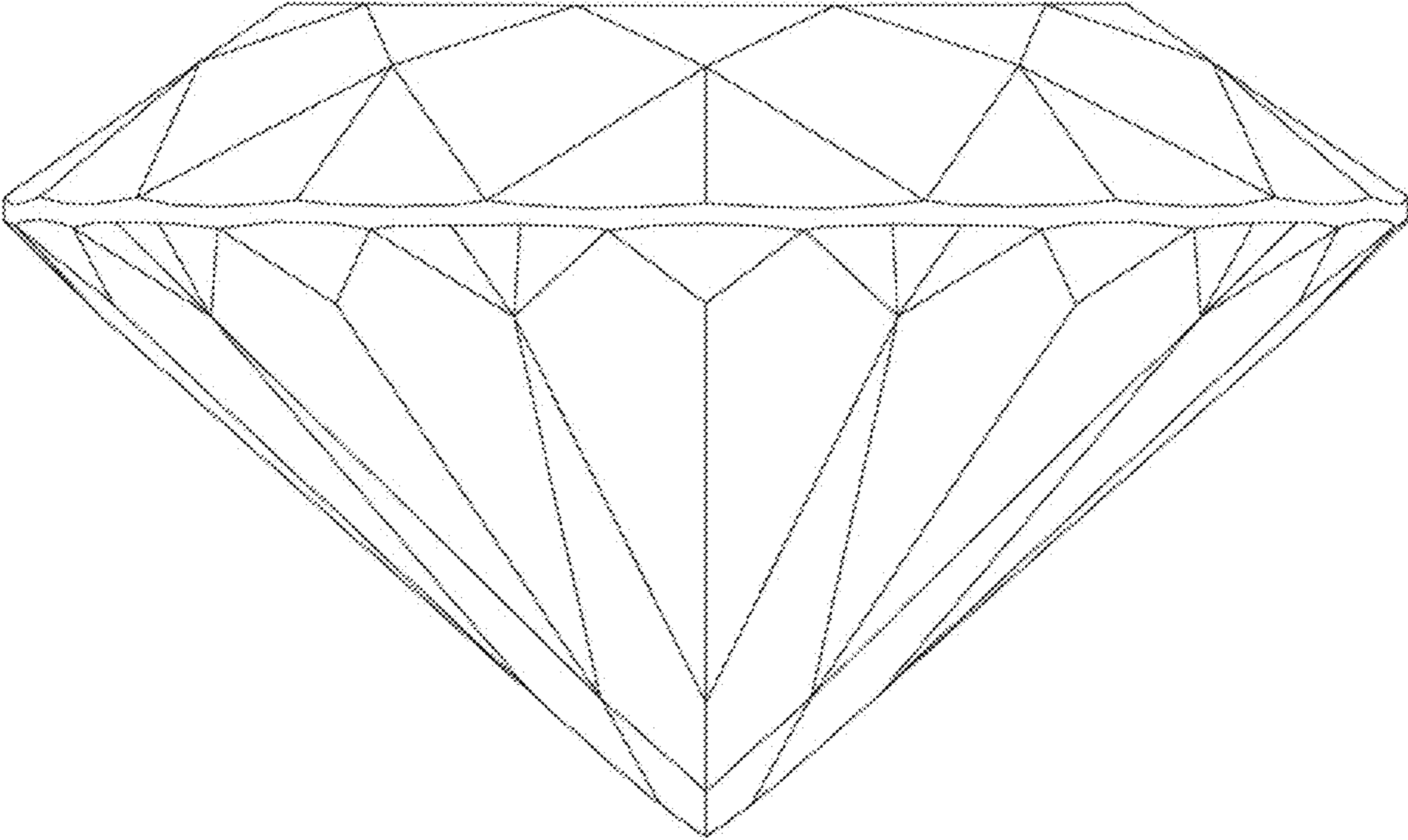

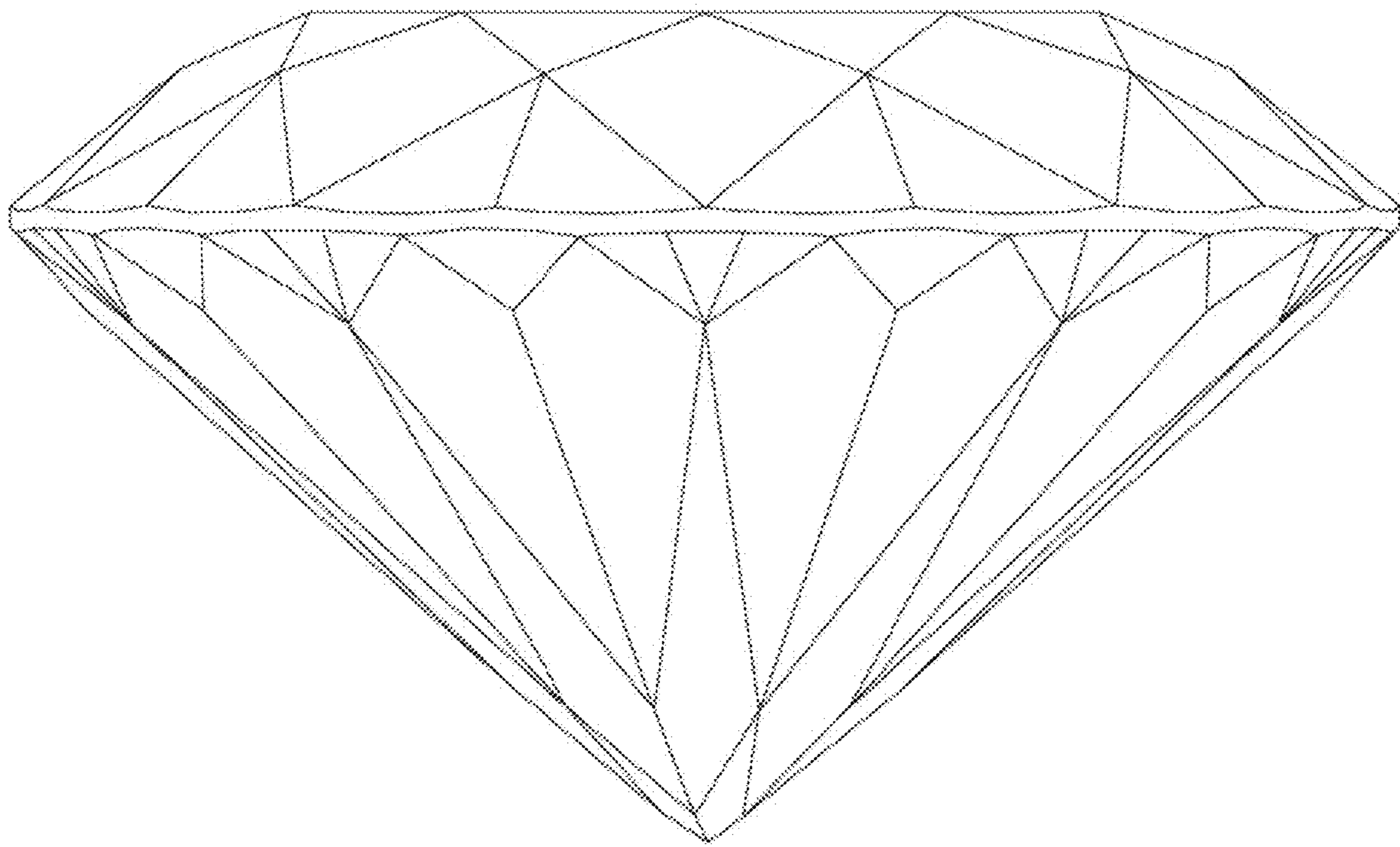

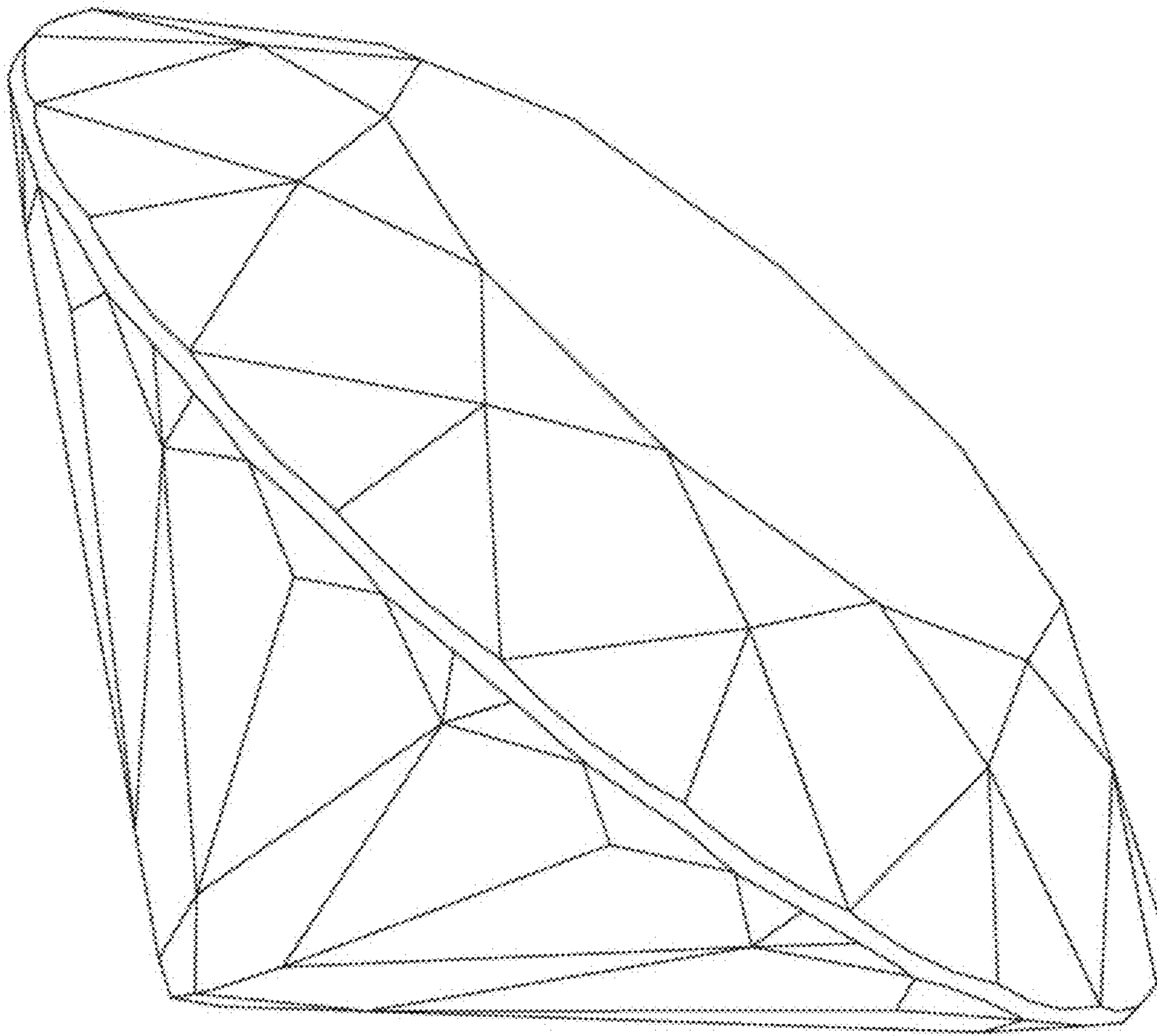

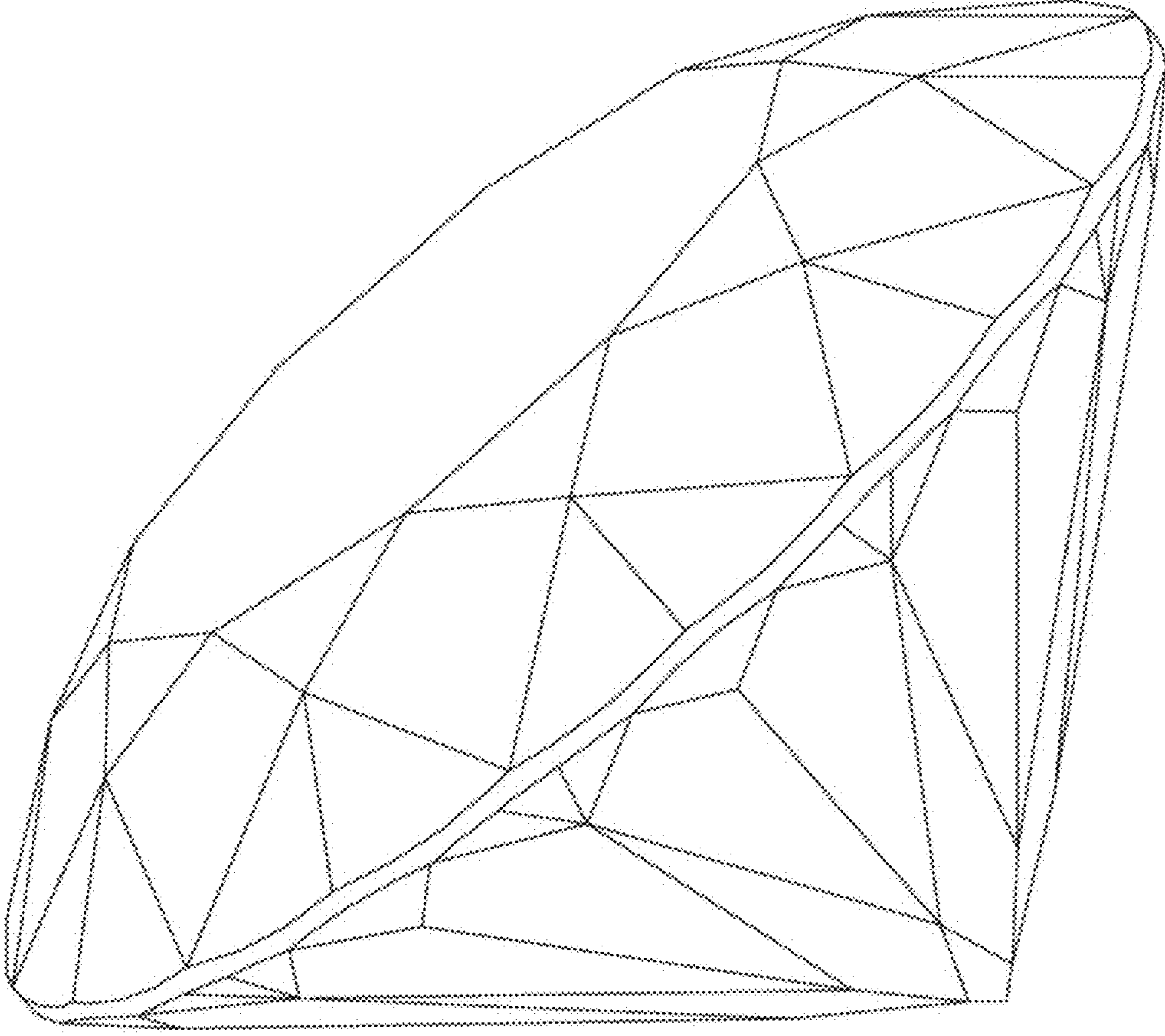
