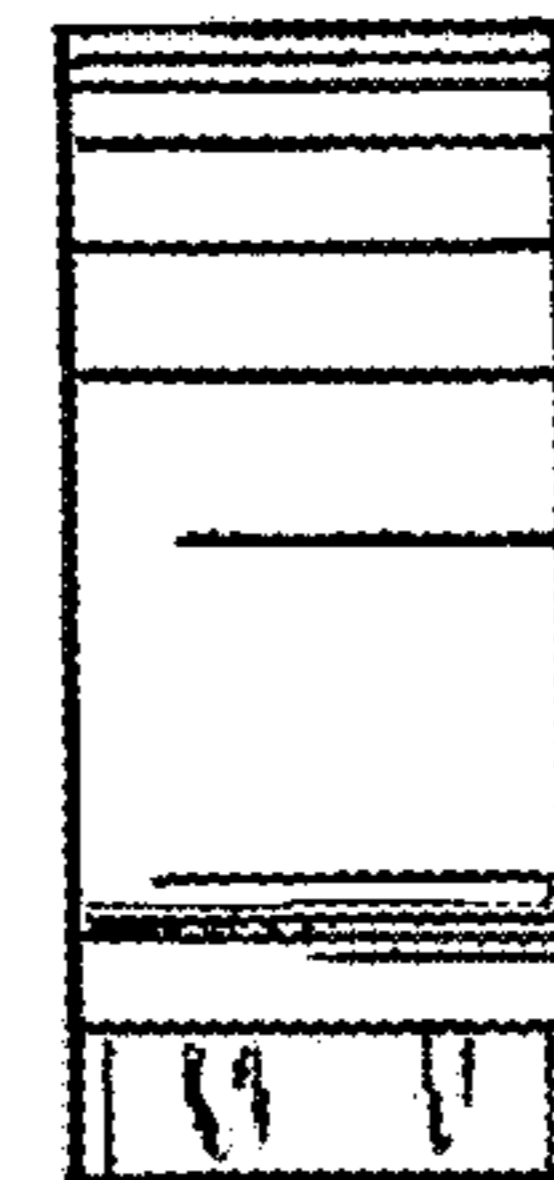
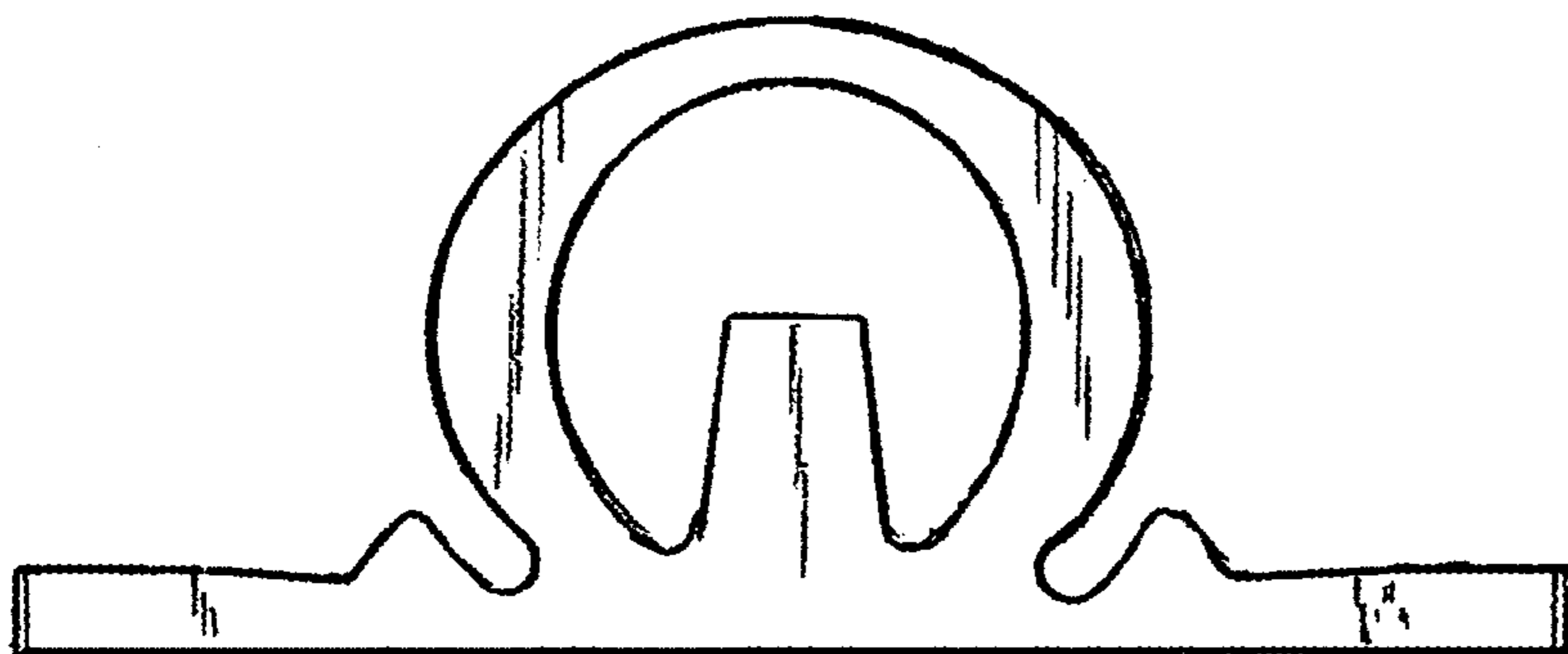
(57) **CLAIM**

The ornamental design for a cushioning apparatus, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a cushioning apparatus showing my new design; with the rear elevational view being a mirror image thereof; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; and, FIG. 4 is a right end view thereof; with the left end view being a mirror image thereof. The broken lines in FIGS. 2 and 3 illustrate portions of the cushioning apparatus that form no part of the claimed design.

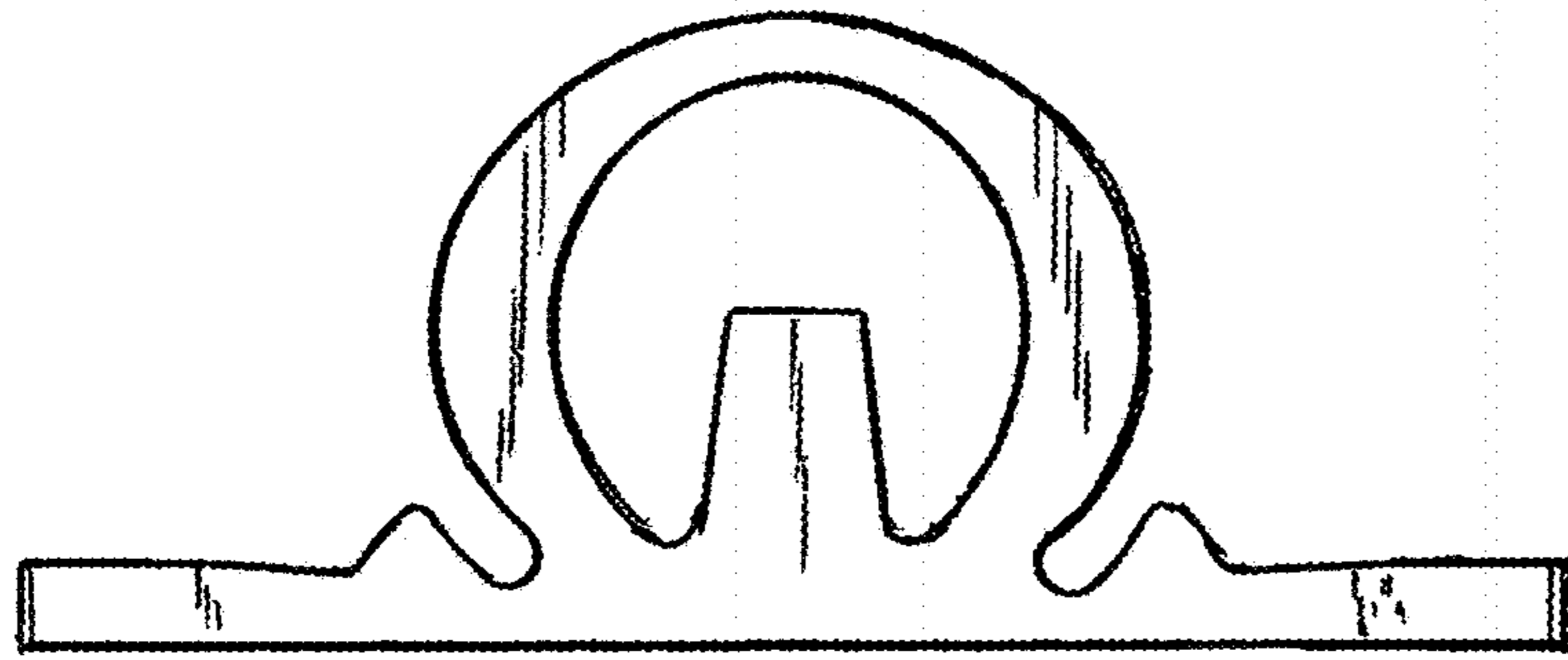

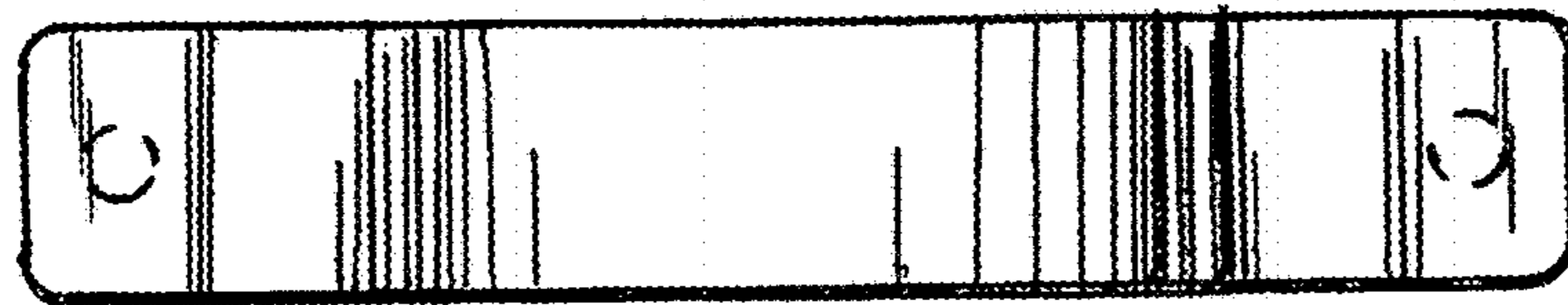

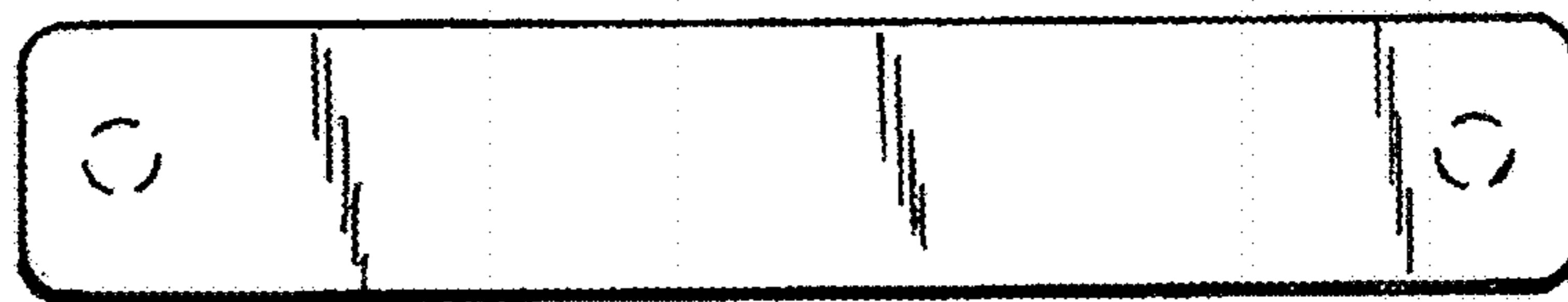

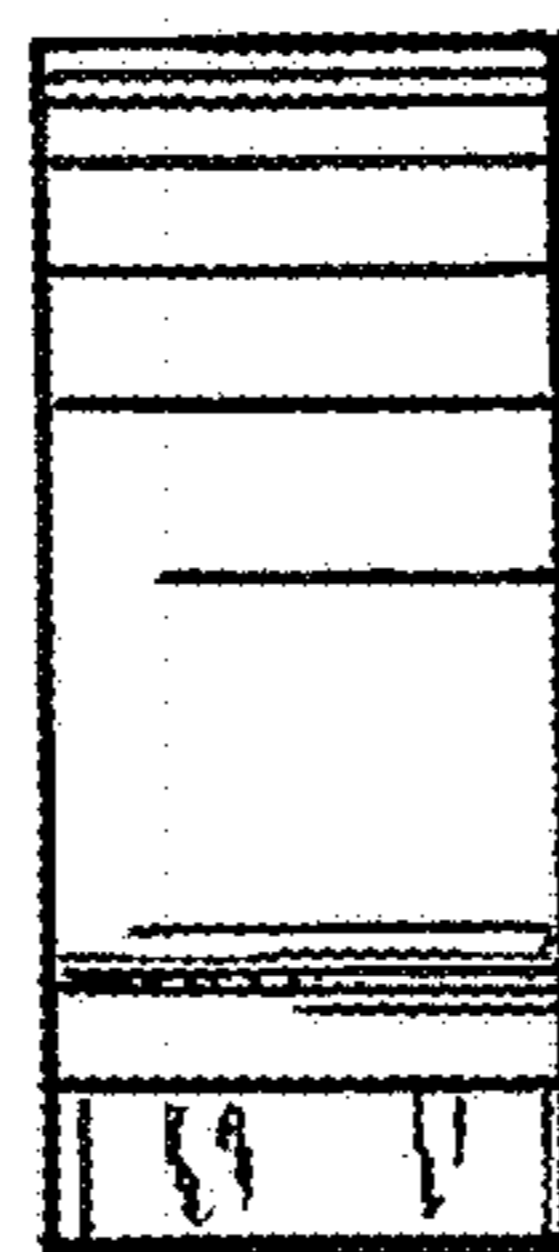
