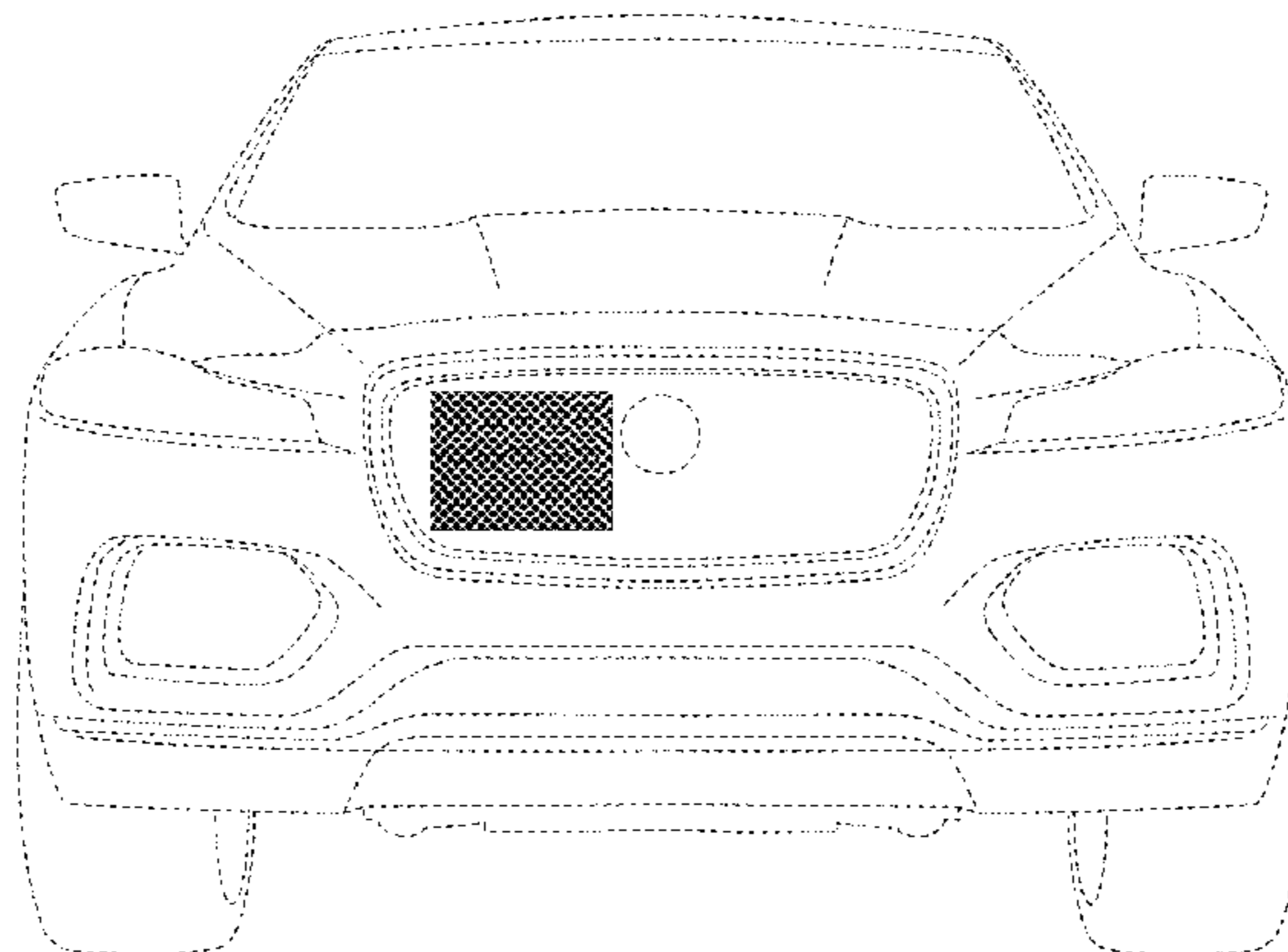
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a vehicle grille;
 FIG. 2 is an exploded front view of the vehicle grille of FIG. 1;

 FIG. 4 is an exploded front view of the vehicle grille of FIG. 3.

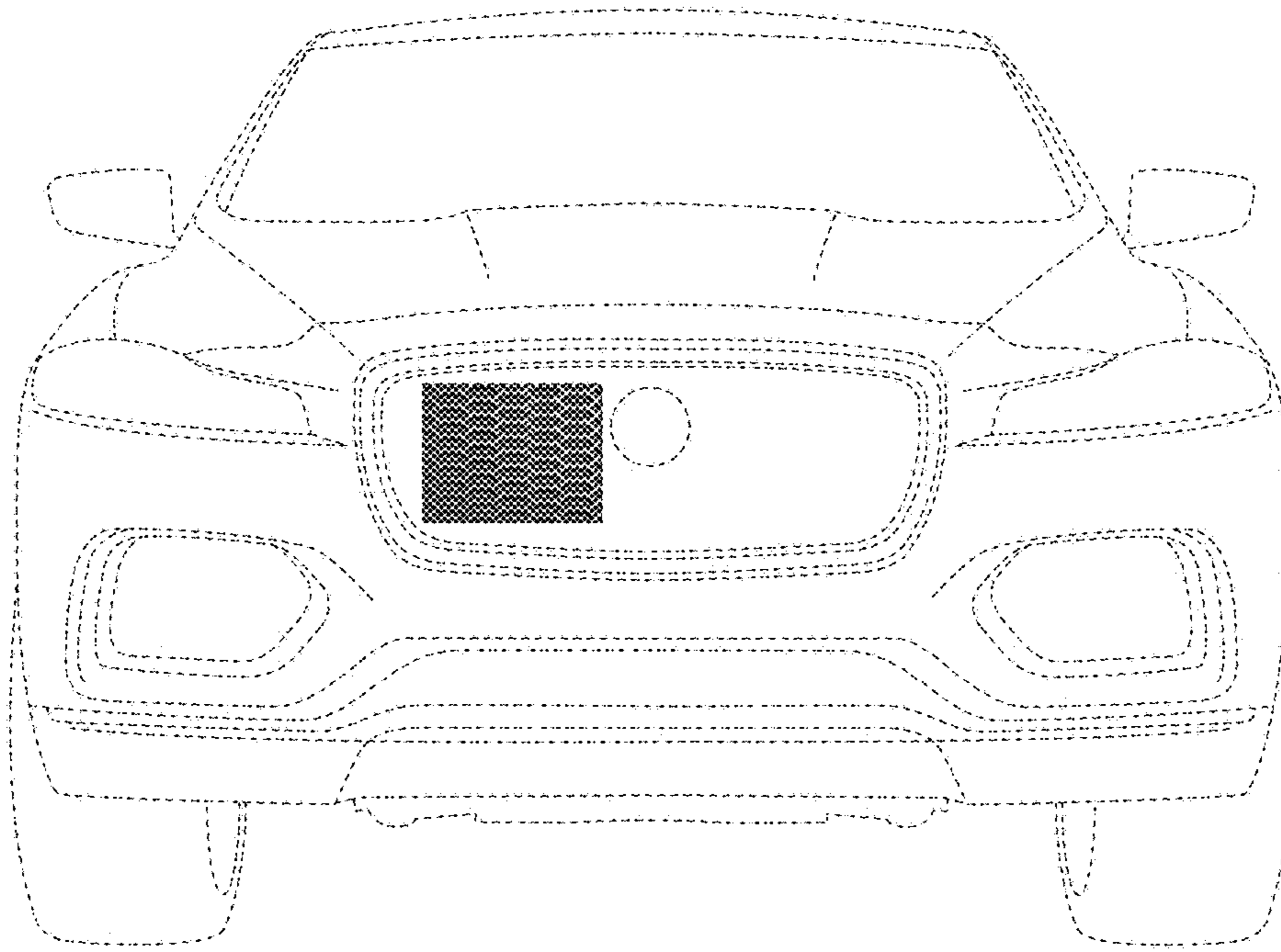

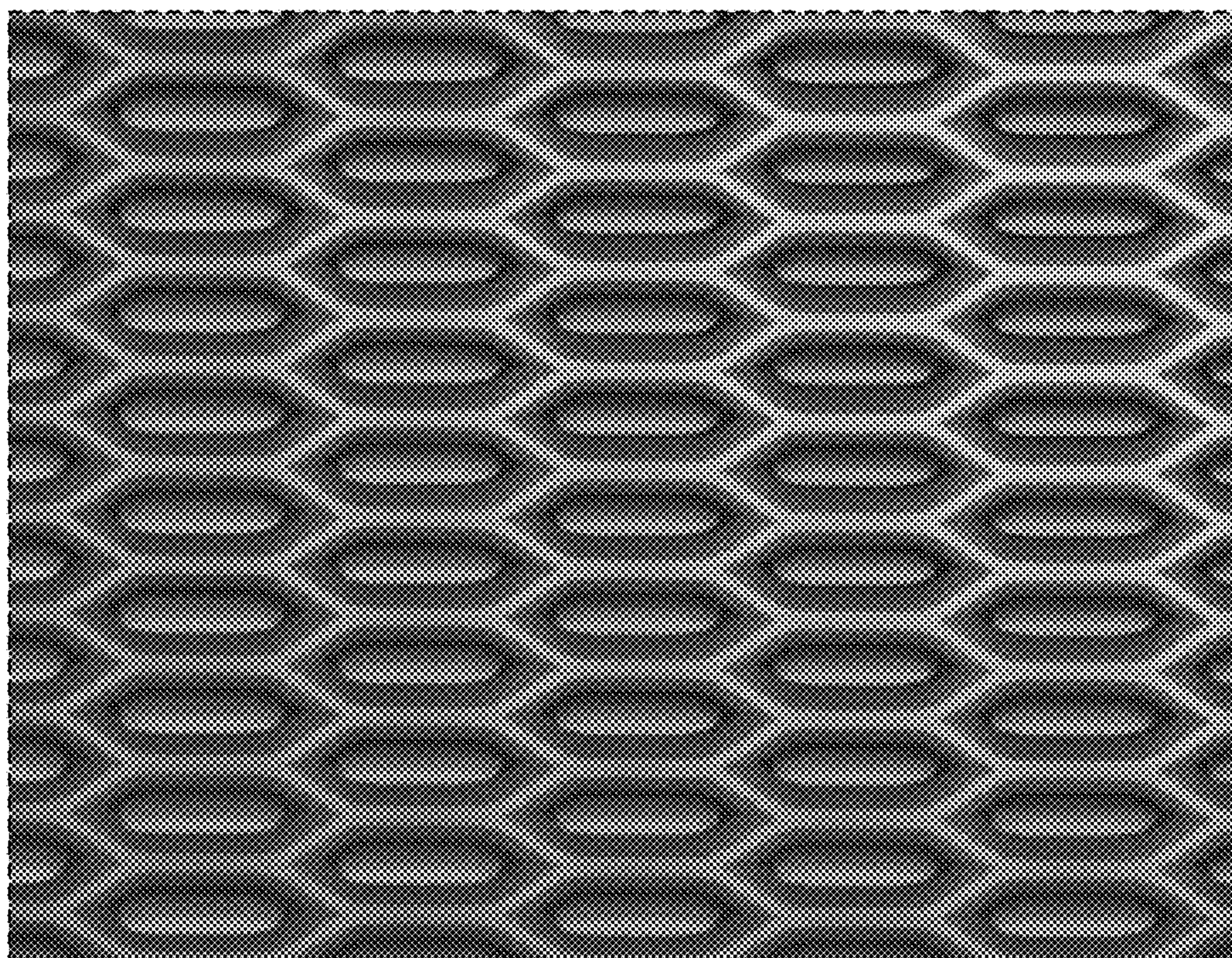

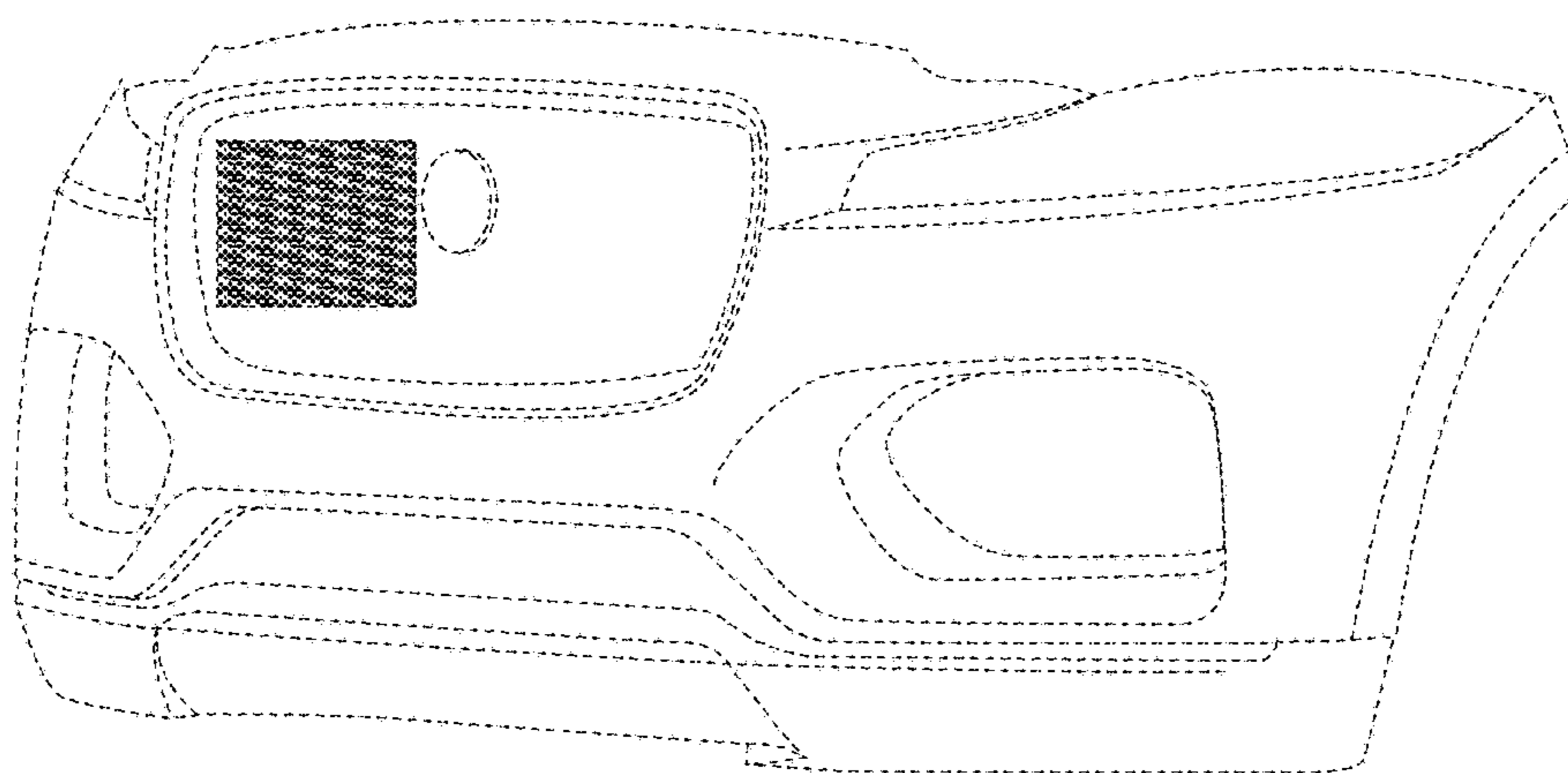

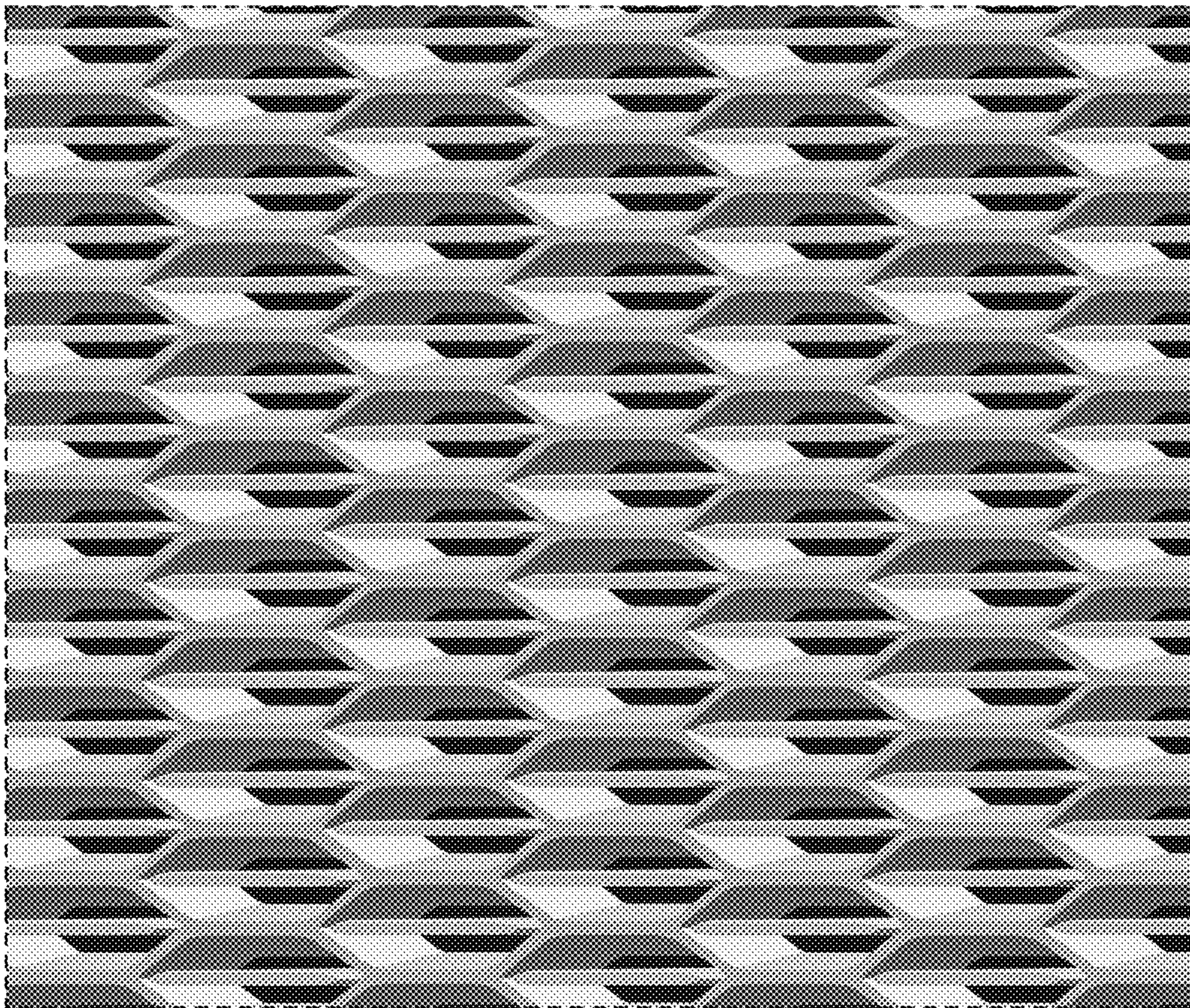
