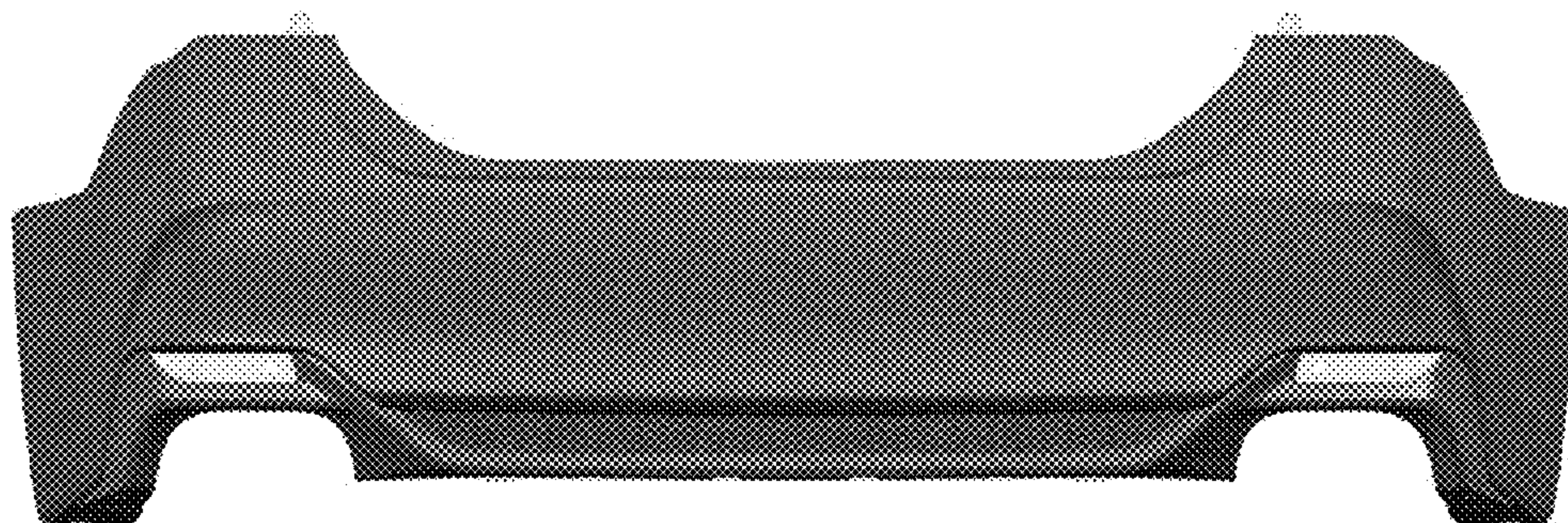
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a rear bumper for an automobile showing our new design;

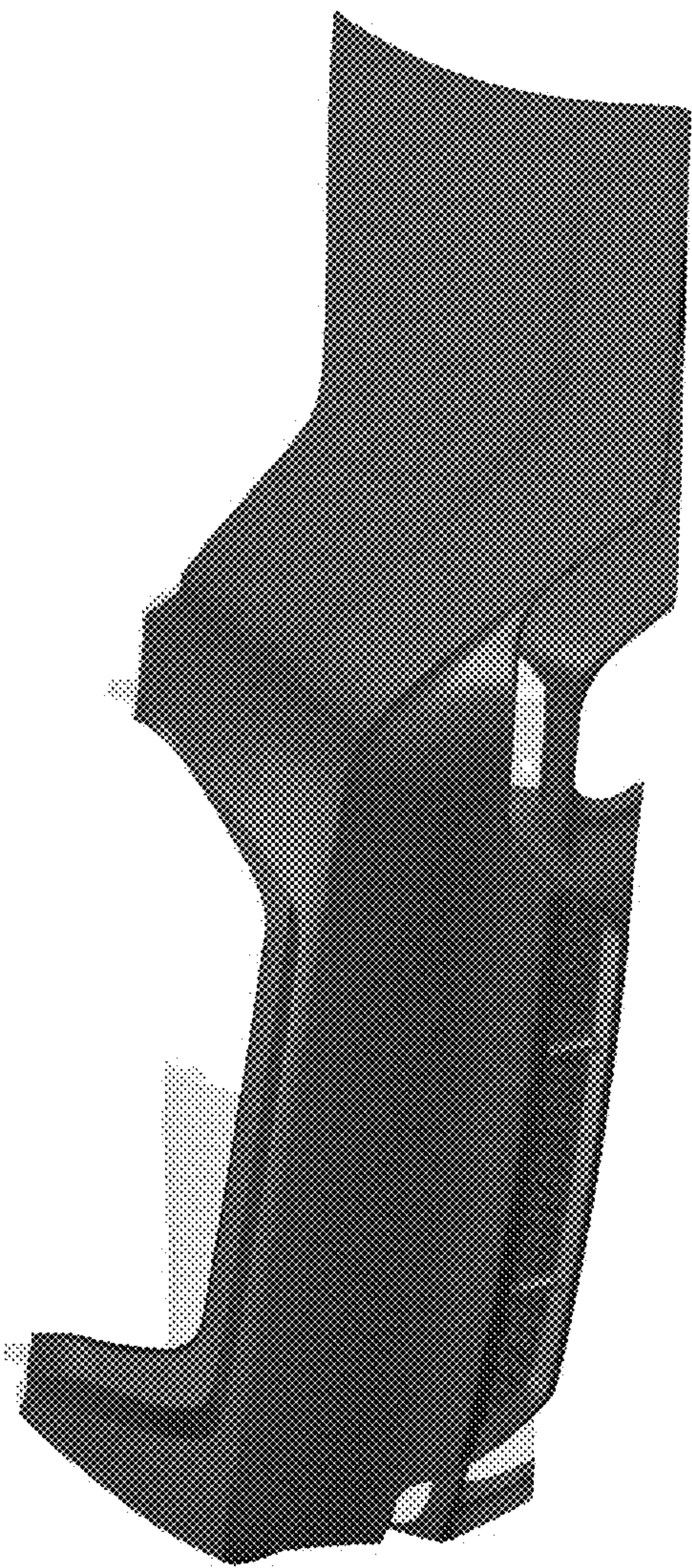

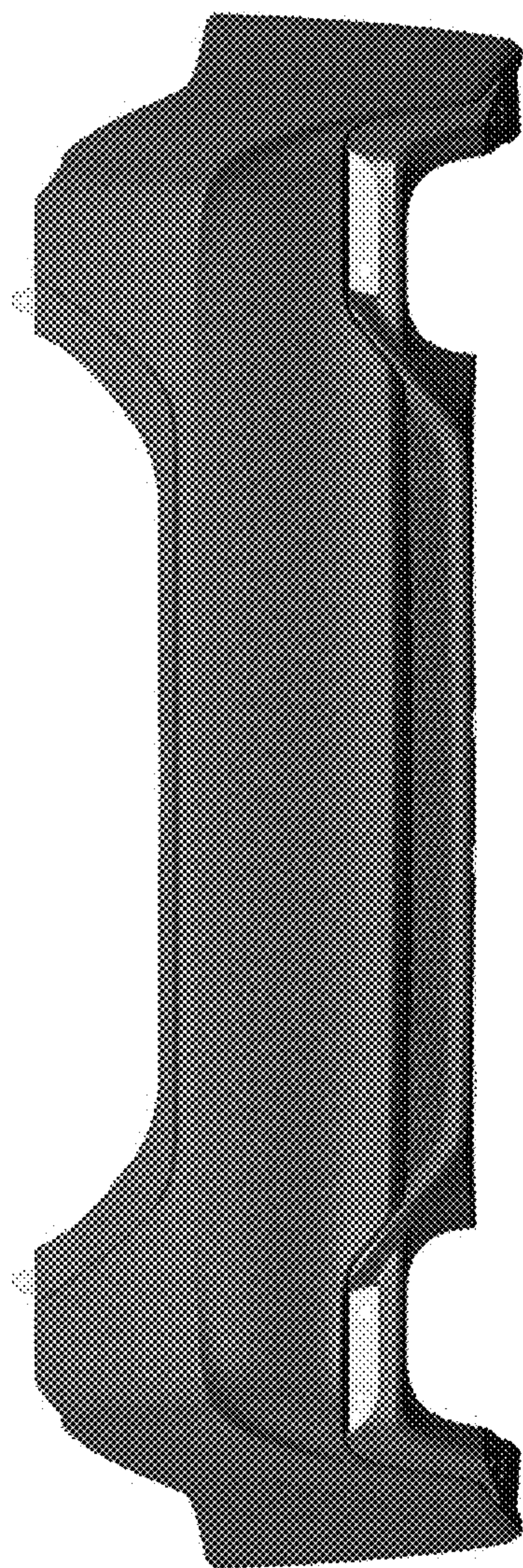

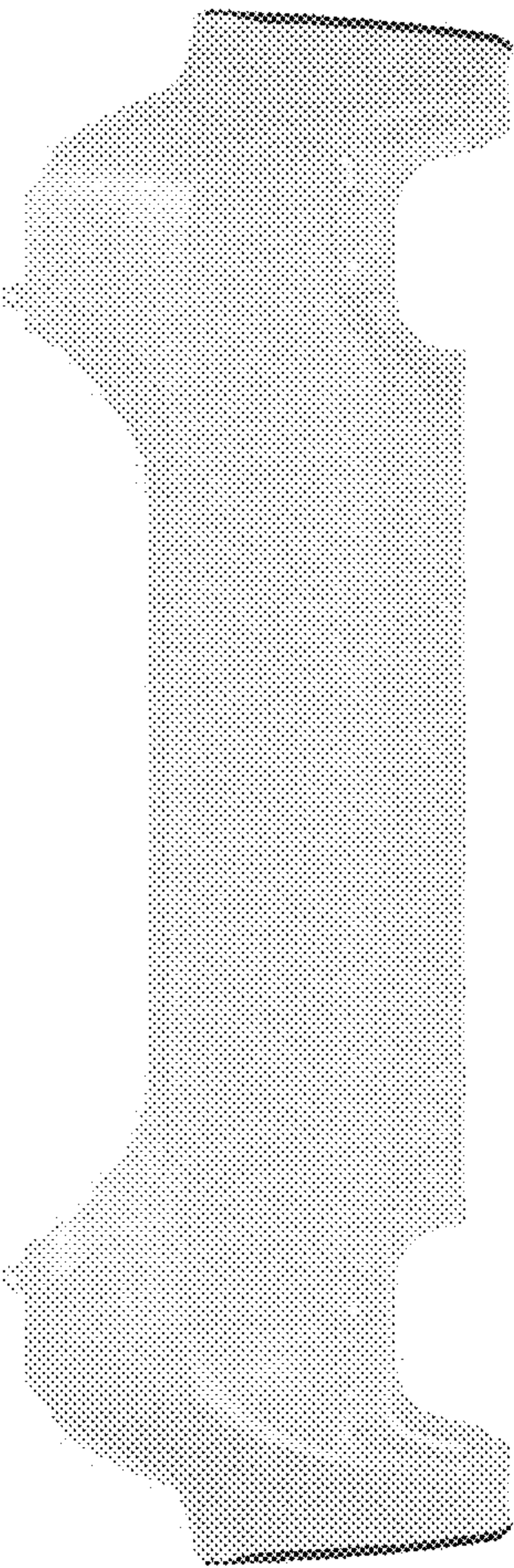

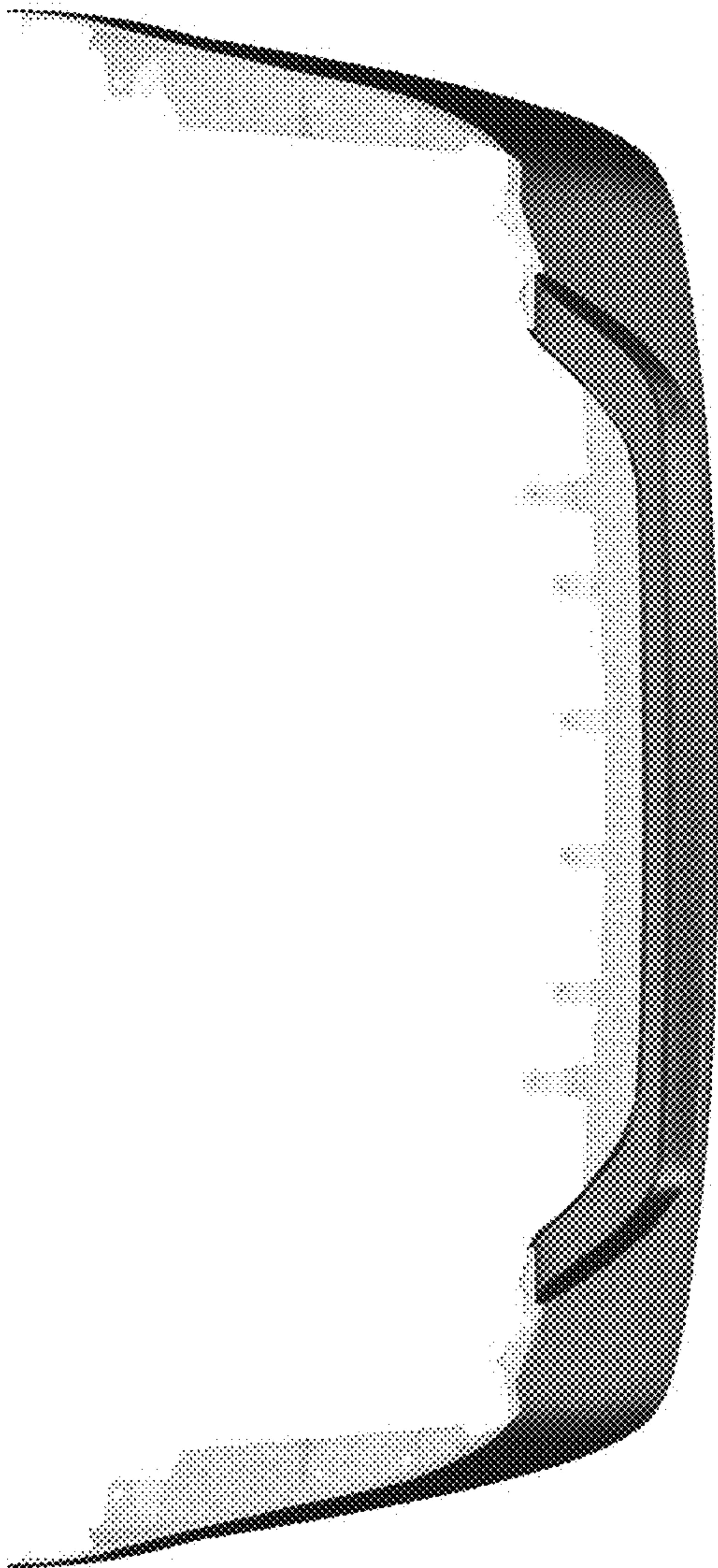

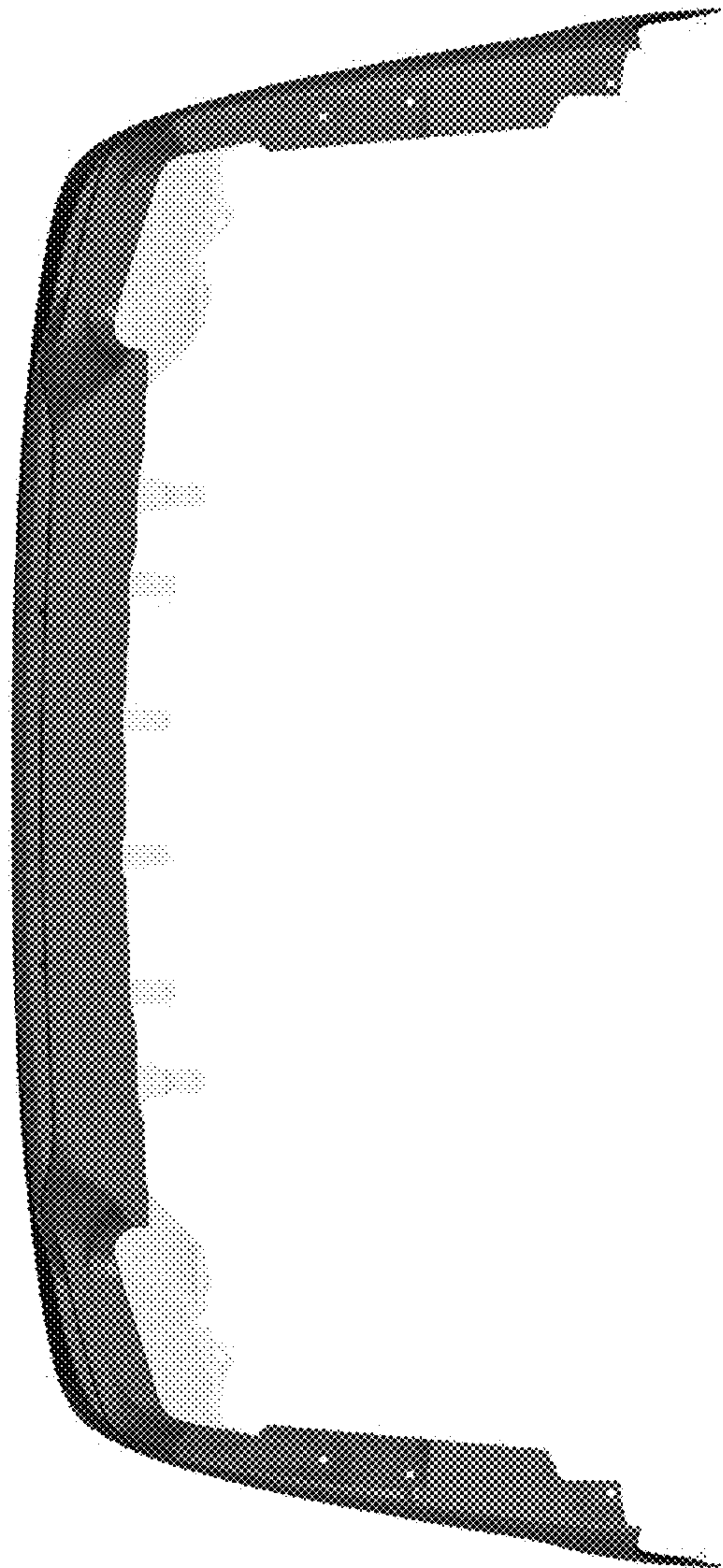

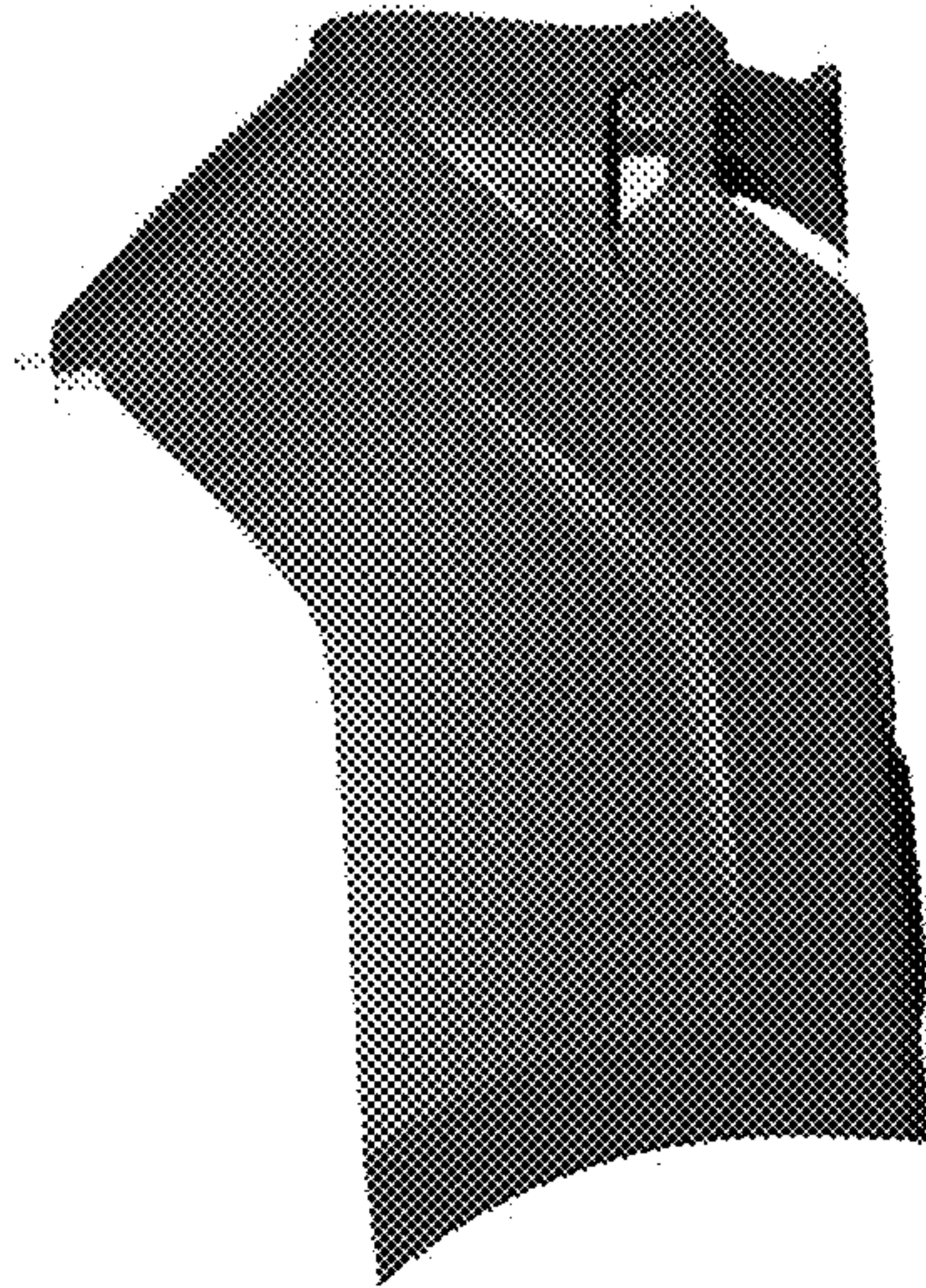
