(57) **CLAIM**

The ornamental design for a display screen with an animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1A is a partial front view of a first image in a sequence for a display screen with an animated graphical user interface that extends to FIG. 1B at the bottom horizontal jagged broken line;

FIG. 1B is a partial front view thereof extending from FIG. 1A at the top horizontal jagged line;

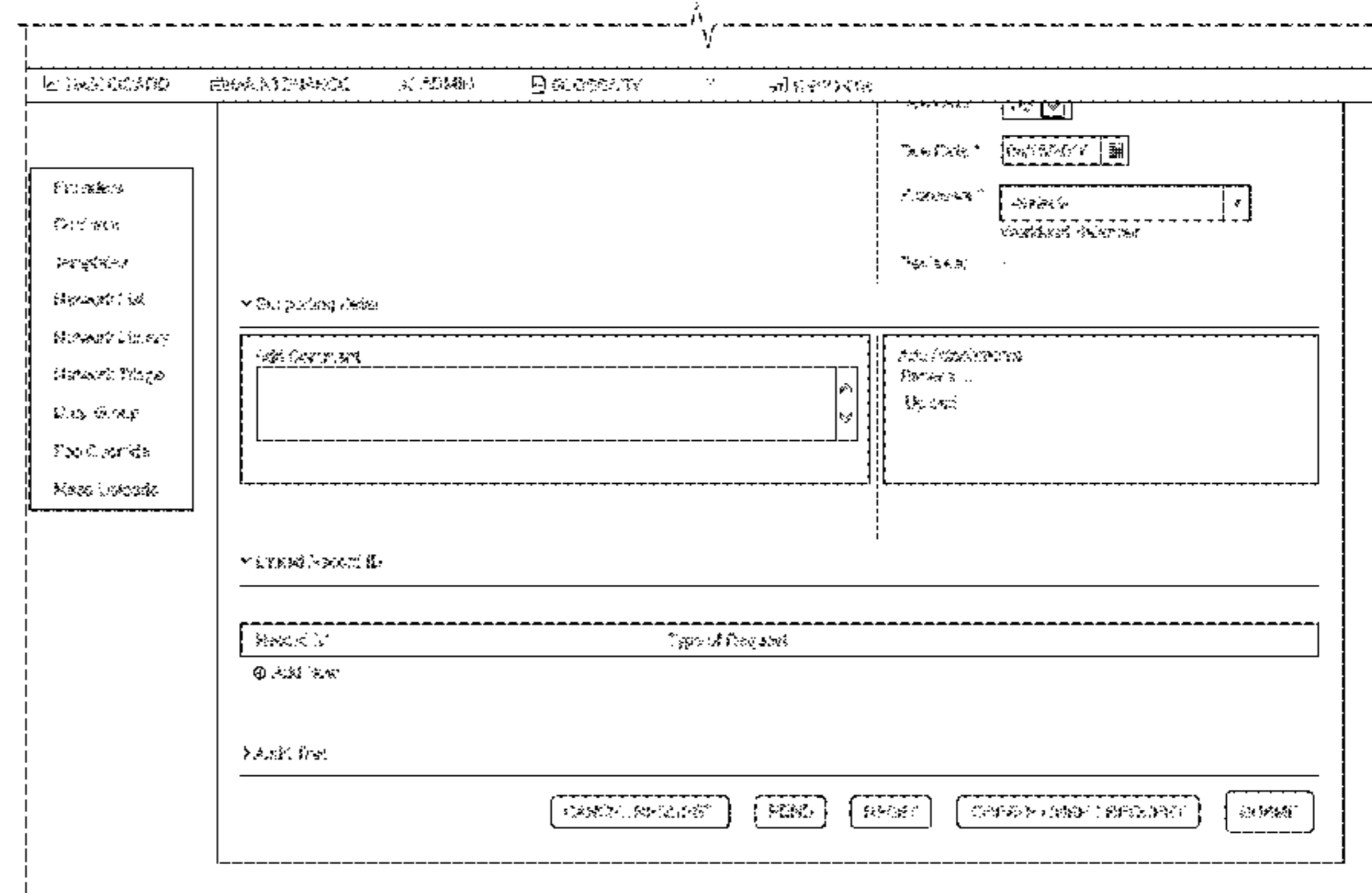
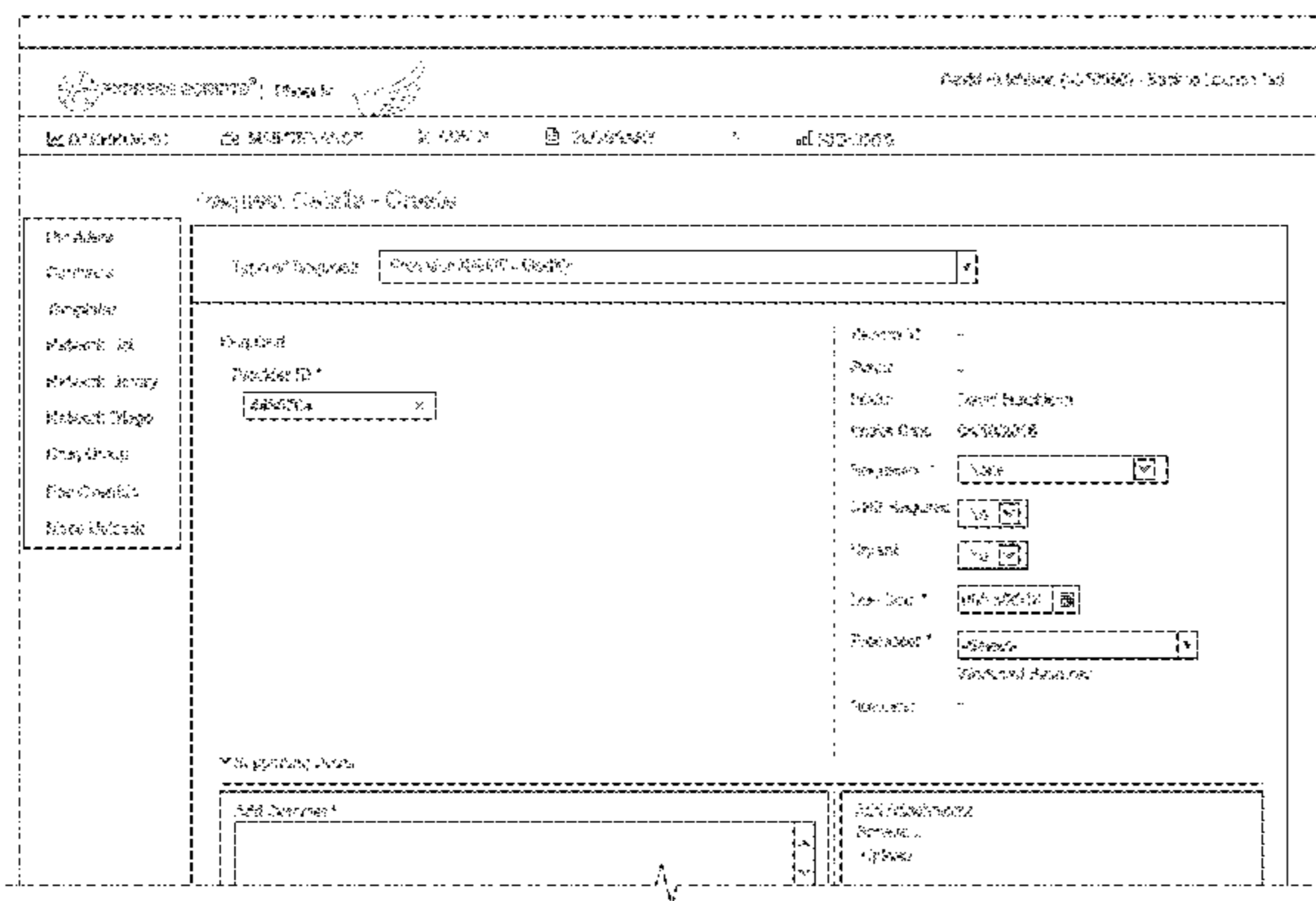
FIG. 2A is a partial front view of a second image thereof that extends to FIG. 2B at the bottom horizontal jagged broken line; and,

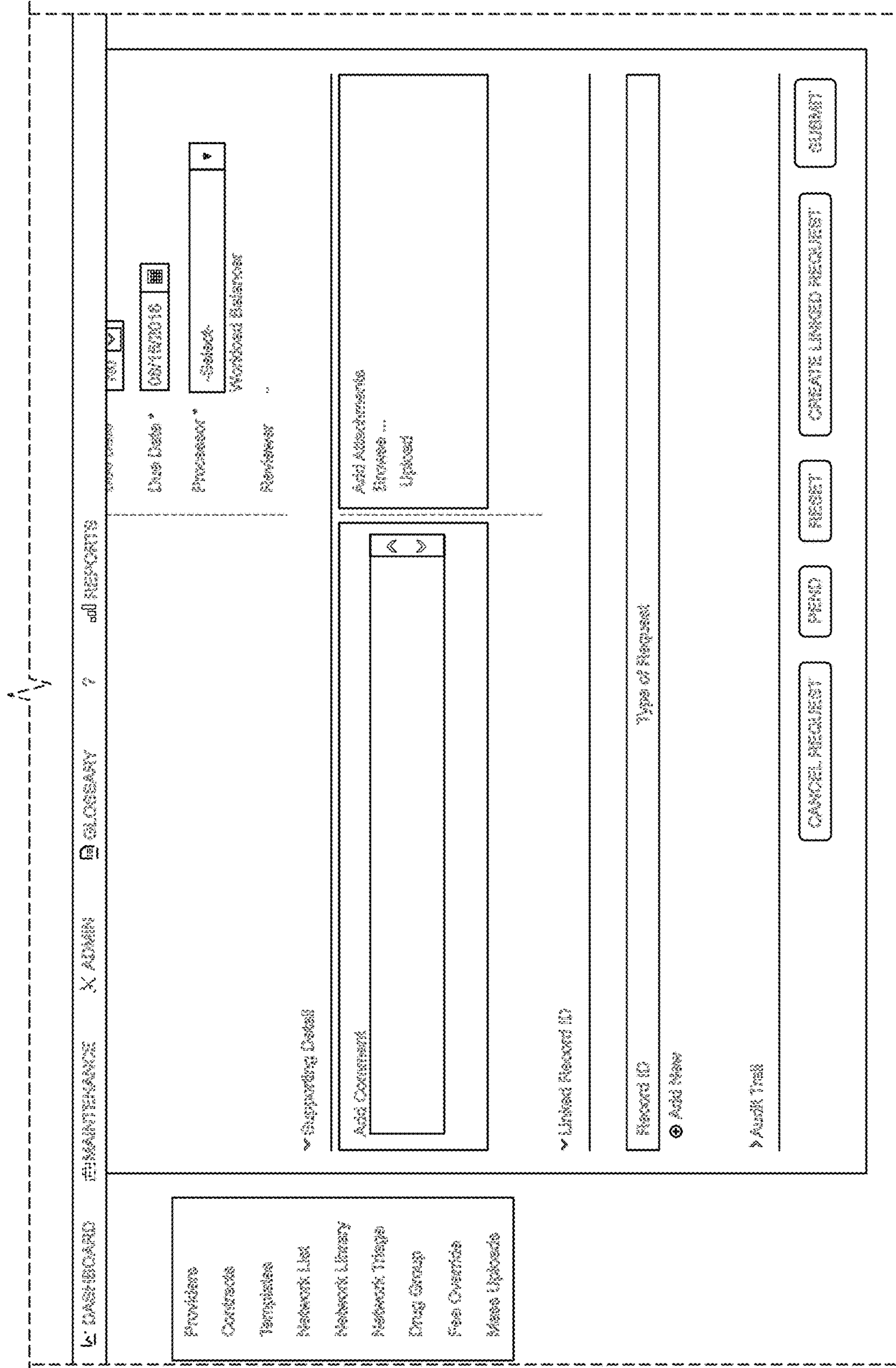

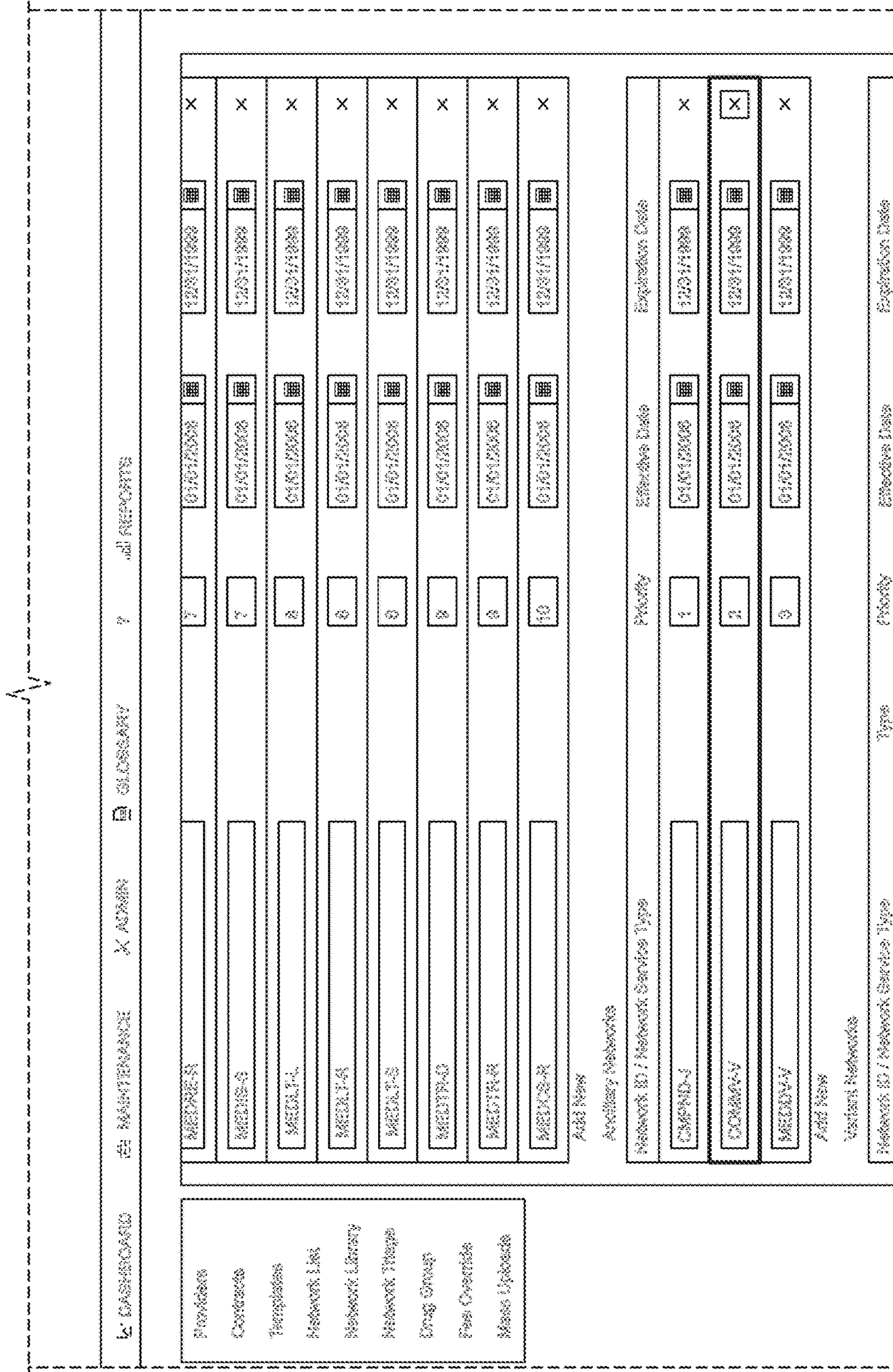
