FIG. 10 is the design of FIG. 5 with environmental portions removed.

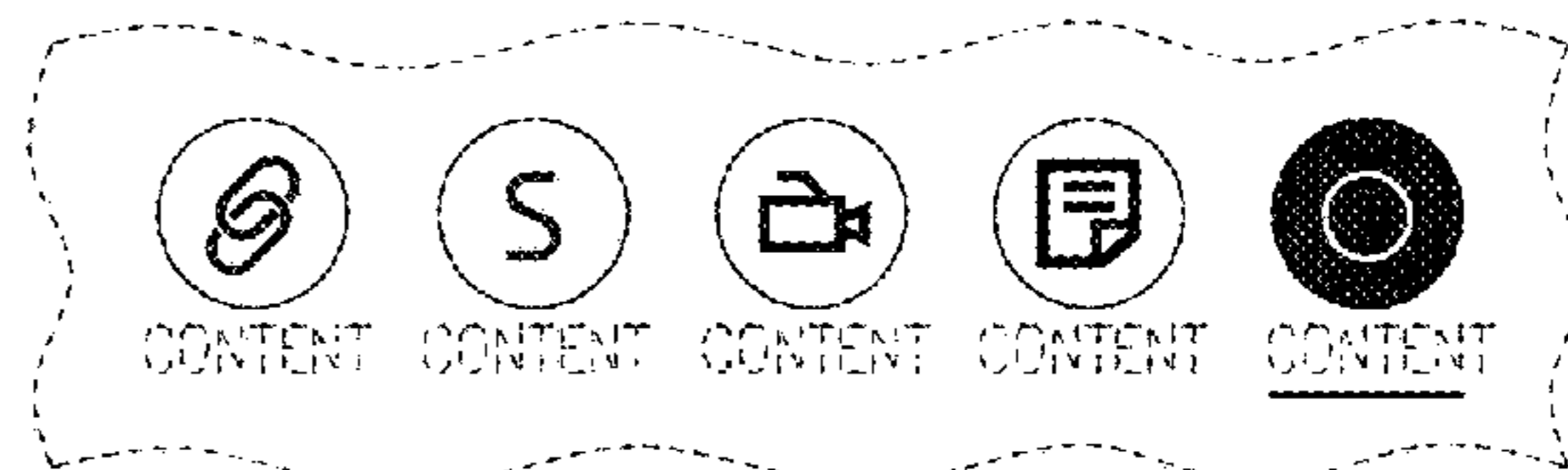
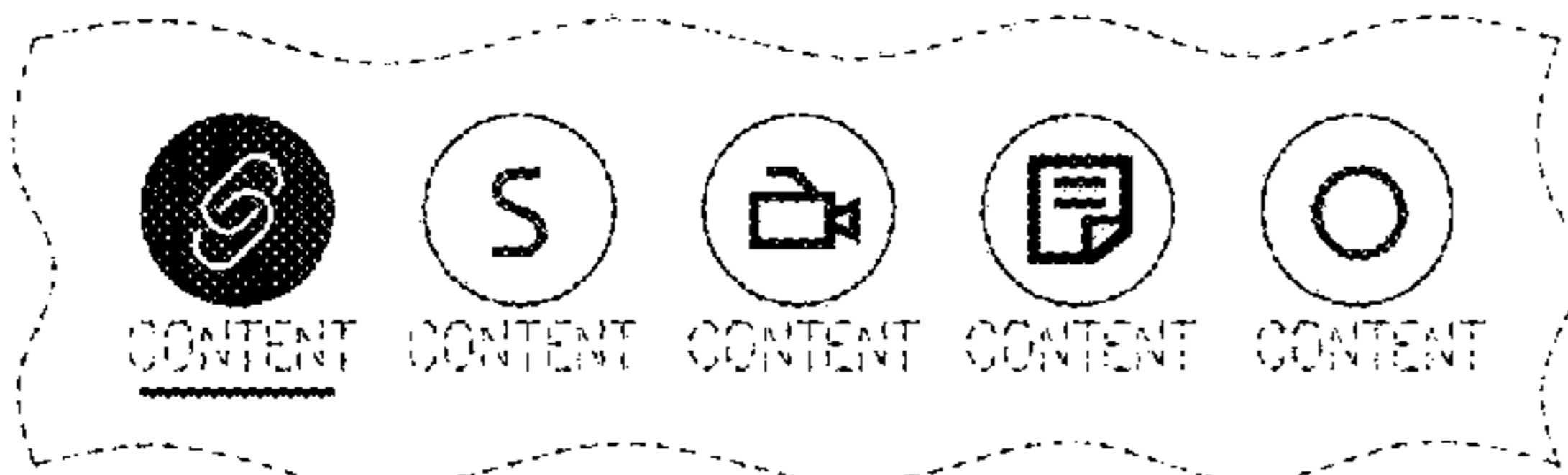

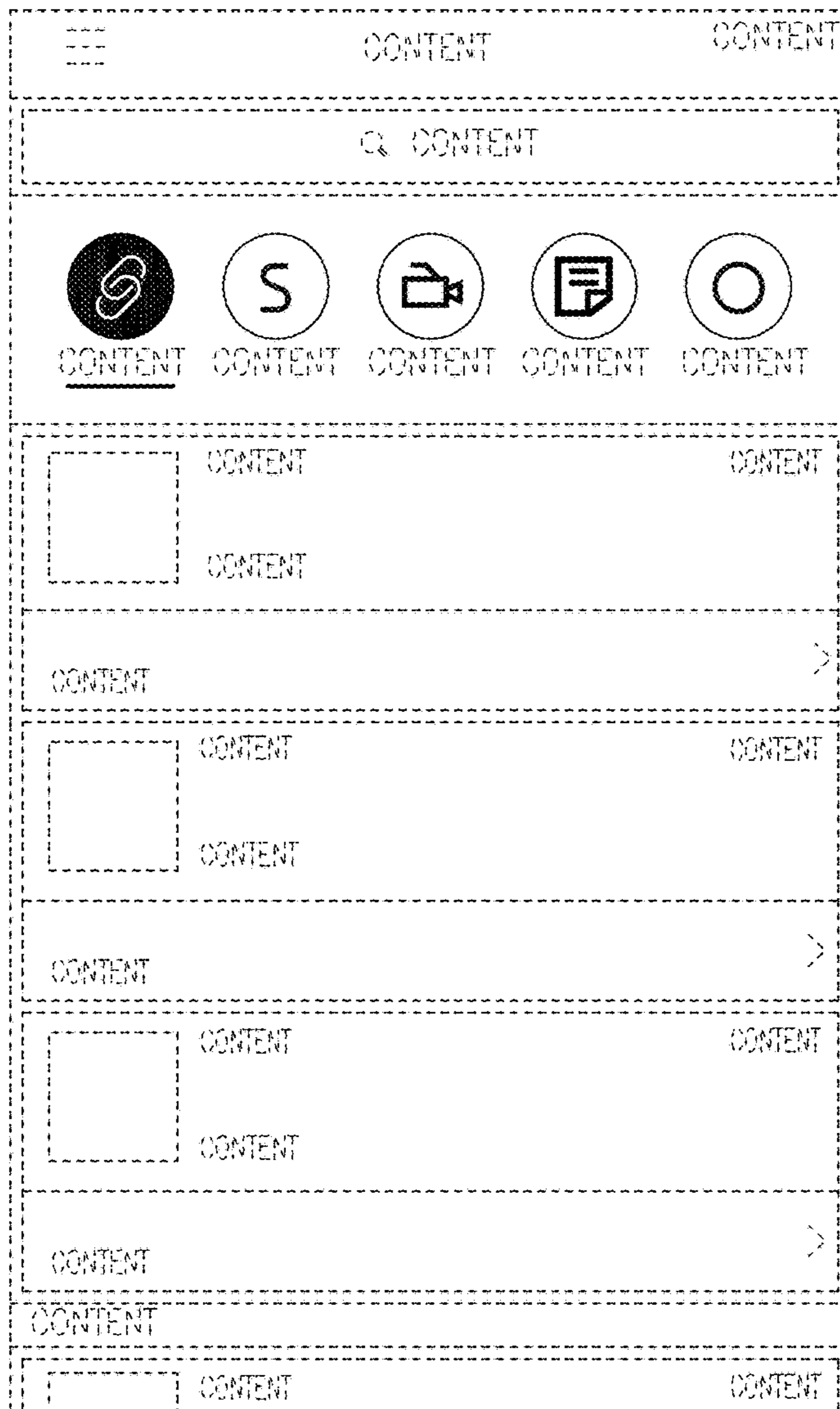

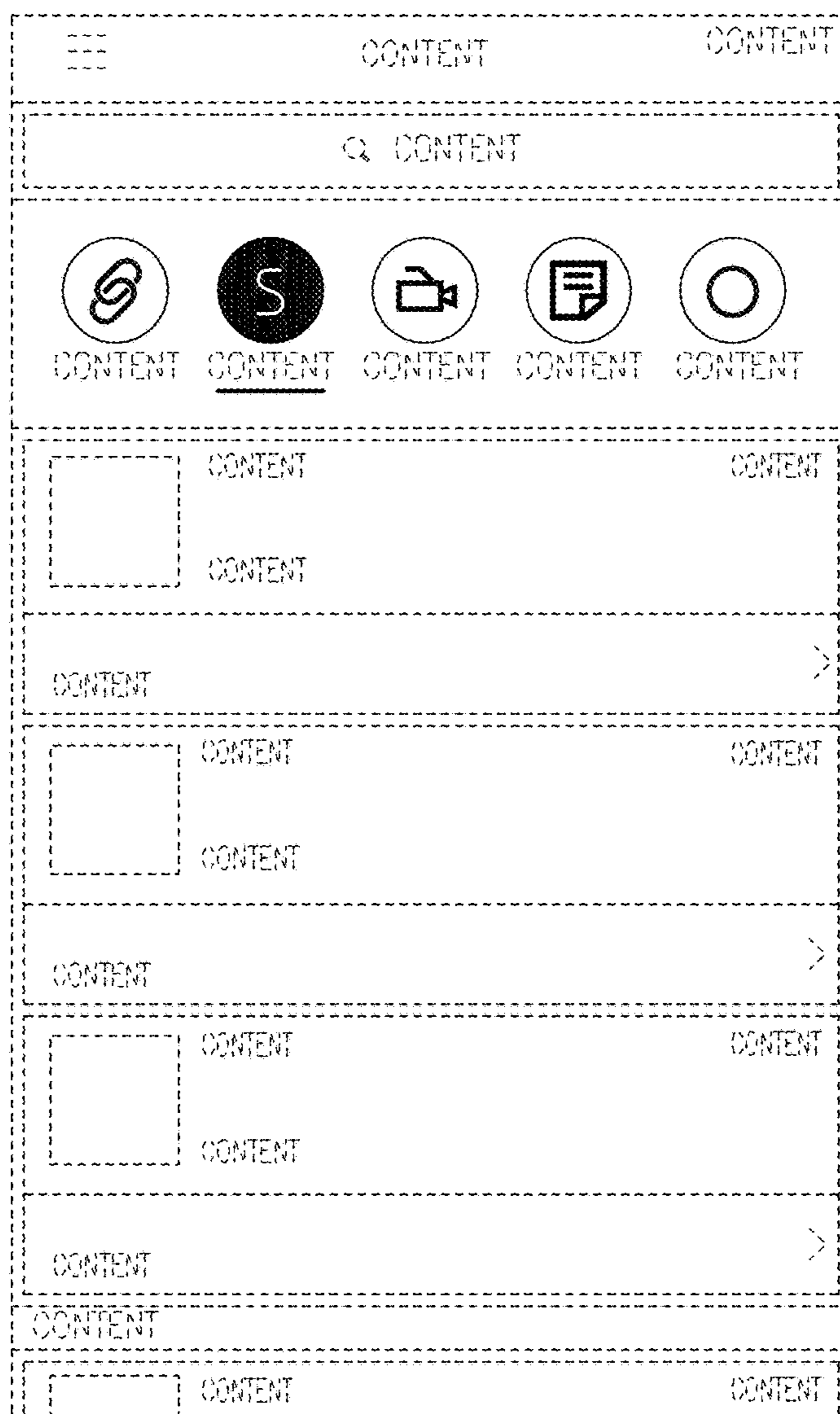

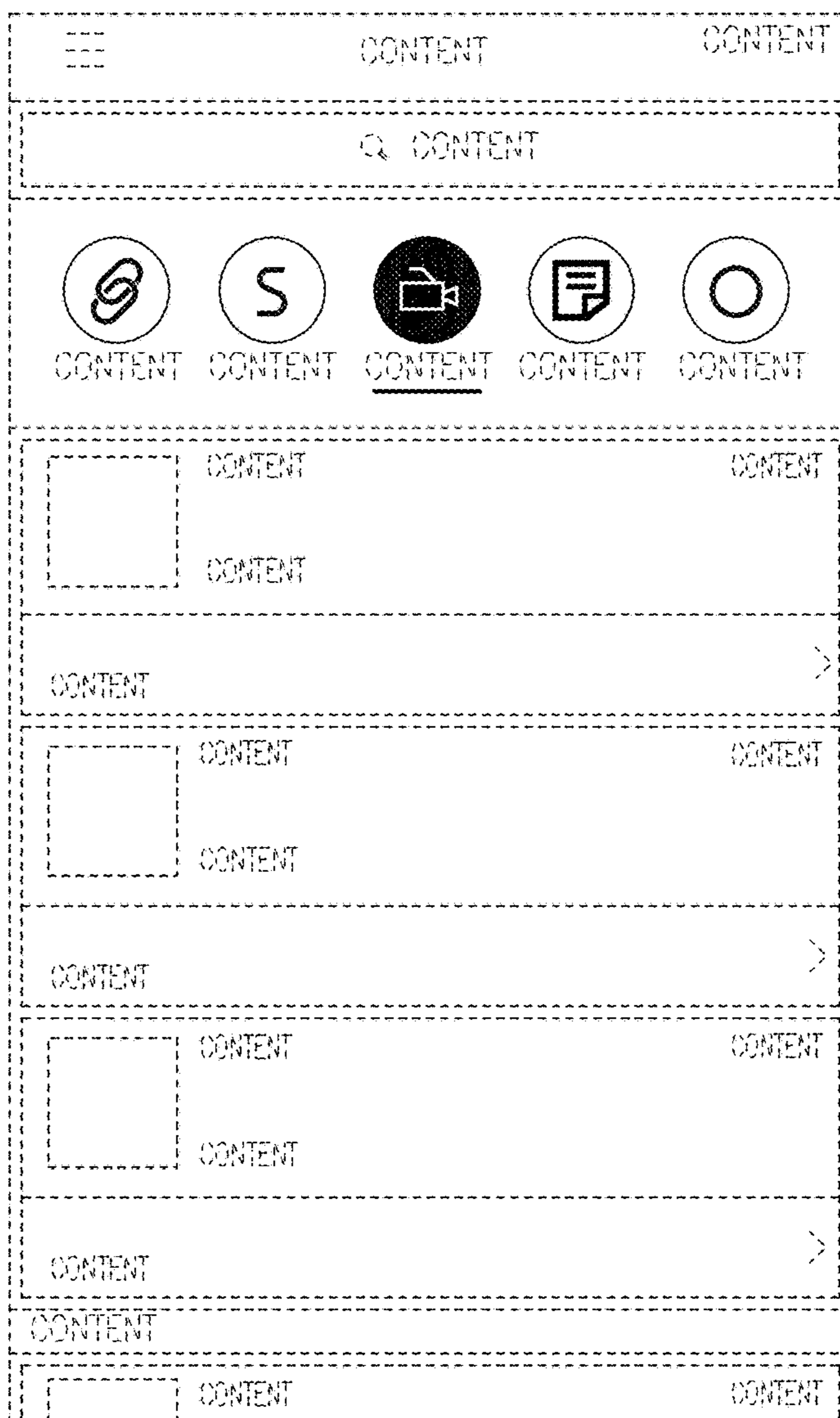

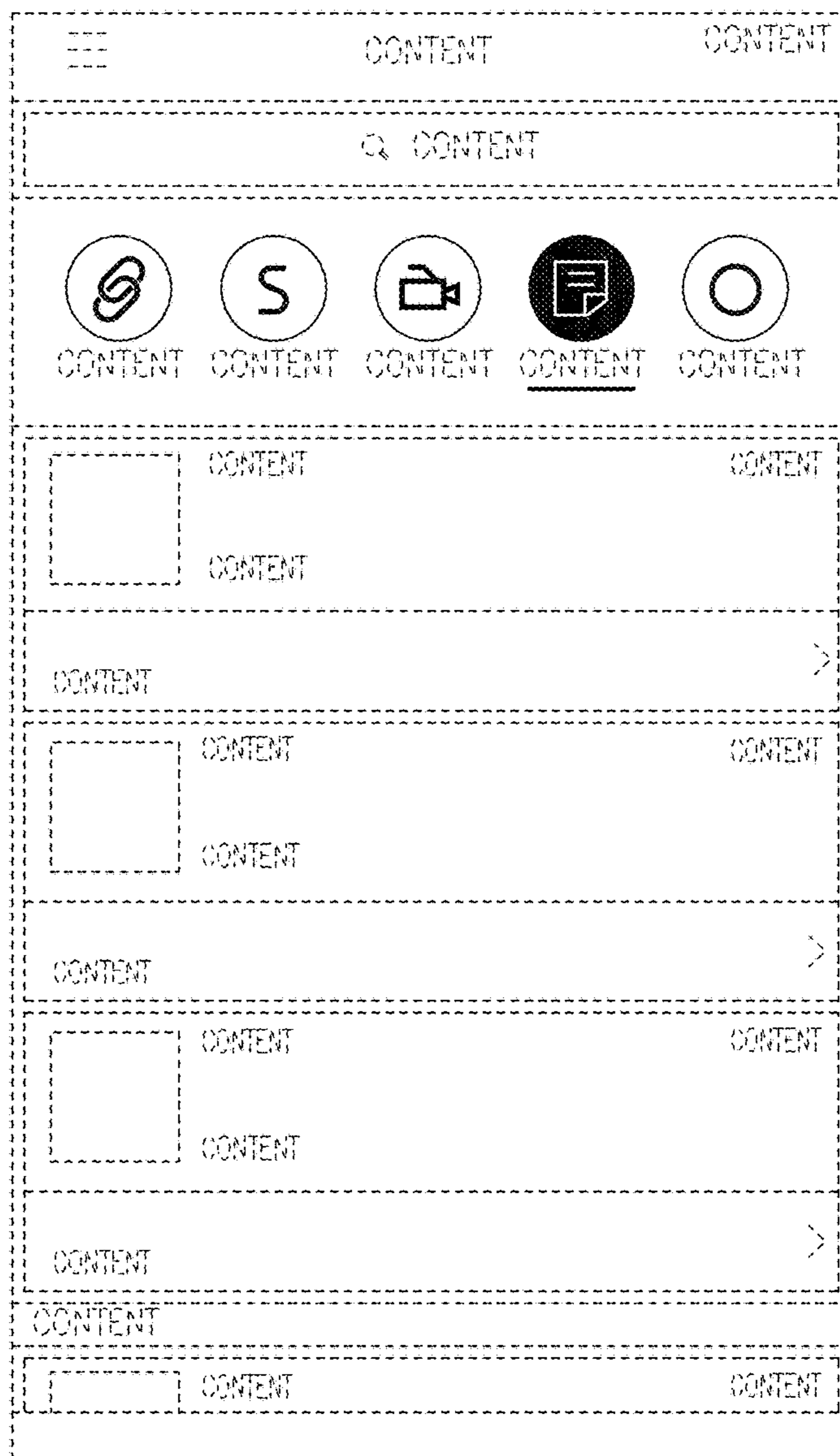

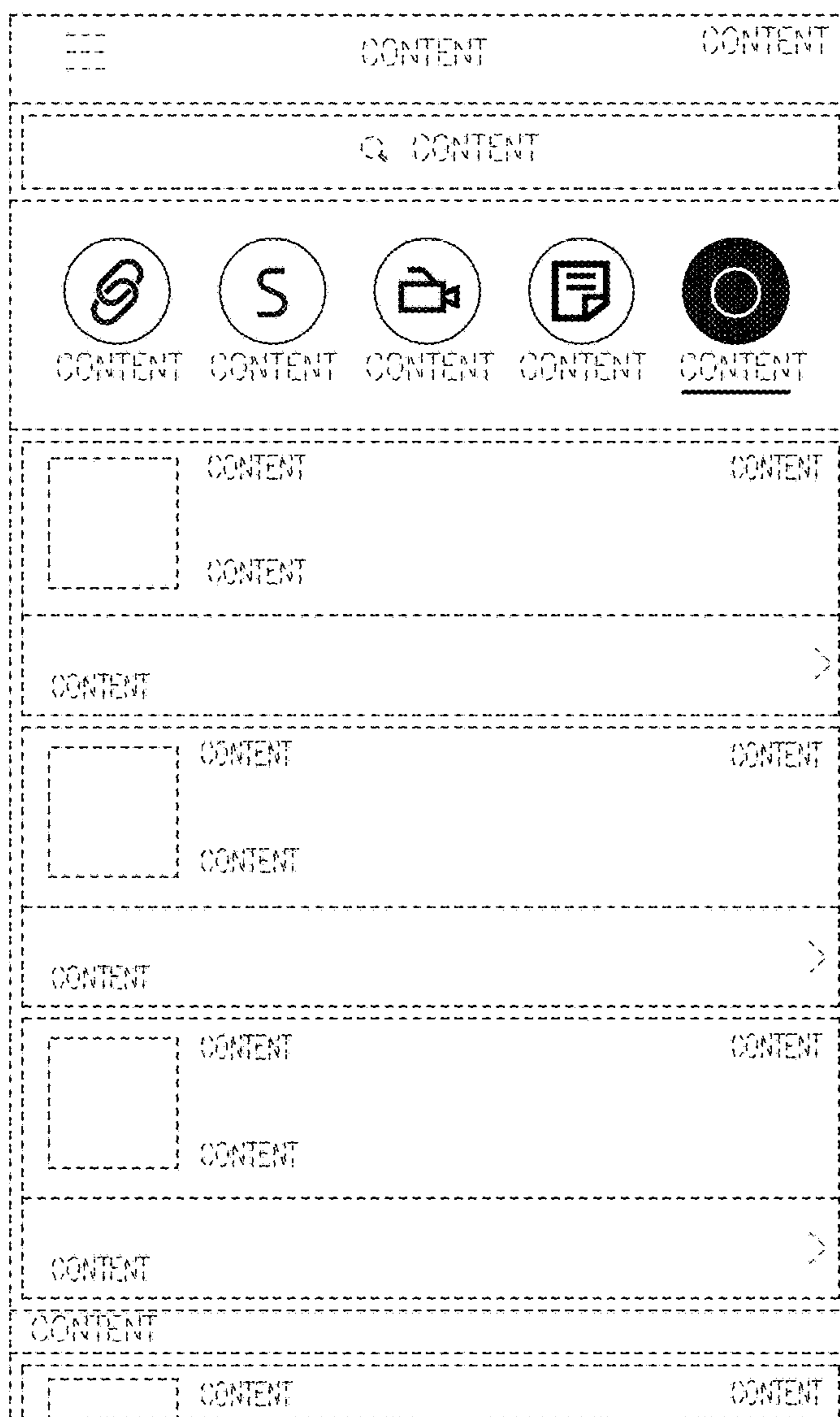

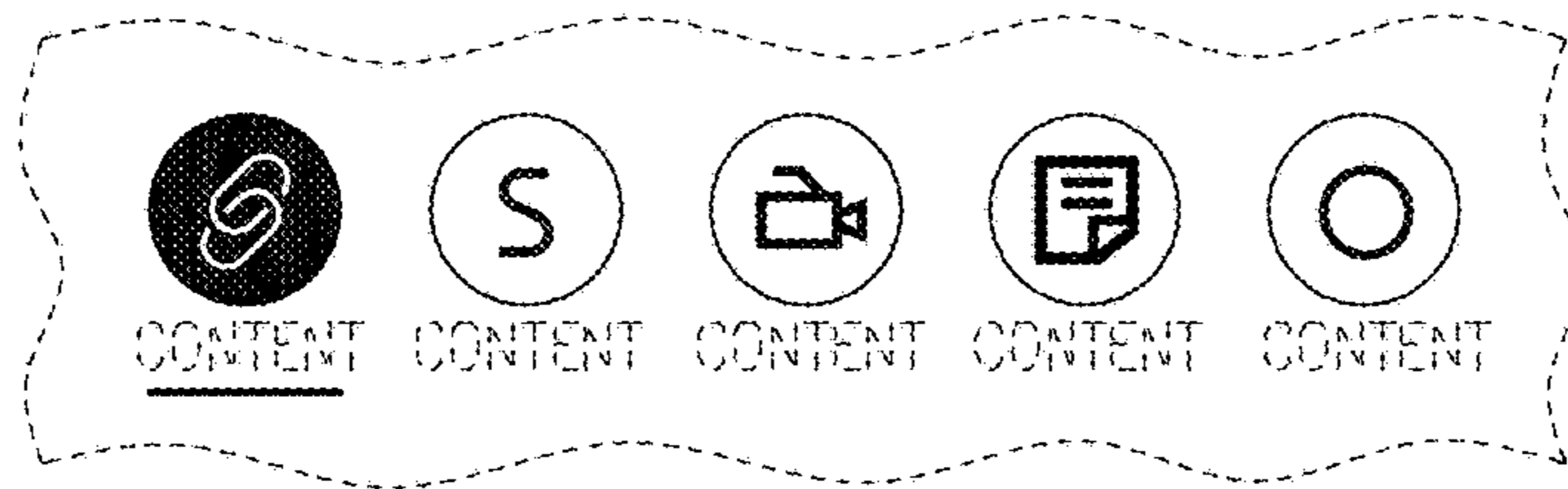

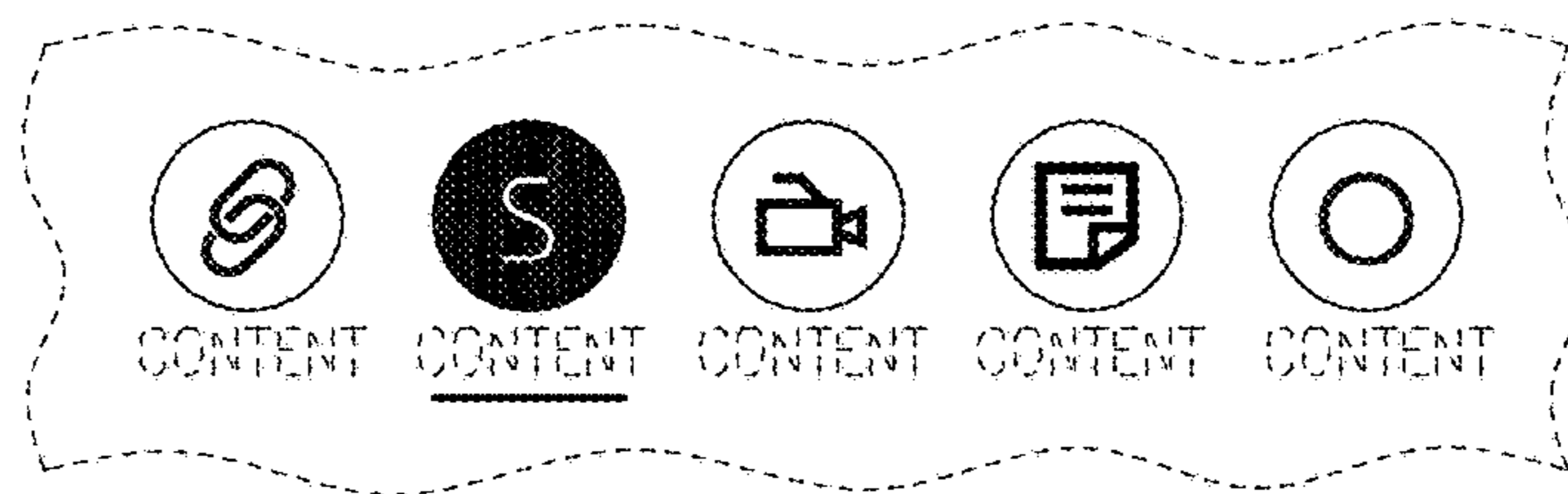

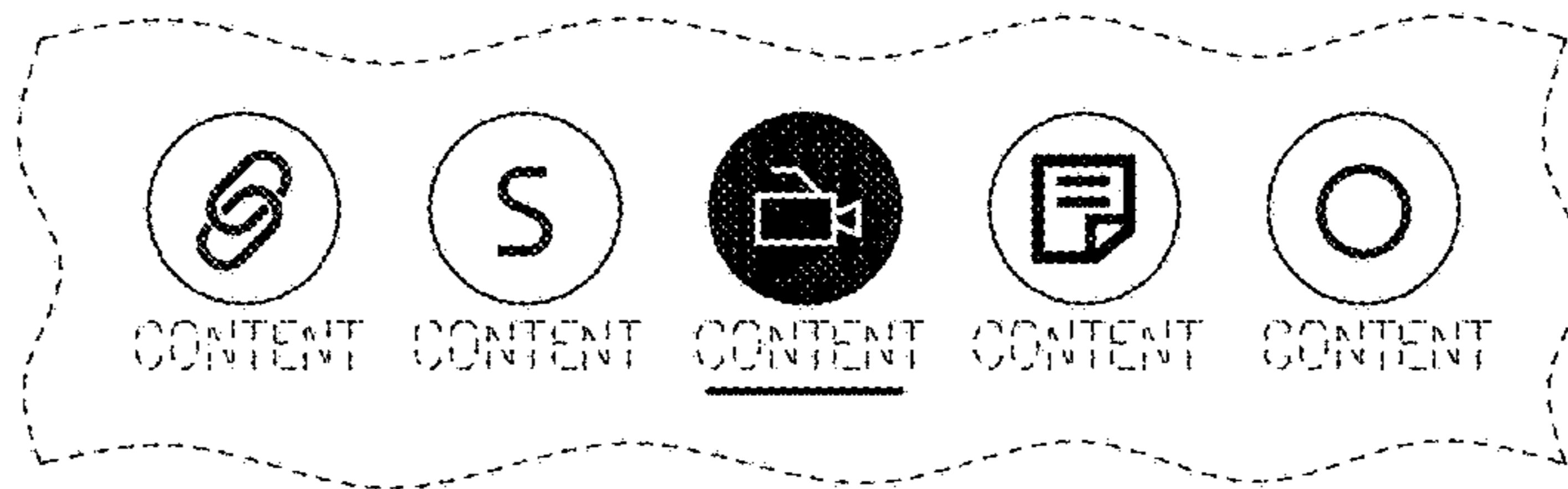

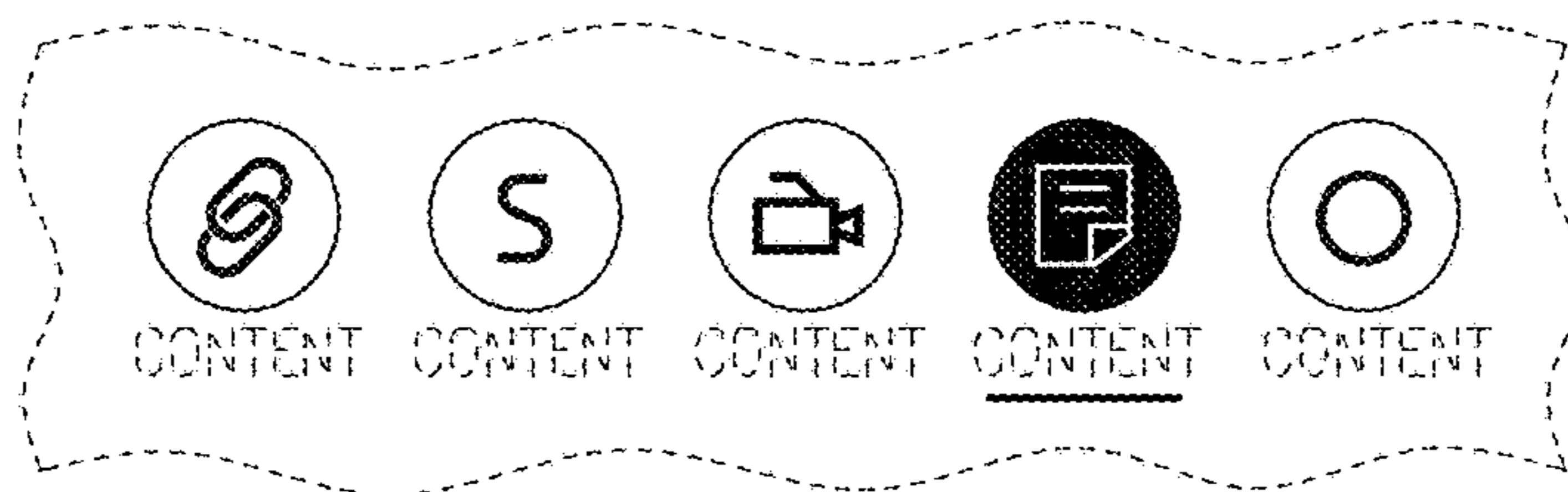

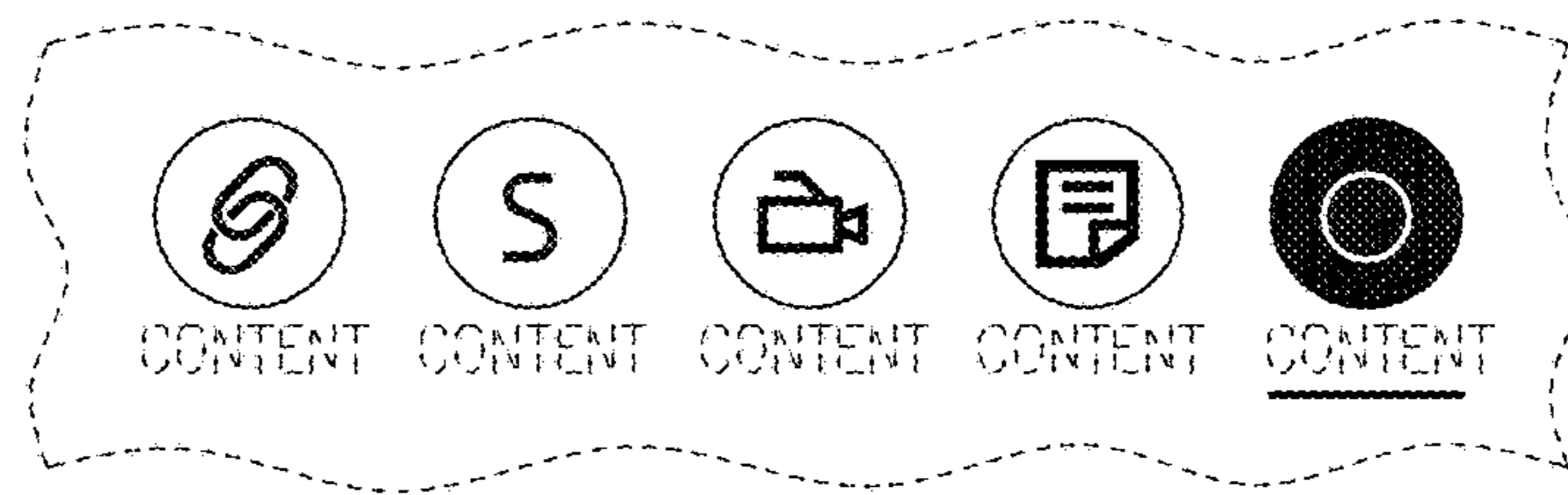
